BRITAIN ACTS TO GUARANTEE SMALL ALLIES

Move Taken in Emergency Session of Cabinet

GREECE, TURKEY ARE RE-ASSURED

Cabinet Session Coincides with Movements British Warships in Mediterranean

London, April 10.—(AP)—The British cabinet, in emergency session, was reported reliably today to have offered to guarantee the independence of Greece and Turkey.

Earlier Prime Minister Chamberlain was said to have told Italy that any attempts to seize the strategic Greek-owned island of Corfu would be interpreted by Britain as an invitation to war.

The urgent cabinet session coincided with emergency movements of British warships in the Mediterranean.

It was announced officially that both Houses of parliament would be convened on Thursday, breaking the Easter recess which began last Thursday and was to have extended until April 13.

Issuance of emergency fleet orders at Malta and the sailing of the battleship Malaya from Manton, France indicated to some observers that Britain might be preparing to protect the Greek coast.

All British naval officers on holding in Tangier, Morocco were ordered to return to their ships immediately.

A Greek spokesman here said that Britain had not been asked to send ships to protect Greek ports, which are important to the safety of the British-French trade routes through the Mediterranean.

Chamberlain's message to Premier Mussolini, said to have been conveyed by the Earl of Perth, British ambassador to Rome, was reported to be that Britain would "consider any attempt to seize Corfu as a cause for war."

College To Stage 'High School' Day

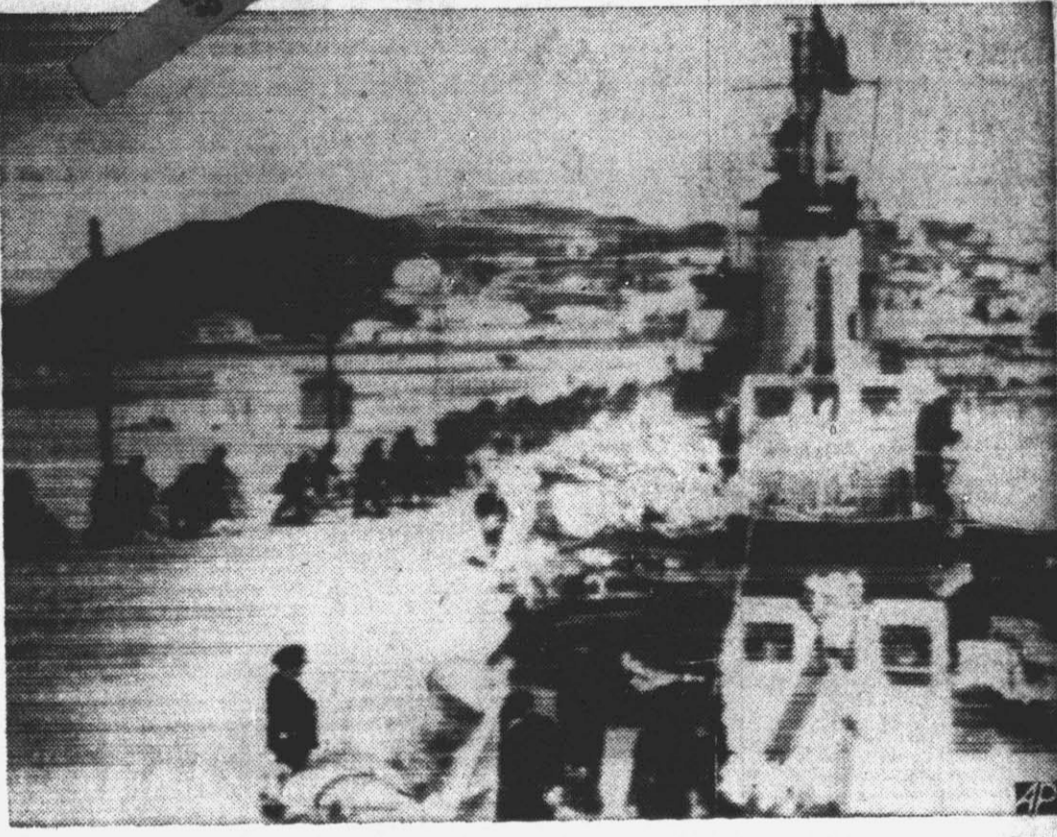
Final preparations are being made today on the E.C.T.C. campus for showing the three thousand visitors to High School Day tomorrow some of the work and some of the play which are a part of college life.

POST REFUSED BY APPOINTEE

Amlic Declines Nomination to ICC Membership

Washington, April 10.—(AP)—Thomas R. Amlic, former Progressive member of the House from Wisconsin, asked President Roosevelt today to withdraw his nomination as a member of the Interstate Commerce Commission.

It was understood the President would accede to his wishes.

It was made known officially that the President would reply to the request during the day and would send to the Senate tomorrow the withdrawal request.

The White House would not make public Amlic's letter to Roosevelt. It was also said that the President's reply would not be given out by the White House.

The Amlic nomination ran into a storm of opposition in the Senate Interstate Commerce committee.

Coincidental with word that Amlic had asked withdrawal of his name, some senators heard that the President might nominate former Governor Elmer Benson of Minnesota to the ICC post.

Much Uncertainty Over New Slot Machine Law

Raleigh, April 8.—There has probably been as much editorial and public forum comment about the "slot machine act" as about any one item of legislation considered in the 1939 general assembly. As a matter of fact, there is no "slot machine act." The only reference to slot machines is found in Section 130 of the Revenue Act, and there is wide divergence of opinion as to just what that section permits and what it forbids in the way of slot machines. It is the opinion of many legislators and of some state officials, who decline direct quotation, that it will take a supreme court decision to determine the legality of certain types of amusement slot machines.

One thing all agree upon: The "one-armed" bandits are still outlawed. By no stretch of meaning can the phraseology of the licensing act be construed to legalize this type

Would Be To Assure Cooperation With Allies

Paris, April 10.—(AP)—France and Great Britain were reported today to be considering joint military and naval demonstrations to back up their eastern European allies against further Italian-German expansion.

A two-hour extraordinary meeting of the French defense council on Easter Day, when Edouard Daladier, premier and national defense minister, consulted commanders of the French army, sea and air forces was said by informed sources to have been concerned with such demonstrations.

There was no hint in the press or official quarters as to what form such measures might take. It was said that the defense chiefs met to plan "preparations for all eventualities" and that "this is not the time for statements, but for military measures to complete preparations."

After the meeting Daladier conferred with British ambassador Sir Eric Phipps and Foreign Minister Georges Bonnet.

College Building Is Showing Progress

With the foundation already laid work on the new \$330,000 classroom building at East Carolina Teachers College is progressing rapidly.

Present work on the project, made possible through a federal appropriation, is confined to setting up window frames on the foundation.

When completed, the building will be one of the most up-to-date on the campus. It is tentatively planned to house the science and home economics departments on two floors of the three-story structure.

Workmen plan to begin pouring concrete some time this week on a paving project near the new building. The new paving will begin at the science building, go by the new building around the power plant, and rejoin itself. Additional paving is not anticipated for the campus any time in the immediate future.

BUSINESS HURT BY WAR SCARE

Hull Makes Statement After Talking With F. D. R.

Washington, April 10.—(AP)—Secretary Hull called attention today to economic dangers attending threats of war in Europe.

Talking to newspapermen shortly after a conference with President Roosevelt, Hull said the European situation was keeping business people hopelessly alarmed about the future.

Hull said that as a result of the tension, capital was stampeding out of Europe by the billions of dollars and purchasing power there was drying up enormously. This, he said, had affected the prices of goods bought and sold throughout the world. Repercussions, he said, were being felt by all nations.

A State Department official, meanwhile, said that despite the discouraging international economic outlook, the department would push forward the negotiations of trade agreements.

Congressional leaders decided to lay before President Roosevelt the controversial problem of drafting a new neutrality policy. He arrived at the White House today.

New York, April 10.—(AP)—Mrs. Grover Cleveland Bergdoll, wife of the notorious World War draft dodger, announced on her arrival from Europe today that her husband would sail next week from Germany to surrender himself to military authorities and serve the remainder of the five-year sentence imposed on him before his escape in 1919.

Mrs. Bergdoll arrived with four of her five children. She went to Europe last December with the announced intention of persuading her husband to return to America.

Bergdoll fled from military guards after he had been sentenced to five years in prison for evasion of the World War draft. A warrant for his

REQUEST HELP OF ROOSEVELT ON NEW POLICY

Turn to President for Advice on Neutrality Act

LINDBERGH ALSO ASKED TESTIFY

Leaders Declare War Threats Abroad Necessitate Re-enactment of Present Law

Washington, April 10.—(AP)—Alarmed by unsettled conditions in Europe, congressional leaders turned to President Roosevelt today for help in drafting a new neutrality policy.

They decided to lay the controversial problem before the chief executive as soon as he arrived from a vacation at Warm Springs, Ga., where he held a crowd at the railroad station yesterday. "I will be back in the fall if we don't have a war."

As the Senate Foreign Relations committee resumed hearings on neutrality proposals, administration lieutenants decided that war threats abroad necessitated the temporary re-enactment of the "cash and carry" provisions of the present law before they expire May 1.

Today's session was postponed because of the death of Senator Lewis of Illinois.

There was a wide divergence of congressional opinion over a permanent neutrality course, ranging from a ban on all arms shipments to broad authority for the President in regulating commerce with warring nations.

The House Foreign Affairs committee will begin neutrality hearings tomorrow.

Acting Chairman Bloom (D-N.Y.) invited Colonel Charles A. Lindbergh to present his views when he reaches the United States late this week.

Bloom sent a radiogram to the aviator, who sailed from France unexpectedly on Saturday. Chairman Sheppard (D-Tex.) of the Senate Military committee, also was considering Lindbergh to testify before his group.

Under the "cash and carry" system belligerents can buy certain American products only by paying cash and transporting them in foreign ships. Some senators want to place in this category all arms and munitions, sale of which is now banned entirely, whenever the President finds a state of war exists.

Tax Evasion Suit In Dramatic Close

New York, April 10.—(AP)—The income tax evasion trial of John Torrio, former Chicago underworld leader, came to an abrupt and dramatic close today when Torrio and two of his four co-defendants pleaded guilty.

Pleading guilty with Torrio were his brother-in-law, William Slock-bower and James La Penna.

When their pleas had been recorded, Federal Judge John Clancy declared a mistrial for the other two defendants, Louis La Cava and John D'Agostino.

Torrio was a one-time crony of Al Capone during the early days of prohibition in Chicago.

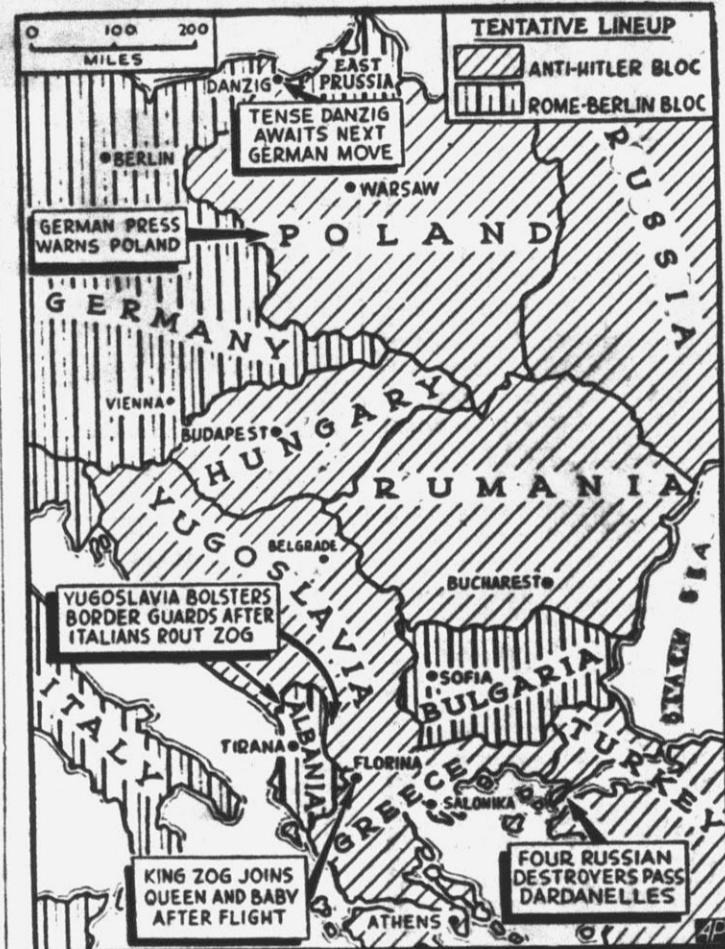
Negro Ordered Held In Fatal Road Wreck

PLAN FUNERAL FOR SEN. LEWIS

State Rites To Be Conducted in Senate Chamber

Washington, April 10.—(AP)—A state funeral in the senate chamber was arranged today for Senator James Hamilton Lewis, who died last night of a heart ailment.

Senate officials said the funeral would be held tomorrow or Wednesday probably at noon. Burial in Arlington cemetery will follow.

President Roosevelt, members of the cabinet, the House and the diplomatic corps have been invited. Leaders arranged to adjourn the senate at noon today out of respect of the veteran Illinois senator, who served as Democratic whip.

The chamber will not resume legislative business until Wednesday or Thursday.

Governor Hoey Received No Plums From Assembly

Raleigh, April 10.—Although the governor is credited with having exerted more influence over the recent legislature than any governor in his mid-term session in years, the fact is Governor Hoey got out of the legislature no important political plum to hand out to some friend, or to use as a trade for legislation.

It is further true, despite the popular belief that the state is overburdened with superfluous commissions, that this legislature was not very commission minded. Fewer good jobs were created by the 1939 assembly than by any session in many years.

Eight senate bills and five house bills providing for commissions or appointments by the governor were enacted into law, but only one of the appointments carries any full time salary and that is the lowest state salary bracket. All of the oth-

FARMERS FEEL COSTS OF WAR

Wallace Makes Plea For Farm Appropriations

Washington, April 10.—(AP)—If war comes and whether America keeps out of it or not, Secretary Wallace said today, it will cost this nation huge sums to keep its farms going.

"If an isolation policy is our main objective," he told a Senate Appropriations sub-committee, "we must prepare to use vast sums of money to subsidize domestic consumption, to store surplus and to maintain farm income."

Even peaceful nations are sharply affected if others fight, he said. His statement was given in a closed meeting of the committee. It was made public by the Agriculture department.

"Such costs," he said, of burdens borne by non-belligerents, "will be small, of course, in comparison with the cost of war itself. But the cost of peace in a world at war can be much greater in the case of agriculture than in any other industry."

Such a cost is as properly a part of our national defense as the army and navy appropriations.

At his request, the sub-committee deferred until Thursday consideration of a proposed \$400,000,000 in additional farm benefits.

PREMIER FAILS REACH TIRANA

Provisional Albanian Government Formally Accepts Italian Rule, Pledges Loyalty of Its People and Praises Mussolini for Taking Over Control of Nation

Tirana, April 10.—(AP)—The provisional Albanian government pledged today the loyalty of the Albanian people to Premier Mussolini and formally accepted Italian rule on their behalf.

The President and Secretary of the administrative committee broadcast loyalty addresses to Albanians and to Italy.

Contrary to expectations in Tirana, Mussolini had not arrived in time for the broadcast and it was doubtful that he would come today.

The "appeal" of Albanian leaders to Mussolini to permit them to found an Albanian Fascist party also was read over the radio.

"We express our thanks for your (Mussolini) sacrifices which have saved the Albanian people from so many dangers," the appeal said.

"For the past 26 years we have had a bad administration in Albania and have shown that we have been incapable of governing ourselves," said the President of the provisional Albanian government committee set up by Italians.

"This state of things led us to peril, that of Albanian disunity. Our sole hope was that the beloved and genial person of Il Duce, who has made moral and material sacrifices for us and has liberated Albania from her peril."

"The army which comes today is an army sent by Il Duce and it comes as a friend, not as an enemy."

"Beloved Duce, you have made many sacrifices for us and have saved us from many perils and for this reason we address to you for whom all is possible and of whom we have no right to ask anything, to you who have given us that all that you save the Albanian people."

GIVE FACTS ON USE OF POTASH AS FERTILIZER

There can hardly be a doubt in the minds of those who are at all familiar with conditions in North Carolina that both the quality of tobacco and the yield per acre might be greatly improved in most cases by the use of fertilizer mixtures recommended by the Official Committee of Agronomists of the United States Department of Agriculture.

The efforts of the committee were directed towards developing fertilizer practices which will insure satisfactory yields, improved quality and larger returns from the growing of tobacco.

According to E. G. Moss, assistant director in charge of the Oxford tobacco station, and James F. Bullock, assistant agronomist United States Department of Agriculture, potash is one of the most important plant nutrients in the production of bright tobacco and the liberal use of it is highly desirable.

WRECKS CLAIM SMALLER TOLL

Five Killed on Eastern N. C. Highways In March

Five persons were killed on highways of Eastern North Carolina during March compared with six during the previous month. The figures were released today by Lieut.

Lester Jones head of Troop A of the state highway patrol. The patrolmen in the Troop investigated 36 highway accidents in March in which 22 persons received non-fatal injuries.

Comparison of the figures shows fewer accidents for March than February both fatal and non-fatal. Arrests made in March totaled 335, of which 52 were on charges of driving drunk.

The combined force traveled 114,589 miles. Other activities included vehicles inspected, 1,817; lights corrected 1,925; warnings issued 37; courtcases extended 387 cars covered, three; vehicles stored, 22; vehicles weighed 289 with 168 found overloaded; complaints investigated 295; citations issued, 283.

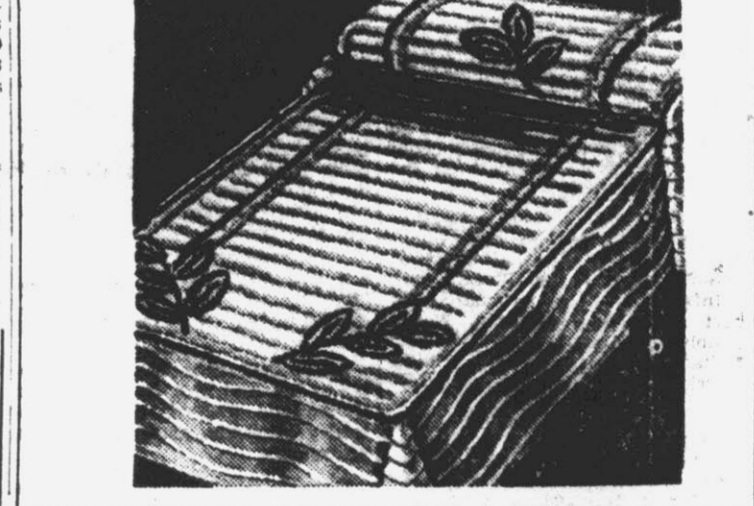

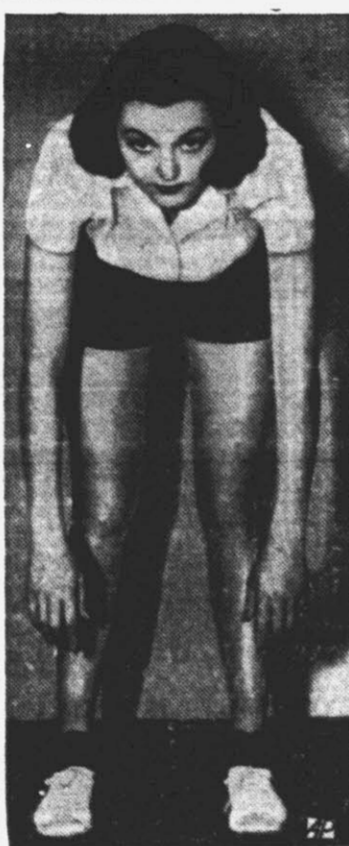
The new little-girl frocks demand little-girl posture—head up, shoulders back.

LETTER TELLS OF FAR EAST

Stuart Carr Writes an Unusually Interesting Letter

Stuart Carr of Greenville, who at the present time is in the Far East as representative of the E. B. Ficklen Tobacco Company, has written a letter which will be of much interest to his friends here. The letter follows:

Dear Dave: Saturday, the third, was by far the most interesting day experienced since I departed from the "Best Tobacco Market in North Carolina," on July 24, 1938.

I had arrived at Singapore on the second and the following morning a friend took a car with me to go on a tour.

We left the Raffles Hotel for Johore, a distance of seventeen miles and a small state ruled by a Sultan. A few miles out of Singapore are several pineapple groves or plantations, as they might be called. Pineapples grow in rows about two feet apart and are very thickly planted. They are not re-seeded but grow out the tops of other pineapples when they are cut and stuck in the ground. Ten months is required for these tops to root and bear. After that time the plant may be cut twice each year for about three years before another replacement is necessary.

A short ways farther down the highway we encountered rubber plantations. Upon investigation our guide informed us that the liquid begins to run from the tree after the same has been growing for seven years and under normal conditions the sap continues to drip for thirty more.

Rubber trees are planted about ten feet apart and in rows twenty-five feet distant. There is very little activity in the rubber market at present and many of the trees are not milked at all. From one of them the sap had leaked down the side and had dried into a string-like form. I pulled the cord from its end to the source on the tree and found it to be as elastic as a rubber band. Amazing.

The milk is caught in small cups, the same fashion as is our turpentine, poured into a vat, mixed with an acid which allows rubber to form around a slab. It is then stamped with the name of the owner and sent in soft slabs of 18x36 inches to a refinery.

After seeing this, I could not help but recall my illusions as a boy in thinking that rubber came from the entire trunk of the tree rather than from the sap.

We next proceeded to Johore, located on the Malay peninsula across the island from Singapore.

Johore is a state rich in tin deposits and rubber plantations, ruled by the high and mighty Sultan. This office has been in the family for generations, the title being handed down at the death of the reigning monarch to his nearest male relative.

Fortunately for us, the Sultan was in England and with a little "cum-

shaw" we persuaded one of the servants to show us through his luxurious palace. In all he contains three palaces but this particular one is where most of his time is spent.

I have never seen the like of trophies. There were many very dear presents which his subject had possibly given to remain in good graces. Practically every conceivable kind of treasured oriental product was in his trophy room. Also there were many stuffed tigers, birds and game which the Sultan himself has killed. In one of the many pictures adorning the rooms, the Sultan is shown with eight dead elephants in one heap, supposedly his bag for one day.

The palace has one "gold room" in which is housed complete dinner sets for about fifty guests. Many of the composites, bowls, etc., are touched up with borders or designs of very expensive jewels. We inspected the many elaborate-

ly furnished bedrooms, banquet halls, meeting rooms, etc., but lastly the room housing the thrones of the Sultan and his wife.

No doubt you know what is coming next—the most exciting part was when I sat on the Sultan's throne (yes, WITHOUT the crown). This trip has been intensely interesting all of the way. Many sights seem almost incredible to me, but I guess it's just that we do not have them in the dear old U.S.A.

At present I am in Penang, an island off the coast of upper Malaya. I came up by plane (4 hours) from Singapore this morning.

Incidentally, Dave, I miss the old reliable "Reflector" like a front tooth, but hope to be reading it again very soon.

Washington Daybook

By Preston Grover

Washington—The man who moves the big circus tent has come to the aid of the dispossessed farmer. It is one of the few bright novelties in a migrancy problem drab and dreary in almost all other respects. It came about this way. There are 50,000 to 75,000 roving farm families, mostly in California, "following the crops." They stop a few days to cut and crate lettuce. Then they move on to the carrot fields, then to hoeing potatoes, and to the harvest of figs and oranges. Each job may last only a few days for the majority of the 250,000 to 300,000 men, women and children. To most of them it is a far departure from the farm homes they lost in the drought and dust bowl, humble as they may have been. For months on end they have lived on ditch banks, drinking ditch water, and living under conditions the Farm Security Administration describes as miserable almost beyond belief.

Operate Circus Style
But the old circus technique has come as a partial relief. Farm Security found an engineer, George D. Harrington, once with Barnum and Bailey circus. He had also engineered for the Southern Railway and for the army.

He planned for Farm Security administration a series of moving camps which would follow the migrant farm workers and his family as they followed the crops. Each camp can be picked up—tent floors, shower and sleeping rooms and the other necessary camp facilities—in eight trucks and moved 60 miles or more to the next spot.

Some Permanent Camps
For a few lucky migrants, 14 permanent camps have been established, where wooden floors are set up in rows over which the fugitives from the farm belt can pitch their tents. In each of these 14 camps, ten of which are in California, some 50 families become permanent residents, each with a small plot of ground upon which they raise vegetables.

But at best, these devices are designed only to relieve the misery while more permanent aid is developed. A sample of the more permanent aid which may grow up is on the noted Tagus farm run by "Clint" Merritt in California.

While most California farming is on a mass production basis demanding peak supplies of labor at planting and harvest time, Merritt has diversified his crops so that peak demands are reduced. Each crop has a different planting and harvest time so work for 300 families is provided on the 7,000.

But at best the Tagus farm, the moving camps and the permanent camps barely touch the problem. The government does not know what to do with these wanderers, nor does California, nor seemingly anybody.

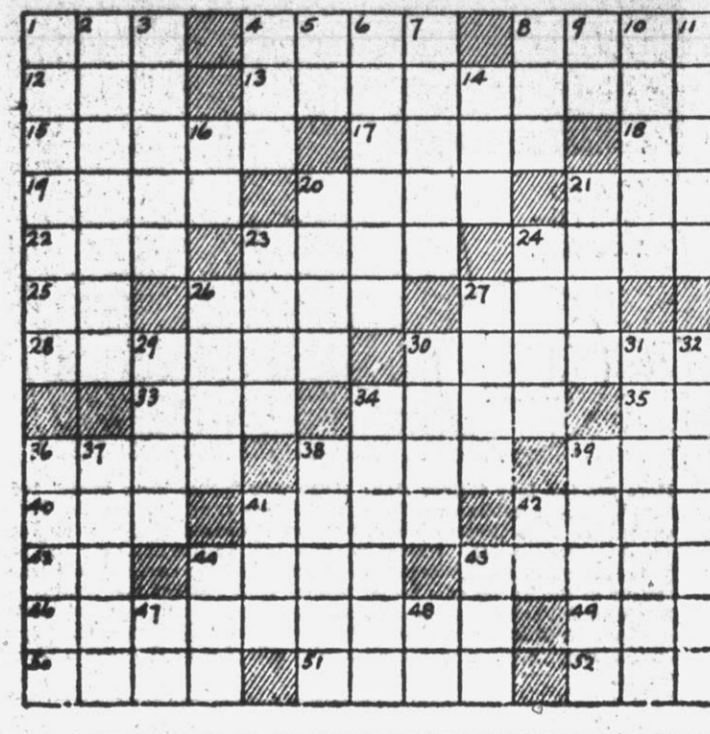

compensation and the other six will get the same per diem they draw for attending their regular board meetings.

The governor will have the privilege of naming two purely honorary commissions—one to assist in observing the one hundred and fiftieth anniversary of the University of North Carolina, and one to help Duke University observe its one hundredth birthday. These commissions will have little to do—and will get little for it.

Five commissions are to be named to study and report back to the legislature or to some state agency as to findings of fact and recommendations for action.

One commission will study the feasibility of establishing a nautical school, as a unit of the Consolidated University. The school would be established, if at all, somewhere on the coast and membership on the commission is expected to be eastern.

The legislature didn't enact any wages and hours laws at the recent session, but authorized appointment of a commission to give further study to the question and recommend action for the 1941 session.

The deplorable situation in Swain and Haywood counties in the far west and of Hyde county in the east—brought about by taking so much property off the tax books by establishment of federal park areas in the county, called for legislation authorizing a commission to study the situation and recommend action for relief. Small appropriations were made to defray expenses of the commission and the members will draw per diem pay for the time actually spent on the job.

The teachers' and state employees' retirement bill is in almost exactly the same fix as the wage-hour legislation. Nothing was done about it except a commission was authorized to study and report at the next session.

The problem of education for exceptional children also requires commission study. In the opinion of legislators and a group will be named to perform that service and let succeeding legislatures know what they find out in the matter.

Finally, commissions were authorized to assist in establishing and maintaining the Cape Hatteras Park and the Cape Fear Park. Like most of the others, these appointments are more honorary than remunerative and the chief emolument will be getting names printed on nice looking stationery.

In addition to the honorary commission appointments listed in the foregoing paragraphs there will be several new positions to fill after July 1st, but they will be in departments and while the governor doubtless will be consulted, the real appointment will be made by the department or division head.

The legislature itself also named one or two commissions, notably one to assist Fayetteville in observing the sequi-centennial of ratification of the federal constitution.

On the whole, "pickings" for the governor and his friends are mighty meager as result of 1939 legislation.

MUCH UNCERTAINTY OVER NEW SLOT MACHINE LAW (Continued from page one) hince largely upon the definition of "per se gambling devices," according to state officials.

As a section of the revenue act—the purpose of slot machine license is frankly to raise money. In attempting to put the rate too high, the legislature virtually gave a monopoly on the slot machine business

to one or two companies. The first tax levied is an occupational tax of \$1,000 to be paid before any manufacturer or distributor can sell, lease, farm out, or place on percentage any vending machine. That automatically cuts out several little distributors. There are several other taxes applicable to distributors of the various types machines, rendering estimates of revenue rather uncertain.

The licensing tax to be paid on each individual machine ranges from a minimum of \$5 on the smallest pool tables to as much as \$500 on amusement machines requiring deposit of a dollar or more to play. Counties, cities and towns may levy half as much as the state collects.

The bone of contention in the whole slot machine section is found in the last paragraph of sub-section 5, which says: "It is the intention of this section to license and permit the operation of only legal machines as defined in Section 1 of this section and not the intention to license or legalize any gambling machine or device, or any other machine in connection with the operation of which there is given or allowed any premium, prize, coupon, reward, refund or rebate." And a further proviso states that it is not the intent of the section to legalize any machine which is per se a gambling device.

Proponents of the bill contended at the time it was under consideration, and it is now believed by officials, that this does repeal or modify the Planagan Act in any serious respect, and that it does not, as some editors have charged, throw the slot machine business wide open. It is extremely difficult, however, to find any responsible official who will permit direct quotation when he expresses an opinion.

Summarized, the situation is just about this: Nobody knows what the slot machine law will be after July 1st.

The new board will have policy-making power for the banking departments. About half its membership is ex-officio, composed of state officials. Compensation for members of the commission is fixed at the same figure as that drawn by members of the budget commission. Under continuing act the governor also will name several members of the budget commission, though most of that group is ex-officio.

Another group with advisory and some elements of administrative power is the commission for coordination of activities of State College and the State Department of Agriculture. This commission will be composed of five ex-officio members and six appointive, but the eligibility of appointive places is restricted. The governor is chairman, and on the group will sit the president of the Consolidated University, the dean of administration at State College, the commissioner of agriculture, the assistant commissioner of agriculture, and three members each from the board of trustees of the university and from the board of agriculture.
