

CZECHS FACED BY THREAT OF PRAGUE NAZIS

Threatened with New Steps To Break Resistance SEEK DETERMINE POLICE SLAYER

Not Known Whether Killing Grew Out Of Political Tension or Private Quarrel.

Prague, June 10.—(AP)—Nazi officials today threatened new "measures" to break Czech resistance to Germany's protectorate over Bohemia and Moravia unless the mysterious killing of a German police sergeant in Kladno Thursday was solved by 8 p. m. (2 p. m. EST).

While German authorities questioned a young Czech woman and pressed a search for the slayer of the sergeant, Nazis of industrial Kladno prepared a spectacular tribute to the slain officer.

Kladno, its Czech community fined 500,000 crowns (\$20,000) and disciplined by a stringent curfew, the closing of its schools and the removal of civic authorities, speculated on what new restrictions might be imposed.

The warning that they would be issued by police at the office of Baron Von Neurath, Reich's protector of Bohemia and Moravia. Kladno authorities, after questioning the woman, who is a hospital nurse, said they had accurate descriptions of at least two men involved in the incident.

They had not established, however, whether the killing grew out of political tension between Czechs and their Nazi "protectors" or from a private quarrel.

The body of the policeman, Sergeant William Knies, was returned from here where a post mortem was performed yesterday. To Kladno, German comrades held a short memorial service for Knies.

STATE ENACTS TOBACCO LEVY

Wrong Bill, However, Seek To Correct Situation

Concord, N. H., June 10.—(AP)—Frustrated with the knowledge that the legislature had enacted the wrong tobacco tax bill into law, New Hampshire officials studied possible means today of correcting the situation.

Melvin Morse, legislative counsel for Governor Francis Murphy, who signed the measure without noting the error, expressed the confidence the legislature itself would act swiftly to remedy the mistake.

Attaches of the governor's office, in the absence of the chief executive, said also the error could be easily corrected by amendments which, they added, probably would be introduced in the House and Senate next Tuesday. The amendments, they said, would bring the bill in line with the intent of the governor.

Members of the governor's staff explained that the legislature debated the proper bill, but that the copy of the Ways and Means committee sent the wrong bill to the crossing committee.

William Neal, master of the New Hampshire Grange, checking into a minor point into the law, detected the fact that the act, which levied a 15 per cent tax on tobacco products sold in the state, was not the one which included a section directing that the revenue, estimated at about \$1,000,000 a year, be used to lower real estate taxes by abolishing the annual \$1,300,000 state levy.

It was proposed that the channel which is to run from Washington to Hardee's creek be extended to Tarboro to provide water transportation for that city.

The statement sets forth that the principal grounds upon which the adverse conclusions are based are that it would be impracticable to obtain a navigable channel without the construction of locks and dams, and that the cost would greatly exceed the benefits that might be expected from the improvement.

B. B. Sugg Named Vice-President of Eastern Asso.

The Eastern Carolina Tobacco Warehouse Association, in regular meeting in Wilson yesterday, adopted a resolution urging an earlier opening of the market this year.

The association also urged continuation of the seven-hour working day in preference to the proposed shorter day.

W. E. Fenner of Rocky Mount, was elected president of the association, and Vice-President Sugg was selected as one of the delegates to the U. S. Tobacco Association meeting, J. S. Picklen, president of the United States Association, was a guest at yesterday's meeting. Also present were R. M. Gerritt, president of the national association sales committee, and F. F. Arnold, executive secretary of the North Carolina Farm Bureau Federation.

Predicting that not less than 950,000,000 pounds of tobacco will be grown this year, and "probably more," Sugg started off the meeting with an explanation of the question the association was to discuss. He told the association that it was approaching "the greatest crisis ever to face the tobacco industry" and urged that "you take the opportunity to solve your problems in a united way."

J. E. Winslow of Greenville, president of the North Carolina Farm Bureau Federation, a guest at the meeting, told the warehousemen that "I want the set up to stay as it is. We farmers are satisfied with it except one thing."

This "one thing," Winslow declared, "is a fair division out of the industry. We do not ask for an exorbitant price but we want a fair price. We want returns in line with what we ought to have."

C. T. Hall, chairman of the tri-state advisory committee of the Department of Agriculture, urged better understanding among the growers, warehousemen and buyers and good-will within the industry as a whole.

Representatives of other belts at the meeting reported that their associations already had voted in favor of earlier openings. The resolutions will be presented to the United States Tobacco Association when it meets on June 29 in White Sulphur Springs, W. Va., to select dates for openings.

Designed To Lighten Burden Imposed On Business

Washington, June 10.—(AP)—The House passed and sent to the Senate today a far-reaching series of amendments to the Social Security law designed to increase and extend its benefits and lighten the burden it imposed on business.

Pain passage came after the House shouted down a Republican attempt to send the measure back to the House Ways and Means committee. The motion to recommit was offered by Rep. Carlson (R-Kan.). Chairman Doughton (D-N. C.) demanded a roll call vote on passage.

The amendment would freeze the present payroll tax rate for old age insurance at one per cent for the next three years. It previously was scheduled to increase to one and a half per cent next January 1.

Benefits of the law would be extended to employees of national banks, seamen and employed persons over 65 years of age, adding a total of about 1,100,000 to the rolls.

Officials estimated the freeing of the tax rate and other changes offered potential savings to employers and workers of about \$1,710,000,000 in the next three years.

FRANCE HEARS HITLER PLANS TO TALK PEACE

Official Confirmation Of Proposal Lacking, However

BERLIN CIRCLES ALSO UNADVISED

Proposal Said To Involve Specific Propositions to France, Britain and U. S.

Paris, June 10.—(AP)—Reports reached French diplomatic circles from usually well informed sources in Berlin today to the effect that Adolf Hitler was preparing specific propositions to France, Britain and the United States for settlement of the problems which are causing world war fears.

The reports, which received no open and official confirmation, said that Hitler was expected to make the proposals in a speech during the early part of July after launching of a new German warship.

He now is working on them, the report said, but there has been no hint of their nature.

Some diplomatic circles recalled the House of Lords' speech of Viscount Halifax, British foreign minister, Thursday night, in which he told of Britain's willingness to examine such problems at the conference table if Germany would renounce any threat of force. Diplomats said that his speech might have been the key to the Reichsfuehrer's reported decision.

Diplomats in Paris said they were unable to reconcile the reports of Hitler's plans with continuing German press attacks against the British foreign secretary's speech.

Berlin, June 10.—(AP)—Sources close to Chancellor Hitler today described as a "surprise to us" the reports in Paris that the Reichsfuehrer was planning specific peace proposals. These sources said that so far as they knew the chancellor had no such plan in mind.

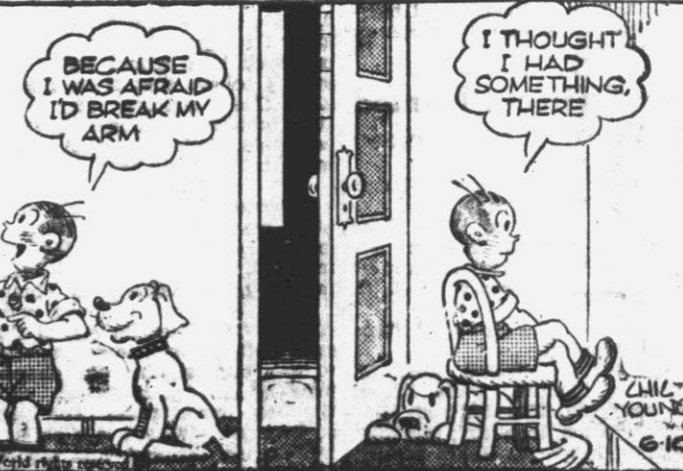

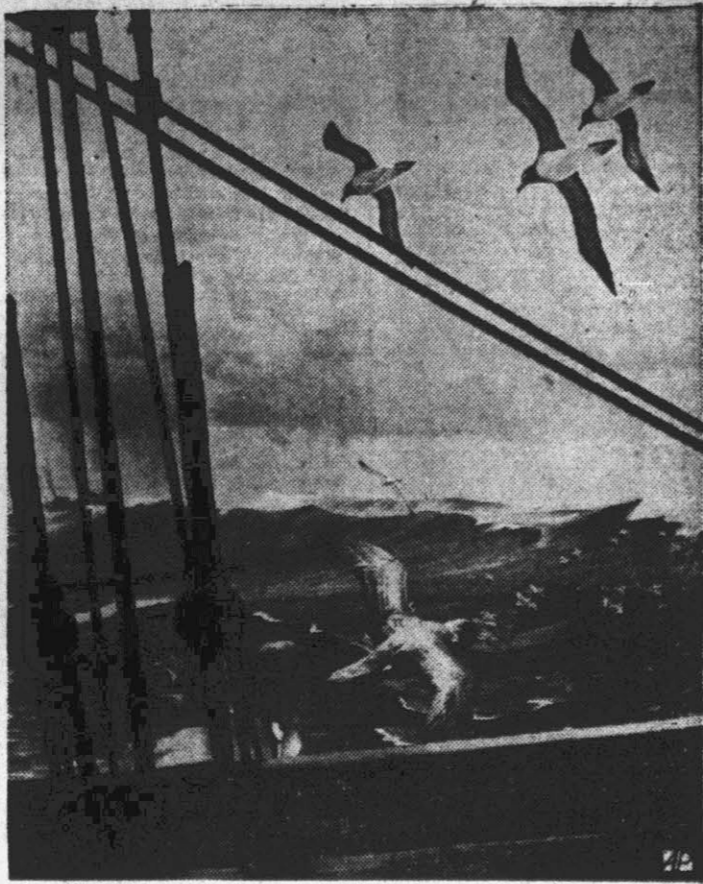

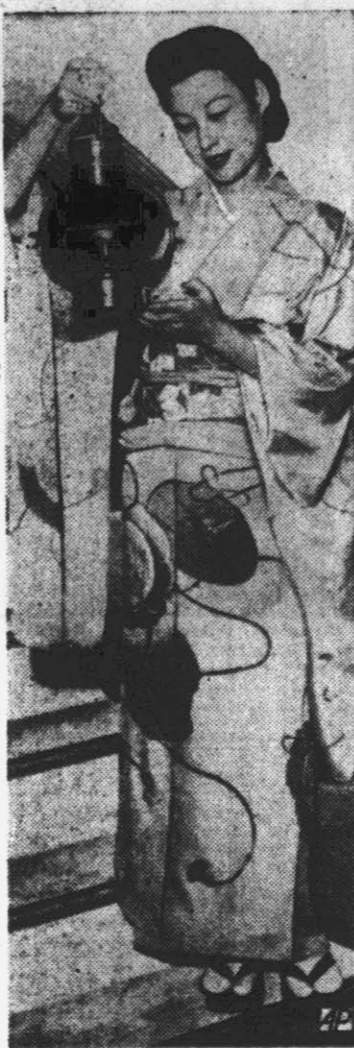

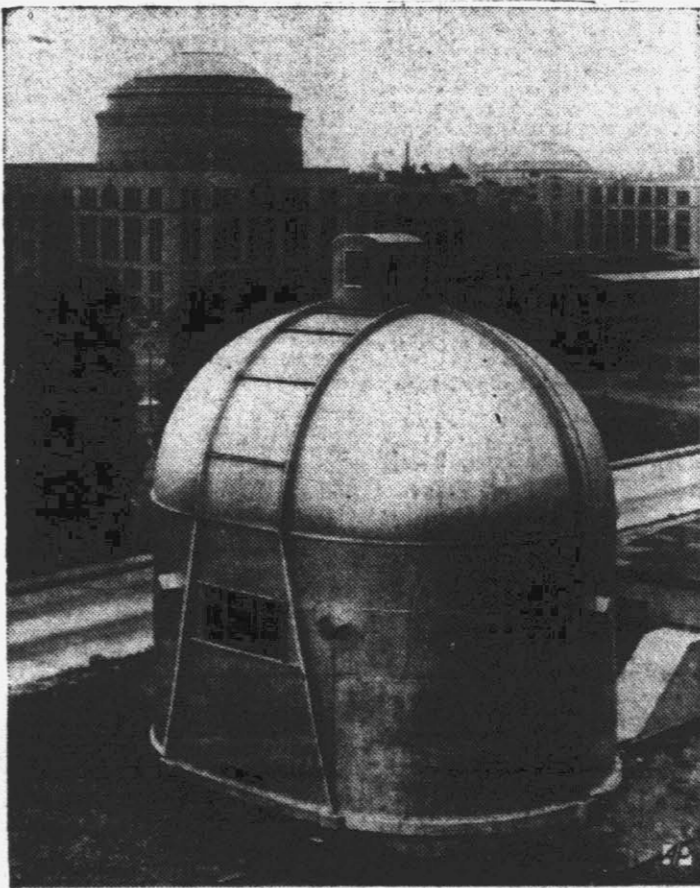

Hicks, or Nix, or something, who said he is an official of the North Carolina Journeymen Barbers, called from Durham Friday morning to take exception to the story which this correspondence sent out regarding a fight made on the reappointment of N. C. Whitney of Winston-Salem as a member of the State Board of Barber Examiners.

To hear him talk the master barbers and the journeymen are closer together than a politician and the pork barrel; there has never been any discord among or between them, and everything is now, has been and forever more will be sweetness and light.

Just the same there was such a fight made—though perhaps not by Mr. Hicks, or Nix, or something—and not only that, but there is now a movement on foot among the journeymen barbers to "recall" the entire Board of Barber Examiners. The recallers claim this is possible under the statute.

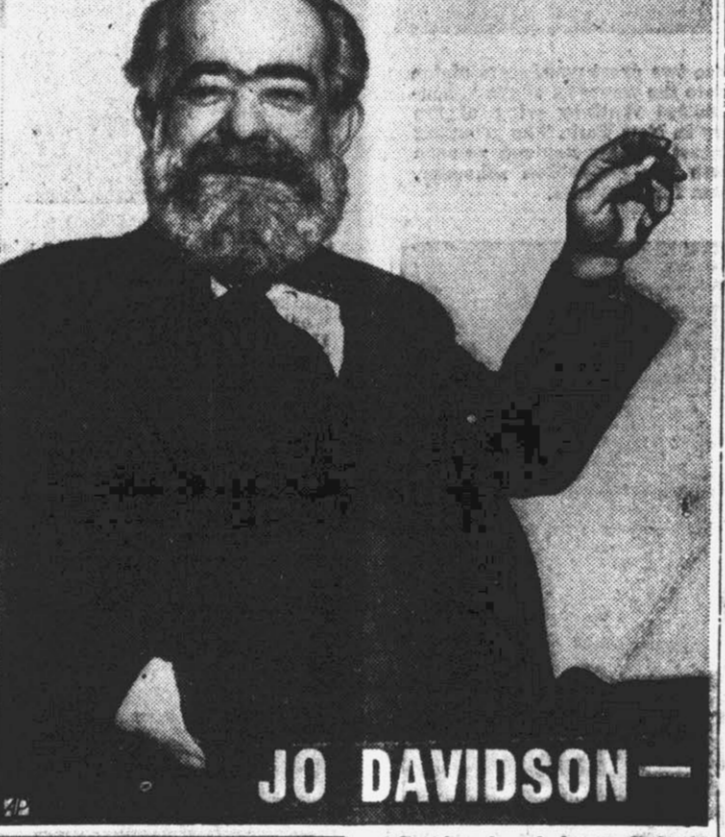

STRIKE TIE-UP IS THREATENED

A. F. of L. Demands Are Made On General Motors

Detroit, June 10. (AP)—The A. F. of L. automobile workers threatened today an intensive tie-up of General Motors plants if the corporation does not open collective bargaining negotiations with it.

Harold Dowell, head of the UAW faction headed by Homer Martin, been re-elected in the old American Federation of Labor charter when it called strikes in three General Motors plants at Flint and Saginaw.

The management denied, however, that the strikes called Thursday were effective, and R. J. Thomas, president of the rival UAWA branch affiliated with the CIO, said they were "a complete failure."

Dowell added that the A. F. of L. UAW declared that "contrary to reports the plants in Flint are down and the Saginaw plant will be closed down if it tries to operate."

He referred to the Chevrolet assembly plant and the Fisher body plant number one at Flint, and the Chevrolet gray iron foundry at Saginaw.

"If negotiations are not started," Dowell added, "a sufficient number of plants will be shut down to see that negotiations are begun."

Raleigh, June 9.—The most arresting thing in connection with the parole hearing Thursday for Fred Beal, the famed Gastonia case convict, was the complete lack of ven casual public interest.

that under the North Carolina plan the counties pay one-fourth of total Old Age grants and one-third of grants to aid dependent children. County boards realize that the more they get for the aged and for the children in their units the more each unit will have to contribute to the fund.

Mrs. W. T. Best, commissioner of Public Welfare, and Mr. Yelton are hopeful that Federal provisions for old age and children's aid benefits will be liberalized to such an extent that there will be available for North Carolina an additional \$525,000 for the children and perhaps an additional million for the aged.

Amendments to the existing laws are now being considered which, if finally approved, would give this state the additional funds.

As it is, North Carolina stands far, far down the list in payment to its aged and to its dependent children. For old age assistance, it
