ANNOUNCE AIM TO NEGOTIATE TIENTSIN ROW

Talks Between Japs And Britons To Start Soon

FACT REVEALED BY CHAMBERLAIN

"Intolerable" Treatment of Britons Expected To Cease In View of Parley

London, June 28.—(AP)—Prime Minister Chamberlain announced today that negotiations would start immediately in Tokyo "to effect the settlement of various conditions relating to Tientsin."

He told the House of Commons that in view of Japan's agreement to begin discussions, the British government assumed that Japanese soldiers' treatment of British subjects, which last week Chamberlain called "intolerable insults" would cease.

"There is reason to hope that that will be the case," the prime minister said.

Earlier the cabinet had received news of Japan's readiness to open negotiations and had approved Chamberlain's statement to Commons.

This statement was similar to the communique issued earlier by Tokyo. Chamberlain said, "I am now able to announce that as a result of an exchange of views between his majesty's government and the Japanese government it has been agreed that conversations shall take place at Tokyo in order to effect a settlement of various conditions relating to Tientsin."

He added that the talks were expected to begin at once.

Tokyo, June 28.—(AP)—The Japanese government announced formally today that at the request of the British government it would negotiate with Britain at Tokyo on arbitration of the two-week-old Tientsin dispute.

Chamberlain hoped the negotiations would be limited to the Tientsin controversy, but the Japanese were determined to include the question of British support of Japanese currency.

Sarah M. Collins Claimed By Death

Miss Sarah Margaret Collins, 22, died in Pitt General Hospital last night around 7 o'clock following a few days of illness.

Besides her father, surviving are five brothers, John Arthur Collins and James Edward Collins of Greenville, Raymond Lee Collins of Grifton, Ralph Stokes Collins of Maryville, Tenn., and Jack McRae Collins of Chesterfield, S. C.; also three sisters, Mrs. Lorenzo B. Tucker and Mrs. Mahlon G. Tucker of Greenville, and Mrs. Leo Veniers of Ayden.

Active pallbearers were Thomas Stokes, Matt Moore, Dr. Randall Smith, Howard Johnson, Mark Moore and Delmar Elliot.

To Hear Petition To Increase Fare

Raleigh, June 28.—(AP)—The Utilities Commission on July 12 will hear an application of the Seashore Transportation Company to increase bus fare between New Bern and Beaufort and Morehead City, C. H. Noah, traffic director of the commission, said today.

The present fare is 50 cents and a five cents increase will be asked. The Beaufort Chamber of Commerce is protesting the proposed boost, Noah added.

Production Testing For County Dairies

R. R. Bennett, Pitt county farm agent, today declared that tests are being conducted monthly at the Little Creek Dairy, Pecan Grove Dairy and the S. T. Lewis Dairy, all of Pitt county, for the purpose of increasing milk production of cattle. Bennett said that the tests gave the dairymen an opportunity to practice the most effective methods of increasing the milk supply of dairy cattle and to iron out the animals whose milk supply is not so high and which merely increase operating costs.

National Labor Board Decision Is Set Aside

Cincinnati, June 28.—(AP)—In one of the first high court decisions bearing on A. F. of L.-C. I. O. strife, the Sixth United States Circuit Court of Appeals today unanimously set aside a National Labor Relations Board order for a run-off election to determine the bargaining agents for 3,000 employees of the Consumers Power Company of Jackson, Michigan.

The case came before the tribunal on a petition by the International Brotherhood of Electrical Workers (A. F. of L.) to join the run-off. It was an offshoot of a NLRB case and desist order issued against Consumers Power as a result of alleged violations of the Wagner labor act. The company has appealed this and arguments will be heard next fall.

The board held an election in January. The Utility Workers Organizing Committee (C. I. O.) received 1,160 votes, the Brotherhood 1,072, but 506 workers wanted neither union.

The NLRB granted the UWOOC request for a run-off, but put on the ballots only a choice between the UWOOC and no union. This policy, it told the court, prevented men who wanted no union from having one "forced down their throats."

Mead Bill Would Insure Loans To Little Fellow

By PRESTON GROVER. Washington, June 28.—(AP)—The latest legislation intended to hit the jackpot of hoarded savings and broadcast them into the channels of hungry business is the Mead bill providing insured bank loans for small industries.

In a broad sense it is patterned after the Federal Housing Act under which the government insures 80 to 90 per cent of loans made by banks and loan companies for house building. In its preliminary hearings before a Senate banking committee it already is found to contain the usual grist of difficulties. Nevertheless there is better than a fair prospect that they will be met with revisions in time to permit the bill to get through this session. Part of the support for the bill is from banking groups who would oppose it except for the fact it is less obnoxious to

OPEN WAY FOR AGREEMENT ON FDR'S POWERS

Administration Beats Back GOP Opposition

BACKERS HOPE FOR COMPROMISE

Versions of Bill To Extend Monetary Powers Sent to Conference

Washington, June 28.—(AP)—Administration leaders beat down Republican opposition in the House today to keep the way open for a possible compromise of the Senate's drastic curtailment of President Roosevelt's monetary powers.

Rallying overwhelming Democratic support, they won a vote to send to a conference with the Senate conflicting versions of a bill to extend those powers beyond the Friday midnight expiration date.

The tally was announced at 209 to 161. The House previously had approved continuation of all of them. The Senate, however, rewrote the House measure to provide extension of the \$200,000,000 stabilization fund, but to end the President's power to devalue the dollar further and to buy foreign silver. It also voted to fix the treasury price for domestic mined silver at 75.50 cents an ounce.

The principal task before the conference committee, therefore, will be to find a way to compromise or compromise authority shall prevail.

Meanwhile the treasury cut its foreign silver price from 40 to 38 and a half cents an ounce. The second reduction in as many days followed the two policies of the treasury inaugurated within 24 hours after the Senate voted to forbid further purchasing of foreign silver by the treasury.

On Monday the foreign price stood at 43 cents. Other developments: The Bureau of Agricultural Economics estimated the 1939 spring pig crop at 52,314,000 head, an increase of 20 per cent, or 8,864,000 over the 1938 spring crop.

At Hyde Park, N. Y., meanwhile, 13 Democratic and nine Republican governors from states as distant as Arizona and Florida were President Roosevelt's luncheon guests.

At the suggestion of the President, himself a former governor of New York, speeches and politics were barred while the state executives sat at tables under the trees on the Roosevelt estate.

HOEY TO SEEK LONG HOLIDAY

Wants Two Days For Fourth; Banks Here To Close

The three Greenville banks, State Guaranty and Guaranty Dickinson avenue branch, will observe both Monday and Tuesday as a July Fourth holiday, it was revealed here this afternoon.

All other banks in the state also are expected to observe two days. It already has been announced that state offices will observe two days. The Fourth coming on Tuesday.

It was learned here this afternoon that Governor Clyde R. Hoey would issue a proclamation tomorrow calling on the citizens to observe both Monday and Tuesday as a holiday in celebration of Independence Day.

What other businesses other than banks will observe the proclamation was not known. The Greenville Merchants Association already has voted to observe only Tuesday, with the regular half holiday on Wednesday. Whether the governor's expected proclamation will influence the organization to change its plans was not known this afternoon and President O. P. Matthews could not be reached for a statement.

GOVT. TENANTS DUE BENEFITS

Farmers On Federal Lands May Share In Program

Raleigh, June 28.—E. F. Floyd, AAA executive officer at State College, explained today that farmers operating land owned or controlled by any federal agency are eligible to receive payment under the agricultural conservation program.

On the other hand, Floyd pointed out, land owned or controlled in the name of a federal agency will not be allowed to come under the 1939 program for payment.

Explaining the eligibility of private persons, Floyd said, "Any grower renting, leasing or carrying out farming practices as a sharecropper, share tenant, or cash tenant on land owned or controlled by any federal agency, whether or not wholly owned by the United States, is eligible for payment."

For instance, a grower operating a farm purchased through the Farm Security Administration can file for and receive payment for carrying out approved soil building practices.

However, should a farm be owned or controlled in the name of the federal agency, no payments will be made under the 1939 program for approved practices carried out on this land.

According to this ruling, payments cannot be made to the Community Credit Corporation, Federal Farm Mortgage Corporation, the Reconstruction Finance Corporation, the Farm Security Administration, the Tennessee Valley Authority, the Forest Service, Federal Intermediate Land Banks, regional agricultural credit corporations, and any other part of the executive branch of the government.

However, payments will be made to the Federal Land Banks, the Federal Deposit Insurance Corporation, Joint Stock Land Banks, production credit associations, banks for co-operations, national agricultural credit corporations, and similar establishments, since these agencies are not wholly owned and controlled by the United States.

Lecture To Be Held At 8 O'Clock Tonight

A lecture on controlling the tobacco moth will be held tonight in the Pitt county courthouse at 8 o'clock. Speakers for the occasion are experts in moth control and they will use lantern slides to demonstrate their lectures.

R. R. Bennett, county farm agent, said that a number of control methods have proved effective, and that these methods will be outlined and discussed at the meeting.

Fliers Fall Short Of Setting Record

Springfield, Ill., June 28.—(AP)—Hunter Moody and Wilbur Parrish, Decatur airmen who sought to establish a new world sustained flight record for light planes, landed their small monoplane at 5:23 a. m. (C. S. T.) today, 58 hours and 17 minutes short of the record of 218 hours.

Trouble with their motor caused the fliers to bring their plane back to earth at the Municipal airport after having flown continuously for 159 hours and 43 minutes.

Old Ships Never Die. Portsmouth, Eng.—(AP)—Half a dozen old cruisers and 30 obsolete destroyers of the Royal Navy are being converted for convoy duty and as training ships for the Royal Naval Volunteer Reserve.

Appeal Stays Death For A Doomed Negro

Raleigh, June 28.—(AP)—Glenn Maxwell, Negro, sentenced in Alleghany county to die for murder, appealed to the Supreme Court today, automatically postponing his execution which had been set for July 7.

Tomorrow Paroles Commissioner to decide whether the State House Bricey Hammonds, Robeson county Indian, Hammonds was also set to die July 7 after conviction of murder.

Britain Said To Be Willing To Talk Proposal

Berlin, June 28.—(AP)—Britain has sent a note to Germany which officials said tonight expressed willingness to discuss a new French-British-German naval treaty to replace that of 1935, denounced by Hitler April 28.

The note, delivered by Sir Neville Henderson, British ambassador, to Baron von Weissacker, state secretary in the foreign office, also was said to have denied that Britain was trying to "encircle" Germany and asked a number of questions relating to naval matters.

It was a reply to the German note of April 28 ending the 1935 treaty. Officials said that Germany's answer would be made soon.

In denouncing the treaty, Hitler charged that by an "encirclement" policy, the British government has one-sidedly withdrawn the basis for the naval treaty.

The questions Britain asked were described as being of a "technical character."

Hocutt Is Seeking Sane July Fourth

Raleigh, June 28.—(AP)—Ronald Hocutt, director of the Highway Safety Division, wants July 4 this year to be "a day of independence from death and injury on the highways of our state."

Hocutt called today on every citizen and organization in the state to make it one.

Saving 47 persons were killed and 10 injured on July 3, 4 and 5 last year. Hocutt said that "We must all do our parts to see that this ghastly toll is reduced this year."

Consumption Of Milk In State Said To Be Too Low

Raleigh, June 28.—North Carolina per capita milk consumption, four-tenths of a pint daily, could be doubled and still be below the standards set by nutritionists for good health and body growth, John Arrey, extension dairyman at State College, said today.

In an effort to raise this figure, a concerted drive, now nearing completion, was waged during June to increase the consumption of milk and its products. Practically every individual and organization connected with the dairy industry had a part.

U. S. DECLINES HEED WARNING SENT BY JAPS

Holds Japan Responsible For American Interests

REPLY SIMILAR TO EARLIER ONE

Foreign Vessels Had Been Warned To Leave Chinese Ports Of Foochow and Wenchow

Shanghai, June 28.—(AP)—United States Consul General Clarence Gauss notified Japanese officials today that Japan would be held responsible for any damage to American interests in attempts to take the Chinese ports of Foochow and Wenchow.

Gauss also replied to a Japanese warning that foreign vessels leave the two ports by Thursday noon with a reassertion of previous declarations that United States naval vessels would go wherever necessary to protect American citizens.

This reply was the same as that given to a similar Japanese warning accompanying occupation of Swatow last Wednesday. It also was similar to a British reply made known yesterday.

No American naval vessels were at either of the two ports where Japanese were said to be completing preparations for direct attacks. Villages outside Foochow were bombed today. Nine Japanese transports were said to be in the vicinity.

Eighteen foreign missionaries, including Americans, were said to have left Wenchow on a British steamer. Other foreigners were staying there. All commercial ships were expected to leave before the Thursday noon deadline set by the Japanese.

A message from the mission colony at Foochow, where 20 American lives, reported "all remaining," apparently referring to all foreigners. Japanese naval headquarters announced Japanese had occupied completely islands dominating the mouth of a river on which Foochow is situated.

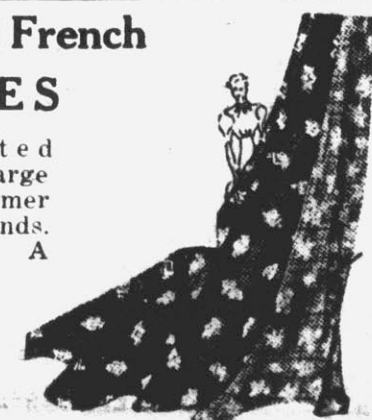

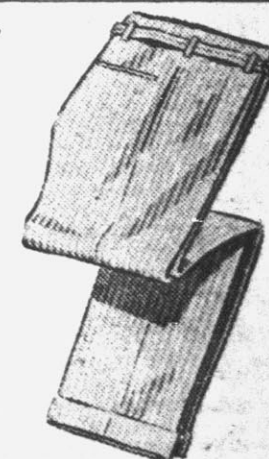

Washington Daybook

By Preston Grover

Washington—President and Mrs. Roosevelt have reduced gift giving to comfortable simplicity. To visiting sovereigns and other notables they present copies of the Roosevelt writings or autographed photographs, or both.

From a diplomatic standpoint it leaves the State Department at ease, as no sovereign or notable, be he great or small, can feel that he was shabbily treated since all the gifts are strictly personal, valued chiefly because they were given by the President and his wife.

The President gave King George a set of his public papers bound in blue Morocco engraved with his own insignia and that of the king. Mrs. Roosevelt gave the queen a copy of her book, "This is My Story," also done in blue Morocco, and they exchanged signed photographs mounted in silver frames.

The King's gift to President Roosevelt was a gold ink well. It becomes a historic relic and probably will be placed in the "Museum" on the ground floor of the White House where numerous other gifts to the President are collected.

The President's public papers bound in black Morocco were given Crown Prince Frederick and Crown Princess Ingrid of Denmark and Crown Prince Olaf and Crown Princess Martha of Norway. To them also went Mrs. Roosevelt's book and the Roosevelt photographs.

Occasionally President Roosevelt gives copies of one of his two other books, "On Our Way," and "Looking Forward."

Speeches As Gifts

To South American countries the President visited in 1936 on his trip to the Inter-American conference in Buenos Aires he presented copies of the three speeches he delivered on that journey. They were hand-somely printed and bound by the government printing office. The three speeches appearing in French, Spanish, English and Portuguese.

To President Somoza and Mrs. Somoza of Nicaragua the President and Mrs. Roosevelt gave autographed photographs in silver frames on their recent visit.

While the President's gifts are fairly uniform, the presents he receives range from things of extreme beauty and value to just plain gag-gets. The "Museum" in the White House already is crisscrossed with them, all carefully tended and watched over by White House police.

In a case with other selected items the gold handled dagger given the President by the Sultan of Muscat on his visit here last year. It is a wicked looking blade with a nasty oriental curve as if designed to slide under your ribs and come out under your left ear.

Many Odd Pieces

Also in the museum is a Japanese vase, its deep red glow almost hiding sub-surface decorations. Beside it is a desk lamp in the shape of a pump. Pump the handle and the light turns on. Massachusetts WPA workers sent it in 1938 to commemorate pump-priming.

Most of the museum pieces are gifts of American enthusiasts, ship models, hunting knives, clocks, an intricately carved wooden church, a wooden statue of Will Rogers, briar pipes, a chair with the picture of Roosevelt reproduced in the wood. Most troublesome to the officer on guard is a wooden caricature of the President by Jack Sparling of New York. The glasses are forever falling off. 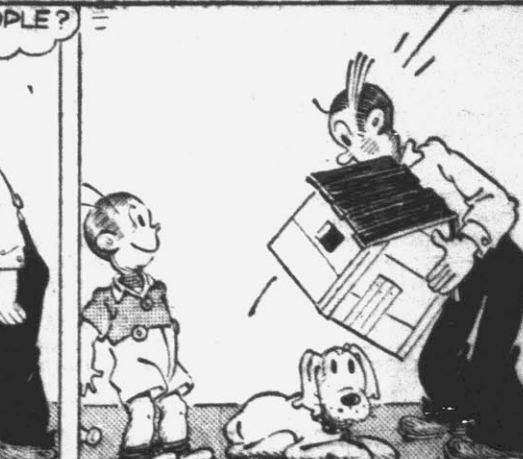

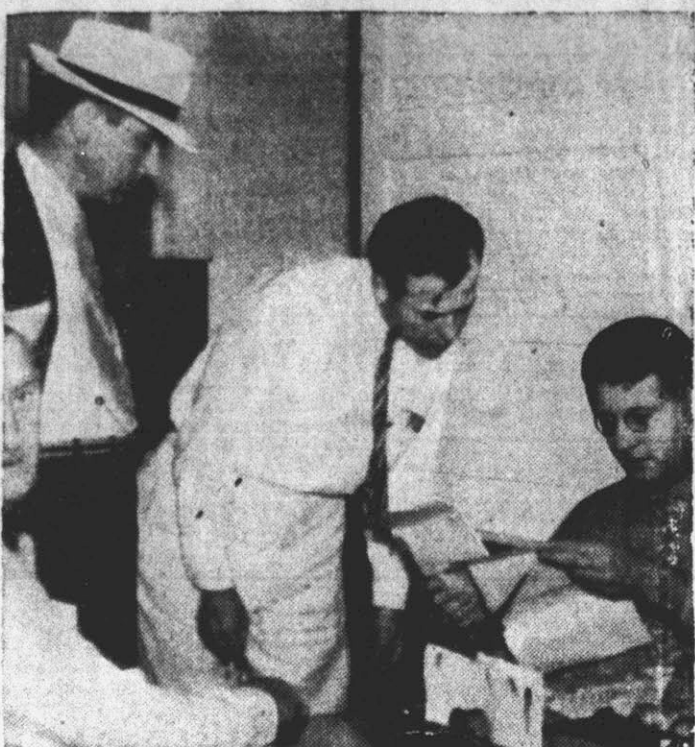
