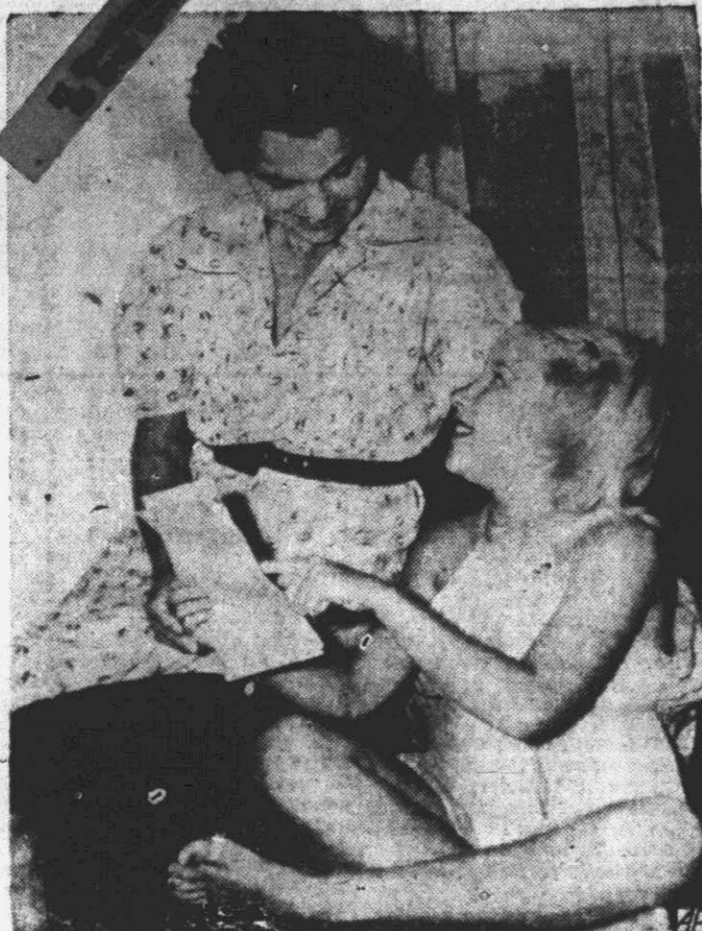

CHAMBERLAIN MAY INCREASE SIZE CABINET

Minister Considers Taking In Eden, Churchill

PLAN IS LIKELY FOR NEW CHANGE

Would Put Weight on British Warnings Against German People

London, July 1.—(AP)—Prime Minister Chamberlain today was reported considering the advisability of taking Anthony Eden and Winston Churchill into his cabinet...

Reconstruction of the government, which several political commentators said was likely to come soon, was described as part of Britain's concerted barrage to convince Reichsfuehrer Hitler that Britain means what she says about meeting force with force.

One political writer said flatly that the prime minister shortly would bring Churchill and Eden into the government as a gesture of the strength of Britain's opposition to any use of force.

Both Churchill and Eden have been repeated targets of Nazi press attacks and both now are staunch supporters of Britain's policy of building up defensive mutual assistance alliances.

Evans of Grimesland, R.F.D.; six grandchildren; two brothers, J. G. Lewis of Roper, and W. H. Lewis of Chocowinity; four sisters, Mrs. J. N. Edwards of Grimesland, R.F.D., Mrs. L. F. Edwards, Chocowinity, Mrs. G. W. Barrow and Mrs. J. B. Barrow, both of near Dudley's cross roads in Craven county.

Mr. Lewis was a farmer and with exception of four or five years spent in the Black Jack community of Pitt county, he had resided in the Chocowinity township in Beaufort county, where he died.

FOUR DROWNED IN 15 MINUTES

Downpour In New Jersey Washes Victims Away

East Rutherford, N. J., July 1.—(AP)—An ordinarily dry drainage ditch raised to a seething torrent for a few brief hours by the rush of rain water today gave up the body of a seven-year-old boy, one of four persons sucked to death within the space of 15 minutes.

The second victim was Sophie Kostoplas, 11, who was sucked into the raging stream 10 minutes after the Unger boy was swept to his death.

Hysterical playmates, all of whom were sitting on the apron wall paddling bare feet in the pond, added their screams, attracting the attention of Henry Pfeiff, 37-year-old Rutherford insurance man.

William Steigleman, 46, street department employe, jumped to aid Pfeiff and was also knocked flat.

PITT FARMERS HOLD MEETING

Farmville Is Host To Pitt and Greene REA Members

Farmville, July 1.—R. M. Billhimer of Washington, D. C., affiliate of the Rural Electrification Administration, addressed several hundred farm men and women who gathered here today for the first annual stockholders' meeting of the Pitt and Greene Electric membership.

In an address hinged on the wide spread advancement of electric service made possible through the REA's program, Billhimer related concrete objectives and told how the rural areas, particularly those of Pitt and Greene counties, had taken advantage of the opportunities afforded them under the REA plan.

George W. Davis, Farmville mayor, delivered the welcome address and introduced various speakers for the program, which included speech-making, electrical demonstrations and a mammoth barbecue dinner, the latter being held in the city park at the noon hour.

A proposal to increase the 175 miles of rural electrification lines by 75 miles was outlined by John B. Lewis, an attorney for the corporation. There are approximately 700 farm families represented in the area embracing the Pitt and Greene Electric Membership.

Another feature of the program was a delegation through the Farmville power plant, where the operations of electric engines that supply the farm homes with power were explained.

Among those from Greenville attending the fete were R. R. Bennett, Pitt County farm agent, and Miss Ethel Nice, Pitt County home demonstration agent.

MODERN TRAIN GREETED HERE

Citizens View City's First Air-Conditioned Train

A number of prominent Greenville citizens greeted the first air-conditioned train to operate through Greenville on its initial visit this morning.

The Atlantic Coast Line railroad put the modern coaches into service on the Greenville-Baton Rouge route today. Three officials of the line were on the train. They were M. H. Howard of Wilmington, general passenger agent; S. L. Grimes of Rocky Mount, in charge of the electrical department, including the air conditioning phase; and O. N. Monroe of Rocky Mount, car foreman.

A delegation representing the Eastern Carolina Chamber of Commerce also was aboard. The delegation was headed by Secretary N. G. Bertlett. Others were C. W. Howard, Jr., J. H. Conley, Guy Elliott, Rev. Leland Cook, and Wendell Prescott, all of Kinston.

A number of Greenville citizens boarded the train, but had little time as, running a few minutes behind, a little time was lost despite the hand-shaking and congratulations.

The Greenville Chamber of Commerce was well represented at the station. President J. Nat Harrison and Secretary Willard T. Kyrer being present.

While waiting for the train, J. L. Horne recalled the first Atlantic Coast Line train ever to come to Greenville. He said it was in 1891, according to his best recollection.

At that time the river bridge was not completed and the train ended its run at a settlement called Riverton, a point in front of the Northside Lumber Company. A few months later, however, the bridge was completed and the line was operated to Greenville, which at first was the terminal. After operating from Weldon to Greenville for about two years, the line was extended to Kinston, its present terminal.

Mr. Horne recalled that J. R. Moore was the first agent here and that George Smith was engineer and George Sutherland was the conductor of the first train to come into Greenville.

He also related that the late Col. I. A. Sugg presented the engine with some deer horns which remained on the front of the engine for several years.

"I watched the first train that ever came in Greenville, and I am on hand to see the first air-conditioned train to enter our city," declared Mr. Horne.

SENATE CHECK IS PLACED ON FDR'S POWERS

Debate Sweeps Away His Monetary Authority

PLANS ARE MADE FOR SHOWDOWN

Farm Officials Making Greatest Plans Since New Deal Was Started

Washington, July 1.—(AP)—A rip-roaring Senate Republican filibuster swept away President Roosevelt's dollar devaluation powers early today but Democratic leaders obtained an agreement for a show-down vote Wednesday on restoring them.

Over in the House at another late night session a rebellious bloc of Republicans and Democrats had passed a short time previously a neutrality bill distasteful to the administration.

The stunning double defeat, perhaps only temporary on the money issue, threw administration forces into a state of bewilderment.

They predicted ultimate victory on the devaluation question, but were highly doubtful that repeal of the arms embargo asked by the President could be passed this session in view of the 200 to 188 House vote to continue a modified ban on arms shipments. Adjournment in mid-July was widely predicted.

The President's authority to devalue the dollar further and to maintain a \$2,000,000,000 exchange stabilization fund expired at midnight. Republicans, aided by a lone Democrat, Tydings of Maryland, talked to death a Senate-House conference agreement extending them two years and raising the price for domestic silver at 71 1/2 cents an ounce.

The talk marathon continued, however, and Democratic leaders finally obtained an agreement to vote by 5 p. m., Wednesday, on the conference report. The Senate adjourned at 1:53 a. m.

Other developments: Armed with a \$1,194,498,633 appropriation approved reluctantly by President Roosevelt, Agriculture Department officials began their greatest effort to improve farm conditions since the early days of the New Deal.

Legislation providing the record-breaking sum for operations during the next 12 months was signed by Mr. Roosevelt last night. The total included \$775,000,000 for payments to farmers, including \$225,000,000 which was not in the President's budget.

Three Men To Die By Gas On Friday

Raleigh, July 1.—(AP)—Governor Hoyt announced today he would not intervene for three men sentenced to be executed Friday for murders, but he granted 60-day reprieves to two others.

Reprieved was James Godwin, convicted in Guilford of the murder of Donald Moss, Thomas Turner and T. J. Gold, High Point lawyers and representing Godwin, conferred with Commissioner of Paroles Edwin Gill this morning and asked for time in which to complete compilation of "new matter."

Also reprieved was James Pureton, Negro, sentenced in Forsyth in the murder of Melvin Nesbitt. Pureton's lawyers have prepared a new appeal to Superior court, Governor Hoyt said, causing him to intervene with a stay of execution after he had said he would not sign one.

The men who now apparently will be executed Friday are Alfred Caper and Bricey Hammonds, both convicted in Robeson county, and James Henderson, sentenced in New Hanover. Caper was convicted of killing J. C. McNeill, Hammonds of the slaying of Lacey Brumles and Henderson of the killing of Mrs. Jesse Hobbs.

Red Oak H. D. Meeting. The Red Oak home demonstration meeting will be held at the club building Wednesday, July 5, at 3 p. m.

Notes spotted from John H. Harris, extension landscape specialist. "What to Do in July" - Those shrubs that have finished flowering may still be pruned. Remove seed pods from pink spiraea (Spiraea Anthony Waterer) and it will bloom several times during the summer.

All seed pods and old flowers should be removed from flowers to keep them blooming. To keep your shrubs attractive, never cut shrubs flat across the top but thin them out from the ground, removing old canes and perhaps shortening the more vigorous ones.

"If your lilacs, roses or crepe myrtles are affected with powdery mildew, use the Bordeaux spray or find dusting sulphur while the dew is on the plants.

"Small shrubs and trees, especially newly planted ones, should be worked around just as you would your crop. A good substitute for cultivation is a good mulch of leaves, straw or some other material. It is especially important to mulch azaleas, rhododendrons and other acid-loving plants since several of these plants will not tolerate cultivation around their roots.

"4-July through August is the critical period on your lawn. Set your lawn mower high to prevent mowing it too close. Unless facilities are available for continuous watering it is better not to start. The usual cause of brown lawns in summer is insufficient humidity in the soil. In order to hold moisture, the soil must have organic matter such as manure, woods mold, peat moss or some other material. No amount of commercial fertilizer will replace this necessary element.

"5-Now is the time to make summer cuttings. Use only this season's growth and do not use the extreme ends because this growth is too tender. Make cuttings from four to six inches long and keep in moist place. Complete directions are available upon request.

"6-Spray your roses with Bordeaux to control brown spot. This should be applied about every two weeks and if green aphids are prevalent add Black Leaf 40 (Nicotine of Sulphate).

"7-For fall blooms the following annuals should be sown: Alyssum, aster, calendula, candytuft, marigold, stock, zinnia and verbena.

BABSON (Continued from page one) loans outstanding, you had a good idea as to the trend of future business. Today, the amount of money owed on installment contracts is also a tremendous factor.

Debt Reduction Discouraged. Not only has little been done to help reduce debt, but the recent tax laws have discouraged business men in doing so. For instance, if a small and financially weak concern could buy up its notes at a substantial discount the discount would have to be reported at the end of the year as profit and be taxed at 12 to 16 per cent.

Meanwhile, big business concerns, whose bonds and notes have been selling at par or better, have been calling their bonds and refinancing their debt. They have thus been able to take advantage of the lowest interest rates in history and have cut their fixed charges drastically. The small business man has been unable to do this.

The latest idea in Washington is to encourage debt reduction. It will permit financially weak concerns to buy in their interest-bearing obligations at less than par without incurring a tax liability. As far as helping out the smaller business man from a credit standpoint, this is the first forward step that Congress has taken in a long time.

The undistributed profits tax was also a handicap to business concerns, big and small, who wanted to cut their debts. This tax is being completely abolished in the new "business relief" tax measure now going through Congress.

The bill, which wipes out the tax liability incurred by a company buying in its own obligations below par, is a constructive step. It can become a definite aid to executives, workers and investors of weak business concerns. This new program should help to strengthen many second-grade bond and note issues. In fact, with high-grade corporation bonds selling at all-time highs, many business and professional men, who can afford to take a little risk, may be wiser in buying some of the better second-grade issues.

Debt No Longer Disgrace. As I write this column at my workplace by the sea, I am forcibly reminded of the great change that has taken place since the World War in people's attitude toward debt. Only 25 years ago, debt, like small-pox, was something to avoid. Banks, schools and parents encouraged savings. The goal of all was a bank account—even though it started at only one dollar. Mortgage were a disgrace.

Today, I find an entire change of sentiment here in the old city. Banks, schools and parents no longer encourage deposits. Debt is no longer shunned. Despite this change in attitude, I cannot believe

that debt is any less dangerous today than it ever was. Yet, even in the face of this situation, I am optimistic on business for the near future. In fact, June industrial activity was considerably better than May. Moreover, July should be as good a business month as June. However, the changed attitude as to thrift and debt, if continued, makes me very fearful that we are heading into a terrible smash some day!

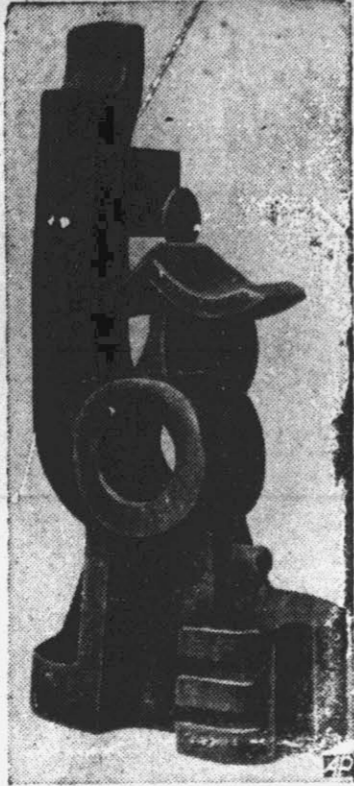

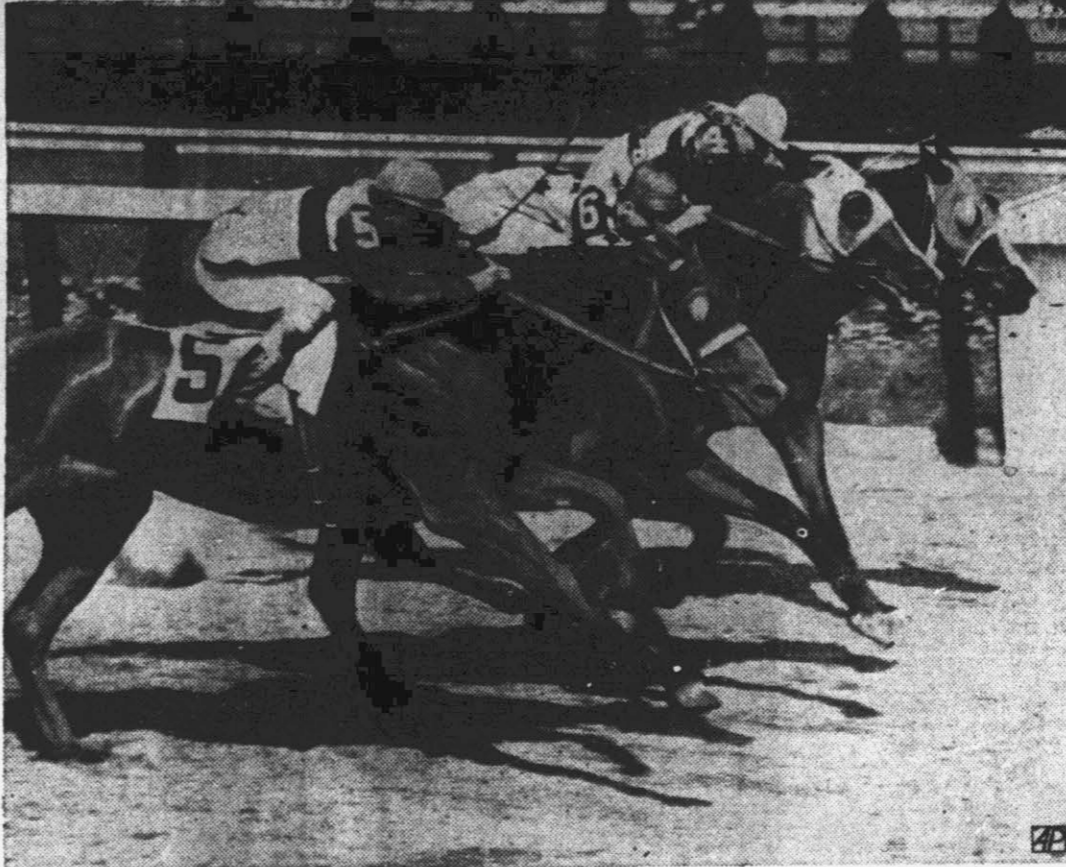

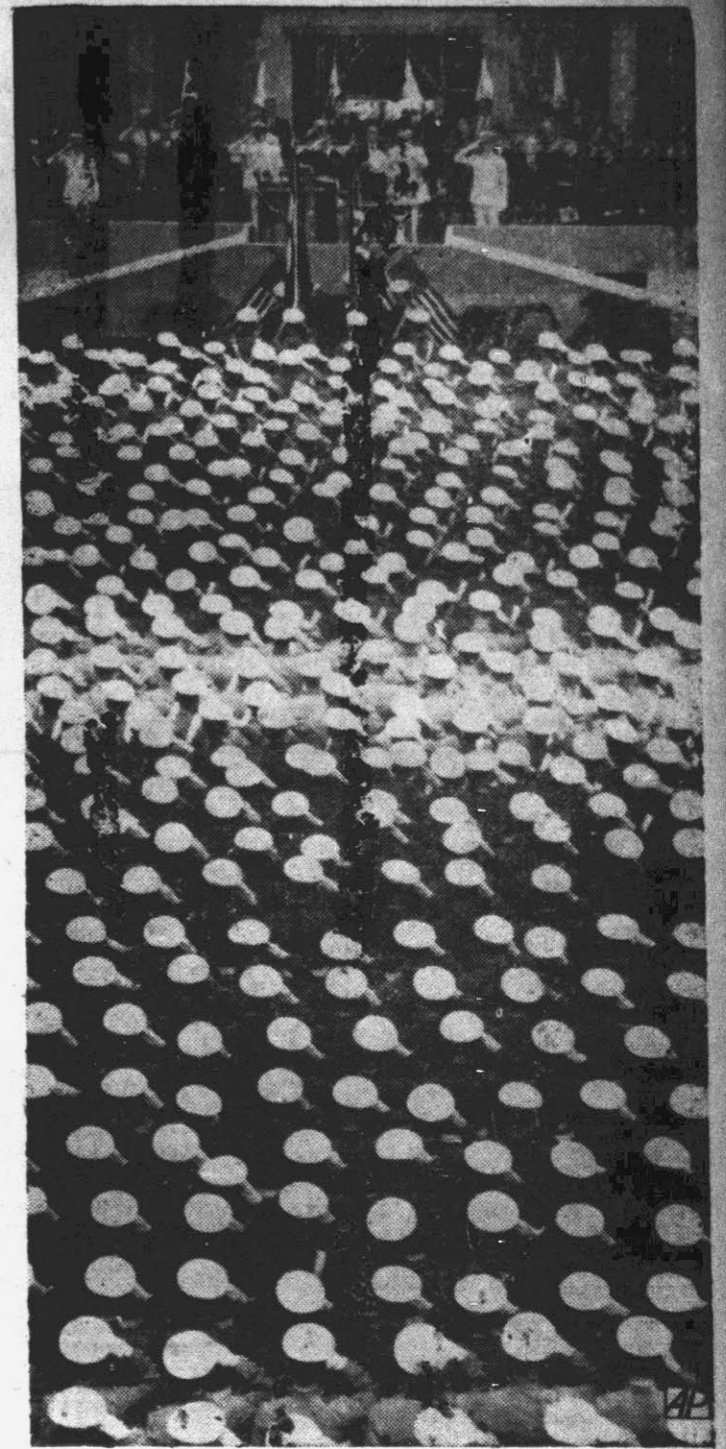

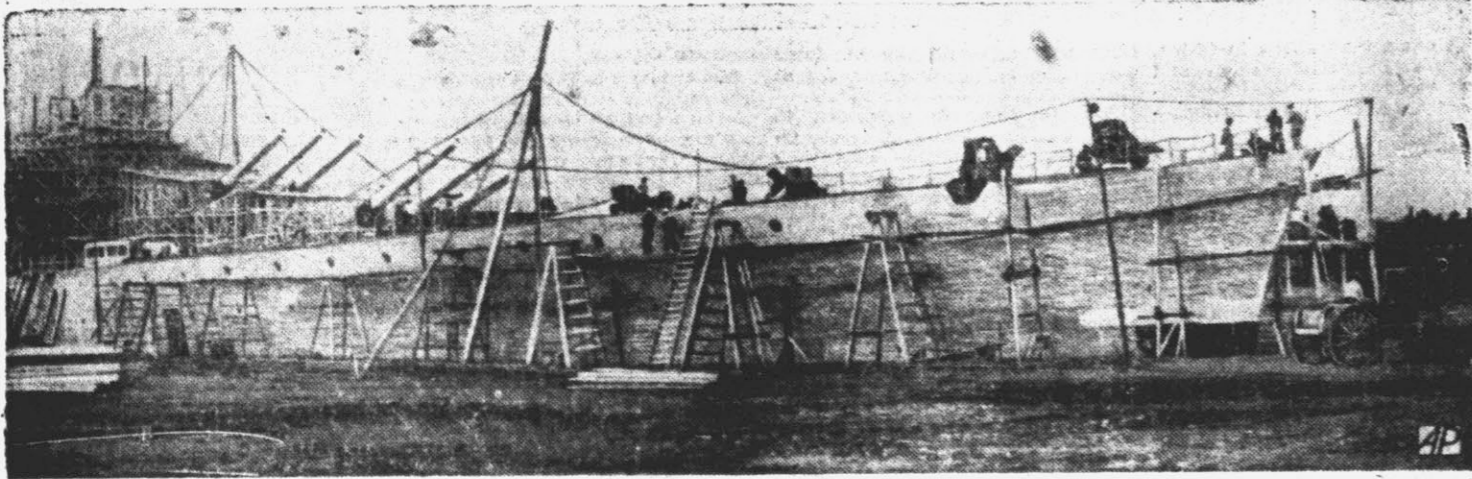

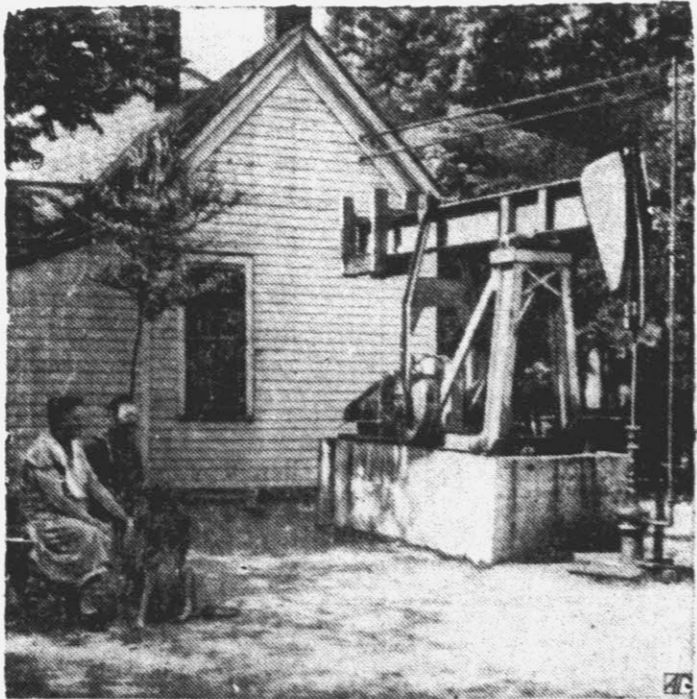

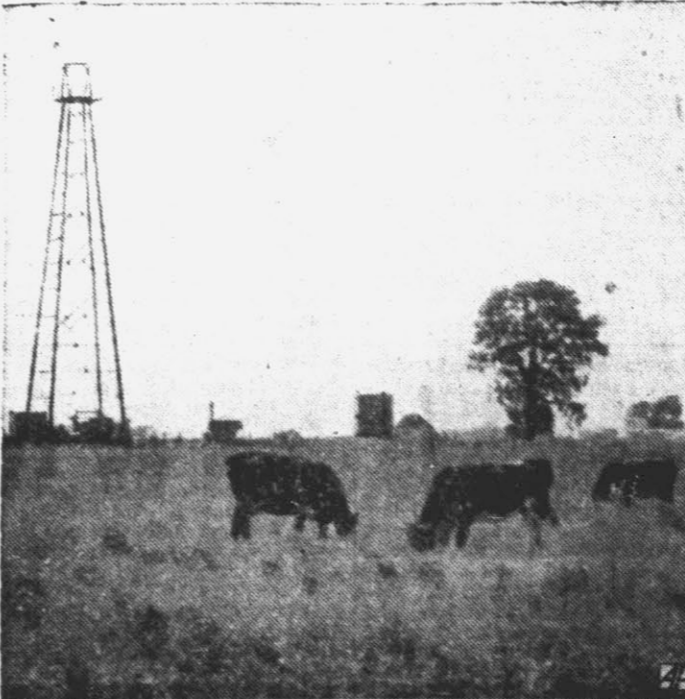

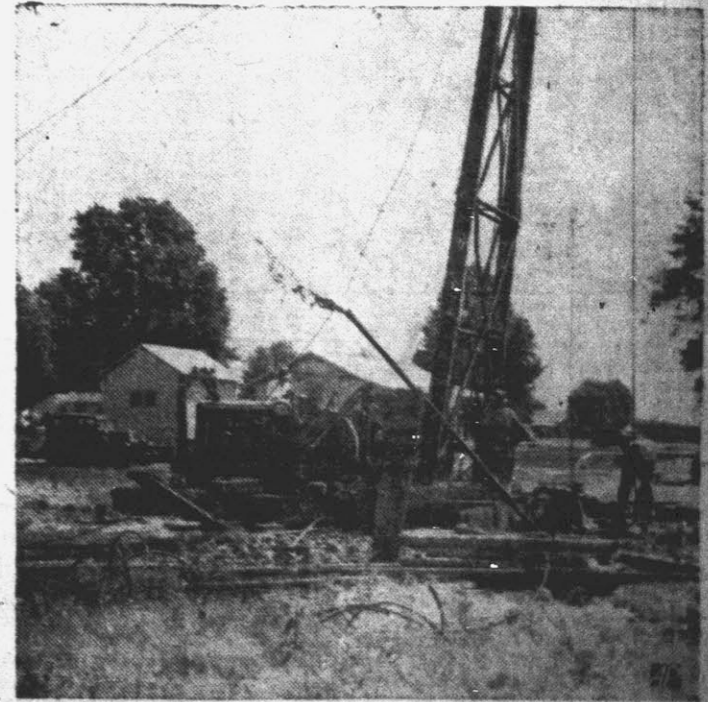

Washington.—Heaps of tax experts around here were ready to dispute the statement of the President that broadening the tax base would not raise the amount of new revenue expected by its advocates. At his press conference the President said the cost of collecting income tax from a wider range of citizens would almost eat up the revenue, although he favored it as a means of making the public aware of its responsibilities. Tax experts said that reducing the exemptions would raise more money without any appreciable cost. A married man with an income upon which he pays only \$3 or \$4 now would have to pay \$30 to \$40, they pointed out, if the personal deductions were reduced from \$2,500 to, say, \$1,500.

But nobody needs to sweat much about that for two years. The President is not pressing for it this year and Congress won't press for it next year—not with elections coming on. **NOW ABOUT THOSE ITALIANS** You might like to know that army folk are revising early impressions about the fighting ability of Italians. When the Italians were routed in a panic at Guadalajara in the Spanish civil war a hasty impression grew up that Mussolini's legions could not fight. Since then, critics have received more facts. The Italian troops beaten at Guadalajara were mostly conscripts from here and there about Italy, incompletely trained and not long enough in uniform to develop discipline or morale. And they were commanded by second-string Italian officers who didn't know how to coordinate their attack with the air service. Such a combination would promise failure eight times out of ten. They suspect Mussolini has some better troops. However, most officers here seem to believe that two crack divisions of French troops could have driven the entire Italian contingent into the Mediterranean in a week's campaign.

ODDS AND ENDS A State Department reporter, evidently by mistake, received a letter from a collection agency informing him that he owed \$5 to a certain Washington physician. If you do not pay this account within 24 hours, the letter said, "we shall take steps which will amaze you."

"And make it snappy!" he stipulated.

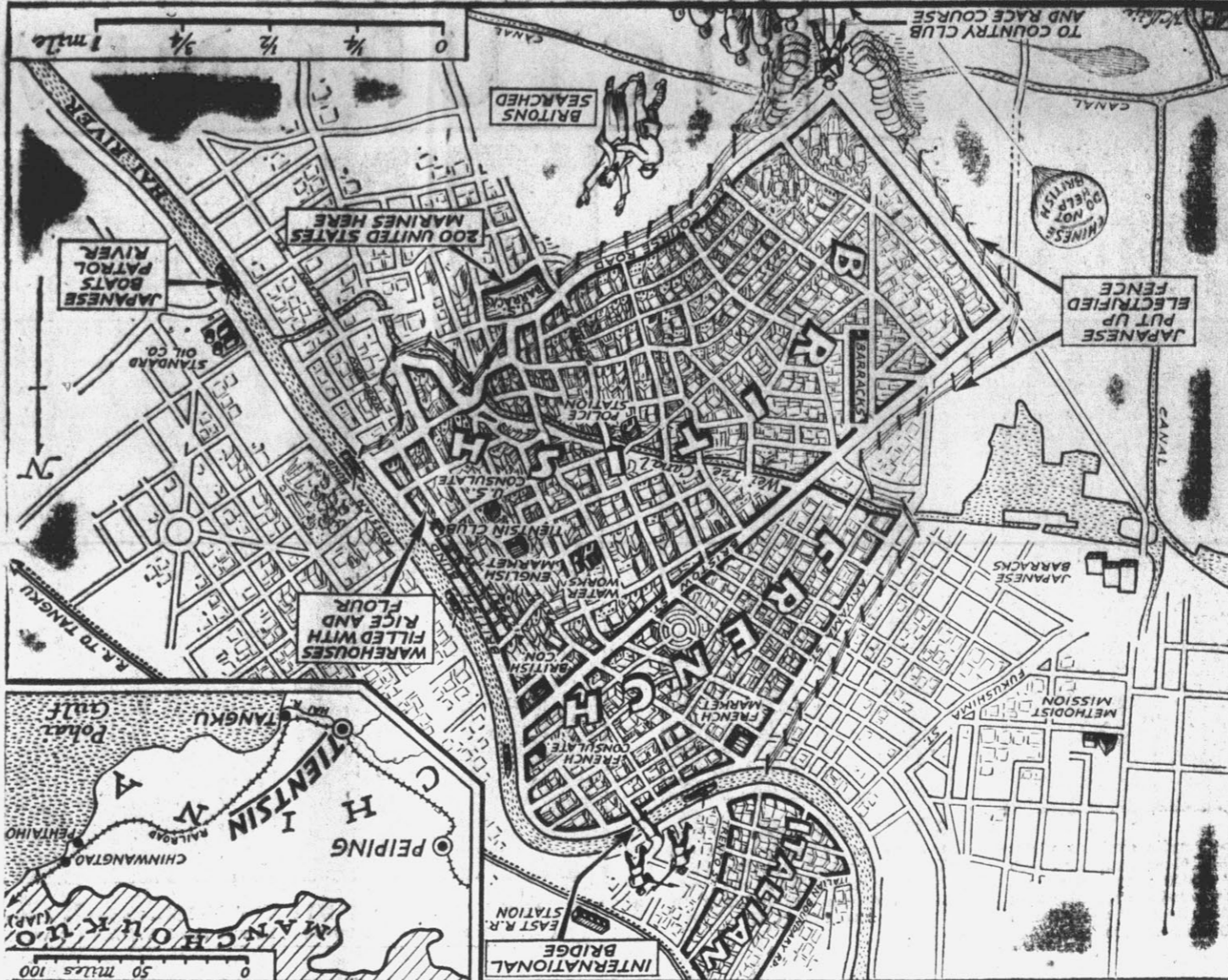

Here's How British Are Besieged In Tientsin

Japan, in trying to swallow China, has long been lured by foreign concessions, around which she has had to divert her campaign. Most officials now believe foreigners must be ousted—or at least forced to "lose face" with Chinese—before Japan can win.

Possibly as a testing ground for a drive against all aliens in China, Japan has blockaded British and French concessions—sheltering 120,000 persons, 1,500 of them Britons—in Tientsin.

Ostensibly the blockade was applied after an argument over four Chinese refugees accused of terrorism. But when Britain offered to negotiate, Japan upped her demands. In London, Prime Minister

Chamberlain, harried by European woes, hoped the affair could be "localized," hesitated to retaliate. So the Japanese proceeded to block supplies entering the area. All Britishers entering the area were searched—some were forced to undergo. Electrified wires were strung around the area. Natives working in concession public services were warned relatives would be killed if

they did not quit. Meanwhile, the United States was interested in the "broader aspects" of the dispute. Though having no concessions in China, she has \$200,000,000 invested there. In 1938, China and Japan accounted for nine per cent of her imports, 10 per cent of her exports. Moreover, 300 Americans live in the blockaded Tientsin area.

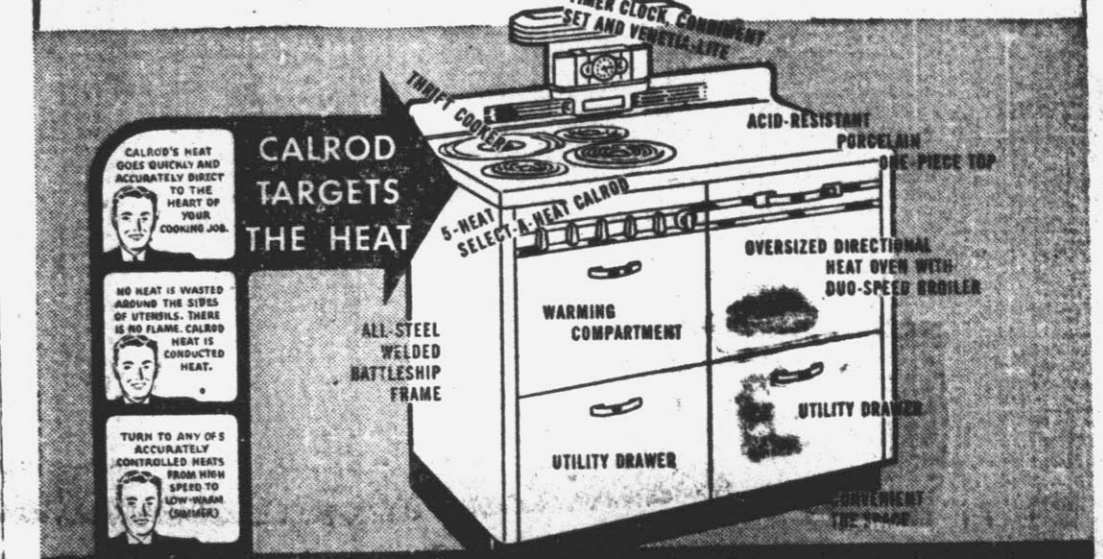

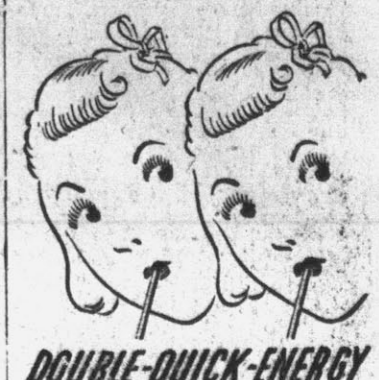

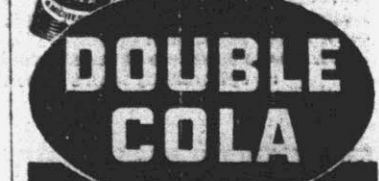

The "nights" sponsored by the Greenville baseball club have tended to stimulate much interest in baseball. Although other clubs in the league have cashed in on the "night" idea launched for the first time this year in this vicinity by the local club, they're still having nights in Greenville.

Asden, which turned its baseball franchise over to Wilson before the present season got under way, was the first town to be honored. Farmville was the next and during the past week Bethel, Stokes and Pacotous were guests of the club. Secretary Moore says that other towns in the county will be honored before the season is brought to a close.

The largest turnout of Colored people in the city's history is expected tonight. Greenville will entertain the New Bern Bears in the third game of the week between these teams last night's game having been rained out.

Washington residents will have the opportunity of seeing the Williamson Martins and the Greensies tangle in a game.

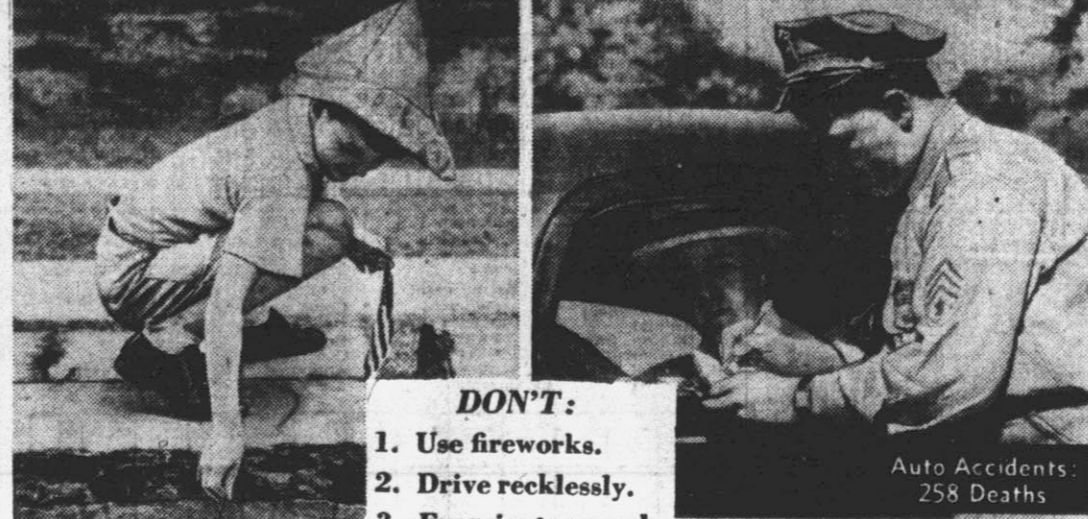

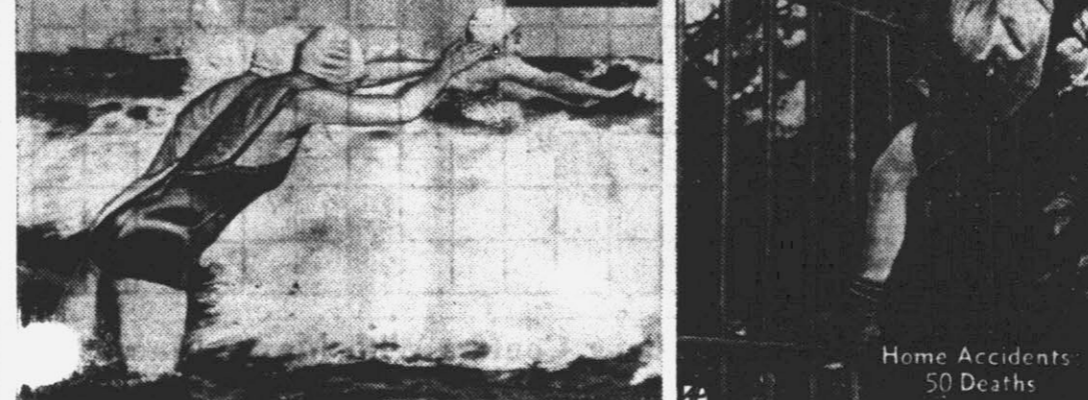

got there they did nothing but whittle, gossip, but mostly just set. 'It's a regular Loafer's Glory,' he said—and so it became.

N. C. LIBRARIES FACING CRISIS

113 May Have To Close Because Of Legal Status

Raleigh, July 1.-(AP)-One hundred and thirteen North Carolina libraries faced the possibility of being closed today due to an apparent unconstitutionality of laws under which counties and municipalities appropriate funds for them.

Miss Marjorie Beal, executive secretary of the State Library Commission, said 113 libraries, in which from 360 to 400 people could be affected by a ruling of Attorney General Harry McMullan that he believed the Supreme court would hold the laws invalid.

Last night at midnight the Charlotte public library, with branches in Mecklenburg county, closed indefinitely following refusal of the voters to approve a proposed tax for library purposes. It was the first library to close due to the rulings of the Supreme court in two cases during the winter.

Last year about this time, Miss Beal said, city and county authorities set up \$27,000,978 for library use. The 1939-40 budgets are now being prepared or have been set up in recent days and funds for the fiscal year starting today could not be estimated here.

Patrick Healey, executive secretary of the League of Municipalities, was out of the city and could not be reached for comment on what action his organization might take. McMullan released a ruling yesterday morning after a study of the case of Twinning vs. Wilmington, which involved a proposed Wilmington bond issue for libraries, parks and playgrounds, in which he expressed the belief the ruling would not affect laws permitting appropriation for library maintenance. He reversed himself late in the day.

No Hail Reported; Rain Is Beneficial

Although a cool breeze blew in with the heavy downpour of rain in the county late yesterday, indicating that there might have been hail, no reports of hail had reached the city today.

Pitt County has had its share of hail during the present season. A local hail insurance agency reported that it had paid out approximately \$20,000 for hail losses this year but did not have the losses compiled to show the damage done by hail in this county.

Farmers of the county welcomed yesterday's rain, in that Pitt County had joined other farming areas of the state in needing rain. A report issued some time ago by State Agricultural authorities revealed that rain was needed in many sections.

Dempsey's Condition Is Now Satisfactory

New York, July 1.-(AP)-An encouraging report on the condition of Jack Dempsey, former heavyweight boxing champion, came from the hospital in a bulletin issued this morning by A. A. Jaller, executive officer of the Polyclinic hospital.

"Mr. Dempsey's condition is quite satisfactory," the bulletin said. "He had a very good night. His temperature is 101 and one-half degrees, pulse 82 and respiration 24." The bulletin was issued at 8 o'clock this morning.

Local Lions' Meeting On Monday Deferred

J. Vance Perkins, secretary-treasurer of the Greenville Lions Club today called attention to the fact that a regular session of the local Lions previously scheduled for Monday night would not be held.

Treasurer Perkins said the meeting was deferred because of Tuesday being a general holiday and that a number of Lions leaving the city Monday night to spend the "fourth" out of town would be unable to attend the meeting.

Business matters that were to have been taken up at Monday night's session will be handled at the next regular meeting of the Lions Club.

Ward Not To Be Regarded Definitely Out Of Race

Raleigh, July 1.-(AP) In recent speculation over the 1940 gubernatorial race there has been a noticeable tendency to omit mention of Libby Ward as a possibility in the field which is admittedly a wide one, but your correspondent recently had it twice brought home that the Speaker of this state's House should not be completely disregarded in forecast of next year's free-for-all.

Not only that, but Ward's candidacy in a crowded field presents intriguing possibilities.

Recently Libby himself came to Raleigh and in his smiling, affable manner completely declined to name himself to anything other than that he is "observing with interest" the gubernatorial scramble. Positively no concession that he intends to run; but on the other hand, absolutely no statement which could be construed as ruling him out.

Then a day or so ago Guilford's Representative John Caffey, impeccable as always in attire and manner, discussed the gubernatorial race at some length.

Fitzhugh J. M. Broughton was mentioned; Lieutenant Governor William Horton came in for comment; Tom Cooper was discussed; and Smith's intentions were given due attention; Commissioner of Revenue A. J. Maxwell's dreams of a second and this time successful candidacy were pondered. The whole field, in fact, was canvassed.

At last Mr. Caffey smiled quite without guile and observed: "And if every one of those we mentioned and talked about gets into the race, I'll bet you even money that not one of them wins the nomination."

Whereas your correspondent perked up and thought that over for a minute or so, then came the dawn of understanding—"I presume you have in mind our mutual friend from Craven as likely to beat them all?"

Again the Caffey smile flashed—"You're not such a bad guesser, at that," he conceded.

From many, in fact, most sources that would have meant little or nothing more than a bit of speculation; but came from Caffey it cannot be that lightly dismissed in view of the relations between Ward and the Guilford legislator.

It immediately came to mind that Caffey was the Ward floor strategist on the night Libby attacked the Speakership. It was recalled that the Caffey last-minute announcement that Ward was his choice had more than a little to do with the closing band-wagon rush

The lines were estimated to cost \$13,776,988.75 and the biennial report was presented to Governor Hoey.

Nashville, N. C., July 1.-(AP)-Nash County Coroner M. C. Gulley today ordered for next Wednesday afternoon an inquest into the death of E. L. Dorsey, 66, of Nash county, who was killed late yesterday when struck by an automobile on the Raleigh highway, between Nashville and Spring Hope.

Sheriff G. V. Paulkner said his investigation showed that the aged man was hit when he stepped in front of an automobile driven by Mrs. Robert Bass of Momeyer. The officer said the Bass car was following a truck. Mrs. Bass was not being held.
