SENATE FAILS REACH VOTE ON LENDING BILL

Temporarily Delayed
By Attack on Neu-
trality Program

ASSAULT WAGED
BY SENATOR NYE

Senate Headed for
Another Night Ses-
sion Unless Agree-
ment Reached to
Limit Debate

Washington, July 29. — (AP)—An attack on the administration's neutrality program by Senator Nye (R.-N.D.) sidetracked the Senate temporarily today from progressing toward the passage of the \$1,649,000,000 lending bill.

The Senate considered for an hour a lending bill amendment by Senator O'Mahoney (D.-Wyo.) to safeguard private industry from possible government competition until Nye's neutrality discussion compelled the chamber to lay the matter aside without a vote.

Nye urged greater control by Congress over foreign affairs, declaring the efforts by the President and Secretary of State to obtain repeal of arms embargo threatened to involve this country in a European war that might break out.

The Senate headed for another night session unless the leadership could obtain an agreement to limit debate. Democratic Leader Barkley who had been hopeful of obtaining a vote this afternoon, said he intended to keep the Senate in session until it took final action.

Asked whether he would hold the Senate session past midnight if necessary, Barkley replied:

"Why not? There is no law against our working on Sunday."

The Senate already had stripped \$500,000,000 from the measure's original \$2,149,000,000 total.

Other developments— Congress will be asked before adjournment to add \$500,000,000 to the total of about \$1,700,000,000 already appropriated for national defense.

Informed persons said the deficiency appropriations subcommittee would send to the House in the last catch-all supply bill of the session recommendations for expenditures slightly in excess of \$500,000,000 mostly for army air corps activities.

Project For Pitt Accepted In Meet

The Pitt County Board of Commissioners met last night, and after inspecting the plumbing and heating project at the Tucker Building, which houses the offices of the county agent, home demonstration agent, and health officer, accepted the project, Auditor J. H. Coward revealed today.

Approval of the project was recommended by Engineer B. C. Allen of Raleigh, but the commissioners made a thorough inspection of the job before putting their stamp of approval on the project.

C. L. Russ, proprietor of a local plumbing and heating establishment, was awarded the contract for the project some time ago. The cost was \$2,204 and the commissioners were said to be "well pleased" with the work.

The project accepted last night was part of a general building project at the Tucker Building, which has already been completed. Although the other work has not been officially accepted by the county, Auditor Coward said the commissioners appeared to be satisfied with the work.

Payments Made on Delinquent Taxes

City Clerk J. O. Duval declared today that delinquent taxpayers were "coming in" following the mailing of letters to all persons who have not paid their 1938 real estate taxes.

August 14 is the deadline and during that week the city will start advertising property for which 1938 taxes have not been paid. Sale of such property is scheduled for the second Monday in September.

Mr. Duval said that on July 1, this year, there was about \$18,000 in outstanding 1938 taxes still on the books. Of this amount, \$12,200 is in real estate owned by white citizens, \$1,800 by colored citizens and the rest represents unpaid taxes on personal property.

The city clerk estimated that \$1,000 in back taxes was paid last week.

GERMAN-JAPAN PACT IS SIGNED

Trade Treaty Viewed
As Warning To
Democracies

Tokyo, July 29. — (AP)— Japan today made a formal announcement of a new trade treaty with Germany, which observers believed was timed as a warning to France and Great Britain.

The new agreement, although only initiated in Berlin yesterday, was announced here with fanfare just two days after denunciation by the United States of its 28-year-old trade treaty with Japan.

Observers believed the announcement was made at this time purposely to counteract the impression caused by the American action, and they interpreted it as a warning that untimely action by France or Britain would drive Japan into closer relationship with the Rome-Berlin axis.

Negotiations for the pact have been under way since 1937, the foreign office announcement said, and finally reached the stage where the draft agreement could be initiated yesterday by Japanese Ambassador to Berlin Oshima and German Trade Expert Dr. Helmuth Wohlthat.

The statement stressed heavily the significance of the pact as strengthening the anti-Communist front in which Germany, Italy, Japan and other nations are bound to combat communism.

Liquor Battle Indicated By Martin Announcement

Raleigh, July 29.—Announcement of former State Senator L. A. Martin of Davidson county that he will be a candidate for lieutenant governor in next year's primary is another indication that there is in the offing a vigorous and vicious liquor battle.

This despite the fact that the Davidson man may not of his own accord and initiative join John Barlevorn into the campaign as his chosen paramour issue. In fact your correspondent is violating no confidence in quoting Senator Martin to the general effect that there are other issues in North Carolina which demand consideration as urgently as any question of a statewide referendum. Yet whether or not he consciously seeks it, leadership of a dry drive in 1940 is certain to be thrust upon the Davidsonian because of his past performances.

Only those with very short memories have forgotten the desperate, determined and, withal, able fight he made in the 1937 Legislature against the current ABC law. Nobody who is acquainted with Senator Martin can for a moment doubt the depths of the sincerity with which he abhors liquor and all its works nor the intensity with which he believes it wrong for the state to give it any legal standing whatsoever.

That being so, Senator Martin isn't going to be able to campaign without regard to the prohibition question. The ardent dries will not let him and his own deep-rooted convictions are going to force him to a crusade before the campaign is over.

Several Suggestions To Be Discussed At Conference

Atlanta, July 29.—(AP)—Georgia bright leaf tobacco growers will meet with Governor Rivers here tomorrow night to seek a remedy for depressed prices at state markets.

A committee representing growers dissatisfied with prices, ranging from 4 to 12 cents below the 1938 level, will discuss with the executive staff proposals as:

An appeal to Secretary of Agriculture Wallace, a plea to the major tobacco buyers and manufacturers, a marketing holiday and the authority of a gubernatorial proclamation; an agreement among farmers to retard sales or withholding them from the market.

The governor asserted he had not yet decided on a plan of action.

Committeemen planned their order of business with the governor as word reached them that the N. C. Carolina Farm Bureau Federation had expressed willingness to cooperate with Georgia growers in their campaign for better prices.

Proposed Institution To Cost About \$450,000

TO BE LOCATED
IN CITY LIMITS

City of Wilson Had
Agreed to Donate
Land and Provide
Water and Sewer
Connections

Rocky Mount, July 29. — (AP)—Lee Gravely, chairman of the State Sanatorium Board, announced this morning that Wilson had been selected as the site for the proposed \$450,000 tubercular hospital for Eastern North Carolina.

Gravely said the site committee, in a letter to him announcing the place, said the sanatorium would be situated on the 10-acre T. H. Woodard farm, about 200 yards north of the Wilson county limits on route 301 and Herring avenue.

The report described the site as "easily accessible to the people of Eastern North Carolina."

The City of Wilson has agreed to donate the farm, the letter said, and provide connections with the city water main and sewage disposal plant without charge.

The letter was signed by the three committee members, State Senator Joe Blythe of Charlotte and Representatives O. M. Mull of Shelby and L. L. Burgin of Hendersonville.

The next development awaits action of the federal government on the request of the State Sanatorium Board for a grant of 45 per cent of the \$450,000. Gravely said the site had the board's approval and he praised the "unselfish efforts" of the committee members, who spent a month inspecting more than 100 prospective sites.

An effort had been made by Greenville to have the hospital located in this section and it is understood that this was one of four cities given final consideration.

Mayor Jack Spain, advised of the decision to locate the hospital in Wilson, declared, "We are sorry that Greenville was not chosen, but we are glad that a nearby site was chosen." He also expressed congratulations to the neighboring city of Wilson.

J. Nat Harrison, president of the Greenville Chamber of Commerce, which organization led the fight for Greenville, was out of the city.

RESTORING CONFIDENCE

Babson Says Outlawing 'Pressure Groups' Will Help

Gloucester, Mass., July 29.—Our decade-old business depression has, for the first time in 160 years, caused our standard of living to decline. At least, that is what Howard Connelley, president of the National Association of Manufacturers, said a few nights ago. He insists that "only through restoration of confidence in the American system can this country resume progress."

In general, everyone agrees with Mr. Connelley. Naturally, we all want confidence. We all know that when we are confident, things go along much better—we work harder, more people have jobs, and we spend money more freely.

On the other hand, there is tremendous disagreement as to what is meant by "confidence." Different groups of people, different sections of the country, and different political leaders have entirely opposite views as to what will restore confidence. Both Howard Connelley and Norman Thomas would state that the greatest need of the world is "confidence." Yet, they would absolutely disagree as to what will bring about that confidence.

No One Agrees on Anything

Some people, for instance, want old-age pensions for everybody,

while others feel that this would bankrupt us. Some want stricter labor legislation, while others argue for less. Some want more federal money spent for "relief," while others insist that all relief expenditures should come from local "community chests." Some want prices fixed at "cost," while others insist that only free markets for commodities, labor and enterprise will bring about prosperity. Some hope to see government banks which will give credit to everyone, while others think that the government is already meddling too much with our banking system.

Some want neutrality, while others believe that the United States should come out now and say we will sell England and France all the munitions they want to buy. Some want higher tariffs to protect labor, while others say that lower tariffs would mean greater foreign trade and hence more jobs. Some believe higher income taxes would help business, while others insist that lower income taxes would result in more employment. Some want a bigger army and navy, while others want this money spent on schools, hospitals and libraries. Some are

CROPS HURT BY ARID WEATHER

Damage Not as Wide-
Spread, However,
As In 1936

Washington, D. C., July 29.—(AP)—A mid-summer drought gripped millions of acres of America's crop and pasture lands today, threatening incalculable loss to farmers.

In contrast with the severe dry weather of 1934 and 1936 which was almost nationwide, present drought conditions are confined to Middle Atlantic and New England states, the southwestern "dust bowl" and sections of the Rocky mountains and upper Great Lakes.

While losses have been heavy, particularly in the eastern drought belt, J. B. Kincer, the weather bureau crop specialist, explained that they were not comparable in seriousness to those of 1934 and 1936.

"Drought conditions are more localized and developed much later this year than in severe drought years," he said, "consequently, damages will not be nearly so heavy."

Federal farm officials reported that a sharp deficiency in moisture and high temperatures this month had dried up pastures and damaged corn, potatoes, commercial truck crops and berries in the northeastern states. Scattered rains this week brought a degree of relief.

Inasmuch as the nation has bountiful supplies of cotton, wheat and most other agricultural products, drought losses are expected to have small effect on prices and supplies, officials said.

British And Japanese Troops Line Up Along Barbed-Wire Barricade

Tension Flares Anew
Following Shanghai
Incident

BRITONS HELD BY
NIPPON TROOPS

Taken In Custody
Upon Entering Japanese
Defense Zone,
Supposedly Through
Error

Shanghai, July 29.—(AP) British and Japanese troops faced each other across newly-erected Japanese barbed-barricades on a Shanghai boundary tonight as result of an incident which caused Japanese-British friction here to flare anew.

Japanese naval forces ran up the carrier along a mile and a half of the British defense sector after an encounter in which Japanese seized and held four British soldiers for two hours and a half.

British military commanders protested the barricade, asserting it was on territory inside the British zone. There were strong indications that the encounter held further possibilities of trouble.

The friction began when four men of the Seaforth Highlander regiment entered the Japanese defense zone in a truck to repair barbed wire. British officers said the men mistakenly believed they were in the British zone.

Quickly men of the Japanese naval landing force—the permanent Shanghai garrison—blocked off the alleyway in which the Britons were working, cutting off their escape. Then 200 Japanese, working at high speed, strung three strands of wire along a mile and a half stretch from Soochow creek to the northern limit of the British defense sector.

Reports of British-Japanese trouble running through the nearby Japanese-occupied part of the city caused a panic among Chinese residents.

After two and a half hours of negotiations, British officers obtained the release of the men and trucks.

Injured Slightly In Car Crash Near Here

Patrolman C. R. Williams investigated an accident on the Greenville-Winterville highway yesterday afternoon, in which Whit Dail, Winterville man, received minor injuries.

It was explained that the automobile skidded, apparently because of wet concrete, and overturned. Dail was treated for his injuries at Pitt General Hospital. The automobile was not damaged to any great extent.

Two Are Tried Here At Afternoon Session

Faced with a heavy docket, yesterday's session of Municipal court ran into the afternoon, two cases having been disposed of at the after-lunch session. Several cases were continued.

Chester Tetterton, charged with operating an automobile without a driver's license after he ran over Clarence W. Stoneham, who was putting down sewer pipe behind White's store on May 24, was ordered to pay \$5 on the costs and forbidden from driving a car for five years.

Willie Teel, Negro, was convicted of assault and given a 30-day road sentence, suspended upon good behavior for one year.

Supreme Court Justices Agree On Most Of Cases

Raleigh, July 29.—North Carolina's seven Supreme court justices shared opinion writing during the 1939 spring term almost as evenly and as quickly as possible and during the term they found themselves not completely in accord in less than 10 per cent of the 198 decided cases.

Justices Heriot Clarkson and William A. Devin wrote 25 opinions each. Chief Justice Walter Stacy, Justices Michael Schenck and M. V. Barnhill expressed the court's collective views on 24 occasions; while Justices A. A. F. Sewell and Wallace Winborne wrote 23 opinions each. A total of 30 decisions were decided in "per curiam" decisions—a technical term meaning that no detailed opinion, written by a single justice, was necessary and the case was decided "by the court as a whole."

In all these 198 decisions there were only 18 with dissenting opinions, though in a very few of the "per curiam" cases the court was equally divided with one of the justices taking no part in the decision. All in all, however, there were dissents in only about 10 per cent of the cases.

There were 169 civil, 14 capital felony and 15 other criminal appeals included in the 193 cases. In 61.1 per cent of all cases the decisions of the lower courts were sustained by the Supreme court decisions, with 121 affirmations against 69 reversals for a percentage of 59.2. Of the 14 capital felonies whose cases were decided at the spring term, 10 were deemed in accordance with the lower court verdict, while four were given new feasts on life by the "New Trial" route. Of the other criminal cases, 11 were affirmed, four reversed.

MAKE SWITCH HERE TONIGHT

Convert Telephones
To Dial System
After 10 P. M.

Officials of the Greenville branch of the Carolina Telephone and Telegraph Company will throw a switch tonight between 10 and 11 o'clock that will convert approximately 2,000 subscribers in this city to the use of the progressive dial system of telephoning.

Complicated work of installing such a system has been under way in Greenville for several months and every detail has been worked out with clocklike precision. The telephone building here was renovated and new equipment has been installed for the automatic system of telephoning.

Individual instruction has been offered to subscribers throughout the week, and for those who did not take advantage of the instruction in the business office of the telephone company, there are directions for using the new system in the directory that has just been issued by the company.

Particular attention was called to the changes in the telephone numbers of the fire department and police department. Instead of calling No. 1, persons wishing to communicate with police in the future are asked to dial 3147, and those wanting the fire department are asked to dial 3116 instead of asking the operator to ring 17. These emergency numbers can be found on the first page of the directory.

NAVY RESERVE SUMMONED BY GREAT BRITAIN

Huge Mobilization of
Sea Forces Un-
dertaken

PREPARING FOR
FULL STRENGTH

Chamberlain Expected
to Make State-
ment Monday on
British, French and
Soviet Talks

London, July 29.—(AP) Britain swung into a huge mobilization of naval forces today to bring her vast armaments to full strength for the August and September "danger period."

While regulars and reserves were summoned to duty to place the fleet at the peak of fighting power along with land and air services, sources close to the government said Prime Minister Chamberlain was expected to make a statement Monday on the British-French-Soviet talks.

It was said plans for "immediate" military staff conversations among the three powers would be announced then, along with reaffirmations of a desire for a three-power mutual aid pact.

Officers and men of the regular navy—back from leave which had been advanced a month so the fleet would be fully manned during the period regarded as most likely to produce international tension—set about readying ships to go to sea. Some 12,000 reservists packed their kits to report Monday. After an inspection by King George, August 9, reserve vessels will join regulars in the biggest peace-time war game in British history.

Reinforcement of naval power marks another step in the show of force which the government hopes will impress Chancellor Hitler of Germany of "Britain's sincerity of purpose."

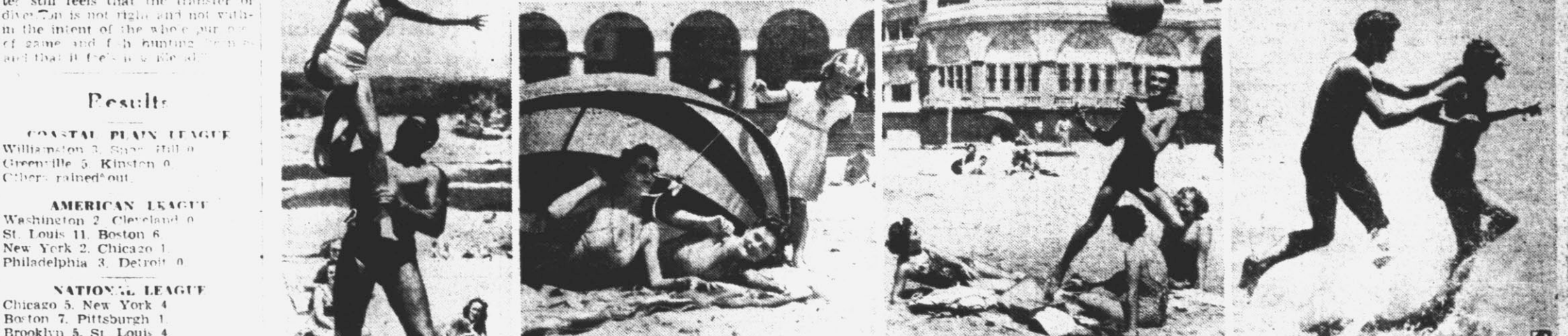

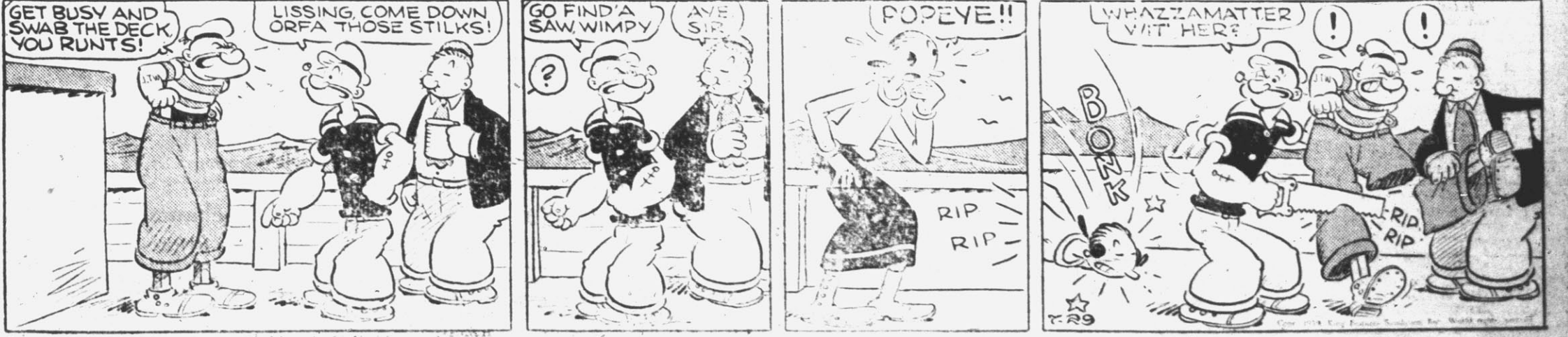

Raleigh, July 29.—Under the head
"Reciprocity" the Employment

uring laws to prevent married

a "career."

Congress Puffed and Hailed
Our congressmen are even more
upset than are the people. They are
constantly being puffed and hailed.
Most of the groups above mentioned
have "associations" with paid secre-
taries who are in Washington fight-
ing for their "good causes." In or-
der to hold their jobs, each of the
secretaries tries to call personally on
the largest number of congressmen
and bombard them with the great-
est number of letters and telegrams.
The whole thing has become a great
big racket. Worst of all, our sena-
tors and representatives do not
have time to study, or even to think.
They are harassed day and night
by these selfish pressure groups.

This all means that our funda-
mental difficulty is that we have
thrown out of the window the rep-
ublic which Washington, Madison
and Hamilton founded. As we all
know, they set up a government
with three distinct branches to
check each other. Moreover, the
legislative branch was divided into
two groups—the House of Repre-
sentatives, elected by popular vote,
and the Senate, elected by the state
legislatures. They moved Congress
from New York City to "a quiet and
secluded place" on the Potomac,
which they named Washington.

Republic vs. "Mobocracy"
The founding fathers' idea was to
have us elect our representatives
and our president in accordance
with the principles outlined, and
then to let them alone. Every two
years there is an election and we
have the privilege of throwing out
any representatives whom we do
not like. While they are in Wash-
ington, however, we are supposed to
let them alone and operate a rep-
resentative republic rather than a
mob-rule democracy.

If space permitted, I should like
to show how this pressure-group
racket has gradually increased.
Briefly, before the World war, it
operated only on the legislative
branch. Since then, it has been ap-
plied to the executive branch. The
courts are still free from intima-
dation by lobbyists; but they will
next be attacked. Yet, the founders
of our country planned that Congress
and the executive should be as free
from attacks from pressure groups
and paid secretaries as are the
courts.

Outlaw Pressure Groups
Yes, the country needs confidence.
Only by the restoration of confi-
dence will business return to nor-
mal, unemployment and relief be
eliminated and our various govern-
ment budgets be balanced. The first
confidence needed, however, is in
our Congress. Before we can have
confidence in anything else, we must
have confidence in our senators and
representatives. We must have con-
fidence enough to forbid pressure
groups from harassing them.

In short, confidence will be re-
stored as pressure groups are out-
lawed. Now, just one more thought:
Of course, I believe in free speech.
You should always be free to write
your senators or representatives any
letter that you wish, or talk to them
in person when they are home. By
pressure groups, I mean paid lobby-
ists, paid lawyers, paid propa-
gandists, and other paid people who
are making a business out of gov-
ernment relief and so-called wel-
fare.

taches it was purely a matter of
coincidence that the task of writing
opinions was so evenly divided
among the justices, as there is no
fixed or set rule governing the mat-
ter. Obviously an effort is made by
the chief justice to come within
reasonable limits of assigning the
writing of opinions within even lim-
its, but it was very far from un-
usual that during the last term the
division should have been so close,
that there was a difference of only
two in the highest and lowest num-
bers written.

It probably was more than a co-
incidence, however, that the per-
centage of cases affirmed or reversed
varied so greatly among the individ-
ual justices.

Judge Clarkson, for instance, was
an "affirming" judge with a ven-
geance; his opinions sustaining the
lower court 21 times, while he hand-
ed down only four reversals. He
wrote eight opinions in criminal
cases, five of them capital, and
found no error in any of them. Of
17 civil opinions, 13 were affirma-
nces against four reversals.

He was therefore the leading
"yes" man of the court with a per-
centage of 86, against the composite
51.1 for the court.

Other justices with more affirma-
nces than reversals were Judge
Winborne with 15 against 8; Judge
Schenck with 15 to 9; Judge Devin
with 14 to 11.

The justices who found the lower
courts wrong more often than right
were Seawell (10 affirmed, 13 re-
versed), the chief justice (11 af-
firmed, 13 reversed) and Barnhill
(18 affirmed, 16 reversed).

Of the 30 "per curiam" only 3
were reversals.

As noted, there were but 19 cases
with written dissents. Of these,
seven were 4-3 decisions, while
there were four with two dissents
and eight in which one justice dis-
sented alone. Judge Barnhill led the
dissenters, with three, Judge
Devin had two, Judges Clarkson,
Stacy and Winborne, one each.

Neither Justice Seawell nor Justice
Schenck wrote a single-handed dis-
sent.

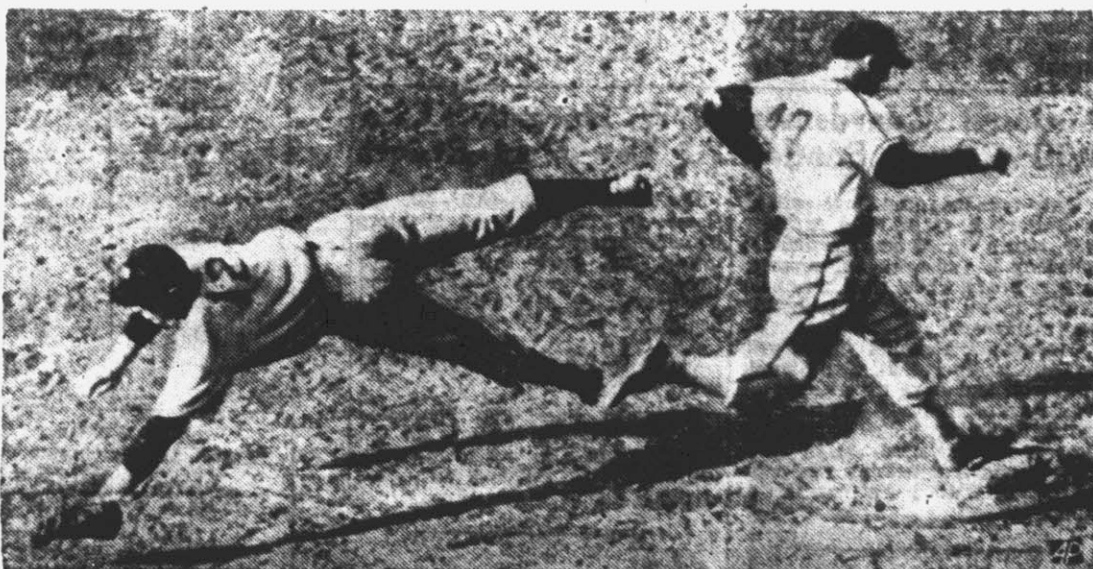
