TWO FACTIONS
LAY PLANS FOR
NEXT SESSION

Both Administration
And Foes Seek Pop-
ular Opinion

SEVERAL ITEMS
NOT COMPLETED

Conflicting Views Ex-
pressed on Opinion
Of "Home Folks" as
to Unfinished Meas-
ures

Washington, Aug. 7.—
(AP)—A new struggle to
swing popular opinion for
against the unfinished items
on the Roosevelt program
was in the making today as
members of the first \$13-
000,000,000 Congress laid
their record before the
"home folks."

From President Roosevelt down
administration leaders took the atti-
tude that public reaction would
be the 1940 Congress to adopt
most of the New Deal measures
killed during the session which ended
Saturday night.

Republican legislators on the other
hand, argued next year that the
Senate and House would show even
greater indifference and that there
was a distinct drift away from ad-
ministration policies.

Indications pointed to a record
amount of political and legislative
debate throughout the country be-
fore the final Congress of President
Roosevelt's second term meets in
January.

The President, who will leave to-
night for Hyde Park, N. Y., to study
the last batch of congressional bills,
may discuss the situation when he
goes to the west coast in October.

He was represented by Senate
Leader Barkley (D-Ky.) as believ-
ing that when opposition congress-
men have sounded out their con-
stituents they will modify their
views on such measures as the neu-
trality and lending programs. The
former was held over until next year
as the latter was killed by a bi-
partisan coalition in the House.

Seven Cases Aired

Louise Simpkins and Morgan
Forham were adjudged not guilty
in a case charging them with tres-
passing.

Marylin Barrow was given a 30-
day sentence and was sent to the
roads for failure to pay the cost
after being convicted on a charge
of drunkenness.

GEORGIA BELT
AVERAGE DOWN

Growers Paid 13.67
Second Week; Bor-
der About 18

Atlanta, Aug. 7.—(AP)—Second-
week sales in the Georgia bright
leaf tobacco auctions totaled \$4,801-
360.59, the State Department of
Agriculture reported today.

Growers sold 35,135,362 pounds in
15 markets for an average price of
3.67 cents.

This compared with the opening
week's average of 14.75 when grow-
ers disposed of 27,024,786 pounds for
3.85-5.75-6.2.

With well over half of the new
crop already sold, the season total
for Georgia showed 62,160,148
pounds auctioned for \$8,786,836.21.

Today began the first day of a
full week's sales on the 15 tobacco
markets in the border belt of the
Carolinians and tobaccoists expected
large sales as the result of prices
which prevailed at the opening of
the auction season Thursday.

Border belt tobacco markets re-
ported satisfactory prices today as
the full week of the season got under
way. Offerings continued heavy and
price was brisk.

At Lake City 1,250,000 pounds were
on the warehouse floors and a day's
sales of 725,000 pounds or more was
expected. Prices were fair ranging
from six to 30 cents. Growers were
described as pleased with slightly
better prices for domestic type lungs
and primings.

Lumberton reported improvement
in both prices and quality over last
week's offerings.

Tabor City's opening average was
estimated at 19 cents. The probable
day's sale was placed at 200,000
pounds. Last week sales for Thurs-
day and Friday totalled 450,000
pounds.

An average of from 18 to 19 cents
was reported on the Darlington
market. Medium grades were said
to be selling better than they were.

Agree to Vote By
Automotive Labor

Detroit, Aug. 7.—(AP)—An official
of the American Federation of La-
bor-United Auto Workers announced
today that his union had consented
to a National Labor Relations Board
poll of Packard Motor Company em-
ployees and would not contest simi-
lar elections ordered for Chrysler
Corporation, Briggs Manufacturing
Company and Motor Products Com-
pany plants.

The announcement apparently
averted the likelihood of a CIO-
UAW strike in the Packard plant
authorized yesterday by a vote of
the Packard local.

Frank Bowen, regional director of
the NLRB, said today that the
Packard vote would be held August
17. The Motor Products poll is
scheduled for August 15. Elections
in the Briggs and Chrysler plant,
Bowen said, will be held later.

Fred Durrance, regional director
of the UAW-AFL, in making his an-
nouncement, said the move was in
line with a recently adopted policy
of the union. Earlier there were
indications that the UAW-AFL
would contest the board order.

"We will not try to block the elec-
tions in Chrysler, Briggs and Motor
Products either," Durrance said in
announcing he had signed the stipu-
lation consenting to the Packard
election "because we have cleared up
an important point with the labor
board."

Seeking Driver of
Liquor - Laden Car

Local ABC officers are attempting
to identify the owner of an automo-
bile which was wrecked during a
chase Saturday afternoon and
which the officers said contained 19
gallons of illegal liquor.

The officers said the car had been
sold, but the title was not changed.
The liquor-laden car was
"jumped" on Railroad street and
a chase started which extended
through a colored section of the
city, out Fourteenth street on route
42 a dirt road. The car turned over
about a mile from Bell's fork and
the occupant jumped and ran.

Officers are checking the license
number with motor vehicle officials
in Raleigh in an effort to determine
the present owner of the car.

SHIP COLLIDES
WITH ICEBERG

Freighter, However,
Not Believed Bad-
ly Damaged

Boston, Aug. 7.—(AP)—The 503-
foot Canadian Pacific Steamship
Lines' freighter Beaverhill, bound
from Montreal to London, struck an
iceberg early today off the northeast
coast of Newfoundland, but several
hours later she reported she was in
no immediate danger and the Coast
Guard said she was proceeding on
her way.

Laconic radio messages ashore
gave few details of the incident and
none to explain whether the Beau-
verhill had been badly damaged.

The liner Ausonia reported nearly
five hours after the accident that
the Beaverhill was proceeding slowly
in dense fog and the Ausonia was
standing by. The SS. Montclair was
10 miles away and on her way to
the Beaverhill's aid.

The Coast Guard cutter Cham-
plain, on ice patrol, reported the
vessel struck the berg at 5:30 a. m.
E. S. T., about 100 miles off the
Newfoundland coast.

Receipt of word that the Beau-
verhill was taking no water and that
she was proceeding, coupled with
the absence of any wireless report
for assistance, led mariners here to

Cooper Denounces
State's Sales Tax

Wrightsville Beach, Aug. 7.—(AP)—
Members of the North Carolina
Food Dealers Association, in annual
convention here today, heard Mayor
Thomas E. Cooper of Wilmington
say:

"If you think that crooked bunch
in Raleigh is going to take the sales
tax off you are crazy."

He said he proposed to fight with
the retailers in an effort to remove
the sales tax. Declaring the "Ralph
McDonald plan of taking it off all
at once is unsound," Cooper said the
sales tax can be removed one-half
of one per cent each biennium.

He described the levy as a tax on
poverty and added "taxes belong to
the people who can afford to pay."

Four Expected In Race
Not Born In Tar Heel

Raleigh, Aug. 7.—Four of the half-
dozen North Carolina citizens most
prominently in the public prints as
candidates for governor cannot join
with full truth and veracity in sing-
ing "I'm a Tar Heel born, a Tar
Heel bred and when I die I'll be a
Tar Heel dead."

All of them may have voice
enough to carry the tune and they
may be able to subscribe to the lost
two-thirds of the dirty, but only
James Melville Broughton and Allen
J. Maxwell are Tar Heel born.

Of the other four, two let out
their first wails of anguish and
alarm at conditions in Virginia—
Willis Smith whose native city is
Norfolk, and Lloyd Lee Gravelly,
who entered the world at Danville.

Another is a Jay Hawker by birth,
Lieutenant Governor Wilkins P.
Horton, whose natal spot was Kan-
sas City. Still another, William-
son's Tom Cooper, claims South
Carolina. Mullins the city, as his
native heath—maybe that's where
he gets some of the fire he puts into
his attacks on the "Raleigh Gang."

And so, speaking purely from a
numerical standpoint and with no
regard whatever to the relative po-
litical standing of the candidates,
it's two to one that North Carolina
will come January 1941 set its first
non-native born governor since the
days when the King of England used
to send them over to carry out the
royal writ.

As to age, the oldest (Maxwell) is
something over 66, the youngest
(Gravelly) isn't yet quite fifty.

PROCEED WITH
PLANS TO PEG
FARM PRICES

Commodity Credit
Corporation Voted
\$119,000,000

RATE OF LOANS
EXCEED PRICES

Appropriation To Be
Used in Attempt to
Provide Farmers
With Better Prices
For Crops

Washington, Aug. 7.—
(AP)—Administration farm
officials went ahead today
with plans to maintain arti-
ficial props under prices of
major agricultural products
after Congress, in one of its
final acts, voted \$119,000-
000 to restore the capital
stock of the Commodity
Credit Corporation.

The appropriation gave the agency
about \$250,000,000 for loans to farm-
ers on surpluses of wheat, corn, cot-
ton, wool, dairy and other farm
products withheld from markets,
until prices improve.

Officials explained that such loans
made at rates in excess of market
prices, tend to lift and maintain
prices above what they otherwise
would be.

For example, loans are being
made on wheat stored on farms at
rates averaging about 61 cents per
bushel. While local prices are slightly
below these rates, officials believe
they would be considerably lower if
it were not for the loans.

The corporation expects to use
about \$100,000,000 for wheat loans
about the same amount for corn
loans. The balance will be held for
other commodities.

The agency already had \$550,000-
000 invested in loans on cotton total-
ing 11,050,000 bales. Officials
doubt there will be any material de-
mand for cotton loans this season
in as much as market prices are
above rates at which loans would be
made.

Negro Jailed for At-
tempted Rape on
White Child

Freddie Lee Coward, 12-year-old
Negro, is being held in the county
jail, without privilege of bond,
charged with attempted criminal
assault on a six-year-old white child
of the Bernard's crossroads com-
munity. W. G. Leggett, county jail-
er, revealed today in reporting sev-

Former Gov. Leche
Of New Orleans
Accused

New Orleans, Aug. 7.—(AP)—
Former Governor Richard Leche was
today, along with Seymour Weiss,
hotel owner and powerful political
figure, on charges of violating the
Connally "hot oil" act.

Named with Leche and Weiss in
the indictment, which Attorney Gen-
eral Frank Murphy studied yester-
day, is William Weiss, a prominent
oil field operator and the East
Texas Refining Company.

Weiss also was charged in another
indictment with evading payment
of income taxes for 1938 and he and
Louise Lesage, suspended assistant
to the president of the Standard Oil
Company of Louisiana, were named
in a third indictment as conspiring
together to violate the income tax
laws.

Weiss and Lesage had previously
been indicted on mail fraud charges.
Weiss and Leche were accused of
receiving \$67,000 each in the pur-
ported deal. Leche, one-time lieuten-
ant to the late Huey P. Long, quit
the governorship six weeks ago
today, after announcing the resig-
nation of Dr. James Monroe Smith
as president of Louisiana State Uni-
versity.

The indictments charged Weiss
and Leche were partners in an
agreement by which Burford built
a 59-mile pipe line from the Rodessa,
La., oil fields near Shreveport to
East Texas and the Pelican Oil
Company, given a daily increase
from 5,000 barrels to 20,000 barrels
by the State Conservation Depart-
ment.

The government alleged the East
Texas Refining Company agreed to
take 1,000,000 barrels of the "hot
oil," but that only 480,000 barrels
were actually shipped, on which
commissioners of \$48,000 were paid
to Weiss for distribution. The pipe
line which cost \$499,000 then was
sold for a reported price of \$950,000
and \$100,000 paid to Weiss as a com-
mission.

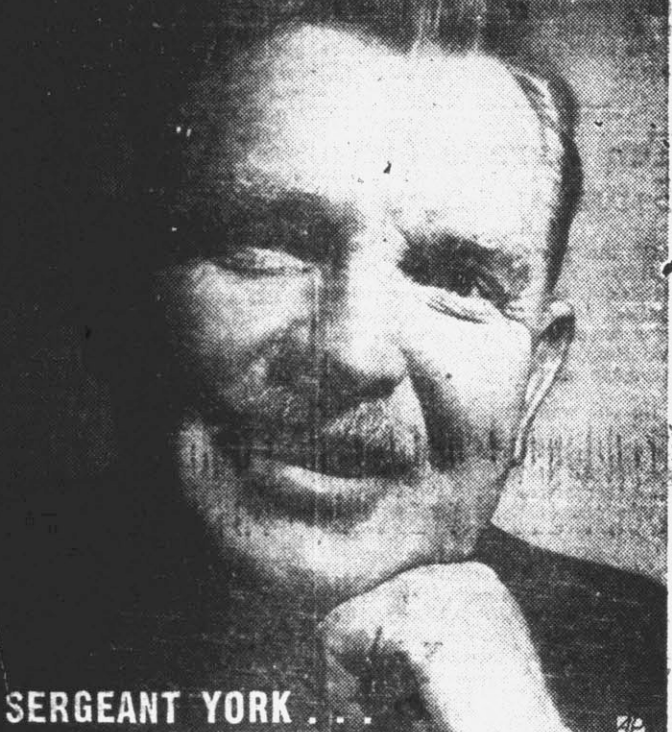

SERGEANT YORK

WHO HE IS

IF YOU remember the big push of the Allies in 1918, you probably remember Sergeant Alvin C. York. A Tennessean who didn't want to enlist in the U. S. Army because of religious principles, he accomplished the most amazing individual exploit of the war when, almost single-handed, he captured 132 members of a German machine-gun company. His unerring pistol shots mowed down 25 of the company. The others gave up. York himself is a descendant of German immigrants to the U. S. He has five sons and two daughters and doesn't think that's a particularly large family. He plans to send his children to college, expects his sons to become farmers, but won't object if they don't. York is 52, looks younger. He weighs 250 pounds, but doesn't look fat—just strong. And he has the biggest hands you've ever seen.

We had in my day and that was about three months a year for ten years. I was educated in the university of hard knocks—that's what we call it. But my kids, they've always gone to school eight months a year because things have changed.

"When I came back from the war I decided that what we needed was some schools so for years I made cross-country lecture tours, telling people about how we didn't have much education, and raising money. In 1926 I had enough money to start my Agricultural Institute—we took in all ages. After that I got after the law-makers in the state, too, and now Tennessee's got a lot more schools and they all run eight months a year. We've got 304 students in our high school and 440 in the grades now.

"Sure I belong to the American Legion, Mark Twain Post 137 in Jamestown, Tenn. That's my county seat. But we don't talk about war—we do philanthropic work."

Man About Manhattan

New York—A detective tells me that as sure as shooting Voodooism is practiced in Harlem, Voodooism is that weird "conjury" religion said to have been imported from Africa, but more likely from Haiti, by slaves. It is predicated on the potency of various charms, such as nail-parings, dried lizards, and human hair. It is accompanied by frenzied symbolical dances and leans heavily on witchcraft.

Not long ago a Negro was arrested in Harlem for theft, and around his neck was found a conjur bag. In it were the front paws of a dead rat, a canule of "Goufus" (just powdered fish scales), nail parings, and a bone which he claimed was the knuckle of a monkey's hand.

All of these charms, if purchased from the right source, are said to be powerful enough to destroy your enemies or at least to give you an advantage over them. There is a story in Harlem to the effect that the Voodooists concentrate on Joe Louis every time he fights, and they ascribe all his victories to the infallibility of their "medicine." Joe's defeat at the hands of Schmeling on their first encounter was discounted on the theory that some of the more powerful Voodoo worshippers, taking a temporary dislike to Louis, conjured up an even more powerful form of medicine and turned it against him.

Where the Voodooists meet is a closely guarded secret, but this detective tells me their worship is a perversion of the old Voodoo and is allied with the "loco" weed belt, or marijuana, dives, of which there are supposed to be more than 500 in Harlem. The effects of the weed make its users more conducive to mass hypnotism, an essential part of Voodoo ritual.

They tell me there are even "drug stores" in Harlem to which worshippers go for their charms, the most potent of which is "gris-gris," said to be so powerful that all you have to do is leave a little "gris-gris" on your enemy's doorstep during the dark of the moon and he will disappear. Dried toads, powdered bone, powdered fish scales, snake skin, dried human skin, dried lizards, and various "ointments" are available for true believers.

Each of these charms has a special purpose. If you work for a man who isn't paying you a decent wage you simply confer with the chief medicine man and he suggests a "remedy." These medicines are powerful enough to insure your success in business and to confound your rivals in courtship.

Although Voodooism has been practiced since the Revolutionary war in this country, no one really knows much about it. Authorities have no date for its arrival in America. Said to be a relic of the Guinea coast, it is more probable that it developed in the French colonies in the Indies. It flourished strongly in the slave districts up to and after the Civil war, particularly along the Mississippi and in New Orleans.

That its influence should have reached Harlem, famed black belt of the Metropolitan area, seems inevitable. How strong it is, whether it approximates the ancient fanaticism of the early arrivals, no one knows.

But it survives, and will survive as long as there are such things as witches and goblins to ride broom sticks in the dark of the moon.

FEED SAMPLES ARE EXAMINED

Agriculture Department Lists Many Activities

Reflector Bureau.

Raleigh, Aug. 7.—A total of 1,798 samples of feed were examined microscopically and chemically by the North Carolina Department of Agriculture under the provisions of the state feed law during the year which ended December 31, 1938, according to somewhat belated announcement in "The Bulletin," just published by the department.

Complete analysis of each sample taken and a detailed report of feeding-stuff inspection during 1938 is included in the Bulletin.

Computed from the sale of tax tags there were 310,426 tons of feed sold in the state in 1938 compared with 290,740 during the year 1937.

The four inspectors—C. H. Lutterloh of Pittsboro, J. S. James of Maple Hill, T. A. Holcombe of Candler and E. J. Harrington of Carthage, visited every county several times during the year and collected a total of 1,538 official samples.

During the year a total of 12,232 bags of feed were withdrawn from sale for various violations of the feed law, and the registrations of 16 brands were cancelled. Three hundred and eighty-four lots of feed were seized and held for satisfactory adjustment with the department. A total of 2,434 bags of feed was returned to the manufacturers for failure to comply with the law.

Penalties amounting to \$603 were assessed to cover the cost of the seizures made.

In the further effort to enforce the feed law, the department reports, the columns of the Agricultural Review, official publication, with a circulation of 19,000, have been used to inform the public of low analysis and incorrectly labelled feeds.

lot who has not at one time or another been a member of the North Carolina House or Senate, and the Revenue Commissioner is listed as with "legislative experience" by reason of the fact that as far back as 1899 he was clerk of the Senate and for ten years (1901 to 1910) he was principal clerk of the upper chamber.

Mayor Cooper served two terms in the House (1935-37); Smith was Speaker of the House in 1931 later serving in the ranks in 1927 and 1928; Broughton was a Senator in 1927 and again in 1929; Horton has three Senate terms (1919, 1927 and 1931) in addition to two terms as presiding officer of it (1937-39); Gravelly was a four-term Senator (1920-31-35-37).

None of the six is an eligible bachelor, so the maiden ladies' vote will probably be split. Broughton's senatorial biography lists four children; Smith's shows he married in 1919 but is silent as to offspring. Gravelly has a son and daughter; Horton's biography in the 1939 Legislative Manual says nothing about children, but showed he married in 1918. Cooper has two children. Maxwell has been twice-married and has four children.

By occupation Broughton, Horton and Smith are lawyers; Maxwell has been a public official virtually ever since he became Mayor of Whiteville back before this century began; Cooper is Mayor of Wilmington, after having been a banker and a mule dealer; Gravelly is a tobacco-nist.

Religiously the Methodists have four to Baptists two (Broughton and Maxwell). Horton, Smith, Cooper and Gravelly are all listed as Methodists.

Washington Daybook

Washington—This outgoing ses-
sion of Congress could easily go
down in history as the Second War
of the Rebellion.

In it the South fought off domi-
nation by northern and western el-
ements of the party led by the New

Deal. Likewise it
won most battles
in which north-

ern industry was
pitted against
southern indus-

try. In both
classes of issues,
naturally, there
were exceptions,

and there were
exceptions. For
some of the South-
erners stood staunchly
by the New Deal.

The South was
not in complete
rebellion, of
course, nor was

it always alone
in rebellion. The Southern support
was credited with salvaging the re-
organization bill, trimmed though it
was. In turn, there was almost
unanimous congressional support
for the agriculture bill in which ad-
ministration objections were over-
ridden heartily. The big money ad-
ditions were made in the Senate
where, under leadership of Senator
Russell of Georgia, well more than
a quarter-billion was added to the
agriculture budget figure. And the
increased benefits were directed
heavily southward.

They Had Support
The southerners did not win out
alone. They won in many of their
efforts principally because of Re-
publican support.

The concluding blow of this com-
bination was the wrecking of the
spending-lending bill. Republicans
and southerners led the attack in
the Senate by which it was whittled
from a huge spending program to
little more than a farm aid bill. The
same combination in the House
amassed most of the votes by which
it finally was prevented from reach-
ing the floor.

When the relief bill was up, a
southern representative, Woodrum
of Virginia, led the same combi-
nation in obtaining an investigation
of WPA. The result was that many
of the so-called "ultra-liberal" fea-
tures of WPA, such as the federal
theater, went out. Restrictive fea-
tures were written in and polished
off both in the House and Senate.

Another Virginian, Representative
Smith, succeeded in winning House
approval for an investigation of the
Labor Board, which has been ana-
thema to many southern industrial-
ists. Again the core of his support
was from the South.

Housing, Wages, Security
The administration request for
\$800,000,000 authorization for slum
clearance was stilled by southern
opposition which contended it was
principally of benefit to a limited
few big cities.

The Hatch bill to outlaw "per-
nicious political activities" of fed-
eral employees was hardly to be
classified as southern legislation, as it
was initiated by the New Mexico
senator whose name it bore. Never-
theless it had heavy support from
southern members, who considered
it a curb on patronage politics in
the south.

Wage-hour amendments, fought
by the administration, made head-
way largely because of support of
southerners who had persisted in
demanding regional differentials
to permit the South to

dustry. Finally, southern states pushed
through to a showdown the social
security amendments by Senator
Connally of Texas. They were de-
signed to pour a larger portion of
old age benefits southward.

The net result has been a recoup-
ment of southern influence in the
party and a substantial tempering
of the labor laws whose effect, di-
rectly or indirectly, was to reduce
the South's competitive advantage
from its cheap labor.

SHORT SHOTS

Reflector Bureau

Raleigh, Aug. 7.—Members of the
State Bureau of Identification and
Investigation, headed by Director
Fred Handy, are rapidly acquiring
for themselves in North Carolina
the same sort of reputation enjoyed
by Edgar Hoover's sleuths of the
Federal Bureau of Investigation.

At the "bull pen" or political
table of a local grill, the following
conversation of them occurred
recently. Incidentally, it's a hard
and fast rule at this table that
newspaper men are welcome to
come, eat, take part in the ball ses-
sions and use any information they
can pick up with the definite and
distinct understanding that no
quotes by name are permitted.

"If they call the FBI operatives
'G-men,' do you suppose we ought
to call our state bureau detectives
'S-men?'" queried one at the table.

"No, just call them Handymen,"
came back another.

"But, after all, it's how they an-
swer, not how they're called that
really counts," broke in a third.

Recent discussion by the Raleigh
city fathers of ordinances making it
illegal to open grocery stores on
Sunday, even for the sale of bread,
while at the same time cafes and
restaurants are free to sell any kind
of eatables, including sandwiches,
brought the following crack from
Lynn Nisbet, Luck-witted local
journalist:

"Old man Moses, first to start
these Blue Laws, made it illegal to
eat pork in any form on Sunday or
otherwise. Now Raleigh's making it
illegal to sell bread on Sunday;
which will make both pork and
bread taboo. But by putting a sliver
or two of pork between two slices of
bread it will make everything per-
fectly legal."

It's getting to be quite the thing
to put newspaper editors on pro-
grams of all sorts. Latest indication
is assignment of "Bob" Gray, Jr.,
Fayetteville Observer editor, to one
of the top spots as a speaker at the
annual convention of the North
Carolina Truck Owners Association
at Wrightville Beach this week.

Gray will talk at the association's
Saturday luncheon.

Speaking of editors and speeches,
orchids are being widely awarded
Talbot Patrick, president of the
State Press Association and pub-
lisher of the Goldsboro News-Ar-
gus. When he made his report and an-
nual address at the convention last
week, his own paper did not use up
most of its front page telling what
Mr. Patrick said.

This is in marked contrast to the
practice of some papers, notably the
whose big boss is ambassador to a
neighboring country. Others, also,
often have been caught at the prac-
tice of boosting their own big bosses
at the expense of other news and
the innocent subscribers.

Further indication, if any was
needed, that the North Carolina
State Employment Service is not
solely an agency through which do-
mestic servants and ditch diggers
can be hired is found in the recent
registration at the Raleigh office,
all within one week, of four civil
lawyers—one a graduate of Wash-
ington University Law School, the
other three trained at Wake Forest.
All hold LL.B. degrees and have had
considerable experience in other
fields.

Bottler's Head



WALTER S. MACK

The special meeting of stockhold-
ers of the Pepsi-Cola Company was
called to order last week by the
president, Walter S. Mack, Jr.

Mr. Mack outlined briefly the con-
ditions of the company at the pres-
ent time. He stated the stockholders
probably knew, from articles ap-
pearing in newspapers recently, that

the company has just gone through
the most profitable six months in
its history, showing estimated prof-
its, after estimated reserves for
depreciation and taxes, including
income taxes, of approximately
\$2,500,000 for the first six months
of this year, which is about 76 per
cent above the figure for the same
six months of last year.

Mr. Mack stated there were about
400 franchise bottlers covering the
United States, about 100 franchise
bottlers in Canada and about 60
franchise bottlers in other parts of
the world. He further stated that in
a few places in the United States,
Pepsi-Cola was outselling in bottles
any of its competitors in the Cola
field, and plans were now being
formulated to improve sales through
sales promotion and organization,
and that some field men already
have been sent out to aid and
stimulate the franchise bottlers
throughout the country.

Mr. Mack further stated plans are
being made to organize franchise
bottlers throughout Europe and
South America and that the com-
pany recently appointed Mrs. W. B.
Forsythe, an English Canadian who
has had experience in the develop-
ment of Cola drinks in Europe, to
be in charge of this work, with
headquarters in London. The Cuban
plant has just recently been finished
and will open for operation within
the next 10 days; plans are being
formulated to make it the seat of
operations for Central and South

America. All subsidiaries of the
company are wholly owned, includ-
ing the English company, Cuban
company and Canadian company.

Mr. Mack stated the company has
just recently gone into the six-bottle
carton carrier for chain stores which
they had just started to push ag-
gressively, and is showing exceed-
ingly good results. He further stated
that the company's New York plant,
which is probably the largest bot-
tling plant under one roof in the
world, would probably have to be
further enlarged, and plans are be-
ing made to increase its capacity
this fall.
