

Britain Advises Hitler Of Aim To Back Poland

MESSAGE SENT BY SIR NEVILLE

Note Reportedly Requires Removal of Threats of Force As Prerequisite to Negotiations, Expected Reply Would Forestall Action Until Tomorrow

London, Aug. 28.—(AP) Britain's ambassador to Germany, Sir Neville Henderson, flew to Berlin this afternoon with a message to Adolf Hitler which, informed quarters said, reaffirmed the British intention to support Poland if she is attacked.

The details of the note were not disclosed but it was reported to have said the first requirement for any negotiation of the Polish question was the removal of threats of force.

Sources close to the government indicated the message was of such nature a reply was expected from the German fuhrer. This, it was believed, would forestall any decisive action until tomorrow at the earliest.

Sir Neville left by train a few minutes before 5 p. m. (11 a. m. E.S.T.) and was expected to reach Berlin early in the evening.

Shortly before he left London, the government took a series of emergency steps, indicating the possibility of war was still considered "imminent" as Prime Minister Chamberlain has repeatedly stated.

A special session of Parliament was called for tomorrow to hear a statement from Chamberlain on the latest developments and take any action thought necessary.

The admiralty, which already had taken control of all British shipping, advised merchant vessels to stay out of the Mediterranean and Baltic seas.

At the same time, the government made effective sweeping defense regulations under the new emergency powers act, closing military areas, restricting civil liberties and public utilities under new regulations.

The note which Sir Neville was carrying to Berlin was given final approval by a noon cabinet meeting after it had been under consideration by the cabinet Saturday night and yesterday afternoon.

When Sir Neville left Berlin airport, photographers wished him "good luck."

He responded that he wanted all "the good luck" he could get.

Berlin, Aug. 28.—(AP)—Adolf Hitler expects to receive Sir Neville Henderson, the British ambassador, at 10 o'clock tonight (4 p. m. E.S.T.) to receive the reply of his majesty's government to Germany's proposals for a solution of the German-Polish war crisis.

Arrangements for the British ambassador's visit were made while Hitler was represented in well-informed circles as willing to have some friend, like Premier Mussolini of Italy, mediate Germany's dispute with Poland.

Sir Neville was flying from London after a series of three British cabinet meetings had completed the reply to Hitler's proposals.

RUSSIA MOVES ENDORSE PACT

Parliament Meets To Effect Treaty With Germany

Moscow, Aug. 28.—(AP)—Soviet Russia's parliament took the first step toward formal endorsement of the German-Russian non-aggression pact today.

The lower house, in a four-minute session at which Premier-Foreign Minister Molotov was given a huge ovation, adopted an agenda which included agricultural taxation and compulsory military service measures, along with the non-aggression pact—the two bills making it likely the pact would reach formal ratification before tomorrow.

The upper house was called into session at 4 p. m. (8 a. m. E.S.T.) and the two houses were summoned for joint meeting tonight.

Stalin, War Commissar Marshal Klement Voroshiloff, French Ambassador Paul Nagiar and the British envoy, Sir William Seeds, were absent at the first session. A number of diplomats attended.

Tries to Avoid Wreck And then Causes One

Highway Patrolman C. R. Williams today was pondering the outcome of an investigation of a road accident last night around 8:15 o'clock involving Phillip Sullivan, white, and Oscar Carney, Negro.

Williams said that the lights of the Carney automobile went out and that he stopped to repair them. Meantime, Sullivan's car, travelling in the same direction, struck the rear of the Carney car.

"If a person's auto lights go out, he's supposed to fix them then," said Williams, who added "that if Carney's car had no lights, then it is not very easy to detect the car ahead that had no lights."

Negro Faces Charge After Road Accident

Highway Patrolman W. W. Massengill said today that William Smith, Negro, is charged with driving an automobile to the left center of the highway following an accident on the Greenville-Bethel highway.

The patrolman said an automobile driven by Smith, headed toward Bethel, side-swiped another car driven by Wiley Hines, Negro, who was headed toward Greenville. No one was injured and damage was slight.

DATE REMAINS SAME IN N. C.

Thanksgiving To Be Observed at Usual Time

Raleigh, Aug. 28.—(AP)—Governor Hoey said today he had decided not to change the date of Thanksgiving in North Carolina.

Reasons for changing the date from November 30 to November 23, as suggested by President Roosevelt, "are not impressive," the governor declared in a statement.

"After mature consideration," he said, "I have decided that it would be unwise to change the date for Thanksgiving Day, and hence the date of Thursday in November will be designated in due time as the official date, which will be November 30, 1939."

"The reasons for a change are not impressive. For 75 years the last Thursday in November has been observed in America as a day of thanksgiving. The suggestion that it is too close to Christmas and too far away from Labor Day overlooks the fact that Armistice Day is generally observed. Anyway, if Thanksgiving was to come mid-way between Labor Day and Christmas, it would be fixed for early November."

"I am advised that the orphanages in the state have plans for their Thanksgiving offering and a change of date would disrupt their program, and would result in much confusion as to many other observances of the day."

Youth Is Attacked On Street By Dog

Chief of Police George Clark this afternoon declared war on dogs running at large on the city streets after Redden Jones, 14-year-old Greenville youth, was allegedly pulled from his bicycle by a stray dog and bitten severely on the thigh.

Chief Clark said the boy had been selling peanuts on the tobacco market and was going for additional merchandise when attacked by the dog. The youth was treated by a private physician for his injury, described by Chief Clark as a "bad bite."

The police chief said the dog belonged to Sherman Parks and that its owner had been indicted for allowing his dog to run at large and would be tried in the Friday morning session of city court. Chief Clark reiterated a warning that persons allowing their dog to run at large would subject themselves to indictment.

Netherlands Decree Mobilization Orders

Amsterdam, Aug. 28.—(AP)—The Netherlands proclaimed the general mobilization of its army and navy today.

The Netherlands had about 130,000 men under arms prior to the mobilization order. The first act of mobilization should add 114,000 men to the army, or make about 244,000 all told.

The Royal Dutch Navy, which includes 12 modern men of war, has been in readiness for some time. Reservists will be used to fill out skeleton crews on second-line ships.

ANTI-SEMITIC LEADER FACING CHARGES

Tar Heel Accused of 'Diverting' Silver Shirt Funds

HAD OPERATED IN ASHEVILLE

Accusations Made by Investigator for Dies Committee Probing Un-American Activities

Washington, Aug. 28.—(AP)—A Dies committee investigator charged William Dudley Pelley of the Silver Shirts today with having "diverted" assets of a stockholders' publishing house "to his own personal uses."

The investigator, Robert B. Barker, told the House inquiry into un-American activities he had spent the past three months investigating affairs of Pelley from Asheville, N. C.

He declared that the loss of creditors and preferred stockholders of Galahad Press as a result of what he called Pelley's diversion was between \$35,000 and \$40,000.

The Galahad Press, which Barker described as a religious publishing house, was operated at various times from New York, Washington and Asheville. It was declared bankrupt in North Carolina in 1934. The witness asserted.

Barker, saying his testimony was based on a search of bank accounts and court records, declared that Pelley, who was described as an anti-Semitic leader, diverted \$100,000 of assets to his own uses and to the "foundation for Christian economics."

"Did this diversion bring about the insolvency of the Galahad Press and loss to stockholders?" Chairman Dies asked.

"Yes, sir," the witness replied.

HIGHER PRICES ON LEAF MART

Reported From \$3 to \$5 Higher Than Last Week

Prices on all types of tobacco were reported stronger on the Greenville market, as sales were resumed this morning following the week-end holiday. Offerings were reported to be bringing from \$3 to \$5 higher than on last Friday.

Today's break was mostly of common tobacco, many estimating more than half of the offerings to be tips. It was pointed out that grades are selling high and this was believed responsible for the large amount of tips being placed on the floors at this time.

Good leaf also sold good on the market today. One sale of 1,400 pounds brought \$369.62, for an official average of \$26.40 per hundredweight. The price range on the 11 grades in the sale was from \$17 to \$32, with four grades selling for \$30 or better.

All warehouse floors were cleared this afternoon and first sales will be held tomorrow as scheduled.

FRANCE MAKES ANOTHER PLEA

Directs Second Peace Appeal to Fuehrer Hitler

Paris, Aug. 28.—(AP)—Premier Daladier drew up a second letter to Adolf Hitler today in an effort to dissuade the German fuhrer from going to war and keep the way open for peaceful negotiations.

The French government simultaneously extended its preparedness for war with publication of a decree applying censorship to news and photographs.

Effective today, the decree said all printed publications, radio broadcasts and newsreels must be submitted to the newly formed general information service for approval.

DIRECT TALKS ARE REJECTED

In Declining Suggestion That He Confer Directly With Poland, Fuehrer Implies His Demands Include Even More Than Danzig and Polish Corridor

Berlin, Aug. 28.—(AP)—Adolf Hitler was represented in well-informed circles today to be willing to have some friend, like Premier Mussolini, mediate in Germany's dispute with Poland which had led Europe to the brink of war.

In rejecting direct negotiations with Warsaw, the German chancellor disclosed that his demands on Poland not only included return of the Free City of Danzig and the Polish Corridor, but also vaguely implied he would insist on other "adjustments" at the expense of Poland.

In connection with the suggestion that Mussolini would be acceptable as a mediator, reliable sources said that Bernardo Attolico, Italian ambassador to Germany, is in frequent touch with Hitler and Foreign Minister Von Ribbentrop.

Hitler indicated in a reply to Premier Daladier of France, made public early today, that he considered direct talks with Poland would be futile.

"I see no possibility for us, on our part, to exert influence in the direction of reasonableness upon Poland," the fuhrer declared.

He did not comment directly on the Daladier's suggestion that the French premier was "ready to make every effort which an upright man can undertake" toward a peaceful solution.

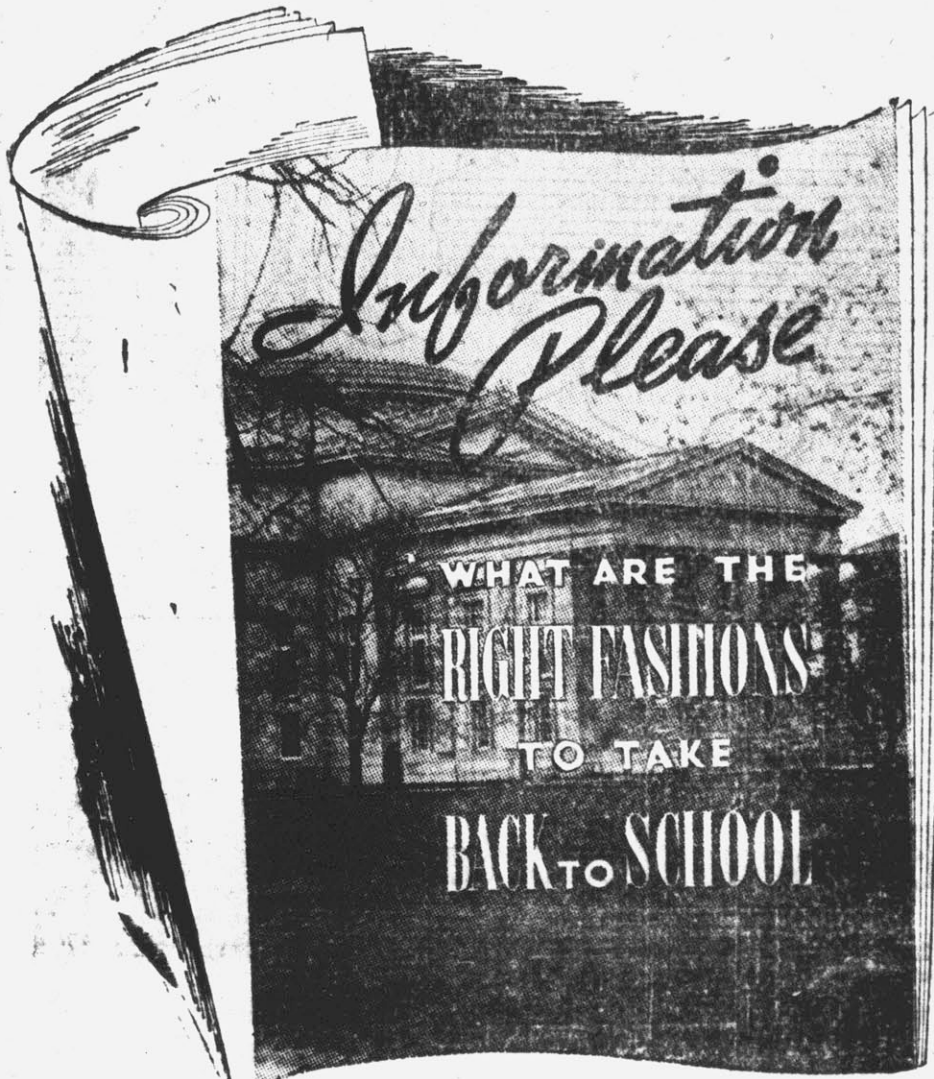

Greenville, along with other clubs in the Coastal Plain League, tonight will enter its last week of scheduled play for the season by clashing with D. C. Walker's Snow Hill Billies in the Guy Smith stadium at 8 o'clock.

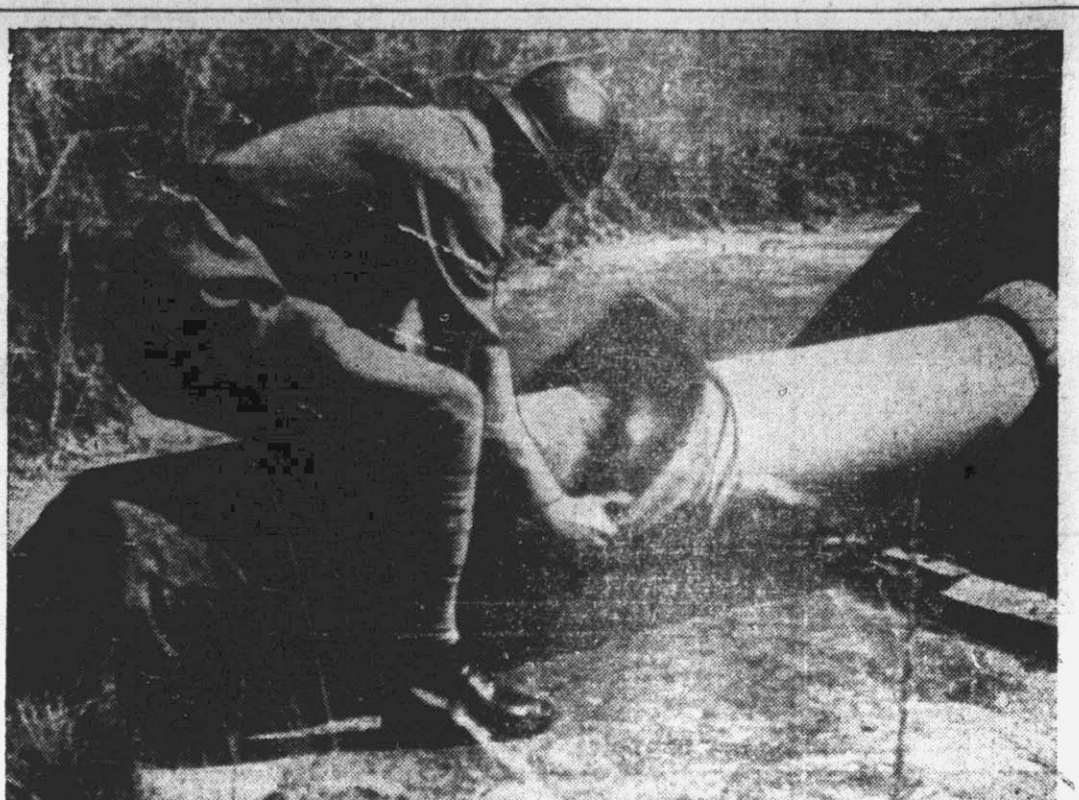

And in no circumstances, whatever his personal opinion on the picture involved shall be, shall he utter criticism thereof in front of witnesses, under penalty of dismissal.

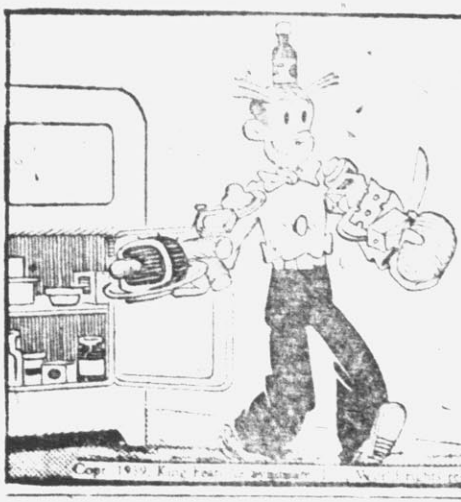

screen) will censor his son's fledgling movie career, send him packing back to his books.

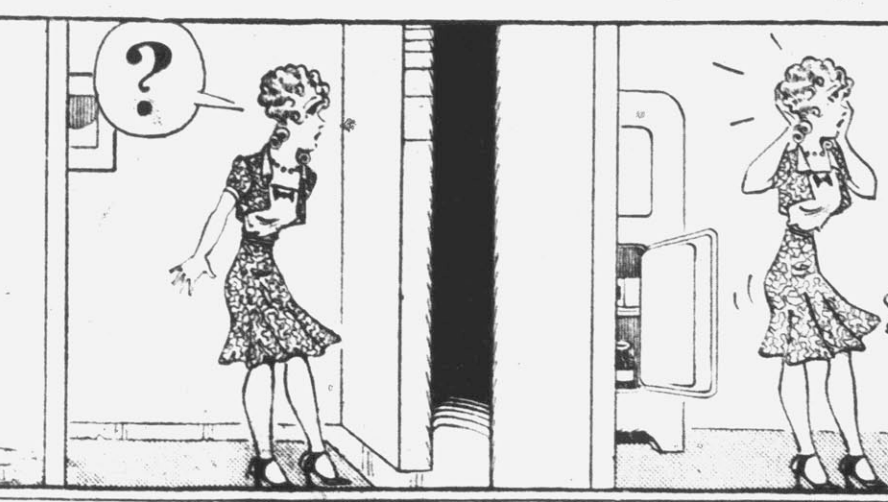

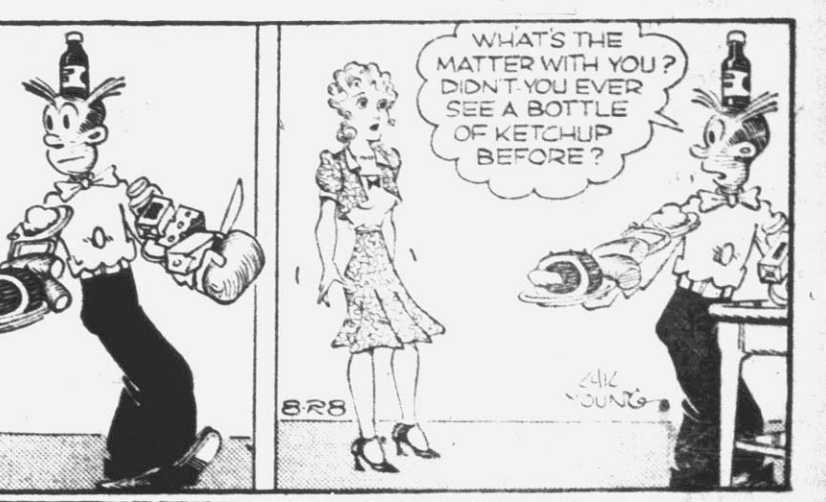

Washington — We have seen enough of these army maneuvers in the past day or so to convince us that the next war, just like the last one, is going to be hell on the feet.

That goes in spite of the motorization that supposedly moves the army through the war with the greatest ease.

There is still an awful lot of walking in a war and just plain standing around waiting for somebody else to do something so YOU can do something.

Stonewall Jackson or old General Forrest (the wasn't a Manassas general) would have shuddered until their boot buckles rattled if they could have seen how the Battle of Bull Run would be fought in these modern times. Bull Run is a muddy little rivulet about 30 miles south of Washington where the North and South first really tangled in the war that was expected to end in two weeks but lasted four bloody years.

They Obey Rules On that old battleground, and at Plattsburg in New York, the army is conducting maneuvers to test-out its new equipment and some of its new generals. From what we saw and from what we were told, both equipment and generals worked well, but the confounded roads weren't wide enough. Besides that, when the army is conducting a mock war everybody has to obey the rules. That takes all the fun out of a good war.

Old General Forrest, the black-

smith who dropped his anvil and became one of America's greatest soldiers, once said that the way to win battles was "get there fustest with the mostest men." One of these later day generals at the Manassas maneuvers tried that and almost lost the war. He was supposed to start his march for Bull Run and glory at 7 a. m., but he started instead at 6:50. He got there fustest with the mostest men but an umpire sent him back. The "enemy" had to have time to finish breakfast.

With these modern high-speed tanks a 10-minute head start means grabbing off five miles of Virginia countryside. Also a thousand army trucks can jam 50 miles of Virginia country road until a greased pig couldn't squeeze through. When that happens the boys go to war as they have from time's beginning. The boys get out and leg it across the fields.

Congress Was Missing What we missed at Manassas was Congress. Congress quit early on the day of the first battle of Bull Run in 1861 and followed the Union forces out of town to watch them wrap up the Johnny Rebs. Members perched themselves on convenient hillsides to see such sport as Congress is rarely treated to.

Hastily and badly organized, both Feds and Confeds were about to take to their heels before the battle was many hours old. But Stonewall Jackson held his Virginians to the line and the other Confederates rallied. No Federal general stood "like a stone wall" to encourage the union forces. They broke and started for home and mother.

Congress adjourned from the surrounding hillsides, singly and in groups. There was no threat of filibuster. They headed for Washington by unanimous consent.

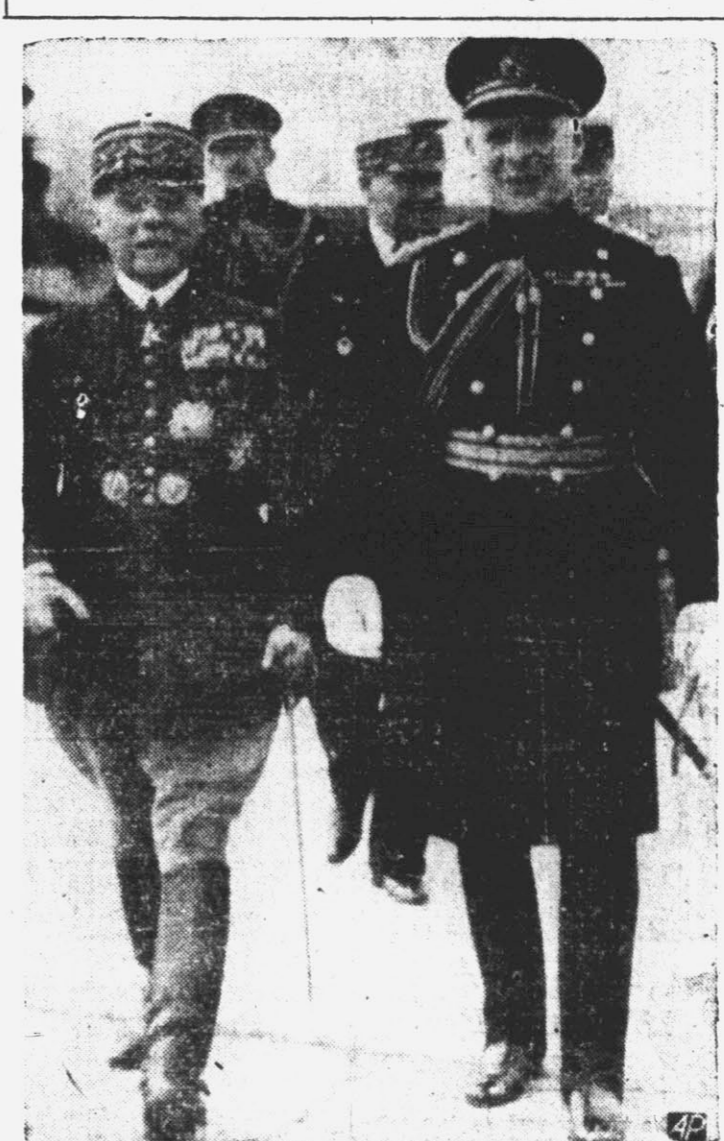

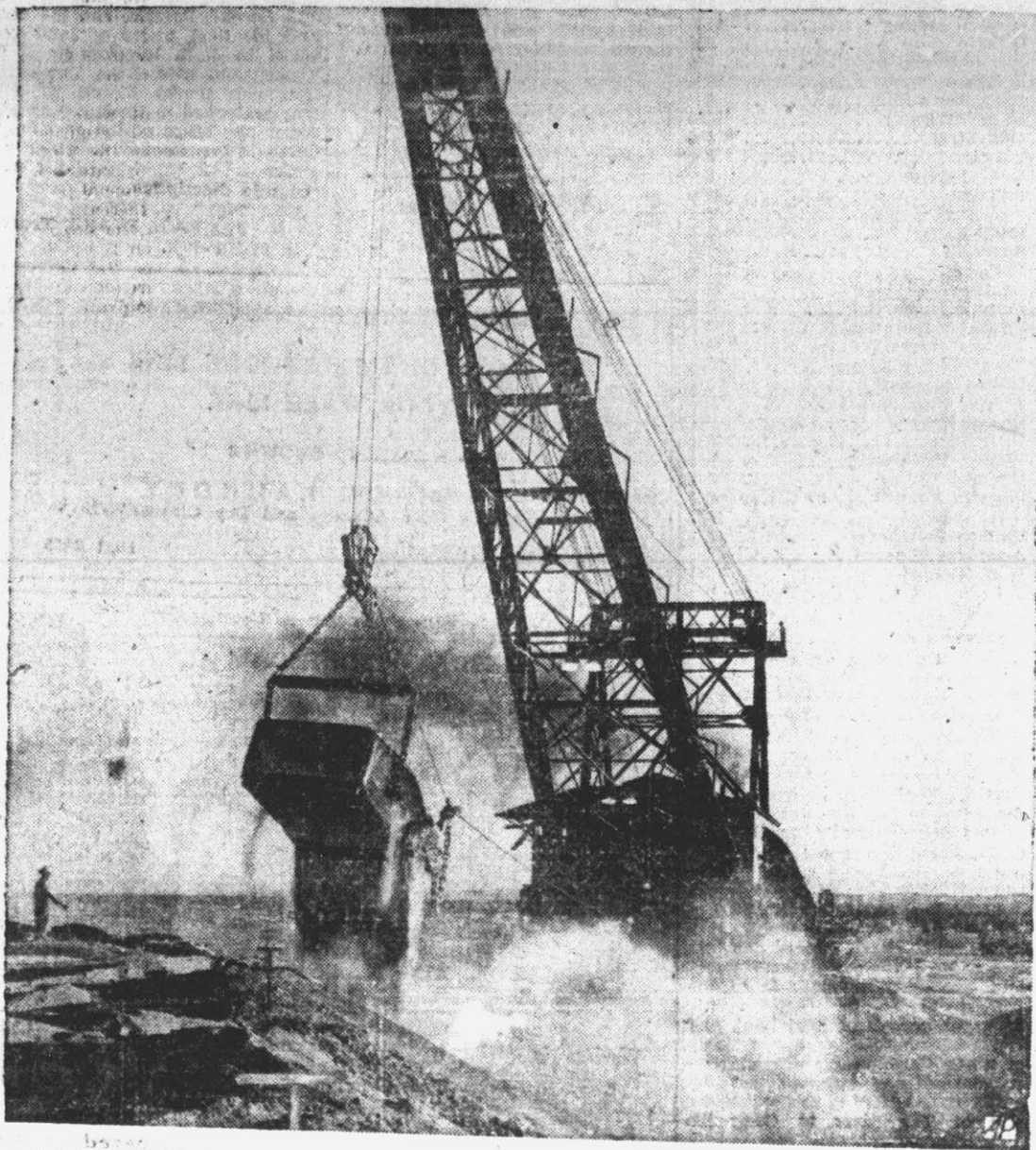

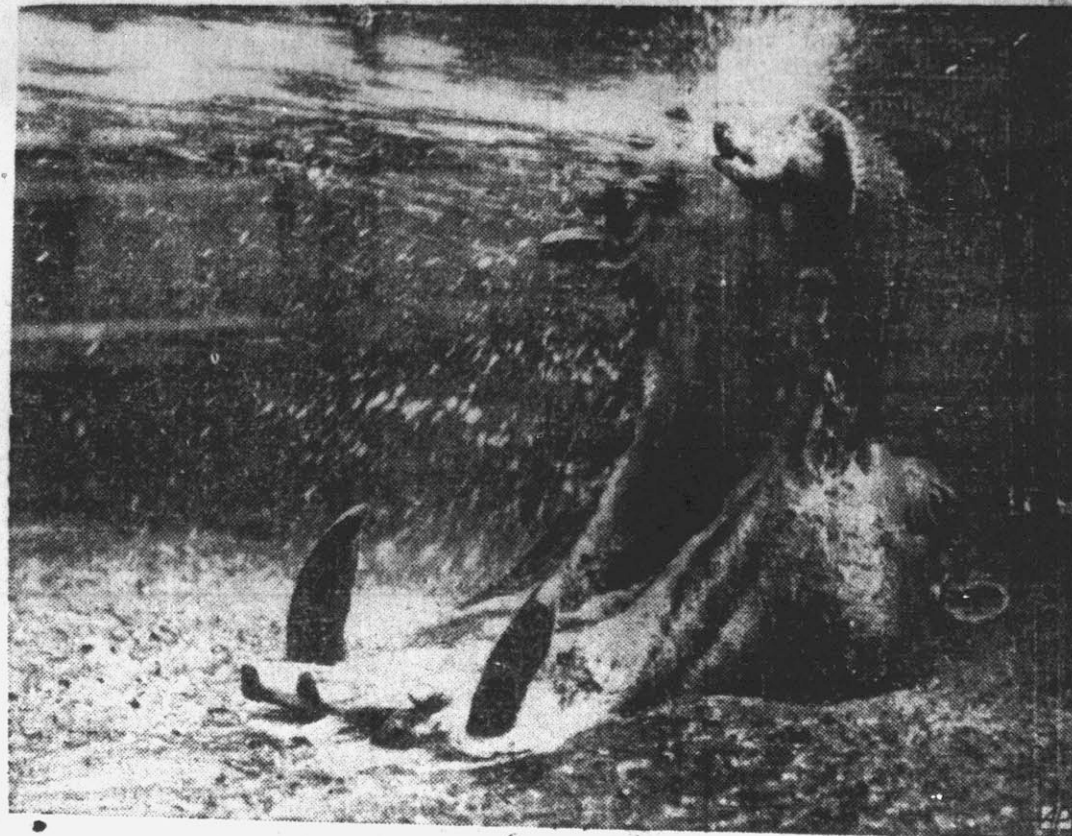

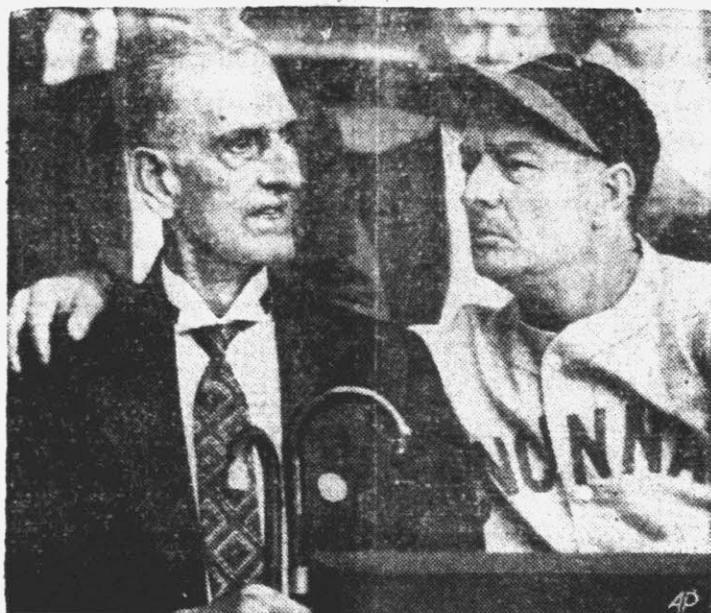

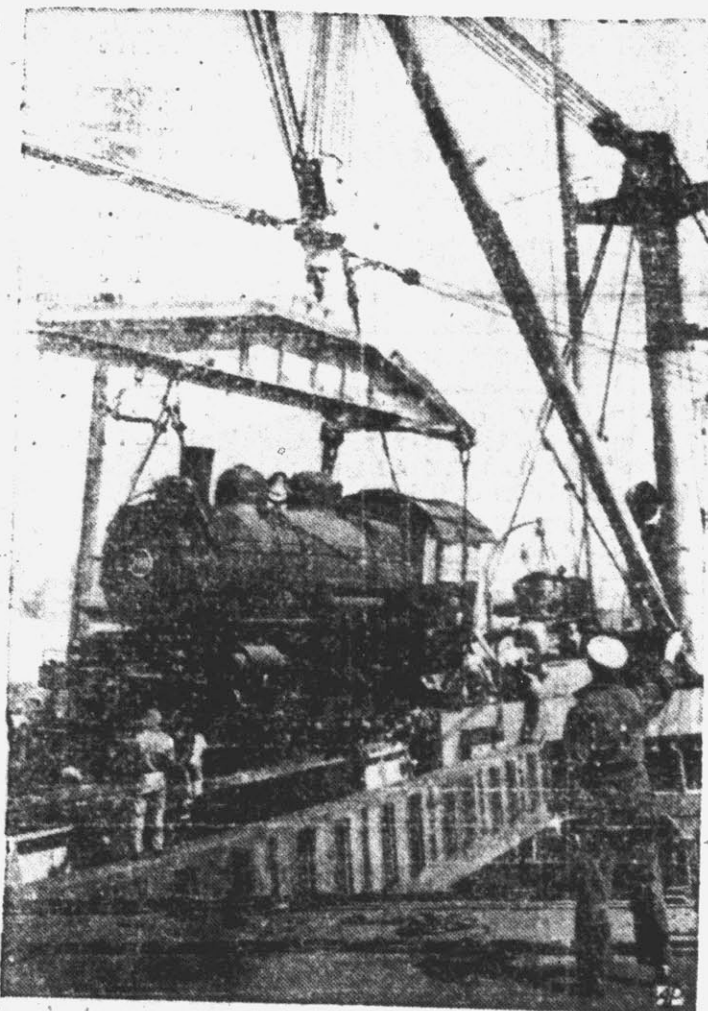

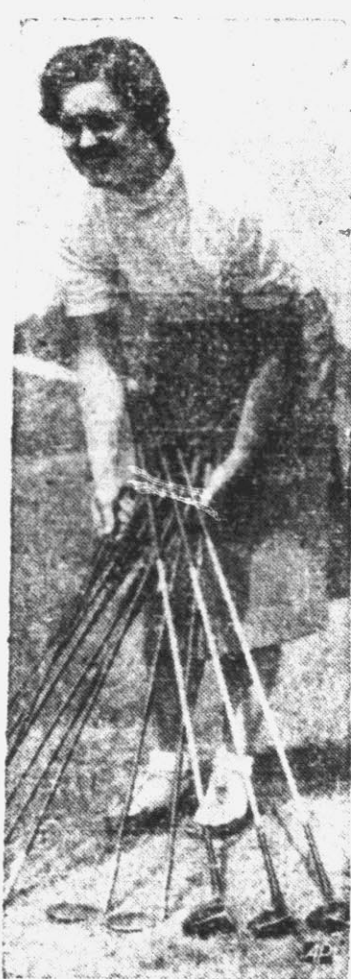

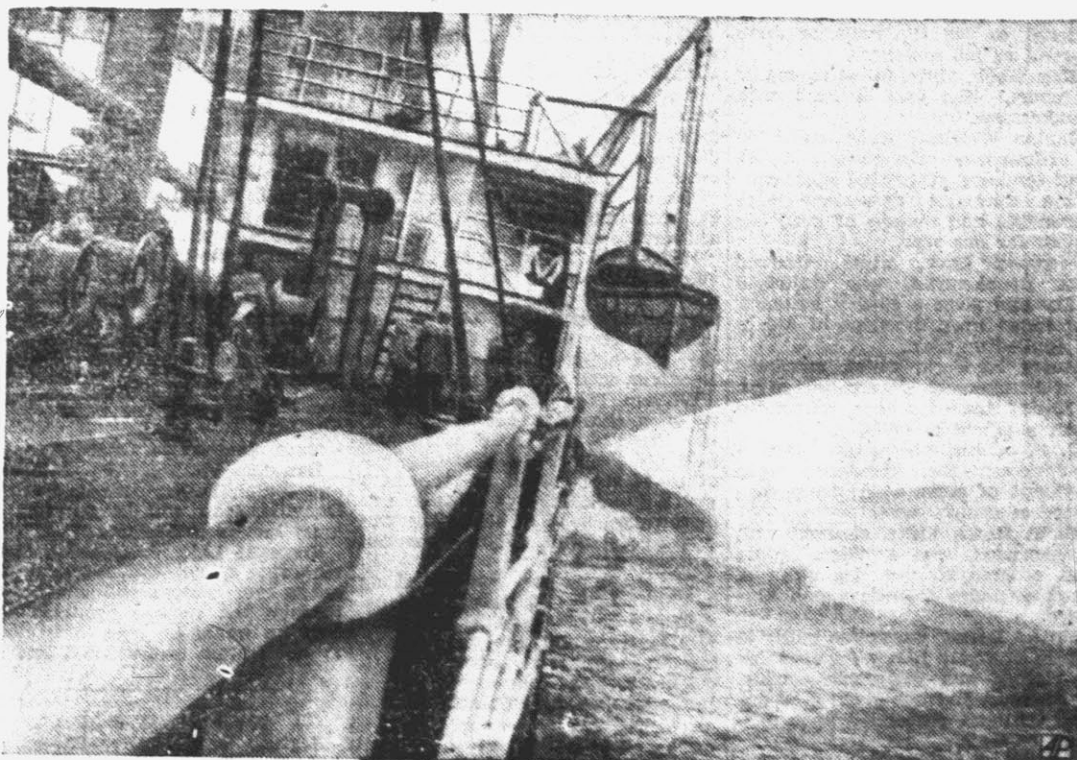

CATTLE SALES ARE PROMOTED

Western N. C. Farmers Want to Sell To East

Raleigh, Aug. 28.—Cattle growers of Western North Carolina have more than 12,000 desirable beef animals they'd like to sell in Eastern North Carolina, or to producers in other states, and the State Department of Agriculture is going to do all it can to help promote the sales, it appears from a neat booklet just issued by the department.

The booklet has been mailed to prospective purchasers, and contains a complete enumeration of the 12,750 "for sale" cattle which are owned by 607 farmers of Allegheny (Ashe, Avery, Buncombe, Haywood, Madison, Mitchell and Watauga).

Boosting the sales, Paul L. Fletcher, livestock marketing specialist of the department, who declares that North Carolina feeder cattle gain on an average of 100 pounds more per year than animals wintered elsewhere.

"This should prove an attractive feature in disposing of the animals," Fletcher said. "Prospective buyers are being sent an illustrated bulletin listing the name of the owners and a complete description of the animals offered on the market."

The booklet is being sent to approximately 2,000 buying prospects, including 665 out-of-state livestock growers.
