WOULD RECESS CONGRESS FOR ACTION BY FDR

Could Be Free to Intervene in Behalf Of Peace

ACTION BLOCKED FOR THE PRESENT

Johnson (D-Col.) Announces He Will Renew Efforts When Downey Finishes Speaking

Washington, Oct. 9. (AP) - The Senate leadership blocked temporarily today an effort by Senator Johnson (D-Col.) to recess the chamber to give President Roosevelt a free hand to work for European peace.

Johnson told the chamber that "the whole world would be satisfied" if the Senate would recess for three days. He said that would be considered a sign that the United States wanted peace in Europe and that the people were counting on the chief executive to do what he could to effect it.

"We must accept the belief that Germany will listen - will accept an honorable peace," Johnson told the Senate. "They know how the President stands. When they call him in they must be seeking an honorable peace."

The Colorado Senator cited press reports of Germany's willingness to let Mr. Roosevelt act as a negotiator for peace.

When Johnson concluded, Majority Leader Barkley (D-Ky.) urged that the recess motion be withdrawn. He said that Senator Downey (D-Calif.) had expected to have the floor for a continuation of his address against the administration's neutrality bill which would repeal the existing embargo against the sale of arms to belligerent countries.

Johnson withdrew his motion, but served notice that he would renew it after Downey had completed.

Meanwhile Rep. Fish (N.Y.) proposed that the House agree to a minimum of 30 hours debate on the neutrality legislation when the resolution finally reaches it from the Senate.

Deladier to Speak

Paris, Oct. 9. (AP) - The War Ministry announced today that Premier Daladier had decided to broadcast a speech to the nation tomorrow as the result of Adolf Hitler's peace speech last Friday.

Daladier's address will be broadcast on a nation-wide French hook-up at 8 p. m. (2 p. m. EST).

Before announcement of the speech, Daladier conferred with Generalissimo Maurice Gustave Gamelin, chief of the British-French land forces.

Formal peace proposals have not been presented to France. Nazis in Berlin said after Hitler's speech that his peace proposals would be given no more formal character.

SUB SEARCHED OFF U. S. COAST

Craft Reported Seen 200 Miles Off Iriquois Route

Portland, Me., Oct. 9. (AP) - Persistent reports that a U. S. navy and coast guard craft were searching by sea and air for a submarine sighted off this coast yesterday approximately 200 miles off the normal course of the "Iriquois" refugee ship Iriquois were met with silence today by all official sources.

Arthur Greenleaf, Maine's commissioner of sea and shore fisheries, announced he saw the submarine moving at high speed on a course that would take the craft in the general direction of the European ship lane.

Navy and coast guard officials both in this state and in Boston declined to confirm or deny reports that a wide search was being made for the submarine.

While five miles off Portland lights on coastal patrol, Greenleaf said he and two wardens saw the submarine within 50 yards of their motor cruiser yesterday, start to circle the patrol boat and then speed off to the southeast.

Portland, N. H., navy yard officials said no American undersea craft was near the position given which is 13 miles south of Portland.

Twice before since the war began fishermen have reported unidentified submarines off the main course.

Washington, Oct. 9. (AP) - The White House said today that navy patrols had observed an un-American submarine yesterday about 20 miles west of Key West, Fla.

Stephen Early, a presidential secretary, said it was possible it was the same boat which was reported Saturday 15 miles off Miami, Fla.

The submarine, Early added, was comparatively small. Also seen in the same vicinity, he said, were two non-American tankers.

He declined to say, however, whether the submarine and the tankers were of the same nationality.

"This information is still in the process of being checked," Early said.

He made that statement when asked whether other governments and American shipping had been notified of the presence of the submarine.

Still In Winterville Township Destroyed

Members of the Pitt county ABC force and of the sheriff's office yesterday located and destroyed a 50-gallon capacity steam liquor distillery in Winterville township.

The still was not in operation and no one was at the site when officers arrived. The still and 100 gallons of beer were destroyed.

Officers described the plant as being a crude affair.

Two to Cooperate On Any Official Statements

REPLY MADE TO POINTED QUERY

Allies' Principal Aim Of Crushing Hitler Repeatedly Stated By British Government

London, Oct. 9. (AP) - Prime Minister Chamberlain told the House of Commons today that Britain and France were "in complete accord" as to the purposes of their participation in the European war which they frequently expressed, and that any more specific statement of their war aims would be evolved through consideration of the two powers.

Chamberlain's statement was in reply to a question by Laborite Arthur Henderson, who asked "whether it is the policy of his majesty's government to publish in due course of time and jointly with the French government a specific statement of war aims based on principals already enunciated."

"His majesty's government and the French government are in complete accord as to the purposes for which they entered the war," Chamberlain replied.

"These purposes have more than once been stated by both governments," he added. "No doubt as time goes on both governments will consider whether their war aims should be stated in more specific form."

Chamberlain said that Henderson "may take it that any such statement will only be made by agreement between the two governments."

The British government has said repeatedly that the principal aim of the war is to "crush Hitlerism" and to free Europe from the menace of aggression. The restoration of Poland and Czechoslovakia also has been mentioned.

RE-OPEN WEED MART TUESDAY

Sales To Be Resumed In Tobacco Belts Tomorrow

Greenville today was all set for the re-opening tomorrow of tobacco auction sales, closed September 12 following the withdrawal of British buyers from the market and the subsequent drop in price.

All markets will re-open simultaneously, with a full corps of buyers on the various centers.

The federal government, through the Commodities Credit Corporation, will enter the market, providing money to purchase surplus tobacco. The Imperial Tobacco company will handle the buying and handling of tobacco for the government and will retain an option on the weed.

A large quantity of tobacco was on the floors today, but warehousemen reported there still was plenty of room.

One of the largest breaks in the history of the market is anticipated here tomorrow when auctions will be resumed according to the original sales schedule.

No one in official capacity would hazard a guess on the average to be paid when the marts resume sales. An average of approximately 14 cents was paid up to the time the markets closed.

Sales will be resumed with the assurance that the crop next year will be below the normal annual demand. Secretary Wallace has set next year's quota at 660,000,000 pounds while the normal demand is approximately 750,000,000 pounds. A bumper crop of a billion pounds was produced this year.

Farmers voted to limit production in a referendum held last Thursday. Pitt county cast a favorable vote of more than 99 per cent and control was favored in each of the six participating states.

Assured of a reduced crop next year, farmers are hopeful this will tend to bring higher prices for this year's yield.

Greenville's ten warehouses were all set for the resumption of sales. Factories have just about caught up with stemming, re-drying, etc., and are prepared to start work on full schedules when the tobacco starts coming in again.

Government Making Plans To Enter Tobacco Market

EIGHT KILLED IN SEPTEMBER

Monthly Report of Patrol Headquarters Issued

Eight persons were killed in highway accidents in Eastern North Carolina during September, compared with 12 in the previous month. It was reported at the offices of Lieut. Lester Jones, head of Troop A of the State Highway Patrol, today.

A decrease also was shown in the number of persons injured, 31 having received non-fatal injuries last month compared with 53 the previous month.

The number of accidents for the month, however, was greater than for August. Patrolmen investigated a total of 68 accidents in September, compared with 66 the preceding month.

A total of 593 arrests were made by the combined forces stationed in Eastern Carolina. Of this number 96 were charged with driving drunk, compared with 43 drunken driving cases in August.

Of the 593 arrests, 584 defendants were convicted and nine were acquitted. Sentences totaling eight years and four months were meted out to the defendants. In addition fines totaling \$5,207.07 and costs of \$5,813.69 were paid.

Other activities of the patrolmen included: vehicles inspected, 4,648; lights corrected, 3,455; warnings issued, 73; courtesies extended, 609; cars recovered, five valued at \$3,685; vehicles weighed, 289,144 of which 144 were found to be overloaded; complaints investigated, 322; cases of first-aid rendered, 20; citations issued, 1,177; driving licenses approved, 75.

License Plate Puzzles Patrolman

Completing Legal Technicalities of Program

Washington, Oct. 9. (AP) - The Agriculture Department today awaited last-minute clearance of legal technicalities before revealing details of its program to aid southern flue-cured tobacco growers when markets reopen tomorrow.

A spokesman said the program was in process of being "cleared" and was expected to be completed by the time sales resume.

Boiled down, the program calls for the Commodity Credit Corporation to put up federal funds to be used by the Imperial Tobacco Company of Great Britain to buy tobacco.

Tobacco bought by Imperial buyers will be placed in Imperial warehouses, but the CCC will retain title until the British company actually pays for it.

Withdrawal of Imperial buyers because of a shortage of exchange due to the European war was held responsible for the market shutdown which ends tomorrow.

In addition the CCC will make loans to American buyers who buy for resale to foreign countries in order to tide them over the present shortage of international exchange.

Statement Made By Mayor Spain

Mayor Jack Spain has issued a proclamation in connection with Fire Prevention Week in which he calls upon the citizens of Greenville always to be careful in preventing fires and urging the cooperation of the public with the city's fire department.

The resolution follows: "That Whereas the week of October 9th to 14th has been designated as National Fire Prevention Week, and

"Whereas the Greenville Fire Department is desirous of your cooperation in helping to carry out the plans of National Fire Prevention Week in our city;

"Now, Therefore, I, Jack Spain, Mayor of Greenville, am authorized by the Board of Aldermen to designate October 9th through 14th as Fire Prevention Week for the City of Greenville and ask your full cooperation in helping prevent fires throughout the coming year by:

"1. Observing five-minute parking laws upon sound of fire alarm, giving all volunteer firemen and trucks an opportunity to proceed to fire for immediate work.

"2. Clean out all attics, basements and rubbish that might cause a fire.

"3. Clean up all vacant lots and call fire department, if necessary, to burn same or street department, if garbage trucks are needed.

"4. Always be careful as citizens in preventing fires as our firemen can only fight fires after they occur, and in so doing you save both lives and property by being fire-conscious.

"5. Always feel free in calling your fire department for consultation for any fire hazard that might arise."

NAZIS TAKING TO OFFENSIVE IN SOME AREAS

Move Apparently Designed to Take Prisoners

WAGE DRIVE IN LIMITED AREAS

French Sources Express Belief Germany Anxious To Question French Prisoners

Paris, Oct. 9. (AP) - French military sources said today that German forces had taken the offensive in limited areas along the Western front.

The action, these sources said, apparently was designed to take prisoners to question for information as to French military strength and plans. German attacks were reported near Saarbrücken, Saarbrücken and along the Nied river.

Units of the French tank corps were given credit for turning back German attempts to re-take captured positions inside Germany.

German artillery fire and increased patrol skirmishes reported from Saarbrücken, west of Luxembourg, led French military observers to predict a possible big-scale Nazi offensive soon against that section of the Maginot line.

In Paris meanwhile the War Council announced the arrest yesterday of 26 of 72 former Communist deputies on charges of violating the decree dissolving the Communist party and forbidding Communist propaganda.

The arrests, it was said, were based on a letter sent to Edouard Herriot, president of the Chamber of Deputies, urging convocation of Parliament for debate of "immediate peace."

He is survived by his wife, Mrs. Gertrude Tripp; five sons, Joshua, Jr., Joseph, Henry, Benjamin and Leon Tripp, all of near Greenville; three daughters, Mrs. Herbert Moring, Mrs. Penney White and Mrs. Clarence Briley.

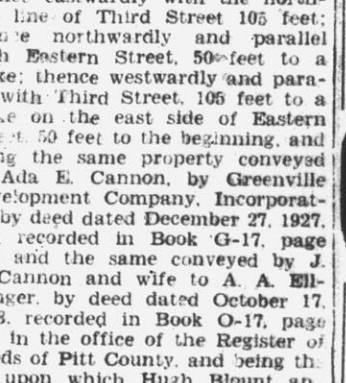

# UNC PREPARES FOR NYU TEAM

## Nation's Number One Air Raider To Lead Violets

Chapel Hill, Oct. 9.—Coach Mal Stevens, who will lead New York U.'s violent Violets against North Carolina in an inter-sectional headliner here Saturday, is best known perhaps as the Nation's No. 1 air raider.

Carolina won over V. P. I. last Saturday 13-6.

And the former Yale coach, who rose to the top of his profession with his election to the presidency of the American College Football Coaches Association, is certainly one of the leading exponents of the forward pass.

However, Coach Stevens is a many-sided man, and as Dr. Marvin A. Stevens he has won an equal reputation as a teacher and practitioner of medicine, surgery, and orthopedics.

And although he is coach of one of the biggest eleven in the country, this remarkable man is still an assistant clinical professor of orthopedic surgery at Yale and an assistant attending surgeon at two hospitals in New York and New Haven.

Dr. Stevens is also a member and fellow of the American College of Physicians, and is co-author with Dr. Winthrop Phelps of a volume on "The Control of Football Injuries."

A native of Stockton, Kansas, Stevens was a remarkable athlete, winning five varsity letters in one year at Washburn College before transferring to Yale, where he was prominently mentioned for all-America back in 1923.

Stevens joined the Yale coaching staff in 1924 as backfield tutor and chief scout and was appointed head coach in 1937. At Yale his teams won 22 games, lost 11, and tied 8.

He entered the Yale School of Medicine in 1925 and was graduated in June of 1929, following which he served as instructor in orthopedics, surgery, and gynecology.

Coach Stevens was appointed to his post at New York University in 1934, and was reappointed in 1936 for a five-year term. His five teams there have won 24 games, lost 16, and tied 2, and rolled up 749 points or almost double the 432 for the opposition.

New York University teams of the past two seasons under Stevens have become known as one of the greatest passing teams in the country, and here's the reason.

The Violets have thrown 354 passes, or an average of 22 per game, and have completed 163, or 46 per cent, of their heaves, for a total gain of 2,078 yards, or 136 yards per game.

Yes, it looks like an epic aerial battle when the New York and North Carolina air raiders meet in Kenan stadium Saturday.

### BRITAIN HEALTHY BEFORE WAR CAME

London (AP)—British death rates in three major categories dropped to new low levels in the statistical year 1938-39. It is disclosed in the annual report of the Ministry of health.

The report shows a standardized death rate of 8.5 per 1,000; an infantile death rate of 53 and a maternal mortality rate of 2.97. The number of deaths from tuberculosis in England and Wales was the lowest in history, 21,930 compared with 23,971 in 1937. It was the first time in the country's history that maternal mortality fell below the rate of three.

A slight upward trend of the birth rate which was observed first in 1938 carried it to 13.1 but at that it was still below the figure for every year before 1933.

# YANKEES HOLD CHAMPIONSHIP

## Take Fourth Straight From Cincinnati Reds

Cincinnati, Oct. 9.—(AP)—In one of the daffiest finishes in all World Series history, the Cincinnati Reds' defenses blew up yesterday to let the New York Yankees win their fourth straight world championship by a 7-4 ten-inning victory in the fourth game of the 1939 fall classic.

After fighting back from an early disadvantage into which home runs by Charley Keller and Bill Dickey had dropped them, the National League champions fell apart like a 1906 jalopy in the ninth and tenth innings; and the Yankees, taking advantage of every break, scored five times in those two frames on four hits and four Red errors to pull out the decision.

And for 30,794 fans, united to roaring heights of delight by the Reds' seventh-inning three-run scoring spurge, this finish was a heart-breaker, for it came about on a collapse of the one feature that stood out for the Reds in the first three games—their fighting fielding.

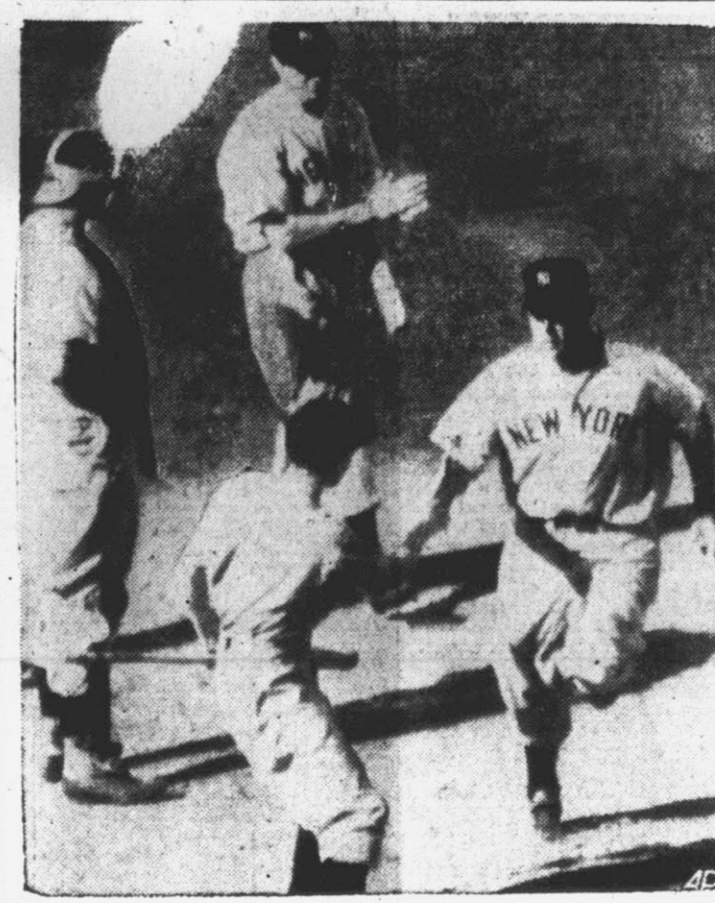
This lapse of the Rhineland defenses topped off an up-and-down collection of performances by the five hurlers who saw action. Tall Paul Derringer started for the Reds, but the loser was Bucky Walters, who took over in the eighth, and thus was charged with his second defeat of the set.

For the Yankees, Fordham Johnny Murphy, the square-jawed Irishman with the excellent control received credit for the first series victory of his career, although he saw action in relief roles in each of the last three sets. He entered the game in the seventh, after Oral Hildebrand had retired because of an ailing side and Steve Sundra had been tagged for the Reds' first three runs.

Thus, the Yankees completed their domination of baseball for the fourth time in a row and for their eighth world championship. Eleven times they have won the American League pennant.

Yesterday's triumph was their ninth straight series game victory, beginning with the last tilt in the 1937 set, and marked the 29th time in 32 games that they have finished on top of the National Leaguers.

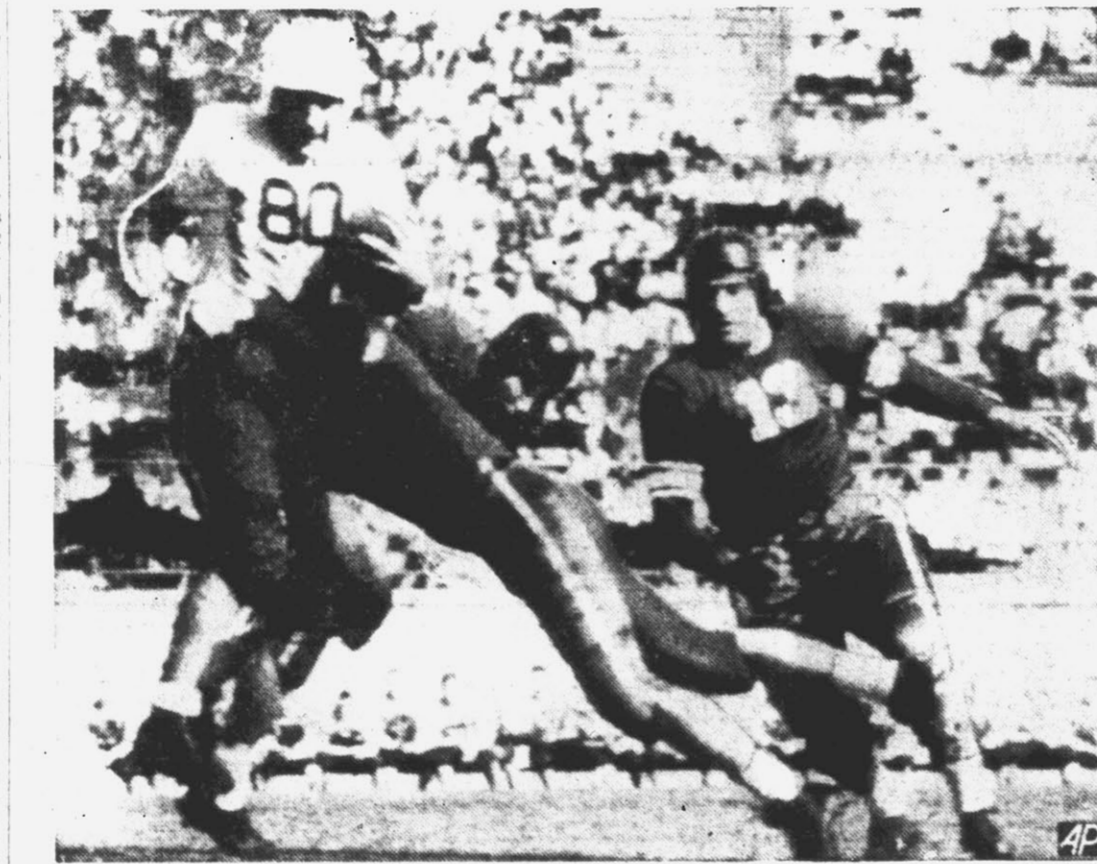

Washington Daybook
By Preston Greer

WASHINGTON - Funeral ob-
solutions are not in our line but along
with a number of other newspaper
men we are especially sorry at the
death of Senator Logan of Ken-
tucky.

He was one of that fairly limited
number of senators who are both
able and willing to sit with a re-
porter through an hour of chat and
discussion of tough issues with
many angles. He was not a "natural
authority" on a single issue that
we can recall, yet he had a knack
of assembling a mass of sound in-
formation which he was willing to
let reporters have if they asked
for it.

He had spent most of his life as
a judge before coming to the sen-
ate and his knowledge of the law
was much respected not only by the
press but by fellow senators. He was
not a "hard working" legislator who
spent dismal hours in his office dig-
ging out tax data. Nevertheless he
probably read from day to day far
more than the average senator, and
on subjects of special interest to
him he read and studied as much
as any.

In A Fight
The supreme court fight interest-
ed him deeply, and throughout that
period he was a source of abundant
help to Senator Joe Robinson, ma-
jority leader, whose death came as
a dramatic climax to that historic
conflict two years ago. Senator Lo-
gan was one of the lead-off men
for the administration group trying
to win authority for appointment of
young and fresh men to the su-
preme court.

He endured probably the tough-
est grilling of any who spoke. We
happened to talk to him briefly be-
fore he went on the stage for that
speech and he said then that he
knew what he was coming up
against. He hoped only that he
would be permitted to talk long
enough without interruption to give
some semblance of coherence to his
speech. He had prepared it care-
fully.

Nothing like that happened. When
he arose he drew a barrage of ques-
tions which continued without in-
termission until he finished three hours
later. A glance at the Congressional
Record shows that rarely was he
permitted to finish more than three
or four sentences at a time until
some senator arose to question or
argue. Patiently he answered reams
of questions that drew him down
side-by-side, and as patiently he re-
turned to his own theme after each
skirmish.

Prophecy
A strange little story now is
available in connection with Lo-
gan's death that could not be told
before. A day or so after Robins-
on's death, we happened to be
talking with Senator Copeland of
New York, the senate's only physi-
cian-member in a long time. He re-
called then what reporters had noted
at the time that he had two times
gone over to Robinson's side to coun-
sel him against such tempestuous
speech as was his habit. He knew
Robinson's condition.

"Who will be next to go?" we
asked him.
If so happened that Logan, in a
speech some time before, had quoted
that little bogey-man verse begin-
ning:
"Last night I saw upon the stair
A little man who wasn't there,"
By way of answer, Copeland re-

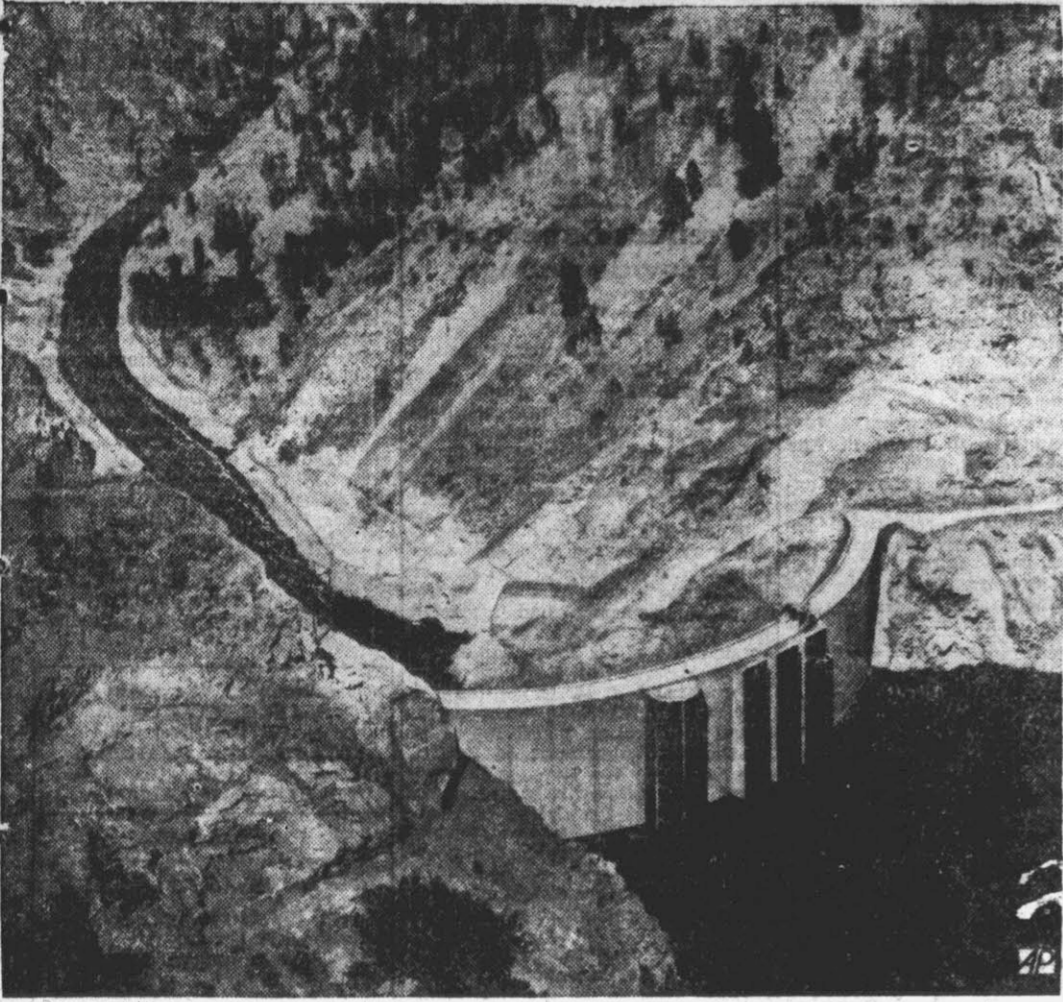
Germany Expands in Fight for 'Living Room'

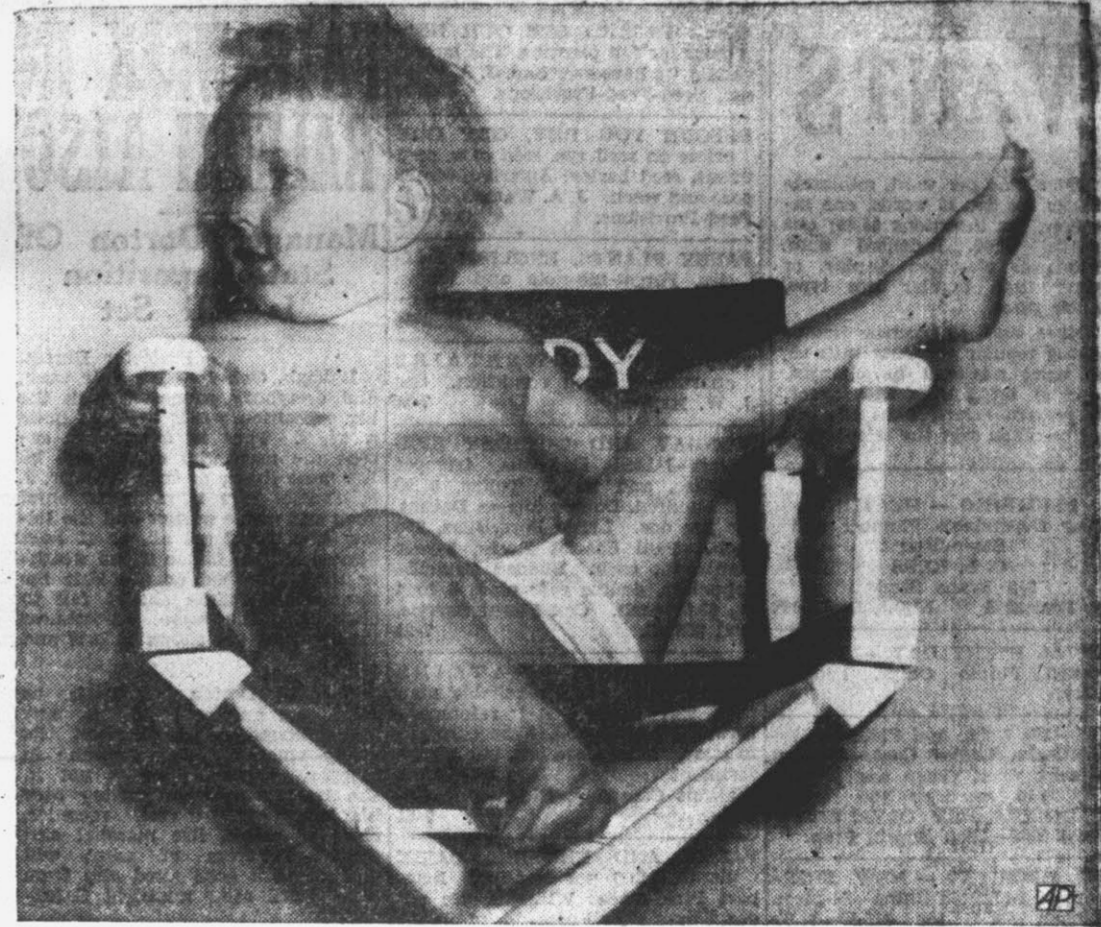

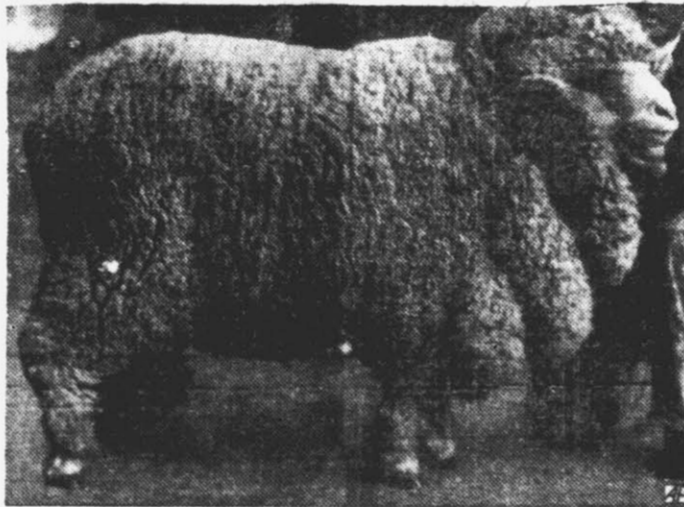

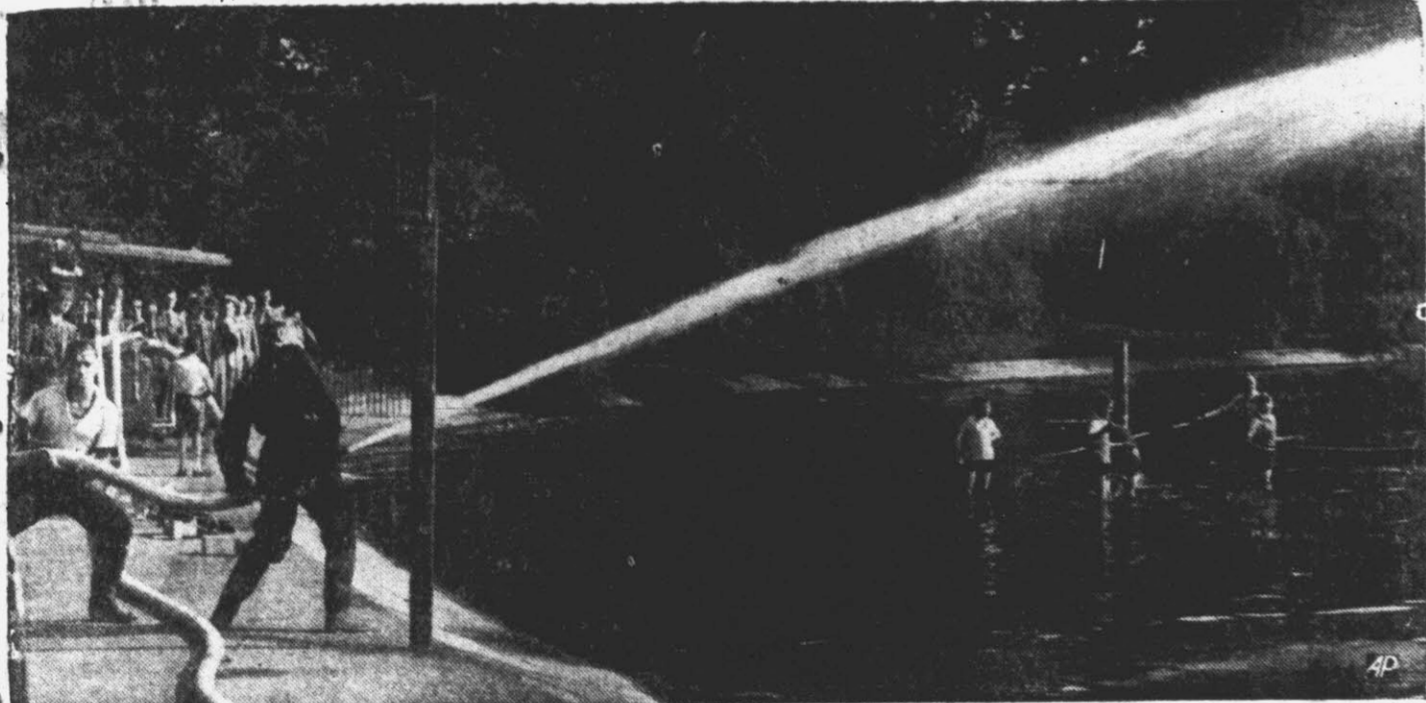

Dorton who is manager, chief cook and bottle washer and the fellow who would get all, or at least almost all, the blame if the weather should be bad for the Fair for some other reason should fall to click with the same smoothness that marked the shows of 1937 and 1938.

That's probably because all the possible Dorton doings have been done and the fate of things rests in the hands of the weather Gods and the enthusiasm of Tar-Heels, young and old for the State Fair. Helping Dr. Dorton in getting over to the public the impression that this week's affair is going to be the "biggest ever," Louis H. Wilson, Department of Agriculture publicity head, has flooded every publication in the state with an ocean of propaganda readable and interesting, but propaganda just the same, although in the best sense of the term.

Wherefore if the Fair isn't successful it will not be for lack of thorough, hardworking preparation on the part of its manager and its press agent.

Now as to what the Fair really has on the ball. The expositions of last year and the year before are generally conceded to have been quite successful and well-attended. This success is unanimously attributed to smart management and general knowledge of what makes a good fair. There is the same management again this year.

Exhibits ought to be more numerous and better balanced. The premium list has been upped about 1 per cent to a grand total of some \$17,000, with \$2,000 going in ten awards to county progress exhibits.

The state's most noted specialists have cooperated in preparing for the showing of agricultural, educational and industrial classes. State College experts, extension service specialists, experiment station heads have done their best to make these classes attractive.

And so on the strictly educational and agricultural side, the Fair ought to be fully up to par.

On the entertainment side of the picture, Wednesday afternoon undoubtedly the most attractive on a basis of known factors, Lucky Teter and his Hell Drivers will perform that day, and they need no ballyhoo from this, or any other corner. They've been here before and if not a single new customer went, they'd play to a packed house of those who have seen them before, but want to see them again.

The free acts, to be given each afternoon and night, are termed exceptional. In the past two years the Fair's acts have lived up to advance notices. There is no reason to suspect they'll fall short this year.

Then there'll be the Midway, and chances are it will be the usual run-of-mine Midway, no better, no worse. Critics may knock and synchs may scorn, but after all what would a Fair be without a Midway?

All in all that Fair's here again, and it ought really to be just a bit bigger and better than ever before.

# NEW CHANGE IN SECURITY ACT

**Workers Over 65 may Build Up Wage Record**

Rocky Mount, Oct. 9.—Recent changes in the Social Security Act make it possible for an employee of an industrial plant or business concern to have a social security account and build up a wage record that will enable him to qualify for old-age insurance and survivors benefits, even though he is more than 65 years old.

Under the original law, a work-

er was not included under the old-age insurance system after he reached his 65th birthday; therefore, very few men and women past that age applied for a social security account number.

"They are beginning to realize that they now have a chance to qualify for benefits," said R. S. Marshall, manager of the Rocky Mount, field office, "and every week we have workers who are over 65, coming into the office to get social security account numbers."

That part of the revised act, which makes special provision for these older workers, contains one clause which was made retro-active, so that all wages received by workers during 1939 could be credited to their social security accounts, even though they have already reached the age of 65. This provision will enable many workers, now past 65, to build up a wage record before July 1, 1940, that will enable them to qualify for old-age and survivors insurance benefits next year.

Mr. Marshall called attention to the fact that each of these older men and women should make known his account number to every employer for whom he has worked during 1939, because every employer, subject to the act, is required to include in his next quarterly wage report, the name, account number, and wages of each worker over 65, as well as those under that age.

# Holds White Man On Forgery Count

Luther Lamb, Wilson county white man, was bound over to Superior court under bond of \$200 on a charge of forgery at a preliminary hearing in city court today and was immediately returned to Washington, where he faces a similar charge.

According to the evidence Lamb telephoned Key Brown's drug store, ordered 52 cents worth of merchandise and told the clerk to send change for \$5. "The man ordered the goods and change delivered to Quinberry's man, although it later developed that he was not staying there. When the delivery boy neared the manor, the man stepped up on the porch received the order and change and handed the boy a check for \$5.

The man was accused of a similar charge in Washington the next day and he is under bond of \$300 in that city.

Other cases heard this morning follow: John Howard Peete, Negro, assault, 10 days or \$5 and costs; Willie Bell Negro, drunk and disorderly, 30 days or one-half costs; Tom Parker, Negro, drunk and down, 30 days or costs; Joe Spellman, Negro, assault with a deadly weapon, 30 days or \$5 fine and costs; John Smith, drunk, 30 days or costs.

# SEES NO NEED OF DIVERSION

**Revenues Expected to Provide Enough Cash**

Raleigh, Oct. 9.—The steady climb which North Carolina's revenues have made this year makes it decidedly unlikely that diversion of highway funds will be as lively an issue as had been expected in many quarters.

Whom this will help and whom it will hurt, when the individual candidates are considered, is more or less problematical as none of the suspected aspirants had indicated any particular desire to make diversion one of his main planks.

Commissioner of Revenue A. J. Maxwell and J. M. Broughton are the two candidates to whom opposition to diversion would appear to be the handiest weapon, in view of the fact that the Revenue Department head plans his campaign on the very solid foundation of "Better and Broader Highways," while Mr. Broughton during the last General Assembly grew eloquent to a degree in opposing diversion before the Finance committee of the 1939 legislature.

But in view of the twelve and a half per cent increase in Revenue division receipts for the first quarter of the current fiscal year it begins to appear that there is no chance of any diversion under the "contingent" provision of the Revenue act; and if there is no danger of actual diversion it is going to be next to impossible to work up any real enthusiasm for an anti-diversion campaign plank.

There remains the possibility, however, that Mr. Maxwell will call for removal of the "contingent" pro-
