SUCCESSES BY NAZI AIRCRAFT ARE REPORTED

Claimed Three Allied Planes Downed in Dog Fights

USUAL HOLIDAY IS NOT OBSERVED

Communique Regarding Air Fights Failed To Mention Reported Loss of Nine German Planes

Berlin, Nov. 7.—(AP)—The German high command reported today that three allied warplanes were shot down in dog fights yesterday in southwestern Germany.

(The communique made no mention of a German-French aerial battle as reported from Paris in which nine of 27 German attackers were said to have been shot down.)

Two French planes, the high command said, were shot down at Saarlautern, four miles within Germany on the northern flank of the Western front and a British plane at Mainz, about 60 miles within southwestern Germany. (The British announced last night that one Royal Air Force plane had not returned from a reconnaissance flight.)

Otherwise, the communique said, there was "no noteworthy fighting action, except minor scouting by troops and weak artillery fire on both sides."

Because of the war a traditional Nazi holiday—the November 9 anniversary observance of the 1923 Munich beer cellar putsch—has been cancelled.

Defendant Forced To Repay Checks

Repulse Attack On Ships

London, Nov. 7.—(AP)—The Admiralty said tonight light British ships, aided by Polish destroyers, had fought off an attack by German airplanes in the North Sea without suffering damage.

A communique stated: "This morning in the southern part of the North Sea certain of our light forces, including two Polish destroyers, were in action with German aircraft.

"No damage was done to any ship. Enemy casualties are not known."

Nazi Planes Driven Off

London, Nov. 7.—(AP)—German planes, a report passed for publication said, flew high over the Shetland islands north of Scotland today and disappeared in the haze as British anti-aircraft guns opened fire.

Israel Gibbs, Negro, was taken into custody last night by local police officers upon request of Sheriff Rumley of Beaufort county. The nature of the charges upon which the Negro is wanted was not known by local officers.

Naval Plane Burns

Honolulu, Nov. 7.—(AP)—A naval observation plane burst into flames in diving practice and crashed into the sea off Barber's point today.

The observer was missing, but his companion was saved.

The plane was from the aircraft carrier Enterprise.

The pilot, picked up by a naval boat after he had managed to stay afloat 40 minutes, was Lieut. Junior grade, W. R. Wallis. He suffered only slight burns about the face and forearms.

The observer was identified as chief aviatorist mate, W. T. Rhodes of San Diego, Calif.

RUSSIA STAGES ARMS DISPLAY

Caps Celebration with Show of Military Strength

Moscow, Nov. 7.—(AP)—Soviet Russia capped her celebration of the 22nd anniversary of the Communist revolution with a display of military might today as War Commissar Klementi Voroshiloff warned that, though neutral, the nation must "be prepared."

Voroshiloff spoke briefly in Red square, through which thousands of troops marched in a parade that lasted more than an hour and a half.

"The Soviet government watches the international situation and will react to every event," Voroshiloff declared after praising the work of Soviet troops in Poland and Outer Mongolia.

Mechanized units, including 206 medium size tanks, formed a large part of the military display. Hundreds of thousands of civilians watched the parade pass through streets decked with red banners and bunting while airplanes roared overhead in formation.

State college; and Dr. Luther Shaw, extension plant pathologist.

HULL OPPOSES ANY CHANGE IN SHIP REGISTRY

Says Action Would Impair U. S. Neutrality Act

TRANSFER ASKED FOR U. S. VESSELS

U. S. Lines Had Applied for Permission To Transfer Trans-Oceanic Craft to Panamanian Registry

Washington, Nov. 7.—(AP)—Secretary Hull expressed today his opposition to the transfer to Panamanian registry of United States Line ships as impairing the integrity of the neutrality act.

Hull said he had given this opinion to the Maritime Commission. He did not indicate what the commission's reaction was.

The United States Lines applied for permission to transfer to Panamanian registry ships which had been in transatlantic service.

After one member of the commission said yesterday that the transfer had been approved, the full commission issued, after a late night session, a statement saying that it was deferring final action pending investigation of all the facts.

At his press conference, Hull recalled that yesterday he had told Maritime Commission members that there was no question of foreign policy involved in the transfer, but that his opinion was given in the absence of virtually any of the facts.

The secretary of state added that as some of the facts pertaining to the application of the United States Lines for transfer of registry had since come to him, he did not feel favorably impressed with them.

'GREEN LIGHTS' ON HONOR LIST

High School Publication Commended At Meeting

"Green Lights," tri-weekly publication of Greenville high school, was adjudged an honor newspaper last week-end by judges in the Southern Inter-scholastic Press Association. Competing out of its normal classification in the local paper met unusual competition with schools whose enrollments are 800-1500. The convention was held at Washington and Lee university in Lexington, Va.

Heretofore "Green Lights" has been in the classification with other schools whose enrollments range between 400-800. Having won the cup in this division for two successive years the local entry was automatically advanced to the next level. Cup-winner in this group was "Chatterbox" of Danville, Va.

The fifteenth annual convention of the S. I. P. A. attracted 325 high school journalists and advisers from Texas to West Virginia. Eminent newspaper and magazine writers appeared on the program during the three-day convalescence. Outstanding among these were Turner Catledge, chief of the Washington staff of the New York Times; Gilbert Parrar, typographer and stylist; Denver Lindley, associate editor of Colliers; and Fred W. Perkins, head of the Scripps-Howard newspaper alliance in Washington.

Mr. Catledge and Mr. Perkins were especially informative in their relation of the way in which authentic news is gathered and disseminated in Washington. Each declared the capital to be the chief news-center of the world at present. The White House conferences were described and lauded by each of these journalists.

Reynolds Answers Federal Charges

Washington, Nov. 7.—(AP)—The R. J. Reynolds company of Winston-Salem, one of eight major tobacco firms cited by the Federal Trade Commission for violation of the Robinson-Patman act, has filed an answer to the charges in preparation for a hearing on Friday.

Replying to the charge that it discriminated in prices between purchasers of its products of light grade and quality, the company said its salesmen do not make sales to retail dealers generally and that "it does not sell this product to retail dealers."

The company said its salesmen called on retail dealers solely to seek "to induce such retailers to place orders for respondent products with jobbers."

AVERAGE HERE 19.21 MONDAY

Offerings on Local Market to Date Total 56,300,040

An average price of 19.21 cents per pound was paid on the Greenville tobacco market yesterday, an average of 16.07. These figures include the 23,996,436 pounds sold prior to the marketing holiday for an average of 13.82 cents a pound.

R. C. Rankin, sales supervisor, reported this average was paid despite the fact a great amount of the offerings was of low quality.

Yesterday's sales brought the season's offerings to 56,300,040 pounds, which was sold for \$9,039,785.82, or an average of 16.07. These figures include the 23,996,436 pounds sold prior to the marketing holiday for an average of 13.82 cents a pound.

The market continues to pay higher averages. During the past week growers were paid an average of 18.51, compared with 18.44 paid for the week ended October 27 and 17.44 for the week ended October 20.

Mr. Rankin reported that competition on the market was just as keen and prices just as strong today as yesterday.

With offerings becoming lighter each day and the long block on the local market coming to an end, Mr. Rankin said next week warehousemen will be able to handle all tobacco on the same day it is brought to the market.

FRENCH STILL HOLDING FAST DESPITE FIRE

Troops Hold on to Important Forbach Salient

NAZI ATTEMPTS ARE FRUSTRATED

French Also Said to Have Flattened German Land Movement Against Another Frontier City

Paris, Nov. 7.—(AP)—Military sources reported today that French troops on the Western front still were holding fast in the important Forbach salient despite intermittent German artillery fire.

All Nazi attempts to penetrate the deserted city to remove the threat of French guns dominating the German industrial center of Saarbruecken have failed, these sources said.

The French also were reported to have flattened a German land movement against Merten, another French frontier city southwest of Saarbruecken. German infantry tried twice yesterday to seize Merten, but were repulsed each time.

Isolated sectors on the northern bank of the front were subjected to a German barrage during the night, which a French communique described as "quiet."

Clearing weather produced a notable increase in air force activity, marked yesterday by a spectacular dog fight in which nine French fighters were reported to have engaged 27 German planes over the line.

The French said their fliers brought down nine Nazi planes and set the rest to flight.

SAYS WAR FOR A NEW WORLD

British War Aims Set Forth by Lord Halifax

London, Nov. 7.—(AP)—Foreign Secretary Lord Halifax declared tonight that Britain was fighting for a "new world" in which nations would be immune from "insane armed rivalry."

In a broadcast on British war aims, Lord Halifax asserted: "When the challenge in the sphere of international relations is sharpened as today in Germany the denial to men and women of elementary human rights that challenge is at once extended to something instinctive and profound in the universal conscience of mankind."

"We are therefore fighting to maintain the rule of law and the quality of mercy in dealings between man and man and in the great society of civilized states," he added.

The foreign secretary spoke of the war against Germany as against the substitution of brute force for law and aimed at repairing the damage successfully brought by Germany upon her weaker neighbors.

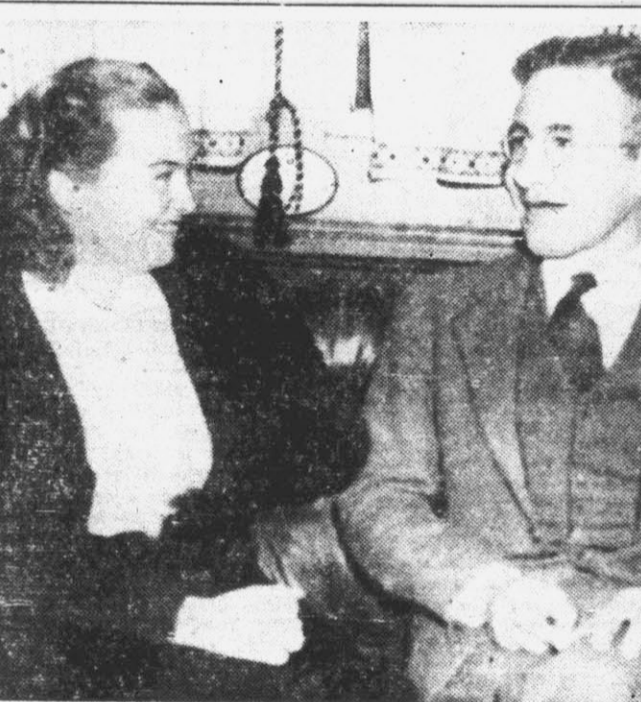

Nazi Prize Crew Off To Fortress

Transferred From Norwegian Craft Olav Trygvason

Bergen, Nov. 7.—(AP)—Seventeen German seamen, the erstwhile prize crew of the American freighter City of Flint, were moved from the minelayer Olav Trygvason today to be taken to the fortress at Gongsvinger, near the Swedish border.

The Germans, held when Norway returned the City of Flint to her American crew, were expected to leave on tonight's train for the trip across southern Norway.

An eighteenth German originally in the prize crew became ill and was left at Murmansk, Soviet Russian port, at which the Flint stopped after her capture by a German raider October 9.

The American crew, granted no shore leave was busy putting the ship in order. This was not taken as an indication of early departure, however, as ship's chandlers reported no provisions had been put aboard.

Mrs. J. Borden Harriman, U. S. Minister to Norway, and Maurice P. Dunlap, counsel at Bergen, who visited the ship yesterday, declined to discuss disposition of the cargo or departure plans.

The local unit will serve 27 Eastern North Carolina counties and will be under the management of H. A. Wood, assistant state supervisor. In addition to Mr. Wood, at least one other person probably will be employed at the office here.

Mr. Wood will spend most of his time in the field, but will make his home in Greenville. He has rented an apartment at the corner of Third and Woodlawn streets.

Offices, at least temporarily, will be located in the Guaranty Bank and Trust company Dickinson avenue branch.

The first clinic will be held here Friday, when over 50 persons are expected to be interviewed.

The announced purpose of the Vocational Rehabilitation program is to remove from society the burden of maintaining a large group of dependent persons who, because of physical disability, are unable to earn a living and support their dependents. The organization proposes to accomplish its purpose by preparing disabled persons for, and placing them in, remunerative employment.

Each year in the United States 800,000 persons become permanently disabled through accident, disease or from congenital causes. Experience has shown that 600,000 of this number are able to return to or enter employment of their own initiative. The remaining 200,000 could be made partially or wholly self-supporting through Vocational Rehabilitation service if adequate funds were available.

The organization, financed by the federal and state governments, first finds the disabled person, provides vocational guidance in the selection of suitable type of employment; attempts to restore the client physically by surgical or medicinal treatment or provision of an artificial appliance, provide vocational training in the occupation which it has been determined the person can work despite his handicap; and give assistance in securing employment in the occupation for which the person has been fitted.

The Pitt county welfare department is cooperating with the new local agency.

KING LEOPOLD VISITS QUEEN

Joint Offer Announced Following Surprise Trip of Belgian Monarch to Queen Wilhelmina of the Netherlands; Statement Declares Two Countries Have Good Relations with All Neighbors

Amsterdam, Nov. 7.—(AP)—Queen Wilhelmina of the Netherlands and King Leopold of the Belgians today announced they would send messages to Germany, Britain and France jointly offering their good offices for peace.

The offer, to be made to the heads of the states of the warring powers, will be as follows, an official announcement said:

"In the hour of anxious tension for the world before war in western Europe begins with full power, we are convinced we are obligated to make our voices heard again.

"The belligerents declared some time ago that they are not standing obstinately against examination of a reasonable and fixed basis of a reasonable peace.

"We consider that in the actual circumstances it is difficult for the belligerents to seek contact with one another, and as sovereigns of two neutral states which have good relations with all their neighbors, we are willing to offer our good offices.

"In case they are accepted, we are willing to use all means which the belligerents give us and which we possess to find in the spirit of friendly understanding factors to facilitate an agreement.

"This appears to be our task for the welfare of our people and for the whole world.

"We hope our offer will be accepted and that in this way the first step will be taken toward permanent peace."

The announcement was issued shortly after King Leopold departed for Brussels following a surprise conference with the queen which started last night.

The Hague, Nov. 7.—(AP)—Leopold, king of the Belgians, and Queen Wilhelmina of the Netherlands, engaged today in apparently urgent talks aimed, observers said, at keeping their countries out of war and protecting their vital interests.

There were suggestions that the two states lying between Europe's great warring powers were seeking to reconcile divergent foreign policies and present a joint neutrality front.

King Leopold arrived late last evening after a hurried motor trip from Brussels and proceeded at once to the Noordeinde palace, where he conferred with Queen Wilhelmina.

King Leopold followed up last night's conference with another hour and a half meeting with Queen Wilhelmina today. There was no official announcement on the nature of the talks, but informed quarters said King Leopold was concerned over the possibility of a German attack on France through Belgium.

Informed sources said only that Leopold had come here to "discuss aspects of the international situation." These sources disclaimed knowledge of any new move by Germany which might have motivated the conversations.

Revenue Statement Backs Prediction On Diversion

Raleigh, Nov. 1.—Commissioner of Revenue A. J. Maxwell's statement to oil jobbers last week that diversion is likely to become only an academic question in North Carolina found substantial confirmation in the statement of revenue collections for the month of October, showing an increase over October, 1938, of 22.27 per cent in revenue division receipts and a 14.64 per cent increase in this division for the current fiscal year.
Undiminished, apparently, by the closing of the tobacco markets during much of September, sales tax collections went above the million dollar mark for the first time since last January, when Christmas shopping was reflected in the returns.
Franchise revenue went up to \$1,155,765.82, an increase of more than \$300,000 over October, 1938, but Mr. Maxwell explained that this was due to the fact that some taxes, ordinarily not paid until November, came in a little earlier than usual. Next month he predicted, this will be reflected in reduced franchise tax yields.
Elsewhere along the line there were other substantial advances, the

whole of them summing up to the fact that there will be, on the basis of current receipts and prospects for the remainder of the fiscal year, plenty of money in the general fund to avert the necessity of diverting any from the highway funds in order to avoid deficit.
When the current budget was set up, its balance was based on diversion of \$2,500,000 of highway funds plus estimated receipts only slightly in excess of those for the last fiscal year.
In the first four months of the fiscal year current receipts for the revenue division have exceeded those for the corresponding period of 1938 by \$1,510,382.57, a ratio which if maintained would yield almost \$5,000,000 more for the present year than was collected in 1938-39—an increase more than sufficient to take care of estimated expenditures.
Sales tax receipts alone have shown an increase of almost \$100,000 a month, on the average, since July 1, with the four months total for this year standing at \$3,751,539.59 against \$3,739,660.44 in the first four months of last year's fiscal reckoning.
Down in the motor vehicle division of revenues, the gasoline tax continued to show the way to all other levies, passing the two million mark (\$2,278,747.34) for the ninth time in the ten months of the present calendar year. Total for the four months of the fiscal period ran \$8,963,337.17 this year against \$8,452,281.54, an increase of more than half a million dollars and an indication that North Carolina will have its first \$25,000,000 gas tax collection this year. For the 1938-39 period this revenue went above \$24,000,000, or an average of \$2,000,000 per month for the first time in history.
For the first four months total collection of revenue from all sources reached almost \$20,000,000, or practically \$5,000,000 per month, and this with no important income tax collection months included.
General revenue reports for the entire year indicate that this income tax will run much higher than last year when the time comes to pay it for the 1939 calendar year, as income taxes ordinarily move up correspondingly with other revenue returns.

SUCCESSES BY NAZI AIRCRAFT ARE REPORTED

Claimed Three Allied Planes Downed in Dog Fights

USUAL HOLIDAY IS NOT OBSERVED

Communique Regarding Air Fights Failed To Mention Reported Loss of Nine German Planes

Berlin, Nov. 7.—(AP)—The German high command reported today that three allied warplanes were shot down in dog fights yesterday in southwestern Germany.

(The communique made no mention of a German-French aerial battle as reported from Paris in which nine of 27 German attackers were said to have been shot down.)

Two French planes, the high command said, were shot down at Saarlautern, four miles within Germany on the northern flank of the Western front and a British plane at Mainz, about 60 miles within southwestern Germany. (The British announced last night that one Royal Air Force plane had not returned from a reconnaissance flight.)

Otherwise, the communique said, there was "no noteworthy fighting action, except minor scouting by troops and weak artillery fire on both sides."

Because of the war, a traditional Nazi holiday—the November 9 anniversary observance of the 1923 Munich beer cellar putsch—has been cancelled.

Defendant Forced To Repay Checks

Malissa Taft, Negro girl, was convicted in County court this morning of failing to report earnings while employed as domestic help and at the same time drawing unemployment compensation and was given a 30-day sentence, suspended upon payment of court costs and also paying back the \$26 she allegedly drew in compensation.

Other cases disposed of at the morning session followed: Leon Gilbert, Negro, assault on a female, pay one-half costs; Henrietta, Annie May, Adelaide and Missouri Gallette, assault, pay one-half costs; Herman Gay, Negro, driving drunk, not guilty; Brownie Gray, Negro, abandonment and non-support, two years on the roads; Sam Simmons, Negro, possessing illegal liquor and driving without a license, \$25 suspended upon payment of days costs to be deducted and the balance to go as a fine, and upon further provision he not drive a motor vehicle until he secures a license; Jacob Tyson, careless and reckless driving, not proved; Dewey Frank Linton, driving careless and reckless, not proved.

J. W. H. Roberts prosecuted in the absence of Solicitor Charles Whebebe, who is ill.

Repulse Attack On Ships

London, Nov. 7.—(AP)—The Admiralty said tonight that British ships, aided by Polish destroyers, had fought off an attack by German airplanes in the North Sea without suffering damage.

A communique stated: "This morning in the southern part of the North Sea certain of our light forces, including two Polish destroyers, were in action with German aircraft.

"No damage was done to any ship. Enemy casualties are not known."

Nazi Planes Driven Off

London, Nov. 7.—(AP)—German planes, a report passed for publication said, flew high over the Shetland islands north of Scotland today and disappeared in the haze as British anti-aircraft guns opened fire.

Negro Man Being Held

Israel Gibbs, Negro, was taken into custody last night by local police officers upon request of Sheriff Rumley of Beaufort county. The nature of the charges upon which the Negro is wanted was not known by local officers.

Naval Plane Burns

Honolulu, Nov. 7.—(AP)—A naval observation plane burst into flames in diving practice and crashed into the sea off Barber's point today.

The observer was missing, but his companion was saved.

The plane was from the aircraft carrier Enterprise.

The pilot, picked up by a naval boat after he had managed to stay afloat 40 minutes, was Lieut. Junior grade, W. R. Wallis. He suffered only slight burns about the face and forearms.

The observer was identified as chief aviator's mate, W. T. Rhodes of San Diego, Calif.

RUSSIA STAGES ARMS DISPLAY

Caps Celebration with Show of Military Strength

Moscow, Nov. 7.—(AP)—Soviet Russia capped her celebration of the 22nd anniversary of the Communist revolution with a display of military might today as War Commissar Klementi Voroshiloff warned that though neutral, the nation must "be prepared."

Voroshiloff spoke briefly in Red square, through which thousands of troops marched in a parade that lasted more than an hour and a half.

"The Soviet government watches the international situation and will react to every event," Voroshiloff declared after praising the work of Soviet troops in Poland and Outer Mongolia.

Mechanized units, including 206 medium size tanks, formed a large part of the military display. Hundreds of thousands of civilians watched the pageant pass through streets decked with red banners and bunting while airplanes roared overhead in formation.

Mercker, in charge of the potato program marketing section of the AAA, also will appear on the program. Others to participate on the program include Mr. Etheridge of the marketing divisions of the State Department of Agriculture; L. P. Watson, extension horticulturist of N. C. State college; and Dr. Luther Shaw, extension plant pathologist.

Pitt Board Holds Monthly Meeting

A petition was accepted and will be sent on to the State Highway and Public Works Commission asking that the road from Grimesland to the colored training school be improved.

The board voted to donate \$50 to the local chapter of the Kings Daughters, the money to be used in erecting a chapel at the Stonewall Jackson Training School.

HULL OPPOSES ANY CHANGE IN SHIP REGISTRY

Says Action Would Impair U. S. Neutrality Act

TRANSFER ASKED FOR U. S. VESSELS

U. S. Lines Had Applied for Permission To Transfer Trans-Ocean Craft to Panamanian Registry

Washington, Nov. 7.—(AP)—Secretary Hull expressed today his opposition to the transfer to Panamanian registry of United States Line ships as impairing the integrity of the neutrality act.

Hull said he had given this opinion to the Maritime Commission. He did not indicate what the commission's reaction was.

The United States Lines applied for permission to transfer to Panamanian registry ships which had been in transatlantic service.

After one member of the commission said yesterday that the transfer had been approved, the full commission issued, after a late night session, a statement saying that it was deferring final action pending investigation of all the facts.

At his press conference, Hull recalled that yesterday he had told Maritime Commission members that there was no question of foreign policy involved in the transfer, but that his opinion was given in the absence of virtually any of the facts.

The secretary of state added that as some of the facts pertaining to the application of the United States Lines for transfer of registry had since come to him, he did not feel favorably impressed with them.

'GREEN LIGHTS' ON HONOR LIST

High School Publication Commended At Meeting

"Green Lights," tri-weekly publication of Greenville high school, was adjudged an honor newspaper last week-end by judges in the Southern Interscholastic Press Association. Competing out of its normal classification the local paper met unusual competition with schools whose enrollments are 800-1500. The convention was held at Washington and Lee university in Lexington, Va.

Heretofore "Green Lights" has been in the classification with other schools whose enrollments range between 400-800. Having won the cup in this division for two successive years the local entry was automatically advanced to the next level, Cup-winner in this group was the "Chatterbox" of Danville, Va.

"Green Lights" was second. The fifteenth annual convention of the S. I. P. A. attracted 325 high school journalists and advisers from Texas to West Virginia. Eminent newspaper and magazine writers appeared on the program during the three-day conclave. Outstanding among these were Turner Catledge, chief of the Washington staff of the New York Times; Gilbert Farrar, typographer and stylist; Denver Lindley, associate editor of Colliers; and Fred W. Perkins, head of the Scripps-Howard newspaper alliance in Washington.

Mr. Catledge and Mr. Perkins were intimate and informative in their relation of the way in which authentic news is gathered and disseminated in Washington. Washington, Nov. 7.—(AP)—The R. J. Reynolds company of Winston-Salem, one of eight major tobacco firms cited by the Federal Trade Commission for violation of the Robinson-Patman act, has filed an answer to the charges in preparation for a hearing on Friday.

Replying to the charge that it discriminated in prices between purchasers of its products of light grade and quality, the company said that its salesmen do not make sales to retail dealers generally and that "it does not sell this product to retail dealers."

The company said its salesmen called on retail dealers solely to seek "to induce such retailers to place orders for respondent products with jobbers."

Offerings on Local Market to Date Total 56,300,040

An average price of 19.21 cents per pound was paid on the Greenville tobacco market yesterday, as 1,659,506 pounds of the golden weed were sold for a total of \$320,626.38.

R. C. Rankin, sales supervisor, reported this average was paid despite the fact a great amount of the offerings was of low quality.

Yesterday's sales brought the season's offerings to 56,300,040 pounds, which was sold for \$9,039,765.82, or an average of 16.07. These figures include the 23,996,436 pounds sold prior to the marketing holiday for an average of 13.82 cents a pound.

The market continues to pay higher averages. During the past week growers were paid an average of 18.51, compared with 18.44 paid for the week ended October 27 and 17.44 for the week ended October 20.

Mr. Rankin reported that competition on the market was just as keen and prices just as strong today as yesterday.

With offerings becoming lighter each day and the long block on the local market coming to an end, Mr. Rankin said next week warehousemen will be able to handle all tobacco on the same day it is brought to the market.

FRENCH STILL HOLDING FAST DESPITE FIRE

Troops Hold on to Important Forbach Salient

NAZI ATTEMPTS ARE FRUSTRATED

French Also Said to Have Flattened German Land Movement Against Another Frontier City

Paris, Nov. 7.—(AP)—Military sources reported today that French troops on the Western front still were holding fast in the important Forbach salient despite intermittent German artillery fire.

All Nazi attempts to penetrate the deserted city to remove the threat of French guns dominating the German industrial center of Saarbruecken have failed, these sources said.

The French also were reported to have flattened German land movement against Merten, another French frontier city southwest of Saarbruecken. German infantry tried twice yesterday to seize Merten, but were repulsed each time.

Isolated sectors on the northern flank of the front were subjected to a German barrage during the night, which a French communique described as "quiet."

Clearing weather produced a notable increase in air force activity, marked yesterday by a spectacular dog fight in which nine French fighters were reported to have engaged 27 German planes over the line.

The French said their fliers brought down nine Nazi planes and set the rest to flight.

SAYS WAR FOR A NEW WORLD

British War Aims Set Forth by Lord Halifax

London, Nov. 7.—(AP)—Foreign Secretary Lord Halifax declared tonight that Britain was fighting for a "new world" in which nations would be immune from "insane armed rivalry."

In a broadcast on British war aims, Lord Halifax asserted: "When the challenge in the sphere of international relations is sharpened as today in Germany the denial to men and women of elementary human rights that challenge is at once extended to something instinctive and profound in the universal conscience of mankind."

"We are therefore fighting to maintain the rule of law and the quality of mercy in dealings between man and man and in the great society of civilized states," he added.

The foreign secretary spoke of the war against Germany as against the substitution of brute force for law and aimed at repairing the damage successfully brought by Germany upon her weaker neighbors.

Nazi Prize Crew Off To Fortress

Transferred From Norwegian Craft Olav Trygvason

Bergen, Nov. 7.—(AP)—Seventeen German seamen, the erstwhile prize crew of the American freighter City of Flint, were moved from the minelayer Olav Trygvason today to be taken to the fortress at Gongsvinger, near the Swedish border.

The Germans held when Norway returned the City of Flint to her American crew, were expected to leave on tonight's train for the trip across southern Norway.

An eighteen Geman originally in the prize crew became ill and was left at Murmansk, Soviet Russian port, at which the Flint stopped after her capture by a German raider October 9.

The American crew, granted no shore leave, was busy putting the ship in order. This was not taken as an indication of early departure, however, as ship's chandlers reported no provisions had been put aboard.

Mrs. J. Borden Harriman, U. S. Minister to Norway, and Maurice P. Dunlap, counsel at Bergen, who visited the ship yesterday, declined to discuss disposition of the cargo or departure plans.

New Light Sought On Missing Judge

New York, Nov. 7.—(AP)—Emil K. Ellis, attorney for the widow of the long-missing Supreme Court Justice Joseph Crater, said today a girl he believed was June Price, a former Broadway show girl, was a patient at the Pilgrim state hospital at Brentwood, L. I.

"If it is Miss Bruce," Ellis said, "I believe she can tell us what happened to Justice Crater."

The New York Post said yesterday that Mrs. Stella Crater Kunz, widow of Justice Crater, would seek to link the disappearance of June Price with the vanishing of her husband October 6, 1930.

Mrs. Kunz is seeking in Supreme Court to collect \$60,000 double indemnity on the four insurance policies held by the Justice.

Ellis had declined to explain just how the show girl figures in the case. He made it clear he did not believe Miss Bruce had any connection with Crater's actual disappearance.

KING LEOPOLD VISITS QUEEN

Joint Offer Announced Following Surprise Trip of Belgian Monarch to Queen Wilhelmina of the Netherlands; Statement Declares Two Countries Have Good Relations with All Neighbors

Amsterdam, Nov. 7.—(AP)—Queen Wilhelmina of the Netherlands and King Leopold of the Belgians today announced they would send messages to Germany, Britain and France jointly offering their good offices for peace.

The offer, to be made to the heads of the states of the warring powers, will be as follows, an official announcement said:

"In the hour of anxious tension for the world before war in western Europe begins with full power, we are convinced we are obligated to make our voices heard again.

"The belligerents declared some time ago that they are not standing obstinately against examination of a reasonable and fixed basis of a reasonable peace.

"We consider that in the actual circumstances it is difficult for the belligerents to seek contact with one another, and as sovereigns of two neutral states which have good relations with all their neighbors, we are willing to offer our good offices.

"In case they are accepted, we are willing to use all means which the belligerents give us and which we possess to find in the spirit of friendly understanding factors to facilitate an agreement.

"This appears to be our task for the welfare of our people and for the whole world.

"We hope our offer will be accepted and that in this way the first step will be taken toward permanent peace."

The announcement was issued shortly after King Leopold departed for Brussels following a surprise conference with the queen which started last night.

The Hague, Nov. 7.—(AP)—Leopold, king of the Belgians, and Queen Wilhelmina of the Netherlands, engaged today in apparently urgent talks aimed, observers said, at keeping their countries out of war and protecting their vital interests.

There were suggestions that the two states lying between Europe's great warring powers were seeking to reconcile divergent foreign policies and present a joint neutrality front.

King Leopold arrived late last evening after a hurried motor trip from Brussels and proceeded at once to the Noordeinde palace, where he conferred with Queen Wilhelmina.

King Leopold followed up last night's conference with another hour and a half meeting with Queen Wilhelmina today. There was no official announcement on the nature of the talks, but informed quarters said King Leopold was concerned over the possibility of a German attack on France through Belgium.

Informed sources said only that Leopold had come here to "discuss aspects of the international situation." These sources disclaimed knowledge of any new move by Germany which might have motivated the conversations.

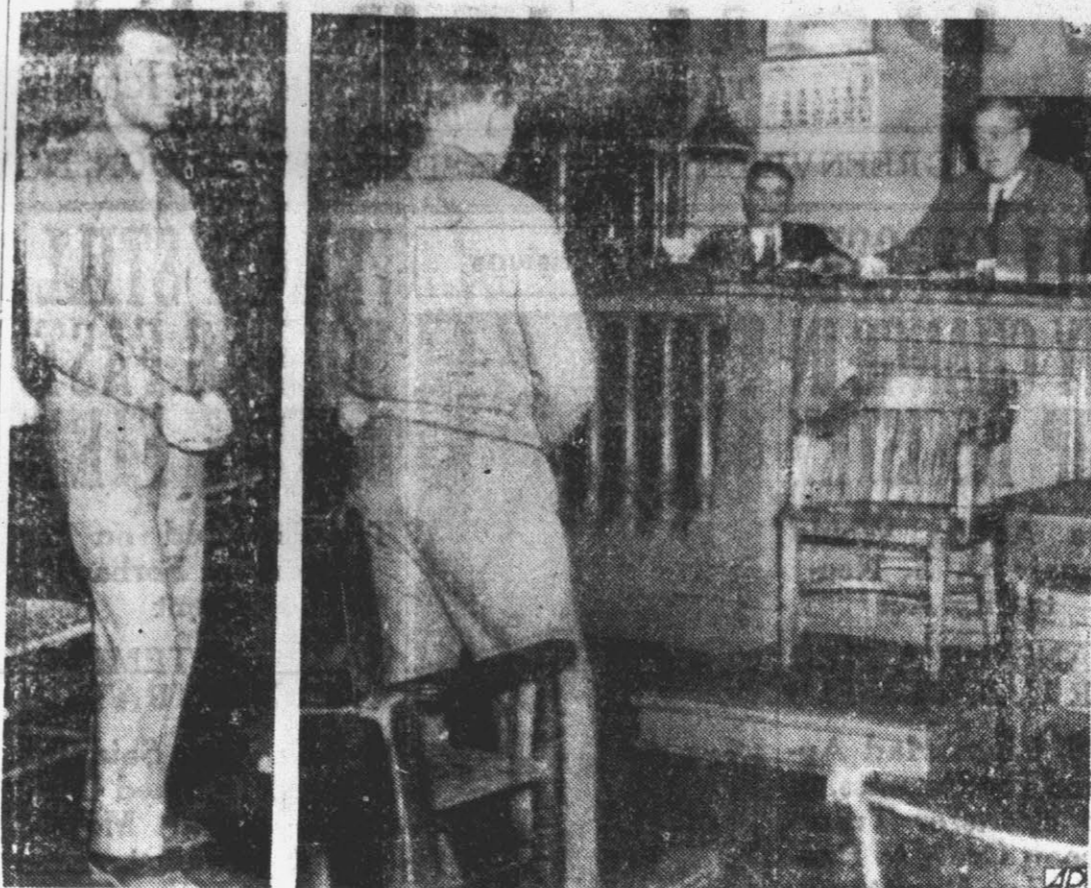

Since then she's had good roles—all characters, no glamour stuff for Fay!—in "A Child Is Born," "Untamed," "Women Behind Bars," "Abel Lincoln in Illinois" and "Parole Fixer." She "aged" from 40 to 0 in one of her roles, would like to try it again.

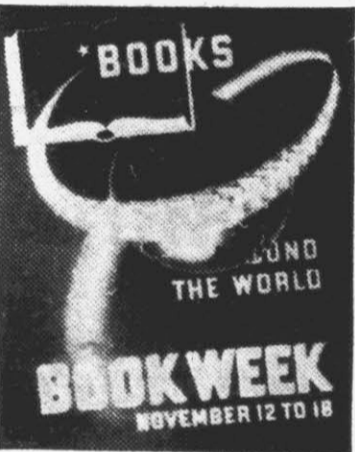

What It Means

Washington — What price the neutrality law?

Listen to certain shipping men with long experience, and you hear that the first effect may be an under-cover scramble by American ship owners to register their vessels under foreign flags.

That legal device might keep American vessels running on their regular routes in the minimum danger zones prescribed by the neutrality law.

But it also means they would abandon the protection of the American flag and the United States navy.

It's either foreign registry, say these shipping experts, or abandoning the business route for the last 20 years. And many shippers are expected to choose foreign registration before they abandon business and tie up their ships.

A Practical Problem

The shipping experts, are not, of course, attempting to pass on the question of whether it is right or wrong to have a neutrality law. That, they are quite agreeable to congress and the American public to decide. But as a practical problem, they do insist that the law plays havoc with the American merchant marine.

And in any event, the minimum danger zones required under the law will keep the American flag off the creamiest route in the world—the trans-Atlantic run.

But what if American ship owners should abandon their routes instead of taking chances under foreign flags?

In that case, the United States maritime commission says a big section of the already sick merchant marine would be tied up.

Large Annual Loss

The commission's data show that 86 American vessels totaling 561,719 tons would have to lie idle. That's about one-fourth of the tonnage we now have on the high seas. In all we have 326 ships in foreign trade, a total of 2,150,000 tons of shipping.

These ships would lose about \$50,000,000 in revenue annually. About 6,000 seamen would be affected. Some \$27,000,000 usually paid out each year for wages, food, repairs, insurance, fuel, and what not on the abandoned runs, no longer would be spent. Brokers, tug crews, pilots and domestic agents will lose another \$6,500,000.

Then there's the question of subsidies. The maritime commission estimates that \$180,000,000 put up by the federal government since 1923 to help American shippers get business would be a total loss. That's the part of the subsidies paid to ship owners running on routes that now are in danger zones, and would, therefore, be abandoned.

But how about foreign trade, as such, without regard to the nationality of the vessels that carry American products?

Industry Not Affected

Conservative opinion leans to the belief that the neutrality law will have little or no immediate effect on American industry, with the exception of aviation. With the arms embargo out of the picture, for instance, the French and British can order the \$80,000,000 worth of planes they had ready to ship from this country on September 5. Similar orders should continue for months.

But the French and the British have not been buying other war materials on a big scale in the United States, nor have their normal orders in other lines increased very much, indicating they have large stocks in warehouses.

Likewise, the Allies seem to have plenty of farm staples on hand, what with a world surplus of wheat and cotton to draw on, much of it in their own colonies.

On the other side, the economists suggest that the Germans have neither the gold with which to buy American surpluses, nor the ships to carry products through the British blockade.

That means business as usual in the United States—for some months to come—unless actual warfare on

RACES IN VIEW FOR CONGRESS

Contests Seen For More Than Half Of Districts

By HENRY AVERILL, Reflector Bureau.
 Raleigh, Nov. 7.—With the 1940 general elections just a year away today (figuring on the Tuesday after the first Monday and not on the absolute date), and the primaries less than seven months in the future, it is now possible to forecast to an absolute certainty that there now appears no likelihood of anything more than a pro forma or nominal opponent to the incumbent.

The districts in which the present Congressmen apparently can sleep well at night, without nightmares of being unseated are the First, where Lindsay Warren is as safe as government bonds; Second, where so far there have been no reports of a rival to Judge John Kerr; the Fifth, where smiling Lon Folger looks as good as "in" again and that without trouble; and the Ninth, where aged "Farmer Bob" Dough-ton is a cinch to win as long as he wants to.

In some other districts there is no announced opposition to the incumbents as yet; but there are rumblings which indicate that all isn't going to be beer and skittles for the sitting member.

In the Third, for instance, there is much talk of State Senator John D. Larkins, Jr., as an opponent for Congressman "Hap" Barden, and it would be no surprise whatever if Jones county's Kentucky Colonel should decide to make the race.

Larkins is almost uniformly regarded as an up-and-coming political prospect, and it is also universally conceded that he is nobody's dumb child. It therefore follows that he may reserve his fire for a later date—say for a chase after the lieutenant governor's post in 1944—but if he can locate any real support in the Wayne-Pender-Sampson end of the Third, he's an even bet to run against Barden. He's well hooked up in Craven-Carteret-Onslow sector, but realizes he must get substantial backing in the other end in order to have a real chance.

In the Fourth, Congressman Hal Cooley hasn't made any friends by his actions with respect to the repeal of the arms embargo. After proclaiming himself opposed to the administration's program he later experienced a change of heart, or something, and got aboard the band wagon.

There are rumors, though they quite frankly cannot be dignified by being called anything stronger, that Timous Valentine plans to run against the incumbent; though in view of the previous alignment of the pair it is hard to put much credence in them.

Another district in which there is no more than a mild possibility of a good scrap is the Seventh, where State Senator Emmett Bellamy of New Hanover would take very little persuading to get into the race against Congressman J. Bayard Clark of Fayetteville. There hasn't been much open persuasion, however, and it's problematical whether the urbane and courteous gentleman from the lower Cape Fear will risk a licking.

The Sixth, Eighth, Tenth and Eleventh seem to be certain battlegrounds. In the Sixth there are already three announced opponents for incumbent Carl Durham. The Eighth put on the Deane-Burgin row last time and it sure to have a hot campaign next year. In the Tenth and Eleventh they run to keep in training for the Republicans and contests are regarded as a matter of course.

Getting back numerically to the Sixth—Oscar Barker of Durham, Ed Hanford of Alamance and John Caffey of Guilford have already told the world that they want to replace the Chapel Hill druggist who hasn't yet let out a chirp about his intentions with regard to next year.

It is assumed that Mr. Durham will run again, however, as it's always a hundred to one that a fellow in office will run for re-election in the absence of especially compelling reason to the contrary—and in this case none seems to exist.

In the Eighth, it is said that C. B. Deane is going to run again; while there is no reason to suspect that sitting Congressman W. O. Burgin is anxious to retire. There has been much talk about the candidacy of John Lang, Jr., of Moore county, who is now state NYA head.

If there is a repetition of the Deane-Burgin, it offers a very attractive opportunity for others, as there isn't the slightest doubt that a large proportion of the electorate became at least slightly nauseated over the long-drawn-out legal battle between that pair.

In the Tenth, it appears that veteran Major A. L. Bulwinkle will be opposed by Jim Abernethy of Lenoir, a much younger man; and there is a considerable body of thought that assigns Congressional yearnings to Ed Butler of Morgan-ton, a former president of the State Young Democrats. Abernethy has important money connections and would not lack for the sinews of war.

In the Eleventh Zeb Weaver is more likely to be opposed by Asheville's blind City Judge Sam Cathey than by any other single foe; but W. L. Whitmore of Hendersonville made a good race against the veteran member last time, and cannot be eliminated until he says so—though there is evident an opinion that he will not run this time.

Labor to Wage Campaign For Assembly Strength

Reflector Bureau.
 By HENRY AVERILL, Raleigh, Oct. 31.—Labor in North Carolina—as represented by the AFL-affiliated State Federation of Labor—is actively campaigning right now for greater strength in the 1941 General Assembly, the member of which will be nominated in the spring primaries next year.

President of the State Federation, C. A. Fink of Salisbury, is convinced that there were "too many corporation lawyers" in the 1939 legislature and is urging his organization and its members to get actively into the political battle with a view to electing enough friends of organized labor to make it an important group in the Assembly. He particularly wants as legislators men who are active affiliates of the union.

"If we are to get anywhere with our legislative program we must have some members of our affiliated unions in the next legislature," said Mr. Fink writing in the October issue of the North Carolina Federationist. "I earnestly urge our members to enter the campaign for election to the legislature. There were entirely too many corporation lawyers in the General Assembly and that accounts for the difficulty labor has in the adoption of proper labor and social legislation."

There are many counties in the state where organized labor, if it ever really becomes "organized" politically, is powerful enough to hold the balance of power if indeed it cannot elect members of unions; and the latter is capable of accomplishment in some counties.

There seems to be no doubt whatsoever that the Federation plans a more vigorous political attitude than it has ever adopted in the past, and

there are signs that its increasing strength is being recognized by numerous office seekers.

This despite the fact that in the 1939 legislature there was an overwhelming majority against any of the more advanced or drastic legislation sought by labor. A state wage-hour law, for instance, was so badly beaten from the very start that efforts to enact such a measure almost boomeranged into a weakening of the existing state statutes on the subject of hours.

About the only North Carolina law which has to do with regulation of pay provides that railroad workers shall be paid twice a month, and this law says nothing whatsoever about the amount they shall be paid per hour, or week, or any other unit of time.

First indication of a really belligerent attitude of the Federation in North Carolina came during its state convention some months ago, when a rousing resolution was adopted denouncing "Hap" Barden, Congressman from the Third district for his stand on wage-hour amendments.

Now President Fink is calling on all unionists to rally en masse for a legislative campaign to seat lawmakers friendly to labor and unseat those who are not.

"Now is the time to begin waging a campaign for the enactment of legislation as called for in our convention," says Fink.

"Some members of the 1939 legislature must not be re-elected to the 1941 General Assembly. They have manifested such antagonism toward all labor and social legislation that they should be defeated if they offer again for election.

The names of such legislators

will be published at an early date." Mr. Fink also promised publication of a list of those legislators whose records are satisfactory to labor.

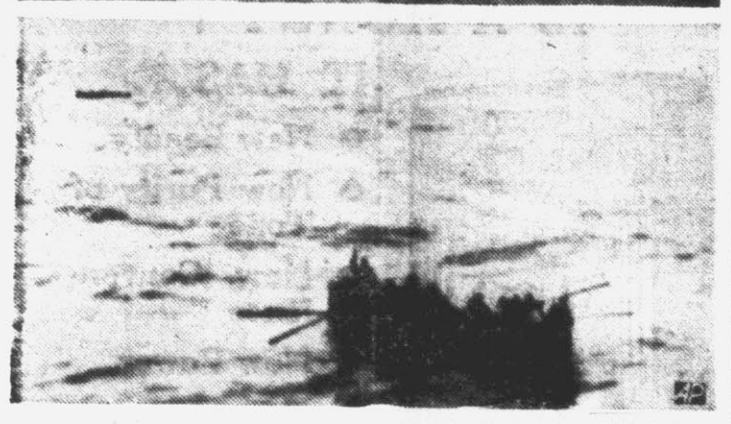

Tells Lions Club Of Help To Blind
"In Pitt county there are at the present 32 blind people enrolled for home-teaching courses," stated Mrs. Annie B. Faircloth in an address to the Greenville Lions' club last night in the Woman's club.

Mrs. Faircloth, who is associated with the State Commission for the Blind, has been spending the last week in Greenville and Pitt county, where she has interviewed 24 blind persons and aided a number in getting started on some home industry.

"Home-teaching for the blind is the surest way to aid dependents in becoming creative and economically secure," declared Mrs. Faircloth.

Practically all of Mrs. Faircloth's work is done in teaching handicrafts, chief of which is leather work, and in packing braille. As yet no group classes have been formed; individual instruction has been imperative.

When asked how long it took one to learn braille, Mrs. Faircloth stated that "six weeks of intensive work is necessary for a student to become able to read braille."

The Greenville Lions' club is local sponsor for the work now being undertaken by Mrs. Faircloth among the blind of Pitt county. To the end that the club may support this work more generously, a Thanksgiving dance is being planned by the Lions' club. Profits from this social event will be used in rehabilitating the blind of this county.
