RUSSIA STRIKES AT FINNS WITH RENEWED FURY
Roosevelt Condemns Russian Invasion Of Finland

USE OF FORCE IS SPREADING

President Asserts that Action of Russia is a 'Profound Shock' to the United States Government and its People, and One Which Jeopardizes Rights of Mankind

Washington, Dec. 1.—(AP)—President Roosevelt declared today that Russia's invasion of Finland was a "profound shock" to the United States and jeopardized "the rights of mankind to self-government."

In a formal statement read to a press conference, the chief executive said all peace-loving peoples would "unanimously condemn" his new resort to military force as the arbiter of international differences.

"The news of the Soviet naval and military bombings within Finnish territory has come as a profound shock to the government and peoples of the United States."

"Despite efforts made to solve the dispute by peaceful methods to which no reasonable objection could be offered, one power has chosen to resort to force of arms."

"It is tragic to see the policy of force spreading and to realize that justice and disregard for law is still on the march."

"All peace-loving peoples in those nations that are still hoping for the continuance of relations throughout the world on the basis of law and order will unanimously condemn this new resort to military force as the arbiter of international differences."

"To the great misfortune of the world, the present trend to force makes insecure the independence of some of our nations in every continent and jeopardizes the right of mankind to self-government."

"The people and government of Finland have a long honorable and wholly peaceful record which has won for them the respect and warm regard of the people and government of the United States."

Before the press conference the president asked Russia and Finland to pledge before the world that they would refrain from bombing defenseless citizens and undefended cities.

At the press conference the president, when questioned, said he had nothing to say about possible application of the neutrality law to the Russo-Finnish conflict, nor did he comment on whether the United States was considering withdrawing recognition of Soviet Russia.

Nine Are Tried In City Court Today

Americans Taken From Finnish City

Washington, Dec. 1.—(AP)—The American legation at Helsinki notified the State Department today that its staff members were transporting "numerous Americans" from the Finnish capital.

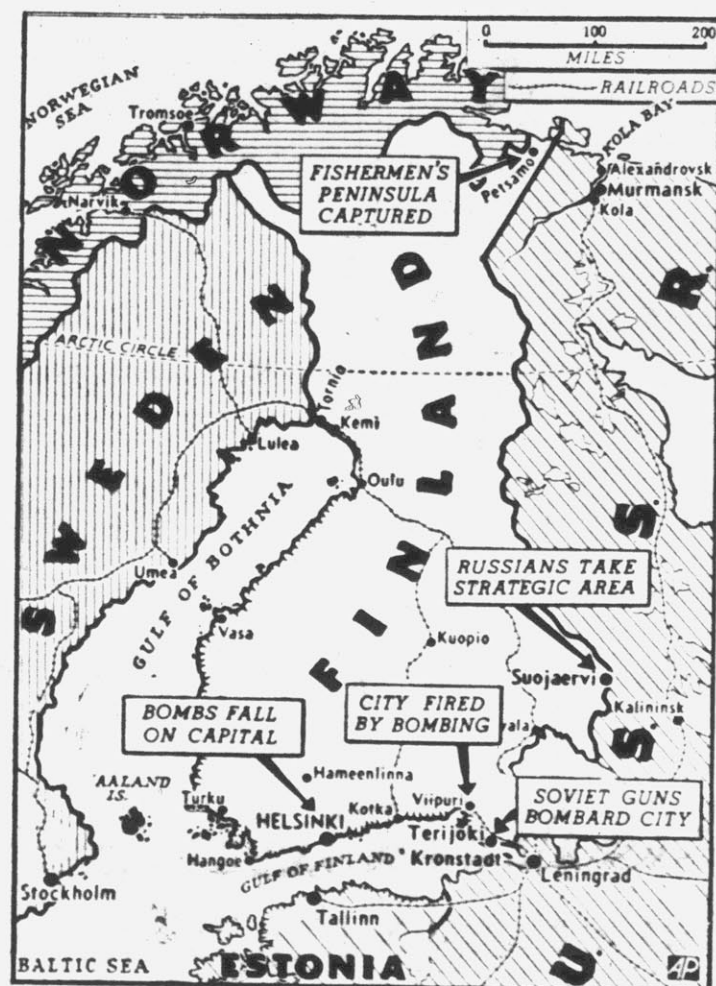
The legation workers were using their own automobiles to carry the Americans to temporary headquarters at Badrunkulla. The last report said there were about 300 Americans in Finland.

Fires were being brought under control, the legation said, and added this line: "The casualty list includes children."

Russian Bear Invades Finland

New Finnish Governm't Is Favorable to Russia

Former Leaders Assailed by Moscow are Dropped

Helsinki, Dec. 1.—(AP)—Finland formed a new government tonight, dropping leaders who had been assailed by Moscow, as Russian armed forces renewed and extended their attack upon the country.

While the new government was being formed Russian bombing planes swooped low over the capital and machine-gunned civilians in the streets. Viiborg and other cities also were raided.

Russian attacks extended from Finland's extreme Arctic tip where soldiers were reported dropped by parachutes from warplanes to seize important towns, to Finland's extreme southwestern corner where Red warships opened a blasting onslaught against the strategic Fort Hangoe guarding the entrance to the Gulf of Finland.

Finnish defense batteries on the Russaroe fortress were reported to have sent one of the attacking warships to the bottom of the gulf.

The new premier is Risto Ryti, 50-year-old governor of the Bank of Finland. His foreign minister is Vaino Tanner, socialist finance minister in the outgoing government and regarded as friendly to Russia. Dropped all together were Premier Aimo K. Cajander and his foreign minister Elias Erkko, both of whom had been attacked bitterly by Moscow as trying to lead Finland into war against Russia.

Rebel Government Reported Set Up

Moscow, Dec. 1.—(AP)—Tass, official Soviet Russian news agency, reported today that a "peoples government of the democratic republic of Finland" had been formed in Terijoki, Finnish town near the point where Russian troops first crossed the border yesterday.

Tass said it had been formed by agreement of representatives of a number of parties and Finnish soldiers who, it alleged, rose in revolt. (A Helsinki dispatch said the rebel government in Terijoki drew only laughter in the Finnish capital.)

HOPES TO WIN PIVOTAL STATE

Says He Will 'Be Glad to Make the Fight' in 1940

New York, Dec. 1.—(AP) District Attorney Thomas E. Dewey today formally entered the campaign for the Republican presidential nomination.

Replying to a declaration of a group of state party leaders that he could carry this "pivotal state," Dewey told them he would "be glad to make the fight."

The leaders had just opened a Dewey headquarters in a ceremony which included the reading to Dewey by J. Russell Sprague of nearby Nassau county of this manifesto calling upon republicans generally to work to bring about a Dewey nomination.

Responding, the young district attorney said: "I appreciate this support for the nomination next year and I will be glad to make the fight. I have confidence in the republican party which has always stood for good government and stable business."

"Today its responsibility is to reawaken hope in a nation which is driven almost to despair by incompetent government and the unstable business."

"I went on to express 'faith in the nation and in its future and in every element of its people'."

"Relieved of a hostile and sniping government," he added, "I am convinced they can again learn to pull together for a united nation."

Red Oak Citizen Claimed By Death

Red Oak citizen, 48 one of the Red Oak community's most prominent citizens died at his home at 11:30 o'clock last night following two months of declining health.

Funeral services were conducted at 3 o'clock this afternoon at the home by Rev. Gilbert Davis, pastor of Red Oak Christian church, of which Mr. Allen was a member, assisted by Rev. Chester Pelt, Free Will Baptist minister of Winterville. Burial followed in the family cemetery near the home.

Active pallbearers were B. L. Tyson, R. R. Tyson, H. R. Allen, H. H. May, Thomas Manning and Sam Pollard.

Mr. Allen, the son of the late Thomas and Minnie Stokes Allen, was born and spent his entire life on the farm where he died. He was well known throughout his community. For a number of years, he was superintendent of his Sunday school and at the time of his death he was serving on the Board of Deacons and also was teaching the men's Bible class. He had been a member of the church for 24 years.

He is survived by his wife, Mrs. Sarah Causey Allen; two daughters, Miss Edith Glenn and Inez Allen; three brothers, Albert, James and Ferner; Allen, all of the Red Oak community; two sisters, Mrs. Lizzie Vandford and Mrs. George L. Allen, also of Red Oak.

Many Pitt Youths On NYA Program

There are approximately 135 young people of Pitt county receiving over \$2,500 a month under North Carolina's National Youth Administration program, but K. T. Futrell, superintendent of welfare said that there are about 20 vacancies in the youth training program at present.

According to Anna A. Cassat, director of the State Board of Charities and Public Welfare, "If 10,500 youth training opportunities were allocated by the NYA in North Carolina on a population basis, Pitt county would be entitled to approximately 163 who would earn \$2,765.50."

On a basis of the November 1939 report, youths of the county were losing \$913 a month in income which was equivalent to training opportunities for 55 youths. During the last payroll period, there were 108 Pitt County youths earning \$1,792.80. Futrell explained that a check of the referrals to the NYA since November 15 and those which are already in the process of being referred, that about 20 vacancies remain to be filled.

TOLL OF SHIPS SUNK BY NAZIS LISTED AT 194

Number Indicates Both British and Neutral Craft

LOSS IS LISTED AT 735,768 TONS

Today's War Communique Reports Only Feeble Artillery Activity on the Western Front

Berlin, Dec. 1.—(AP)—DNB, official German news agency, reported today that from the beginning of the war to November 28, 194 vessels, totalling 735,768 tons—both allied and neutral—headed for Great Britain had been sunk by German submarines or mines.

DNB said the sinking of 163 ships—52 of them neutral—totalling 639,688 tons was confirmed by German reports.

Non-German sources, the agency said, disclosed an additional 32 ships of 96,079 tons total, half of them neutral, representing 39,321 tons.

The statement listed 150,887 tons of shipping as tankers and said the average was 7,500 tons per ship—in other words about 20 tankers.

DNB insisted the total losses must be considerably larger, however, charging that the British admiralty had not published all losses, especially those along the British coast.

Today's army communique told of "feeble artillery and scouting activity" on the Western front and said bad weather hampered aerial reconnaissance to the extent that four flying boats were forced by the weather to alight on the North sea. The planes were damaged, but the crews were saved.

Exonerate Driver In Highway Death

Curly Murphy, Kingston, Negro, was absolved of blame at an inquest held today at Aven into the death of Annie Mae Dail, nine-year old daughter of Mr. and Mrs. L. M. Dail of near Aven, who was killed Wednesday afternoon near Aven grammar school.

It was brought out at the inquest that the Dail child, a student in the second grade of the Aven school, ran into the truck driven by Murphy while she and several other children were playing. The little girl's neck was broken.

The coroner's jury, headed by Deputy Coroner E. S. Williams, returned a verdict that the child came to her death by "unavoidable means." The family of the child and the Negro were represented by counsel at the inquest.

Funeral services for Annie Mae were conducted from the home of her parents, Tuesday afternoon at 2:30 o'clock. Burial was in the family plot in Jackson cemetery.

300 Persons Receive Checks From Savings

More than 300 persons, mostly Greenville residents, today received welcomed checks in the form of Christmas savings.

The First Federal Savings and Loan sent out more than \$6,000 to the 300 persons holding Christmas savings. It was announced that new classes were now started where a person can save from 25 cents to \$5 weekly.

Negro Badly Injured In Affray Last Night

Five persons, all Negroes, were arrested yesterday on charges of assault. It was reported at police headquarters this morning.

One of the five persons engaged in the affray, is in Pitt General hospital suffering from severe stab wounds. Tootie Harper was taken to the hospital with a knife blade broken off in his head after allegedly engaging in an affray with Sam Ricker, who was hit with a severe blow on the side of the head. The affray was said to have taken place at the Busy Bee cafe about 7:30 o'clock last night.

Other persons arrested yesterday or last night on assault charges were Sarah Taylor, Ernest Hines and Ella Mae Hunter.

SEEK CHANGES IN FARM LAWS

Local Men to Attend National Farm Bureau Meet

Raleigh, Dec. 1.—(AP)—North Carolina's delegates to the American Farm Bureau Federation convention at Chicago next week will ask national support for proposed farm law changes to permit adoption of long range crop control programs.

The state Farm Bureau's executive committee directed the delegates to present a resolution favoring a special federal tax to finance long-range control programs and amendments to the AAA which would permit farmers to vote to have crop control for three to five years or longer, instead of only a year-to-year basis.

Another resolution set forth that no other crop pays a tax proportionately to the \$500,000,000 federal levy collected annually from tobacco and other products and asked the national bureau to favor a congressional action to set aside 20 per cent of the tobacco tax to provide tobacco farmers with parity prices for their wares.

Need of Seal Funds In County Expressed

While Greenville's sale of Christmas seals is already under way, the need for funds derived through such sales was revealed today, by K. T. Futrell, superintendent of public welfare.

Futrell said that "seventeen Pitt county residents are now in the Sanatorium, eight Burr cottages are being occupied in the county, and the welfare office has been held responsible for 25 X-rays this year owing to the diminishing seal sale funds."

"An increase in tuberculosis cases rather than a decline in sale of seals was described as the cause of the welfare office's being held responsible for the X-rays which are usually paid for out of seal sale funds."

Squadron of Planes Rains Explosives On Helsinki

Capital Attacked for Second Successive Day; Soviet Forces Strike All the Way From Arctic Ocean to the Southwestern Shores; New Government May Be Friendly to Russia

Helsinki, Dec. 1.—(AP)—Russia's armed forces struck against Finland with renewed fury today and operations extended from the Arctic ocean to the country's southwestern shore, adding aerial machine-gunning to their raids with explosive and incendiary bombs.

A large squadron of bombers roared down on Helsinki for the second successive day, machine-gunning the capital proper and its suburbs and setting the city ablaze with incendiary bombs.

Beginning at 1:15 p. m. (6:45 a. m. EST) this raid was still in progress one hour and 40 minutes later.

Finnish reports said many of the raiders were shot down. Casualties in the city could not be estimated immediately. Fifty persons were officially listed as killed in yesterday's attacks on the capital along with a number of dead and wounded in provinces in widespread new attacks today was undetermined.

A new government was formed to succeed that of Premier Aimo K. Cajander, which resigned early today, even though it had a vote of confidence from an historic session of the parliament.

Its composition was not announced immediately. Previously Vaino Tanner, finance minister in the resigned cabinet and described as friendly to Russia, had been expected to be named premier.

Copenhagen reports said diplomats expected the new government would come to terms with Russia.

The Finnish legation in London, however, said there was no question of a surrender.

The new attacks followed expiration of an ultimatum broadcast from Moscow threatening annihilation of Helsinki unless an agreement was reached by 3 a. m. (8 p. m. Thursday, EST).

Russian forces were striking today at Finland's farthest northern outposts at points along the 800-mile eastern frontier and along the southern seacoast around to the extreme southwest.

Near the middle of this front Soviet land forces had occupied territory north of Lake Ladoga and farther south had advanced on the Karelian isthmus north of Leningrad. (Moscow reports a Russian warship was reported to have opened a heavy bombardment of the Russian fortress at Hangoe on a strategic southwestern Finnish promontory 75 miles west of Helsinki and guarding the entrance to the Gulf of Finland. (Russia had demanded Hangoe for a naval base.)

At the extreme northern tip of the Russian-Finnish border Russian warships were reported to have occupied by parachutes and to have occupied Petsamo, principal town of Finland's narrow corridor to the Arctic ocean.

Helsinki, Dec. 1.—(AP)—Helsinki chief of police said tonight that 30 women and children were killed by Russian bombs dropped in the raid on the capital early this afternoon.

HOURS SET FOR TRUCK DRIVERS

Speed Limit and Mechanical Inspection Provided

Raleigh, Dec. 1.—Regulations governing the transportation of gasoline and other dangerous combustibles will be issued by Commissioner of Revenue A. J. Maxwell tomorrow and will embrace three main points, including an invasion of the hours of work field, one laden with all sorts of potential political and legal dynamite.

The three principal points in the regulations will be:

- (1) Drivers must not work more than 55 hours per week.
 - (2) A flat speed limit of 35 miles per hour is made applicable to all trucks under the regulations.
 - (3) Specific provisions for mechanical inspection of trucks and physical inspection of drivers.
- The commissioner recognizes that there will be plenty of controversy over the first two points, at least, and probably over every phase of the regulations. He started out with the apparent and cordial cooperation of the truck owners, but wound up completely behind the eight-ball so far as they are concerned. He is pictured as quite apprehensive that there will be a hard struggle over the rules, and he is well aware that his action is going to be denounced bitterly as the opening salvo of his unannounced gubernatorial campaign rather than a sincere effort to make the state's highways safer.

The commissioner was told flatly by the trucking interests that they do not recognize his right to enter into the matter of the working hours of their employes. They declined to have any part whatever in making any regulation along these lines, the nearest approach to that being their request that if Maxwell made any rule at all—without admitting his right to do so—he follow the Interstate Commerce Commission's regulations which permit truck drivers to work 60 hours weekly.

Maxwell based his decision for a 55-hour week on the general North Carolina work hours statutes; which in the past have specifically not applied to trucking interests regulated by the State Utilities Commission, the federal I. C. C. or which have eight or less employes. His decision is going to be attacked as a political sop to labor. Some of the conferences preliminary to drawing up the final draft of the regulations were attended by labor organizers, a fact which has struck in the craw of the truckers and which they regard with great hostility.

As for the 35 mile per hour speed limit, here again the commissioner spurred recommendations of the trucking and resorted to the North Carolina motor vehicle laws regarding speed—a statute which incidentally has been held by the Supreme court to give nothing more than "prima facie" evidence of negligence or unlawfulness.

This section provides: "No person shall drive a vehicle on a highway at a speed greater than is reasonable and prudent under the conditions then existing," and adds a section (b) which prescribes "where no special hazard exists the following speeds shall be lawful, but any speed in excess of said limits shall be prima facie evidence that the speed is not reasonable or prudent and that it is unlawful—thirty-five miles per hour for vehicles designed, equipped for or engaged in transporting property."

Practically every truck operator consulted about the speed limit declared emphatically that a 35-mile limit is ridiculous under present day conditions of highways. They contended that such a low limit is actually a menace rather than an aid to safety on the roads. Their idea was 45 miles per hour but they were willing to cooperate in enforcing a limit of 40 miles per hour.

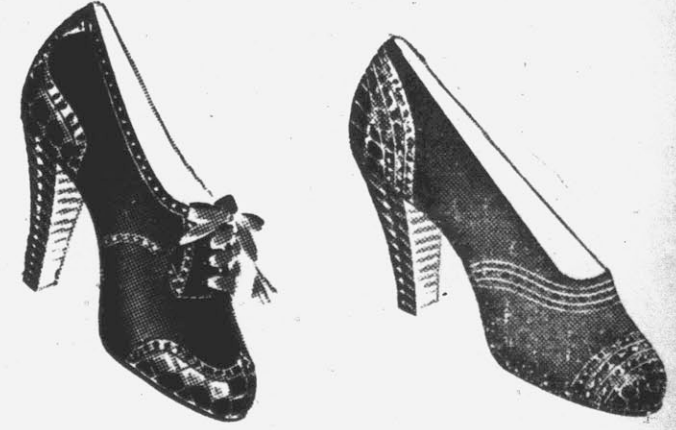

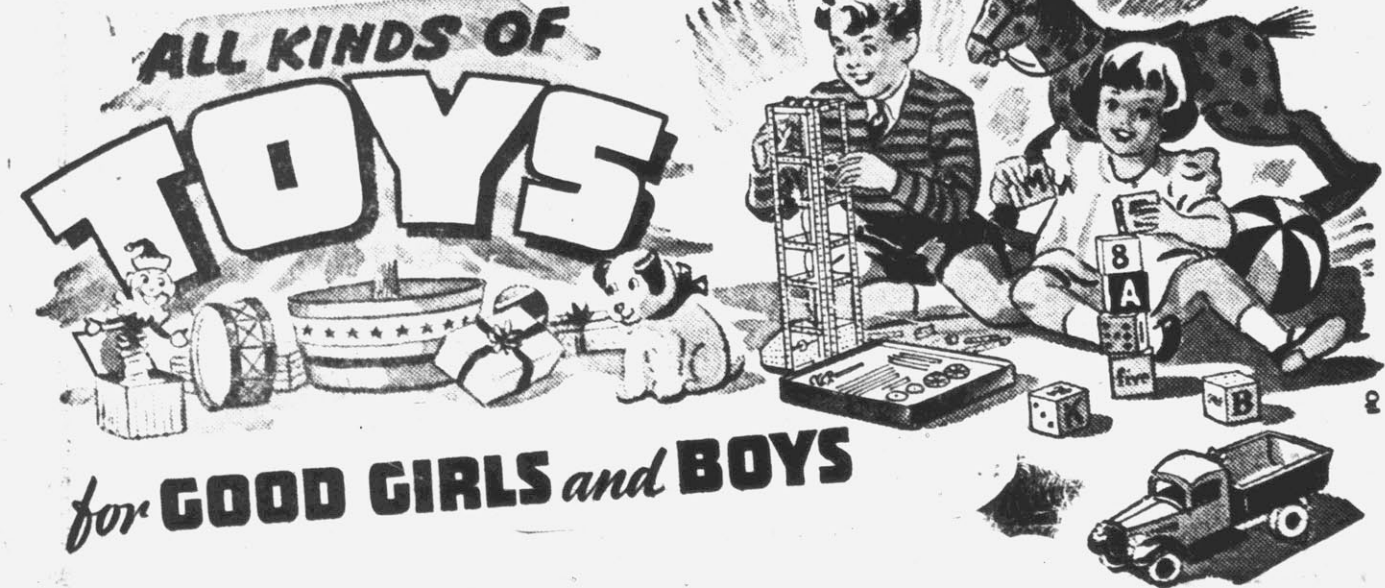
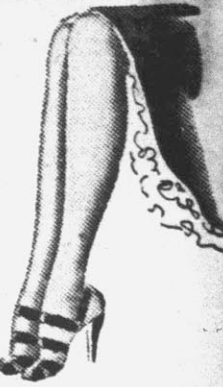

SHORT SHOTS

Raleigh, Dec. 1.—Fifty years of
state college will be the subject of
D. A. Lockmiller, of the State
College Department of History, who
will address the State Library and
Historical Association at its session
Monday morning, December 4, ac-
cording to Dr. C. C. Crittenden, sec-
retary of the association.

Dr. Lockmiller is a prolific writ-
er during the past two years
published no less than three
books: "History of North Caro-
lina State College," "Magoon in
Carolina," and a popular biography of
William Blackstone.

Commissioner of Revenue A. J.
Axwell took a trip into the field
Wednesday afternoon at
Sommerville when he told a group
of civic clubs there that one of the
tasks North Carolina should be
thankful for is the very de-
cided and noticeable awakening of
interest in the State's history with-
in the present year.

Much more has been written,
read and spoken of North Caro-
lina history in 1939 than in any
previous year.

Unprejudiced observers attribute
much of the growth of interest in
North Carolina's history to publica-
tion in papers and radio broadcasts
interviews and quizzes of Walter
E. Murphy of Salisbury who
possibly has more historical
information in his head than has
ever been put on paper about North
Carolina.

Friends from all over the state
are still beseeching Mr. Murphy to
act as secretary of state in next
year's primary.

Another angle to the spread of
interest in history of North Carolina
has been the drama "Lost Colony" at
Roanoke Island, a presentation
which has been so widely and ex-
tensively publicized as to attract
international attention.

Then the Fayetteville celebration
of the sesquicentennial of the
state's ratification of the constitu-
tion played its part—as has the
agency of many places in the
state to stage historical pageants.

Definite plans for restoration of
York's palace at New Bern are
being laid before the North Carolina
Society for Preservation of Antiques
at its meeting here in December.
The wing of the mansion of the
palace is still standing and
entirely the architect's drawing for
the palace were discovered making
possible authentic and exact restora-
tion.

The exodus of state officials for
answering began before today.
Wednesday it was almost impossible
to find anyone in his office. There
didn't appear to be anything im-
portant brewing, however, even po-
tentially.

Asheville's power company em-
ployee strike is reported to be the
most of its kind ever to vex that
city. Without professing to know
anything whatever about the merits
of the matter, it can be predicted
that it will fall. It seems that labor folks
never learn they can't stop es-
sential public services without draw-
ing upon themselves the anger of
those who have to do without such
services.

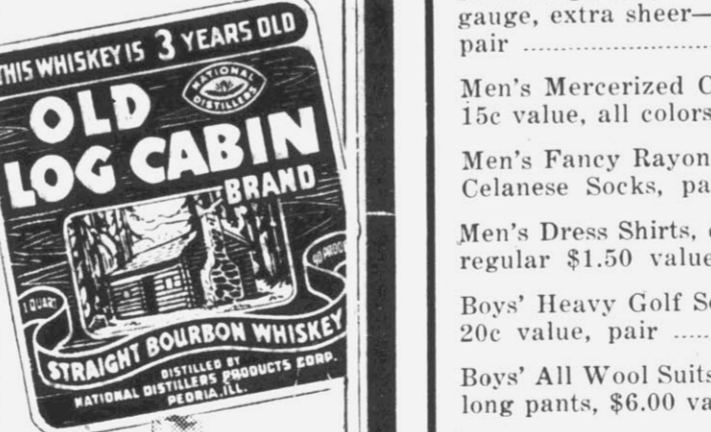

Inter Se Book Club Meets

The Inter Se Book club held its regular meeting on Tuesday afternoon at the home of Mrs. Tyson Bilbro. Mrs. William Taft, in her most charming manner, presented a delightful paper on historic churches of North Carolina. She discussed mainly St. Paul's Episcopal church at Edenton, St. Thomas' church at Bath, Calvary church at Tarboro, and the First Presbyterian church at New Bern, giving a description and the historical background of each.

Outstanding interest during the discussion of international affairs was a letter read by Mrs. L. M. Buchanan. This letter was one

which had been written to members of her family by close friends living in the midst of wartime activity in England. As contained in the letter: From England, October 24, 1939. We went on holiday to Exmouth and when we returned I found they were billeting London evacuees upon us. First of all I had a nurse from a London hospital, a teacher and a child and now it has boiled down to the teacher, who is a very sweet little soul some age as myself—to start with, she looks a teacher and is most frightfully marshy and plays no games, but her sweet nature invades everything, so we are boiling down very well with our new war-time friend—she is attached to the school and they are trying to share the building with this Woolwich evacuated school and the Maidstone children—one school going in the morning and the other in the afternoon and poles of home work being given for the children to do at home—but I am afraid this war time education will not yield brilliant results, but we must not grumble.

The week-end we had the influx of three, the bank in which I was employed before I was married asked me to stand ready to return at a minute's notice and it was a "minute's notice" too, for on Tuesday September 5 the manager telephone at 9:15 and said "can you come at once to take a till at 1 o'clock, 9 of my men have been called up." So off I went and was down in time to start my war work of bank cashier. Our 11th man left last week and so far we have only 5 temporary clerks, and the work seems to have doubled itself, owing to 20,000 evacuees being in the town and about 25,000 soldiers. We are rarely home before 9 at night, and we start at 9 in the morning. But my little maid that was with me when you were here, is still here and she seems to carry on my home fairly well, with the help of her married sister who comes to give her a hand turning out rooms once or twice a week.

Really we hardly realize there is a war as regards seeing or hearing any fighting or raids—but of course we have many discomforts; we are all blacked out, no street lights or shop lights and our houses are sealed at night. Our raid wardens walk the street ready to fine us if lights are showing.

We are prepared to the last eventually, we have anti-aircraft guns all along our hills; and London is a mass of balloons as a barrage. Our observer corp is on 24 hour duty listening and watching for raiders and the A. R. P. are also on duty 24 hours all ready with first aid posts, demolition squads, fire fighters, nurses and ambulances, etc., and we have strict instructions never to go out without our gas masks, and faintly enough all this goes on and we seem to have taken it in our stride and think nothing of it. We have had several air raid warnings. When hooters go at several points all over the town, everything stops, cars and traffic are put into side roads to keep main roads clear, the firemen are at their posts and all the departments are at their posts, until the warning is given again by hooters that all is clear.

We had one last week at 1:30, lunch time, and in the bank it caused a good deal of fun and pende-monium. I was in the middle of taking a credit and the manager came along and seized my till and ran off with it to the safe and I followed with the rest of the money and checks. The office was cleared of all ledgers and papers of value and we just waited an hour and a half until the "all clear" signal and then it was all brought up from the dungeons and we did not see a plane or hear a gun. Being only nine miles from Chatham we are really near a military and naval objective.

Scotland seems to have had more trouble, and two days last week they had continuous raids all day but they were always going for the fleet just on the coast and not over the towns.

Our food seems very plentiful except bacon—many days one cannot see any bacon at all in the shops and then, when there is some, there is not much of it, and it soon goes, due I suppose to most of our supplies coming from Denmark. Our shipping is so disorganized it just cannot keep a steady flow of goods into the country—of course the housekeeping is going up. Our ration cards are expected at any time now. Butter is four shillings and sugar two shillings.

Of course petrol is already rationed; a car gets five gallons a month unless it is a business car when application is made for more and considered. My husband used

48 a month before war and he is now allowed 18 so you can see it is quite scarce.

I cannot think Germany can hold out for long, nor do I think such can prosper, but Russia seems wrong an unknown quantity these days—incidentally the 7-6 in the pound income tax is very crushing and I cannot see that it can stop there. We cannot fall to be a poor nation for—the there is a lot of distress now just through luxury trades fading out—a case in point, my husband's people in the nursery trade find no demand at all for flowers and plants and they are left with no business at all, and not sufficient land to cultivate market garden stuff to make a living—the whole of last year's cultivation is a loss and they have to wait another nine

months before they can get a crop of vegetables and then not enough to get a living from. His youngest brother has joined up to help things and has already gone to France as a lorry driver—his wife and two children receive about 30 shillings a week allowance. The other brother has got into the observer corp and receives three pounds a week and has 4 children and still the old people have to live from the business. One of the big nursery firms in the town had its director shoot himself this last week—the only thing left for some people is to join up and be paid to kill someone. It is all just too terrible—and just because Hitler and his mob want all they can see—they are mad men and should be kept under lock and key or shot—surely the United States

will help us if only with their neutrality policy, which must be against Germany—we don't want to kill Germans or Germany but we must have leaders there who can be trusted, and until they have gone, we shall continue this war if we are brought down to the very dust ourselves.

Norman says he is going to dig up our lawns to grow vegetables next spring, if there seems no end to it then; he has signed on the national register to go back to sea in the merchant service, but so far we are losing more ships than men, so he may not be called for months yet, so in the meantime he hopes to get into the observer corp when he will watch for raiders etc.

We have taken German prisoners who did not know a state of war

existed, and were told they were on maneuvers and most of them say their food is bad and they have no blankets and supplies do not come up, so it would seem that they are really hard put to it now.

I feel they must have a revolution when the whole thing must collapse. I am sure our government is counting on that sooner or later and our saying we are prepared for a three year war is for German ears only—lets hope and pray it will never drag out so long—the miseries of a few months are enough.

How lucky you all are to be in U. S. A. where there never seems to be the thought of war, except other people's wars!

Safety Drive Set For Pitt County

Even though no school bus accidents have occurred in Pitt county during the current school year, D. H. Conley, county school superintendent, today declared that he is launching a concerted drive through school principals in an effort to make drivers of school busses more safety conscious.

In a communication with the Pitt school superintendent, C. C. Brown, equipment engineer of the State School Commission, pointed out that during the present school year there have been an appalling number of school bus accidents throughout the state, adding that "the number has been greater than any two years combined for the same period of time."

Engineer Brown explained that "a singular, and perhaps a good thing about these accidents, is the fact that at least 90 per cent of them have happened to new busses; and while our first and last consideration is the safety of children transported, the accidents have been costly."

After disclosing that "most of these recent accidents have been the fault of school bus drivers, while the majority of previous accidents involving school busses could be charged to the carelessness of motorists," he urged Superintendent Conley to cooperate with the State School Commission in its efforts to eradicate such conditions in the future.

Causes of school bus accidents, as outlined by Brown, were: "Children running alongside the bus after being released; drivers entering arterial highways or attempting to go through crossroads without first bringing the bus to a stop to determine if it is safe to proceed; backing busses or driving hurriedly across the grounds to gasoline tanks and stopping busses on heavily congested highways in thickly populated communities."

FDR Endorsement Of Seal Sale Released

The following endorsement by President Roosevelt was released today in connection with the local Tuberculosis Christmas Seal campaign:

"As the Christmas season approaches, my mind is drawn to the fact that it is again time for all of us to give our support to the sale of Christmas Seals.

"This is such a well established custom in the United States that it seems hardly necessary again to call the attention of the people to its importance.

"Tuberculosis still menaces the lives of all our citizens and it leads in the cause of death of those between the ages of 15 and 45. The fine work that has been done by the National Tuberculosis Association in the prevention of this dreaded disease merits the continued support of all the people of our country."

Julius H. Rose, commander of the North Carolina department of the American Legion, returned to Greenville last night from a two-week speaking engagement that carried him as far west as the Cherokee reservation in Smoky Mountain park.

Commander Rose said that November was his heaviest month for speaking engagements and that most of the work in this particular field has been shifted to the background. He will confine his duties for the next several months to problems in general concerning the legion.

Places where Commander Rose delivered talks were Morganton, Asheville, Waynesville, Spruce Pine, Boone, North Wilkesboro, Kernersville, Newton, Indianapolis and Chapel Hill.
