SOVIET DRIVES WITHSTOOD BY FINNISH LINES

Red's Massed Offensive Continues for Ninth Day

FAIL TO EASE VIGOR OF DRIVE

With Supplies Apparently Depleted on Both Sides, Bayonets Are Used In Place of Bullets

Helsinki, Feb. 10.—(AP)—The Red Army's massed offensive on the Karelian isthmus was continued for the ninth consecutive day, but all assaults were thrown back with heavy losses.

Russian infantry continued to attack with undiminished vigor and with heavy artillery and tank support, but no where were the Finnish lines broken, declared the high command.

Tonight's communique reported destruction yesterday of 32 enemy tanks, making a total of 72 destroyed or captured in two days. It also reported four Russian planes shot down.

Although the heaviest assaults on the Karelian isthmus, where the Red army has made its main efforts to break through, the Finns reported that the Russians lost 800 men killed northeast of Lake Ladoga, sight of another long-continued battle.

Artillery shells and hand grenades replaced bombs in Russian warplane attacks and Finns fought with bayonets instead of bullets as heavy fighting apparently depleted supplies of both nations.

Pierce fighting was reported on the Karelian isthmus, where wave after wave of Russians advanced on Finnish posts, but were reported repulsed in savage bayonet and hand grenade encounters with the Finns.

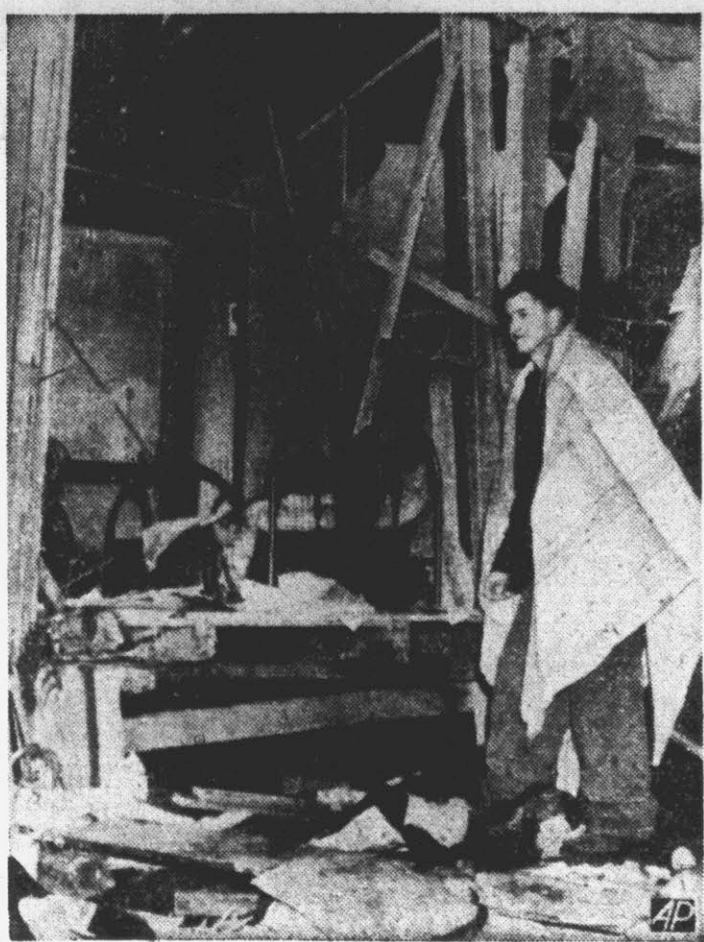
Craven Citizen Dies After Brief Illness

France Asserts German Peril Must Be Crushed

PELLEY WOULD JAIL LEADERS

Favors Life Imprisonment for 2 Solons And CIO Head

Washington, Feb. 10.—(AP)—William Dudley Pelley, head of the Silver Shirt Legion, testified today that he favored life imprisonment for Senator Robert M. LaFollette, Wisconsin progressive, John L. Lewis, CIO head, and Rep. Samuel Dickstein, New York Democrat.

Pelley told the House committee investigating un-American activities that he had advocated this action while being questioned by Rep. Voorhis (D-Calif.), committee member.

The line of questioning brought a clap of gavel pounding from Rep. Starnes (D-Okla.), acting chairman, who said he was not going to let the committee serve as a "sounding board" for loose charges against leading Americans.

District Attorney David Pine of the District of Columbia, issued a fugitive warrant for Pelley today at the request of North Carolina authorities. Pelley, whose Silver Shirt headquarters is at Asheville, is wanted in North Carolina for violation of a suspended sentence.

Voorhis questioned Pelley about some of his writings, including an article advocating that LaFollette, Lewis and Dickstein be tried by a jury of "Silver Shirt" members and given life imprisonment.

"I consider that these gentlemen have engaged in communist activity," Pelley declared, while Starnes pounded away with his gavel.

Voorhis, smiling asked Pelley if there were others in this class, including members of the committee. Pelley answered that he had already expressed his "affection" for the House committee. This aroused Starnes' ire again. The acting chairman said the committee was not interested in the affections of any witness.

Statement Made in Reply to U. S. Secretary of State

Paris, Feb. 10.—(AP)—France warned today that the "constant peril" of Germany must be crushed before she can join any international economic system, such as Secretary Hull mentioned in a statement yesterday.

A semi-official note said United States Undersecretary of State Sumner Welles, who was welcomed on his mission to seek information in European capitals.

But it commented more coolly on the State Department's announcement of diplomatic conversations with neutrals, "relating to a sound economic system and at the same time a world-wide reduction of armaments."

England and France are now seeking by victory of their arms to obtain "material and positive guarantees" of peace without which no stable organization of international relations could be established either in the political or economic field, the French note said.

Students in Fight Against NYA Cuts

Chapel Hill, Feb. 10.—Resolutions and petitions signed by over a thousand University students were on their way to Washington today after a mass meeting protesting against the proposed one-third cut in NYA appropriations for student aid now pending in Congress.

The bill if passed would cut out jobs or work scholarships for 41,000 college and 119,000 high school students, it was brought out at the meeting, and a large percentage of these must have aid to stay in school. Carolina has 32 students on NYA jobs, but the passage of the proposed bill would lessen this number by about 100.

President Frank P. Graham and Dean R. B. House joined with Phil Ellis, Lee Wiggins and other student leaders in speaking against the cut and urging that the NYA program be continued as in the past.

Local Home Entered While Family Away

The home of J. R. Hodges at 305 Elizabeth street, vacant since before Christmas, was the victim of a robbery some time within the past month or two, it was revealed at police headquarters today.

Expecting the family home from burley tobacco markets within a few days, the cook went to the house yesterday, found the back door unlocked and some canned goods and four hams missing.

Police found that clothes had been moved about, but the cook was unable to say whether or not any were missing. The full extent of the robbery will have to await the return of Mr. Hodges.

HULL LOOKS TO PERIOD AFTER END OF STRIFE

Post-War Economic Sanity is Being Emphasized

GIVEN AS AIM OF DISCUSSION

Declares Curtailment Of Armaments And Adoption of Sound Commercial Policies Essential

Washington, Feb. 10.—(AP)—Peace and economic sanity in the post-war period were emphasized by Secretary Hull today as the objectives of discussions now under way between the United States and other neutral nations and of the assignments on which Under-Secretary Welles will visit Rome, Berlin, Paris and London.

Hull said that for some time the United States had been doing everything possible to keep alive basic ideas, formulas and programs relating to a sound and stable period of international relations after the European war is ended.

They keystones of that policy, he explained, are:

1.—The halting and curtailment of armaments.

2.—The adoption by all nations of sound and liberal commercial policies.

It is necessary for the world to achieve those objectives, Hull declared, if there is to be economic sanity in the post-war period rather than economic autarchy and totalitarianism.

When peace does come, Hull declared, it is hoped that there will be very definite understandings—and even commitments—the basic principles vitally necessary for a peaceful world.

Maritime Union Charges City Of Flint Captain With Neglect Of Duty

Master of American Vessel on Recent adventurous Voyage

Accused of Disregarding Safety of His Men, Principally by Declining to Get His Crew Out of Hands of German Prize Crew

New York, Feb. 10.—(AP)—The National Maritime Union (CIO) announced today it had filed charges of neglect of duty against Captain Joseph A. Gainard, master of the City of Flint, accusing him of disregarding the safety of his men during the vessel's recent adventures at the hands of a German prize crew.

The union said the charges were filed by its attorney with Commander R. S. Field, director of marine inspection and navigation, in Washington, asking that Captain Gainard's license be revoked.

Filed with the charges, the union said, were two affidavits by members of the crew.

The complaint charged principally that Gainard had several opportunities to get his crew out of the hands of the German crew and to get in touch with American authorities, but had refused.

Captain Gainard said he was denied permission to communicate with American officials.

He even threatened to put his crew in irons, the complaint said, when its spokesmen asked permission for the crew to go ashore at Tromsø, Norway, and get in touch with the American minister to Norway.

Confesses Murder Of "Best Friend"

Raleigh, Feb. 10.—(AP)—Frederick L. Handy, director of the state Bureau of Investigation, announced today George Mills, 32, of Hampstead, Pender county, had confessed that he killed and robbed "his best friend" and neighbor, William Hudson, 65, last Sunday.

The director said Mills told SBI men and local officers he shot Hudson, struck him with an axe and took \$10 or \$11 from his pockets while they were on a wood-cutting expedition in the forest near their homes. Mills said he had been drinking. Handy reported.

The director said two Negroes, Vance Townsend and Richard Hancley, were implicated in the confession as accessories after the crime.

Admits Patrolman "Quit" Under Fire

Raleigh, Feb. 10.—(AP)—W. J. Spain, assistant commissioner of revenue, said today the recent resignation of State Highway Patrolman J. L. Hunter of Smithfield, followed a hearing on charges of "irregularities in the collection of arrest fees."

Spain said he and R. R. McLaughlin, director of the motor vehicle bureau, conducted the hearing about 10 days ago and "the hearing left enough questions in our own minds concerning the matter that the patrolman was requested by Major J. B. Armstrong to resign."

Lieut. Arthur T. Moore of Fayetteville and Sergeant V. R. Mallard conducted an investigation. McLaughlin said, "after rumors began in Smithfield."

SOVIET RUSSIA CONDEMNED AS DICTATORSHIP

Roosevelt Speaks Out Against Finland Invasion

SPEAKS BEFORE YOUTH CONGRESS

Declares that Soviet Union Dictatorship Is as Absolute as any Other in the World

Washington, Feb. 10.—(AP)—President Roosevelt today declared Soviet Russia to be a "dictatorship as absolute as any other dictatorship in the world" and characterized its war with Finland as an invasion of a neighbor "so infinitesimally small that it could do no injury to the Soviet Union."

Mr. Roosevelt stated his views in a speech to the American Youth Congress meeting, in which he upheld the rights of some of his hearers "to call yourselves communists," but added that "as Americans you have not only a right, but a sacred duty to confine your advocacy of changes in law to the methods prescribed by the Constitution of the United States."

He professed himself to be disillusioned with the Russian experiment in government, "although years ago I hoped that Russia would work out its own problem and that their government would eventually become a peace-loving popular government which would not interfere with the integrity of its neighbors."

"That hope," Mr. Roosevelt said, "is today either shattered or put away in storage against a better day."

"The Soviet Union as a matter of practical fact known to you and to all the world is a dictatorship as absolute as any other dictatorship in the world."

"It has allied itself with another dictatorship and it has invaded a neighbor so infinitesimally small that it could do no injury to the Soviet Union and seeks only to live at peace as a democracy and a liberal forward-looking democracy at that."

Horton Speaks To Farmville Group

In an address which he delivered before the Benjamin May Chapter, Daughters of the American Revolution, at a meeting in Farmville to P. Horton of Pittsboro, a candidate for the Democratic nomination for Governor, made a vigorous plea for "ambitious national defense."

As a part of his national defense program, Mr. Horton advocated "adequate measures of national defense inclusive of one of the strongest navies in the world, an army commensurate with our needs, a great system in the sphere of aeronautics as related to our military establishment and all other military agencies necessary in the prosecution of such a defensive and protective program."

At the same time the speaker, who was accompanied by Mrs. Horton, lauded the Daughters of the American Revolution for their long sustained interest and devotion to patriotic concepts, especially in the field of enlightened and ennobling citizenship.

She is survived by her husband, J. A. Stanley; two sons, H. A. Parvin of Suffolk, Va., and Carl N. Stanley of Norfolk, Va.; three daughters, Mrs. T. H. Worthington of Wilmington, N. 15 Persons Killed With Many More In Hospital

Rain Following Wind Prevents Fires But Handicaps Rescue Work; Streets littered with Debris; Power and Communication Lines Down; Nearly Every Building on Main Street Damaged

Albany, Ga., Feb. 10.—(AP)—Between 12 and 15 persons were killed and several hundred injured by a tornado which smashed the business section of this southwest Georgia city today.

Two companies of National Guardsmen were ordered to the city by Gov. E. D. Rivers. Heavy rain followed the winds, preventing fires, but rendering rescue work difficult.

Debris littered the streets of the city. Communication and power lines were smashed, trees were leveled, buildings unroofed and windows smashed.

W. M. Pryse, managing editor of the Albany Herald, reported a foot square piece of paving was blown through an upstairs window of his home.

From Washington came word that the Red Cross was sending disaster relief workers into Albany.

Ambulance drivers were ordered to pick up only the injured, leaving the dead for later.

Roaring out of the southwest, the tornado ripped through scores of Negro shanties, smashed railroad properties around the station and unroofed the depot and crushed the walls of nearly every business building along the main streets.

Pryse said injured were being poured into the hospital at Albany so fast "they had to lay them out on the floors and try to get to the most urgent cases first."

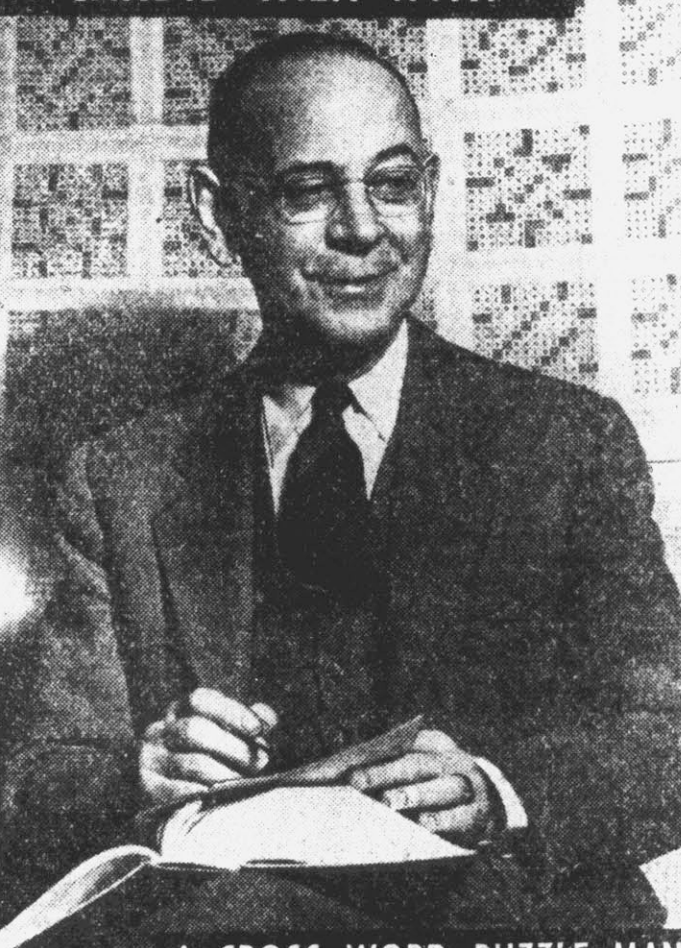

WHO HE IS
GENIAL, professorial J. Van Cleft Cooper is a crossword-puzzle builder who daily puts hundreds of thousands of newspaper readers through their mental calisthenics. He was proclaimed "Crossword Puzzle Champion" in 1928 after a New York contest. At that time his average time for solving a puzzle was six minutes. Today he blushes if he takes five. A New York paper used to clock Mr. Cooper as he solved advance proofs of his puzzles. His time was printed as "The Bogey Time." The son of a minister, he was for years organizer for a Broadway theater; he still serves as organizer in his home-town church in Mt. Vernon, N. Y. He began building puzzles for The AP Feature Service in 1929. Now he's nearing his 6,000th puzzle.

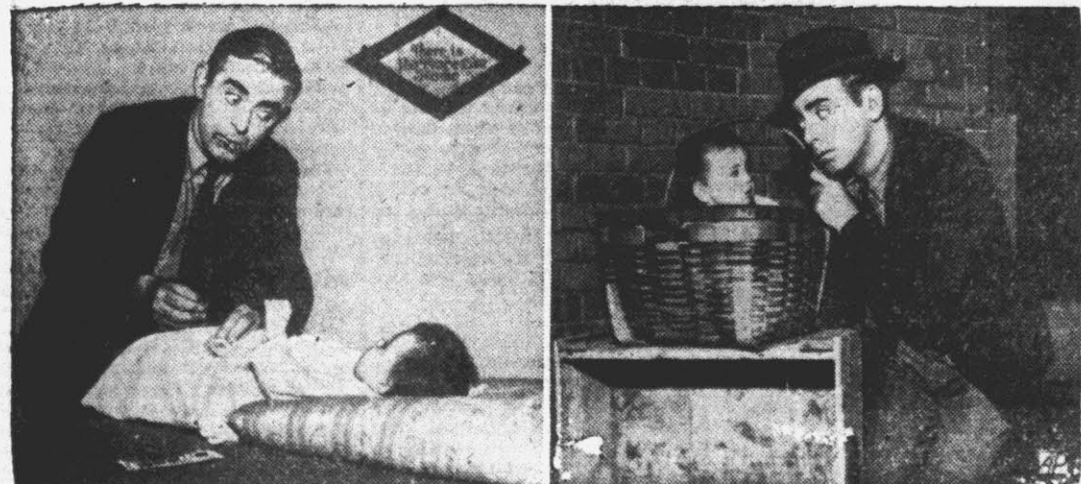

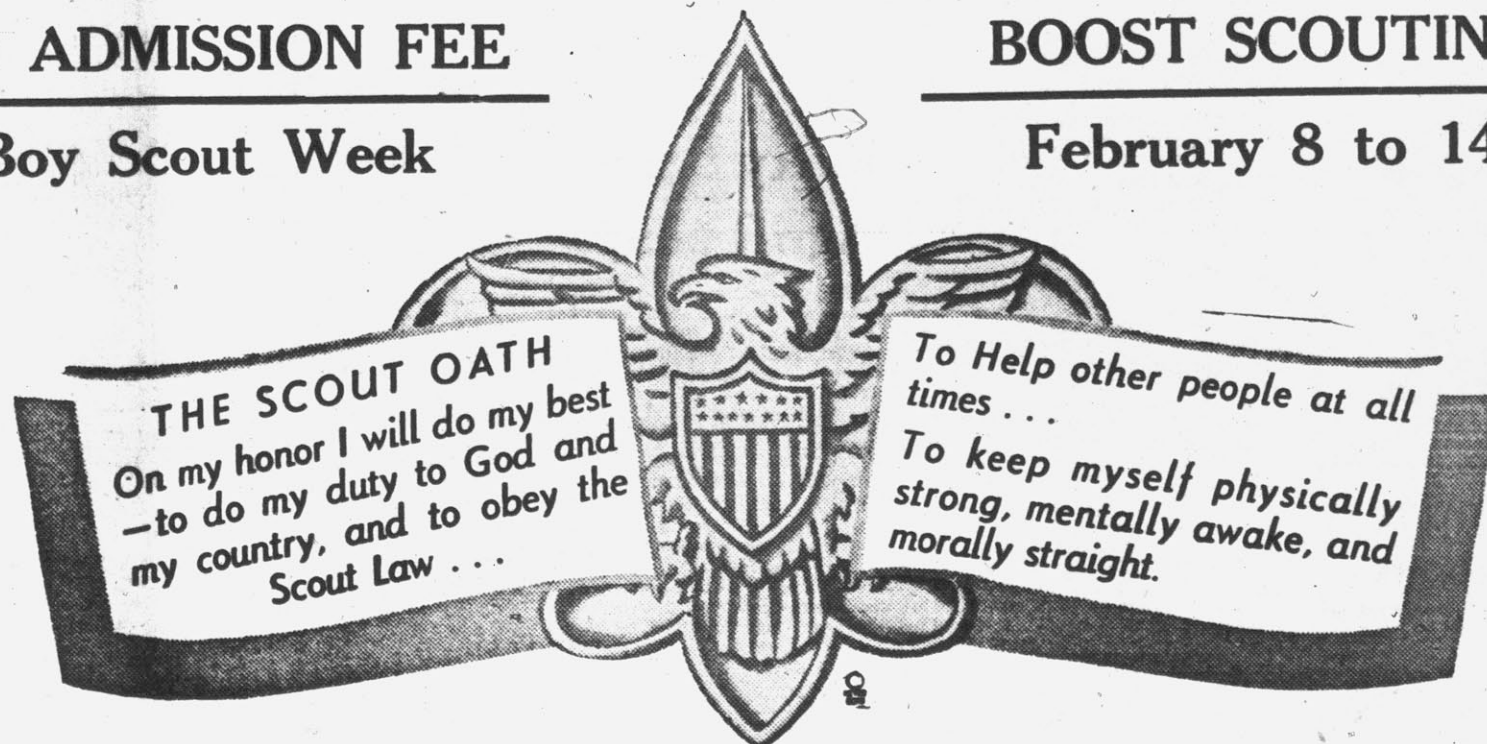

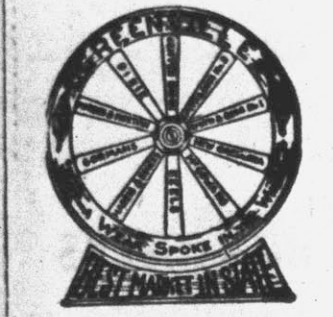

Mary Ann gasped, and when I looked at her her eyes were frightened.

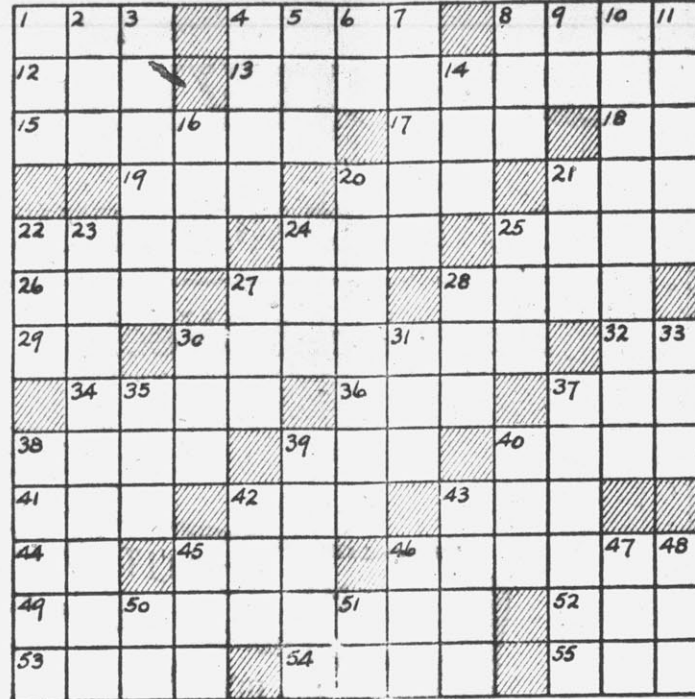

FEW CASES UP IN HIGH COURT

Next Week's Calendar is Short, But Interesting

Reflector Bureau. By HENRY AVERILL. Raleigh, Feb. 10.—Next week's calendar for the Supreme court is comparatively short, but on it are at least four cases of more than ordinary public interest.

The docket lists 13 civil and one criminal appeal on the regular calendar, with two cases, combined into one for purposes of argument. Regular cases are from the Second and Nineteenth judicial districts, with those from the Second to be called on Tuesday.

The one criminal case will be the first involving a "legalized guild" to make its appearance since the court so brusquely declared the Dry Cleaners Commission act unconstitutional. The important civil appeals involve two perennial causes of controversy—private power utilities versus publicly owned plants and the right of an overwhelmingly Democratic legislature to force Democratic rule on an overwhelmingly Republican county.

The "guild" case is from Asheville where F. C. Mitchell was convicted of violating the plumbing contractors act by working as a journeyman plumber without having a license from the state board of plumbing examiners. In his appeal he argues strongly that the whole act is unconstitutional. Brief was written before decision of the Dry Cleaners case, else it is certain that Judge A. A. F. Seawell's recent decision would be cited as an authority.

There may be technical differences which will change the result, but in the face of the Dry Cleaners case it looks as though the plumbers commission may well be "given the works" by the court.

The private against public power cases are the two voluminous High Point actions in which there is really involved only one simple question—has the city the right to erect its own power plant on the Yadkin river in territory outside the city limits and even outside the county in which it is located?

One of the suits was brought against High Point by the county of Yadkin, the other by certain High Point citizens. Behind both, however, as the real adversary of the power project is the Duke Power Company. The State of North Carolina has intervened, purportedly only as to the question of navigability of the Yadkin river.

All of which makes the State, the Duke Company, Yadkin county, and a group of influential industrialists lined up on one side and the city on the other. In the lower court the combine won, and High Point has been restrained from building its power plant with the aid of PWA grant and loan.

There are two political controversies up from Madison county, where the local Democrats, much in the minority, are always seeking to get control of the county offices (and the pay and emoluments thereof) through legislative fiat. Every legislature sees new efforts of the Democrats to harass the majority party in Madison and to "starve" the county into going Democratic in self defense.

The Madison Republicans are a fighting lot, however, and so far have refused to concede anything. This time there are involved the posts of county physician and tax manager. Local laws of the legislature have set up methods of naming these officials which makes it certain Democrats will get the places. The county commissioners (Republicans) have defied the local laws and proceeded to name officers of their own selection (Republicans, of course). They contend that the local laws are unconstitutional and void.

In the two appeals now up the Superior court judge (Democrats) has sustained the local legislation. The Republican commissioners will fight it out before seven Supreme court justices (all Democrats.)

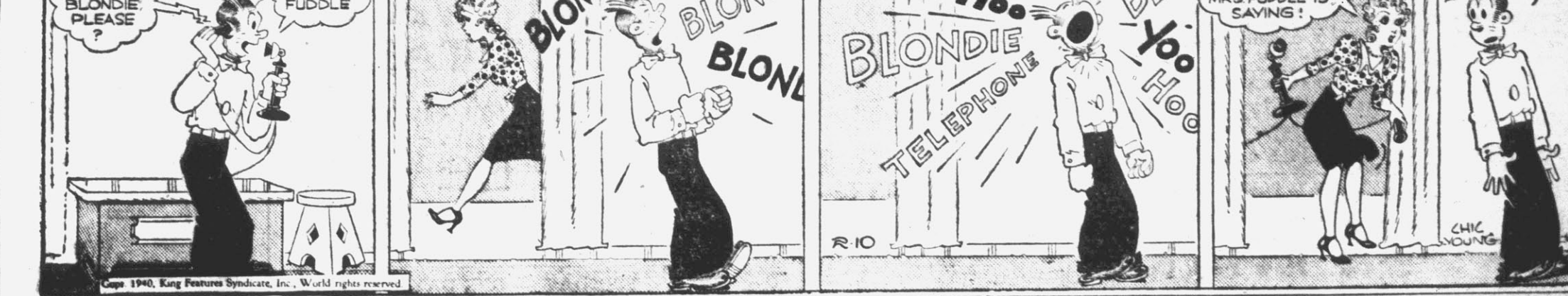

rapidly clearing the world trade routes of the picturesque tankers, freighters, and other cargo boats. Most able economists agreed that the choking off of foreign commerce was a prime cause of joblessness, hunger, and suffering in all nations.

The importance of world trade has never been fully realized by most people. Foreign commerce is the keystone of world prosperity and peace. Our overseas markets in good times absorbed only 10 per cent of our total output; but that 10 per cent was a vital 10 per cent. Half of our cotton crop, for instance, was sold abroad. Think of the importance of cotton to United States prosperity. Southern banks, land values, jobs, wages, warehouses, railroads, shippers, are all tied up with the price of cotton. And the price of cotton depends on our foreign markets.

Tough Assignment
It seems impossible, however, to get the importance of foreign trade across to the public. The high-tariff opposition has a far easier job. Inevitably, in any tariff-lowering program, some localities or some producers feel they will be hurt. They protest violently to their Congressmen. Therefore it is almost impossible to wrangle any real tariff reductions through Congress. Secretary Hull (a former senator) knew that the only way to lower tariffs and increase employment as a whole would be a reduction program which exposed constituent-conscious Congressmen from voting to ratify it. Hence, the State department's trade program came into being.

Over twenty reciprocal trade agreements have been negotiated since 1934. Secretary Hull and his experts have done a painstaking, conscientious job. They have started to do the job which practical, God-fearing people admit must be done—a slow and gradual, rather than a sharp and sudden, decrease of tariff walls. They have held hundreds of hearings, have listened patiently to thousands of protests. For every concession they have made to foreign nations they have wrung from them an equally good one for Uncle Sam. Moreover, due to the so-called "most favored nation rule" the pacts have lowered tariffs, helped business, given jobs all over the world.

Bright Spot of New Deal
The reciprocal trade program has been a truly bright spot of the New Deal. In his quiet, but firm, way, Secretary Hull has fought harder for peace in this decade than any other man alive. He is a tower of strength, vision, and unselfishness. His program has increased our exports to countries with whom we have completed agreements by 60 per cent; while our exports to those countries with which we have not bargained have expanded less than 40 per cent. Moreover, our imports from treaty nations have not increased any faster than with non-treaty nations. This, in a nutshell, tells the effectiveness of the program, its aid to jobs and industry.

America, however, is a high-price, high-wage, high-tax nation. Needless to say, high tariff people do not like Secretary Hull's program. "Buy America" has plenty of political "oomph." The G. O. P. needs campaign ammunition and they will make the most of decrying these trade pacts. They claim, for instance, that the program permits an excessive influx of farm products—\$8,000,000,000 worth in 1939. But Secretary Hull points out that \$530,000,000 of this was corn, rubber, silk, cocoa, bananas, which have always been admitted duty free!

Impregnable Position
The State department is prepared to defend its policies at all costs. The Republican heavy artillery is laying down the battle's opening barrage. What the outcome will be, no one knows. The New Deal's record is full of broken promises and failures. For this reason, it seems like mighty poor strategy for the Republican shock troops to assault the one position on which the New Deal is economically impregnable—its foreign trade policy! As a statistician, I believe that the Hull trade pacts should be backed to the limit by every straight-thinking, unselfish, and honest American!

Senate Reapportionment Where Real Trouble Lies

Raleigh, Feb. 10.—Chief howl of the Piedmont and some parts of the west about failure of North Carolina's General Assembly (five of them in a row) to follow the "Constitution's mandate" by reapportionment of legislative seats has been directed at the House of Representatives.

It is much more frequently heard that "Guilford would have four or five seats in the House," or that "Nash and New Hanover would each lose a seat in the House" than that such a county would get more Senate representation. Truth of the matter is that reapportionment of seats in the legislature is a combination of both Senate and House readjustments. This correspondent pointed out some weeks ago that the matter is not nearly as simple as it seems on the surface. It's the Senate reapportionment, not that of the House that brings up all the row; because the Constitution lays down a fixed and undeviating mathematical formula (complicated, it's true but still easily applied with the exercise of moderate brains.)

There are those who contend, and have been contending for a long time, that there should have been a reapportionment of the House by this formula method even though there were no Senate readjustment, but when the Constitution itself is inspected, it seems that the two reapportionments are almost inseparable, and that there is less authority for making a House reapportionment alone than there perhaps would be for a Senate shakeup without a corresponding House change.

Very few people know what the Constitution does say about the subject. The provisions are all contained in Sections 4, 5 and 6 of Article II.

Here are the three pertinent sections:

Sec. 4.—The Senate districts shall be so altered by the General Assembly, at the first session after the return of every enumeration by order of Congress, that each Senate district shall contain, as near as may be, an equal number of inhabitants, excluding aliens and Indians not taxed, and shall remain unaltered until the return of another

enumeration; and shall at all times consist of contiguous territory; and no county shall be divided in the formation of a Senate district, unless such county shall be entitled to two or more Senators.

Sec. 5.—The House of Representatives shall be composed of one hundred and twenty representatives, biennially chosen by ballot, to be elected by the counties, respectively, according to population, and each county shall have at least one representative in the House of Representatives, although it may not contain the requisite ratio of representation; and this apportionment shall be made by the General Assembly at the respective times and periods when the districts of the senate as hereinbefore directed to be laid off.

Sec. 6.—In making the apportionment of the House of Representatives the ratio of representation shall be ascertained by dividing the amount of the population of the State, exclusive of that not comprehended within those counties which do not severally contain the one-hundred and twentieth part of the population of the State, by the number of representatives, less the number assigned to such counties; and in ascertaining the number of the population of the State aliens and Indians not taxed shall not be included. To each county containing the said ratio and not twice the said ratio, there shall be assigned one representative; to each county containing two but not three times the said ratio there shall be assigned two representatives and so on progressively and then the remaining representatives shall be assigned severally to the counties having the largest fractions.

Beer Consumption Increases In N. C.

Raleigh, Feb. 10.—North Carolina consumed 301,000 barrels of beer and ale during 1939 as compared with 264,025 barrels in 1938. There are 31 gallons to a barrel.

Despite the 12 per cent increase in consumption, North Carolina still lags in consumption as compared with other states, according to the Brewers and North Carolina Beer Distributors Committee. The per capita consumption in this state is not quite three gallons, while the nation's per capita consumption is twelve and a half gallons—more than four times the per capita consumption in North Carolina.

Although North Carolina is way down the list on the basis of per capita consumption, the beer industry pays the state and its various political subdivisions almost \$1,500,000 annually in taxes and license fees. If this state consumed as much as the average for the nation, more than \$6,000,000 would be paid into the state treasury annually.
