FINNS HOLDING RED FORCES AT VIIPURI GATES

High Command Announces Soviet Assault Repulsed

RUSSIANS DRIVE ON THREE SIDES

Heavy Fighting Also Reported In Arctic Region Near Petsamo and Lake Ladoga Area

Helsinki, March 4.—(AP)—The Finnish high command announced today that its forces fighting invading Russians almost at the gates of Viipuri had repelled attacks aimed at the city from three sides.

In addition, the Finns reported fighting in the Arctic region far to the north near Petsamo and north-east of Lake Ladoga, where they said 1200 Russians were killed.

The attacks against Viipuri were beaten back yesterday according to the daily army communique as the Russians attempted to advance across the ice of the Bay of Viipuri at a second point between the bay and the Vuoksi river and at a third point near Avtrapa, a few miles farther to the northeast.

Sources close to Adolf Hitler believed he told Undersecretary of State Sumner Welles that Germany would fight until Britain and France recognize a "German Monroe Doctrine for Central Europe" and restore her lost colonies. Hitler's price for peace, according to this version includes permanent German political domination over Bohemia-Moravia, Slovakia and Hungary—this territory is shown by diagonal lines. This plan also provides that England and France promise not to stir up the Balkans and the Baltic region and that the "stranglehold control" of the Suez canal cease.

FIRE DAMAGES PERKINS MILL

Blaze Keep Fire-fighters Busy For 24 Hours

A fire at the J. J. Perkins Manufacturing Co., Inc., makers of tobacco household material and located at the end of Eastern street, kept local firemen on the go from about 7:30 o'clock yesterday morning until 8 o'clock this morning.

The loss to the manufacturing company was said to have been about \$5,000. Smoke from the blaze invaded the ventilated tobacco storage across the railroad tracks, but J. S. Ficklen, head of the company owning the approximately half a million dollars worth of leaf, said the tobacco was damaged but very little.

The fire was declared by firemen to have started from a fire in a stove in the corner of the single building that was destroyed. "Bull" Garris was said to have been cooking breakfast in the stove and upon returning after leaving it for a few minutes found the building afire.

The building destroyed was filled with lumber, part finished and part rough. Although firemen kept steady streams of water pouring on the fire, they were unable to check it. After subduing the fire at any one particular place it would blaze up again almost the moment the firemen turned the hose elsewhere.

Several lumber-filled buildings were near the burning structure, but firemen kept the blaze confined to the single building.

A steady stream of spectators viewed the blaze during the day and night.

PENNSYLVANIA TOWN SINKING

Coal Mines Under Village Collapse After Rains

Shenandoah, Penn., March 4.—(AP)—Midway, Shenandoah sank slowly today, toppling homes and cracking business buildings as abandoned anthracite mine workings below the town collapsed after a 24-hour rain.

Residents, awakened by the rumbling that warned of the cave-in, fled from a 16-block area that settled slowly and steadily. Police Chief Frank All Alinsky said no one was reported killed or injured, but property damage was heavy.

By 8 a. m., seven hours after the subsidence first was detected, many buildings had settled 18 inches and widening cracks streaked across factories and bridge structures. Many homes were split in two. Gas and water mains were broken. Street pavement caved in.

Women sobbed hysterically among the hundreds of spectators who looked on from safe areas outside the section police roped off. Many saw their homes collapse.

TOTAL AMOUNT OF BUDGET CUT AGAIN BOOSTED

Reductions of \$293,000,000 Made So Far This Term

MAY TURN LOOSE WORKING CASH

Movement Started In Senate To Spend At Least Part of Treasury's Billion Dollar Fund

Washington, March 4.—(AP)—The House Appropriations committee raised the total of budget cuts made in Congress this year to \$293,000,000 today.

At the same time a movement developed in the Senate to spend part of the Treasury's \$1,000,000,000 working cash, which Treasury officials contend should be kept on hand for use in event of an emergency.

Both developments reflected the election year desire of members of Congress to avoid new taxes or an increase in the limit on the national debt.

In its latest whack at President Roosevelt's budget estimates, the House committee trimmed \$2,986,277 from the Interior Department bill of the funds refused, \$250,000 had been scheduled for the Byrd Antarctic expedition. In this connection, the committee said, it had been misinformed last year as to how much longer the expedition was going to be needing appropriations.

The Senate resounded to praise of accomplishments of the Roosevelt administration, which began seven years ago today.

Senator Barkley, the Democratic leader, said in an anniversary speech that the new deal had helped labor and business alike. He added:

"I have searched in vain among our critics—including presidential candidates whose common theme song is now the alleged failure of the new deal—to offer any constructive suggestions that contribute to a solution of the unemployment problem."

Italy Protests Against Britain's Blockade Of German Coal Shipments

Note Declares That Economic and Political Relations Of Two Countries Endangered; Protest Note Also Strikes at Contraband Generally and Interception of Mail

Rome, March 4.—(AP)—Italy, protesting against the British blockade of German coal shipments to Italy, has told Great Britain that "economic and political relations" of the Rome and London governments are endangered.

The note of protest, delivered yesterday to the British embassy, was published today.

The note went beyond a formal protest against the British Admiralty's orders to halt the coal shipments. It struck at contraband control generally and charged that interception of mail on the high seas was a flagrant violation of the Hague convention of 1907.

The submission of all maritime traffic of non-belligerent countries to contraband control, the note said, "is manifestly abusive."

In London foreign office circles indicated that Italy's protest would meet a cool British reception.

It was reported in authoritative quarters that "the most rapid and careful consideration" would be given the Italian note and that an effort would be made "to be as accommodating as possible."

At the same time, these sources said, it would be unwise to believe that Britain would retreat from her original position in view of "unrestricted warfare by Germany against the allies and neutrals."

Darden Warns Of Defective Fences

W. A. Darden, Jr., superintendent of distribution for the Greenville Water and Light Commission, discussing the recent death of a Wilson child who came in contact with an electric stock fence, declared that such fences put on the market by reputable firms are safe, but added that "bootleg" fences and the home-made variety were dangerous.

In fact, Mr. Darden declared there were two or more instances of dangerous fences in Pitt county and said that something should be done about it.

Mr. Darden declared that it also was important that such fences be correctly installed and properly used.

The local superintendent declared that Prof. David S. Deaver, head of the Department of Agricultural Engineering at N. C. State college was "exactly right" in saying that the low cost of the electric fences is carried too far by some farmers who think they can make such a fence serve their purposes without regard for the safety features which are found in products sold by reliable manufacturers.

Mr. Weaver declared that until some regulation is put into effect in North Carolina "we may expect to have from time to time re-occurrences of the Wilson county tragedy."

UPHOLDS RIGHT TO PROSECUTE MEDICAL BODY

Indictments Against AMA Upheld By Court

CASE INVOLVES ANTI-TRUST ACT

American Medical Association Charged With Restraint Of Trade In Opposing Health Groups

Washington, March 4.—(AP)—The United States court of appeals ruled today that the Justice Department could prosecute the American Medical Association on charges of violating the Sherman anti-trust act.

It sustained the validity of an indictment which charged that the AMA, two of its affiliates and 20 individual physicians had acted in restraint of trade by opposing activity of a group health association in Washington.

By this action the court reversed a decision of the district court which had upheld a demurrer in which the AMA pleaded that the practice of medicine was a "learned profession" rather than a trade and therefore not subject to prosecution. The case is therefore sent back to district court for trial.

The appellate court held that the practice of medicine fell within the scope of the Sherman anti-trust act.

Last October the Supreme court refused to pass on the case. The appellate court's decision opens the way for another opportunity for the Supreme court to review the litigation.

PROPOSE BILL LIMIT CENSUS

Proposal Would Eliminate Personal Income Question

Washington, March 4.—(AP)—Authoritative sources said today that a Senate Commerce subcommittee had approved a resolution recommending that questions regarding personal income be eliminated from the 1940 census.

The committee agreed that its action should be kept secret until tomorrow, but a reliable source told reporters that the resolution, by Senator Tobey (R-N.H.) had been approved by a vote of three to two.

Chairman Bailey (D-N.C.) of the subcommittee was said to have supported the resolution, but the other votes were not made public immediately.

It was reported the committee voted to keep its action secret because the Commerce Department had asked additional time to file a statement. It was added, however, that the subcommittee intended to take no further vote.

The resolution will be voted upon by the full commerce committee tomorrow, and, if approved, will go to the Senate floor. It merely would express "the sense of the Senate" that questions regarding personal income be stricken from the census.

It was reported the committee voted to keep its action secret because the Commerce Department had asked additional time to file a statement. It was added, however, that the subcommittee intended to take no further vote.

### SPOILING OUR RELIGION

Phillips Brooks in one of his sermons tells the story of certain savages who, having received the gift of a sun-dial, forthwith built a raft of over it that this sacred object might be protected from the elements. Without realizing it, of course, they rendered their gift worthless. In their desire to preserve its sacredness they failed to realize that it lost all value when they failed to use it.

Some people treat their religion the same way. They are willing to do everything about religion except use it. Religion is to be respected, praised, defended, but not used. It is something to be kept in the church, not taken into the world; to be talked about in very holy terms, but never made the theme of natural conversation; to be used on Sundays, but not the rest of the week. Like the savages who built a raft over their sun-dial, people who thus treat religion necessarily destroy it.

A religion that cannot be taken out into the world and used amid its daily problems is not a sacred reality; it is a flimsy and useless ornament. The religion that has to be kept in church and talked about in whispers is as useful to men seeking direction in life as is a sundial under a roof to men who want to know the time of day.

Despite the fact that firemen were called early yesterday morning and some of them were forced to remain on duty throughout the day and night at the fire at Perkins Manufacturing Company, somebody took it upon himself to turn in two false alarms, one about seven o'clock last night and the other at 11:30. In addition to the dangers surrounding the answering of fire alarms each and every alarm answered costs our city around fifty dollars and yet there are some persons who must think it fun to turn in a false fire alarm. The announcement that England and France will do the bulk of their tobacco buying from Turkey and Greece together with the announcement that "England will turn to Brazil for its cotton supply, offers little encouragement to southern growers who have been depending almost entirely on these two cash crops. As we see it there is little hope for our section to continue to tie its hope to tobacco and the quicker we realize it the better. The planting season is almost at hand and the wise

farmers will see to it that they give their first attention to the production of home supplies, and diversification of their farming program. The financial hope of the eastern North Carolina farmer lies not in tobacco but in a balanced farming program including dairying and livestock. There is no sense in our placing all our dependence in crops for which there is little or no demand and then sending money out of the state to purchase supplies that can and should be produced right here at home.

## Washington Daybook

Washington A core group of New Dealers looks Senator Taft as the man they will have to beat in November.

They haven't altogether liked Senator Taft since he was in the picture. As to the Michigan Senator, they doubt he has the ready pull in the stretches they credit to Taft. His radio voice has improved him, as they view it, not to the level of the Taft who won a series of radio debates from Representative V. V. Craig, sparking liberal.

As to Tom Dewey, of New York, they say that no glamour boy from New York can match the glamor of Roosevelt and that anything less would appear third grade to an electorate grown used to such fancy glamor as the Roosevelt brand.

**Quieter Country?**  
As a matter of fact, some of the New Dealers have begun to suspect that the country may be waiting for a bit of calm political weather. That is how come they write Taft into the picture. One of them analyzed him as "conservative, stumbling, hard working, friendly and perhaps a little bit dumb."

For a country striving for a quieter way of life than it has had in the past seven years, that combination, he said, might just fill the bill.

Incidentally, they haven't decided who from their own ranks will be the best man to stop Taft—except Roosevelt himself. They don't concede that Roosevelt is the only one who can stop him, or Vandenberg or Dewey, or Representative Martin or Frank Gannett, or anyone else for that matter. They are just speculating.

**Ship Mystery**  
We cannot pass without telling you about Lieutenant Commander N. W. Sharpe, the only survivor of the ill-fated cargo boat Cyclops which disappeared mysteriously during the World War with all on board.

Commander Sharpe, now in the press division at the Navy Department, explains it this way. He was on recruiting duty in St. Louis during the war when along came an order calling for a certain number of men to go to Norfolk, Va., for sea duty.

The commander lined them up one morning, marched down the ranks counting off the men in pairs and stopped at the next man to Sharpe.

"This detachment," he said, "will go to Norfolk."

John Harry Fox of St. Louis was the man next to Sharpe. Before he left for Norfolk he gave his dress jacket to Sharpe in return for a sea-jacket and a short overcoat. Fox was put on the Cyclops. Only the luck of the count saved Sharpe.

The Cyclops went down sometime between March 4 and April 15, 1919, in the West Indies. Not a trace of her has been found. Germany searched her own records after the war, found no submarine in the vicinity at the time, so couldn't claim credit for the sinking.

Navy men speculate that the Cyclops' shippy cargo of manganese may have shifted and flipped her bottom up before she could put out a call.

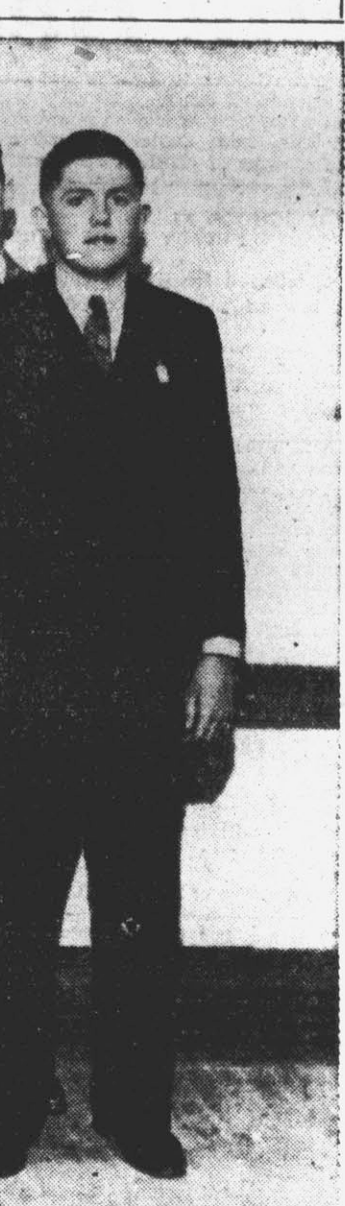

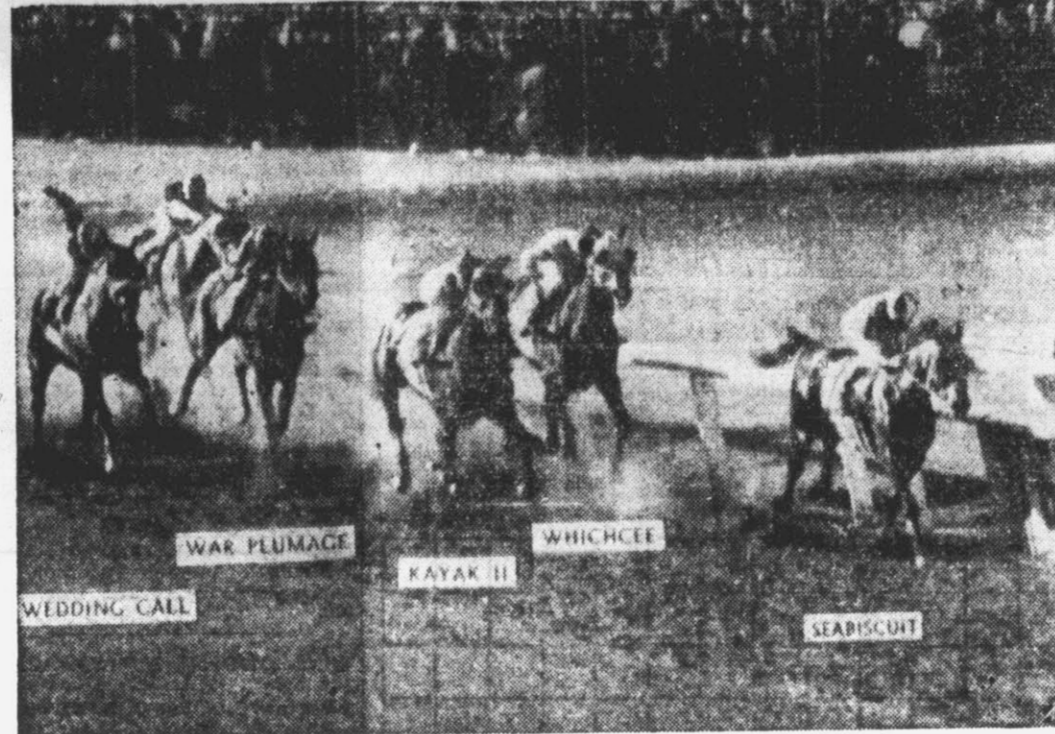

Radio Inventor To Be Honored  
Bologna, Italy.—(AP)—A monumental tomb memorializing Guglielmo Marconi is to be erected on the grounds of the family villa Pontecchio, near Bologna, where the inventor carried out his first experiments in wireless telegraphy. A wide open space surrounded with cypress and fir will be laid out on the sloping ground below the villa. Plans call for an open crypt in the center containing the sarcophagus where the remains of Marconi will have their final resting place. A bust of the scientist will stand on a low column in front of the colonnaded entrance to the villa. The monument is scheduled for completion by July 20, 1940, the second anniversary of Marconi's death. The Marconi villa will become a museum for relics of Marconi's studies and researches.

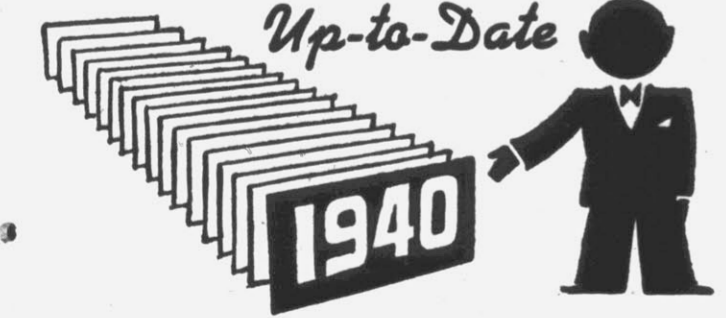

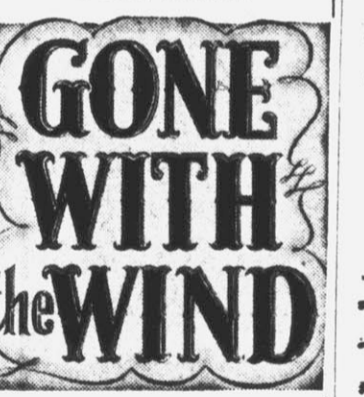
Seek Changes For Farm Loan System
