U. S. OFFICIAL SLAIN BY NAZI BOMB IN NORWAY

SWEDEN FILES PROTEST WITH NAZI OFFICIALS

Objects To Incursions By Warplanes Over Nation

FIERCE CLASHES NEAR FRONTIERS

With Battle Zone Next Door Steadily Expanding, Sweden Busy with War Preparations

Stockholm, April 22.—(AP)—Sweden protested strongly to Berlin today against incursions by Nazi warplanes over her territory and asked measures to prevent repetition of flights which "yesterday were especially numerous and grave."

Faced with a steadily expanding battle zone next door in Norway, Sweden already has taken sweeping precautions to prevent the conflict from infringing on her neutrality.

Fast moving columns of British and French troops, striking swiftly inland from debarkation points on Norway's coast, were reported engaged in a series of fierce clashes with German forces on the Trondheim and Oslo fronts.

The conflict in Norway was shaping into a full-fledged war in modern style, with perhaps 100,000 men in the field, British, French, Norwegian and German, some moving behind tanks and others attacking under cover of artillery and aerial bombardment.

Spurred by fear of further widening of the struggle, Sweden achieved peak preparedness short of general mobilization.

Swedes were worried by the incursions of German planes. Extraordinary air defense precautions were taken.

Focal points of the fighting apparently were Verdal, 35 miles north of Trondheim, and Elverum, 60 miles north of Oslo near the Swedish frontier.

Approximately 300 miles of rough terrain separates the two battlefronts.

Pitt Negro Absolved In Highway Fatality

Joe W. Mayo, Pitt county Negro, whose automobile struck and killed Elbert Bradley, eight-year-old Negro boy about three miles from Greenville on the Belvoir highway Friday, was exonerated of blame at a coroner's inquest this morning.

It developed at the inquest that the Negro boy started to run across the highway directly in front of Mayo's automobile and the driver could not avoid striking the child.

IN RAEFORD COURT

Judge Albion Dunn left this afternoon for Raeford where he will appear in court tomorrow as defense counsel for Jacob C. Williams, of this city, who will be tried on a manslaughter charge growing out of a recent highway accident near that city.

Leaving Hungary

Budapest, April 22.—(AP)—The United States legation today advised American citizens in Hungary to "decide as to the advisability of leaving for the United States while there still are means of a egress available."

The legation notice said American citizen should "consider the effect" which extension of the war to this part of Europe "would have upon the possibility of travel."

A prefatory declaration said the legation "has no information which would lead it to believe that the war will be extended to southern Europe."

There are about 400 American citizens in Hungary, but the legation said that most of them were Hungarians or persons who went to the United States were naturalized and then returned to this country to live.

STAGE SET FOR RALLY TONIGHT

Sen. Josh Lee of Oklahoma to Address Democrats

The stage was all set this afternoon for the District YDC rally to be held in the Armory building here tonight and plates will be set for 350 persons.

In addition to a large number of Pitt county Democrats, candidates and others from other sections of the state began to converge on the city this afternoon for the affair. An unusually large delegation was due from Raleigh.

The program is scheduled to get underway at 7:30. A delegation from here was scheduled to leave at 5:30 o'clock for Rocky Mount to meet Senator Josh Lee of Oklahoma, who will deliver the principal address of the meeting. The delegation will be accompanied by an escort from the State Highway patrol and the speaker will be hurried back here in time to get his dinner and begin speaking about 8:15 or 8:30 o'clock.

Sponsors declared today that the ticket sale had been gratifying. Following his address, a delegation will return Senator Lee to Rocky Mount, where he will enroute for the return trip to Washington. Those in charge of the rally have declared themselves fortunate in securing the senator for the address and are expecting many Democrats in this section to avail themselves of the opportunity of hearing the Oklahomaan, regarded as one of the most outstanding speakers and dominant figures in the United States Senate.

The speaker will be introduced by Hoover Taft, state YDC organizer. The program is expected to be completed within an hour or so after the dinner.

J. D. Simpson Files From Third Ward

J. D. Simpson, Railway Express agent here for a number of years, today announced his candidacy for the Board of Aldermen from the Third Ward.

Mr. Simpson reported he had decided to seek the position after he had been advised that J. M. Taft, present member from the district, had decided not to seek re-election.

Mr. Simpson served on the board in 1938-39.

The election is May 6. In addition to the post being sought by Mr. Simpson, terms of two other members of the board expire this year. They are J. A. Watson from the Second and Dr. M. B. Massey from the Fourth.

Air Force Concentrating on German Bases In Norway And Sweden In Attempt To Halt Transport Of Nazi Troops By Air; New Signs Of Impending Show-down Battles

London, April 22.—(AP)—The British Air Force is synchronizing raids on German bases in Norway and Denmark, attempting to choke off the Nazi air ferry service which poured German troops into the invaded North country.

Air ministry announcements said today that both Aalborg in northern Denmark, and Stavanger, southern Norwegian port, had been raided during the night by British bombers repeating attacks which on the previous night also included Kristiansand, another southern port.

The Stavanger airbase was "bombed and machine-gunned," destroying "a number of enemy aircraft," the ministry said. The Aalborg airbase, which British believe is Germany's only large field in Denmark, was said to have suffered "extensive damage by high explosives and incendiary bombs."

Britain reported that all raiders returned safely from the Stavanger attack and only one was missing after the Aalborg attack.

A well informed source said that British and Norwegian troops had joined "at several places" and that joint action in eastern Norway had been "extremely successful."

Strong allied forces were deployed along potential battle lines spotting Norway's snow-packed mountains and valleys and signs pointed toward impending show-down battles with the Germans.

"The Norwegians rally well," this source said, "getting more and more arms and the morale of officers and men is very high."

Superior Session Is In Second Week

Judge J. Will Pless, Jr., of Marion opened the second of a two weeks' term of Superior court here this morning and by mid-afternoon several cases, three of them involving liquor charges, had been removed from the docket.

Jack Atkinson, Negro, was acquitted in one of the liquor cases. The jury was given the case before the luncheon recess and shortly after court reconvened brought in the verdict of acquittal.

E. Porter, white man, pleaded guilty to giving a worthless check and was given a 60-day sentence, suspended upon payment of a \$10 fine, court costs and the amount of the check, \$14.50.

Arthur Sparkman, Negro, was given 60 days on a driving drunk charge after he announced that he was unable to pay a minimum fine and costs of court.

Two defendants charged in separate cases with illegal possession of whiskey were acquitted on directed verdicts from the bench. They were Clara Little and Andrew Bell, both Negroes. The directed verdicts came after the State had concluded its evidence.

Ellis Edward Peterson, Negro, pleaded guilty to carrying a concealed weapon and was given a 60-day sentence, suspended upon payment of a \$50 fine and court costs and upon further condition that the defendant show good behavior and not carry any concealed weapons for two years.

Judge Walter Bone of Nashville, who presided over last week's session of court, originally was scheduled to preside this week, but exchanged with Judge Q. K. Nimocks of Fayetteville, who in turn traded with Judge Pless.

Young Boy Is Blamed For Fire This P. M.

Damage estimated at between \$400 and \$500 was caused by fire at the garage and storage room at the residence of Bernice Allen on the corner of Myrtle and Paris avenues this afternoon.

Chief George Gardner said that he was advised that a small boy returning from school set the building on fire, apparently unintentionally, while striking matches.

The building and some furniture stored in it were destroyed by the blaze.

SENATE GROUP AIRS CHARGES AIMED AT WPA

Accusations Discussed Before Agency Chieftains

COST OF TRAVEL AMONG CHARGES

Navy Officials Meanwhile Continue To Seek Approval For Expansion Of Program

Washington, April 22.—(AP)—In secret session, the House sub-committee handling the \$975,000,000 WPA appropriations bill discussed today charges that some of the money previously given the relief agency had been mis-handled.

The charges, contained in a report by J. O'Connor Roberts, committee counsel, have not been made public, but Chairman Woodrum (D-Va.) said that in general they alleged excessive travel expenses and administrative costs. WPA work done on private property and improper certification of persons for WPA work.

The WPA officials appearing were Commissioner F. C. Harrington and Col. Brehon Somervell, administrator in New York City.

Woodrum predicted that the appropriations bill would not reach the House for three weeks more. Hearings will require at least two weeks more, he said, adding that a third week would be needed to prepare final drafts.

President Roosevelt has urged congressional leaders to push the measure to enactment as an aid to early adjournment. Leaders have tentatively set June 10 as the adjournment goal.

The navy's efforts to obtain congressional approval for expansion continued before the Senate Naval committee, where Rear Admiral Joseph K. Taussig declared that the trend of developments in the Far East might eventually force the United States into war against Japan.

Taussig, former assistant chief of naval operations, asserted that he was expressing only his own viewpoint.

Grimes'd Woman Declared Suicide

A coroner's jury yesterday afternoon held that Mrs. Edna Earle Heath, 21, of Grimesland came to her death from self-inflicted shotgun wounds.

The verdict exonerated Mrs. Heath's husband, Wardell Heath, who had been jailed shortly after the shooting.

The coroner's jury found that Mrs. Heath shot herself just under the right breast by placing the stock of the weapon against the side of an outhouse, where the shooting occurred, placing the muzzle against her body and pulling the trigger.

Her husband was taken in custody and brought to the city jail here after the shotgun had been found under the house under the bed. It was brought out at the inquest that the couple's small boy dragged the weapon into the house.

Funeral services were conducted at the home of Mrs. Heath's father-in-law, Sam Heath of Grimesland, at 3 o'clock this afternoon by Rev. W. A. Crow, Methodist minister of Grimesland. Burial was in Greenville cemetery here.

Active pallbearers were Don White, J. L. Outlaw, William Galloway, Guy Elks, Theodore Dixon, Eddie Hodges, Casper Galloway, T. P. Fleming and Lloyd Whitehead.

Besides her husband, Mrs. Heath is survived by two sons, Sam and James Earle Heath, and her mother Mrs. Columbus Ward of Bear Creek.

Two Pitt County Men Are Granted Paroles

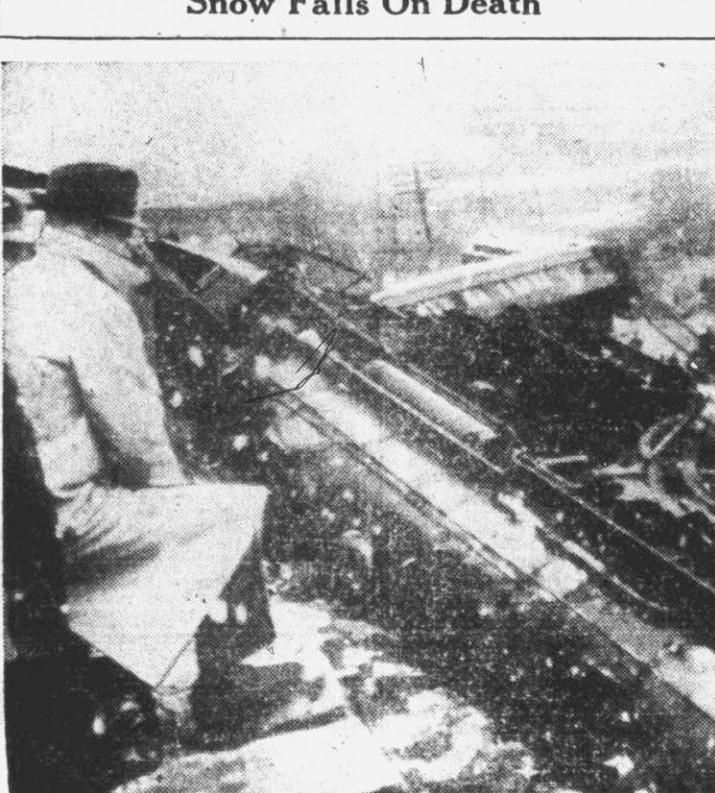
According to advices reaching here from Raleigh, paroles for two men convicted in Pitt county were announced by Parole Commissioner Edwin M. Gill today.

Germans Report Towns Held by Allies Aflame

Claim Britain Hard Hit By Nazi Air Bombs

Berlin, April 22.—(AP)—DNE, official news agency, said today that Namsos and Andalsnes, western Norwegian towns where British forces landed, are aflame.

The agency, in its daily report on the military situation supplementing the high command's communiqué, added that the British had been hard hit by German air bombs.

The German expeditionary force, according to this report, has gained ground steadily northeast and south of Trondheim. Namsos is 100 miles north of Trondheim and Andalsnes is the same distance south.

At the same time it was announced officially that 11 allied planes, nine British and two French, were shot down during yesterday's air attacks over Norway, the North Sea and the Western front.

It was stated that two British bombers were shot down over Seavanger airport, four crashed during the attack on Aalborg airport in Denmark and over the north German coast, while the remainder were shot down by German pursuit planes along the Western front.

According to information received by DNE from Stockholm, the bombardment of English positions at Namsos lasted six hours.

Warned To Leave

Stockholm, April 22.—(AP)—British warnings that the far-north Norwegian port of Narvik, held by Germany, would be bombarded and advising residents to leave the town before firing started, were broadcast three times today.

The British gave Narvik citizens until 3 p. m. (9 a. m. EST) to leave the beleaguered port.

The British decision to subject Narvik to concentrated bombardment apparently was the Allies' answer to the German aerial attack yesterday at Namsos, Norwegian port south of Narvik and a landing place for British troops.

FLOOD CAUSES HEAVY DAMAGE

Much of Eastern New England Inundated By Tides

Boston, April 22.—(AP)—Immense tides inundated eastern New England coastal communities today, causing thousands of dollars damage to homes and shore roads in the wake of a week-end northeast gale which left a snow blanket over much of the area and cut off all communications with the northern section of Maine.

Fears that the storm would swell rivers in the six states to menacing levels abated as the prospect of continuing cold weather and snow flurries prompted weather bureau experts to forecast "no imminent flood danger."

Although the gale still spilled as much as five to ten inches of snow in some northerly sections, the weather bureau forecast only "a little more run-off in the Connecticut and Merrimack river valleys."

Meanwhile, a crest nine feet above flood stage in places rolled down the Ohio valley in Ohio, but the rain-forged river receded north of Marietta. Rivermen generally agreed that the worst was over. Hundreds of families driven from lowland homes up-river returned to clean up.

Stroke Suffered By Arden Taylor Fatal

Arden Taylor of Kinston, former sheriff of Lenoir county and a former resident of Greenville, died at his home last night following a stroke of paralysis suffered a week ago.

Funeral services will be conducted in Kinston tomorrow afternoon. Mr. Taylor is survived by two brothers and two sisters, all of whom at one time made their home in this city. They are B. F. Taylor of Taiboro, Dan W. Taylor of Goldsboro, Misses Lula and Daisy Taylor of Goldsboro.

Hubert Harrington Allegedly Shot By Bennie Harrell, Who Is In Greenville Hospital With Pistol Wound In Leg Allegedly Inflicted By Dewey Brooks; Arrests Are Made

One Pitt county man is dead, another is in the hospital in a serious condition, a third is suffering severe bruises and two are in jail as the result of a shooting and fighting scrape yesterday afternoon in a field off the Greenville-Washington highway about two miles from this city.

The affray, according to members of the sheriff's department, who investigated, resulted when a group of five men who live north of Tar river invaded a poker game being played by eight men who live in the community where the game was under way.

Hubert L. Harrington, 22, is the dead man. He is the son of Mr. and Mrs. Preston Harrington. Funeral services were held at 3 o'clock this afternoon at the home, with Rev. Herbert Morris of Vanceboro and Rev. J. C. Williams of Greenville, Pentecostal Holiness ministers, in charge. Burial followed in Greenwood cemetery. Besides his parents, the young farmer is survived by six brothers, Seth, Jack, Preston, Jr., Edward, George and Frank Harrington, and one sister, Miss Dorothy Gray Harrington.

The man in the hospital is Bennie Harrell, who was shot in the leg allegedly by Dewey Brooks, who wrested the gun from Harrell, who is charged with having fatally shot Harrington. Harrell, although in the hospital in a serious condition, is technically under arrest.

The two men in jail are Jesse Whitaker and V. T. Harrell, the latter a brother of the man in the hospital. Sheriff J. Knott Proctor said several others were under the surveillance of his department.

The shooting took place about 5 o'clock yesterday afternoon about a quarter of a mile from the highway. Within a short while the highway was nearly blocked by Sunday afternoon motorists who had stopped. Many of them walked into the woods to the scene of the shooting.

Miss McRoy is survived by her mother, Mrs. Nicie McRoy of Beaufort county; five sisters, Mrs. Buck, Mrs. Andrew Coghill, Mrs. Ollie Adams, Mrs. Edward Stanley Davidson, Miss Lillian Adams, and two brothers, William Henry McRoy and George McRoy, all of the Galloway's crossroads section.

Mr. Taft is prominent in state YDC circles, at present being organizer for the state organization. This is his first entry into politics, however.

The candidate received his education in the public schools of Greenville and Duke university. He is a member of the law firm of Blount and Taft.

Had Gone to Remove US Citizens In War Section

Assistant Military Attache At Stockholm In Dombos, Norway, To Aid Nationals Get Out of Country, Killed In German Raid; State Department Seeking More Information

Washington, April 22.—(AP)—The State Department received word today that Captain Robert M. Losey, assistant military attache at Stockholm, Sweden, was killed in a German bombing raid at Dombas, Norway, yesterday.

Losey was the first American killed on land since the European war started.

The State Department said Capt. Losey had gone from Stockholm to Norway to assist in removing Americans from the war zone.

Frederick Sterling, American minister to Sweden, cabled the State Department he had just received a telegram from Opdal dated yesterday and signed by Major Ysander, presumably a Norwegian army officer, which read as follows:

"American military attache Capt. Losey was killed by German bomber plane at Dombas today. Inform Mr. Harriman (American minister to Norway.) He will be sent tomorrow (Monday) via Boras to Fjellnas, where instructions from the legation are awaited."

The State Department has instructed its legation at Stockholm to obtain all possible information on the circumstances of the death.

Stockholm, April 22.—(AP)—Capt. Robert M. Losey, assistant United States military attache in Stockholm, was killed by a bomb splinter the Göteborg newspaper Handels-Tidningen said today.

Losey, it said, was standing upright in a mountain tunnel during a German air bombardment at Dombas, Norway, yesterday when a bomb exploded ahead of the tunnel and a fragment struck him in the head.

The newspaper said nobody else in the tunnel was hurt.

Ten Are Tried At City Court Today

A. P. Cayton, white man, was acquitted of a traffic law violation.

Louis Garris, Negro, was found not guilty of abandonment and non-support.

Four of the five convicted of drunkenness were given 30-day sentences, suspended upon payment of costs. They were Tank Gooding and James Keys, colored, Richard Teel and Jesse Coburn, white. Dell Parks, white woman, convicted of the charge was given a 30-day sentence, to run concurrent with a former like sentence, which was ordered invoked after having been suspended at the time of the trial.

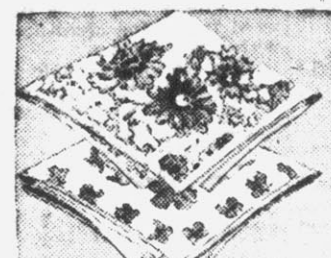

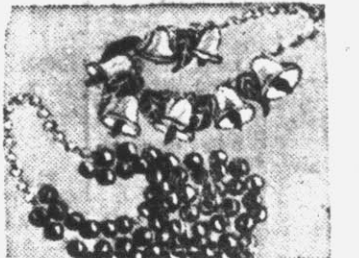

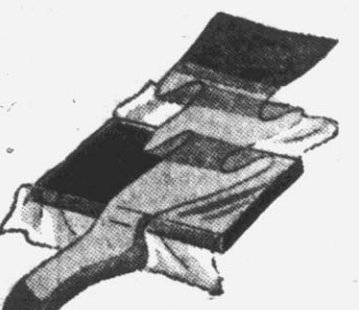

Paris Style Fads Brighten War Mode

Paris designers have produced some amusing tricks to brighten a wartime mode. Bruyere uses them in both frocks and accents. For instance, she makes what she calls 'half dresses' which are simply the front half of a

frock. They can be slipped on over another frock of contrasting color and, attached by belt and scarf, transform its appearance. Hat to top the costumes have scarfs to match the half-dresses. Here are some other ideas from the same designer:



Since beauty experts have had a lot to say about the harmful effect of an overdose of sun on skins, Bruyere brings back the parasol. New ones are made of polka-dotted taffeta or printed crepe to match some other part of the costumes such as the detachable handle of a handbag or printed crepe spats which may be adjusted over slim back shoes. (The detachable bag handles and spats can be had to match any print frock in the collection.) Above is one of the new parasols, of navy blue and white polka-dotted crepe to match a spectator sports frock of the same fabric. It is topped by a flannel jacket and sports hat of Royal Guard Red.

Astology plays a part in the new fashions, too. This simple black silk crepe frock has sleeve and hipbone-line shirring in the pattern of the astrological sign of the Quinquex. It is worn with a detachable collar of mother-of-pearl sequins—a new idea for freshening a dark frock without the usual pique accents. The dress is cut to lie flat when the back belt is untied and so fold like a handkerchief to avoid wrinkling when packed.

This new and startling silhouette is Bruyere's answer to the wartime evening dress problem. She likes its shortened length for two reasons—its practicality in a city suffering from blackouts, and its youthful charm, which she thinks is strong enough to bring it back. The lies of the frock are inspired by those of a Chinese pagoda. It's designed of black taffeta and its multiple tiers are bound in black-stitched ceru taffeta. Other short evening dresses designed for dancing, are fashioned with wide, frothy white tulle skirts or are made of white taffeta printed with gigantic roses. The low waistlines are marked with narrow ribbons belts.

Washington Daybook

Washington.—When the memoirs
of this war are written, our navy
experts will scour them for an an-
swer to the question: Why, oh why,
didn't Germany mine the Skagerrak
and the Kattegat?

When news came that ships of the
British navy were plowing through
the gray mists of the Skagerrak,
navy men here giggled. When no
word came that a single British boat
had been blasted to the bottom by a
mine, the navy boys couldn't believe
their ears and eyes.

With the report that the British
not only had crossed the threshold
(Scandinavians call Skagerrak the
"sleeve") but had swung around the
Skaw and were headed down that
foyer of the Baltic, the Kattegat
(the "cat's throat") the experts were
dumbfounded. The Nazis not only
had left the door wide open but
hadn't even bothered to sprinkle
tacks on the floor.

Looked Like a Set-Up
What on earth had the Germans
been up to? They must have known
for weeks, maybe months, that they
were going to try for the Scandina-
vian coup. With Denmark as a
springboard, they could have poured
troops endlessly across that nar-
row elbow into Norway and Sweden.
It's hardly more than a ferry boat
ride, and between ribbons of mines
through which the British navy
could not cut, it would have been
as safe a ride as from New York's
Battery to Bedloe island.

The astonishment of the folks in
the navy building at this one-more
cockeyed fact in the most cockeyed
war in history, sent me to the re-
cord. There's no real answer there
but there is an interesting phase
of this mining business, which a
study of World war reports and
maps brought out.

That is, that the business of lay-
ing mine-fields is about 10 per cent
mine, 90 per cent bluff.

Don't take this as an under-
estimate of the value of the mine men-
ace. But the undersea garden is
much more sparsely planted with
the "tulips of death" than the war-

ring nations would have each other
believe.
This bluff is part of the game.
The navy department has a collec-
tion of amazing maps. Solid pink
squares, oblongs and triangles show
"announced" mine areas. Here, said
the Allies or the Germans, are min-
ed seas. If you don't want your
ship blown to smithereens, keep out.
But on these self-made maps is a
scattering of pepper and salt—and
these spots show the areas actually
mined. That's what I mean by
90 per cent bluff.

Made Skippers Wary

For example, the whole of the
Baltic was supposed to be mined in
the World War. Actually there was
a scattering of mines throughout
this inland sea which could only
have (according to the experts)
"announced" value. Some occasional
destruction was enough to make
captains wary of the whole area.

The announced mine areas in the
World War were of staggering propor-
tions. From the western coast of
France, below the English channel
to the northern entrance to the
North Sea, there was hardly an im-
portant channel that wasn't mined.
But many of these sections had on-
ly a scattering of "death tulips."

One section mined thoroughly was
the 230 miles from Scotland to Nor-
way, where the United States and
Great Britain in 1917 and 1918 laid
70,000 mines to make a Maginot line
of the entrance to the North Sea.
This project was possible because
the United States developed a new

mine that could be laid at great
depths and exploded at the slightest
touch. For three years, the Germans
had been cutting cables on Allied
mines, emptying their deadly in-
nards, slicing them in half for soup
kettles and punch bowls. The new
mines ended that.

Accent On Bluff

That greatest of all mining ef-
forts taught warring powers a new
technique but naval authorities to-
day are agreed that it has not been
duplicated in the present war. And
the consensus is that there is more
bluff now than there was in the
World War.

There are some experts here who
say that the Germans had good
reason not to mine the Skagerrak
and Kattegat. The Skagerrak is
deep (well over 1,300 feet in some
channels) and the Kattegat is nar-
row. In both the currents are fierce.
Also, it is said, the Nazis wanted
to leave their only channels to the
outside world open. Maybe these
guessers are right. But history will
have to prove it to the navy people.

In early presidential elections no
uniform method of choosing electors
was followed. The legislatures
frequently named them.

The practice of holding elections
on more than one day was not un-
common in the early years of the
United States.

The Greens today were in Kingston playing the Sunbury team of the Inter-State league, which is in training in that city. Manager Rube Wilson was away on business and Morris Wilson had charge of the local team.

Meanwhile plans for the opening of the season are going forward here and it was decided today to play the game Thursday afternoon. Greenville opens with Wilson here.

Skipper Rube continues to draw the lines tighter around his team and, although his club will be composed chiefly of rookies, and therefore is of the unknown quantity, he is hoping to develop some good material out of the score or so rookies now on the roster.

Man About Manhattan

By George Tucker

New York.—Of prime importance to a Broadway producer of musicals are competent song writers, and when Harry Kaufman was ready to go to work on "Keep Off the Grass" he hired James McHugh and Al Dubin, two of the cleverest melody and lyric writers in the business.

McHugh is a tall, wide-shouldered, easy-mannered fellow who looks a lot like Bugs Baer, the humorist. His son, Jimmy, 24, is married to Eddie Cantor's daughter Edna, 19. When he got Kaufman's urgent wire he came on from the coast and established living quarters in the Warwick, which is to say he acquired a couple of extra rooms in which there were only a piano, a couple of chairs, a table, and paper.

His co-worker, Dubin, was already ready to go to work. He, Dubin, and Kaufman went into conference. They discussed the book. They discussed Ray Bolger, and Jimmy Durante, and Jane Frohman, and the others, so as to ascertain the nature of the music to be written and to determine the right mood.

Then McHugh and Dubin, a round, sparse-haired and extremely affable individual, locked the door and went to work.

I do not know Dubin personally. I have said hello to him and seen him on a few occasions. McHugh says he is one of the fastest writers he ever saw, or worked with. Dubin wrote the lyrics for all the Warner Gold-digger films. He wrote "Shuffle Off to Buffalo" and "Forty-Second Street." Last year with McHugh he wrote "South American Way" and all the score for "Streets of Paris," which is also a Kaufman show.

McHugh himself is an old, experienced hand at writing hit tunes at haphazard and also in the scores of film or stage productions. He wrote the music for the Deanna Durbin pictures. He wrote "I Can't Give You Anything But Love, Baby."

The first thing he does is to select a definite title. He and Dubin work over this carefully. That sets the gait, the tempo, the mood. Then

he goes to work. As he finishes the melody he passes the sheet to Dubin, who is already at work thinking up lyrics. By the time McHugh 2; bases on balls—off Flythe 1, Smith 1; struck out, by Smith 2, Flythe 3; hit by pitcher, by Flythe (Johnson); passed ball, Northcutt 2; umpires, Roebuck and Powell; time of game 1:22.

For "Keep Off the Grass" McHugh probably wrote a hundred different songs and Dubin probably wrote 35 sets of lyrics. Out of this will come perhaps 15 numbers.

For writing this score they are being paid 4 per cent of the gross. Every time \$25,000 comes into the box office (sometimes they take this much in a single week) they will get a thousand. This is quite aside from the royalties the song will bring in from radio, orchestras, and sheet music sales, not to forget phonograph records.

Unlike freelancers who write songs when the spirit moves them, composers of shows only begin to work after their scores are completed. They must attend all rehearsals and be ready to make swift revisions when a hitch develops, or a change is needed. At yesterday's rehearsal of the chorus I saw McHugh write 16 bars of new music in 15 minutes. He wrote it standing at the piano, one hand in his pocket, while the pianist sat there and played it, bar for bar, as it was written.

"That's sausage-grinding," McHugh explained. "No inspiration necessary. If you had to write a hundred words in a hurry, you could do it without thinking. What's a few bars more or less to a songwriter?"

DERBY NOT ALWAYS PRESENT DISTANCE

Louisville, Ky. (AP).—From the beginning of the Kentucky Derby in 1875 through 1895, the Derby distance was one and a half miles. Then, in 1896, the distance was reduced to one and a quarter miles and has remained so since that time.

When the Derby was run over the mile and a half route, Spokane set a record in 1889 by covering the distance in 2:34.

Twenty Grand, winner of the 1931 Derby in 2:01 4-5, holds the record for the present mile and a quarter grind.

1940 DERBY HAS LARGE NOMINEE LIST

Louisville, Ky. (AP).—Nominations for this year's Kentucky Derby—totaling 127—were the largest since 1930 horses were named for the 1931 running.

Nineteen Derbies have had larger subscriber lists than that of 1940, however. The record was the 196 nominated in 1928.

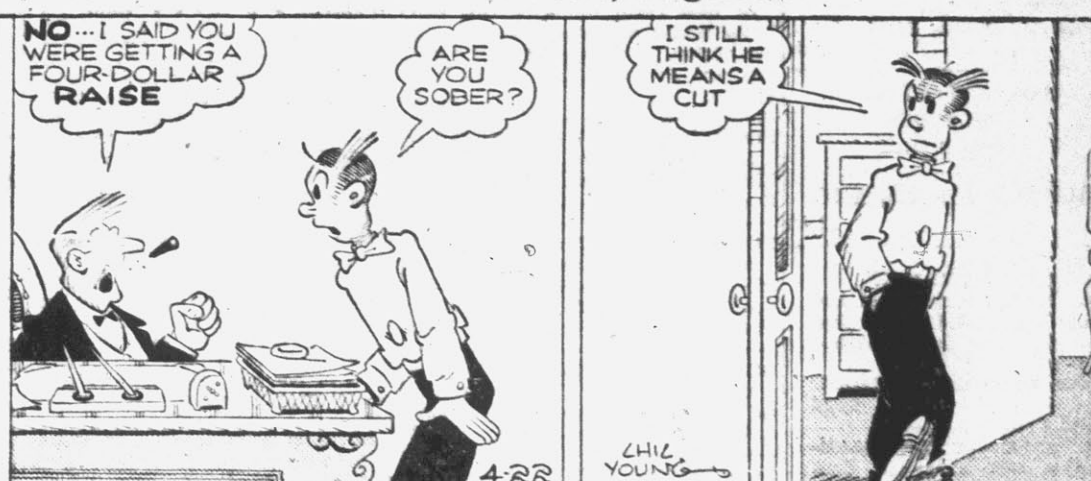

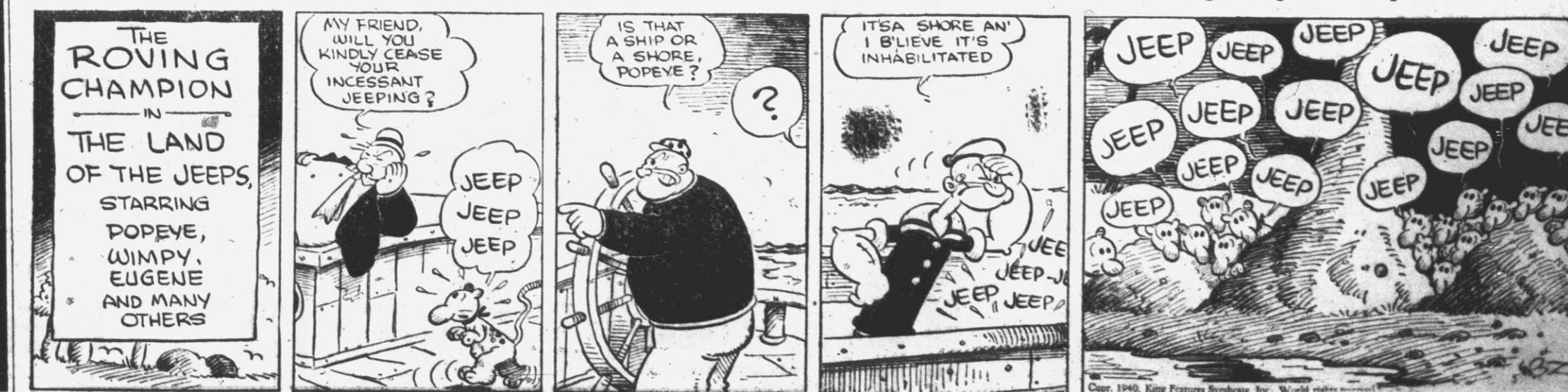

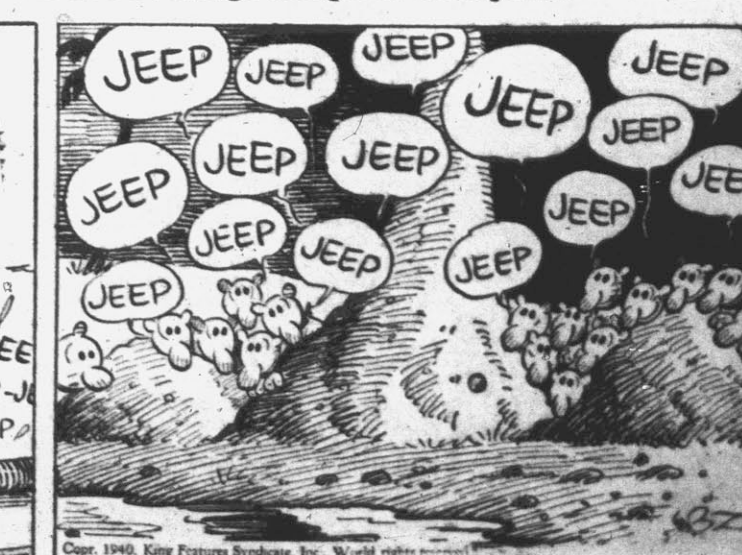

No Marked Change Noted In Gubernatorial Race

Raleigh, April 22.—"Another day, another dollar — a million days a million dollars" is an old army quip. But from your Raleigh reporter's point of view the gubernatorial candidates can't do much better than paraphrase it to "Another week, just another week" so far as any visible change in the situation is concerned.

A week ago the "wise boys" were predicting that the second primary contestants will come from the trio J. M. Broughton, W. P. Horton, A. J. Maxwell, and there is absolutely no reason to change the prediction now.

This despite the fact that Tom Cooper has been shouting mightily about the "Raleigh Gang" and "Organized politicians" from the rear platform of his gaudy sound truck. This, also, despite the fact that Lee Gravelly seems to be picking up more support than was generally expected in many quarters. One of the leading workers for another candidate, in an "off the record" conversation with your reporter paid Lee a fine compliment when he remarked — "There's one thing about Lee's strongest where he is best known; and that's something that can't be said about all the candidates. Some have their strongest support where they are least known."

If there was any outstanding feature of the week it was the ability of J. M. Broughton to hold his own in the reports, at least, at the top of the prospect list. He accomplished this in the face of the most intensive Hubert drive of the entire campaign. Nobody watching the campaign could have escaped noting that the lieutenant governor's machine was opened up wide and the signal was "full speed ahead."

The propaganda boys went to Harrington: "What have you got to do with it, you — — —". V. T. Harrell and Bennie Harrell, brothers, then walked over to where Hubert Harrington was standing. Earl Speight hit B. T. Harrell with his fist and Bennie Harrell drew a .32 calibre pistol from his pocket and shot Hubert Harrington twice, one bullet entering the right side of the face and coming out the left, and the other piercing his left shoulder. Hubert Harrington walked about 200 to 300 yards before he fell. He was dead when officers arrived.

After Hubert Harrington was shot, Dewey Brooks, one of those playing poker with Harrington and the others, jumped on Bennie Harrell and took the pistol away from him. In the Harrington, Frank Harrington, Jesse Whitaker and Bennie Harrell then started advancing on Dewey Brooks, who was holding the drawn pistol. The men advancing on Brooks were declared by some to have drawn knives, but this was not verified. Dewey Brooks then shot Bennie Harrell, the man who had fatally shot Hubert Harrington, in the back of the head. The three, Fountain Harrington, Frank Harrington and Jesse Whitaker, continued to advance on Dewey Brooks, who snapped the pistol (the weapon had only three cartridges when officers arrived and these three already had been fired, two at Hubert Harrington and one at Bennie Harrell). When the pistol failed to fire again, Dewey Brooks threw it down and ran. He was caught by his three pursuers, however, and beaten so severely he had to be taken to the hospital for treatment.

Sheriff Proctor declared that the group who invaded the poker game had been drinking rather heavily, but that there was no evidence that the players had been drinking. Members of the sheriff's department reported that they broke up a poker game about 1 o'clock Sunday afternoon in which several of those playing in the game were killed. It was believed that after the first game was broken up the players moved from an old shack back off the road to the field across the highway.

Then at the last of the week Horton called in all his field workers and county managers for a conference and dinner, and of course that was cause for much more Horton talk.

In short there was unquestionably a lot of tumult and shouting for the lieutenant governor here in Raleigh, if nowhere else; but what its effect, if any, cannot yet be measured.

Meanwhile, Broughton and Maxwell continued the more or less even tenor of their ways; announcing a manager here and a worker there, building up new fences and repairing damaged ones in various sectors. Neither startled the populace with any sensational coup of political strategy.
