ASKS UNITY IN FIGHT AGAINST FIFTH COLUMN

President In Plea For Federal - State Cooperation

COMMON FRONT IS ADVOCATED

Report Issued Prior To Roosevelt's Statement Shows FBI Kept Busy During Past Year

Washington, Aug. 5.—(AP)—President Roosevelt today called for unity between federal and state governments in strengthening national defense and uncovering subversive activities.

"And the common defense should be through the normal channels of local, state and national law enforcement," he said in a message to the federal-state conference on law enforcement problems arising from the preparedness program.

"We must be vigilant always, on guard and swift to act."

A report made public in advance by J. Edgar Hoover, said that the FBI investigated 16,885 defense cases during the year which ended June 30 against 1,651 in the previous year and 250 in 1938.

Hoover reported "a negligible amount of sabotage (in the United States) in the second World war, in contrast to the similar period in the first World war."

Eleven Are Tried In Today's Court

Eleven defendants were tried at the regular Monday morning session of Municipal recorder's court. Three of the seven cases aired involved traffic collisions.

Miss Mary Jenkins, white, and Linwood Woodard, colored, involved in one of the collisions, were freed of charges of careless and reckless driving.

Buck Mulder and James Leon Crawford, white men, were bound over to Superior court on charges of breaking, entering and larceny. Mulder was placed under bond of \$500 and Crawford under bond of \$300.

R. G. Arnold, white, was acquitted, but a co-defendant, Roscoe Norfleet, colored, was found guilty of careless and reckless driving, and was given a 30-day sentence, suspended upon payment of court costs.

Ivey Watson, Negro, was convicted of abandonment and non-support, but sentence was continued.

John Whichard, colored, was acquitted of a larceny charge.

Arthur Mashburn, colored, was acquitted of engaging in riotous and disorderly conduct and assault, but a co-defendant, James Pettus, also colored, was convicted and given a 60-day sentence to be served at the county home.

American Steamer Released By Japs

Shanghai, Aug. 5.—(AP)—The small American coastal ship Estelle was released today by Japanese authorities who had held her for five days after she took refuge from a typhoon in a zone forbidden to shipping.

United States Consul Richard Butrick made representations to the Japanese to get the steamer released.

The vessel had been detained by the Japanese navy off the blockaded Chekiang province coast. The Japanese recently warned all shipping to stay away from Chekiang ports.

No Americans were aboard the ship.

JAPAN DRAFTS NEW PROTEST

Arrests Of Japs By British Evoke Further Ire

London, Aug. 5.—(AP)—The Japanese embassy announced today that Ambassador Mamoru Shigemitsu was drafting his third protest in three days to the British government against the growing number of arrests of Japanese subjects throughout the British empire.

An embassy spokesman said the ambassador probably would call on Foreign Secretary Lord Halifax this afternoon.

The announcement of the third protest was made by the embassy as soon as confirmation was received of the arrest of three Japanese business men in Rangoon and a Japanese journalist at Singapore.

Four Japanese, two of whom have been ordered deported, are being held in London. A Hongkong merchant taken into custody Saturday made the number arrested throughout the empire total nine.

Arrests Negro On Burglary Charges

David Ellis, Negro of the Fountain community, was arrested and brought to the county jail this morning by J. O. Bryan, Fountain police chief, on a charge of first degree burglary.

The Negro is alleged to have gone to the home of Mrs. Golden Phillips, white woman of near Fountain, one night two or three weeks ago, raised the window and started to enter, getting part of the way in. Mrs. Phillips was quoted by officers as saying that the Negro, who was dressed only from his waist down, to have made immoral suggestions.

The woman was said by officers to have told them that the man fed on a pretense of securing a gun. Mr. Phillips was at a tobacco barn at the time.

Officers said the Negro admitted the charge, but declared he was drinking at the time and did not realize what he was doing.

Makes Report On Jail's Population

With Superior court two weeks off, the county jail population is unusually low at this time.

There are only seven white men, 10 colored men and three colored women being held pending trial, most of the cases to be tried in Superior court. It is not unusual for 35 or 40 persons to be in jail just prior to the opening of the August term of court.

In addition to those in jail awaiting disposition, three Negroes, one man and two women, are serving sentences.

Several persons were arrested over the week-end by ABC officers and state patrolmen on charges involving drunken driving or illegal traffic in liquor.

SEN. SHEPPARD FEARS ATTACK AGAINST U. S.

Firmly Believes Hitler Will Turn On This Nation

CONSCRIPTION BILL APPROVED

Committee Favors Burke - Wadsworth Measure 7-3; Fight On Senate Floor Expected

Washington, Aug. 5.—(AP)—Senator Sheppard (D-Tex.) told the Senate today that it was his "firm belief" that Hitler intended eventually to attack the United States.

He spoke after the Military committee, of which he is chairman, voted 12 to 3 to send to the Senate floor the Burke-Wadsworth compulsory military training bill requiring the registration of approximately 12,000,000 men from the ages of 21 to 30, inclusive.

"Does the Senator think," Senator Wheeler (D-Mont.) demanded, "that Hitler will attack the United States?"

"He will try to attack the United States," Sheppard replied. "That is my firm belief, and if it was not, I would not be here trying to get the Senate to approve this legislation."

Wheeler contended that most of the "emergency" had been manufactured by "propagandists" who, he said, wanted to scare the Senate and the people of the country "into giving dictatorial powers to some."

"The only emergency I can see is that the election is coming up," Wheeler said.

Committee approval cleared the way for Senate consideration this week of the conscription measure, which "has the personal endorsement of Secretary of War Stimson and was recorded by the Budget Bureau as being in accordance with President Roosevelt's program."

Considerable opposition to the bill was foreshadowed in the Senate despite the fact that only three votes were recorded against it in the committee.

Guardsmen to Get No UCC Payments

Raleigh, Aug. 5.—North Carolina National Guardsmen, who happen to be out of work and drawing unemployment compensation while at home will not be eligible for these benefits during the three weeks of summer training in military camps and forts, Chairman Charles G. Powell, of the N. C. Unemployment Compensation Commission, announced.

Inquiries have been received from local Employment Service offices about this point, particularly from Charlotte.

"The Commission feels that it would be socially desirable, but legally impossible to pay unemployment benefits to otherwise eligible unemployed workers who are called to the camps during the summer training period," said Chairman Powell.

On advice of General Counsel Adrian J. Newton, he pointed out that these guardsmen will not be eligible for the weekly continued claims in the local offices, nor will they be "available for work," both of which are required before a claimant can draw benefits under the law. Also, there is the question of whether or not they are "employed" while in the service of Uncle Sam.

Naturally, such claimant-guardsmen will be eligible for benefits when they return from camp and can sign the weekly continued claims, thus showing that they are again available for work, and are not employed—if otherwise eligible for benefits—Mr. Powell pointed out.

Strategic British Centers Attacked

Rome, Aug. 5.—(AP)—Some of Britain's most important strategic centers in the Anglo-Egyptian Sudan, Kenya and Aden zones, including newly-built airfields, were wrecked over the week-end by Italian bombardments, Stefani, official Italian news agency, reported.

New British air bases, the agency said, were discovered by Italian scouting planes and attacked by a strong bombing squadron.

Not only was a large hangar set afire at Haiya, important Anglo-Egyptian Sudan rail center, Stefani said, but planes on the ground were so badly damaged that they were put out of action.

COOLEY TO BE AT TEST FARM

Will Address Annual Field-Day Event Thursday

Raleigh, Aug. 5.—Rep. Harold D. Cooley, member of Congress from the fourth district, will be the principal speaker at the 17th annual farmers' field day at the Upper Coastal Plain Test Farm near Rocky Mount, Thursday, August 8.

Commissioner of Agriculture W. Kerr Scott, who will introduce Cooley, today estimated that approximately 3,000 farmers, their wives and others will be present. Tours of research plots and agricultural exhibits will be a feature of the all day program. Secretary of State Thad Eure will be chairman for the day and field tours will be under the supervision of F. E. Miller, director of the test farm division of the State Department of Agriculture and R. E. Currin, Jr., assistant director in charge of the farm.

Other speakers will include Dr. G. K. Middleton, acting chief of the agronomy division, State College; E. Y. Floyd, State AAA officer, State College and James Abrams of Macclesfield district winner of the Young Tar Heel farmers public speaking contest.

The wreck occurred at almost the same place as the Bacca-Calcutta mail train was wrecked last year when 35 were killed and 36 injured.

A length of rail had been removed from the track.

BRITISH FIRM SENDS BUYERS

Imperial to Buy Georgia Tobacco For U. S. Agency

Richmond, Aug. 5.—(AP)—The Richmond News Leader said today there were reports here that the Imperial Tobacco company's buyers would attend the Georgia tobacco markets' opening Thursday as the buying agents for the Commodity Credit Corporation.

The company's buyers would make sufficient purchases, the paper said, to offset the loss in purchases by the withdrawal of the Imperial and other British companies from the market because of the European war.

The paper added that indications were the Imperial would buy from 150,000,000 to 250,000,000 pounds of the bright tobacco crop for the Commodity Credit Corporation on the same basis as the Imperial bought last season, with the exception that it would not have option on the 1940 crop, as was the case last year.

ABC OFFICERS ARREST SEVEN

Local Enforcement Crew Reports Busy Week - End

The Pitt county law enforcement officers had a busy time during the week-end, arresting four Negroes on a charge of illegal possession, jailing the Negro woman from whom the four are quoted as saying they purchased the contraband, and arresting two other white men on charges of illegal possession.

The four Negro men, George Wright, LeRoy Hardison, Allen Parmalee and Grant Morris, were arrested near Grimesland Saturday night about 10 o'clock as they were entering that town from across the river. They had one quart of bootleg liquor.

Officers said the four had signed statements saying they purchased the liquor from Clara Little, Negro woman of the Six road community near Paclouis. The Negro woman was arrested this morning by the ABC officers. She was released on bond signed by her father, Bert Little. Wright also was freed on bond, but the other three Negroes are being held in jail.

Saturday afternoon the officers arrested Charlie J. Peaden and Edgar Davis, white men of near Falkland, on charges of illegal possession. The two men are alleged to have had a gallon jug of bootleg liquor in their possession, but to have broken the jar when officers approached.

Warns Merchants Of Forger In This Area

Greenville merchants were warned in today's bulletin of the local Merchants Association to be on the lookout for a man forging the name of "Milton E. Gundersheimer" to checks drawn on the Celanese Corporation of America, Cumberland Md.

The name forged by the man is that of a responsible resident of Baltimore, Md. The printed checks are forged as well as the signature it was explained. Checks were said to have been cashed in Wilson.

UCC Collections To Date Revealed

Raleigh, Aug. 5.—Contributions from liable employers in North Carolina to the Unemployment Compensation Fund through July 31, including 1936 collections at the rate of 9 per cent of the payroll, 1937 collections at 1.8 per cent of the payrolls, and 27 per cent of the payrolls since, amounted to \$36,806,046.4., to which is added \$930,616.19 in interest on this state's deposit balance in the U. S. Treasury, giving total receipts of \$37,736,662.60.

Benefit payments in the 31 months since January 1, 1936, amounted to \$15,412,596.84, through July, leaving a balance of \$22,324,065.76. This balance is subject to reduction of \$750,000 to \$1,200,000 to be turned over to the Railroad Retirement Board.

DECLARE TIDE IS FAVORABLE

Weather Also Said To Be Satisfactory For German Attempt To Invade British Isles; Royal Air Force Continues Attempts To Smash Blitzkrieg Before It Is Launched

London, Aug. 5.—(AP)—Increasing Nazi activity at French channel ports reported by British bombers back from raids deep in Germany kept England on the alert today as tides and weather combined to offer Adolf Hitler more favorable conditions for his long-promised blitzkrieg.

Authoritative sources indicated that the Royal Air Force, attempting to smash any invasion before it could be launched, was hurling more and more planes into nightly attacks on German industrial centers, troop concentrations and channel bases.

The Air Ministry reported meanwhile that three Messerschmitt fighters were shot down this morning as spitfire pilots, continued to carry the war into the Nazi camp.

Two of the German planes were shot down on the far side of the English channel within range of German anti-aircraft guns, by a squadron of nine spitfires, the Air Ministry said.

"Germany is out for a bigger headache than she has yet suffered," one spokesman predicted grimly.

The government meanwhile moved to strengthen Britain's defenses by placing the home guard, now 1,500,000 strong, under new leadership, replacing with younger officers a handful of elderly generals whose ideas of war were described as "highly antiquated."

At the same time the civilian population surrendered its traditional August bank holiday to speed the work of producing munitions and vital war supplies.

German bombers kept up their scattered attacks on England with a series of raids during the night which the government said resulted in the death of one person, a few other casualties and "negligible damage."

Thousands of green and yellow leaflets containing extracts from Adolf Hitler's peace offer speech to the Reichstag were dropped in a northeast English town and in sections of southeast England last night.

Terms Reached In Pact With Russia

Washington, Aug. 5.—(AP)—Sumner Welles, acting secretary of state, said today a new trade agreement with Soviet Russia replacing the one expiring tomorrow probably would be completed soon.

Welles said he understood that the new agreement was in the offing, but had not yet been actually reached. Whether the new agreement would merely extend the existing one under which Soviet Russia agreed to purchase \$40,000,000 worth of goods annually was not disclosed. Welles said the details would have to await the actual signing and would be announced simultaneously here and in Moscow.

Ruhr Oil Plant Bombed London, Aug. 5.—(AP)—The Air Ministry communique tonight said British bombers attacked the oil plant at Sterkrade in the Ruhr and left it in flames.

ish ship bearing King Phillip II's ambassador (Rains) and niece, Dona Maria (Marshall) to Elizabeth's court. It's a rousing, bloody bit of sea warfare, beautifully photographed. And "The Sea Hawk" never stops moving. The action encompasses Captain Thorpe's side-odition after Spanish gold in Panama; capture of his company and their imprisonment as galley slaves; their escape and a harum-scarum duel between Flynn and that villain, Woffingham (Daniell). Stand-out performance: Miss Robson as Elizabeth.

"Pride and Prejudice." Screenplay by Aldous Huxley and Jane Murtin from Jane Austen novel as dramatized by Helen Jerome. Directed by Robert Z. Leonard. Principals: Greer Garson, Lawrence Olivier, Mary Boland, Maureen O'Sullivan, Edna May Oliver, Ann Rutherford, Edmund Gwenn, Heather Angel, Inesport, Karen Morley, Marsha Hunt.

One of the most delightful comedies to hit the screen is this account of aggressive man-hunting by the ambitious mama (Boland) of five marriageable daughters (Garson, O'Sullivan, Rutherford, Angel, Hunt) in a small English community of the post-Napoleonic era.

"Pride and Prejudice" has a style that would distinguish it entirely apart from its interesting and amusing tale. Match-making mama is kept just this side of caricature by Miss Boland; strong-minded Lizzie is done sensitively by Garson; and Gwenn makes an ideal father. Oliver, of course, is wealthy Mr. Darcy, main object of mama's schemes for Lizzie. He plays it with the dour romanticism that won him feminine sighs in "Rebecca." Surprise: Marsha Hunt as the ugly duckling.

The Isle of Manoa was lovely until the bad white man (McLaglen) came looking for pearls, bringing Shanghai Ruby (Farmer) to steal Kahuia (Hall) from his native love (Bradna). Beautiful scenery, nice underwater stuff in the pearl sequences—but the only unexpected development is failure of the smoking volcano to erupt. Fun if you're tolerant.

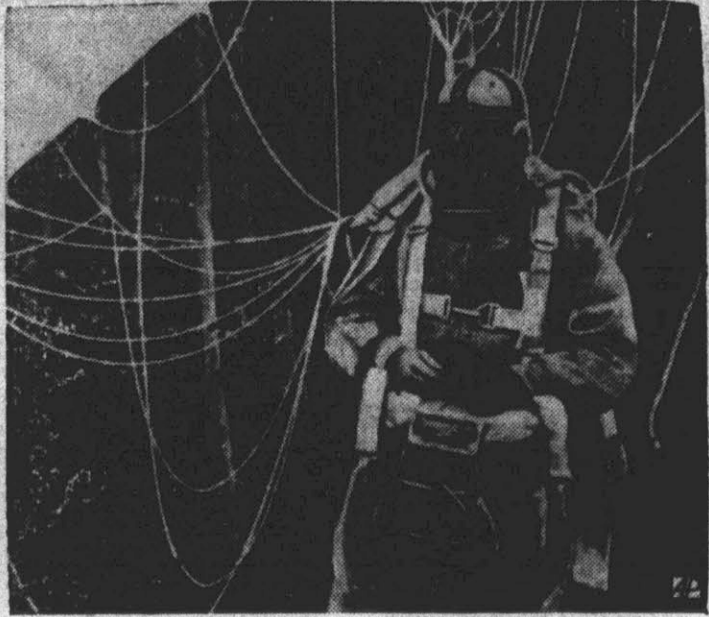

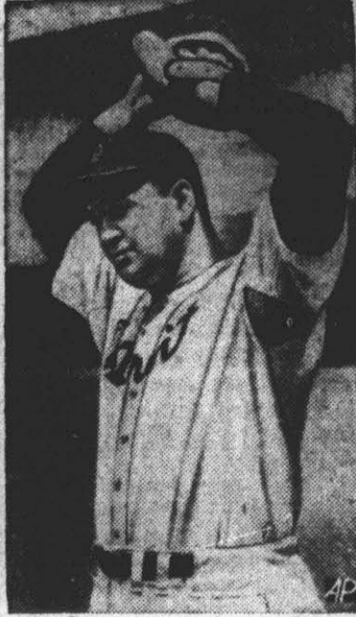

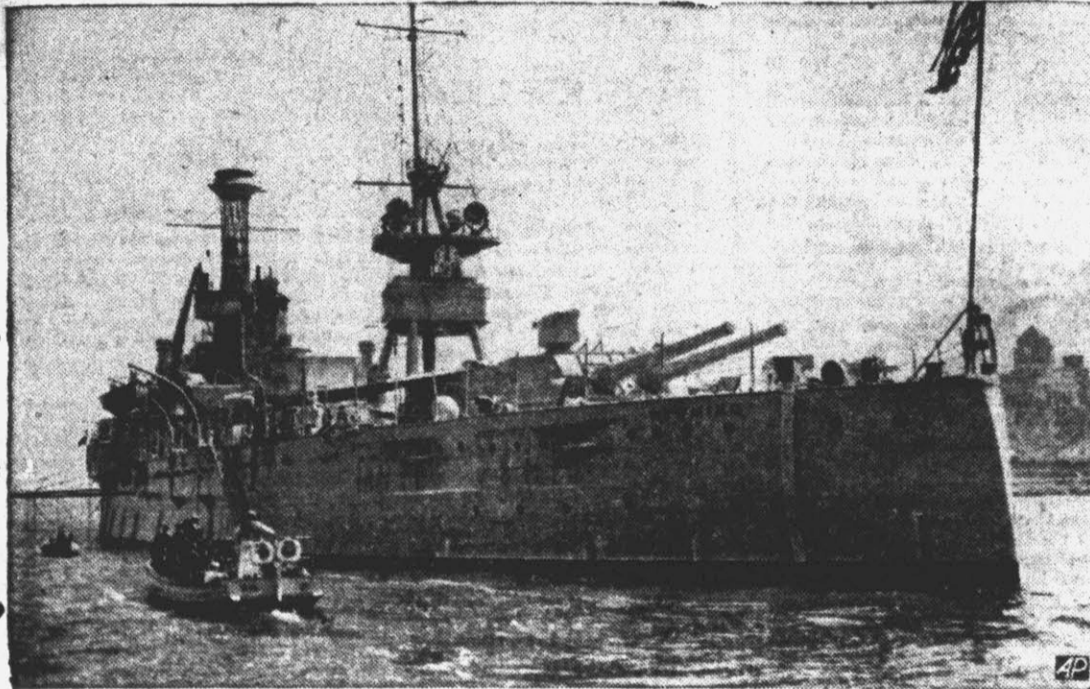

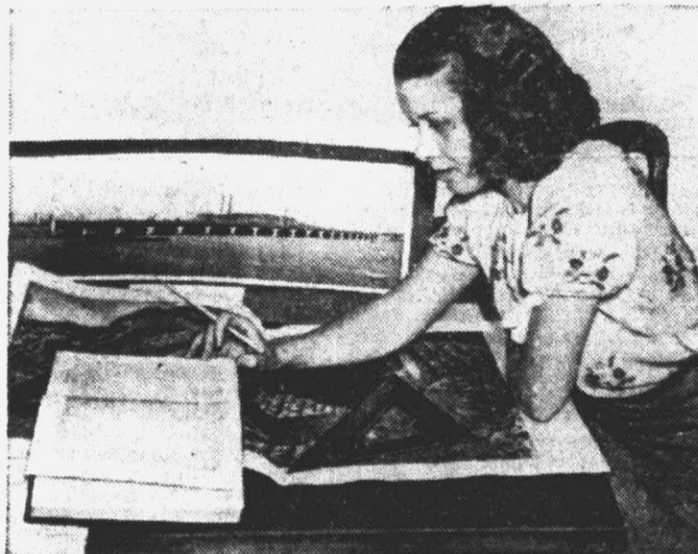

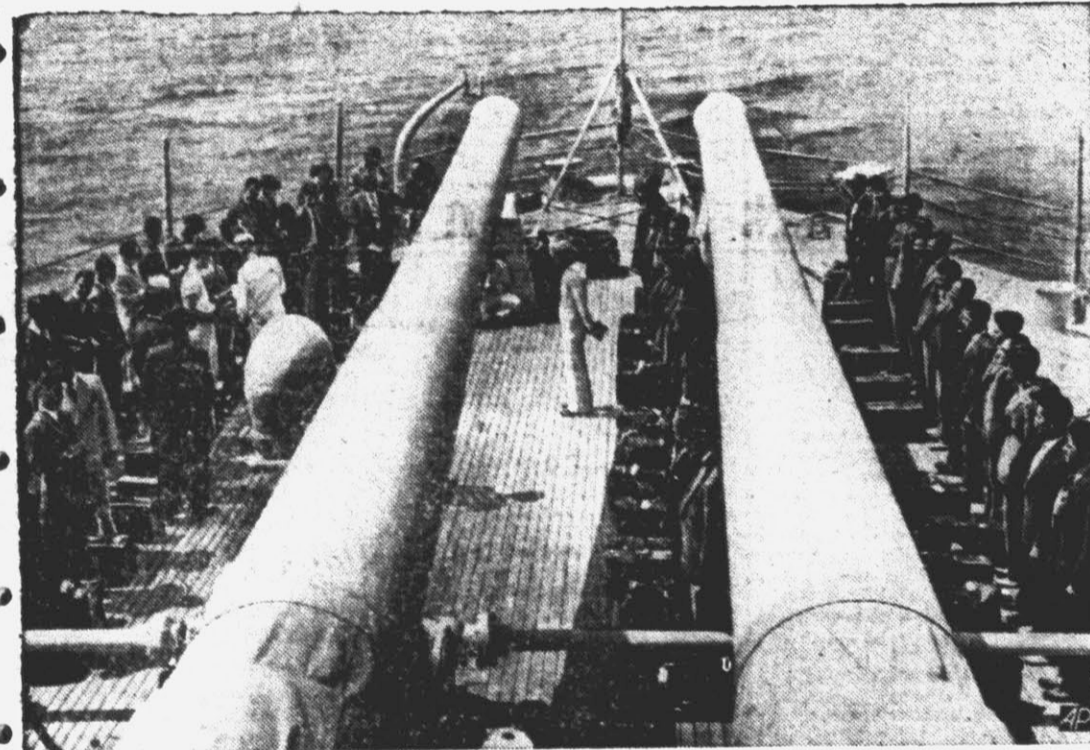

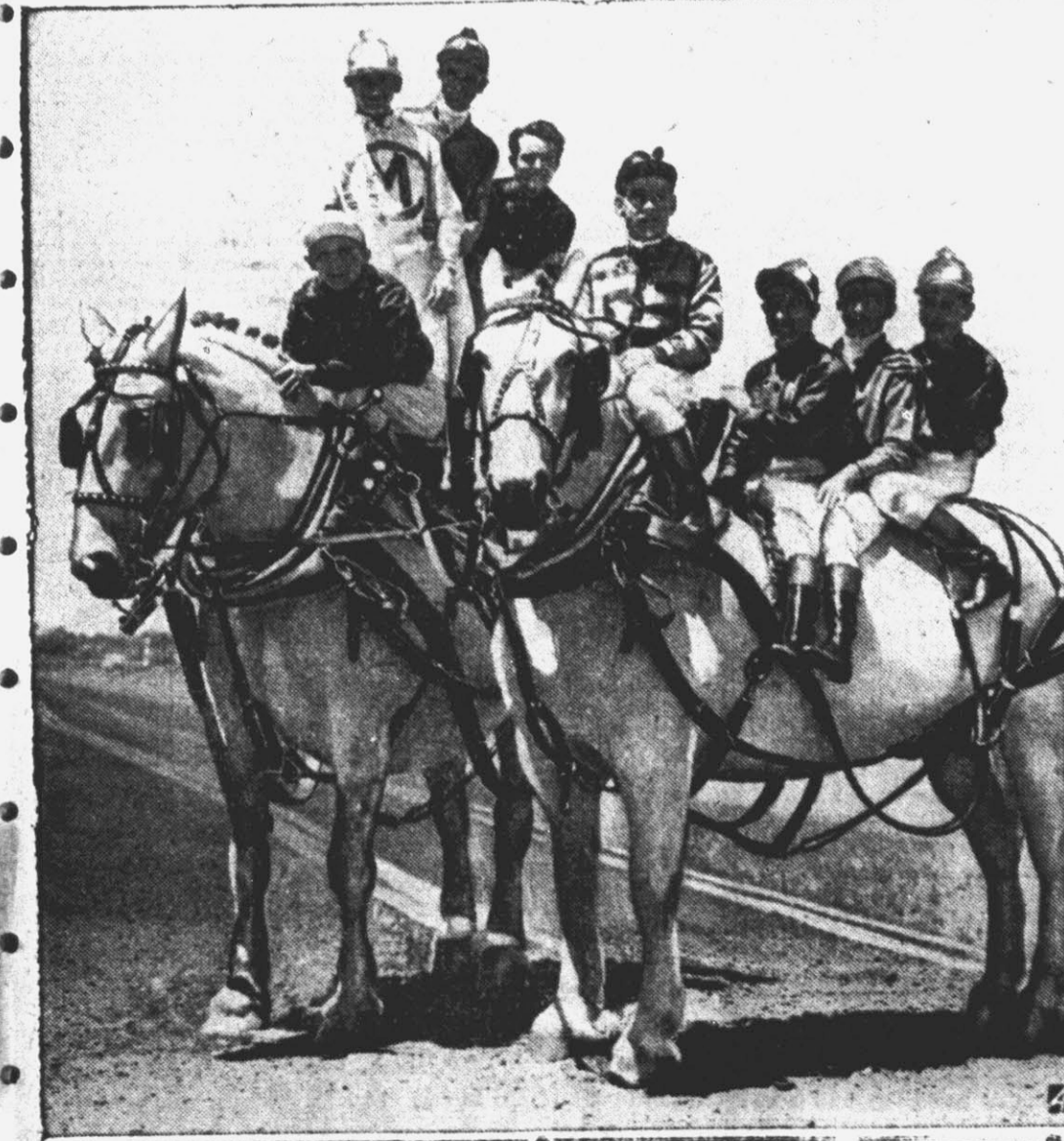

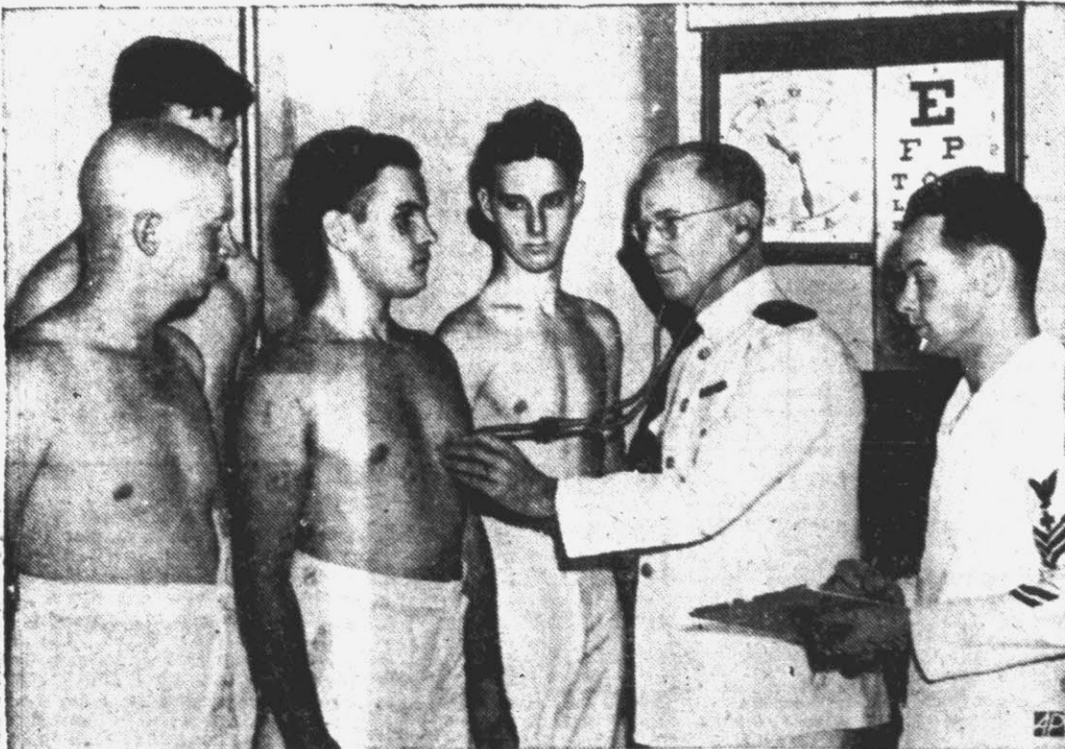

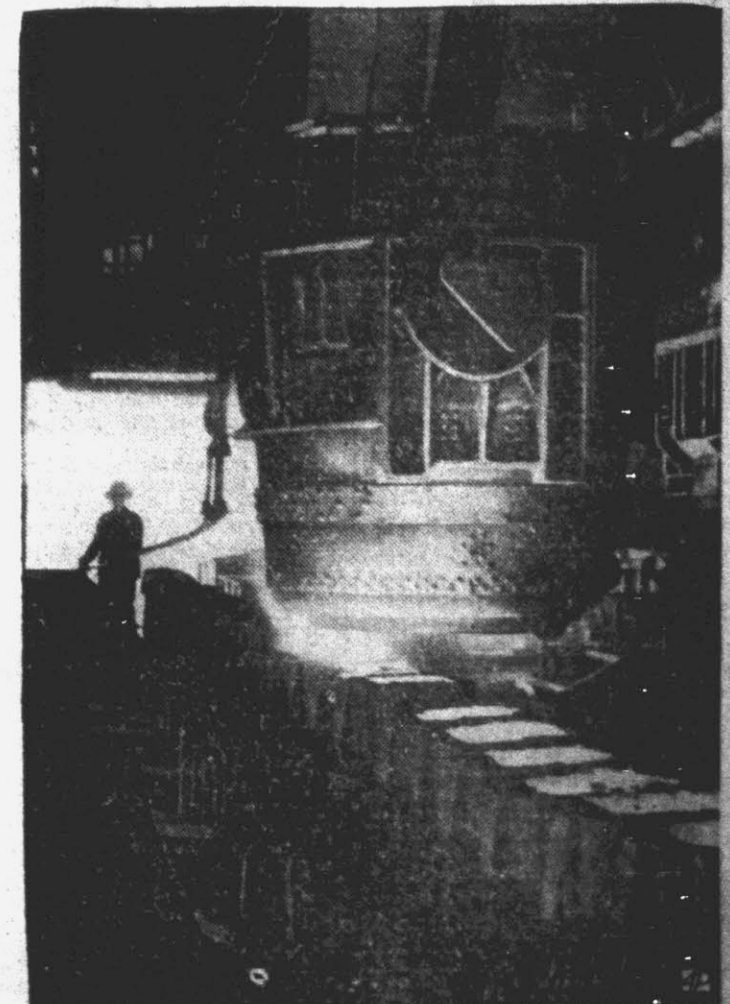

PEOPLE ARE STILL HONEST

Here are some facts extremely disconcerting for any patriotic American to confront: Hotel managers declare that on an average one hand towel per guest disappears from their hotels every day and one bath towel per guest each week. Some hotels even report that occasionally the Golden Bibles disappear. In the big cities, automobile sales agencies remove cigar lighters from cars immediately upon their arrival because such equipment is stolen almost immediately if left in cars which made one display. There is said to be millions of dollars worth of goods smuggled into the United States every year, not by professional smugglers but by people of responsibility and prominence in their communities.

The people who take the hotel towels, etc., are not thieves—they are people with double standards of morals. They seem to have the feeling that because they have paid for a night's lodging they have bought such incidental articles as hand towels, soap, etc. People who do these things are, for the most part, honest in their business dealings and, on the whole, quite reliable. But they just fail to realize that principles of honesty apply equally to the little things of life and the big things.

However, the picture is not entirely dark. Yesterday I handed a man two five-dollar bills which had stuck together, believing I was giving him only one, and he discovered the mistake and handed one back to me.

Johnny, you'd better be looking for your gun. If you are an able-bodied male, between 21 and 31, without dependents and not working in a key position in some defense industry, you are going to need it.

That is the way the thing looks now, although I have pointed out before that the compulsory military service bill is in for a battle before it clears the Senate and House and is signed by the President. A law in some form it will become, certainly—the only time that any sort of compulsory military service has become operative in the United States during peace time.

The way the bill looks at this writing, about 12,000,000 young men are going to register with their respective draft boards sometime in September. Within a month, 400,000 will be told to report for military training, and although some will have legitimate excuses which will exempt them, the rest can take it and like it... or go to jail.

We Need A Big Stick

The reason for the bill—and a majority of the folks back home seem to agree that the reason is adequate—is primarily that we were caught without a navy adequate to defend both oceans. Not having a navy that can take care of the Atlantic as well as the Pacific (best estimates are that it will be 1947 before we can reach that state of preparedness) the idea is that we must have an army which will scare the pants off anybody.

Opponents of the bill aren't arguing that we don't need the army... they're just claiming that we can get enough men by enlistment. The

army people, having been through all that before, say it can't be done, despite recent enlistments of about a thousand a day. They claim and history backs them up, that shortly this voluntary business will reach the saturation point and they'll have days when nobody comes in and says "I wanna be a soldier."

The bill currently provides for registration of men who are 18 and not yet 64. Only those between 21 and 45 are liable for military service, but the others may have to serve in home defense units. There's a probability that men under 21 and over 45 will not have to register at present.

Of the estimated 12,000,000 men between 21 and 31, one out of 30 will be called to the colors for 12 months' service, around the last of September. The idea is to call 400,000 more men come spring, and 600,000 more in the fall of 1941. The bill states as strongly as Congress can that all that should be given their jobs back when they return from duty. In the case of businesses not involved in interstate commerce, all Congress can do is urge.

You Can Sit It Out, Too

Exemptions will include men employed in agriculture or other occupations necessary to national health, safety or interest; men with dependents, and men mentally, physically or morally unfit.

"Draft dodgers" (men filing false returns) will be subject to five years in the hoosegow or \$10,000 fine. It's called the Burke-Wadsworth bill and the White House hasn't given it its official nod to the measure. It may not go through but whether this one does or doesn't, Johnny, you'll get your gun. Unless, of course, a Spiffire should squat in the lap of Hitler, Mussolini, Stalin and Co. (the and Co. being mostly Japan's war party) in which event I guess, Johnny, we could just go on about our business.

Raleigh, Aug. 5.—Barber shops, hotelobbies and street cars are excellent places to study cross sections of citizenship. A group on a Raleigh street bus got to arguing the army draft. All participants in the discussion were beyond military age, but they had very definite opinions about how the draft ought to be handled. One man didn't like the idea of drafting boys under 21 years of age. Another man thought that instead of leaving at home men with wives and children, they ought to be taken first, because they have more to fight for. Still another one didn't like the draft at all. And so the argument waxed.

Finally one elderly man got up to leave the bus, and delivered himself of this gem: "This is the best illustration I have seen in a long time of the blessing of American citizenship. There isn't a country in Europe where such a conversation could be carried on without fear of arrest by government agents. I'm willing to leave the details of the draft to leaders who know what they are doing. And I'm ready to fight now or any time for preservation of this liberty we have."

And that reminded one of the others of an experience a year or two ago. He said he had been criticizing the state government for the location of some public buildings. The man with whom he was talking thought they were properly located. "Did he ever occur to you to think that if you had as little sense as Clyde Hoey you might be governor, and if he had as much as you he might be starving to death, too? There seemed very little left to say after that."

They would rather hear a news broadcast than pay a cover charge for the privilege of listening to a "society" orchestra.

All day she sits at a typewriter punching out letters but she would rather be playing Helen Holmes on the top of railroad box cars. She comes from Texas, and twice she has fallen off box cars. What, you will very properly ask, what business has a young girl running on the top of box cars? Absolutely none. "But I can't help it," she confesses. "It's a sort of mania. I've been doing it ever since I was big enough to climb upon one. My mother finally sent me to New York to stay with my aunt—just to keep me off box cars."

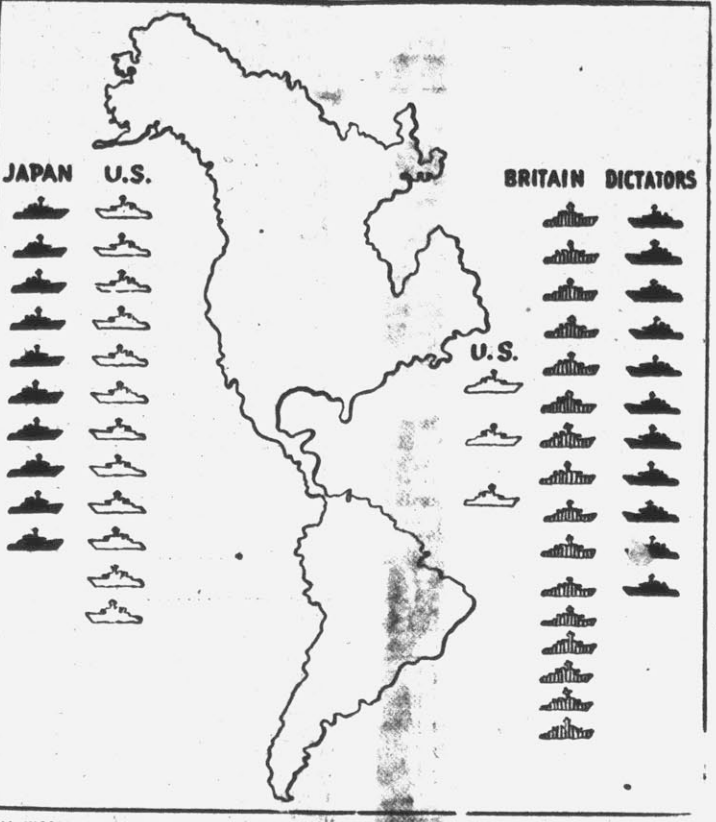
