PETAINE AND HITLER AGREE ON ROLE FOR FRANCE Nazis Speed Up Tempo Of Air Assaults On Britain

LONDON HEARS SEVEN ALARMS

Empress Of Britain Reported Sunk As Germany Increases Warfare On British Shipping; Outcome Of German-Italian-French Negotiations Anxiously Awaited

The tempo of Nazi aerial warfare against Britain and British shipping was speeded up today with the reported sinking of the 42,348-ton Empress of Britain, as the world awaited the outcome of the German-French-Italian diplomatic negotiations to determine France's new status in Axis-dominated Europe.

London was under alarm seven times between daybreak and early afternoon after a night-long hammering in which more homes and buildings were smashed and numerous casualties inflicted.

At least six persons were killed by a bomb which wrecked an apartment house. Many were buried under the debris and released only after air raid precaution workers and volunteers dug into the wreckage.

Axian planes attacked eastern Scotland, the British naval base of Rosyth, Liverpool, Wales and midland industrial cities as well as the capital last night.

At sea the Germans claimed to have sunk the staff liner Empress of Britain, in which King George and Queen Elizabeth returned home after their visit to the United States and Canada in 1939. Later reputedly in troop transport service.

Informed Nazi sources said German combat planes bombed the liner north of Ireland and left her in a sinking condition after the crew got away in boats.

The Royal Air Force, taking advantage of the clearest weather observed in the English channel since the start of the war, attacked a Nazi convoy off the French coast. Watchers believed at least one vessel was hit. Boulogne, on the French coast, was still ablaze from British night bombing.

The British claimed bomb hits on power stations at Kiel and Hamburg, Germany.

Germany, it was disclosed today, has adopted a new four-year plan to be directed as was that recently completed by Reichsmarshal Goering.

Rev. Grant was presented by Dr. R. C. Boyd, local Presbyterian minister, who had charge of the program.

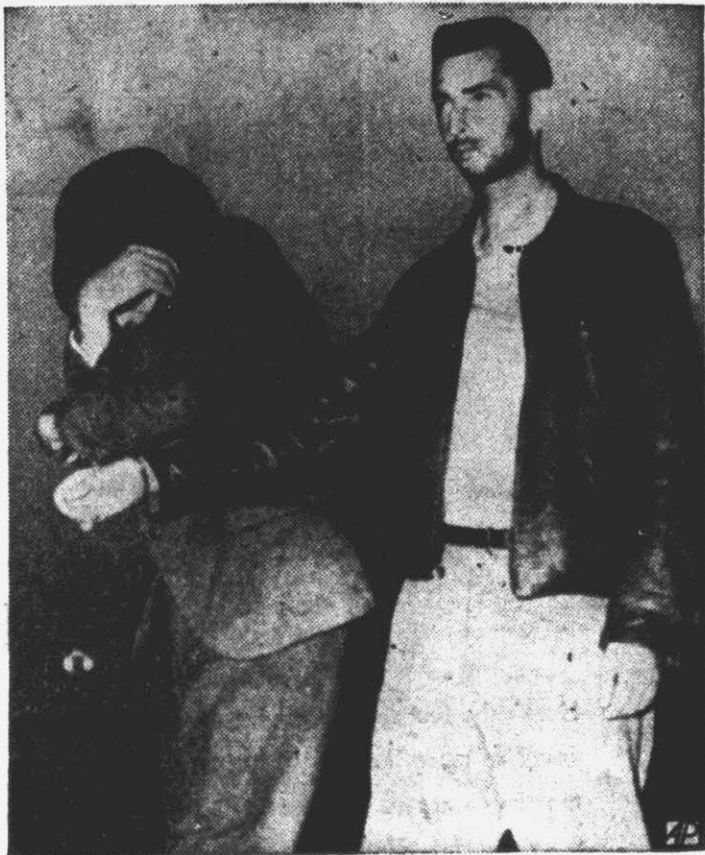
One new member, John F. Holbrook, was inducted into membership. The club also had two guests, Morris Brody and L. R. Bell.

Navy Day Finds Nation Carrying Out Program

Plan Designed To Give U. S. Command Of The Seas

Washington, Oct. 26.—(AP)—An extended observance of the "most momentous" Navy Day, as Secretary Knox described it, opened today with the nation well launched on a program of warship construction designed to give the United States command of the seas.

Although the date officially designated by Knox as "Navy Day" is tomorrow, the navy planned a three-day observance starting this afternoon with the ceremonies here at the monument of John Paul Jones, the Revolutionary war hero and "father" of American sea power.

Training vessels were ordered to receive visitors Sunday and local drills and demonstrations were arranged, but, as was the case a year ago, general visiting to vessels of the fleet and to navy yards was prohibited. Dinners, speeches and other local demonstrations were scheduled for Monday.

The keynote of the occasion was sounded in New York last night by Rear Admiral Clark H. Woodward, commander of the third naval district, who said that within six years the United States would have doubled its naval tonnage and with the fleet thus created should have command of the seas.

NEW CONFLICT IS SEEN OVER FRENCH FLEET

Doubtful Britain To Allow Navy To Fall To Foes

PREDICT SECOND BATTLE OF ORAN

Strategist Also Predict That Britain Will Take Over French Islands In Eastern Waters

London, Oct. 26.—(AP)—

The spectacle of another "battle of Oran" with the British Mediterranean fleet swooping down on Toulon to trap French naval units there before they could put to sea was envisioned today by informed quarters should France agree to cooperate with the Axis powers against Britain.

Strategists also predicted that units of the British navy would attempt to take over French island bases in the Indian and Pacific oceans while Martinique and other French possessions in the Western Hemisphere would be left to Pan-American attention.

There was no doubt in British minds that Hitler's principal purpose in his conference with Marshal Petain, the aged leader of defeated France, was to get his hands on the French fleet which, even after the battering the British gave it July 3 at Oran, Algeria, is better than anything the Axis powers have.

The government, of course, kept official silence on Britain's probable course should the French ships pass to Hitler, but experts cited a feeling which is general in informed quarters that England's powerful navy would immediately try to bottle up the French fleet at Toulon.

U. S. Note Sent To French Officials

Washington, Oct. 26.—(AP)—Secretary Hull said today that President Roosevelt had sent "communication" to the French government several days ago in regard to negotiations now under way between France and Germany and their effect on American interests.

The communication, the Secretary of State said, was dispatched about the time that Adolf Hitler and Marshal Petain had met "somewhere in occupied France" to discuss the possibility of closer collaboration between their two nations.

Hull declined, however, to make public the text of the President's communication or any details of the specific subjects involved.

The secretary, answering newspaper men's questions, said that at the Havana conference the 21 American nations had formulated a policy involving the territories of the Western Hemisphere owned by European governments whose status might be changed by developments in the European war.

New Italian Offensive Is Seen Against Egypt And Possibly In Greece

Fascist War Machinery Geared To Move In More Than One Direction As Suspension Of Air Service To Greece Indicates

Possible Showdown With That Country To Come Soon

Rome, Oct. 26.—(AP)—

The Rome radio said today that a new Italian offensive in Egypt was imminent, while sudden suspension of Italian air service to Greece caused foreign observers to wonder if a showdown with that little nation was not also on the immediate schedule.

The radio said Marshal Rodolfo Graziani's army in north Africa is "now ready and fully prepared to deal a final blow to the British in Egypt."

"The blow," it added, "will fall at any moment."

The newspaper Piccolo said water pipelines had been laid from Libya to the Italian front on the western Egyptian desert and described other minute preparations which the radio said were ready to "last detail."

At the same time the high command reported British warships had shelled but done no damage, to Italian positions near the advanced Italian base of Sidi Barrani.

Numerous patrol clashes have occurred in this area in recent days and the high command told of widespread bombing.

As the Italian military machine apparently was set to move in one or more directions, well informed Italian sources expressed the opinion that an agreement had been reached by which France will give "passive" aid against Britain by permitting use of air bases in unoccupied France and along the Mediterranean and by which she will continue to defend her naval bases against the British.

The air service to Greece was suspended until November 4 and observers recalled that Italian steamship sailings were postponed just before Italy entered the war.

Showdown Fight Follows Lewis Backing Of Willkie

CIO PRESIDENT STAKES OFFICE

Declares He Will Resign If Roosevelt Wins; Says Democratic Victory Will Be National Evil

A showdown fight for the nation's millions of labor votes developed in the presidential campaign today after John L. Lewis, the CIO leader, gave his unqualified support to Wendell L. Willkie, with the assertion that "re-election of President Roosevelt for a third term would be a national evil of the first magnitude."

The Republican nominee who was campaigning in the heart of Pennsylvania's coal fields at Wilkes-Barre as Lewis declared his position, immediately welcomed the statement of support. "I am glad to have the help of Mr. Lewis—a valiant defender of labor who puts his country above all," Willkie said.

Lewis, speaking by radio from his office in Washington last night, stated his position as president of the Congress of Industrial Organization on a victory for Willkie November 5. He asserted that he would resign if Mr. Roosevelt won.

"Sustain me now or repudiate me," he dramatically challenged members of the CIO and promptly in speech and statement other leaders of that organization began to choose sides in the struggle.

In New York, Allan D. Haywood, national organizing director of the CIO, announced that he and many of his colleagues had assured Lewis that they "endorsed his statement and pledged fealty in his leadership."

But in Philadelphia, Alexander McKeown, president, and other high officials of the American Federation of Hosiery Workers, a CIO affiliate, telegraphed Mr. Roosevelt a pledge of "continued loyalty and enthusiastic support."

Similar divisions of political opinions were evidenced in numerous comments on the Lewis pronouncement.

One of the first reactions from Democratic campaign ranks came meanwhile from Daniel J. Tobin, president of the International Brotherhood of Teamsters, American Federation of Labor, and chairman of the National Democratic Labor Bureau.

In a speech in Chicago Tobin said last night that the head of CIO coming out for Willkie had aligned himself with the "enemy of labor."

President Roosevelt faced a weekend of speech-writing and traveling while Willkie undertook a swift round of campaigning in New York (Continued on page six)

Details Of Axis Terms Not Stated

Ministers Approve Trips Of Petain and Laval To Confer With Hitler and Other Axis Officials After Official Report Made To Vichy Cabinet

Vichy, France, Oct. 26.—(AP)—

Marshal Petain of France and Adolf Hitler agreed "on collaboration in principle" for "the reconstructing of peace in Europe" it was announced officially here tonight.

Means of applying the agreement will be examined later, said a brief communique issued after a cabinet meeting.

Hitler and Petain held a "general examination of the situation and in particular the means of reconstructing peace in Europe," it was added.

"The two chiefs of state were in accord on the principles of collaboration." (Informed persons had said last night in Vichy that the German-Italian-French negotiations were a possible prelude to an Axis "peace drive" and that overtures for a cessation of hostilities might be made later through President Roosevelt.)

(A French radio broadcast picked up in New York by NBC declared "France's future position in the new European war has been decided," and added: "France's position will not be on the basis of a conquered nation, but on the basis of a partner with complete equality.")

Later the communique from the ministers themselves said they had unanimously approved the trips which Petain and his vice-premier Laval have made to confer with Hitler and other Axis officials.

Democratic Funds Stated At \$31,876

Raleigh, Oct. 26.—(AP)—North Carolina Democrats have contributed \$23,479.50 to the fall elections campaign and party expenses have totaled \$3,496.62. State Chairman E. B. Denny said today in his preliminary report to Thad Eure, secretary of State.

Later he listed an \$8,396.92 surplus inherited from the former chairman, Gregg Cherry, making a total of \$31,876.62 available for the current drive for votes.

The chairman estimated that the contributions came from 2,700 persons and he compared this with the Republican contribution of \$30,422.77 from 175 persons.

Largest single contribution was \$2,500 from A. L. Bland, Charlotte hotel man whose father, T. L. Bland, was a prominent Republican. The gifts ranged downward to 50 cents. They included one of \$100 from N. N. Harrell of Wilson.

Arrested In N. C. For Failing To Register

Rockingham, N. C., Oct. 26.—(AP)—Special officer J. J. Heeny announced today that he had arrested a man who gave the name of Thomas E. Gorman, 30, on a charge of failure to register for the compulsory military training program. Heeny said Gorman told him he was born in Buffalo, N. Y., and that he was in Omaha, Neb., at the time of registration.

Figures Computed For Draft Quotas

Washington, Oct. 26.—(AP)—Figures to be used in computing draft quotas for 6,175 local board areas throughout the country have been compiled by national selective service headquarters for early distribution to state governors.

Regulations require the army to notify the governors by Monday how many men each state must contribute to the first 30,000 draftees to be inducted into service November 18. The call for men will be distributed by the governors among the local draft boards.

The board quotas will be figured on the same basis as quotas for the states. Figures which will be used in these computations will include estimates of the class 1-A (fit and available for service), manpower of each state and the estimates of the quota credits for volunteers from each state. The latter have been compiled here and will be sent out soon.

A state's quota is the difference between the number of class 1-A men it should contribute to the land and naval forces in existence next July 1 and the number which it already has contributed and will contribute through regular voluntary enlistments to those armed forces.

Bridges Wrecked Over Burma Route

Tokyo, Oct. 26.—(AP)—The Japanese claimed today their bombers had cut the Burma supply route to China completely—at least for a few months—by destroying suspension bridges over mountain gorges in Yunnan province.

A communique said two bridges over the upper reaches of the Mekong river were bombed for an hour yesterday by low-flying planes whose pilots saw the spans dangling in ruins when the smoke cleared away.

The bridges were a weak link in the communications route to Chungking through rough country where there was believed to be no alternative supply route and construction of temporary replacement bridges probably would require several months, the Japanese said.

Oakland, Calif., Oct. 26.—United Airlines plane landed safely with its landing gear retracted after turning back here from Fresno when the wheels locked in the air, the 11 occupants were uninjured. Ambalances and fire equipment which rushed to the field were not needed.

WHAT IT MEANS: Our Arms Program

Washington. — When the first number comes out of the fish bowl in the draft lottery on October 29, the United States embarks on a peacetime program that in five years may increase our military might fivefold, on the average, and make us the heaviest-armed nation on earth.

That's the real meaning behind the simple business of pulling capsules out of a clear glass jar. The draft itself will contribute the most powerful element in the program blueprinted for Congress by the Army and Navy. For, if continued for the five-year period prescribed by the selective service law, it will provide the nation with 4,000,000 trained military reserves.

Those reserves will cost a cool billion dollars a year, or five billion dollars by 1945, not counting equipment, but adding in food and transportation.

Our first line army will number more than 1,200,000 men. It's built on the plan calling for a five-garrison force of 75,000, a coast defense force of 50,000, an air force of 150,000, a mobile army for the continental United States of 800,000 men, and an overhead force (hospitals, administration, replacements, etc., of 125,000).

The reserve will consist of the national guard, assuming it serves only one year, and the selective service men who have served their year.

The biggest step-up in military might will be the air force. From the 7,000 planes we now have in both the army and the navy, we will have jumped to 40,000 planes. We'll have 400,000 men to fix them and run them in 1945, instead of the less than 100,000 now available in a moderately warm place.

Use a small brush to clean out stem and spout of percolators. Thorough cleaning of the pot is essential for good coffee.

Do not over-garish meat platters. When a cut of meat, fowl or fish needs serving and carving at the table, the carver should have elbow room and not be bothered by too many frills.

Tea sandwiches sometimes warrant a frosting to give extra daintiness. Mix together equal portions of white cream cheese and finely chopped pineapple and spread over Boston brown bread or fruit filled sandwiches. Always arrange the sandwiches flat on a tray or truck them around the outside of a platter or basket of sandwiches.

Naval manpower will jump from about 190,000 to more than 500,000 and tonnage from nearly two million tons of fighting ships, to three and a half million tons in 1945.

The program may be altered at any time. The best observers on Capitol Hill, for instance, suggest that a sudden end of hostilities abroad that would also end the threat of totalitarian powers would send most of this expansion program into the legislative wastebasket within a week or two.

Other experts suggest that the immediate threat of war, on the other hand, would find the program stepped up in speed and scope. For instance, it would be feasible to plan for a first line army of 4,000,000 men within two years, if the nation decided to go to war with a definite enemy at a certain time.

The cost of this mighty instrument of war to the taxpayer will be astronomical. No competent bookkeepers have dared yet to reckon it. All you can do is gauge fragmentary costs. It is possible to say, for instance, that Congress has authorized defense expenditures of about \$17,000,000. That may keep parts of the plan moving for about two years.

The cost of the drafted army alone will range close to a billion dollars a year. On that basis the total cost might range around \$40,000,000 in five years.

Assuming that this mighty armed force will not be used to fight, what is its value to the nation?

Primarily it's insurance—at a very high premium. When the ambassador of a foreign power addresses our secretary of state in 1945, he may be talking to the representative of the world's No. 1 military power.

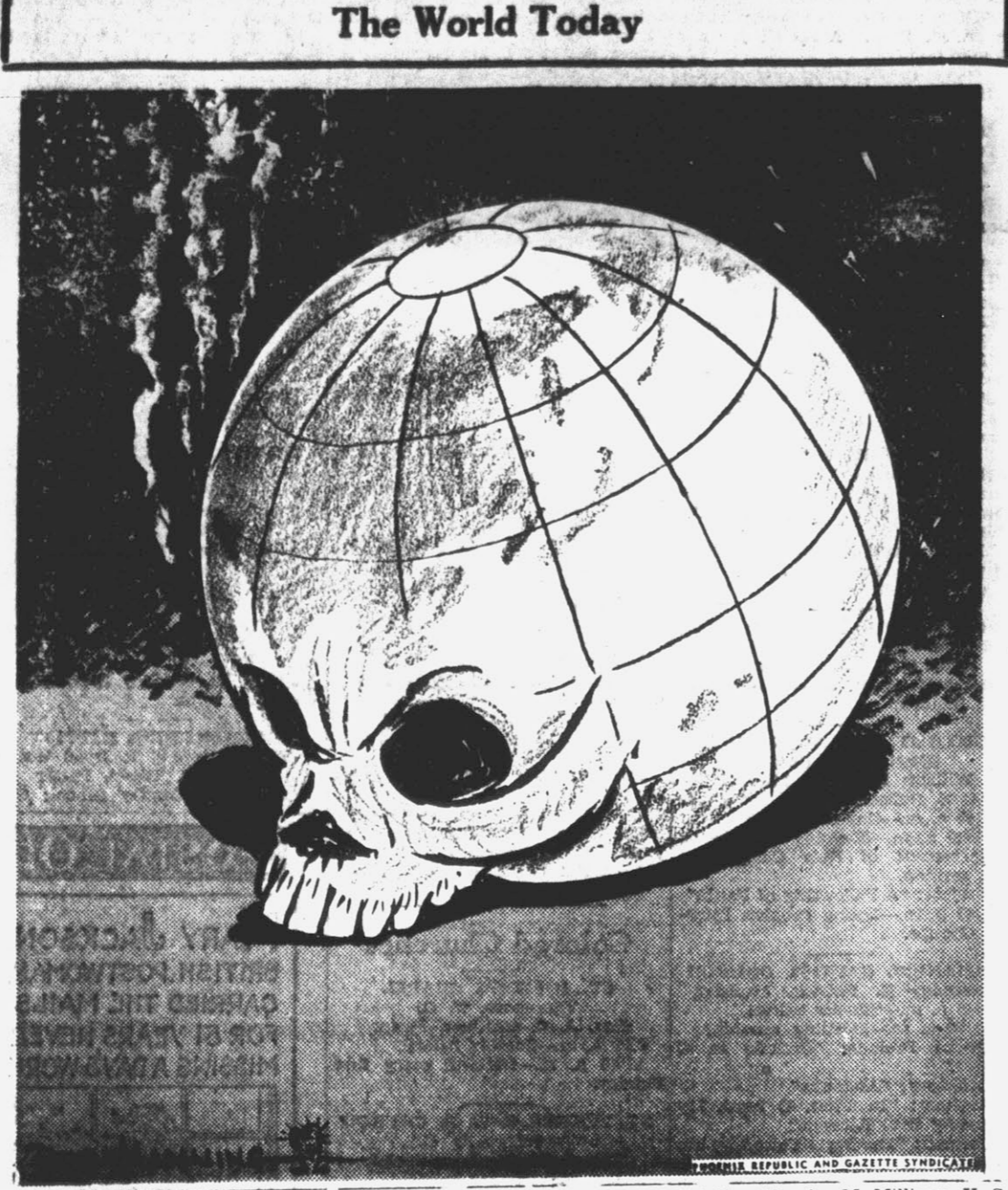

Raleigh, Oct. 26.—The prominent "play" given by many newspapers to a recent ruling of the attorney general that courts have no authority to revoke automobile driving permits is causing the State Highway Safety Division no little anguish these days.

No sooner had the article hit the street than scores of those whose licenses have been taken away from them upon conviction of drunken driving or other kindred offense sat themselves down and wrote irate letters demanding return of their permits.

"You have taken up my license illegally. I want it back immediately if not sooner" was the general gist of these letters.

Of course, none has been returned and none will be. The McMillan ruling was surprising only in that it was given at all. Even a casual reading of the automobile laws reveals that revocation of the license is within the province and purview of the Department of Revenue and not as a direct result of a court mandate.

The result, actually, is the same. A court cannot revoke a license by legal decree; but equally as important, it cannot prevent administrative revocation as an automatic result of conviction for an offense in the category calling for revocation.

Thus the A. G. opinion added nothing to the store of human knowledge, not charged by so much as a jot the status of anyone whose license has been revoked as an aftermath of conviction in a court of North Carolina or other state.

Even the Supreme Court, which probably takes fewer legal holidays than any other government agency, will not hold a session on election day. Oral arguments scheduled for that day will be heard the next.

One extra point missed on the first Greenville touchdown gave the Mock boys a 14-13 victory, over Parley's boys.

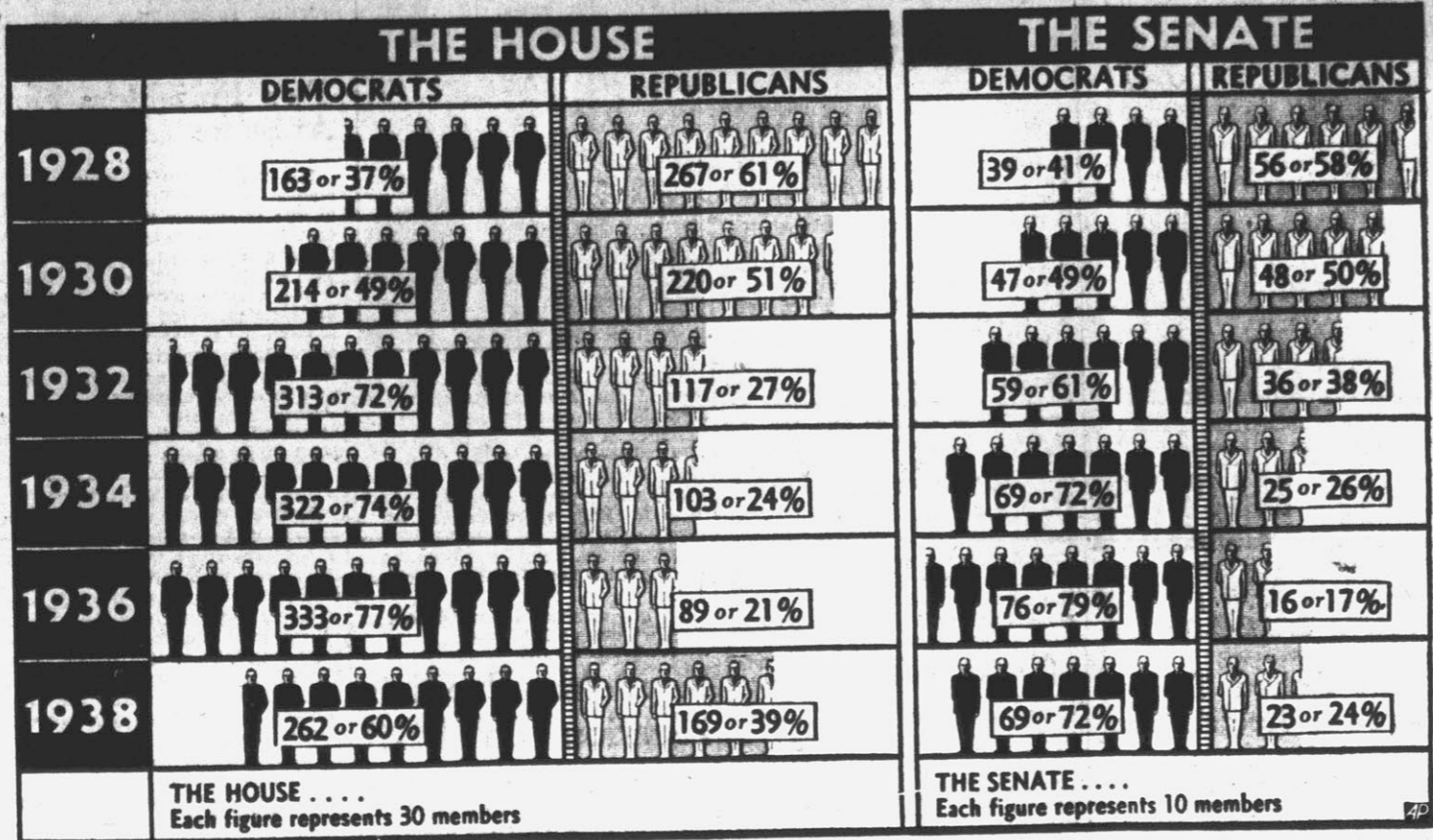

U. S. LABOR ACT AFFECTS MANY

60 Pitt County Firms Under Wage-Hour Rules

By HENRY AVERILL
Raleigh, Oct. 26.—More than 100,000 employees in 36 counties served by newspapers maintaining this bureau must now be paid at least time and a half their regular rate of pay for all hours worked in excess of 40 in any work week under provisions of the Fair Labor Standards Act (Wage-Hour law).

These figures were given your reporter by Major A. L. Fletcher, regional director for the wage and hour division in the Carolinas.

Major Fletcher made it clear that not all the 1,775 firms and 109,264 employees would, therefore, make changes in their present wage or hour status. Many of these concerns are already operating on the 40 hour week standard. With those already under the law, the only difference will be that the overtime is now a matter of law, rather than agreement or voluntary action of the employer.

The maximum work week without overtime pay became effective October 24. Previously the standard was 42 hours.

The minimum rate of pay for all industries covered by the act (those engaged in interstate commerce) is 30 cents per hour, except for industries in which the rate has been made higher by wage orders. Eleven wage orders calling for minimum of from 32 1/2 to 40 cents per hour have been established for the manufacture of textiles, clothing, paper and leather.

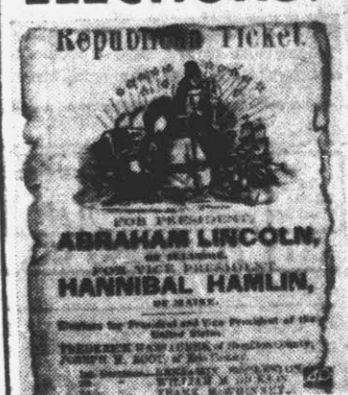

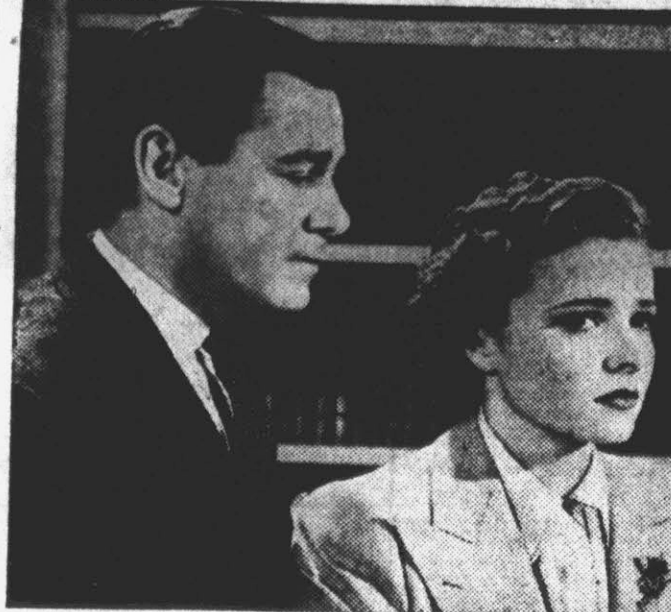

know that I never side-step a scrap. I thrive on trouble. Give me some new upset to face each day and I am a happy man. I am no pacifist in business, religion, or war; and I am all set for any actual participation in the current fight abroad. But I also know that when our enemies suffer in the end.

Dividends may increase, but total incomes of business men and investors will be drastically reduced by taxes. Even war talk and a feeling that the right side is winning brings increased activity in the stock market. The demands for labor will put more money into the pockets of the man on Main Street and into the tills to stores. Only unbiased historians years hence will be able to judge whether or not wars ever provide lasting economic values. Surely real prosperity can come from our present situation only as it strengthens our character and teaches us needed lessons.

Let's Remember 1929

Unfortunately, we have not yet recovered from the effects of the last war. Furthermore, fundamentally, we profited little from it, either financially or spiritually. We had a slump in business, after the armistice, followed by several years of rising values. Then came the swift kick in the pants so many of us remember. Now, we are on the eve of another great outbreak. God grant that it will not come before we are prepared.

Our country is like a sick child who before recovering from an ear-ache breaks out with chicken pox. We are not yet out of the depression starting in 1929. Temporarily, the economic situation will ease up, winning us to a false sense of security and prosperity. Geographically our country is so large, and our numbers and resources so great, that many have the impression we cannot be licked. However, in Hitler's eyes we are already tottering from internal labor troubles and Congressional fights.

Prosperity Best Defense

Germany now has the great bulk of the resources of the Continent, let alone the Scandinavian countries. With this backing, anything can happen to us economically. One saving grace is that in all history no man has yet conquered the world. If I have learned anything in the past forty years, it concerns man's frailty. Some day a leader will rise in some other country who will be Hitler's match. Until then, we must keep prepared economically, as well as militarily for whichever way the tide turns.

I may sound like an alarmist. If so, forgive me. I am anxious only that we Americans are not caught sleeping, economically, at all will realize the price our young people must some day pay for the present expenditures and brief respite from unemployment. Hitler has no idea of invading the United States as long as our people are prosperous. He, however, believes,

SLOT MACHINE CASE COMES UP

Court Asked To Determine Legislature Intentions

(By The Associated Press)

Raleigh, Oct. 26.—North Carolina's Supreme court will be asked this week to rule affirmatively that the intention of the 1939 General Assembly was to modify the Flanagan Anti-Slot Machine act when it adopted a much debated section of the Revenue Act providing for a license tax on certain types of slots.

It will be a good trick, if the court can do it. Not even the legislators who enacted the law knew what they meant—practically all of them admitted that, and certainly not two judges or lawyers have been able to get together in any agreement on the proposition since then. It has even been openly charged and vigorously denied, that the real intent of the law makers was to bring about just such a state of confusion as has come about.

Be that as it may, Aaron Goldberg of Wilmington and Brantley Womble of Raleigh, counsel for E. Laing and J. N. Finch, convicted slot distributors, are going to argue to the court Tuesday that the legislative intent was to modify the 1937 law to the extent that machines of the type in question (the type which both defendants admit they handled) would be legal and licensed by the state of North Carolina.

The appeals (there are technicality four cases against each defendant but the question is the same in all) are out of the ordinary in that they are from pleas of guilty in lower court. Now it is argued that the matter to which the pleas were entered does not constitute an offense.

Finch's counsel also advances the argument that his client's conviction is invalid because his name does not appear in the body of the indictment against him.

The men were sentenced to prison on terms on their guilty pleas—a fact which in all likelihood accounts for the appeals. They had probably expected fines and were prepared to pay them and go on their way, perhaps not rejoicing, but to go on their way just the same.

They were caught, however, in the midst of the drive North Carolina superior court judges agreed they would launch against illegal slot machines, and Judge R. Hunt Parker passed out the road sentences—twelve months for Finch and eight months for Laing. Finch is alleged to be an associate of Joe Calcutt, the Fayetteville slot tycoon who is now under heavy bond awaiting trial here in November.

Lawyers and laymen alike express more than a little interest in getting the Supreme court's ruling on the exact meaning of the 1939 Revenue Act provision regarding slots. Does it, or does it not amend, or repeal, in part at least, the Flanagan act?

There is considerable skepticism however, over the ultimate value of even a clear cut decision on the matter. It is almost time for another General Assembly to convene and cynical souls are already predicting that the 1941 law makers will undo anything the courts may do in the matter of clarifying the situation. Every Assembly practically, in the last decade has tinkered with the slot laws, and each time the tinkering has permitted the slot racketeers to reap another harvest from suckers all over the state. It is almost certain there'll be action again next year.

The eight slot cases top a very tight calendar for oral argument in next week. Two other criminal cases, one from Franklin the other from Wake, and five civil appeals all from Wake, are listed.

Swiss Government Checks Movement

Bern, Switzerland, Oct. 26.—(AP)—The Swiss government moved today to suppress a widespread fascist totalitarian organization called the Swiss Union of Friends of Authoritative Democracy with simultaneous raids in a number of cities resulting in numerous arrests of alleged officials and employees.

The number of arrests was not disclosed, but a government communique said "all officials of the organizations, residents in Switzerland," were seized. They were charged with violating the Swiss law for protection of the nation's democracy.

19.22 AVERAGE PAID FOR WEEK

Prices Stronger At Close Than During Mid-Week

Official figures for the last marketing week shows that the Greenville tobacco market sold 4,937,008 pounds of tobacco for \$94,737.34—an average of \$19.22 per hundred-weight.

The week's figures show that much inferior grade tobacco is being sold on the market now. During the previous week 5,423,112 pounds were sold for \$1,148,171.21—an average of \$21.17.

While prices were "easy" several days last week, the decline in the average was largely due to a decline in the quality of tobacco offered. Many farmers sold the last of their crop during the week, resulting in a large quantity of non-descript leaf being sold on the market.

Season's sales to date total 41,538,324 pounds, which brought \$7,426,210.29 for a season's average of \$17.86, a figure \$1.95 higher than the average paid for the 53,105,377 pounds sold up to the corresponding date a year ago.

All warehouse floors were cleared Friday and sales will be resumed according to schedule on Monday.

The daylight raids on London today were brief.

London, Oct. 26.—(AP)—London's eighth air raid alarm of the day—quelling the record of the war—was sounded just after nightfall after a day in which German planes struck almost continuously at southeast England and the capital city.

Most of the alarms were brief, but the raids came with clock-like regularity and at short spaced intervals.

During many of the raids, however, there was no bombing in London.

Four German planes were shot down today and one last night, the Air Ministry reported.

Warns Britain Of Possible Invasion

London, Oct. 26.—(AP)—Field Marshal Sir Cyril Deverell warned Britain today against the possibility of a German invasion during the long winter ahead.

New York, Oct. 26.—(AP)—Senator Robert R. Reynolds (D-N.C.), returning from a defense inspection tour of the Panama Canal Zone and South America, predicted today the re-election of President Roosevelt "regardless of the attitude of John L. Lewis."

Reynolds, interviewed aboard the liner Argentina, said he found South Americans "extremely anxious" to see Mr. Roosevelt re-elected because "he has given attention to matters below the Rio Grande and his great naval policy has developed a splendid friendship with South American nations."

Turning from domestic to international affairs, he said: "There is no doubt about the great German influence in South America, but I was appalled that it was not more, when you consider that the Germans have been settling there for the last 350 years."

He said the German consulate staff in South America had been steadily increasing and "that they were working to build up Nazi influence. Despite German propaganda, he said, he was convinced the United States held the balance of influence."
