ITALIAN "BIG PUSH" REPULSED BY GREEK FORCES

HARD BATTLES PRESAGED FOR NEW CONGRESS

Republicans Expected To Offer Stiffer Competition

WILLKIE TALKS MONDAY NIGHT

Says He Feels Obligated To State Position In View Of Fact So Many Backed His Candidacy

Washington, Nov. 8. (AP)—Resurgent Republican strength, reflected in the steadily growing total of Tuesday's presidential vote, presaged today some stiff political tussles over domestic issues in the months ahead.

As new tabulations swelled President Roosevelt's third term vote to greater proportions and simultaneously raised Wendell L. Willkie's record Republican ballot total, it became increasingly clear that on many policies the Democratic administration in the next four years would face a more determined and enthusiastic opposition than in the last eight.

President Roosevelt gave no indication in his campaign of contemplating a major program of new legislation for submission to the next Congress in January.

In fact, he told the voters that his first two terms had been given to launching what he considered necessary reforms and his third term would be devoted to forwarding those accomplishments while helping the nation weather the great world storm now raging.

The first broad statement of Republican plans to be made since the election will be given by Willkie Monday night in an address broadcast from New York. Willkie said that "in view of the fact that between 22,000,000 and 23,000,000 people voted for me, I feel an obligation to state my position."

Latest tabulations of the election results, meanwhile, gave this picture of the standing of the two candidates with 120,444 voting units already counted out of 127,245.

President Roosevelt carried 38 states with a total electoral vote of 449. His popular vote stood at 26,365,134.

Wendell L. Willkie carried 10 states with a total electoral vote of 85. His popular vote stood at 21,287,102.

Two Stills Found Near County Line

ABC officers of Pitt and Martin counties yesterday afternoon located and destroyed two liquor stills in the latter county near the Bethel Oak City road. Both stills were found in the same woods.

One was a 50-gallon steam plant at which 400 gallons of mash ready for distillation was found. The officers destroyed the mash, a 50-gallon condenser and a 15-gallon doubler.

The other, in the Hassell section, did not appear to have been operated in some time. Five hundred gallons of spent mash was found at the plant, which was of 200-gallon capacity. Officers also found two 500-gallon fermenters, two 50-gallon doubler, two 50-gallon condensers and a 50-gallon steel drum used as a boiler.

BRITISH PLANE ORDER OKEHED

Priorities Board Permits Sale Of 12,000 Craft

Washington, Nov. 8. (AP)—The priorities board announced today that the British Purchasing Commission would be permitted to negotiate orders with the American aviation industry for an additional 12,000 planes.

The action was announced shortly after President Roosevelt told his press conference he had established a rule of thumb policy, whereby Britain and Canada would be supplied 50 per cent of American defense items now coming off factory lines, including large bombers and other things needed both here and abroad.

The 12,000 planes, the board said, will be built in existing plants and in other facilities now being developed.

Great Britain already has orders in effect in this country for 14,000 planes. President Roosevelt said in his Boston campaign address last week. At the same time he had announced that Britain had asked permission to order 12,000 additional planes.

The board said today it was intended under plans now being devised to gear construction of the British planes to American production in such a way as to prevent interference with American defense requirements.

"The question of delivery priorities is being studied," the board said. "They will be fixed at appropriate times as production progresses."

There was no announcement as to when the ships might be ready for delivery.

At his first press conference since he was elected to a third term, Mr. Roosevelt also reported that American and Mexican army officers have carried on conversations regarding joint defense similar to those with other Latin-American countries.

Board, Deadlocked At Four-Four On Alderman J. A. Watson And L. G. Cooper, To Meet Again Monday Night; Mayor Spain's Resignation Already In Effect; Other Business Disposed Of

After taking four ballots to fill the unexpired term of Mayor Jack Spain, who resigned to accept the position of secretary to Rep. Herbert Bonner, the Greenville Board of Aldermen appeared hopelessly deadlocked at four-all on the two remaining candidates and recessed to meet again Monday night.

The two candidates remaining in the race after four ballots were taken were Alderman J. A. Watson and L. G. Cooper, local attorney.

The names of five men were put up on the first ballot. They were Mayor Pro Tem R. E. Sellers, N. O. Warren, Alderman David A. Evans, Watson and Cooper. The voting soon was centered on Cooper and Watson, however, and the board, seeing no hope of breaking the deadlock, decided to postpone the balloting until Monday night.

Indications today were that a "dark horse" would be required to break the deadlock and the name of B. B. Sugg was mentioned in some quarters as a possibility.

The question of naming a mayor to fill the term of Mr. Spain, which ends next June 30, came up after the mayor had tendered his resignation shortly after midnight following the completion of all regular business facing the aldermen.

The resignation took effect immediately and Mayor Pro Tem Sellers took the chair. A rising vote of thanks for his services was tendered to the retiring mayor.

Alderman J. A. Collins moved that Mr. Sellers be appointed mayor and Alderman J. A. Simpson seconded the motion. Mr. Sellers asked that the motion be withdrawn, but his name appeared on the first ballot nevertheless. Mr. Cooper received four ballots on the first ballot but lacked a majority and as the balloting continued the other four members swung to Mr. Watson.

Supporting Mr. Cooper were Aldermen George A. Clapp, Sellers, Evans and Collins, while Aldermen Simpson, M. B. Massey, Watson and L. B. Fleming voted for Watson.

Several other matters were disposed of during the earlier part of the night.

President's Estimate Below His Total Vote

Washington, Nov. 8. (AP)—President Roosevelt disclosed today he had been way off in his guess on the election outcome.

He told his press conference he had forecast 340 electoral votes for himself. The way the returns stood today he had won 449 and Wendell L. Willkie 82.

The 340 forecast was exactly the same he had made on August 2 before the 1936 election. That year he won 523 electoral votes, Alf M. Landon eight.

GERMANS INTENSIFY RAIDS ON SHIPPING

Berlin, Nov. 8. (AP)—German surface warships operating on Britain's vital North Atlantic supply lines from Canada and the United States were reported today by the high command to have "destroyed completely" a British convoy consisting of 86,000 tons of shipping.

The communiqué did not amplify the announcement, but informed quarters said that the convoy was made up from 15 to 20 commercial vessels.

The convoy was said to have been heavily guarded by British warships. (On November 5 the 16,638-ton British liner Ranitiki radioed that she was being shelled by a German pocket battleship about half way

between Ireland and Newfoundland and a little later the British freighter Cornish City, 4,952-ton, sent a similar message of distress. The messages were the last received from the two vessels.)

Informed German sources belatedly commented that Germany had dealt a hard blow to Britain's vital North Atlantic lifeline.

For the last two days German reports have told of a growing aerial offensive against British shipping as a supplement to the counter blockade by U-boats and surface raiders. Germans boasted that their planes had carried their recent attacks more than 300 miles west of Ireland into "regions where hitherto the enemy felt safe."

PART HOLIDAY SPEED-UP FOR FOR ELEVENTH ARMY PLANNED

Further plans were going forward today for the Armistice Day program to be conducted at the Austin auditorium of the college Monday, when a partial holiday will be observed throughout the city.

The banks, warehouses, court house and other public offices and the ABC stores in the county will be closed during the day and the post office will provide only curtailed service. No deliveries, either city or rural, will be made and the windows will be closed.

The Board of Aldermen met in regular session but the question of closing city offices was not discussed.

The Armistice Day program will follow a parade. Robert Lee Humber, who recently returned to his native Greenville from Paris, France, will be the principal speaker.

The parade will form at the Norfolk Southern depot, proceed along (Continued on page six)

NEW TALK OF ADJOURNMENT FOR CONGRESS

Chances For Enactment Of Pending Legislation Slim

MAY QUIT IN NEXT 10 DAYS

Adjournment Would Kill Four Major Proposals, Including Amendments To Wagner Labor Act

Washington, Nov. 8. (AP)—Prospects for the enactment of a half-dozen pending major legislative proposals slumped today as Congressmen, the election over, showed a marked inclination to wind up this session's business by a sine die adjournment within the next 10 days.

Even should a formal request materialize by Secretary of the Treasury Morgenthau for additional taxes and an expansion of the federal borrowing authority, it appeared unlikely that it would sever Democratic leaders from a determination to put off further work until January—a determination that found sympathy with some Republican chiefs.

An adjournment now in effect would kill four house-approved measures and at least two important resolutions pending in the Senate.

Supporters of Wagner act amendments, the Logan-Walter Bill to facilitate court appeals from the decision of government agencies, the anti-lynching measure and the Ramspeck civil service bill would lose the ground they gained in winning House passage of these measures and would have to start all over again in the next session.

Only the Ramspeck bill which would permit the President to bring approximately 200,000 employees of so-called "governmental agencies" under civil service, was in a slightly different category from the others since it was approved in varying forms by both the house and needed only the completion of a satisfactory compromise to win final passage.

The other three measures were waiting Senate action, along with a proposal by Senator King (D-Utah) to relax legal restrictions to permit the extension of credit to Great Britain and a resolution by Senator Tydings (D-Md.) to investigate the government fiscal setup with a view toward recommending an approach to a balanced budget.

Strike Voted For Airplane Factory

Los Angeles, Nov. 8. (AP)—Wynham Mortimer, international organizer for the CIO's United Automobile Workers union, said today the membership of over 3,500 had voted "overwhelmingly" in favor of a strike at Vultee Aircraft, Inc.

It was the first move of its kind in an airplane factory here since the recent industry speed-up for defense.

At issue is a union demand for an increase of the minimum wage from 50 cents to 75 cents an hour.

Raleigh, Nov. 8. (AP)—The State Highway and Public Works Commission today decided that the Winston-Salem-Snow Hill highway should be routed over what is known as the Castoria route, with at least two connecting links to another road known as the Creek route.

BUDGET NEEDS ARE OUTLINED

Requests Are Presented By Various Departments

Raleigh, Nov. 8. (AP)—The State School Commission presented its record request to the Advisory Budget Commission today, listing \$28,590,924 as needed for 1941-42 and \$29,277,833 for 1942-43 for the eight months school term.

If a five per cent salary increase is allowed for teachers, the Budget Commission was told, that more than \$29,342,000 would be necessary for 1941-42 and in excess of \$30,390,000 for 1942-43.

The request for school funds of all kinds, for vocational education, the Department of Public Instruction, etc., exceeded \$29,500,000 in 1941-42 and \$30,501,000 for 1942-43.

The Budget Commission had revealed yesterday that requests had been made for \$96,945,000 in appropriations for the 1941-43 biennium, compared with estimated costs of \$84,223,000 this biennium.

This afternoon the Department of Conservation and Development requested \$214,501 for each year of the next biennium, an increase of \$104,000 yearly, plus \$125,000 for state advertising each year. The biggest increase was the item for forest fire protection which was put at \$85,500.

The State Board of Health asked \$728,903 for each year of the biennium, compared with \$370,068 spent last year and \$377,294 estimated for this year.

Nazi Bombers Hit British Shipping

Berlin, Nov. 8. (AP)—Dive bombers in Germany's counter-blockade forces sank 31,000 tons of British shipping space today, an informed German source declared tonight.

The sunken ships, this source asserted, included four merchantmen totaling 20,000 tons which were bombed in an undisclosed area and two merchantmen totalling 9,000 tons sent down "somewhere west of Ireland."

Besides the sinking, it was said, 23,000 tons of shipping was damaged and the final reports were expected to raise the totals.

Big Formations Of Fascist Planes Said To Be Attacking Greek Troops; Italians May Strike At Salonika Through Yugoslavia; Britain And Germany Continue Aerial Assaults

(By The Associated Press) Greek victories all along the 100-mile Balkan war front were reported by Athens today with Italy's "big push" in the northwest repulsed and other Italian columns thrown back in the center and northeast.

Dispatches from the nearby Yugoslav border said fighting in the northeast was intense, with heavy artillery action on both sides.

Big formations of Fascist bombing planes were reported attacking the Greek troops east of Koritza-Phlorina highway and pounding Greek mountain fortifications.

Three Italian divisions, armed with far superior equipment, were reported pitted against seven Greek divisions.

Advices from the battle zone said the Greeks' guerrilla tactics were making sharp inroads against the massed Italian mechanized onslaught.

The Greek high command said flatly that Italy's forces attempting to knife through the Metaxas defense line in a drive toward Iannina had been repulsed by Greek artillery and anti-tank guns.

"The situation is thoroughly satisfactory," a Greek government spokesman said.

In Istanbul the semi-official Turkish radio said the "Italian failure" in Greece might open the way to Axis action in Yugoslavia—presumably to strike at Salonika via Yugoslavia.

The German high command acknowledged that Royal Air Force warplanes attacked "some towns" in the Rhine province during the night, damaging houses and killing and wounding an undisclosed number.

Belatedly the British disclosed that the historic tower of London had been hit by bombs in recent raids.

Invading air raiders attacked London and widely scattered areas of England, following up a night of blows which British reports said apparently were aimed at Britain's industry, transport and civilian morale.

British planes engaged the invaders high over one London area. Raiders also were reported over the Midlands during the morning.

Celebration Held On Rise Of Nazis

Munich, Nov. 8. (AP)—In the presence of Adolf Hitler, the Nazi party's old guard today celebrated the memorial day for the party's rise to power.

Hitler addressed the gathering tonight, according to the official announcement, which added that the text of his speech would be made public Saturday at noon.

In New York, the National Broadcasting Company, which had scheduled a broadcast of the speech from 1:15 p. m. until 3 p. m. EST, announced that word had been received from Berlin that the broadcast had been cancelled. This indicated a last-minute change in the German government's plans for giving the address world publicity.

RAF Successes

London, Nov. 8. (AP)—The Air Ministry said tonight that "18 enemy planes were destroyed" today as against four British fighters, two of whose pilots were saved.

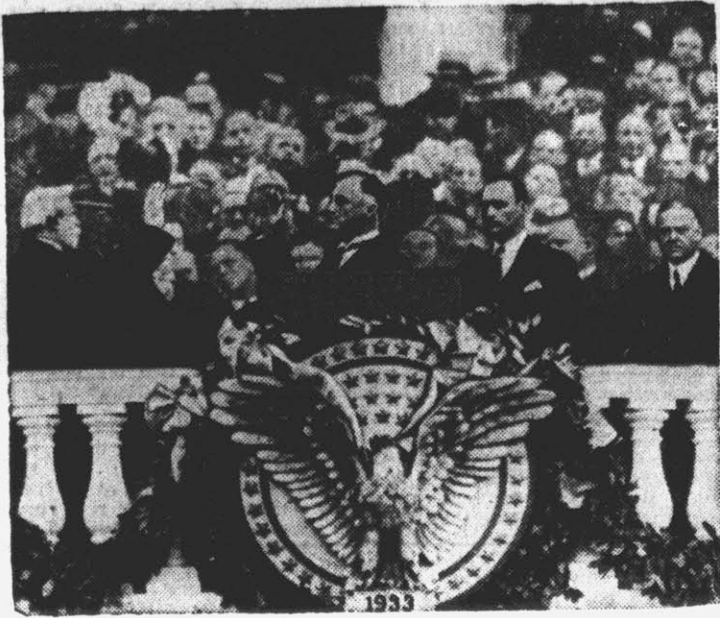

Washington—President Roosevelt pressed right in 1938 and won a third term in 1940.
The Republicans guessed wrong in January, 1938, and lost in 1940. That's the conclusion of many impartial observers. They base it on the general theory that the threat of war led voters generally to support experienced President Roosevelt despite the fact that he ran in violation of the third-term tradition.
The observers thumb back through 40,000 pages and almost three years of Congressional Record for their evidence.
The President guessed, on January 3, 1938 (Page 6, Volume 83, part one, Congressional Record, 75th Congress) that world troubles would be uppermost in the minds of American voters in November 1940, and not domestic difficulties.
Wallace Vs. McNary
Ten days later, Bertrand Snell speaking for the Republican party (Page 184, Volume 83, Congressional Record, appendix, 75th Congress) guessed exactly opposite.
There were, of course, other strong undercurrents that helped to spell victory for the Democrats. Vice-presidential candidates Hen-

ry Wallace and Charles McNary sort of cancelled each other out in the critical western farm states, prevented a Republican slide there.
New Deal publications may have played a part. For instance, the Federal Works Agency's "Millions for Defense" pictured New Deal relief spending for defense in the depression years, well ahead of the national alarm of 1939. "Technology on the Farm," by Henry Wallace's department of agriculture, outlined a 10-year program further accenting help for the poorer farmers of the nation. And a report by the Securities and Exchange Commission added up the hundreds of millions of dollars of family holdings by the Fords, duPonts, Rockefellers, Mellons, etc.
Then there was the relief vote, generally regarded as a reservoir of strength for the party in power, and votes from several big city political machines, like the Kelly-Nash set-up in Chicago, and from the solid south.
But the big element still remains the threat of war.
Started In '37
The story of how the Democrats won begins with Christmas week in 1937. Another economic setback had the country by the throat. Steel production had dropped 70 per cent in

a few months. Automobile sales were bogging. Business and government were alarmed.
Suddenly two New Deal minions, unity-fighting Bob Jackson and general handy-man name-caller Harold Ickes, launched the Administration's bitterest attack on big business. Jackson accused the nation's tycoons of a sidown strike against the New Deal. Ickes attacked the nation's "sixty-families."
"A-ha," said the experts, "the President's getting ready for another attack on business. Ickes and Jackson paved the way. The boss will follow up with the main onslaught in his speech to Congress on the state of the nation."
But the President surprised everybody, perhaps even Ickes and Jackson. He made no attack on big business on January 3. Instead, he opened up with a carefully-worded attack on aggressor nations. He supported the other democracies. He advocated "adequately strong self defense." And finally he appealed to business, labor, and agriculture "to demonstrate national unity in a world of high tension and disorder."
He Saw War Clouds First
The Republicans waited 10 days then sent Snell to the radio for the official reply. Through 3,500 words

almost up to the last paragraph of his speech, Snell concentrated on the domestic scene—the "depression," the "11,000,000 unemployed," the "17,000,000,000 worth of Roosevelt public debt," the "damstraining" reform laws.
Snell dismissed the clouds of war with one oddly-worded sentence:
"Above all, we oppose the continual preaching of war against and hate among our own people."
From then on out, the New Deal marked time on domestic issues, offered fewer and fewer reforms, more and more big defense plans. Republicans multiplied their attacks on spending, extravagance, and in a final splurge, took a business man to head their party ticket in 1940—the one big business man who had throughout the New Deal championed business against "big government."
As war spread, the Republicans supported defense and conscription but charged the President with a slow administration of defense, and insisted he was leading the country toward war. Willkie also talked up to the dictators as the campaign swung into its climax.
But all this came late.
The margin of Roosevelt victory was established in 1938 because he saw the war clouds first.

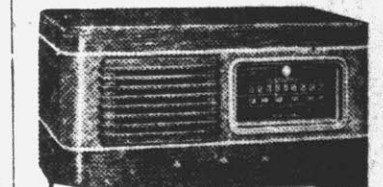

Washington
Daybook
By Jack Stinson

Washington.—If Italy, in its at-
tempted blitzkrieg on Greece, starts
raining bombs on Athens, it will be
the destruction of what nearly all
American continental travelers re-
fer to as "the most superficially
American city in Europe or Asia."

This is a phrase that needs some
explaining, but it boils down to the
fact that there are few if any cities
on the continent where an American
can feel so much at home as in
little Athens in a foreign land.

Almost daily now, I find news-
papers, foreign service officials,
former tourists shaking their heads
sadly over the prospective plight of
Athens and recalling visits to the
metropolis of the Aegean as their
happiest days abroad. Why?

Because at the kiosks on the
streets of Athens, you probably can
buy more American newspapers and
magazines than anywhere else out-
side this hemisphere. On the Athi-
nais are at least a dozen news-
where neon lights boldly announce
Hollywood films in American and
without the bother of Greek sub-
titles. In the drug stores you find
all of the locally nationally-adver-
tised brands of toilet articles. In the
restaurants, you can see Ameri-
can food cooked in the Greek-Ameri-
can manner. In the groceries you can
buy American canned goods and in
the shops and department stores are
wares bearing American labels.

Tops Them All
I have no intention of exaggerat-
ing this Athens, Greece, is not
Athens, Ga., but I haven't talked
to a traveler here who hasn't com-
mented that it is probably easier to
get by in Athens, Greece, without
speaking a foreign language than
in any of the continental cities.

The reason for all this is simply
that probably more Greeks than any
other nationality have come to
America to make their fortunes
large or small, and returned to live
out their days and rear their fam-
ilies in the "old country." Living is
so cheap (or at least has been down
through the years) that a man
with a few thousand dollars can re-
turn to his little village buy a small
farm, a cow, goats and a few olive
trees and live like the king of his
community. These affluent repatri-
ates, having gotten a taste of Ameri-
can life, demand such things as
western and detective stories, a copy
of the "old home town" newspaper,
American movies, and a few luxu-
ries such as American toothpaste
scented soap, ten-cent lipstick.

Lived At Little Rock
A friend told me this story. She
was traveling less than two years
ago in the mountains where the
people have been hearing the thun-
der of guns. At a little village, the
party stopped and she hiked off
alone to a tiny house that topped a
nearby crest. There was a half a

dozen children about and when
they found that the lady came from
America, they insisted that she wait
to meet their father. Soon he came
and in the heartiest Americanese
that ever rolled over the Ozarks
told his visitor that he had lived for
10 years and amassed "his fortune"
in the "greatest little city in the
southwest." Little Rock, Ark.

All over Greece, from Crete to
Macedonia, it is the same. The con-
dition is enhanced no doubt by the
fact that there is a conflict in our
naturalization laws and Greece does
not recognize an American natural-
ized citizen. If he returns to Greece, many
now are finding out about that.
Having returned to the old country
they are being inducted into their
service, regardless of their Ameri-
can naturalization papers.

Acropolis And Parthenon?
There is one other point that for-
mer tourists to Athens are wonder-
ing about. Will the Axis, raining
bombs from the sky above Athens,
blast the Acropolis and complete de-
struction of the Parthenon which
was started by an Italian and a
German just 253 years ago?

Promises Investigations Of Labor Law Complaints

Reflector Bureau.

Raleigh, Nov. 6.—Major A. L. Fletcher, regional director of the Wage-Hour division for the Carolinas, today moved to clear up a misapprehension which seems to exist with reference to investigation of complaints regarding alleged violations of the Fair Labor Standards Act.
Because the division has been sending forms—known as AD-85's—to employers, asking them if they are in compliance with the law, there has been a prevailing impression that the director takes no other action than to ask the alleged offender if he is violating the law—a proceeding which would be the height of futility if unaccompanied by any other form of investigation.
Today Major Fletcher explained that regular inspections will be made of establishments against which complaints have been made. These inspections will follow use of an AD-85 procedure by which the employers are asked to fill out forms showing whether or not the complaints have been justified.
The AD-85 has been used to disseminate information about the act to employers, the director said.
It is believed, Major Fletcher added, that use of this form has proved advantageous to all concerned, although he took pains to emphasize the fact it is no substitute for rigid inspection and investigation.
It has, however, speeded up the division's work; has resulted in payment of thousands of dollars due

employees from establishments which had failed to live up to the provisions of the act because of failure fully to understand these provisions; and has enabled reputable establishments to enter their statements showing they are in compliance, Major Fletcher said.

"Regular inspections which are to follow use of the AD-85 procedure will result in giving quickly a clean bill of health to those reputable establishments where the inspections back up the statements of compliance," Major Fletcher said.
"The basic information contained in these statements will enable inspectors to make their investigations much more quickly and with a minimum of trouble to the employers."
"I know in my own mind that the great majority of these employers have filled out this fact will save them the trouble of long drawn-out inspections which would have been necessary without the use of the AD-85 procedure."
"On the other hand, we know that as long as there are laws, there will be some evasions, and we have al-

ready received complaints that some of the firms which have filled out the AD-85's have resorted to evasions in their statements.

"For the protection of the reputation of the firms as well as for the employees, full inspections will be made of these establishments which have resorted to evasions."
"It will take our trained inspectors a very short time to determine such evasions."

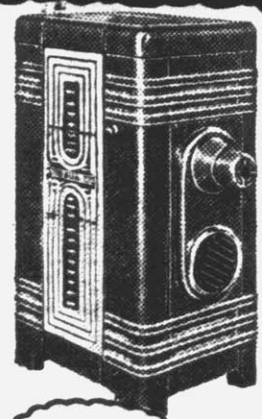

Washington, Nov. 8.—(AP)—The Agricultural Department today estimated this year's cotton crop at 12,847,000 bales of 500-pound gross weight, compared with 12,741,000 estimated a month ago, 11,817,000 produced last year and 13,547,000 the 1929-1938 10-year average.
The indicated yield of lint cotton is 25.1 pounds to the acre, compared with 25.0 pounds indicated a month ago, 23.7 pounds produced last year and 19.1 pounds the 10-year average.
The census bureau reported that cotton of this year's growth ginned to November 1 totaled 9,083,628 running bales; compared with 10,079,112 bales ginned to that date a year ago, and 10,124,773 two years ago.

The acreage of cotton for harvest this year was 24,406,000 acres. The report for North Carolina indicated an acre yield of 434 pounds and a production of 740,000 bales. The Census Bureau's report on ginnings to November 1 by states included North Carolina, 545,994 bales as compared with 400,583 by the same date last year.
