BULGARIA REPORTEDLY WARNED BY GREAT BRITAIN

ALL ATTEMPTS TO ALTER BILL ARE DEFEATED

Democratic Majority In Control Of Lend-Lease Act

2 AMENDMENTS SUFFER DEFEAT

One Would Have Prohibited Use Of United States Ports For Repair Of Warships Of Belligerents

Washington, Feb. 8.—(AP)—With the Democratic majority in full control, the House defeated today an amendment to the British aid bill to prohibit United States ports to be used for repair of belligerent warships.

The amendment, offered by Rep. Fish (R.-N.Y.), was defeated by a standing vote announced as 147 to 70.

Washington, Feb. 8.—(AP)—The House rejected today a proposal that the administration's aid to Britain bill be amended to prohibit the sending of American troops outside the territorial waters of the Western Hemisphere.

By a voice vote, the chamber turned down an amendment by Rep. Van Zandt (R.-Penn.), a modification of one offered by the first woman of Congress, Rep. Rankin (R.-Mont.) but which she subsequently withdrew.

This action came after the House, at the request of the administration leaders, had decided tentatively to put a flat \$1,300,000,000 ceiling on the value of military equipment existing or appropriated for that might be disposed of to foreign governments under the bill.

Miss Rankin, who voted against the U. S. declaration of war on Germany, told the House today that the nation was being subjected to the same kind of propaganda that preceded its entry into the World War and declared that many members who voted for this country's participation in that conflict did so, believing that American troops would never be sent abroad to fight.

The ceiling amendment was accepted in an effort to clarify the 10 per cent limitation which administration leaders induced the House to write into the bill yesterday.

Administration leaders denounced both the Van Zandt and Rankin proposals on the ground that nothing in the aid to Britain bill would authorize the sending of troops abroad.

"This amendment is intended primarily as a smoke screen to befuddle the minds of the American people," said Rep. Richards (D.-S.C.).

To Study Wave Of Warplane Crashes

Washington, Feb. 8 (AP)—The deaths of at least 27 army fliers in airplane accidents in less than two months has prompted the air corps to undertake an intensive study of safety records and crash prevention measures.

Issuance of a detailed statement of these records, which heretofore have been held secret, was reported today to be under consideration by corps officials as a means of supporting their contention that although the number of accidents has increased with expansion of the air corps, the ratio of fatalities to hours flown actually has tended downward.

A dozen naval fliers also have been killed since mid-December, but Navy department officials said the rate of accidents was abnormal.

In two months more army fliers have met death than for entire recent 12 months periods. For the period 1937-39 the average number of fatalities annually was approximately 23.

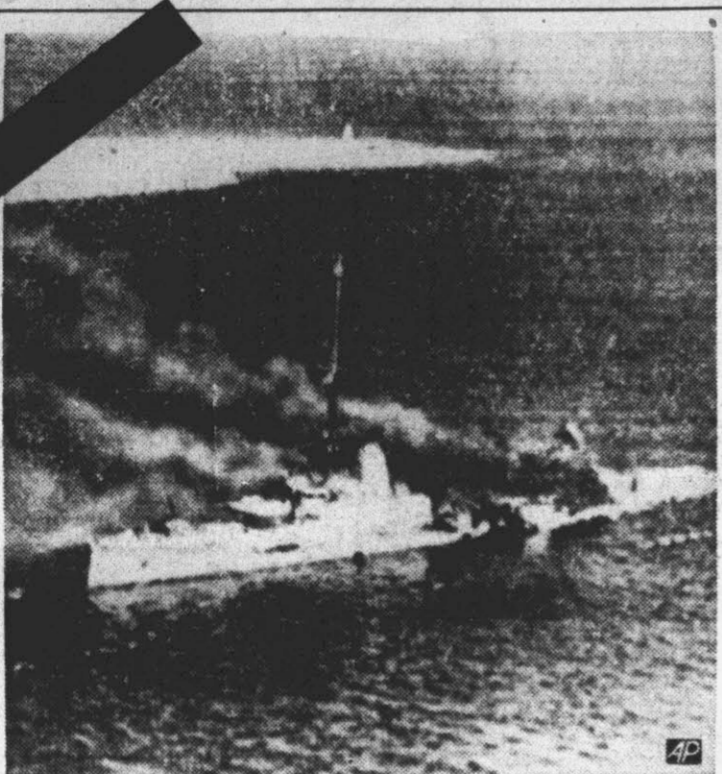
The air corps now is several times larger than it was during that period, however.

Declare Fascists To Conduct Drive

Rome, Feb. 8.—(AP)—An Italian counter offensive "is being prepared" in North Africa, the Italian radio declared today after the high command had admitted the loss of the naval and military base of Bengasi to British forces.

The daily war bulletin said the Fascists withdrew from Bengasi to spare the civil population after great losses had been suffered on both sides in a bitter fight.

NAZI INVASION IS PREDICTED

Secretary Of State Of India Says Move Imminent

London, Feb. 8.—(AP)—L. S. Amery, Secretary of State for India, told a London audience today that "the next big move" by Adolf Hitler is "imminent" and that the only German hope for a decisive result is conquest of England.

"There is only one direction in which he (Hitler) can hope for decisive results... and that is the invasion and conquest of this island," said Amery.

He said the German fuhrer's position was "difficult" and "he is bound to make a supreme effort."

"Let none of us underrate the formidable nature of that effort and the magnitude of the peril which confronts us," he added.

The Nazi "tiger is not as fresh as he was," Amery said, but he solemnly warned "we may have to face losses and sacrifices and restrictions such as we have not dreamed of hitherto."

Pneumonia Claims State Dept. Aide

Fairfax, Va., Feb. 8.—(AP)—R. Walton Moore, 81-year-old councillor of the State Department, died of pneumonia at his home here early today.

Moore, a bachelor who entered the State Department at 74, recently suffered a second attack of the disease. He had recovered from one attack in December.

"Judge" Moore as he was known to his friends, served in Congress from 1919 to 1931 and was appointed assistant Secretary of State in September, 1933, the first year of the Roosevelt administration.

Local Movements Explained To Club

Two movements in Greenville—Bundles for Britain and Boy Scouts—were principal features of last night's meeting of the Greenville Kiwanis club.

Mrs. W. I. Wooten, who was instrumental in organizing the Bundles for Britain movement in Greenville, told how the campaign got started and of the rapid growth it has enjoyed. She said that although no donations had been requested, several hundred dollars had been contributed.

W. T. Kyzer, vice president of the local Bundles for Britain, also spoke briefly on the movement.

Witnesses Describe Scene As Of Un-speakable Horror

Dallas, Texas, Feb. 8.—(AP)—The death toll in the fire that swept the Salvation Army's men lodge and mission reached eight early today as rescue workers poked through the smoking shell of the two-story hotel in the heart of Dallas' business district.

None had been identified. Major Ernest Pickering of the Salvation Army said 25 other men were badly burned or otherwise injured in the sudden roaring blaze originating in a room where the clothing of 57 transients was being de-loused.

Witnesses said the scene was one of unspeakable horror.

A few minutes after the fire broke out one nude man, badly burned, ran screaming to a garage a block away and fell to the ground.

The manager of a filling station called an ambulance while an attendant threw a blanket about the burned man, who was crying for water.

Another, also nude and burned so that his flesh hung in tatters, stood at the center of a street intersection begging for help while firemen rushed to give him first aid.

Witnesses said the transients crowding the lodge to capacity because of cold weather, dashed to the rear of the upstairs room when the flames suddenly burst from the delousing room, thinking there was an exit.

Others flung themselves from second floor windows.

January Accidents Take Eight Lives

Eight persons were killed and 49 received non-fatal injuries in highway collisions in the Eastern North Carolina counties embracing Troop A of the State Highway Patrol during January, it was revealed today in the monthly report of Lieut. Lester Joffe, commanding officer of the division.

The combined force investigated a total of 60 accidents. Arrests during the month totalled 451, of which 54 were on charges of driving drunk. Of the defendants tried in courts, 441 defendants were convicted and 10 acquitted. Sentences meted out amounted to 39 years, nine months and 10 days. Fines totalled \$4,686.45 and costs \$3,900.54.

Patrolmen recovered stolen property valued at \$6,890 and collected \$13,251.26 in revenue, from such sources as overloaded trucks and improper licenses.

Other activities of patrolmen in the troop included: Vehicles inspected 7,545; equipment tickets issued 161; lights corrected 3,522; warning tickets issued 68; courtesies extended 1,128; cars recovered 13; vehicles stored 23; vehicles weighed 40, with 27 found to be overloaded; complaints investigated 444; first aid rendered, four; citations 797.

BILL REMOVES STATE PATROL FROM POLITICS

Department of Motor Vehicles Proposed In Measure

GOV. BROUGHTON SUPPORTS MOVE

Another Bill Offered Today Provides For \$300,000 Agricultural Building at N. C. State College

Raleigh, Feb. 8.—(AP)—Bills to provide a \$300,000 agriculture building at N. C. State College and to carry out an inaugural pledge of Governor Broughton to remove the Highway Patrol "from politics" landed in legislative hoppers today.

Rep. Stone of Rockingham offered the Highway Patrol bill in the House and Sen. Johnson of Sampson sent forward the Senate version. They are chairmen of the important committees on roads.

The bill would remove the Highway Patrol, the Highway Safety division, the Motor Vehicle Bureau, the Automobile Theft Bureau and the Drivers' License Division from the Revenue department and incorporate them in a new department of motor vehicles.

Sen. Ballentine of Wake introduced the bill calling for construction of an agriculture building at State College. It would provide for issuance of \$150,000 worth of bonds by the state and ask the WPA to ante an additional \$150,000.

The department of Motor Vehicles would be administered by a commissioner of motor vehicles to be appointed by the governor for a term at the pleasure of the governor.

The House passed the following bills: House bill 180 to set \$100 as the maximum fee special counsel may receive in Wayne county capital cases; House bill 127 to place the prosecuting attorney of Robeson county on a salary basis; House bill 201 to raise the minimum pay of court clerk and register of deeds in Robeson county from \$125 to \$200 and the maximum from \$225 to \$300.

Negroes Mapping Local Observance

Plans are being made here for participation in Negro History Week to be observed throughout the nation next week with a series of daily press articles and a radio broadcast Thursday to be the principal features.

The series of articles has been prepared by A. O. Dupree, principal of the Pitt County Training school at Grimesland, and one will appear daily in The Reflector. The series will include articles on the Negro national defense, in music, Negro personalities in American history, the Negro in literature, drama and art and the world tomorrow.

The special radio broadcast over local station WGTC is scheduled for 2:30-2:45. Professor Dupree will make the principal address on the subject, "In Spite of Handicaps." Another feature of the radio program will be a recitation, "Creation," by Annie Ruth Person, representing the Bethel school. Musical numbers will be presented by representatives from the Pitt County Training school.

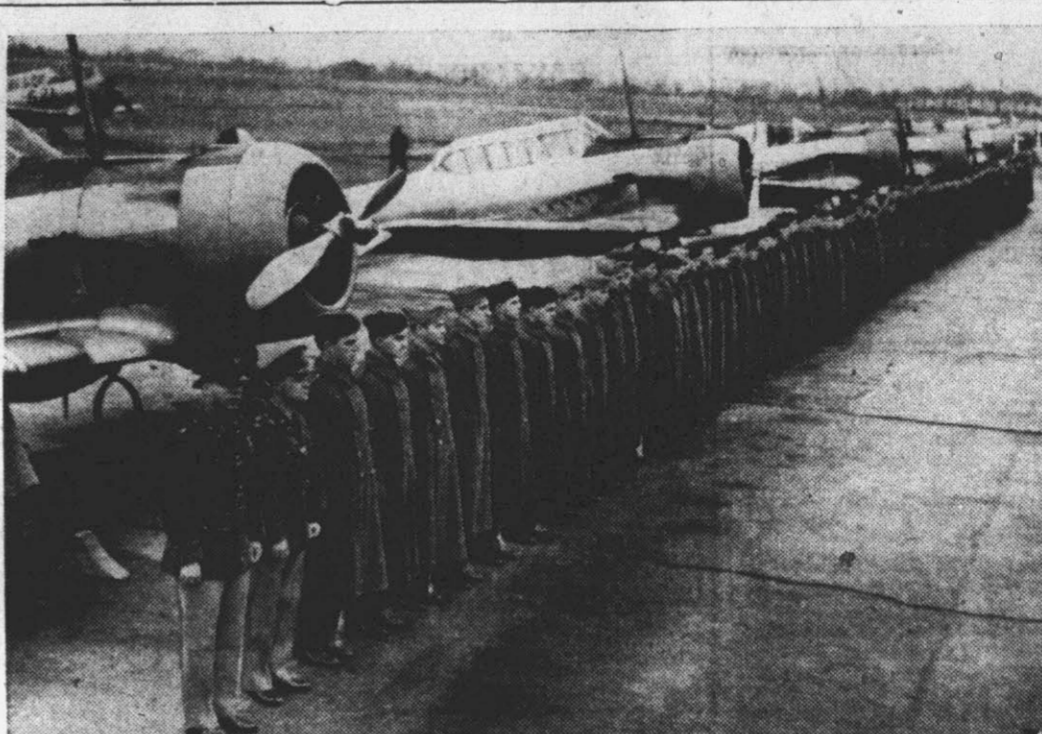

DRIVE OPENED IN THIS CITY

Bundles For Britain Campaign Off To Big Start

The Bundles for Britain movement was officially under way today with headquarters open in the Fire Department after a radio program last night launched the drive on what already appears to be a success.

While the radio program was in progress contributions totaling \$670 were telephoned in, lending encouragement to Mrs. J. T. Little, general chairman, and others heading the movement.

A feature of the drive will be a campaign to save tin-foil carried on under the supervision of the Woman's club, which organization is requesting persons to save all tin-foil and turn it over to officials of the club to be sent to Britain for use in armaments.

Any good, clean clothing for men, women and children, even though used, will be welcomed. Balls of yarn to be used in the Bundles for Britain workshop also are being requested. Scraps of lace, ribbons, buttons for baby dresses and girls' clothes also are needed and will be put to good use if contributed.

Last night's radio program was presided over by Mrs. Little, who, in addition to presenting the various speakers, also made a brief address in support of the movement.

Mayor B. B. Sugg was the first to speak. He explained his proclamation and reiterated his hope that the citizens of Greenville would lend their support in helping to make the drive a success.

Mrs. W. I. Wooten, who has taken an active part in the campaign, spoke in behalf of the various women's clubs in the city. She called on the mothers to help in the drive, saying that English mothers were giving their sons to the cause.

Willard Y. Kyzer, vice president of the local organization, said that the time has come when we must realize the significance of the European conflict and how closely we are allied with it even though we are not present actually participating.

Mrs. S. M. Crisp spoke in behalf of the Service League, recalling that the organization had undertaken the movement as one of its endeavors.

Encouraging

Advice that tobacco was definitely included in the lend-lease bill brought encouragement to farmers, business men and all persons engaged in the various tobacco industries throughout this section.

Inclusion of tobacco in the bill, which will make possible the sale of the product to Britain is expected to prove of inestimable value to all southern tobacco growers.

The federal government already has approximately \$76,000,000 invested in the 1939 and 1940 crops. Options on this tobacco, held by British companies, expire in July, 1941, and July, 1942. Decision to release this tobacco to Britain under lend or lease is expected to provide an outlet for the surplus.

ALF M. LANDON AGAINST BILL

Proposes Outright Subsidy Or Gift For Britain

Washington, Feb. 8.—(AP)—Alf M. Landon, calling the administration's British aid bill a "guess and be damned policy," proposed today that Congress reject it and instead grant Great Britain and outright subsidy of two to four billion dollars.

In response to questions from members of the Senate Foreign Relations Committee, the 1936 Republican presidential nominee, said he disagreed with the stand in support of the bill taken by Wendell L. Willkie, the 1940 GOP candidate, and added that for so doing he hoped he would not be purged from his party.

Sen. Connally (D-Tex.) then asked Landon to assume he was president and explain just what he would do to aid Britain.

Landon explained that he favored an outright "subsidy" or gift of several billions for British aid, explaining that Congress could do this by a simple appropriations measure.

"Do you regard a British victory as vital to our safety," Connally asked.

"I think it is greatly to our advantage," Landon said. President Roosevelt had attempted to "gag" Senator Wheeler (D-Mont.) because of Wheeler's opposition to the measure.

The former governor of Kansas and 1936 Republican presidential nominee also declared that "freedom of debate and discussion" on the bill "is being discouraged in America by the flood of government propaganda and war hysteria."

He used the word "dastardly" in describing what he called Mr. Roosevelt's "systematic attempt" to "silence" Wheeler and "weaken his influence."

Nippon Officials Victims Of Crash

Tokyo, Feb. 8.—(AP)—Admiral Osumi, Japanese supreme war councilor, has been killed in the crash province, China, the navy ministry announced today.

Six other naval officers, including one rear admiral, died in the crash.

The officers were inspecting the Chinese war front and were en route from Canton to Hainan island when the crash occurred, the ministry said.

BIG FIRE LOSS IN MOUNT AIRY

Business Block Swept By One Of Two Conflagrations

Mount Airy, Feb. 8.—(AP)—Two fires, one of which swept a business block and destroyed nine buildings, caused damage estimated by Fire Chief J. S. Belton at \$165,000 early today.

A tobacco warehouse, two leaf-houses, a fertilizer storage warehouse and several small business houses were destroyed in the business district blaze. Heat caused the sprinkler system in a nearby hosiery mill to open and the three-story structure was flooded.

Belton said a 45-mile-an-hour wind subsided less than a hour before this fire was discovered, probably saving more than half of the business area.

Four hours earlier another fire caused damage estimated at \$40,000 to the S. L. S. A. Hennis freight lines terminal and offices several miles from the center of town. The blaze, fanned by a heavy wind, made the structure a total loss.

Ice and wind hampered the fire department.

Dr. Henry Weiman To Arrive Tonight

Dr. Henry N. Wieman, professor of the Philosophy of Religion at the University of Chicago, who has been speaking in Raleigh the past week at the Institute of Religion will come to the East Carolina Teachers College campus tonight for the "Religion Emphasis Week" Feb. 9-11, that is being sponsored by the college Y. W. C. A. and Y. M. C. A.

The program for the "week" will begin Sunday morning with 11 o'clock worship service at which Dr. Wieman will speak.

In the afternoon from 3:30 to 5 o'clock, Dr. Wieman will meet the students and faculty of the College, ministers, secretaries, and student secretaries of the local churches, teachers of the high school and other critic teachers at an informal tea in the social room of the New Classroom building. He will speak at 6:30 at the regular vesper service.

Dr. Wieman, a scientist, a psychologist, and a philosopher, is said to be particularly helpful in the problem of reconciling what seem to be the conflicting claims of science and religion.

Miss Rebecca Ross of Aurora president of the Y. M. C. A., and Miss Irene Mitcham of Goldsboro chairman of Religious Education were in charge of arrangements.

Two Children Burned To Death In Pender

Wilmington, Feb. 8.—(AP)—Two children were burned to death and two others were injured, one seriously, in a small frame-house at Hamstead, Pender county, late yesterday.

The house became a blazing inferno when a can of gasoline exploded. Vivian, five, and Alice, 10, daughters of Mr. and Mrs. Allie Howard, were injured fatally. Their sister, Edna, 17, was badly burned and attendants at the Wilmington hospital, to which she was brought, said today she was not expected to live.

Another sister, Dorothy, 18, also was burned. Her condition was described as satisfactory at the hospital.

Advised Not Let Germans Cross Nation

Britain Keeping Eye On Balkan Nations For Any Attempt by Germany To Send Aid To Hard-Pressed Italians; Fascists South of Fallen Bengasi Surrender To Invading Imperial Army Of The Nile

Surrender of large forces of Italians south of the fallen Libyan stronghold of Bengasi was announced today, while another report said the British, keeping an eye on the Balkans, had warned Bulgaria that she would be bombed if German troops were permitted to march across Bulgaria to aid Italy in Greece.

London, Feb. 8.—(AP)—Authoritative foreign office circles said today there was "no confirmation" in London of Istanbul reports that Britain had delivered a warning to German troops concerning passage of Bulgaria through the country.

The capture of many new troops whose retreat had been cut off south of Bengasi was reported by British headquarters in Cairo. Operations were "proceeding satisfactorily," headquarters said.

The report on the warning to Bulgaria originated in diplomatic circles in Istanbul, Turkey, but was without official confirmation. These sources said Britain had delivered a formal note to the Bulgarian foreign office that Nazi military penetration with the aid of helping the Italians in Greece would be met with British aerial action against railways and communications.

The Greeks were reported today to have hurled back two Fascist counter attacks in the central sector of the Albanian front, inflicting heavy losses on the Italians in the same area where, three days ago, Fascist tank and armored car assaults failed.

Dispatches from the front said the Italians were trying desperately to relieve the pressure on their line at that point and that piles of dead were left on the battlefield.

The last of the Fascist garrison of Bengasi was reported "surrendering in large numbers" after a furious assault with tanks failed to break a British trap along the coastal road of retreat south of the port.

The British command did not estimate the number of captives taken, but previous reports put the Bengasi garrison at 25,000 troops. Among the prisoners were an army commander, a corps commander and "many other senior officers."

The continuing success of the British African campaign was believed by some observers to encourage the French government at Vichy in resisting German demands for more active collaboration—perhaps involving use of the naval base at Bizerte in French Tunisia.

The Vichy government made public a pledge of General Maxime Bregand, commander along the North African forces, that he would not surrender Bizert for use against the British.

On the British home front, the Royal Air Force, disregarding bad weather over the English channel, pounded the Nazi invasion ports of Dunkerque and Boulogne for two hours last night in an attack described as on a "considerable scale."

Allan Jones, popular tenor of the concert stage and moving picture film who will appear in concert at East Carolina Teachers College on Friday night, February 14, has his own cure to suggest for war jitters. "Sing," he says, "Sing loud and long; make lots of noise, and you'll scare the litters right out of yourself. Especially after you listen to the war news of the day, let your vocal chords go to town. You sing, you hear your own voice powerful and loud, and you feel better immediately."

Whatever the case for the ordinary singer, Jones would be able to produce the strong and powerful tone he speaks of, as he proved in an unusual way once while working on a film. While walking a long lake shore, he discovered a man clinging to an overturned canoe in

the middle of the lake and, pitching his voice high, hailed a speed boat slowly crossing the lake a mile away. His voice carried full and clear, and the speed boat went at once to the rescue.

Jones' voice has had careful training from the time he began studying at the age of four in his home in Scranton, Pa. He won music scholarships at New York University and with a well-known New York teacher, Claude Warford.

Later he studied in Paris at the Warford School and with Reynolds Hahn, a French conductor and composer, and Felix Le Roux of the National Opera.

Since those first years he has repeatedly returned to Paris and London for further study.

Though Jones is under contract in Hollywood, he is left free three months during the year for his concert work; and one of his tours will bring him to East Carolina Teachers College Friday night, February 14, under the auspices of the ECTC Entertainment committee.

Debate At Assembly Hour. Four members of the Jarvis Debating Club of East Carolina Teachers College, Miss Elizabeth Bishop of Raleigh, Misses Mary and Martha Gaskins of New Bern, and Jennings Ballard of Alexis—took part in the college assembly hour yesterday in a "streamlined" debate on the question: "Resolved, That the nations of the western hemisphere should form a permanent union." Because of the limited time of the assembly period each speaker was limited to five minutes and no rebuttals were permitted.

Miss Mildred Beverly of Ahsokie, presiding officer, introduced first Miss Martha Gaskins, who defined the terms for the affirmative and, presenting the argument for union for political defense, cited authorities to show that such union "would enable us to build up a front so strong that no nation could ever attack us."

Miss Mary Gaskins, first negative speaker, gave cases to show that the negative side had never been able to change its policy of no entangling alliances without becoming involved in war. Admitting need for defense, she said that the proposed union would not take care of this and could call on this country to furnish more supplies than others without a correspondingly greater power.

Ballard presented the argument that the union is necessary for economic defense, giving the opinion of experts that the large investments of American business in South America would be a total loss almost immediately if Hitler were to come into the continent to the south.

Elizabeth Bishop's chief argument against the union suggested was that its economic disadvantages would outweigh its advantages, as the United States would lose \$32,000,000 annually and would add to the tax burden of the country by the administrative costs of the additional government.

The debating club which sponsored this program is a comparatively new organization on the E. C. campus, having been formed

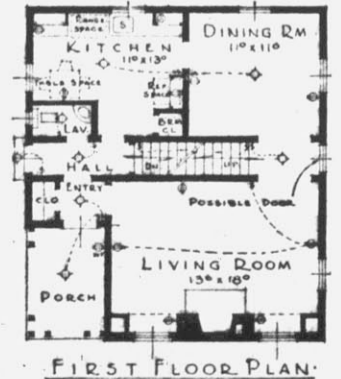

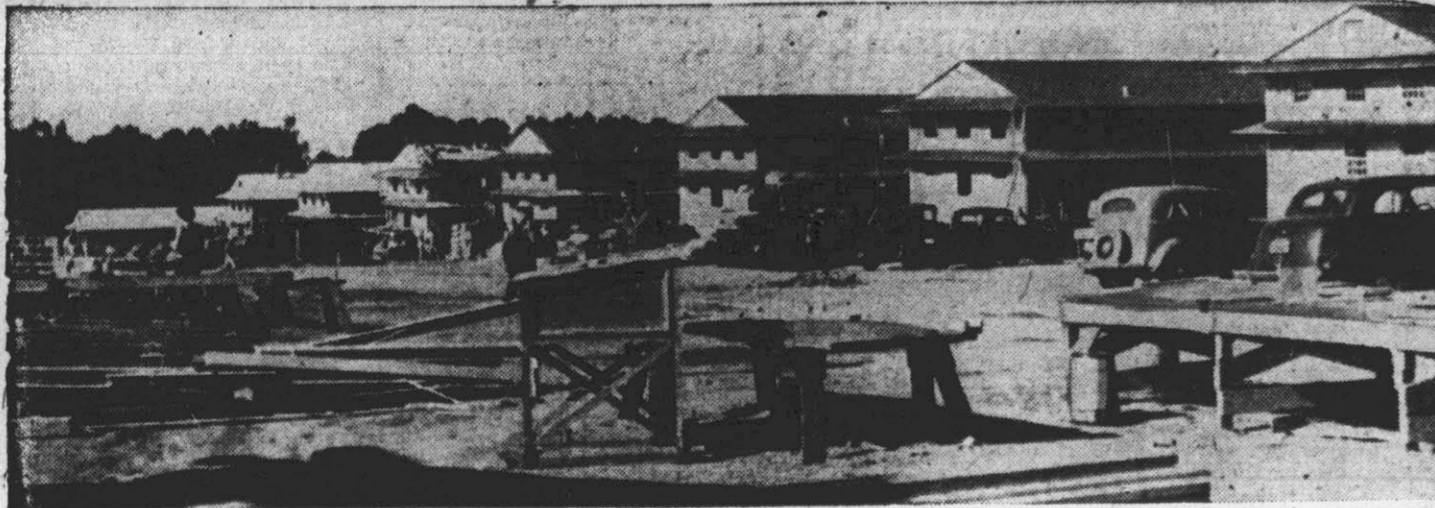

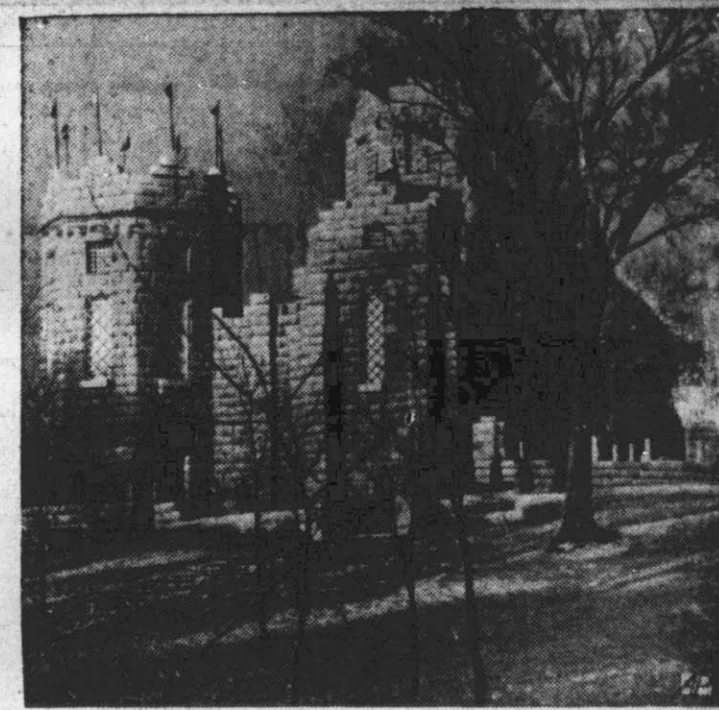

YOUTH WANTS HEALTH PROGRAM

Stating that an alarming high percentage of young men is being rejected by selection boards because of physical disabilities, the American Youth Commission, of which Owen D. Young is chairman, suggested that special rehabilitation camps be established for the rejected selectees who would be willing to respond to such a program.

The report of the Commission explained that the draft rejections typify a basic condition of unsatisfactory health in a large portion of our population.

American Youth Commission surveys show large numbers of youth "soft, underweight and generally lacking in muscular development."

In support of nation-wide youth health, the Commission expressed the opinion that there is no reason to believe that the military emergency will be short, stating that it may last for years.

Short Shots

By Henry Averill and Lynn Nisbet Raleigh, Feb. 8.—Even the east-west air line across North Carolina, making scheduled stops at both Raleigh and Elizabeth City could hardly transport the members of the General Assembly to the Albemarle section's metropolis in the time suggested by Senator Leary.

Opponents of the plan argue that placing the public defenders under the attorney general's supervision would be a grave error. The federal prosecutors are also under the attorney general, who would then be in the position of directing the efforts of federal officers whose purposes were diametrically opposed.

Others argue that the problem can be handled by the bench and the bar, without setting up a new governmental bureau. They say exacting judges can really put the heat on experienced lawyers who fail to do their duty.

Cites State Courts Jackson, in his recommendation for public defenders in his 1939 and 1940 annual reports, replies that the system has been widely adopted in state courts and has proved satisfactory everywhere.

BRICK AND CLAPBOARD CHARMINGLY COMBINED

Brick and clapboard are skillfully combined by Architect Randolph Evans to produce an unusual charming exterior for the February House of the Month of the Monthly Small House Club. If the brick is left in its natural state, Architect Evans recommends a soft green shingle roof with shutters of a matching shade. Negro Oral Hygiene Work Is Completed

The Oral Hygiene program for the colored schools in Pitt county came to a close yesterday after six weeks of dental services by Dr. J. H. Barnhill of the State Board of Health, Division of Oral Hygiene.

According to Dr. Ennett, the Pitt county health officer, Dr. Barnhill worked in the following schools: Ayden, Bruce, Cherry Lane, Cox Farmville, Falkland, Fountain and Zion Hill.

Dr. Barnhill's report shows that he inspected 1087 children, treated 474, and referred to local dentists for treatment, 71.

He performed a total of 1,675 dental operations; made 37 lectures on Oral Hygiene, and the total attendance of pupils and teachers at these lectures was 1,306.

Cites Best Plans For Cutting Wood

County Agent R. R. Bennett declared today that farmers throughout the county are "cutting cords for fuel in the home and for curing tobacco" and offered the following advice:

"Some farmers are following the recommended practice of selective cutting or thinning the timber stand to secure the needed wood. Others are clean cutting (and in some cases may not need the land for crops). Some producers clean cut the woodland except for leaving an occasional seed tree.

"Many farms still have sufficient woodland to supply the farm if selective cutting and forest thinning is practiced. Other farmers already find it necessary to depend on oil heating or coal stoker units to cure their tobacco.

"If a farmer is already out of wood or has a partial supply or if he has plenty of wood for the time being he should resort to a practice of selective cutting and thinning so as to grow as much wood and timber per acre as possible. In many cases the wood supply will have to be supplemented or replaced with oil, or coal or other types of fuel if a good system of forest conservation is to be put into effect."

accessibility are far more important than the house itself. A small house on a good-sized piece of land is better than a big house on a small piece of land. I am bullish on good real estate during 1941. This does not mean old houses anywhere, or city property in general, but it does mean suburban property and productive land. I sincerely hope that workmen during World War II will spend their money on little houses before buying big cars, and on warm blankets instead of on silk shirts!

The governor said that on Monday he would set the date for the special election.

Cost of a Home

As in previous periods of great industrial expansion, more employment and larger pay rolls accompany a boom in residential building. The greater part of this boom should revolve around the small home. In recent years, there has been a tendency even upon the part of the wealthy to occupy a small salable property than to be stuck with a large white elephant. Home today are adequately designed and arranged so that their efficiency from a utility and space point of view is far beyond anything heretofore known.

With an increased demand for houses, it is natural to expect some rise in costs. Building materials will be consumed heavily this year. This is especially true of many products such as wood-fibre, metal lath, plaster, insulating materials, asphalt roofing, etc. The broad trend in their prices should be irregularly upward. On the whole, any advance should be moderate and or-

derly in view of administration measures which can be adopted to head off a rapid price rise. This, the President seems determined to avoid. Upping of manufacturing costs, through rising wages and taxes, is primarily responsible. But costs will certainly be subject to government action to prevent a rise which would endanger home building.

Getting Real Security

In many sections, particularly in defense areas and adjacent to shipyards and air depots, there is a shortage of housing. For rent, resale, or ultimate owner occupancy, one or more small houses in such sections might temporarily be profitable. I am, however, particularly interested in the problem of the average reader who for some time has considered building a home for his family. To him I say, "Go right ahead." Small home building reached a high level last year with 545,000 units constructed. This was the best year since 1928 when 436,000 homes were built. The trend is up and it is well to take advantage of prevailing prices and opportunities.

Large city dwellers are up against high taxes and other municipal restrictions. Fortunate are readers who live in small cities. With the coming decentralization of industry, communities of from 5,000 to 25,000 population will enjoy the best growth. Consider seriously the advisability of a home in such a locality. It would be good insurance against economic reversals, government inflation, or a temporary uprising of the masses.

Build Now

Social security can never be obtained by paying back to the government a certain percentage of your earnings. Wage workers of Germany, France, and even England are learning this today.
