NEW PREMIER IS CHOSEN BY GREECE'S KING

Vacancy Created By Suicide Of Koriza Is Filled

KING CALLS FOR FIGHT TO END

Emmanuel Tsouderos, Active in Greek Public Life For More Than 20 Years, Heads War-Time Greece

Athens, April 21.—(AP) Emmanuel Tsouderos became premier of war-time Greece today, succeeding Alexandros Korizis, who committed suicide last Friday.

The new government was announced as the Greeks acknowledged that the German drive on the east had made a new dent in the allied line and King George II, had called upon the nation to fight "to the very end."

Tsouderos had been named Minister of Foreign Affairs and Finance and Provisional Minister of Economy in the cabinet formed yesterday by Admiral Alexander Sakellariou as vice-premier and the king in the dual role of monarch and premier.

Admiral Sakellariou remains as vice-premier. Tsouderos, in his 50's, has been active in Greek public life for more than 20 years. He is a native of the island of Crete and began a political career with his election to Parliament in 1920.

One of Greece's leading economists, he carried on negotiations with Britain in 1926 for settlement of the Greek war debt. He has held cabinet posts previously as Minister of Finance and Communications and more recently served as president of the Bank of Greece.

Athens, April 21.—(AP)—Greece's new premier, Emmanuel Tsouderos declared tonight that the Greeks would "fight to the end, until the Balkans are cleared of those who led the infamous campaign against us."

In a radio broadcast to the nation he said: "You may rest assured that glory eventually will crown Greece. Greece will remain faithful to her commitments and she is grateful to her great ally, Britain, who came here on her own initiative to fight."

"Behind us we also have the assistance of the United States, from whose great humanitarian principles mankind will benefit. With such allies we may be assured that right and justice will prevail."

Albanian Ionian Coast Reoccupied By Fascists

Rome Claims Forces Have Advanced to Greek Border

Rome, April 21.—(AP)—The Italian high command reported today the entire Ionian coast of Albania as far as the Greek frontier.

In the Mediterranean, the war bulletin said, Italian planes circled and sang a 2,000-ton auxiliary cruiser out of an Allied convoy. The newspaper Il Popolo di Roma said "a big battle to wipe out the Greek army" was in progress at Perati bridge, which spans the Viosa river at the Greek-Albanian frontier. Earlier reports said Fascist dive-bombers had blasted the bridge trapping the Greeks on the Albanian side.

SEARCH BEGUN BY COMMITTEE FOR NEW TAXES

Doughton's Way And Means Committee Starts Work

EXPERTS CALLED TO CLOSED MEET

\$3,500,000,000 In New Taxes Sought To Boost Nation's Total Intake to \$12,600,000,000

Washington, April 21.—

(AP)—Treasury and congressional tax experts summoned by the House Ways and Means committee today to lay the groundwork for writing a new \$3,500,000,000 revenue measure intended to boost the nation's tax intake to \$12,600,000,000.

Meeting behind closed doors, the committee asked for "suggestions" from John L. Sullivan, Treasury Secretary, and from the staff of the joint committee on internal revenue taxation, an arm of Congress. Both have been working separately and in collaboration on estimates of possible money sources.

On the other side of the capitol, meanwhile, Senator Glass (D-Va.) recommended that under present circumstances "every person with any income ought to pay taxes."

Endorsing the idea of higher levies, Glass told the reporters that "universal taxation" in this emergency was "imperative." It would have a salutary effect, he said, for "when people have a responsibility for providing the money, they also will have a responsibility to watch how it is spent" by Congress.

As the House committee began its search for more money sources, predictions were made freely in informed circles that the tremendous new revenue program would necessitate an increase of from 25 to 50 per cent in existing taxes, a return of many World War levies and the tapping of untouched fields.

There was talk that the present basic 4.4 per cent rate levied against individual incomes might be increased to eight, Senator Clark (D-Idaho) said it should be more.

Chairman Doughton (D-N.C.) of the Ways and Means Committee predicted revival of at least some of the so-called "nuisance" taxes levied during the last war and repealed soon thereafter. Taxes of that period included those on railroad tickets, and freight shipments, insurance policies and soft drinks.

He urged, instead, that government efforts to obtain "cooperation" between labor and management be continued.

He cautioned that the government should be authorized to take over a strike-bound defense plant only "in an emergency" and "if there is no other way."

He said he believed "we are going into an era of even greater collaboration between management and labor. We have today a spirit of full cooperation."

Hillman said that he regarded it "very unfortunate" that a few labor disputes which had led to work stoppages had attracted public attention while many disputes which were settled amicably went unnoticed.

"If people are led to believe that there are groups of labor that don't cooperate," he said, "it undermines national defense. It undermines the morale of the people."

Laval And Darlan Expected To Meet

Vichy, April 21.—(AP)—Well-informed quarters reported today that Vice Premier Admiral Jean Darlan and former Vice Premier Pierre Laval are likely to meet soon to discuss strong German terms, concerning which rumors are flying fast.

The German terms were reported to go beyond mere economic collaboration between France and the Reich.

Laval's star appeared to be in the ascendency again, and his friends and leaders have appeared here in force in the last few days.

(In Berlin, political quarters said there was no confirmation that Laval might return to the French cabinet.)

\$5,000 Pelley Bond Not to be Revoked

Washington, April 21.—(AP)—The United States Court of Appeals declined today to revoke the \$5,000 appeal bond of William Dudley Pelley, publisher and leader of the Silver Shirts, who is fighting against being returned to North Carolina in connection with a conviction for violation of securities laws.

SIXTEEN NAZI CRAFT BAGGED

Heavy Toll Is Shot Down In Battle Over Greece Sunday

Cairo, April 21.—(AP)—At least 16 German aircraft were shot down in Greece yesterday, the biggest total in one day since the German army began its offensive, the RAF Middle East command announced today.

Fourteen of the Nazi planes were destroyed by one big air battle over Athens, in which "a very large formation of German aircraft" was engaged, the British said.

Seven of the German planes shot down over Athens were listed as JU-88 dive-bombers.

Seven British planes were reported lost, but three of the pilots were safe.

In addition, German occupied air-dromes and troop columns on the move were attacked. A fire at Katarini air-drome was visible 60 miles from the communique declared.

In Africa, Derna, Bengasi and El Gazala again were raided heavily, it said.

Mechanized Forces Push Southward

Troops Declared To Have Advanced Far Beyond Larisa; Mountain Pass Reported Taken In Western Campaign; German Commentators Say The "Final Phase" Of War Should Be Easily Effected

Berlin, April 21.—(AP) German mechanized forces have pushed southward "far beyond Larisa" in pursuit of Greek and British troops retreating on the Greek Plain of Thessaly, the German high command said today.

Other Nazi forces operating to the west seized a mile-high mountain pass near Metsovon, 40 miles northwest of captured Trikkala, after crossing the Pindus mountain, the daily war bulletin said.

The communique emphasized air assaults against British troop transports along the Greek east coast. A 7,000-ton merchantman was said to have been destroyed in the port of Volos and two transports were reported "heavily hit" at Khalkis. Another transport was sunk from a convoy in the Mediterranean, the

communiqué said today.

high command said. Authorized sources previously had said that the Nazi mechanized units were rolling steadily southward after the retreating Greeks and British across the whole 60-mile width of the Plain of Thessaly in central Greece.

The German seizure of Metsovon pass offered a new threat to the Greeks retreating into northwestern Greece from Albania along an ever-narrowing path.

Italian forces which are pushing the Greeks across the border say the retreating forces have only one main road left open, that which runs south from Ioannina. Metsovon pass is 25 miles east of Ioannina, which in turn is about the same distance from the Albanian border.

German commentators said the Reichwehr's panzer units should traverse the flat plain, which extends roughly 35 miles to the south before running into the southern mountain chains, easily and effectively in what they called the "final phase" of the war.

RACE OFFERED IN FIFTH WARD

G. H. Clapp and A. E. Hobgood Seek 5th Ward Post

Young King Peter Now In Jerusalem

Vichy, France, April 21.—(AP)—Dispatches reaching Vichy today from Beirut, Lebanon, said that a plane carrying 17-year-old King Peter, II, of Yugoslavia had reached Jerusalem in a flight over the Mediterranean during which an unidentified member of the Yugoslav cabinet was killed.

The plane was attacked in flight it was said.

Peter, with other members of the cabinet, including General Dusan Simovic, Vice Premier Vladimir Macek and other officials were reported to have arrived safely after flying non-stop across the Mediterranean from Athens.

(Previous rumors were that Simovic was in Athens.)

American Doctors Needed By Britain

London, April 21.—(AP)—Dr. J. E. Gordon, American liaison officer to the British Ministry of Health, estimated today that it would take the United States three months to meet President Roosevelt's appeal for 1,000 doctors for service in Britain.

Field Marshal Sir Philip Chetwode said the American doctor volunteers would be given a lieutenant's rank with the same pay as the British and would not have to pay British income tax. At the end of the first year they will be promoted to a captaincy, he said.

Dr. G. C. Anderson, a secretary of the British Medical Association, said the British civilian population would be endangered alarmingly if the appeal went unanswered.

FEAR LOSS IN GREEK BATTLE

London Press Gloomy Over Outcome of Conflict

London, April 21.—(AP)—The British press more and more openly discussed the possibility of defeat in Greece as reliable observers today gloomily studied the campaign there and the intensification of the German diplomatic campaign.

Britain's action in sending troops to Iraq was taken as a visible indication of the official belief that the battle is nearing the Suez and the oil fields of the Middle East.

The press almost in one voice, warned against letting the British force in the Middle East be destroyed.

Hitler's real aim, it was said, was to use his armies and diplomacy in lieu of a fleet, to win not merely the Battle of the Balkans, but to trap the British Mediterranean fleet and the Middle Eastern army.

Thus, he would weaken the defense of Britain and knife her empire lifeline.

Observers viewed the unfriendly tone of the Spanish press and reports of prolonged cabinet meetings in Spain as a result of Axis pressure.

They said a German march to Gibraltar would not help Hitler much in his present campaign in the eastern Mediterranean, but it might give him new ports in Spain and Africa to fight the battle of the Atlantic.

Supporting the view that Hitler's aim is to destroy British power in the Mediterranean, qualified sources declared the loss of the battle in Greece in itself would "by no means be conclusive."

If Britain is able to hold a portion of North Africa, including her naval base at Alexandria, one source declared, "Hitler would have a devil of a time closing up Suez and Gibraltar."

But he admitted the latter is "not impregnable."

In this connection observers attached significance to the increasingly steady stand the British are making at Tobruk and Salum in Libya and Egypt.

As a matter of fact, it is reported that at one time before the British sent troops to Greece some British strategists were prepared to accept German occupation of Greece and to rely on North Africa to keep the Mediterranean open.

Hollywood

Sights and Sounds

Hollywood.—With no apparent faith in the notion that three strikes is out, Spencer Tracy and Victor Fleming and company are working behind the usual elaborately closed doors on the third movie version of "Dr. Jekyll and Mr. Hyde."

"Jekyll and Hyde" is no new idea with the pair who, ever since they got together on "Captains Courageous," have been looking for some picture they could do together off conventional paths. In the figuring they began warming up to the Stevenson classic two years ago, have been thrashing it over ever since.

"What we've set out to do," says Fleming, the director, "is to make Hyde believable. With Tracy, I knew it could be done."

Just how they're doing it is the reason for the closed set—the first in Tracy's long career as an open-door advocate. Rumors about his Hyde make-up have ranged from "none at all" (as Tracy originally desired), to "He's using everything fright wig, buck teeth, and hunchback."

John Barrymore, who with "Jekyll and Hyde" in 1920 made his movie transition from slapstick comedy to "serious" drama, went all-out on the Hyde make-up. Fredric March, who won an Oscar for it in 1933, went Barrymore better by a couple of fangs. Fleming and Tracy, falling back on the fact that Stevenson in his book gave no definite physical description of Hyde, are tackling the evil-in-man character in their own way.

Hy, according to Fleming, can be "a grotesque, inhuman monster as he has usually been pictured, or a quiet, deadly sadist."

In the original story there was no "romantic interest" though both picture and stage versions have had women figuring prominently. Fleming and Tracy are conventional here—though the casting has been done "against type." Ingrid Bergman, usually the noble heroine, is playing Ivy Pearson, the barroom singer who becomes the victim of Hyde's sadistic affections. Lana Turner, usually the torrid modern oomph, is the sweet, lady-like though spirited, fiancée of Jekyll.

"Jekyll and Hyde," long a stock piece on the stage, was first dramatized for the celebrated Richard Mansfield, who obtained rights from Stevenson. Henry B. Irving was another famous player of the dual role. Mansfield played it, off and on, for 20 years after his first production on May 9, 1887. It was he who added a sweetheart for Jekyll, and later the romantic elements were developed further.

Current speculation on the Tracy get-up as "Hyde" is nothing new. Mansfield knew it too, doubtless to the box-office profit. In London a widely accepted rumor was that he used a rubber suit, inflated at will, to make his Hyde grotesque.

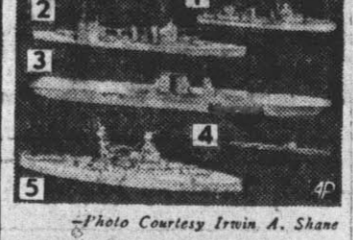

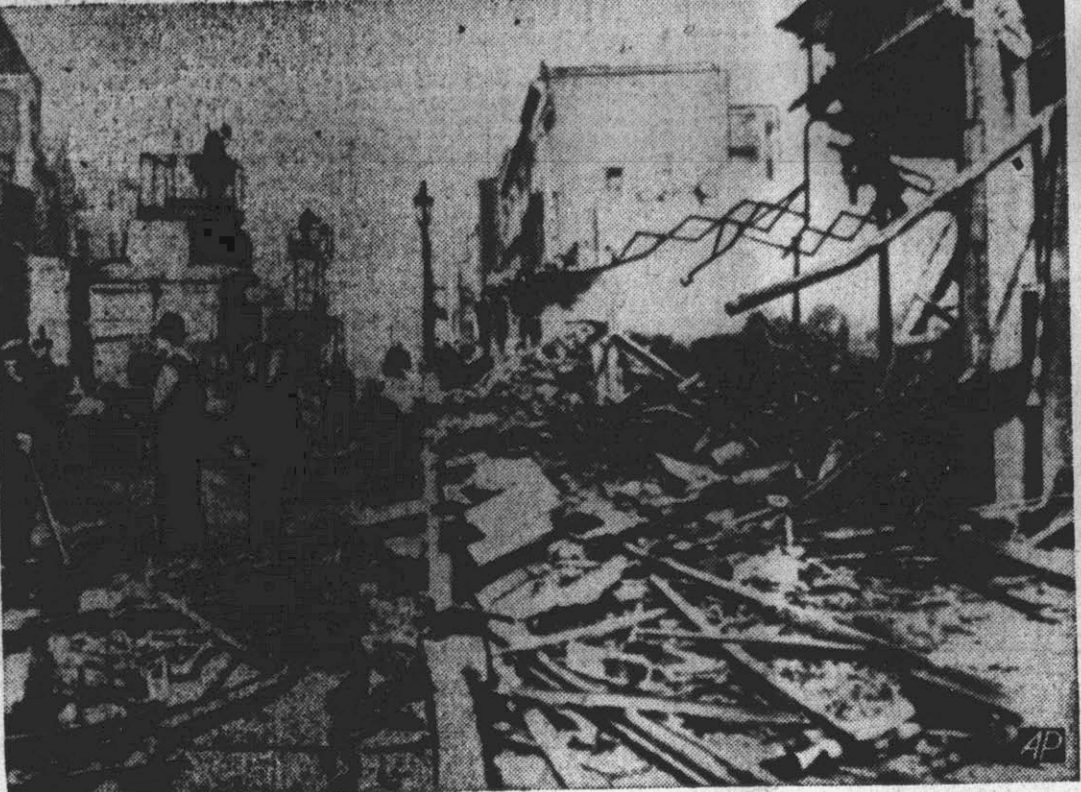
Jordan, at her silence, stopped to look. His eyes caught the ski. He reached over and picked it up.

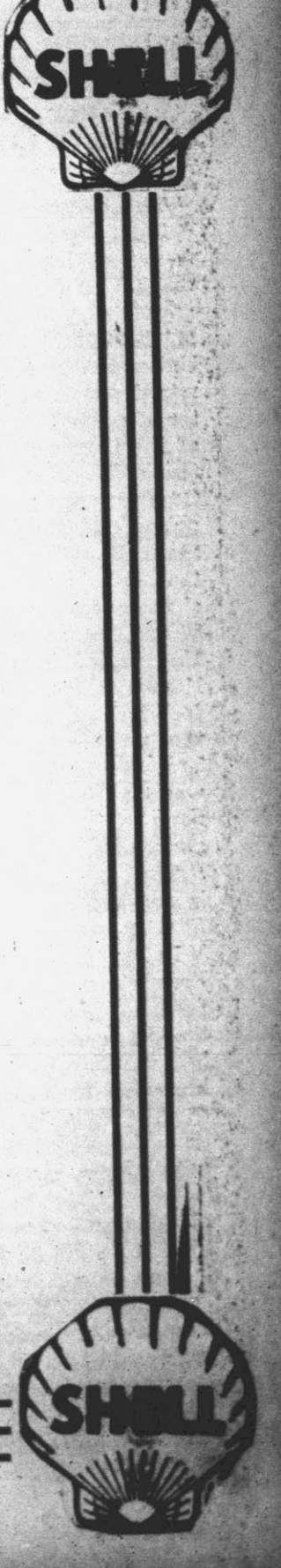
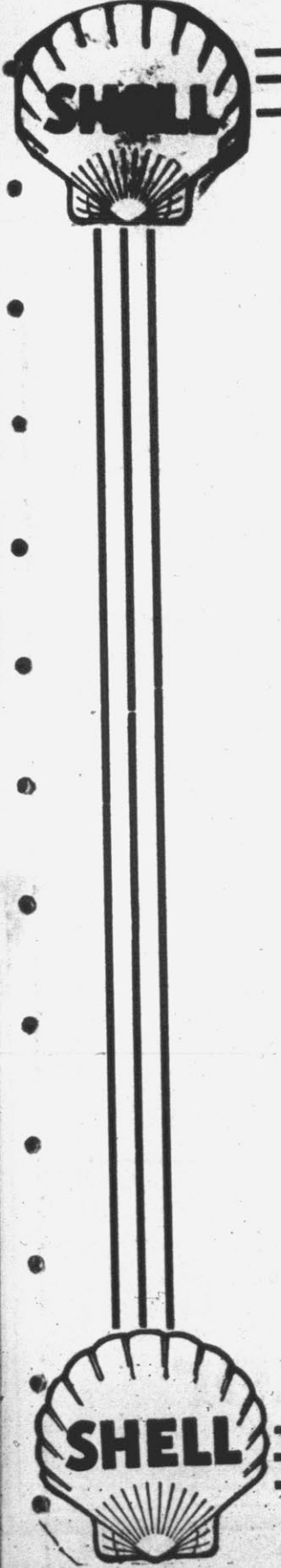

FRANCE BARTERS WITH HITLER

(Scottish Rite News)

The question of whether Britain should permit food from the United States to reach Unoccupied France is apparently still under the official consideration of the United States, though a definite decision became a matter of conjecture when news of the barter agreement between Hitler and the Vichy Government reached surprised officials of the U. S. State Department. It was too late to announce a change of plans for shipping \$1,000,000 worth of flour to Unoccupied France in two French ships. One of the food-laden boats has reached the people of Unoccupied France and the other boat was on the high seas when news of the barter was announced.

The State Department is constantly coming under heavier pressure from the Vichy Government. The French have cited that the food so far received from the United States has actually gone into the mouths of hungry French children, under the capable administration of the Red Cross. Admiral Leahy, U. S. Representative to Vichy, has been applauded and cheered by the French people for his efforts in their behalf. It is almost a certainty that Mr. Leahy has been urged to make stronger representations to the State Department for further shipments of food so that this supervised feeding of France



may continue. In anticipation of listening State Department ears, Vichy recently sent a representative to the United States in hopes of purchasing more wheat.

State Department officials surely must ponder the recent barter with Hitler whereby the Vichy Government agreed to send to Occupied France 1,355,000 head of livestock and other foodstuffs in exchange for 800,000 tons of wheat, a like amount of potatoes and 200,000 tons of sugar.

Now what guarantee does the State Department have that the French will not negotiate another food exchange with Hitler, if the depleted French food supply is made up by American wheat? Administrators of the food already sent to Unoccupied France point to the recent successful distribution of American food. Yet, enthusiasts of this plan forget that United States officials in Unoccupied France have no control over Vichy food supplies which are constantly being "purchased," with weakened German Reichmarks, by the Nazis. United States must realize that the Nazis keep a first-hand account of all food entering Unoccupied France and have at their easy disposal a means by which a proposed additional shipment of American food would be tapped.

Additionally, many feel that behind the Hoover plan lies more than a humanitarian gesture to relieve the hungry French. Some of the plan's followers, as Dorothy Thompson has suggested, say that, with the effort to feed the French and break the British blockade, the foundation for another Munich—a negotiated peace with Hitler—will be laid. Several Hoover aids, it is said, are convinced that Hoover can bring about a reasonable and lasting peace with Hitler—purely a pipe dream in light of recent history. It is also interesting to note that though Hoover's follower's try to lessen French suffering, they apparently fail to recognize Hitler's tightening counter-blockade against the British. Hitler would starve out the British, yet the Hoover planners would trust Hitler to

stand aside while they feed France. No wonder United States officials now hesitate after viewing this basis of the plan to feed Unoccupied France.

COTTON FOR PROFIT

Planning for production pays—and planning for a bale of cotton to the acre or better long before it is actually produced is wise thinking.

Why? Good seed is needed, properly balanced fertilizer is required, and a well prepared seed bed causes the other factors to work their best.

Spring rains—how hard they beat and pack the soil—yet the moisture puts the fertilizer under the cotton to work and with plenty of nitrogen in the mixture, the cotton has the urge to grow and push right up from the ground and do its best for the farmer who treats it right.

Last year cotton demonstrations conducted by the distributors of Arcadian, the American Nitrate of Soda, with the cooperation of county agents and agricultural teachers, produced 2,208 pounds of seed cotton per acre when fertilized with 500 pound of 4-10-6 and side dressed with 100 pounds of Nitrate of Soda. The check plots strained hard, but made 775 pounds of seed cotton per acre without fertilizer and without nitrate.

Study your crop! When the pale yellow color begins to appear in the leaves, the cotton is sick—starving for nitrogen, crying for help—and you above all, are able to come to the rescue and cure the ailment by applying quickly available nitrogen at the proper time.—(H. L. Meacham, Agriculturist of the Arcadian Grower).

Dallas Thornton, with the club last year, is working in the Canal Zone and will not return this season.

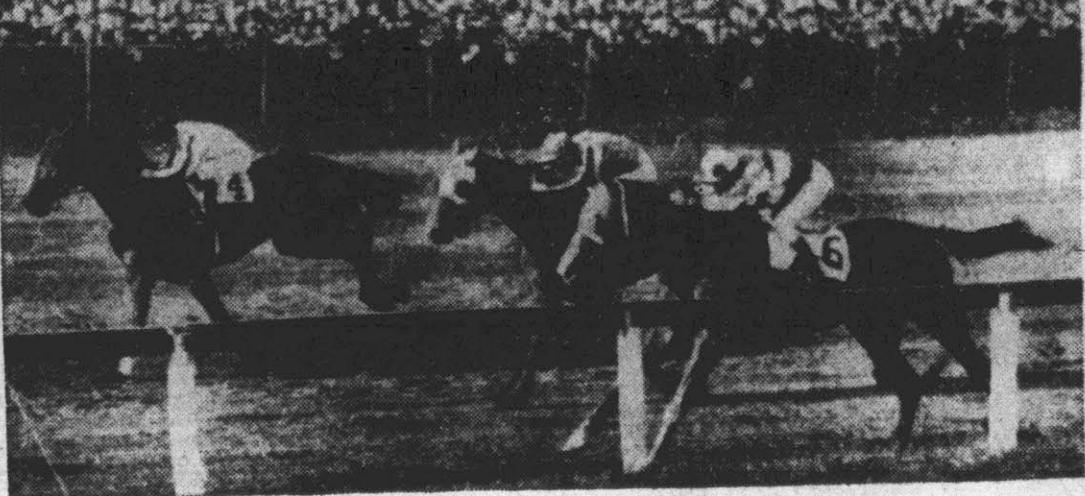

PRAISE WON BY TEXTILE FIRMS

Lauded By Shuford For Stand on Wage And Hour Law

By Staff Correspondent
 Reidsville, April 19.—Commissioner of Labor Forrest H. Shuford this morning lauded the attitude of North Carolina's textile industry toward the federal wage and hour law and promised operators "full cooperation" in strict, but fair, enforcement of the statute.

He spoke before the northern North Carolina-Virginia division of the Southern Textile Association. The commissioner pointed out sharp contrast between recent action of a wage-hour committee of the industry in recommending a 37% cent hourly minimum and the long scabbling something more than a year ago over a proposal for a 32% cent minimum. On the recent committee, he cited, there were three North Carolinians and of the 21 member group no less than ten were southerners.

"In my opinion this indicates most clearly that southern representatives of this industry have accepted fully in principle the wage and hour law and have found that the minimum wage and overtime provisions of the act have aided rather than hindered the industry," he said.

He told the convention that complete administration of the wage and hour law in North Carolina has been placed in the hands of the State Department of Labor—the first such agreement in the country.

"I urge and believe that I will receive your full cooperation in this administration," he said. "I say to you that we will offer you every cooperation. It will be my duty to bring willful violators into line

with employment policies which are in conformity with the act.

"Only a short time ago it was found necessary to bring criminal action against a textile firm, and a fine of more than \$5,000 was imposed. On the other hand, most firms have come into voluntary compliance, making restitution payments for past violations. Such a method of settling should be preferred by all."

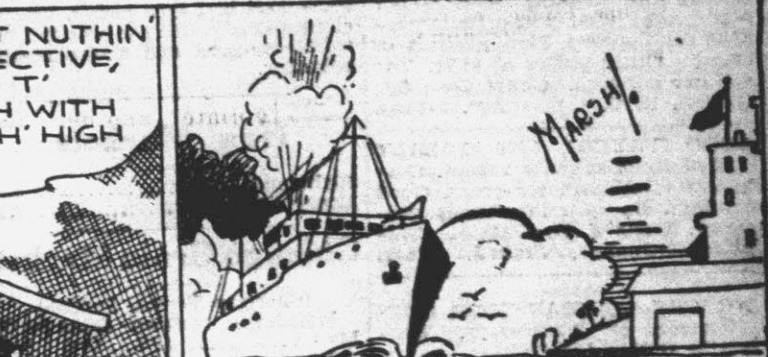

BERRY MARKET TO OPEN SOON

Auctions To Get Under Way On Friday This Week

Raleigh, April 21—Strawberry auction markets in North Carolina are scheduled to begin sales April 25, Harry T. Westcott, marketing specialist of the State Department of Agriculture, announced today. Auction markets are located at: Chadbourn, Wallace, Mount Olive, Warsaw, Rose Hill, Burgaw and Tabor City. Meanwhile, Commissioner of Agriculture W. Kerr Scott has assigned three marketing specialists to the strawberry areas to assist growers in improving their grading and packing methods. In addition, 40 federal-state berry inspectors will be used in the area to grade the crop. Westcott said that harvest of the Klondyke strawberry crop is scheduled in the Chadbourn area April 25 or 26 with peak shipments anticipated by the week of May 5 while the Blakemore and Missionary varieties are scheduled to be moving in the Wallace area by April 28. North Carolina growers expect to harvest their 1941 crop from 7,500 acres compared with 6,000 last season. The strawberry crop last year brought farmers a total of \$1,836,000, or an average of \$3.40 per 24-quart crate compared with \$2.60 in 1939. An additional marketing service to be rendered by the Department will include a daily market news service on berry prices, shipments and timely information from competing areas. A movie on strawberry grading and packing will also be shown at strategic marketing points in the state. "A decided improvement in the packing of berries during the past several seasons has resulted from the enlarged marketing program of the department," Westcott added. "We believe the 1941 marketing program will bring even better results."

This is the first of a series of three lectures on the subject of cancer to be given to the citizens of Greenville and Pitt county. Tomorrow, Tuesday, at noon, Dr. H. B. Ivey of Goldsboro, through the cooperation of Dr. L. R. Meadows, president of East Carolina Teacher's College, will lecture in the Wright auditorium before the student body. Dr. Wooten, through the cooperation of Mrs. J. H. B. Moore, president of the Woman's club and Mrs. Walter Harrington, chairman of the health and welfare committee of the club, will give a lecture on cancer at the Woman's club at 8 p. m. tomorrow, Tuesday. This lecture is open to the public. Dr. Ennett, the local health officer, who has arranged these lectures, declared today that, regardless of the common opinion to the contrary, cancer is a very curable disease if discovered early. He stated that so important is it that people learn more about cancer, he hoped that the Woman's club would be crowded Tuesday night to hear Dr. Wooten.
