

7,000 FASCIST FORCES SURRENDERING IN ETHIOPIA

Two Former Greenville Men Feared Lost In Atlantic

WERE ON WAY SOUTH AFRICA

Ned Laughinghouse, Sr., and Paul Burton, Eastern Carolina Tobacconists, Believed To Have Been Aboard Egyptian Passenger Steamer When She Sunk; Cause Of Disaster Not Stated

Alexandria, Egypt, May 19.—(AP)—The fate of 201 passengers—including 120 Americans—aboard the Egyptian steamer Zamzam, which sank in the South Atlantic while en route from New York to Alexandria, remained unknown today.

Authorities likewise were silent on the cause which sent the 8,292-ton passenger liner to the bottom somewhere between Recife (Pernambuco), Brazil, and Capetown, Union of South Africa.

Two of the Wilson men, believed to be among the passengers of the liner Zamzam, reported sunk in the South Atlantic ocean, Ned Laughinghouse, Sr., and Paul Burton, are former residents of Greenville. Mr. Laughinghouse is a native of this county and his home in Greenville until a few years ago when he moved to Wilson to engage in the tobacco business. He is the son of the late Mr. and Mrs. J. J. Laughinghouse and brother of the late Dr. Charles O'H. Laughinghouse.

Mr. Burton came to Greenville as a small boy when his father W. T. Burton, moved to Greenville to be connected with the tobacco business. Later the family moved to Wilson, but in recent years Paul Burton has been auctioneering at one of the Greenville tobacco warehouses.

The Alexandria Navigation Company received a cable from London advising that the Zam Zam, a veteran of 3 years at sea, was missing, but there were no other details.

The United States consul general here said the 120 Americans aboard the vessel included Protestant and Catholic missionaries en route to posts in various sections of Central Africa, and a group of British-American ambulance drivers and their assistants, en route to service with British and "Free French" forces in Egypt.

She also was carrying a cargo of fertilizer, trucks, automobiles and machinery of various types and was said to have been marked plainly with the flags of non-belligerent Egypt.

When the Zam Zam arrived in New York last February before her last run back, Captain Smith reported she had made the entire trip blacked out and with radio silent commenting that although Egypt was not at war she was "considered a non-belligerent ally of Great Britain and we could not take any chances."

Wilson, May 19.—(AP)—Six Wilson tobacconists, who recently left here for South Africa, were believed today aboard the Egyptian liner Zam Zam, reported sunk in the South Atlantic ocean.

TAX PROPOSAL IS EXPLAINED

Treasury Aide Discusses Department's Suggestion

Washington, May 19.—(AP)—John L. Sullivan, assistant Secretary of the Treasury, told Congress today that revision of the excess profits tax law along lines proposed by the Treasury last fall and imposition of a six per cent income surtax would net an additional \$1,096,000,000 above present corporation taxes, a boost of \$161,500,000 from the hearings' first estimate.

He told the House Ways and Means Committee that the excess profits rates on which the Treasury based its estimates were:

Thirty-three per cent on excess profits net income in excess of a proposed credit up to 15 per cent of invested capital.

Fifty-two per cent on 15 to 30 per cent of invested capital.

Sixty-five per cent above 30 per cent.

These compared with present rates starting at 25 per cent on the first \$20,000 of excess profits net income and ranging upwards to 50 per cent above \$500,000.

Storm Visits City On Saturday Night

Greenville and surrounding sections suffered a severe wind and electrical storm shortly after dark Saturday night, many trees and electric poles being blown down and several persons having narrowly escaped serious injury or death.

Five cars were trapped on the Winterville-Ayden highway when electric line poles were blown down, breaking the wires. The wires fell across some of the cars and a pole fell across the hood of another. All occupants, however, remained in the cars until the current was cut off and patrolmen and other aid arrived.

Power lines were blown down in at least three places, blocking the roads. Electricity was cut off in sections of the city for some time. The streets were littered with limbs blown from trees and one tree was blown down on Evans street and another in front of R. M. Garrett's home on the Ayden highway.

Corporal C. R. Williams of the State Highway Patrol was thrown to the ground while pulling power lines from the cars trapped on the Ayden-Winterville highway, causing those at the scene to fear he had been electrocuted. The officer, however, had made sure the current was off before handling the wires and was none the worse for his fall.

Work Ordered Resumed In Anthracite Fields Tomorrow; 350,000 Employees Of Five Big Railroads Meanwhile Announce Decision To Wage Campaign For 30 Per Cent Salary Increases

(By The Associated Press) Operators of hard coal mines and the United Mine Workers of America (U. M. W.) tentatively agreed on a new wage contract today to increase pay of about 100,000 anthracite miners who were ordered to resume work tomorrow.

President John L. Lewis of the miners had ordered a stoppage effective yesterday. Under the tentative agreement a basic wage increase of seven and a half per cent on all contract and day rates will prevail until October 1, when it will be advanced to 10 per cent. The union has asked one dollar a day increase over the old basic rate of \$4.62 a day and a 20 per cent increase for contract workers.

Representatives of the five big railroad operating unions, representing 350,000 workers, announced in Chicago they had decided on a concerted, national campaign for a 30 per cent increase in all basic rates. They said the demands would be for raises of not less than \$1.80 a day and would be presented to the railroads June 10. No details as to present basic rates were given.

A CIO strike at the Apollo Steel Company at Apollo, Pa., affected 900 men and stopped work on about \$100,000 worth of defense orders, including galvanized sheet iron for the navy. Union leaders said they wanted a 10 cents an hour increase in the minimum wage of 53 cents hourly and restoration of a six per cent wage reduction made in 1938.

Clarence Wkstra, chairman of the Defense Mobilization Board, personally assumed the chairmanship of a panel which began efforts in Washington to end a 10-day strike of 12,000 CIO lumber workers at Seattle. The union asked a union shop, wage increases, paid vacations and other concessions, but no details were revealed.

Striking AFL and CIO machinists of 11 San Francisco bay area shipyards faced today a threat by AFL unions to break the picket lines unless the walkout ended.

The Bay City's Metal Trades Council voted yesterday to send 15,000 workers past the pickets to resume production of \$500,000,000 of defense orders. Action was deferred, however, until after a meeting tomorrow night at which Governor Culbert L. Olson will appear to the 17,000 strikers to get back on the job in the interests of national defense.

John Robert Tucker, 79, of Pactolus township, died Saturday night at his home at 10 o'clock after an illness of four months.

Funeral services were conducted this afternoon at three o'clock at the home by his pastor, Rev. W. A. Crow, of Grimesland, and pastor of Salem Methodist church at Simpson. Burial followed in the Greenwood cemetery in Greenville.

Mr. Tucker is survived by his wife, Sarah McGowan Tucker; four sons, J. C. and J. H. of Grimesland, rt. 1; C. L. and C. M. Tucker of Pactolus community; three daughters, Mrs. J. M. Taft of Greenville, Mrs. J. Russell Stancill, Falkland highway; and Mrs. W. W. Graham of Hamlet; twenty grandchildren and two great grandchildren; one sister, Mrs. Betty McGowan of Greenville; one half brother, W. E. Tucker of Simpson.

Mr. Tucker was born and reared and lived in the Simpson community until seven years ago when they moved to the Pactolus community. He was well known and widely connected throughout the Eastern part of the county.

PLAN DISCLOSE VICHY - BERLIN ARRANGEMENTS

Official German Communique Expected Tomorrow

ARMISTICE MAY BE ALLEVIATED

Conviction Prevails in Berlin That France To Take Measures Against British In Syria

Berlin, May 19.—(AP)—An official communique probably will be issued tomorrow announcing what new arrangements have been made between the French and German governments as a result of the recent conversations, authorized sources said today.

A part of these new arrangements, it was indicated, will likely be certain alleviations in the armistice conditions. These alleviations, it was indicated, will result from the conversations Adolf Hitler, Foreign Minister Joachim Von Ribbentrop and Otto Abetz, the German ambassador to Paris, have held with French Vice Premier Admiral Jean Darlan and Fernand De Brinon, the French representative to German authorities in Paris.

The conviction also prevailed in the German foreign office that France would take "defensive measures" against the British as a result of the air bombardment of Syria. Rumors that Paris would be included in the un-occupied zone as a result of tomorrow's communique were declared to be unfounded.

Five Are Injured In Highway Wreck

Five persons were injured—one perhaps fatally—during a heavy rain about 10:15 o'clock Saturday night when a fire on their automobile blew out on the Cox Mill highway about three miles from Greenville.

Dennis E. Sutton, 17, of Greenville Route Five, was driving the car. After the tire blew out he lost control of the vehicle and it struck a produce truck being driven by Frank Hayes of Durbin.

Dollie Ruth Mills, 16, of Greenville Route Two, suffered a fractured skull and severe lacerations about the head and face. She is confined to the local hospital in a critical condition.

Mamie Ruth Mills, 16, of Greenville Route Two, a cousin of the critically injured girl, suffered cuts about the face and bruises of the body. Odell Mills, 15, sister of Mamie Ruth, also suffered bruises and lacerations. Joseph Tripp, 18, of Greenville Route Five, sustained cuts on the head. Sutton, the driver, was cut on the head and face and suffered a shoulder injury.

Mrs. Powell, sister-in-law of D. B. Powell, local railroad man, is a native of Ashton, N. C. Her husband, a native of Warsaw, sailed a few days before she left New York and was reported safe in South Africa.

Their only child, a daughter, Mary Hester Powell, is a student at Meredith college, Raleigh.

SEVEN KILLED IN EXPLOSION

Two of Boat Victims Nephews Of M. O. Minges

Elbert Griffin of Rocky Mount, and T. W. Cothran of Salisbury, two of the victims in the boat explosion in Little River inlet yesterday were nephews of M. O. Minges of this city and both were employed by the local man's brother, L. L. Minges of Rocky Mount, operator of bottling plants in that city and also in Salisbury.

Seven persons died following the explosion aboard the excursion boat Nightingale. Fourteen others were injured as the boat burned to the water's edge.

The blast occurred while the boat, along with two more in the party, was anchored in a calm sea about 12 miles out.

One of the passengers was quoted as saying that members of the crew working on the engine had been pouring gasoline from a five-gallon container into soft drink bottles and that someone struck a match in the room, setting fire to the gasoline fumes.

Victims besides Griffin and Cothran were G. A. Barber of Salisbury, George B. Barfield, whose bodies were found shortly after the explosion, and Grey Barber, Jr., and Jerry Barber, brothers, and Shelton Lesler of Salisbury, whose bodies were not discovered.

More On Hess

London, May 19.—(AP)—A British Broadcasting Company broadcast to Germany said today that Rudolf Hess, the run-away lieutenant fuedler, had been "just writing and talking" for a week and that Prime Minister Churchill had received a "full report of his many statements."

"A clue to the reason why Hess has lost his confidence in the possibility of a German victory may be found in a recent number of the Zeitschrift Fur Geopolitik, the organ of his friend, Major General Professor Doctor Haushofer, whose arrest has been reported and denied in Berlin.

"Haushofer was frank enough to express considerable pessimism about Germany's prospects in view of the United States intervention in the war."

Forest Fires Raging In Eastern Carolina

Forest fires are raging in Carteret and Craven counties to such an extent that motorists report they were forced to close their windows to keep out smoke and sparks and, in one instance, had to drive through fire across the highway.

Persons going to Atlantic Beach Saturday afternoon and night had to close their windows to keep out the dense smoke and the same situation was in evidence upon their return last night.

Mrs. E. L. Henderson, returning last night with a load of Girl Scouts who had spent the week-end at the beach, reported that in one instance she had to run through fire across the highway.

Free Indian Soldiers Berlin.—(AP)—German authorities have ordered the release of all natives of India detained in civil internment camps for British subjects in occupied France. The gesture, it was emphasized here, was "an additional sign of Germany's friendship and sympathy for India."

In the summer session of East Carolina Teachers College, the first six weeks of which will begin on Thursday, June 5, with registration, and close on Wednesday, July 16, and the second six weeks of which will run from July 17 to August 23 graduate work will be given special emphasis because of requirements that are being set up for work beyond the Bachelor's degree for superintendents, principals, and high school teachers.

Departments that will be offering graduate work are science, mathematics, home economics, English, history, social science, secondary education, and administration and offered is planned to care for both those students who are working toward a Master's degree and those who wish merely to study beyond their undergraduate work without reference to further degrees.

Superintendent Ray Armstrong of the Goldsboro City schools, one of the outstanding superintendents in the state, will give the courses scheduled for principals.

Military authorities at Fort Bragg stated that Corp. Munford's promotion was based on his attention to duty and soldierly qualities.

Commander Is Granted Another Day

Capitulation Of Duke Of Aosta And Staff Allowed Full Day In Which To Collect Wounded After Request Made To British Authorities; No Change On Other African Fronts

Cairo, May 19.—(AP)—About 7,000 Italian soldiers are surrendering in Ethiopia today and their commander at Amba Alaji, the Duke of Aosta, and his staff will surrender at noon tomorrow, the British officially announced today.

The Italian capitulation at their last major stronghold in northeast Ethiopia came after the Italians were allowed one full day in which to collect their wounded, a communique said.

The provision that Aosta, accompanied by General Trezzani and all the Duke's personal staff, surrender at noon tomorrow, was made in compliance with his urgent request it was said.

On the North African front, two Axis columns which crossed the Egyptian frontier with the support of numerous tanks, were declared to have been forced to withdraw when they were engaged by British mechanized forces.

No change was reported in the situation at Tobruk. Likewise, no change was reported in Iraq, where it was said Basra and Habbaniyah remained quiet.

In northwestern Ethiopia, however, Ethiopian natives were reported to have captured an "important position" in the Gondar sector after inflicting severe casualties.

The communique said the "whole of the forces in the area" of Amba Alaji, a 9,000-foot high mountain 280 miles northeast of Addis Ababa, were surrendering and that "it is estimated the prisoners will number 7,000, together with considerable quantities of guns and material."

The delay in the Duke's personal surrender, it was said, was due to his desire to be the last man to leave.

The figures on actual prisoners expected to be taken differed from previous estimates that 35,000 to 38,000 troops, including 7,000 Italians had been trapped at Amba Alaji.

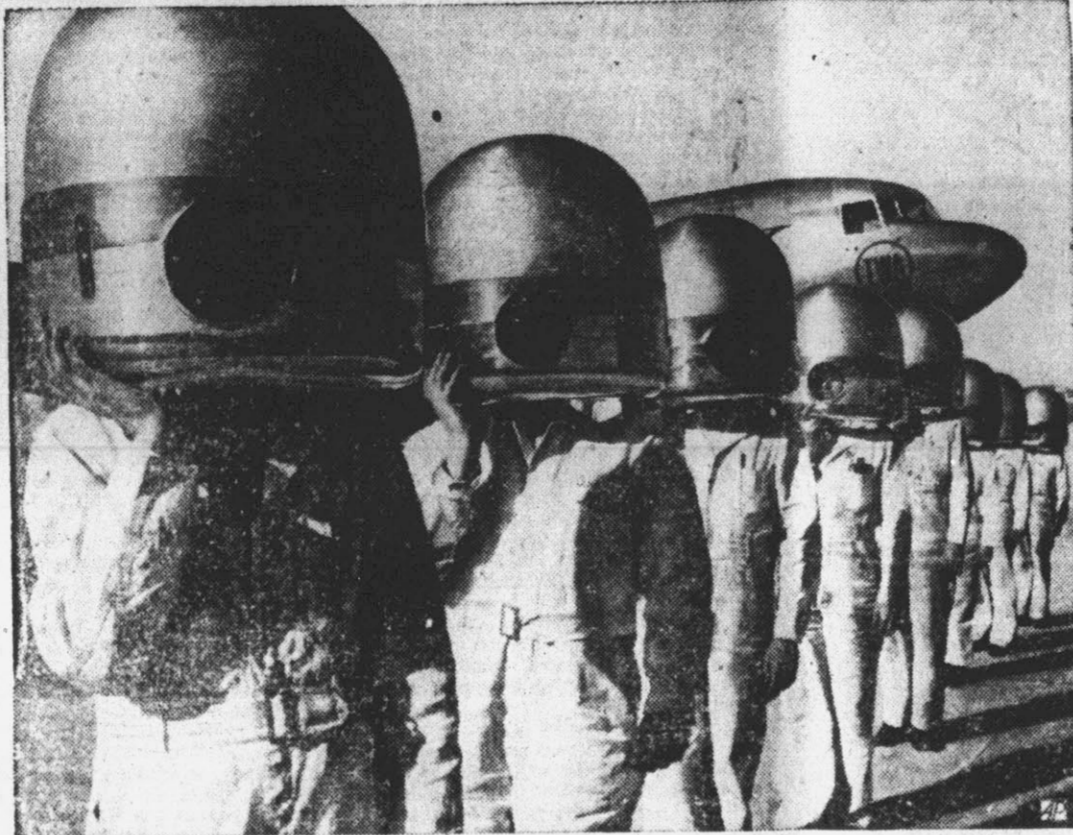

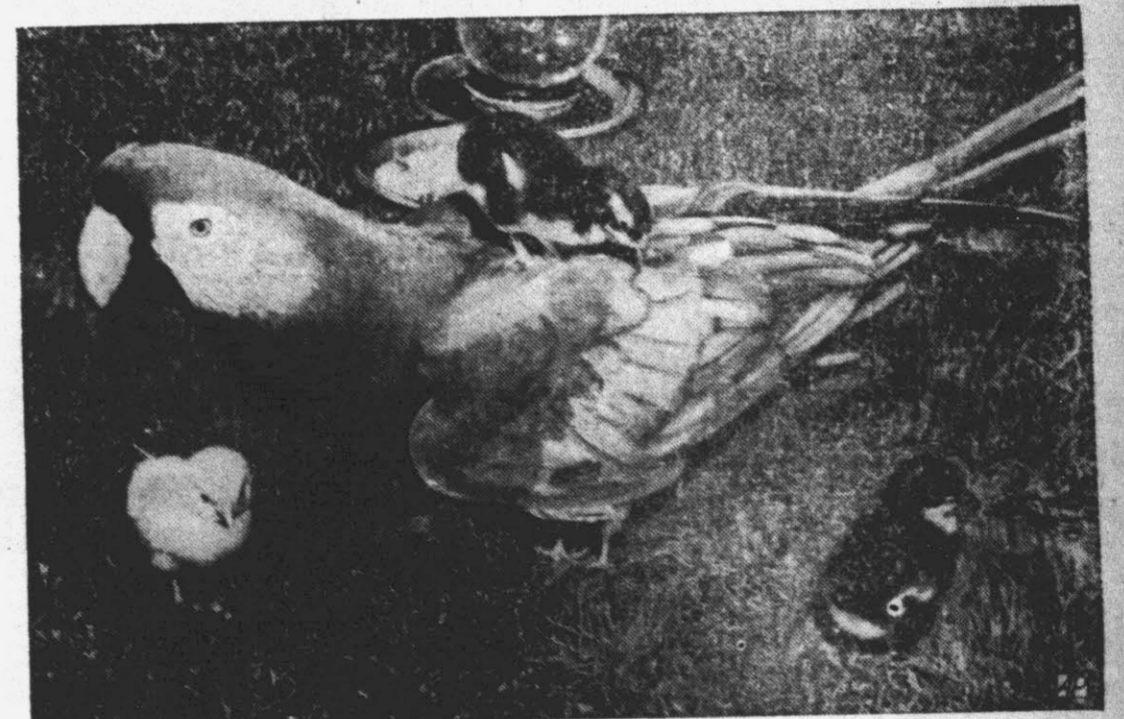

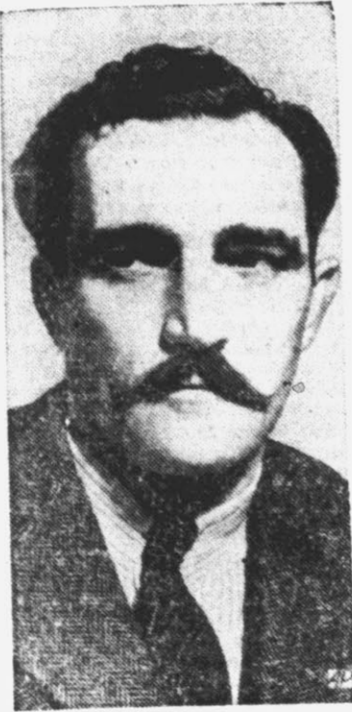

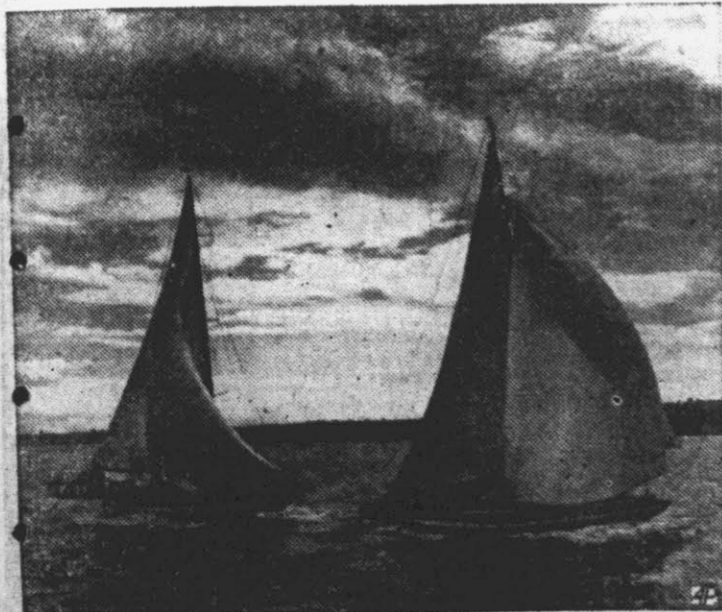

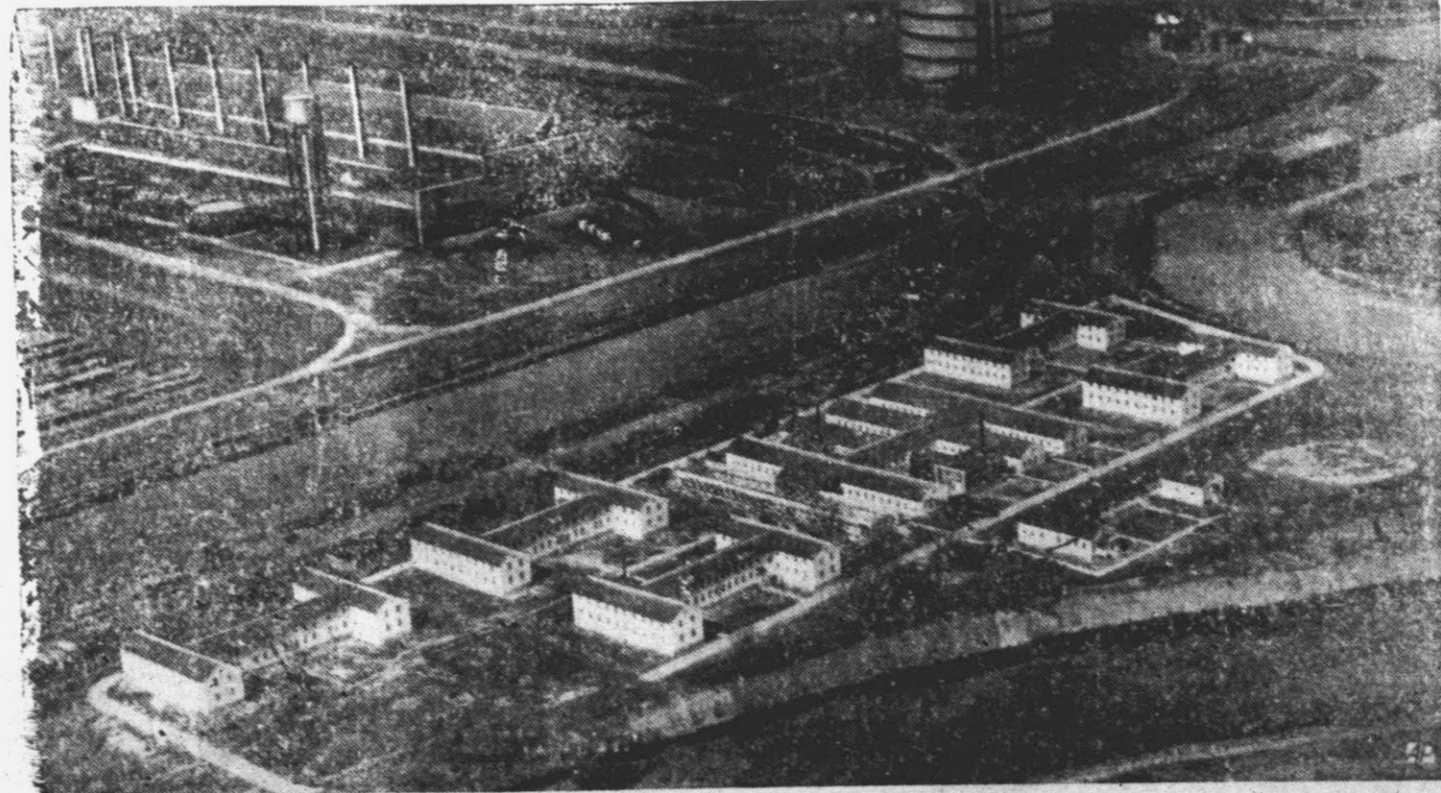

HESS' CAPTURE DOES NOT CHANGE WAR PICTURE

In the excitement following the fantastic capture of Rudolph Hess, No. 3 Nazi, in Scotland, there is danger that the people of the United States will lose sight of the important fact about the war.

The postponement of President Franklin D. Roosevelt's long-awaited speech from May 14 to May 27 has probably delayed any official United States action on the convoy issue.

The capture of Rudolph Hess does not necessarily mean that the Nazi machine is ready to collapse. German successes to date have proved that Adolf Hitler still maintains a united nation

behind him. It is inconceivable that the Nazis would collapse internally at the peak of their war effort. If the German people ever do revolt, it will probably follow severe reverses in the war.

In this country the issue is still clear. To gain time properly to prepare the Army, Navy and Air Force the United States must see that goods manufactured for Britain under the Lend-Lease bill arrive on English shores in every increasing amounts.

Washington Daybook
By Jack Stinnett

(Last of three articles on the farmer and national defense.)

Washington — In spite of the lend-lease program, which farm experts are estimating will shortly double agricultural exports from recent low levels, the most heartening thing to the American farmer in the national defense picture is the great increase in domestic consumer demand.

Although purchases for use in other democracies are supposed to be quite a secret, I could point out that since the lend-lease act has become operative, the Department of Agriculture has reported weekly purchases of such things as dry beans, 16,120,000 pounds; cheese, 3,018,000 pounds; shell eggs, about 142,000 cases; fresh carrots, 138 tons; evaporated milk, 138,000 cases; canned tomatoes, 618,975 cases; lard, nearly 22,000,000 pounds; and pork products, 40,419,000 pounds.

The only reason these figures are worth putting down is that these are some of the products Great Britain needs badly. With every report of purchase, the Agriculture Department is careful to point out that these purchases are made for domestic distribution to public aid families and for free school lunches.

Experts Not Enough. There is no doubt but that all of this is true, but increased purchases of products needed badly in the war countries is undoubtedly a major factor.

In the United States. This is almost too obvious to need explaining by figures. To put it as briefly as possible: The Bureau of Agricultural Economics has done it out that factory wages are about twice what they were in the very early 1920's and three times what they were at the bottom of the depression in 1932-33.

Not only that, but all employment has improved both in numbers and wages. The Bureau estimates that the net contribution of the federal government to the national buying power will be 10 billion dollars compared with four billion in 1940.

"Food For Peace." In conclusion, I want to give an informal quote from Secretary of Agriculture Wickard, for it seems to sum up the report's long-view program: "In this war food will be more important than guns. I believe that. Some people haven't realized it yet.

"It is up to us to provide food for defense and RESERVES of food for peace."

"One other thing is on my mind. If war ceases today or tomorrow, there would be more demand for some of these foods than there is now. The longer the war goes on the greater the post-war demand will be.

"I suspect that if some of these people representing undernourished and underfed people find that in America there is plenty of food, and some to spare for them, that they may have some bearing on the attitude of those representatives.

"It is up to us to provide food for defense and RESERVES of food for peace."

when he could have kept out with great ease and grace? But above all of these—why has the Raleigh News and Observer, which has poked its finger into practically every political pot within the memory of man—preserved such a solemn, somber silence in its editorial columns?

Could it be torn between the Rooseveltian appeal of the Reynolds and its timid toadyism to Governor Broughton? The N. C. State Employment Service cites a good example of co-operation all along the line, resulting in employment for a dozen high school graduates.

During March, last month for which complete figures are available, less than 70,000 of North Carolina's three and a half million people received public financial assistance in one form or another.

Exact total was 68,859 made up as follows: Old Age Assistance 37,095; dependent children 23,627; general relief 5,274; and other financial relief 2,863.

Applicants for relief who received none were: old age assistance 1,419; dependent children 1,265; general relief 2,333; and other financial assistance 1,749.

John W. Lancaster, a candidate for commissioner of public safety in Raleigh's municipal primary, reported campaign expenditures of \$10. He got 17 votes; which figures a rough average of 60 cents per vote.

As the result of recent political upheavals Raleigh is about to swap a chief of detectives for a prison identification expert.

The hope is that Bruce Poole, detective chief beaten in a race for city commissioner, will become assistant warden at state prison, while J. Winder Bryan, prison identification head, has been named Raleigh's next police chief.

CITIZENSHIP AND NATIONAL DEFENSE

Congress designated Sunday, May 18 as Citizenship Day for the observance and commemoration of American citizenship. President Roosevelt issued a proclamation setting aside this day for the public recognition of all persons who by coming of age, or through naturalization, have attained citizenship of the United States.

There are several reasons why we should be proud of being an American citizen. The following are only a few reasons:

1. Because of the unlimited natural resources of our country. It has been said that the United States is the richest country in the world from the standpoint of natural resources. We have surplus food enough to supply certain other countries with a goodly share. This year the underprivileged as well as the privileged school children, have been permitted to eat hot lunches every school day this year.

We have coal, timber, metal and many other products for our own consumption. In fact, we have enough natural resources to convert into war material for our own army and to lend or lease to other democracies across the waters.

Every citizen in our American way of living has the opportunity to worship God according to the dictates of his own conscience. In certain other countries the state dictates the religion of its citizens. They build their religious creed on

exploitation and suppressing the minority groups and build the state on hatred for other countries. 3. Another reason why we should be proud to be an American citizen is because of its history. Of all the shameful mistakes recorded in our American history, there is one thing that overshadows all of them: The purpose for which America was founded. It seemed that during the early part of our American history, his fair land of ours served as a "haven" for those men and women seeking religious, political and economic freedom.

There are many other things we as American citizens should be proud of, but space will not allow me to go farther, but now, what can we Americans contribute to the national defense? 1. Our government does not need guns and tanks as much as it needs men and women who are strong and healthy, morally fit, mind free of prejudice, hatred and injustice.

2. Another way of aiding our national defense program in which every citizen can help, both young and old, is by buying postage stamps and bonds. This program is of two-fold: first it teaches thrift, and second, it aids the government in its vast spending program for defense.

3. Another suggestion is that of not jumping at hasty conclusions based on war propaganda. This is dangerous to the morale of each citizen. Let us do our own thinking based not only on what we read ourselves, but ideas and thoughts of our American statesmen who are more in touch with national and international problems and are also more informed.

4. My last suggestion is, beware of forces in our midst that are non-American. Beware! Beware of forces in our midst that are seeking to hear down our American ideals and principles. Beware of individuals who are trying to destroy our government and our democratic way of life.

There are certain forces in America who construct their political and religious creed on the word "Down." They say: Down with Democracy! Down with the rich! Down with capitalism! Down with individual liberty! Down with religion! Down with God; Can be build anything on the word "Down"? Let us as American citizens build our creed on the word "Up." Up with Democracy! Up from class and race hatred! Up with individual liberty! Up from prejudice! Up from injustice! Up with religion! Up to the stars! Up to eternity! Up to God!

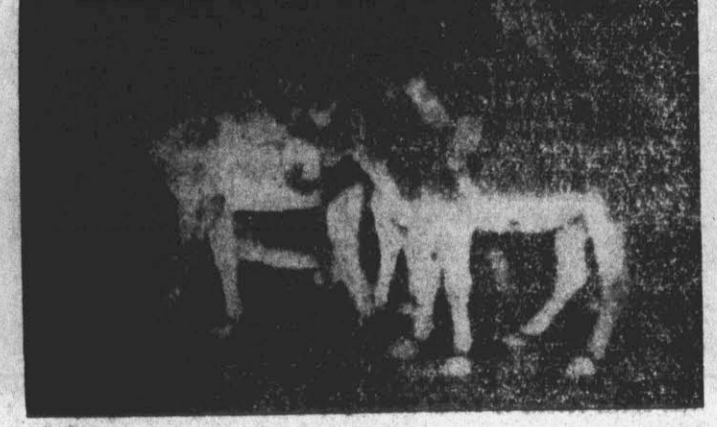

"When dark comes, flames are supposed to dance above the tomb." He took a pipe out of his pocket and put it back again. "Have you eyes to see such things?"

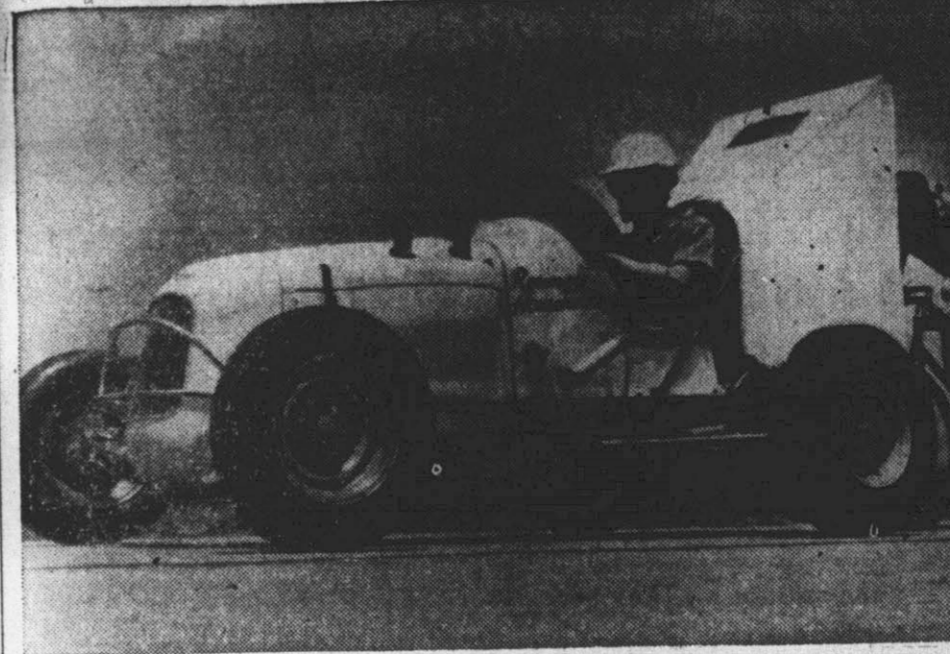
"No," she admitted. And she realized what it would be like here if he might be an enemy or a spy or just a coincidence, he was still a gift from the gods. She made a deliberate decision.

National Committeeman To Be Named On Friday

Raleigh, May 19—There are no hard and fast rules for conduct of Democratic state executive committee meetings, and so the session Friday at which a national committeeman is to be selected will have to set up its own procedure as it goes along.

Chairman E. B. Denny will preside and the course of events will be directed by him. Secretary Arch T. Allen, of Raleigh, said Saturday that he had not conferred with Mr. Denny and, therefore, could not give any guaranteed order of business; but added that he assumed the agenda would be something like this:

First will come a roll call of the committee, which is composed of 12 members from each of the state's eleven congressional districts, the chairman, the vice chairman, the secretary and the president of the Young Democratic Clubs. That makes 136 in all, and so a total of 69 votes is needed for a majority.

As the roll is called there will be, of course, no question about these members, who are present in person, but proxies are permissible and there is in progress a hot fight to get these proxies for former Governor Clyde R. Hoey, on the one hand, and for R. J. Reynolds, Jr., treasurer of the Democratic national committee on the other. Should it appear that more than one person holds the proxy of any absent member, it will be necessary to determine which is valid and for that purpose there either will be a special credentials committee (named probably by the chairman after consultation with the floor leaders of the Reynolds and Hoey forces) or it will be necessary for the whole committee to decide by vote.

After the roll call is completed business of the session will be taken up—and the election of a national committeeman is the business for which the state committee session was called.

That calls for nominations, and despite the fact that the race seems strictly between Hoey and Reynolds there is a ways the possibility of other nominations.

Next will come a question which might conceivably decide the result—how shall the voting be conducted? By roll call with each committeeman answering aloud for his favorite? By secret ballot with each committeeman going forward and depositing his ballot as his name is called?

There's no party rule requiring any set method and so it will be up to the committee to make its own regulations. Mr. Allen said he expects floor leaders for the rivals to agree on some method prior to the meeting. If this proves correct then action will likely be taken on suggestions of the chairman, and without objection.

There is one very definite rule. To be elected a candidate must have a majority of the ballots cast. Thus a third candidate with one vote could force a second ballot in a tight race. (Hoey 68, Reynolds 67, Rucker , for instance.) If there is no majority on the first ballot, successive ballots are taken until there is a majority for some candidate.

Actually, of course, nobody expects any such development. There

is every reason to believe that it will be straightaway battle with Clyde R. Hoey, of Shelby, in one corner and Richard J. Reynolds, Jr., of Winston-Salem in the other.

In view of the numerous examples in recent years even the prediction of a two-handed contest is the height of temerity, so many prospective duels having collapsed at the last minute. Just last January George Uzzell vowed he'd be a Speakership nominee "if my colleague will put my name up"; but when the voting time came Odus Mull's name was alone before the House.

Missionary Heard At Local Service

Gifted young people were challenged to volunteer for Christian Service in spite of its hardships by Miss Bessie Oliver, field secretary of Scarritt College, and recently returned missionary from Korea where she was an ordained minister in the Korean Methodist church, who told of her experiences in the Korean mission field last night at the evening service at Jarvis Memorial Methodist church.

"The whole world has its eyes trained on the Christian church today. If we will combine the forces of democracy and Christianity they will be a real force in the world.

"The greatest need of the Christian church today in this country as well as others is trained leaders. Nothing can uphold the Christian faith in peoples. Material things can be destroyed but not the soul. After the world turmoil of today is over, there will be a greater opportunity for missions," declared Miss Oliver.

Miss Oliver explained that though she had not expected to come home until 1946 for another leave, it would not have advanced the Kingdom of God by remaining in Korea. But that by coming it might help and then return after a season. Coming home is something she declared harder for her than facing death.

The story of the beginning of missions in Korea was related by the speaker. A nobleman forced to leave Korea some years ago due to political conditions fled to Shanghai, China. There he met Christians and was converted. Subsequently he came to the United States to be educated. Here he found Christian people and on returning to Korea resolved to have Christianity brought to his people. His efforts brought missionaries. He gave money to promote the work. The message of Christianity has gone to all the people.

The first problem for the missionaries in this new field was to learn the language and translate the Bible. For the first few years the main efforts of the missionaries were educational—establishing schools, etc. A long list of firsts in educational achievements, promotion of learning, and training of doctors were told of.

In telling of the results of Christian work in Korea Miss Oliver told of the growth of the church from not enough native ministers for conference to an autonomous church for Korea and with three conferences. Now the Korean church is able to carry on without the missionaries who had to be recalled. The intelligensia of Korea are Christian—the intelligensia were created by the missionaries.

Next Miss Oliver related the circumstances surrounding the conversion of a few Koreans and their subsequent unflinching service to their religion in the face of persecution even torture at the hands of the Japanese after they took over little Korea. But all the Koreans are willing to accept the persecution and torture to keep their Christianity. Persecution temporarily stopped one while but recently the Japanese started it again. But nothing can uproot the Christianity in the hearts of the Koreans Miss Oliver declared and plan.

"It is by conquering things within ourselves that we master doubts. If a man is selfish, he never knows there is a fuller life. The most pitiful life can blossom again if it learns how to bloom for others.

"My Master did not say that maybe there was a God. He said there was a fuller life for he knew God. He said in language of sincere and fine confidence, 'You who have seen me have seen the Father.'" Mr. Grant said in conclusion.

"We do not know what is awaiting the world if the Nazis overcome England, but God is in heaven and will come into our lives if we will but let him, and he will bring us the understanding that there is a full life intended for men," declared Rev. Thomas M. Grant, pastor, in his sermon yesterday morning at Jarvis Memorial Methodist Church.

"We have advanced greatly in physical knowledge but not in believing the Master's statement that there is a full life." This statement was preceded by picturing the doubts that assail one in all fields of knowledge and science.

It was possible for her, a woman, to be ordained due to the general conference of the Southern Methodist church in 1930 at their general conference setting up an autonomous church in Korea.
