

NAZIS ACKNOWLEDGE BITTER SOVIET RESISTANCE

SEEKS REPEAL OF CURFEW ON GAS STATIONS

Action Urged By American Automobile Association

BAN DESCRIBED AS UNNECESSARY

Spokesman Declares Trial Has Shown None Of Saving In Operating Cost Passed On To Consumer

Washington, Sept. 8. — (AP)—The American Automobile Association urged today that the eastern seaboard's 7 p. m. gasoline "curfew" be lifted, on the grounds that it was an "unnecessary inconvenience" which has had little or no effect in conserving the East's supply of motor fuel.

This was one of several recommendations made by Russell E. Singer, general manager of the association, to the special Senate committee investigating the petroleum supply.

Singer asked the investigator to report that "the present night closing of gasoline filling stations is not in the public interest and is not justified as a means of gasoline conservation."

"It is already evident," he said "that none of the savings by retail outlets in the form of lower operating costs is being passed along to consumers."

Singer also urged that the committee continue to function for the duration of the emergency "to assure a carrying-through of the steps already taken to relieve the oil shortage and also to guarantee to the public that all concerned meet their responsibility to the uses of petroleum products."

In another recommendation he asked the committee to "use the full weight of its great influence to see that any threatened gasoline shortage is not used as a means of boosting prices." He said his organization had found "widespread disregard" by gasoline retailers of a "fair price schedule" promulgated by the Federal Price Administration.

Jews In Hannover Told To Evacuate

Berlin, Sept. 8.—(AP)—Hundreds of Jews in Hannover received notices today to evacuate their homes within 24 hours.

They were permitted to take only "the most necessary objects and furniture" and advised that the remainder of their property would be sold, the proceeds to be turned over to them "at a given time."

One reason cited for the action was said to have been a book written by the Jew Kaufmann in New York. The book, it was alleged, demands sterilization of all Germans and employment of German soldiers as collies in foreign lands.

(This reference apparently is to a book entitled "Germany Must Perish," by Theodore N. Kaufmann, published by the Argyle Press of Newark, N. J.)

More Reprisals

Vichy, Sept. 8.—(AP)—More than 100 Jews and two prominent French lawyers, one of them a minister of justice in the old republic, were reported today to have been seized as hostages by German occupation authorities in Paris because of attacks on members of the German army.

It was in these new mass arrests that the Germans took the two once-prominent lawyers, former Justice Minister Pierre Masse, who is a Jew, and Theodore Valensi, a former deputy, who is a native of Corsica.

MARKET SELLS HALF MILLION, HALF

More Good Tobacco Offered On Market Today

Today's sales on the Greenville tobacco market were estimated at 1,500,000 pounds, with more good tobacco and less tips being offered. The quality of the sale as a whole, however, was held down to that of the past week by the appearance of a great amount of common tips and trashy grades which are bringing from three to five cents a pound.

Except for these common grades, it was officially declared that the market today would have averaged in the 30 cents range.

Smoking types were reported to be selling stronger, with top grades bringing as high as 50 to 56 cents per pound. Such tobacco was scarce, however.

Warehouse floors were being cleared of tobacco brought here for today's sale, but already some leaf was on the floors for Tuesday's sale.

R. C. Rankin, sales supervisor, said this afternoon, however, that there was room on the floors for 1,000,000 pounds of the weed, all of which could be sold tomorrow.

Drunkenness Charges Tried In City Court

The only other defendant tried was Allen Brock, colored, convicted of driving drunk and given a six months sentence, from which he appealed to Superior court.

Many Big Fires Reported To Have Been Left In Vicinity Of Main Railway Station; Moon Shining On Lakes West Of City Guides RAF Fliers To Target; Strong Resistance Is Admitted

London, Sept. 8.—(AP)—British planes bombed a moon-lit Berlin from midnight to almost dawn this morning in a raid described officially as the heaviest ever made on the capital of the Reich.

The Air Ministry news service said the attackers found the lakes to the west of Berlin shining in bright moonlight.

The Berlin attackers were but striking regularly at the continent, regularly at the continent.

Crews returning from the German capital said that many big fires burst around a main railway station and their glow could be seen long after the bombers set out for home.

The German defenses were strong, the attackers acknowledged. Anti-aircraft was virtually incessant and stopped only to allow the approach of German night fighters.

The Press Association called the Berlin raid by a powerful force the heaviest since the war began, but no figures were issued either for the number of planes or the bomb tonnage.

The forays, highlighting a week-end of RAF attacks on a front ranging from Norway to France, were said to have been carried out in bright moonlight and good results were reported observed everywhere.

Besides the attack on Berlin—the fourth by either British or Russian planes in a little more than a week—the offensive was aimed at Bergen island off Norway, the German naval base at Kiel, the Rhineland industrial town of Huls and the French-occupied port of Boulogne.

Middle Leaf Belt Opens Tomorrow

Raleigh, Sept. 8.—(AP)—Growers of the North Carolina Middle belt placed some of their best tobacco on floors of the nine markets in anticipation of one of the best opening days in years tomorrow.

Other flue-cured belts already open in the South have averaged paying at least 25 cents a pound. The average last year on the Middle belt was 16.55.

General satisfaction has marked leaf sales on every market in the Bright and Border belts and farmers in the Middle belt areas are viewing price prospects with unrestrained optimism. The markets are Aberdeen, Carthage, Durham, Fuquay Springs, Henderson, Louisburg, Oxford, Sanford and Warren.

At Durham alone, the biggest market in the belt, about a million pounds was on the floors over the week-end.

Heavy sales of good tobacco were predicted everywhere.

Maxwell Defends Levy On Industry

Raleigh, Sept. 8.—(AP)—Revenue Commissioner A. J. Maxwell asserted today that figures compiled by a Duke University economist which purported to show that North Carolina had an unduly heavy tax on industry, were not comprehensive enough to give a fair picture of the situation.

Maxwell's statement was made at a meeting here of tax experts and commercial secretaries immediately after Dr. Ben F. Lemmert of Duke had presented his figures.

Dr. Lemmert said that a \$20,000,000 industry paid \$97,000 less in state and local taxes if located in Virginia than if located in North Carolina; and that a \$50,000,000 industry paid \$243,650 less in Virginia than in North Carolina.

Maxwell replied that this did not take all factors into account—such as, for instance, the services rendered for the tax and the fact that North Carolina levies its tax on actual valuation and not on capital stock valuation.

DAMAGED NAZI SUB CAPTURED IN ROUGH SEA

Declared U-Boat May Have Been Attacker of Greer

DOUBT HOWEVER SUCH IS THE CASE

Attack On Undersea Craft Made By One American - Built Plane; Another U.S. Plane Had Part

London, Sept. 8.—(AP)—A German submarine has been captured in the Atlantic, damaged by aerial attacks which forced it to the surface, the Admiralty and Air Ministry announced today.

The U-boat lay in a gale-tossed sea while the British kept guard in the sky overhead until British warships could reach the scene and take over and bring the prize "successfully into harbor."

The circumstances were such as might attend entrapment of the German submarine which clashed with the U. S. destroyer Greer, but the joint London communiques failed to note any connection, giving neither the precise location of the air attack, nor the date.

Naval authorities in London, however, expressed doubt that the captured submarine was the one which fought with the Greer.

(A German version of the clash, accusing the American destroyer of the first blow, indicated that the U-boat had reached port after the incident of last Thursday. U-boats seldom risk wireless communications on the high seas.)

(On the other hand, the search by air and sea for the U-boat, with the suggestion from American and British sources that the undersea craft could scarcely have penetrated the criss-crossing lines of the hunt, is still believed to be under way.)

Two American-made planes figured in the capture. The attack was made by a Hudson (Lockheed) bomber of the coastal command and a Catalina (Consolidated) patrol plane kept watch over the U-boat until surface sources arrived and took over.

Mr. Galloway was the son of the late James and Nancy Hardy Galloway. He was a member of the Eighth Street Christian church.

Surviving are his wife, Mrs. Ella Proctor Galloway; one son, R. Gentry Galloway of Norfolk, Va.; two daughters, Mrs. M. R. Long of Greenville and Mrs. Harvey Turnage of Washington, D. C.; three grandchildren, Harvey Turnage, Jr. and Betty Lou Turnage of Washington and James Scott Long of Greenville; and two brothers, Rufus and O. Jarvis Galloway of Grimesland.

Aged Man Found In Serious Condition

A 52-year-old white man of Hatteras, declared to have been "almost dead of mind and body" when picked up by officers near Sellers brick yard Saturday afternoon, was on the way to recovery and also on his way home today.

County Jailor W. G. Leggett declared the man, Tine T. Willis, who has served a first class seaman and who had papers on him showing him to have been in the naval reserve, was "exhausted of mind and body" when he was brought to the jail by Lieut. Lester Jones of the State Highway Patrol, who went to the brickyard following a call to the jail by residents of that community.

The man was said to have been seen around the place for two or three days, apparently having gone without food. Upon being brought to the jail, a doctor was called and said that there was nothing seriously wrong with him. He was given nourishment and members of his family were to come for him today.

After identifying the man, the patrol radio service was put into use and within 45 minutes a call was received from Hatteras.

Henderson Locks Horns With Rep. Martin Dies

Texas Had Asked for Dismissal of Price Administrator

Washington, Sept. 8.—(AP)—Martin Dies and Leon Henderson locked horns today over the question of whether the boss of the Office of Price Administration and four aides should be fired from the government service on the ground that they held or condoned Communistic views.

Dies, House member from Texas and chairman of the Committee on Un-American Activities, made public yesterday a letter to President Roosevelt urging that Henderson and the four employees be dismissed immediately.

To this Henderson promptly replied that he would turn the accusations over to the Civil Service Commission, and if the Commission held the employees to be unfit he would discharge them as soon as he could get to a telephone. He added, however, that "summary punitive action on the basis of one man's opinion is as 'un-American' a procedure as anything to which Mr. Dies has yet given his attention."

Raleigh, Sept. 8.—(AP)—State Selective Service quarters today announced quotas under which 685 white youths will be inducted into the army October 1 through 21, in the 18th draft call.

Quotas for the 794 Negroes who will be drafted October 24 to 30 in the 18th call probably will be announced tomorrow.

All selectees will be inducted at Fort Bragg.

Rains Help Defense Of Leningrad

German Front Line Dispatches Admit Reds Making Village - By - Village Stand In Defending Russia's Second Largest City; Entire Battlefront Active Despite Drenching Rains

(By The Associated Press)
German front line dispatches acknowledged today that the Red armies guarding Leningrad were making a village-by-village stand, under pounding by hundreds of Stuka dive-bombers, while the Russians declared they were pressing the initiative on a broad sector of the muddy, rain-soaked front.

Soviet reports said Russian troops in some of the fiercest fighting of the 79-day-old struggle, had driven the Germans from positions astride a vital railway leading to Leningrad. On the central front, a Red counter-offensive was said to be gaining momentum after recapturing several important towns.

Berlin Admits Raid On City

Assails Attacks As Low-Down And Contemptible

Berlin, Sept. 8.—(AP)—An early morning British air raid in which at least 27 inhabitants of Berlin were killed was played up under two column headlines today and one newspaper bitterly assailed the attack as "especially low-down and contemptible."

Obviously with the permission of authorities, the press went beyond the customary publication of the high command communiqué. At least a column was given to description of the attack (which the British said lasted from midnight almost to dawn and was the heaviest RAF blow on Berlin so far.)

Emphasis, however, was on "the exemplary discipline of civilians" and the care given victims.

Besides the 27 dead announced by informed sources, a number of others were injured and fear was expressed that the number of dead might increase.

Of 17 British planes downed during the night, three were said to have been bagged over Berlin.

White Man Jailed On Two-Year-Old Count

Jasper Payton, who formerly lived on the Willis McLawhorn farm off the Washington highway, but who for the past two years or so has been living in Warrenton, where he is employed by the State Highway and Public Works Commission, was arrested by members of the sheriff's department yesterday and is being held in county jail on a charge of breaking, entering and larceny.

Officers who arrested the man last night as he was on his way back to Warrenton, reported that Payton told them this was the first time he had been back to the county since the alleged crime.

According to the officers, Payton stole \$73 from Mrs. J. E. Smith, who also lived on the McLawhorn farm, in August, 1939. Mrs. Smith was said to have saved the money from small amounts earned by odd jobs.

Bond was fixed at \$500, which Payton was unable to provide.

Injured In Shoulder When Gun Discharges

Frank Brannon received superficial wounds yesterday when a shotgun he was holding was said to have accidentally discharged, several of the shot entering his shoulder.

The man was at the Greenville Stockyards at the time of the accident.

He was taken to the hospital where his wounds were dressed and he was released.

McKinley Assassinated.
Buffalo, Sept. 7.—President William McKinley was shot at 4 o'clock Friday afternoon in the Pan-American exposition grounds. The shooting was by an anarchist named Nieman from Detroit, Mich. The man had gone up in the crowd and was shaking hands with the President with his right hand when he drew a pistol and shot him with the left hand. One ball took effect in the breast and the other in the abdomen. Nieman was promptly arrested and is closely confined.

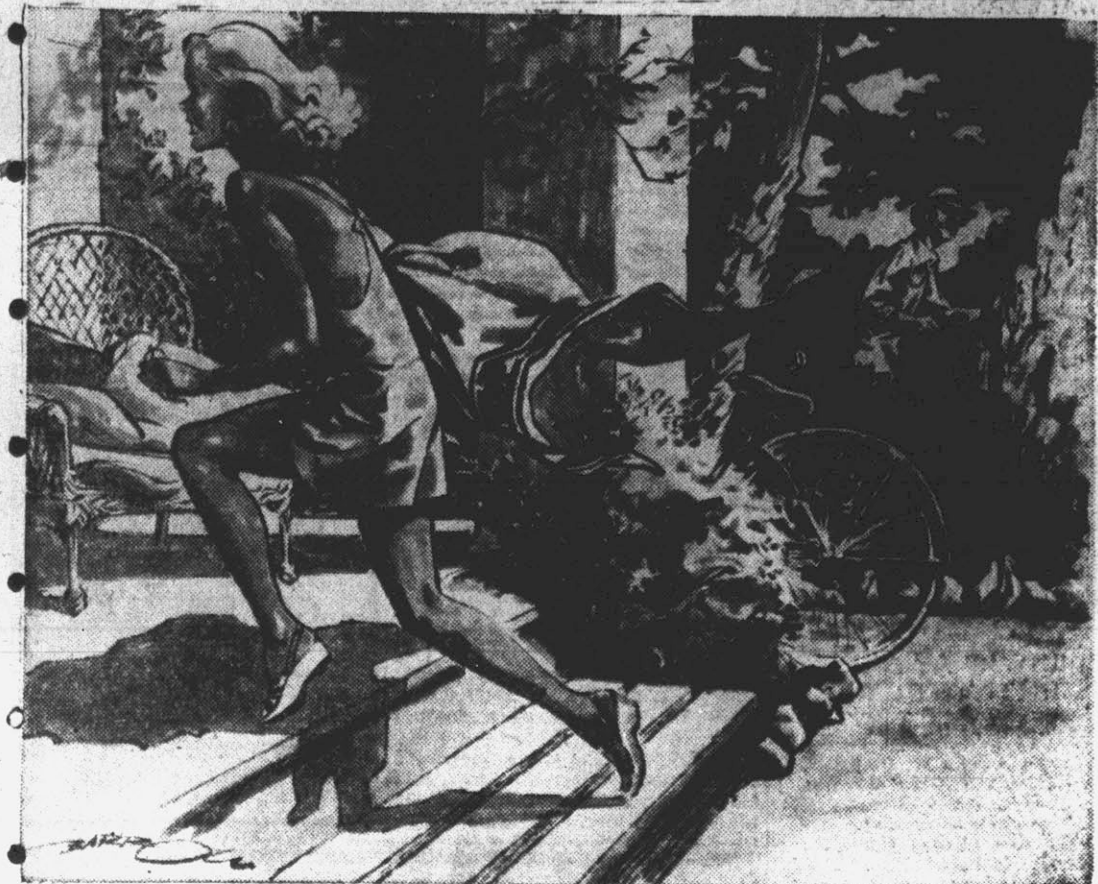

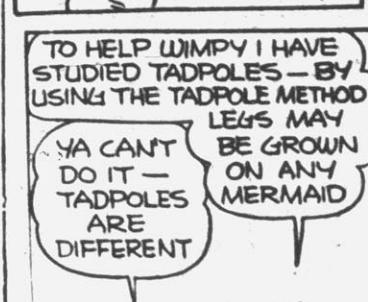

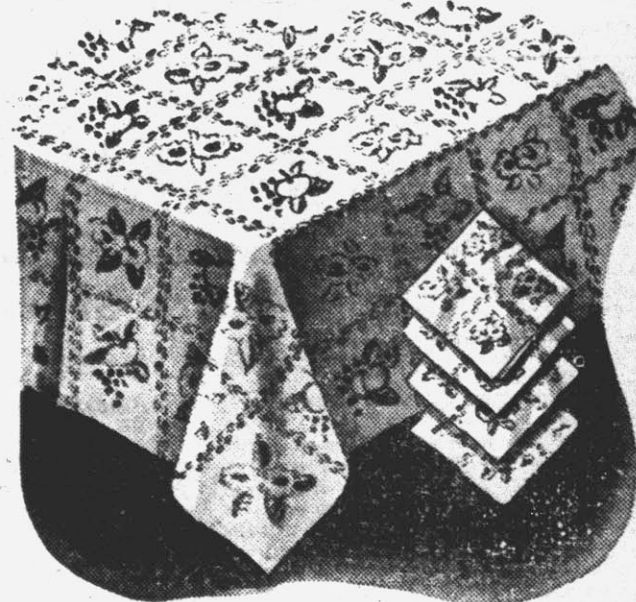

Washington Daybook
By Jack Stinson

Washington—There's a quite a brawl brewing here over the oily subject of butter versus margarine.

It's no new brawl. The current fracas dates from spring, when a committee on food and nutrition met to devise new methods for feeding America better with the hope of making the citizens stronger. The problem is part of the defense program so far as Washington is concerned.

The committee issued, among other things, a sample day's diet which would furnish the necessary vitamins and minerals, and still would cost only 32 cents for the three meals. The menus—all three of them—mentioned margarine, but not butter.

That prompted the Consumers' Council of the Department of Agriculture to arrange one of its weekly radio programs for a discussion of margarine.

One of the characters on the program said: "Many people are finding out they can save quite a bit of money by using margarine instead of butter. It's quite a lot cheaper."

Both butter and margarine are chiefly fat. By law or government rules, both must be at least 80 per cent fat. Butter is made from the fat of cream. And margarine, according to new standards just set up, can be made from animal fat or oil, or vegetable fat or oil, or a combination.

"There's little to choose between the various kinds of pure fats. They are all, more or less, equally digestible, and equally rich in fuel value."

Propaganda, Says Andersen
That brought Rep. August H. Andersen of Minnesota to his feet on the House floor. His state, in 1940, earned \$28,000,000 from butter.

Andersen spoke of the program as "government sponsored propaganda" and called it "virtually a conspiracy against the farmers."

He said the radio performers did their level best to put over the idea that oleomargarine, under the new formula promulgated by the food and drug administration, was equal if not superior to butter in food value, and dadded that "the boldly urged consumers to buy oleo instead of butter."

Andersen asserted that in the past decade he has seen much of "the subversive work of lavender law-ymers, pink economists, and mauve home economic ladies."

He demanded an investigation, and further, he wanted the Department of Agriculture to stop its employees from "scuttling of American dairy farmers."

The Other Side
Rep. W. R. Poage of Texas, arose to remind his fellow members that there is another set of American farmers quite interested in the popularity of margarine—the men who supply the fats and oils, such as livestock men and soy-bean growers.

So the fat is in the fire, quite literally. A group of retailers are settling around Washington asking that a tax on margarine be removed.

Don't be surprised if that margarine tax argument turns into a serious defense matter. That's the way these Washington brawls develop.

Short Shots

Raleigh, Sept. 8.—It may sound preposterous and incredible, but there are well-informed and canny persons in Raleigh's official set who honestly believe that Governor J. M. Broughton "has a mind" to run again at United States Senator Josiah W. Bailey next year.

Your reporter hastens to add, lest there be the slightest misunderstanding about it, that this corner does not share these views and does regard them as "preposterous and incredible." The fact that such views are being held, and expressed more or less seriously, is thought worthy of being passed along for whatever it may or may not be worth.

There would be nothing in the least unethical or underhanded if the Governor did decide to go after the senatorial toga. Nobody questions the right of any qualified citizen to run for any office of trust or emolument in North Carolina (except, perhaps, the Charlotte Observer, which did contend editorially that Dick Reynolds was practically a heel and a louse for daring to challenge Clyde Hoy's Shelby-given right to the national committee post).

The reason that any such intention on the part of the governor is disbelieved in toto is that, whatever his faults and failings, nobody has yet accused Gov. Broughton of lacking political sense.

For him to challenge Senator Bailey would seem, on its fact, to be political folly. The Governor has done his best to build up a smooth-functioning political machine and has made good progress; but he has hardly brought it to the point where it would be potent enough to defeat the senior senator. Two years ago

If you come to Raleigh from now on you'll probably be able to find a parking space on Fayetteville street—the meters will be back, and there are large numbers of natives who just won't pay the nickel

NAZIS ACKNOWLEDGE BITTER SOVIET RESISTANCE

(Continued From Page One)
deadly fire on Nazi troop concentrations, artillery and communication lines.

Behind the lines, Premier Joseph Stalin acted to stamp out the possibility of Nazi fifth column sabotage, ordering the transplanting of 390,000 persons of German extraction from their homes along the lower Volga river to Siberia.

The Russians explained the vast migration order by declaring that military authorities had discovered trends of thousands of diversionists and spies among the descendants of the German families whom Catherine the Great invited to settle along the Volga more than 200 years ago as a bulwark against the Tartar hordes.

The Germans, who comprise 65 per cent of the population of the area—an autonomous republic of the Soviet Union—will be given land in various areas 1,000 to 2,000 miles farther east, the announcement said.

Says Forgiveness Essential In Life

A plea for everyone to practice forgiveness of others was made by Reverend T. M. Grant, pastor, yesterday morning in his sermon at Jarvis Memorial Methodist church. Indicating the emphasis Christ placed upon forgiveness in His ministry, he said, "The inclusion of effective placing of it in the Lord's Prayer, Mr. Grant put his appeal on scriptural basis.

"Christ crowded into the short sentences of the prayer the creed that animated his ministry. He said, 'Forgive us our trespasses as we forgive those who trespass against us.' The crucifixion did not wipe out all sin but it did express a fine spirit of forgiveness. A God-like gesture. Forgiveness was very essential in the preaching and ministry of Christ," declared Mr. Grant.

Then, picturing the internal conflict forever going on in the life of human beings, he said, "All of us fight. Sometimes we fight with forces that are pernicious, strange and subtle. We do not know where they come from. The greatest battle fought are fought inside men. How do men decide when men struggle with what is bad? "The Master of men has believed in human brotherhood and that men can reflect his will. When we condemn, hate in our impressions of folks, we cannot hold the love of God. If we are to have fine and gracious feelings in ourselves, we must have something that deals
