TOJO PLEDGES JAPAN TO STICK BY AXIS

Soviets Declared To Have Beaten Back Nazi Thrusts

REPEL FOES IN WESTERN AREA

Assert Withdrawal From Odessa In Accordance With Plans And Pictures Action As A Strategic Triumph; London Quotes Moscow As Saying Rail Center 200 Miles South Of Capital Recaptured

Moscow, Oct. 18.—(AP) German divisions striking at Moscow's western defenses, were declared officially today to have been beaten back several times by the Russians yesterday, and a Soviet withdrawal from Odessa was pictured as a strategic triumph.

(The Exchange telegraph in London quoted the Moscow radio as saying the Russians had recaptured Orel, rail center 200 miles south of the capital.)

Fighting was especially stubborn in the western direction, where the Red army beat off several fierce enemy attacks, the Soviet Information Bureau said in an early morning communique.

The bureau said at midnight that fighting continued throughout the night and was particularly heavy in the western direction.

It reported that "on October 17, 14 German planes were brought down near Moscow."

(There still was no word from Moscow, where radio communications were generally limited to transmission of official material, concerning reports in other capitals that Soviet government leaders had left Moscow for Kazan, 450 miles east.)

In Washington, however, the State Department said that high officials of the Soviet Foreign Office had left for a destination in the East.

All the U. S. embassy staff, except two secretaries and three clerks also left Moscow with Ambassador Laurence A. Steinhardt, the State Department said. They were accompanied by members of the American Supply Mission, military and naval attaches, two Red Cross representatives and 10 American correspondents.

Conceding that Russian defenders of Odessa had been withdrawn, the Information Bureau said this operation was according to plan—that they were "transferred by our fleet to other sectors of the front in perfectly orderly manner and without any losses."

Tobacco

Both offerings and prices on the Greenville tobacco market Friday exceeded expectations as the day's sales brought to 41,750,450 pounds the total offerings to date, for which \$12,954,908.85, or a 31.03 average, was paid.

Although the 1941 offerings are 1,270,080 pounds under the corresponding figure for 1940, money paid out this year is \$5,198,180.32 more than the \$7,756,226.53 paid out for the same number of sales days last year.

This year's figures also show up favorably in comparison with 1939 figures. The 79,045,070 pounds sold during that banner year brought \$12,923,858.86, or \$30,437.90 below the amount paid out this season for 37,294,620 pounds less tobacco. The 1939 average was 16.35, or 14.68 below the 31.03 established to date on the Greenville market this season.

LANIER NAMED FOR NEW POST

Chosen Secretary Of Leaf Tobacco Exporters Asso.

In a statement released today by H. R. Pettus, president of the newly formed Leaf Tobacco Exporters Association, it was announced that J. Con Lanier of Greenville had been appointed executive secretary of the organization.

Mr. Lanier has had much experience in connection with tobacco problems of farmers, dealers and exporters. In 1933-34 he served as tobacco expert with the Triple A in formulating and organizing tobacco crop control. Later he served as code administrator for the National Tobacco Warehouse Association. Mr. Lanier is largely interested in the production of flue cured tobacco, and owns and operates several tobacco farms. In the recent hearing granted to tobacco farmers before the Ways and Means Committee of Congress in opposition to increases of taxes on tobacco products, Mr. Lanier presented the argument of the tobacco growers.

The purposes of the organization employing Mr. Lanier is the promotion of export sales of American-grown tobacco, and the protection of the independent leaf tobacco industry. In normal times two-thirds of the flue-cured tobacco is exported. The Leaf Tobacco Exporters Association will work towards the recovery and expansion of foreign markets now and in the future.

The executive offices will be established in Greenville in the Shelburn building on East Third street.

Stocks Selling Below Book Values

Babson Says This Very Exceptional

New York City, Oct. 18.—There are half a dozen simple rules which every investor should consider when buying stocks. These are:

- 1. Prefer companies without debt or embarrassing preferred issues.
2. Prefer companies with natural resources, real property, or marketable equities.
3. Prefer companies with goodwill, trademarks, and assets which are difficult to duplicate.
4. Prefer companies which cater to consumers and enjoy a "repeat" business.
5. Prefer companies whose issues are selling for not in excess of their book value.
6. Prefer companies with a satisfactory earnings record.
7. Be sure that directors and officials are men of high character, sound judgment, with a personal financial interest in the company.
8. Most readers know that the market had quite a break following the recent statement of Secretary Morgenthau regarding taking away all earnings of a company in excess of 6 per cent. If he would guarantee 6 per cent on all legitimate companies, or even guarantee the continuance of what they are earning up to 6 per cent, this would be something to discuss. To say, however, that a business man should take all losses on existing and new enterprises and then have the profits on the one that does make good limited to 6 per cent on the capital invested is, of course, fundamentally unsound. This was the argument first used by the Russian radicals in bringing about Communism, and later by Hitler and his crowd in bringing about Nazism.
I do not for a minute fear that Congress will adopt any such crazy legislation. It would be much harder on small businesses than on large businesses and be the end of new enterprises. This, I have already stated through these columns. It, however, should be recognized that the Treasury Department is thinking along these lines. The Good Book says, "as a man thinketh in his heart so is he." (Continued on Page Six)

Everything is in readiness for the opening of the sixth annual Pitt County Fair, under the sponsorship of the two American Legion posts of the county, which will get under way Monday and continue through Saturday.

The shows are expected to arrive here tomorrow morning and the public is invited to ride out to the grounds and get a preview of what will be offered during the week. Workmen are expected to be busy throughout the day putting up the various shows and rides.

Each day has been set aside as a special attraction. Monday will be observed as grand opening night, Tuesday as judging day, Wednesday as school children's day, Thursday as Farmville day, Friday as Pitt County day.

Disregards New Tension In Pacific

Course Announced Even At Time When Press Declares Attitude Of U. S. Has Stiffened To Such An Extent As To Arouse Great Indignation In Japan; Situation Admittedly Critical

Tokyo, Oct. 18.—(AP)—Lieut. General Eiki Tojo, Premier and head of the War and Home Ministries of Japan's predominantly military new cabinet, pledged his government today to go ahead firmly with its East Asia and Axis adherence policies, despite increasing tension in the Pacific.

Even as the army-trained premier announced his course, the newspaper Nichi Nichi told Japanese "the attitude of the United States has stiffened so much as to arouse great indignation of the Japanese nation."

"It is not too much to say that there is being developed a very critical situation in which any unexpected contingency may occur at any time," the newspaper declared.

General Tojo told the press after his first meeting with his cabinet that Japan would follow her three-point course: continuing her efforts to create a co-prosperity sphere in East Asia, pressing for completion of the China affair, and adherence to her treaty obligations.

An information board spokesman added that "in view of the unprecedentedly grave situation prevailing at present the government intends externally to promote cordial relations with friendly powers and internally to perfect the national defense of the state."

(The German radio expressed the Reich's approval of the new cabinet which a Berlin broadcaster said "strengthened the position of the powers marching into the new era under the sign of the tripartite pact heedless of British and American positions.")

There were reports that Yosuke Matsuoka might come back into the government. It was indicated that the former foreign minister who negotiated Japan's part in the Axis pact as well as her pact with Soviet Russia might be named as advisor to the foreign office.

The new foreign minister, Shigenori Togo, has served Japan as ambassador both in Berlin and Moscow.

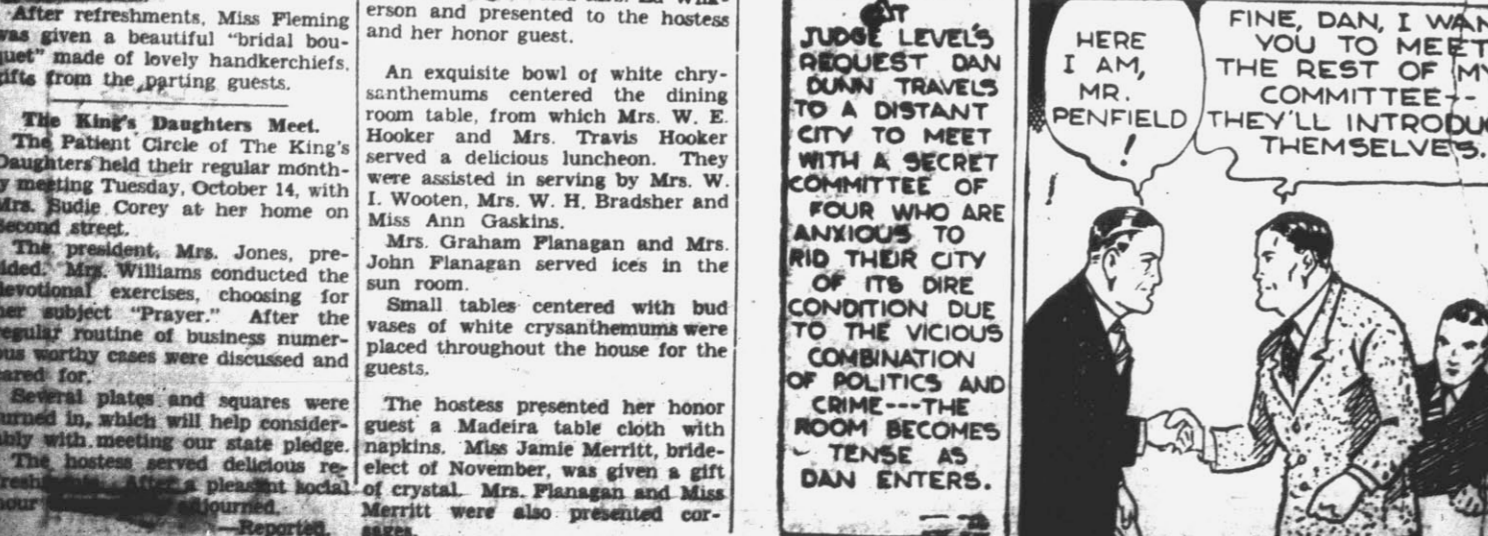

AIM OF WCTU IS DISCLOSED

Organization Summoned to Drive for Prohibition

Reflector Bureau. By HENRY AVERILL. Raleigh, Oct. 17.—The "report and recommendations" of Mrs. Helen C. Wohl, director of citizenship and legislation for the North Carolina Woman's Christian Temperance Union, leaves no doubt that this unit of the prohibition forces intends to make a militant campaign next year for a legislature pledged to call a statewide referendum on the liquor question.

Mrs. Wohl's report was presented to the WCTU convention at Elizabeth City yesterday. She furnished this bureau a copy, upon which this story is based.

Mrs. Wohl indicated that there will be no quarter asked and none given, as far as she is concerned. She called upon the WCTU to make effective the political formula enunciated by Democratic National Chairman Ed Flynn in a speech in North Carolina some months ago in which he said:

"There is only one thing that changes the thoughts and methods of political leaders, and that is defeat. Without success at the polls their leadership lapses."

The legislation director made five specific suggestions for carrying on the prohibition offensive. "But organization must," she said.

"Insist upon an open pledge on one side or the other of the liquor question from every candidate for every state, legislative and county office from the top to the bottom of the slate. Permit no one to evade."

"Refuse to permit the organized wets to spread the propaganda to reliable dry-minded candidates that their past reputations as temperance champions has already earned them the dry vote; and that all they have to do to secure the wet is to leave the liquor issue out of the campaign."

"Petition Governor Broughton to include a liquor prohibition plank in the 1942 state Democratic platform."

"Demand that the costly ABC board be abolished. It has little or no duties to perform, is a waste of public funds, and the public can get along without it. If not checked, it might easily become an official agency for the apology and promotion of the organized liquor traffic. In a political campaign involving large financial contributions, it could become a political power to be feared."

"Request our delegation in Congress to support the Sheppard bill which would prohibit the sale of liquor, beer and wine on United States army, navy and marine corps reservations and in zones adjacent thereto."

Flays 1941 Assembly In addition to making these specific recommendations Mrs. Wohl lashed out savagely at the 1941 House for giving the McGowan statewide referendum bill a heavy dose of "special-rule" chloroform.

"Only the triumvirate of liquor, beer and wine—the three breeders of political death and corruption—could have provided the motive power for the indefensible suspension of popular and representative government by the 1941 House of Representatives when the statewide referendum bill was before it."

She paid her respects to the beer interests in no uncertain terms of bristling hostility. "Nor must we forget that the grand prize 'sneak bill' of the 1941 session was a local beer legalization measure. Bearing a totally deceptive title, it was passed under a code of honor without a reading of the text upon the request of a representative of another county. It has restored the unwanted sale of beer now prohibited in a small religious community some 175 miles removed from the home county of the sponsor of the sneak bill."

And again referring to beer and its booster, the report said: "The sale of beer, a dangerous intoxicant and the cause of much of the shocking highway accident and crime toll in our 75 dry counties continues rampant, uncontrolled and unregulated. It is sold without restraint on Sundays and holidays. It might be noted here that the brewers lobby filed the biggest financial report for lobbying activities during the late legislative session, and that this does not include the public relations activities of the Brewers and Beer Distributors committee which functions on a year round basis."

No Wine Victory "The fortified wine law was by no means a WCTU victory," said the report. "It merely set up two monopolies on the sale of fortified wines and did nothing about prohibiting or limiting the sale of the equally intoxicating unfortified stuff. One fortified wine monopoly is held by the ABC counties, and the other is held by high class hotels and Grade "A" restaurants. The well-heeled hotel operators lobby

was on hand in Raleigh to safeguard the interests of the hotels." "Benefit of Doubt" Mrs. Wohl related that many legislators place the blame for pressure to defeat the referendum bill squarely on Governor J. M. Broughton, but she argued that he be given the benefit of every doubt.

"A number of individual legislators placed the blame for the pressure squarely at the door of Governor J. M. Broughton. During the entire session ugly rumors of 'pledges to the 27 ABC counties' and the like were heard. Legislators with close administration affiliations and several administration lieutenants frequently boasted that no statewide referendum bill would be introduced, and after it was introduced they freely predicted that it would never come to a vote in the house."

"The Broughton administration has more than three years yet to run and we should give it the benefit of every doubt."

Fish Crossed Up Pratt, Kas.—(AP)—Guy Joeserand says the catfish at the Pratt fish hatchery have learned to recognize the sound of the truck which brings their feed once a day. Whenever it drives up the fish swarm to the feeding spots. The other day Joeserand said workmen swapped trucks and not a fingerling was on hand when the feeder reached the banks of the ponds—the fish failed to recognize the new truck.

BRITISH NEED U. S. HELP

(Scottish Rite News)
It is sometimes not real-
ized by the reading public
that Hitler is in more danger
of a real war on two fronts
than ever before.

Because of a threat of a
winter stalemate on the Rus-
sian front, Hitler may be
forced to seek new battle-
grounds in Asia Minor,
Spain, Africa, or an attack
on England itself. Or, as
some English strategists
would have it, Hitler may be
forced to fight on a front not
of his own choosing. It is
the latter kind of a two-
front war Germany seeks to
avoid. Germany, by control-
ling France and Norway, has
successfully avoided it so far,
but if the Russians can
keep Germany penned in for
the winter, a situation favor-
able to the Allies may de-
velop. Favorable, that is, if
the United States acts.

Drawing from the lessons
of World War I, when Ger-
many had to fight two major
land campaigns at the same
time, Hitler hoped that by
wiping out France the con-
tention of Russia would be
unimportant. Though Ger-
many is far from facing a
Russian disaster, the threat
of a two-war front of another
kind has emerged—the
present aerial menace of the
R.A.F. The British air force
has risen to a parity with
Germany's, and is reaching
even stronger with the aid of
Canadian and American re-



enforcements.

Germany must hesitate in
planning any direct attack
on Britain because of this air
equality and at the same
time must watch for a new
front of Britain's choosing in
the future. It takes no
stretch of the imagination
to picture Britain's estab-
lishment of a bridgehead in
Norway or possible even in
northern France while the
Russians fight the Nazis to
a standstill on the eastern
front. Air-power is impor-
tant in an invasion attempt
and Britain is beginning to
have that now.

One thing is certain. Brit-
ain is fighting back with all
it has, even though the pos-
sibility of an invasion of the
continent now seems diffi-
cult. There are those who ask
the question, without think-
ing: Why does not Britain
take land action now to help
Russia? Britain has already
done that. A million mecha-
nized troops have been sent
to the Near East and Middle
East in the last few months.
Every division of well-
equipped mechanized troops
have been dispatched to
probable fields of battle.

Left to defend England it-
self are probably two million
trained troops, only partial-
ly equipped, with which
Britain hopes to resist inva-
sion. Britain has not waited
for the war to visit the tiny
isle. Britain has gone to
meet the war with great con-
centration of troops and ma-
terials in the Near East and
Africa, where the fate of the
world may be eventually de-
cided.

Britain's navy, which con-
trols most of the seas of the
world, is another effective
aid to the Allied cause. Com-
bined with the U. S. Navy,
that control can become Ger-
many's greatest hazard. But
without that combina-
tion at work, the Allied
cause may be lost.

Many skeptics wonder
why the British aerial raids
have not been speeded up.
The answer to that is—they
have. During the month of
August, Britain sent over
Germany and occupied
Europe as many as three
hundred bombers a night,
any many planes executing
daylight raids. After a
month of this, figures show
that Britain dropped as many
bombs on German-
held territory as the Nazis

There's nothing like a few indig-
nant voters for getting things
done."

the U. S. should step in now
when Britain has yet to es-
tablish a great land offen-
sive. That offensive is in the
making, but only with the
real help of United States
forces. The U. S. Navy must

bution is only a started, and
that the war must be fought
at Britain's side while there
is still a war to win.

American power and re-

Washington Daybook

Washington—In Washington we
live so deep in the forest it's often
impossible to see the trees. It is
good sometimes to get the point of
view of some one who doesn't live
in the woods at all. The other night
I had dinner with a newspaper
publisher, one who uses this col-
umn.
"Why," he said, "don't you tell
people how ashamed they should be
of their capital? Washington is the
only city in the world governed by
130,000,000 people. It has been said
and there is a lot of evidence to

bear it out, that it is the worst-
governed city in the world. And
who's responsible? It's just those
130,000,000 people who are too busy
with other things to demand that
the men they elect make the na-
tion's capital a model of beauty and
good government."

Here is how he looked at it: The
national capital doesn't belong to
Washingtonians. It belongs to the
United States. There are more than
700,000 persons in the District of
Columbia and about 300,000 more
in the Virginia and Maryland sub-
urbs who work for Uncle Sam or
live off those who do work for the
government. Yet not one of them
has a thing to say or a chance to
vote in the matters that pertain to
the affairs of Washington.
The District of Columbia is gov-
erned by Congress. In both House
and Senate there are District com-
mittees, which are supposed to re-
commend legislation for betterment
of the capital. Then there are the
city's three commissioners. By law,
one of these has to be an army en-
gineer. The other two are presiden-
tial appointees. At the moment,
they are two former capital news-
papermen. This board has no leg-
islative powers and its executive
powers are limited. Its members
not only have to worry about the
opinion of the people who live here,
they have to answer to the Presi-
dent, the congressional committees,
and to Congress. Hamstrung with
all these bosses, it is no wonder if
they forget they really are working
for 130,000,000 people who call this
their national capital and should
take pride in demanding that it be
the model municipality of the land.
As for the District committees in
Congress, there are few assignments
the members would rather be with-
out. There are two reasons: The
job takes a lot of time and even if
it is done to perfection, how many
votes is that going to get back
home? Not one.

Visitors from all parts of the
country complain that Washington
traffic is worse than that of any

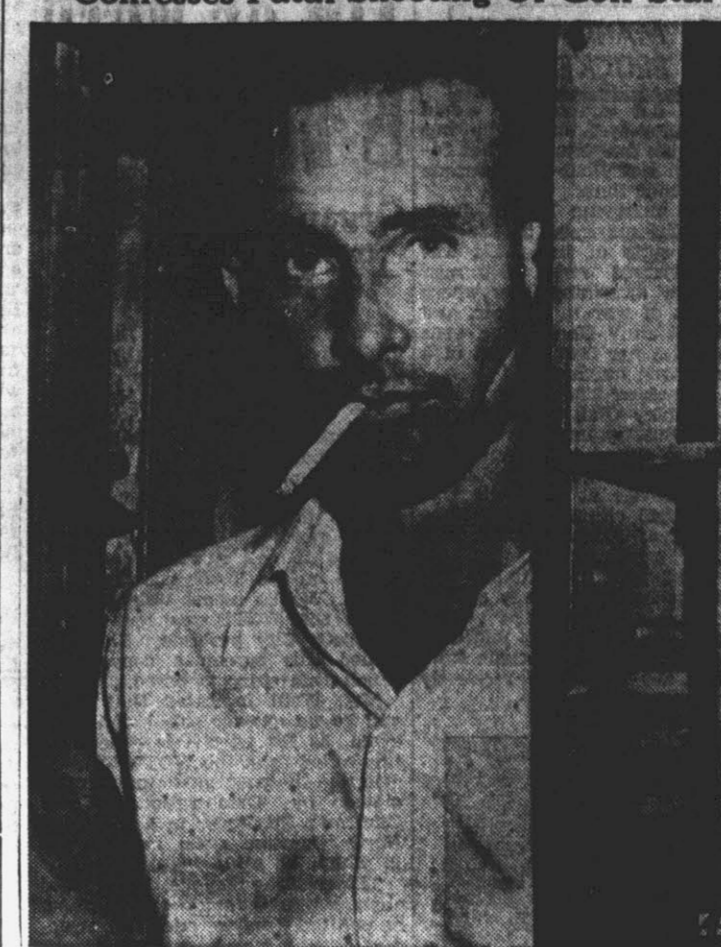

Short Shots
Raleigh, Oct. 18.—There is unan-
imous agreement among those ob-
servers seen by your reporter that
the indictment of ten men in Per-
son county for the attempted
lynching of Cy Winstead, Negro
charged with rape, was a stunning
surprise to most Roxboro and Per-
son county people.
The sheriff, who did such a fine
job in preventing the lynching, is
described as being actually "sick"
when the indictments were return-
ed. These sources credit Judge
Henry A. Grady, a jurist as fearless
as he is irascible, with being the
man on the ground almost com-
pletely responsible for the indict-
ments. If left to the local authori-
ties, they say, doomsday would have
come and gone long before any ac-
tion was taken.
But antedating the indictments
themselves was the probe made by
the State Bureau of Investigation;
and wholly responsible for that
probe was Governor J. Melville
Broughton.
All of which is bringing loud and
prolonged praise for the governor
who is seen as having upheld the
majesty of the law in North Caro-
lina as it has not been glorified in
many years. The Goldsboro mob
flogging of a few years back is being
pointed out as a sharply contrasting
incident. In that case, too, the SBI

HEADACHES IN WINE PROBLEM

ABC Chairman R. Grady Johnson Is Worse Sufferer

Raleigh, Oct. 18.—Wine, particularly the fortified variety, is still a headache to more people than those who drink it for the effect of its 20 per cent alcohol.

A notable migraine sufferer from the potent fermented justice is State ABC Chairman R. Grady Johnson who sits in the middle and gets all the complaints from all sides. Right now he is faced with several particularly knotty problems which appear to require something of a Solomon to decide.

For instance, there's the matter of labels. The North Carolina law provides that no wine shall be sold which contains more than 20 per cent alcohol; but there is in the hands of North Carolina distributors several thousand cases of wines labeled "Contains from 19 to 21 per cent alcohol." That of course, makes the beverage prima facie of doubtful legality. If the wine contains the 19 per cent, all well and good, but if it goes to the full 21 per cent

count day and Saturday as Everybody's day.

All school children will be admitted to the grounds free of charge until 6 o'clock on Wednesday, but they will be required to pay a three cent defense tax imposed by the federal government. Each three-cent tax payment will go to the government, none of it being retained by the fair association. It will be payable at the box office.

Although hundreds of 10-cent tickets were offered for sale at a time when it was not known that they would be subject to the three-cent defense tax, the fair officials decided to pay the levy and so persons holding these tickets will be admitted without having to pay the tax. The officials decided on this move in all fairness to those who purchased the advance tickets since the tax went into effect after the sale of the tickets had started. Passes and complimentary tickets also will be subject to the tax, payable at the box office.

(Continued from page one) revealed as lacking the equivalent of a fourth grade grammar school education is a condition repugnant to American ideals. Nevertheless, the general picture is much brightened by these army statistics concerning the 693,948 selectees who were inducted by last July 1. These data show that 629,293, or about 91 per cent, had a grammar school education or better.

Continued From Page One which colleges can serve most.

First, he said, the colleges need to stress the fundamentals in education—the three B's if you will. Thirty-five thousand men had to make their "mark" during the past year's registration; these men were born since 1910. The United States desires all her soldiers and sailors to be able to pass at least a third grade examination.

Second, the colleges need to emphasize health; an unusually large number have been rejected because they were physically unfit. Perhaps, we have neglected the physical side of man in our efforts to build him up intellectually; both should be developed. This college hopes to have a Department of Health within the next year and be able then to meet the needs of teacher training in this particular field.

Third, to meet the present crisis students need training in hand work of industrial arts. Workers are badly needed throughout the nation in the various arts and crafts; the demand cannot be met immediately, but in a short period of time, the colleges will meet it. Even now, at our own college, we are preparing larger quarters for industrial arts; we hope to have this department in a new building not later than January 1, 1942. The executive committee, of the Board of Trustees, has already approved a request for an entire building on our campus to house this work.

Fourth, colleges need to train for Democracy. This can be done as easily as Hitler trained the youth of Germany in the fundamentals of Nazism. Not only must we teach the principles of democracy but we must give all under our tutelage, from the first grade of the public school to the last year of graduate work, an opportunity to put into practice these principles. Every person should be able not only to govern himself but also to conform to which he lives.

May the colleges accept the challenge presented by these needs.

Mrs. Holland, looking out on the members of the association which has grown so steadily in the past two or three years, began with the illustration of the millions of young men who are serving their country, and went on to say that she saw a challenge also to her audience to serve by serving their Alma Mater.

(Continued from page one) This means that it is not what we accomplish so much as it is what we think. It is much better to think good thoughts and fail temporarily than to think wrongly and temporarily succeed. Hence, this week's message.

Investors Can Buy Insurance Investors who have their money in companies which are seeing their employees ruthlessly "organized" by the CIO come to me in great distress. They attempt to show me that after companies are organized by labor leaders into closed shops they never earn what they did when there was free bargaining between the employer and the wage workers. They also insist that it is not primarily a question of wage raises, but rather of discipline and efficiency. They claim that under a closed shop the labor leaders really rule and the efficiency greatly declines.

I tell these investors to quit their worry, give up struggling against the inevitable and gradually shift their holdings into something which will profit by this labor union move. For instance, when wages are advancing and working hours reduced, wage workers' families spend much more in the local stores. Hence, I advise selling the stock in the XYZ Manufacturing Company and buying the stock in the leading grocery store corporation which is feeding the neighborhood of the XYZ Manufacturing Company. Also some shares in the leading department stores of that community may be a purchase. Investors who have taken such advice have come out satisfactorily.

Studying Book Values Cannot the same principle be used in connection with Mr. Morgenthau's threat of allowing only 6 per cent on book values? For instance, I understand that the book value of Standard Oil of Ohio is around \$65 a share, while this stock is selling at only about 40. If the government should allow 6 per cent on this \$65 before any radical excess profit taxes, then certainly the investor has nothing to fear from a 6 per cent ceiling. Other reported illustrations are American Woolen Preferred with a book value of over \$160 selling at about 74, and Mack Truck with a book value of over \$60 selling at around 30. I am not recommending these stocks, but I do insist that if you hold these and certain other stocks, Mr. Morgenthau should not worry you.

I prefer not to give illustrations of those stocks whose book value is less than current prices, but will give you this tip: Among such will be found the stocks of certain au-

tomobile, tobacco, airplane, soft drink, and patent medicine companies. Companies that have spent large sums in building up trade names very often suffer by having a low book value. This is not necessarily a criticism of these companies.

Conclusion This column appears in nearly 400 papers with a circulation of several million readers. Yet, I receive very few complaints about what I say, but I am burdened with complaints about the government, about taxes, about Wall Street, about big business and small business. The American people have a complex on complaints. Too many are fearful for security, income, jobs, politics, war, etc. Yet the fun of life is in the striving; not in the arriving. Therefore, the message this week is not concerning Mr. Morgenthau's 6 per cent tirade; but rather I am using this as an illustration of the message "let us overcome our obstacles instead of fretting about them."

P. S. One good piece of news comes to my desk as I am dictating this column. There will be lots of turkeys for the holidays. Over 35,000,000 birds have been raised this year, beating the world's record with an average weight of one-half pound more than a year ago. Therefore, we can all have a happy Thanksgiving.

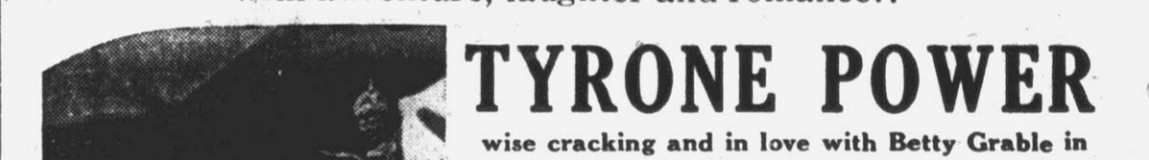
