## GERMANS CLAIM TRIUMPH IN CRIMEAN PENINSULA

### ORDERS CUT IN BENEFIT RATES FOR NEXT YEAR

Wheat And Sun-Cured Tobacco Only Exemptions

FLUE-CUR'D RATE REDUCED 0.1 CTS.

Rates To Be Paid To Farmers Who Plant Within Acreage and Carry Out Soil-building Practices

Washington, Nov. 3.—(AP)—Farmers will receive lower benefit payment rates under the Agriculture Department's 1942 \$500,000,000 soil conservation program for all major crops except wheat and a minor type tobacco.

The wheat rate is 10.5 cents a bushel, compared with eight cents this year. The rate for Virginia sun-cured tobacco was increased from 8 to 9 cents a pound.

Other rates announced today compared with those in effect this year (the old rate is given last): corn (for the commercial area) eight and nine cents a bushel; cotton 1.25 and 1.77 cents a pound; rice 1.25 and 1.77 cents a pound; flue-cured tobacco 1.45 and \$2.25 a ton; sun-cured and burley tobacco 7 and 8 cents a pound; fire-cured tobacco 1.4 and 1.5 cents a pound; dark air-cured tobacco 9 and one cent a pound; Pennsylvania type 41 tobacco 4 and 5 cent a pound; cigar filler and binder tobacco 7 and 8 cent a pound; Georgia-Florida type 62 tobacco 9 and one cent a pound; and potatoes, two and 2.3 cents a bushel.

These rates will be paid to farmers who plant within department acreage allotments and who carry out soil building and soil conservation practices. The amount a farmer would receive for any crop would be determined by multiplying the normal production of his acreage allotment by the benefit payment rate. For example, a wheat farmer with a 100-acre allotment and a yield of 10 bushels per acre would receive 1,000 times 10.5 cents, or \$105.

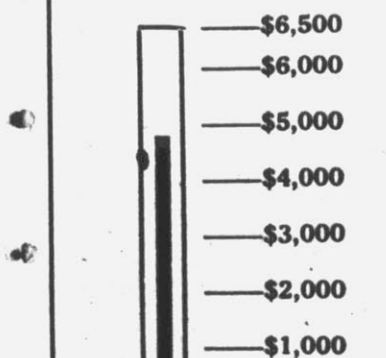
### Pre-School Work To Begin Tuesday

It is requested that parents or older brothers or sisters bring the little children who are to attend the pre-school on the opening day and each day that they are to be registered in order that proper registration be made. No child will be allowed to attend the pre-school who is not a registered member. The children will be given a mid-morning meal at 10 a. m. free of charge and are to be fed directly from the school lunchroom.

### Finland Warned By U.S. Against War On Russia

Told To Cease Operations Or Lose U. S. Friendship

Washington, Nov. 3.—(AP)—The United States has warned Finland that she must discontinue promptly her offensive military operations against the Soviet Union if she desires to retain the friendship of the United States.

Secretary of State Hull disclosed this move by the United States in reply to press conference questions as to whether there was any basis for reports from London that Britain was hesitating to declare war against Finland mainly because of objections raised by the United States.

Hull said this government had frequently called the attention of the Finnish government to American anxiety over the course Finland was pursuing. Because of the friendly relations which we have always had with Finland, however, he added, this government has refrained until now from drawing any final conclusion from the present policy of the Finnish government in the hope that similar relations could be maintained in the future.

The United States is now awaiting the Finnish government's reply.

### MOP-UP DRIVE TO BE WAGED

Plans Announced for Concluding Chest Campaign

A whirlwind finish-up campaign to reach the \$6,500 Community Chest goal—now short by approximately \$1,700—will be launched at a breakfast tomorrow morning for picked workers, who will immediately undertake a "mopping up" drive.

This strategy was decided at a meeting of the Executive Committee yesterday at the call of Chairman Charles B. Bisette, who declared that the goal must be reached in order to insure the continued progressive operation of the seven participating agencies, Boy Scouts, Girl Scouts, Service League, Salvation Army, School Lunch Fund, Kings Daughters and Emergency Relief.

The total raised to date was reported by Chairman Bisette at about the \$4,800 figure. A check was made yesterday which revealed that a large number of outstanding citizens who probably would be glad to contribute to the cause had not been approached for a contribution. The mopping-up campaign will be aimed at these citizens and every effort will be made to see every prospect during the day tomorrow and wind up the campaign Tuesday night.

It also was decided to make repeat calls on some citizens and ask them if they feel they could increase their pledges. Although it is the aim of the directors to see every prospect, it was explained that this might be impossible and Chairman Bisette urged anyone desiring to do their

### ANOTHER PLEA FOR REPEAL OF COMPLETE ACT

Sen. Gurney Would Abandon Neutrality Measure

GILLETTE URGES FOR RETENTION

Iowa Democrat Contends Law Should Not Be Repealed Because It Has Not Been Fully Effective

Washington, No. 3.—(AP)—Senator Gurney (R-S.D.) today urged complete repeal of the neutrality act rather than "another half-way measure," while Senator Gillette (D.Iowa) contended that the measure should be retained because "America's welfare and the perpetuity of her institutions does not necessitate our underwriting the wars of Europe and Asia."

Gillette declared that repeal of the neutrality law was sought not because the statute hindered the nation's defense effort, "but because it has been effective in restraining us from involvement in war."

To argue that the neutrality law should be repealed because it has not been fully effective, he said, "is to argue that, because we have deaths and losses due to traffic accidents, we should remove all stop signs, red lights, and stop-and-go signs."

Gurney criticized not only the administration-supported measure to eliminate the neutrality act's ban against the sale of arms and munitions today into combat areas, but also administration labor policy. He contended that President Roosevelt "has sacrificed the welfare of the nation defense program because he cannot bear to have the leaders of a labor machine of his creation feel unkindly toward him."

### False Fire Alarm Is Serious Prank

Fire Chief George Gardner today again called attention to the seriousness of sounding false alarms, saying that such a prank not only proves expensive to the city, but endangers life and property.

Two false alarms were sounded on Friday night, Halloween, and another was turned in Saturday night. The Saturday night false alarm preceded by a few hours the fire at the home of Jack Moye on Charles street. Although a sufficient number of firemen answered the call to Charles street, Chief Gardner pointed out that it would only have been natural for some of the firemen to feel that the second alarm also was false and not so prompt in jumping from bed and rushing to the scene.

Every time an alarm is sounded a truck rushes to the scene and volunteer firemen have to jump up and dash for the place from which the alarm was sounded. Volunteer firemen get 50 cents for a small fire and \$1 for a major blaze.

### Contend Foe Is Fleeing In Disorder

Retreat Pictured By Hitler's Command As A Double Dunkerque; Donets Industrial Center of Kursk In Hands Of Germans; Moscow Suggests Britain Declare War On Hungary, Rumania, Finland

Germany proclaimed triumphantly today that the Russian army of the Crimea, split by the scourge of lightning assault by land and air, was trying to flee the peninsula through the Black sea ports of Sevastopol and Kerch in a double Dunkerque.

The Hitler command pictured the Russian retreat there as a near rout, declaring that German forces had captured 53,175 prisoners, 250 tanks, 218 cannon, several armoured trains and vast quantities of other war material.

Far from the Crimean front, in the Donets basin to the north, the important industrial center of Kursk, on the railway running north from Kharkov through Orel and Tula to Moscow, had been captured. Kursk is 125 miles north of Kharkov.

Although the Russians readily admitted that the siege of Moscow was becoming most grave, Red army dispatches reported re-capture of the northern section of Kailin, 100 miles from the capital on its northern flank. They said that thousands of Germans were buried under the flaming debris of houses blasted by the defenders.

The Crimean fighting was a test for all arms of Russia's forces—land, sea and air. German occupation of the Crimea would include the Red fleet's great naval base at Sevastopol, as well as strategic airfields and give the Germans new jumping off places for attacks on the Red fleet, if not actually a new approach to the oil-rich Caucasus.

With Russian dominance of the Black sea thus sorely threatened, an authoritative source in London said Russia had suggested to Britain that she might "with advantage" declare war on Hungary, Rumania and Finland.

The British said their government had not yet reached a decision on the suggestion and added that "naturally the United States is being kept informed on the subject."

Finland's role in the war against Russia was newly emphasized by British press reports from Stockholm which said that German and Finnish troops were only 14 miles from Murmansk, Russian Arctic seaport. The Murmansk-Leningrad railway has been the object of Finnish-German land and air attacks almost since the Finnish found hands with the Germans in the invasion of June 22.

### One Of Two Escapees Still Remains Free

Clarence Rickman, one of two convicts stationed at the Pitt county prison camp who escaped Friday afternoon after dashing through the Grimesland school building, continues to evade officers.

Robert Winston May, the second escapee, was captured Saturday morning. Rickman, serving a 30-year sentence imposed in Rutherford county for second degree murder, is believed to have escaped from the large forest near Grimesland and to have fled the section.

"I couldn't—"

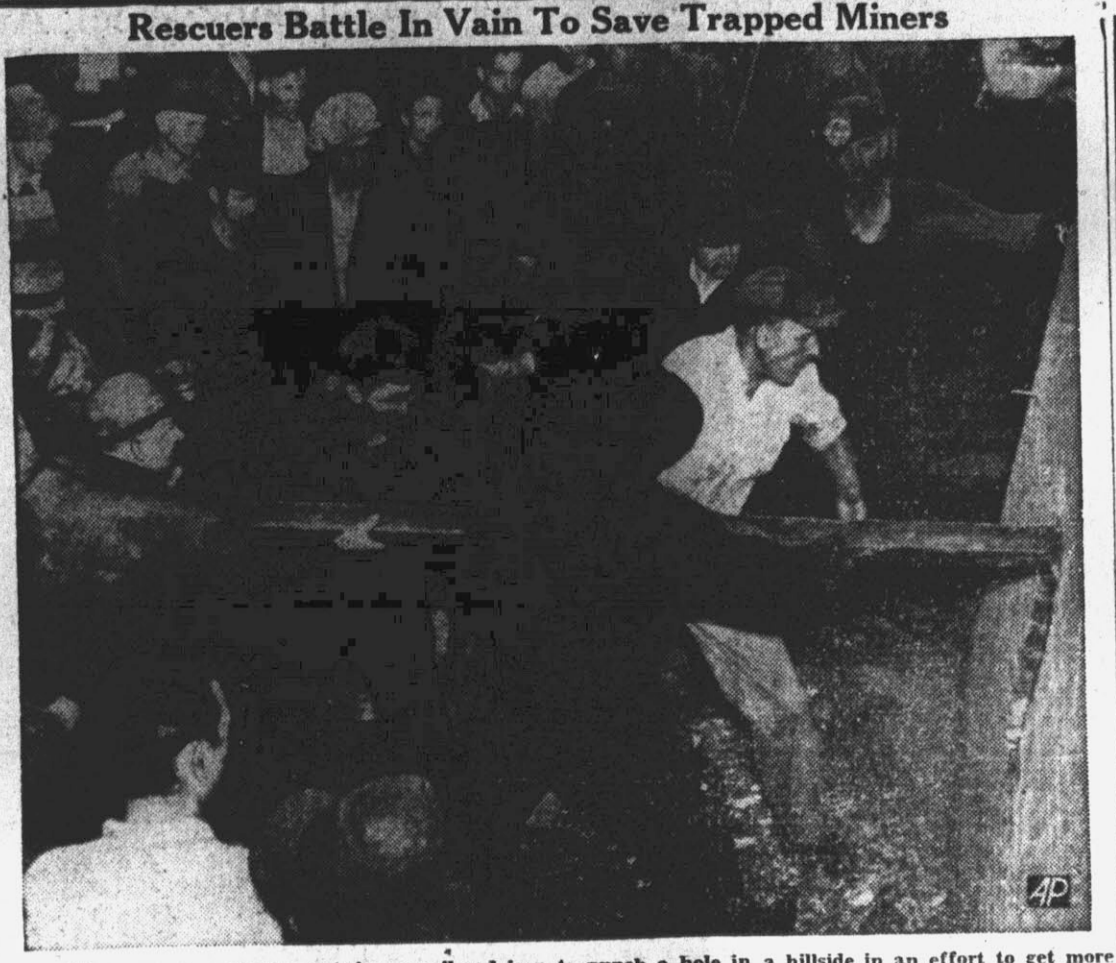

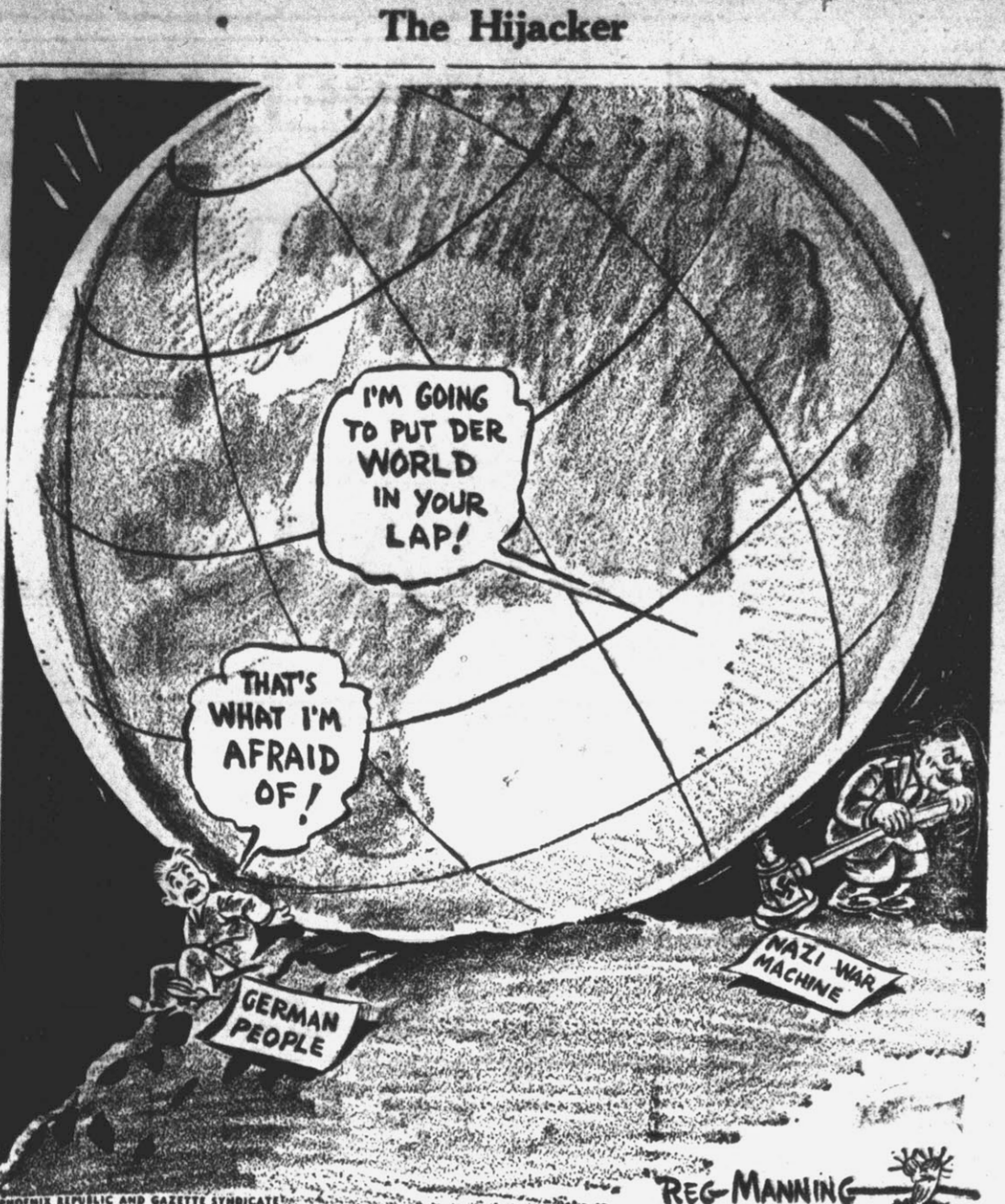

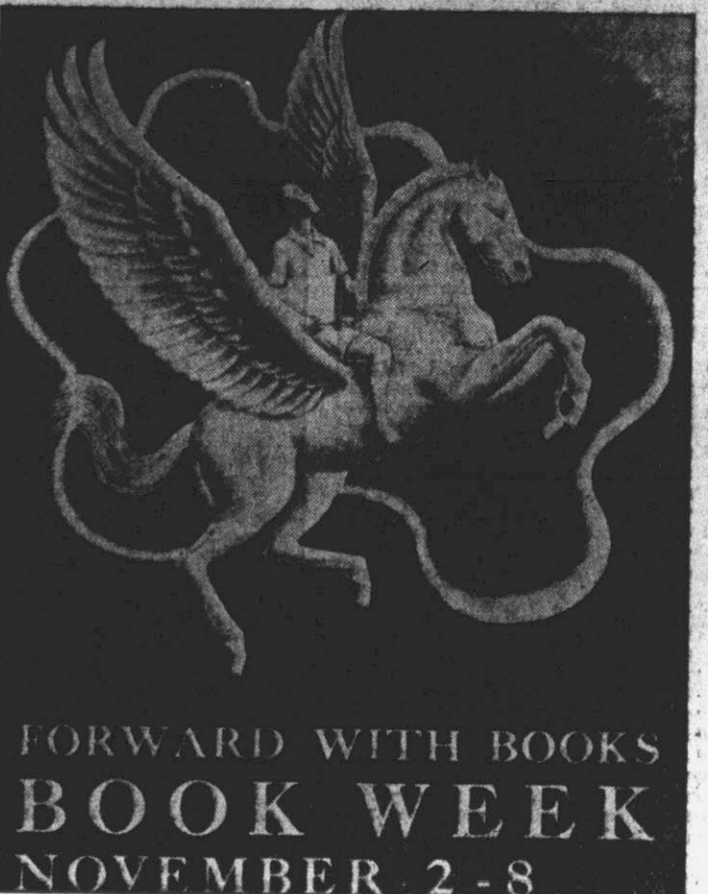

# N. C. SCHOOLS COST BIG SUM

## More Than \$200,000,000 Spent In Eight Years

Nov. 3 — By the end of the year 1941-42 the state of North Carolina will have spent approximately \$319,000,000 on its public schools since the opening of the twentieth century; of which more than \$200,000,000, or more than two-thirds, will have been expended in the eight years beginning in 1935.

This isn't listed that way in a long table of school expenditures carried in this month's School Facts, from the state department of public instruction, but isn't hard to figure out by a bit of elementary addition, subtraction and application of the principles of common fractions.

To get exact about it the table shows that total state money appropriated for public schools from the year 1899 through the coming year 1942-43 will come to \$318,852,111.03, of which the portion included between the years 1935-36 and 1942-43 is \$202,738,040.86.

For the first time in history the total will reach thirty million in 1942-43. It passed twenty million for the first time in 1935-36; went above fifteen million in 1931-32. In fact it had never been beyond \$6,500,000 until that year; and first passed the one million mark in 1919. In the first year of the century it was an even \$100,000.

The cold figures of this table relate a really eloquent story of the state's efforts in behalf of its schools — efforts which were first fruitlessly started as far back as 1754, which was before even the Mecklenburgers or the Halifaxers had thought of a declaration of independence.

From then on, with fitful periods of success and failure, there has been a long history of more or less successful efforts to make the schools of North Carolina worthwhile assets to Tar Heel youths.

Running briefly through this history, the very first stirring came when the provincial assembly of 1754 appropriated 6,000 pounds (really a lot of money in those days) when a pound would purchase far more than \$5 today) for founding and endowing a public school "in the province" — but this money was never used for the purpose for which it was appropriated. In 1766 a public school was incorporated at New Bern on land donated by the Assembly and supported partly from funds realized from a tax of one penny a gallon on all rum and spirituous liquor imported into the Neuse river.

The first state fund actually set up, however, was the Literary Fund. The law creating this passed on January 4, 1826.

From then until the War between the States there was steady, though slow, progress in school affairs. The civil strife of 1861-65 wiped out everything previously gained, and set the state back to scratch in education as well as in practically all other affairs.

Nothing of any practical import was done before 1889 when a new principle was introduced — that being a direct appropriation of a specified sum from the state treasury — and the Literary fund was converted into a revolving fund to be loaned to counties for the erection and repair of school buildings. The first appropriation was \$100,000 and was continued annually until 1906-10 when it was raised to \$125,000 and to \$244,000 in 1913-14.

This fund was distributed to the counties on a per capita basis. This method of state-aid was discontinued at the close of 1918-19, and for two successive years the state understood to pay teachers' salaries for three months from the proceeds of a state property tax of 32 cents on the \$100 valuation.

Still another principle of state support was introduced into the method of distribution of state aid by the general Assembly of 1901. This method of distributive state aid took cognizance of the different financial ability of the counties to support the schools for four months. This resulted in what was called the "Equalization" fund which was continued through the year 1918-19.

When an effort was made to extend the school term in the several counties by levying a statewide property tax of five cents.

In 1921 the state abandoned the policy of levying a statewide property tax, but a increased equalization fund was provided by an appropriation from the general treasury of the state. Before a county could participate in this plan it had to show that the schools could not be operated for six months from the

proceeds of a 30-cent tax levy on the 1920 valuation of property.

In 1931 the legislature assumed state responsibility for operation of the six-months school term, and in addition continued the appropriation for tax reduction. A statewide 15-cent tax levy was imposed to yield the revenue needed for the term.

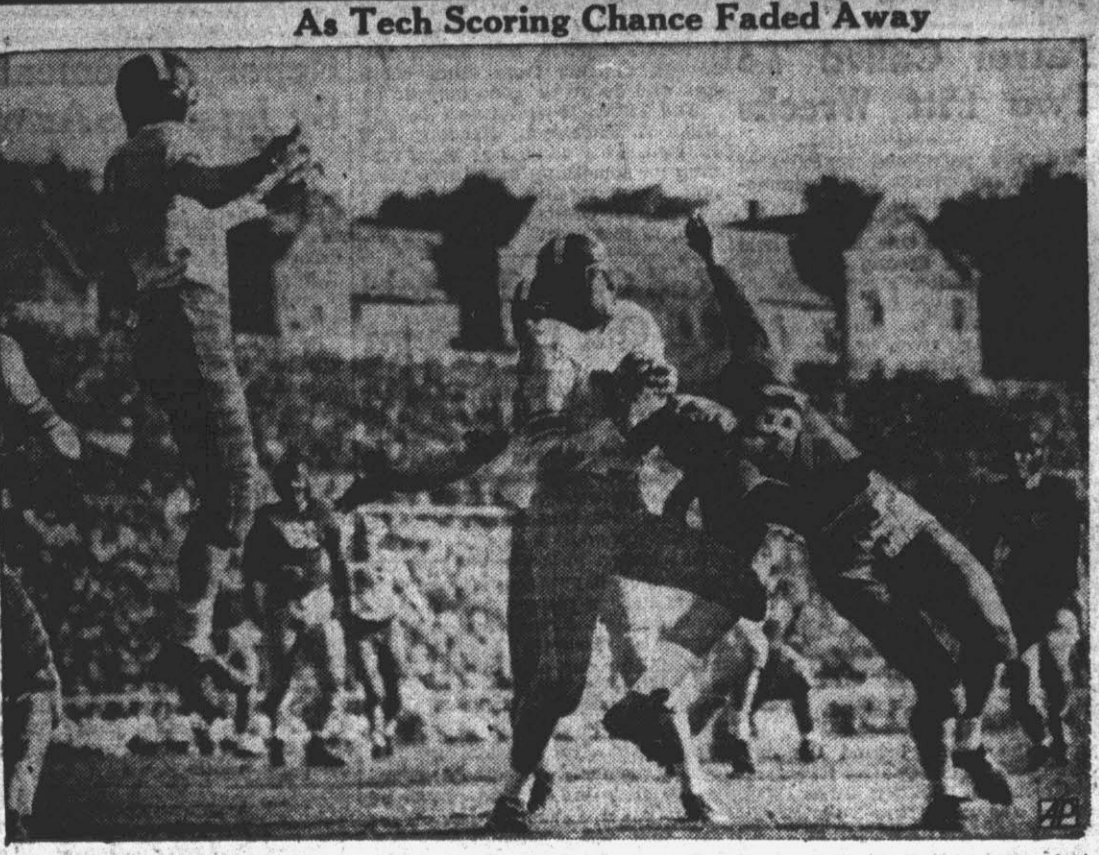
In 1933 the state took over the full eight-months term and discontinued the ad valorem levy, substituting the sales tax. Though there was a drastic curtailment in total appropriations at the session, this was the beginning of sharply increasing state expenditures for the school purposes.

From that point the general operations funds have moved upward without exception, each legislature appropriating a bit more than its predecessor.

Naturally, the 8-months term's support calls for almost all of the \$30,000,000 which will be spent in the year 1942-43; but there are some other items worthy of notice. There will be, for instance, a \$710,000 expenditure of state funds for vocational training and \$200,000 for medical inspection and free textbooks.

The vocational program dates back to 1918-19 when the very first appropriation for the purpose was made. This was a \$3,000 authorization of which \$2,999.89 was actually spent.

Free textbooks were authorized by the 1927 General Assembly, and \$1,228,378.92 was spent the first year. The total state expenditures of \$378,852,211.04 since the opening of the century were divided thus:

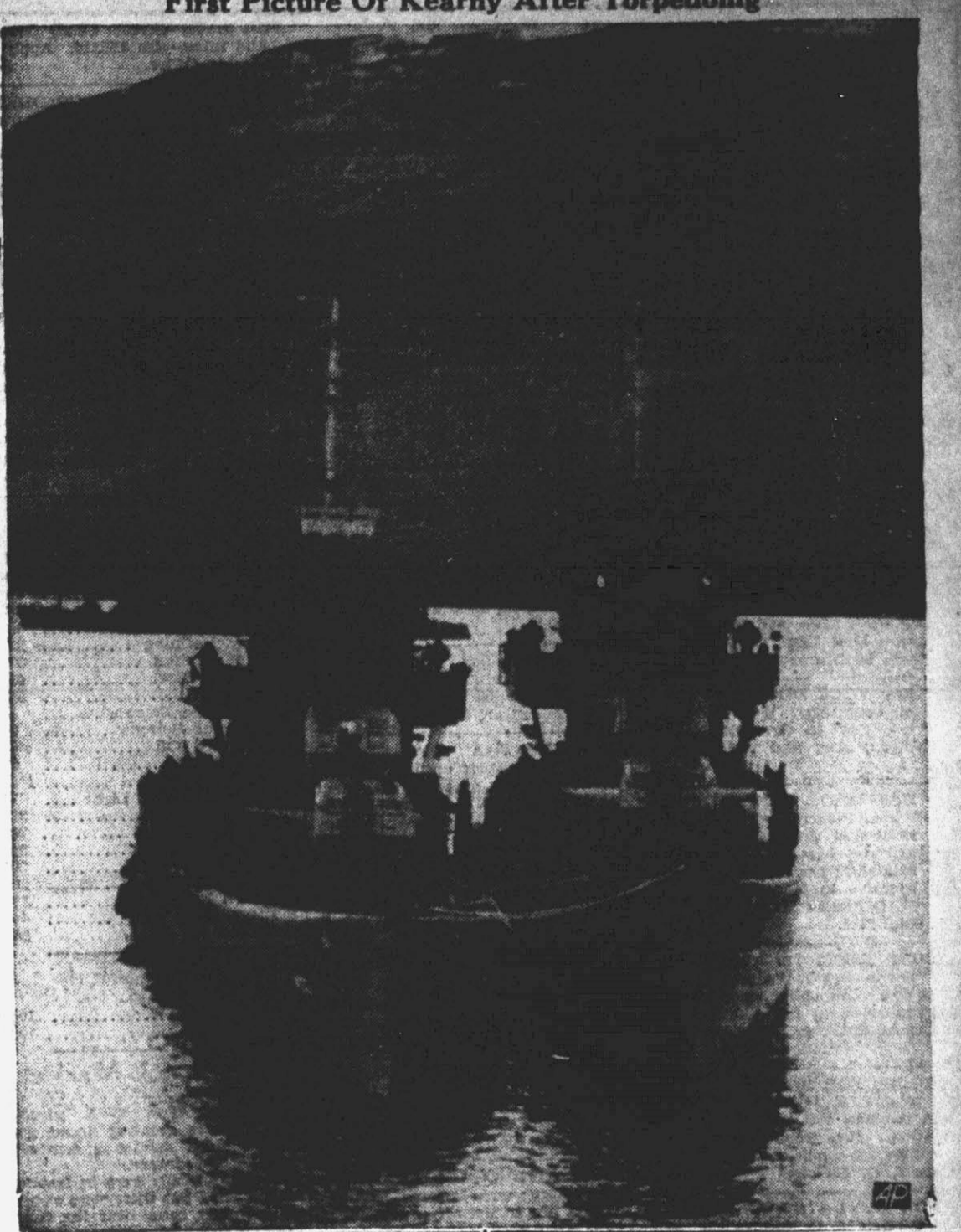

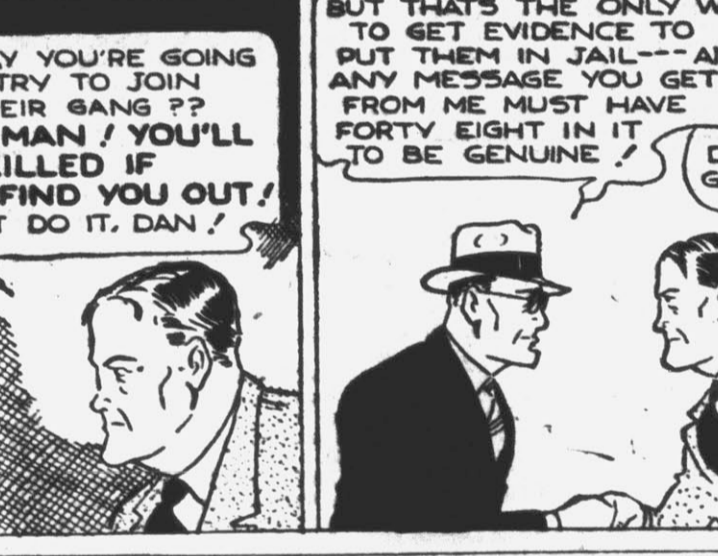

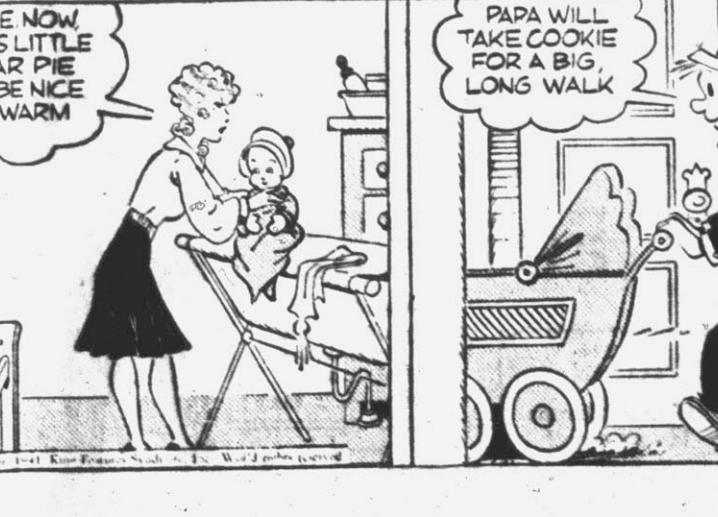

### Opinion Is Filed In Fertilizer Case

Greensboro, Nov. 3.—(AP)—While no official order ending the equity action of the International Agricultural Corporation and Swift Company, fertilizer division, against Carlisle W. Higgins, Ralph F. W. Brimley and John W. Alken has been received from Judge Johnson J. Hayes, of the United States Court for the Middle District of North Carolina here, the opinion of the jurist, filed at court offices in Greensboro today, throws the plaintiffs out of court and ends that particular phase of the much involved fertilizer litigation.

The plaintiffs in this particular action brought suit in equity to compel the immediate return of papers which they had produced in compliance with subpoenas issued by Judge Hayes so that the federal grand jury in session at Winston-Salem, and the office of the district attorney, might investigate alleged unfair practices, price-setting and maintenance, on the part of leading fertilizer manufacturing concerns and dealers.

### Report Movements By Japanese Army

Chungking, Nov. 3.—(AP)—Chinese military intelligence reports recently have told of large Japanese troop movements in French Indo-China toward the borders of China's Yunnan province, British Burma and Thailand, a Chinese army spokesman declared tonight.

He said, however, that there was still no definite indication of the Japanese army's intention although either Yunnan or Thailand might be the ultimate objective of these moves.

The spokesman said the Japanese military had completed taking over control of railways, highways and strategic points in northern Indo-China and that they were scheduled to take over all French administrative bureaus in that area shortly.

The Japanese were said to have massed about 20,000 men on the Yunnan border, where they imposed October 20 more than 10,000 Japanese soldiers were moving toward the Burma sector where British empire troops have taken up defensive positions.

### Death Cheated By Plane's Occupants

Georgetown, Calif., Nov. 3.—(AP)—As fragments of an army bomber were found scattered over a 50-acre area, it appeared today that all nine men aboard had cheated death while the plane fell to pieces in mid-air yesterday.

The discovery of a parachute draped over a fence led to the belief that the only man unaccounted for had reached earth safely. He was Lieut. H. M. Walker, the pilot.

Ground parties were searching for him.

The other eight airmen parachuted safely as the big bomber disintegrated in the air in a raging snow storm over the Sierra, Nav., wilderness. Six were rescued early today, two other were found last night.

The association ordered the investigation after Dean of Education Walter D. Cocking and Dr. Marvin S. Pittman, president of the South Georgia Teachers College, were dismissed by the Board of Regents when Gov. Eugene Talmadge accused them of advocating racial co-education.

Five board members and the governor plan to appear before the three-man committee "to answer any questions" concerning charges brought against the two educators.
