Allied Subs And Planes Score New Successes In Battle For North Africa

Axis Ships Sunk And Damaged In Mediterranean; Air Force In Crete Set Afire; Axis Bases In Africa Undergo Continuous Raids; Patrols On Both Sides Test Enemy Lines

(By The Associated Press) London, Jan. 1.—Allied submarines and planes scored new successes in the Tunisian battle of supply as patrols on both sides tested the battle lines, possibly as a preliminary to the decisive test of strength.

Two more Axis supply ships and perhaps a destroyer have been sunk by British submarines off the Gulf of Tunis and off Bizerte, the Admiralty announced.

From Cairo, British headquarters announced two new aerial assaults on the east coast port of Sfax.

A fourth ship, Cairo said, was hit by an aerial torpedo in a foray off Sicily and was set on fire.

Raiders from the Middle East command also visited Candia air base in Crete and set 20 fires, the communiqué said.

There was no new report from the British eighth army, as it continued its pressure on Marshal Erwin Rommel, 180 miles east of Tripoli.

An Allied headquarters communiqué last night said the Germans in what apparently was an exploratory operation toward the south end of the Allied line in northern Tunisia, had made a stab in the Bou Arada area, 15 miles west of Pont-Du-Fahs, and shelled the station there.

Bou Arada is about 15 miles south of Medjed-El-Hab.

On the other hand French troops captured a station northwest of Heidous, which is a few miles north of Medjed-El-Hab.

Advices from the front last night told of heavy Allied aerial assaults on the Axis supply ports of Sfax and Gabes and a thrust by P-38 fighters into Tripolitania, where the coastal road linking Gen. Walther Nehring's Tunisian forces with Field Marshal Rommel's retreating Africa corps was violently strafed.

The raids climaxed a week of unrelenting attacks on Axis bases and supply lines, with intermittent enemy assaults on Allied rear positions.

Whether the Allies were preparing for an attempt to smash the Axis defense lines before Tunis and Bizerte or whether they were trying to break up enemy preparations for an attack in force was a matter of conjecture.

The latter possibly was given some weight by French reports during the past few days indicating that the Germans were bringing up heavy reinforcements—including tanks—on the southern flank of the front near Pont Du Fahs, 30 miles northwest of Tunis.

British observers, who know Gen. Nehring as a hard-bitten leader with a penchant for the attack, regarded it as highly possible that the German commander might be preparing a powerful attempt to turn the Allied flank and remove the three and a half front communications with Rommel.

News of the ground action in his sector, however, was limited to an (Continued on Page Three)

Holiday Death Toll Smaller

(By The Associated Press) Fewer violent deaths than last year appeared to have attended the nation's new year celebration, an Associated Press survey indicated today.

Thirty seven fatalities, 26 of them caused by traffic accidents, were recorded shortly before noon. This was a sharp decline from the 132 deaths—83 of them in traffic—marked up during January 1 last year.

Credit for the reduction went at least in part to national rationing of gasoline and the reduction in the volume and speed of motor travel.

Fatalities from miscellaneous causes in new year celebrations included the death of a New York woman who plunged down an elevator shaft during an office party and the asphyxiation of two persons in Ohio as they prepared to attend a party.

PLANES LOST IN ALEUTIANS

Two U. S. Fighters And A Bomber Shot Down By Japs

Washington, Jan. 1.—(AP)—The Navy reported today that four Japanese "Zero" float planes had shot down two American lightning fighters and a bomber while losing only one of their own number in a battle over Kiska in the Aleutian Islands.

Communicate number 235 said:

"North Pacific:

"I. On December 30, at 9:30 P. M. a force of 'Mitchell medium bombers (North American B-25) escorted by 'Lightning' fighters (Lockheed P-38), was intercepted by four Japanese 'Zero float planes' while proceeding to attack two enemy cargo ships (or transports) in Kiska harbor. Two 'Lightnings' and one 'Zero' were shot down during the fight. The 'Mitchell' attacked the enemy ships with uncertain results. One of our bombers was shot down.

"2. On December 31, at 1:47 A. M. Medium bombers again attacked the enemy ships in Kiska harbor. Three hits were observed on one of the ships and two hits on the other. No U. S. planes were lost.

"South Pacific: (all dates are east longitude)

"3. On December 31:

"(A) At 4:30 P. M., task force of 'Marauder' medium bombers (Martin B-26) escorted by 'Lightning' (Lockheed P-38) and 'Airacobra' (Bell P-39) fighters, bombed the airfield at Munda on New Georgia island. Results were not reported.

"(B) United States troops on Guadalcanal island killed 20 Japanese in routine patrol activity. The reported presence of Japanese fighter planes at Kiska came as something of a surprise to naval men here since it had been many weeks since the Japanese had offered any aerial resistance over their base there.

The best they had been able to do since last fall had been to oppose repeated American air attacks on their shipping and shore installations with anti-aircraft fire which at times was weak.

The sudden appearance of four Zero float planes apparently indicated not only a determination on the enemy's part to hold on to the island as long as possible but also an ability to get in sufficient supplies of aviation gasoline and other necessities for the operation of at least a few planes.

There was no explanation as how it was possible for four of the clumsy float planes to outshoot the fast and heavily gunned Lightning planes. One explanation suggested by officers issuing the communiqué was that weather conditions might have governed the results and that the Zeros might have attacked out of a cloud.

Warrenton Man Is Victim Of Axe-Man

Warrenton, Jan. 1.—(AP)—Vernon Powell, merchant and cafe operator, was clubbed to death about midnight in his cafe. Officers said they believed robbery was the probable motive.

Powell's body was found in a pool of blood. A bloody axe stood in a corner nearby.

Police Chief Jack Scott, who had led the place only a short while earlier, tried to get bloodhounds for use in the hunt for the slayer but failed.

President Says Unity After War Is Essential

Washington, Jan. 1.—(AP)—President Roosevelt declared today that it was a "supreme necessity" to plan for the post-war peace and to carry forward after the war the unity now being displayed by the United Nations, to prevent another world cataclysm.

The President issued a statement at a press conference opening the new year, asserting the United Nations "are passing from the defensive to the offensive," and adding:

"The unity achieved on the battle line is being earnestly sought in the not less complex problems on a different front.

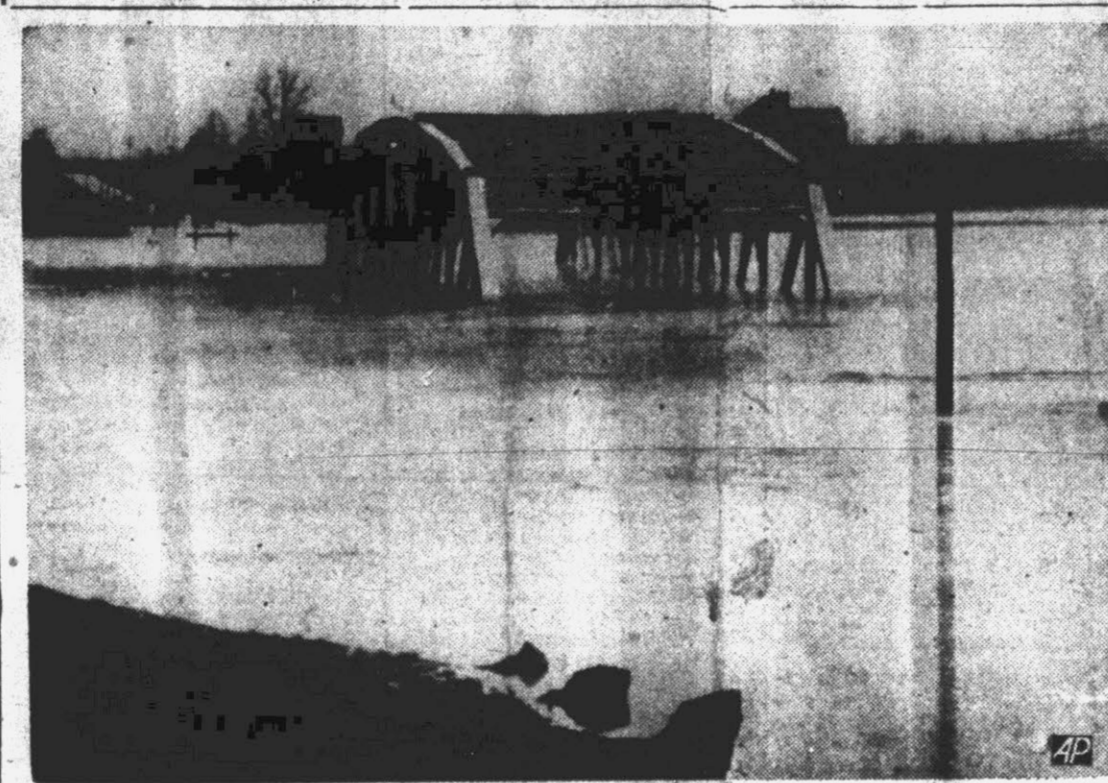
"In this as in no previous war men are conscious of the supreme necessity of planning what is to come after—and of carrying forward into peace and common effort which will have brought them victory in the war.

"They have come to see that the maintenance and safeguarding of peace is the most vital single necessity in the lives of each and all of us."

He emphasized that the original 26 nations, augmented later by three other signers, wanted to remain united at the end of the war as well as during the war.

VICTORY TAX NOW IN EFFECT

Five Per Cent Deduction From All Pay Rolls

(By WILLIAM F. ARBOGAST) Washington, Jan. 1.—(AP)—Starting today the average American who works for a living will have to get along with at least five per cent less income, but eventually he will get some of it back in one form or another.

At midnight last night the new Victory tax went into effect, and Uncle Sam will start clipping from every pay envelope five per cent of each week's pay in excess of \$12.

The tax will be withheld from your pay, the responsibility of collecting and turning it over to the treasury resting with the employer.

At the end of the year, each employer must certify to each employee the amount of Victory tax withheld during the year.

In case you are paid bi-weekly or monthly and your first pay in 1943 includes money you earned in the closing days of 1942, the five per cent comes out of the total, not alone that part of the pay earned in 1943, for the law imposes the tax on all wages received in 1943.

It's not all tax, however, for post-war credits are allowed on part of it. You can use the credit during the war for paying other taxes, liquidating valid indebtedness, buying War Bonds or paying insurance premiums, or you can let it ride until after the war and get it all at once.

There's how the tax works in the case of a man whose total income is \$2,624.

The employer will deduct five per cent of the \$2,000 taxable income each pay day and at the end of the year he will notify the employee that a total of \$100 has been turned over to the treasury.

The employee automatically has a post-war credit, depending on whether he is married or single. If he's married, the credit is 40 per cent, plus an additional two per cent for each dependent. If he's single, the credit is 25 per cent. In no case, however, may the credit exceed \$500 for a single person and \$1,000 for a family head, plus \$100 for each dependent.

New Assembly To Face Many Difficult Problems

Nine-Month Schools, Salary Increases And Liquor Among Major Controversial Issues

(By RALPH L. HOWLAND) Raleigh, Jan. 1.—(AP)—The first regular legislative session held in wartime since 1865 will open next Wednesday. But in place of the near-bankruptcy of civil war days, the state now has its largest surplus in history.

Approximately \$31,000,000 will be in the general fund surplus by the end of this fiscal year. The Highway Department surplus will be about \$19,000,000. Dispositions of those funds will be one of the principal problems before the 1943 General Assembly.

Governor Broughton and other state officials have urged that the legislature set aside at least \$20,000,000 for the post-war rainy days when decreased revenues will be a headache for advocates of a balanced budget.

But other proposals, if enacted, would severely drain the surplus. There are such matters as the nine-month school and increased pay for teachers and state employees. Now that the federal government has ordered liquidation of the WPA, the state must of necessity care for more unemployables. But, as the governor said recently, as long as he is the chief executive, the state will not play Santa Claus to those who can work but won't.

The legislature also must consider such proposals as amending the recently adopted school board amendment, special war powers for the governor, the redistricting of legislative areas, the sales tax and the ever-present liquor problem.

Those are the principal problems now in view. But undoubtedly others will pop up after the legislative wheels start grinding. Refund of revenue from the intangibles tax might be one. The structure of the Highway and Public Works Department during the war might be another.

The governor already has set his sights on a comparatively brief session and it may be if harmony reigns. The governor in all likelihood will recommend that the assemblymen spend as much time in Raleigh as possible and will point out the current troubles of travel. Yet, as Senator L. Y. Ballentine of Wake county remarked, the legislature must slow down at times, particularly on week-ends, to let the enrolling office catch up with its work.

The consensus is that the session will last about 60 days, perhaps a few days less.

There will be a fight over the nine-month school proposal. The Piedmont and west have not raised much objection to it but the farming east has. Proponents argue that the huge surplus justifies the longer (Continued on Page Two)

COUPLE DIE IN GAS CHAMBER

Rosanna Phillips First Woman Executed By State

Raleigh, Jan. 1.—(AP)—Rosanna Lightner Phillips, the first woman executed by the state, and her husband, Daniel, died today in the gas chamber for the axe-slaving last August 3 of Harry F. Watkins, 64-year-old Durham county farmer.

They contended to the last that the other was responsible for the crime but each told prison chaplain L. A. Watts that the other was forgiven.

Phillips, 29, died first on request of the paroles officer, which indicated that if he had assumed full responsibility, clemency might be awarded the 26-year-old scar-faced woman. He entered the chamber at 10:01 but the gas mechanism was faulty and the deadly fumes did not rise until seven minutes later. He was dead in 12 minutes.

The little chamber was fumigated and Rosanna, with a Negro spiritual on her lips, entered at 11:01. She was dead 17 minutes, 20 seconds, the shortest time on record.

Phillips told Watts that Rosanna hit Watkins first and he struck the prostrate farmer after he was dead. He said Rosanna bought a hat and dress with the money they took from Watkins.

Rosanna, who spent 15 minutes with her husband before the execution, said she did not kill Watkins but merely helped to carry the body away.

Phillips was the 25th person executed by the state in the 32 years it has been carrying out capital punishment.

CONGRESS TO DRAW TAX BILL

To Make Own Decisions On New Revenue Measure

(By JACK BELL) Washington, Jan. 1.—(AP)—Congress may be called upon to write its own tax ticket under a broad request from President Roosevelt for about \$90,000,000,000 to finance the war this year.

The view that congress ought to be permitted without undue prodding from the treasury or other executive agencies, to make its own decisions on new taxes was reported today to have been taken by James F. Byrnes, the economic stabilization director who has urged adoption of fiscal policies that will "even the threat of inflation."

Byrnes' reputed attitude coincides with that regarded in some quarters as the beginning of a new trend in relations between the chief executive and congress, marked by the President's statement this week that the legislators would have to decide where to make economies "in the forthcoming budget."

Some legislators estimated this budget total at around \$95,000,000,000.

Direct federal taxes are expected to raise approximately \$25,000,000,000 under present laws and Secretary of the Treasury Morgenthau said last fall, even before the President signed a record-breaking new revenue bill that at least \$6,000,000,000 more was needed. That estimate may be increased greatly.

Additional amounts needed to reach the total required for financing the war are expected to be provided by the various government borrowings, including war bonds. The victory loan drive, the treasury's greatest war financing campaign in history, alone produced approximately \$12,000,000,000 in a 23 day drive in December.

Russians Score New Gains Encircling More Germans

JAPS BLASTED IN NEW GUINEA

Twenty-Three Jap Planes Destroyed By Allied Raids

Allied Headquarters in Australia, Jan. 1.—(AP)—American P-38's led an assault yesterday on Lae, northeast New Guinea Japanese base and shot down nine enemy fighters and damaged two others. General Douglas MacArthur's headquarters declared today in a communiqué supplemented by an air force announcement reporting that 1,286 Japanese planes have been destroyed in the southwest Pacific since the war began.

The smashing blow delivered to Lae was part of wide-ranging Allied air activity that saw four Japanese airmen bombed and strafed and at least 23 Japanese planes destroyed or damaged.

Today's headquarters communiqué said the attack on Lae was a coordinated assault by fighters, attack planes and medium bombers.

"The attack was initiated by 11 of our P-38's which engaged 12 enemy Zeros guarding the airfield," it said. "The P-38's swept the air shooting down nine of the enemy and damaging two, while sustaining only two damaged planes which reached their base safely.

"The attack elements then strafed the field, destroying four bombers and one Zero on the ground. Our medium bombers then finished by bombing enemy ground installations with heavy damage.

In other air action, a heavy bomber fired a twin-engine Jap plane on the airstrip at Gasmeta and planes bombed the airstrip at Wewak, New Guinea, and swept over the northern Solomons in a night raid to hit the airstrip at Buksa on Bougainville island.

The land fighting in the Buna area consisted mainly of mopping up along the corridors driven through Japanese defenses some to the sea but there was heavy fighting again on the Sananda track, north of Buna, the communiqué said.

The air force report for the year of war said that at least 723 Japanese planes of the 1,286 total were definitely destroyed, 250 others were probably destroyed, and 319 were damaged—all in straight aerial combat.

Allied losses, the announcement said, were comparatively small for the period.

Most of the enemy planes were shot down in the New Guinea zone.

The airforce headquarters said U. S. Flying Fortresses, though bombers, had especially shown their superiority over Japanese fighter planes.

Fortress gunners in the last six months have shot down in air combat, 60 Zero fighters, probably destroyed 67 others and damaged 60 more.

Daily tallies of Jap planes destroyed reached as high as 21 in air combat and 20, confirmed by photographs, in ground strafing.

RAF BOMBERS RAID GERMANY

Railway Targets In Northern France Also Hit

London, Jan. 1.—(AP)—The RAF started off the new year by bombing targets in western Germany during the night, the Air Ministry announced today.

Railway targets in northern France also were attacked and mines were laid in enemy waters, a communiqué said. Loss of two bombers in the night operations was acknowledged.

The specific targets which were attacked in Germany and the size of the raiding force were not immediately disclosed.

Britain, meanwhile, spent a raid-free night, no enemy planes being reported over the country up to 7 a. m. today.

The British aerial operations last night followed up attacks by RAF bombers and fighters yesterday on railroad yards and assembly shops in occupied France and Belgium.

Six locomotives were reported damaged and bomb bursts were seen in the target areas in these assaults. No planes were lost, the Air Ministry said, though two fighters were reported missing following a sweep over the Pas De Calais area. Two enemy planes also were listed as destroyed over the continent.

Officials Say New Year To Be Hard But Fruitful

(By JOHN H. WIGGINS) Washington, Jan. 1.—(AP)—The new year was born today to a nation straining for a total wartime status amid official prophecies that each of its 365 days will be a grim struggle toward victory.

It is to be a year of extremes, say these forecasters—a year sometimes bringing military reversals but more often triumphs; prosperity but also economic dangers; vastly increased production of armament, but fewer and fewer civilian goods.

And even in its midnight birth 1943 was received from coast to coast with such mixtures as gaiety by revelers; reverence by watch night throngs in churches; sober effort by continuous shifts of war workers; and with grief by thousands made homeless by floods in sections of Pennsylvania, New York, West Virginia, Ohio and Oregon.

New York's great white way became the "great dim way." Crowds numbered as high as 500,000 who cheered the new year in on streets darkened in conformity with wartime regulations. Hotels, night clubs, restaurants and theaters were crowded. Along the waterfront, they saw the Statue of Liberty's upraised torch flash a "V for victory."

Gasoline rationing reduced motor travel and fewer violent deaths marred the new year's eve celebration. Virtually all war plants continued their round the clock production.

Observance of the new year in the nation's capital brought prophecies from high government officials that 1943 will bring further military progress toward victory but there were warnings of numerous hardships ahead.

Milo Perkins, executive director of the Board of Economic Warfare, predicted air attacks during the year on Hitler's industrial Europe can materially weaken Germany's economic position. Similar assaults on the Japanese merchant marine he observed, can have similar effect on Japan's opportunity to make use of conquered lands.

Secretary of Commerce Jones predicted the national income, estimated at \$117,000,000,000 in 1942, will soar to a record \$135,000,000,000 total. But while it will bring prosperity to the home front, he added, it will also bear elements of economic danger against which the nation must guard.

"No segment of our economy," he said, "will escape the war's impact and every citizen will feel its pressure."

Reds Push To Shores Of Lake 40 Miles Beyond Elista Cutting Off Nazis In Caucasus; Over 300,000 Nazis Killed or Captured In Stalingrad Sector; Nazi Equipment Losses Heavy

(By HENRY C. CASSIDY) Moscow, Jan. 1.—(AP)

Leaving the Kalmyck capital of Elista far in its rear, the Red army has driven to the shores of the Great Lake east of Salsk in an offensive aimed directly at the Caucasus after trapping 22 divisions at Stalingrad and killing or capturing 312,650 of the enemy, the Russians reported today.

The rush to the shores of the Great Lake, now frozen and snow covered, carried the Russian troops to a point about 40 miles southwest of Elista in the biggest single day's jump of the offensive below Stalingrad.

The Russian winter campaign thus had put the German forces in the Caucasus in an increasingly dangerous position after building a wall 37 miles thick at its narrowest point around the 22 German divisions trapped at Stalingrad.

The advance point reached yesterday, a Soviet communiqué disclosed, was Priyutnoe, about 40 miles south of Remontnoe, which was taken the previous day.

The German garrison at Elista was virtually encircled, with the Russians having passed by both on the south and north.

The lake spreads northwest to the approaches of Salsk.

Salsk is a key point of the railway system south of the Don. It is a junction point for a connecting line to Rostov. Consequently it was of importance in maintaining the connection between the Germans in the Caucasus and in the Ukraine.

Twenty miles south of Priyutnoe is Divnoe, the starting point of another railway linked with the Rostov-Baku trunk line. An advance along that line would threaten the approaches of the German forces hurried deep in the Moxdok and Nalchik sectors of the Caucasus.

Another dangerous bend had been created for the Germans farther north along the Don, where their flanks were menaced by two Red army salients southwest of Stalingrad through Kolesnikovskiy and west of Stalingrad to the Millerovo area.

The Germans still held the latter town, but the railroad leading southwest to Voroshilovgrad had been cut.

The special New Year's communiqué said 1,589 towns had been captured in the powerful triple offensive on both sides of Stalingrad, in the middle Don and southwest of Stalingrad with began Nov. 19. Advances up to 125 miles had been chalked up, it said.

Vast quantities of German equipment were reported destroyed or captured in the push. (Continued on Page Six)

State Guard Needs Members Home Duty

(By CHESTER WALSH) More than 200 men have been members of Company 4, Second Battalion, First Regiment, N. C. State Guard, since the militia company was organized in Greenville nearly two years ago under the sponsorship of Post No. 39, American Legion. The ranks are being rapidly depleted now by the draft for the armed forces, Capt. Jasper L. Jones, commanding officer, stated today.

The State Guardsmen serve without pay on a volunteer basis. They receive pay whenever they are called to duty. The State Guard was organized to train men from 38 to 45 years old for military duty to protect the home front in case of a raid by the enemy or a riot or other public disturbance. The guardsmen are expected to take care of any emergency until the regular army arrives. They drill on Tuesday nights. They have an officers' training school on Thursday nights. Men of every walk of life have served in the Greenville unit. Major Zeno Hollowell of Goldsboro is battalion commander. The company's quota is 50 men.

The draft has considerably reduced the State Guard ranks here. The company recently lost 10 men and will shortly lose 10 more to the U. S. army.

Captain Jones today asked for the cooperation of business and professional men in encouraging men to join to keep the company up to standard and safeguard the home front in time of trouble. Men who are willing to join are requested to communicate with the commanding officer at the Greenville Fire Department or at the armory on Tuesday nights.

school term and opponents contend the surplus is only temporary and as a result of the war boom. The east opposes it for rural areas, especially with the current shortage of farm labor.

Just about every state department has asked for increased pay for employees and state institutions and schools have asked the Advisory Budget Commission to recommend enlarged appropriations. The governor favors more money for mental institutions.

Gov. Broughton has not indicated how much emergency power he will ask but capital observers believe it will be for quite a bit and he may get most of it. Some believe the legislature will grant special powers to the Council of State or some other board but the governor would be limited by the decisions of the controlling body.

Dry forces have indicated they will use the war as an argument against the sale of alcohol. One proposal would ban the sale of any alcoholic beverage on Sundays or in military or naval post areas. On the other hand, the wets may seek to allow county seats or towns of more than 10,000 population to vote on the issue separately from the counties. The fact that distilleries have converted to war production and liquor stocks are becoming depleted may have some bearing on the arguments.

Those are but a few of the ideas obtained from questionnaires and personal interrogation of legislators-elect and state officials. Here are the ideas of some experienced assemblymen:

"I am in favor of tying up the surplus so that it cannot be used for the next few years."

"I am opposed to the nine months school term for rural areas."

"I am in favor of increasing the teachers' pay."

"I see no reason to change the liquor situation. It seems to be handling itself very well."

"I feel that teachers as well as other state employees in the lower bracket should have a substantial increase in their pay, and I feel that the state is now in a position and should provide for nine months of public schools."

"In dealing with the surplus, it might be stated that this surplus is just not a happen so. It is a result of long planning and economic government. The defense activities within our state have, of course, enlarged the surplus, and this phase of it is a temporary proposition."

"We should spend a normal part of the surplus to improve our schools and other state supported institutions. That part of the sur-

plus built up on account of extraordinary time should be preserved to take care of possible depression following this period of prosperity. I would not be in favor of putting it in 27-year bonds unless these bonds were assured of a market or were callable.

"Before we spend the normal surplus we should preserve enough to keep us on a cash basis. As you know, it takes several million dollars a month to run the state, and when we lower our surplus below a month's expenses, we are not on a cash basis, and we cannot take discounts, etc."

"Those legislators, reviewing the legislative problem informally, said they wish to wait until the legislature "settled down" before going into details about their stands.

As Ballentine pointed out, the 170 members of the General Assembly have ideas of their own and a fellow might change his mind.

**MANY OFFICES TO BE FILLED**

**President Has Numerous Appointments To Make**

By D. HAROLD OLIVER

Washington, Jan. 1.—(AP)—One of President Roosevelt's tasks as he starts the new year today is that of finding the men for nearly a score of important federal positions which have become vacant in recent months.

The two top posts from a public interest standpoint are those of Associate Justice of the Supreme Court, vacant since October 4 when Justice James F. Byrnes resigned to become economic stabilization director, and a federal price administrator to succeed Leon Henderson.

Nominations may go to the new Senate next week. Senator Frenss M. Brown of Michigan, defeated for reelection in November, is expected to get Henderson's job. Washington has given up guessing on the court place.

Justice Wiley Rutledge, a 1939 Roosevelt appointee on the District of Columbia Court of Appeals and former dean of the University of Iowa law school, has been in the latest speculation.

Besides Brown, two other Democratic senators who lost out to Republicans in November are in line or have been recommended for new government posts.

One, Senator Josh Lee of Okla-

homa will be nominated for a place on the Civil Aeronautics Board.

Senator Harry H. Schwartz of Wyoming has been recommended for a place on the National Labor Relations Board or the National (Railway) Mediation Board should an early vacancy occur.

There is a long-standing vacancy on the Board of Governors of the Federal Reserve System, two on the United States Tariff Commission and, more recently, the solicitorship at the Department of Labor.

Assuming the taxpayer is married and has no children, it develops that his Victory tax bill is only \$60 after he deducts the \$40 credit.

How to get the \$40 is something else.

It may be used currently, at the option of the taxpayer, for the payment of taxes, insurance premiums or outstanding debts, or for the purchase of War Bonds. Or the taxpayer may wait until the war ends and apply the credit at that time to any taxes he may owe, such as income tax installments. If he owes no taxes, or his tax bill is less than the amount of credit, the law entitles him to a refund, which Congress will be paid in negotiable government bonds.

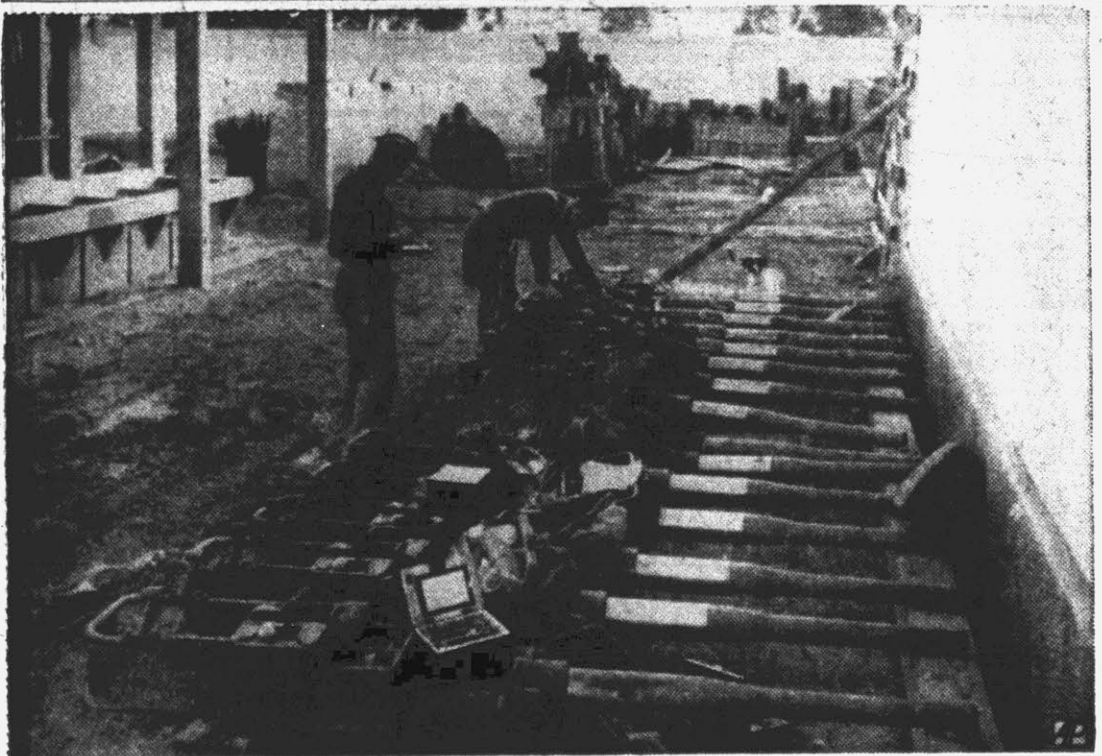
The post war credit is reduced by the amount of the credit used currently.

For example, a married man without dependents may have paid \$40 in insurance premiums during the taxable year and wants to take the credit immediately. Since that is the amount of his credit under the 40 per cent limitation, he may get an immediate refund from the treasury.

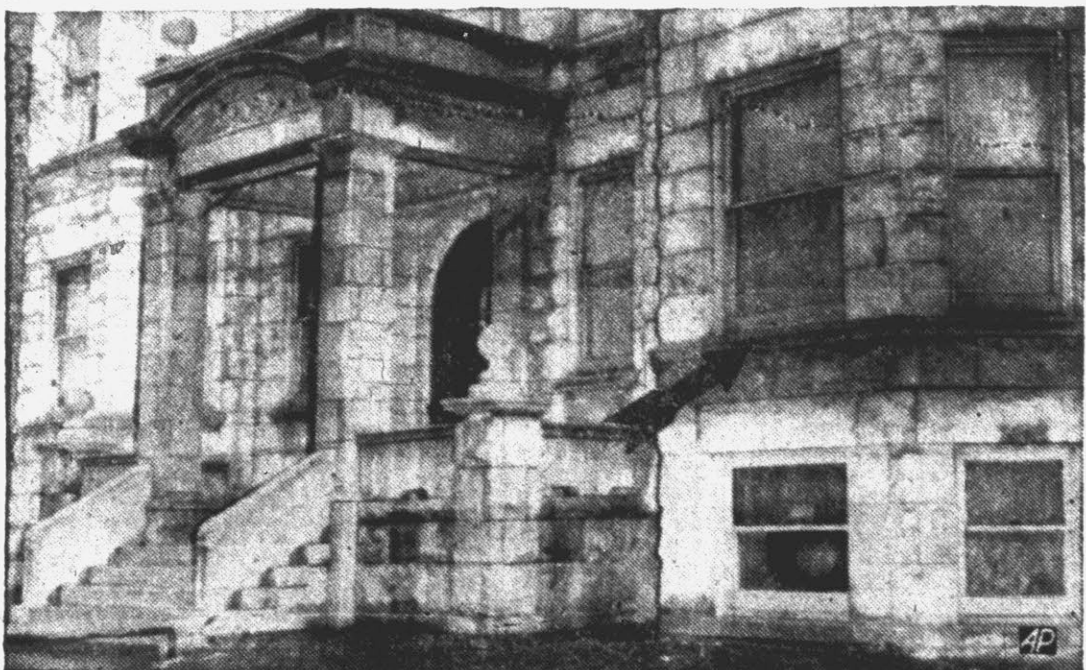

### WASHINGTON IN WARTIME

By JACK STINNETT

Washington—If you can believe the handwriting on the wall, that that old greeting, "Good Morning, Judge," soon is going to be a good deal more cheery when you have to make your bow to the "his honors" of the traffic courts all over the nation.

With the public becoming very "government-conscious" as a result of the war, there's a move on to get rid of "horse and buggy practices" indulged in by many traffic courts.

Sen. Abe Murdock of Utah recently brought to the attention of Congress a lengthy report by the National Committee on Traffic Law Enforcement. When congressmen and other government officials read that "in 42 cities of over 100,000 population, four out of every ten arrests are for traffic offenses," they began to sit up and take notice.

Said Senator Murdock: "We are going through substantial changes in our daily life. These changes are

making us increasingly aware that we still have with us in this motor age many of the practices and conditions that prevailed in the horse and buggy era."

As a result of this survey there is going to be a nationwide drive, sponsored by a good many government officials and members of Congress, as well as the organizations mentioned, to:

- (1) Revise traffic laws to get rid of the unenforceable and more importantly the unnecessary (check your own and you will see what they mean) laws.
- (2) Make traffic laws all over the land as uniform as possible within the limits of purely local requirements.
- (3) Having special traffic courts in all cities where traffic cases number more than 7,500 a year with a violations bureau in operation or 15,000 a year, if there is no such bureau.
- (4) Have circuit and district traffic courts organized on a statewide basis.
- (5) Eliminate "court costs" entirely or impose such costs only on a reasonable basis.
- (6) Appoint traffic court judges who know traffic laws, policing and engineering, as well as have backgrounds in the ordinary legal fields.
- (7) Have permanent or long-term traffic court magistrates, supervised by a chief traffic court magistrate with regulatory powers.

If the folks behind this national movement get their "druthers," there'll be no more that old story: "So I just paid my fine and let it go; what's the use arguing even when you're not guilty?"

At least they hope to bring the "horse and buggy" police courts up to the Model-T era. In some sections, that'll be quite an advance.

# INJURIES KEEP SINKWICH OUT

## Georgia Star Is Not Likely To See Much Action In Rose Bowl Today

Pasadena, Calif., Jan. 1—(AP)—Against a backdrop of world conflict the Georgia Bulldogs and the UCLA Bruins greet the New Year today on the tough but friendlier field of football—the Rose Bowl classic.

Whether there will be another college bowl game until the fight for Democracy is settled is debatable but the 1943 renewal of the granddaddy of all the post-season gridiron spectacles claimed the attention of some 93,000 fans.

Two flat feet and a pair of sprained ankles had tens of thousands mumbering.

The fragile ankles and imperfect pedal extremities belonged to Georgia's All-American backfield ace, Frankie Sinkwich. As the climax to the Bulldogs' practice preparations, coach Wallace Butts said late yesterday that flatfoot Frankie would not start the game.

The squat Georgia Mentor seemed serious as he stated: "I am not going to start Sinkwich. He did not look particularly good yesterday and did not work out at all today (Thursday). It looks like now will have to call on me only for some particular spot. And I'll have to decide on that as the game progresses."

There were some who did not view the statement with alarm, however, socking Sinkwich shuffled and limped through a sensational season. He led the Bulldogs to ten victories in an 11-game schedule, finishing as the highest scorer in the Southern Conference and was voted the most valuable athlete in the country.

It is axiomatic that as Sinkwich goes so goes Georgia. He couldn't go against an Auburn team that pulled out all the stops and Georgia lost its only game.

Reaction at the University of California at Los Angeles camp was flat as a mashed potato sandwich. The Bruins, from head coach D. Horrell down, were prepared for the southern star to play the most spectacular game of his career.

At the same time it was an open secret they feared Sinkwich's backfield mate, Charlie Trippi, more than the high scoring captain of the team. Trippi, the sophomore under study to flatfoot Frankie, ran wild against Georgia Tech in the finale that clinched the conference title and the Rose Bowl invitation.

### Boston's Connolly Passing Again



Boston College's big worry about the New Year's Day Orange Bowl game in Miami has centered around Mickey Connolly's shoulder injury which kept him from throwing the ball when the team arrived in Miami. Trippi, the speed specialist and longpasser, takes over the starting burden and Sinkwich's spot was assigned to Dick McPhee, an able replacement.

Otherwise the 27th Rose Bowl picture was unchanged since the Bulldog powered through the southeast, with one exception, and the Bruin staggered through to his first Pacific coast conference title, meanwhile losing to Texas Christian and the St. Mary's pre-flight on the outside, and to Oregon in his own league.

The picture, as the teams lined up today, was painted in this fashion: Georgia (Sinkwich in or out) 1 to 3 favorite over UCLA. Georgia, No. 2 team of the nation, to win by 12 points or more.

Eastman in Washington this week returned to Chicago last night, his train eight hours late. Before he arrived he had instructed his office to announce the special parole—out of which is expected to come a clearly defined 1943 program.

Whatever promises of cooperation Landis made to eastman or whatever the commissioner has in mind for "definite announcement" will be withheld until the big baseball family has its second reunion within a month.

Eastman possibly gave Landis a "definite announcement" in regard to spring training travel. Several weeks ago Clark Griffith, president of the Washington Senators, said he was told by the ODT director that "definite word on spring training could be expected by early February."

Meanwhile, most of the 16 major league clubs have shopped for training sites nearer home, forsaking the usual lengthy trips to California Florida and other warm weather playgrounds. Three clubs have come up with new spots while others have tentative places in mind, pending the "definite announcement." The Chicago White Sox and Cubs selected the old Mineral Spa, French Lick, Ind., 278 miles south of Chicago. The Boston Red Sox will train in the gymnasium at Tufts College Medford, Mass. Other teams have attempted to get gyms or field-houses but met little success, for many of the athletic facilities have been turned over to service men.

Before settling the question of training at home or within a de-training radius, another important item must be acted upon—whether to open the two major league seasons April 13, as planned, or vote a delay until April 24 or 27. If clubs assemble near home, the later dates would allow extra days of warmer weather to exercise outdoors. The 140 game schedule drawn up for each club in 1943—or even 15 games as in former years—could be fitted into the period from April 27 to September 26, the closing date.

# NO ARGENTINE RIFT WITH AXIS

## Break In Relations At This Time Unlikely

Buenos Aires, Jan. 1—(AP)—A vigorous Argentine retort to an official British statement criticizing Argentine foreign policy led political observers to believe today there is small chance of this country's severing relations with the Axis powers—at least for the present.

The Argentine reply was contained in a 200-word communique issued last night by Foreign Minister Enrique Ruiz Guinazu in which he expressed "astonishment" at the British statement and declared it had been couched "in terms which are not in keeping with the friendly relations between the two countries."

The statement which he referred, issued yesterday by the British foreign office, had deplored the fact that Argentina has continued to maintain relations with "the enemies of humanity."

In issuing the statement the British foreign office declared it wished to correct reports which it attributed to Buenos Aires newspapers and an Argentine official publication creating the erroneous impression that England was supporting Argentina's neutrality policy. In his reply Ruiz Guinazu declared the British statement had been based "on a serious error by the British foreign office in attributing to an Argentine official publication what that publication never suggested or intended to suggest."

## Coffee Rationing Violator Arrested

Charlotte, Jan. 1—(AP)—Nick D Kaperonis, operator of two downtown restaurants here, was arrested today on charge of falsely reporting the amount of coffee he had on hand when the rationing program went into effect.

Ralph Kidd, attorney for the OPA said Kaperonis was alleged to have reported having 80 pounds on hand at the bus terminal restaurant and 60 pounds at the Little Pep-De-monia while actually having 303 pounds at the terminal and 411 pounds at the other place.

Kaperonis was recognized under \$500 bond for his appearance before a U. S. commissioner.

Dowell said the State's General Fund Surplus was expected to top \$30,000,000 by June and contended there would be no need of sales tax revenue during the next biennium at least.

# INDICT 10 FOR BOSTON FIRE

## Laxity And Incompetence Blamed For Big Death Toll

Boston, Jan. 1—(AP)—Condemning "laxity" and "incompetence" among Boston officials, a Suffolk county grand jury has returned 11 indictments against ten men in connection with the Cocoanut Grove night club fire which snuffed out the lives of 489 persons.

Among those indicted were the club owner and manager, a police captain, who was making a routine inspection visit at the club on the night of the disaster; a fire lieutenant and a city building commissioner.

Barnett Welansky, a Boston lawyer and owner of the Grove; his brother, James Welansky, manager of the club; and Jacob Goldfine, vice steward, each was charged with manslaughter. Each was held in \$15,000 bail, double surety.

Others indicted were: James H. Mooney, Boston building commissioner, wilful neglect of duty, \$1,000 bail.

Police Captain Joseph A. Buccigross, a member of the department for 23 years, wilful neglect of duty \$1,000 bail.

Lieutenant Frank L. Linney who inspected the club several days prior to the holocaust, wilful neglect of duty, \$2,500 bail.

Samuel Rudnick, contractor, conspiracy, \$5,000 bail.

Reuben O. Bodenhorn, night club designer, conspiracy, \$2,500.

David Gilbert, who helped construct a new cocktail lounge, conspiracy, \$2,500.

The tenth man named in the indictments was identified by state police as a Boston building inspector. They said that through arrangement with his lawyer he would surrender today.

## Would Halt Draft All Farm Labor

Washington, Jan. 1—(AP)—A halt to the military drafting of farm labor was called for today by Senator Aiken (R-Vt) as the only way to avert "the gravest food crisis in the history of this nation."

"If agricultural workers aren't assured in 1943, we may witness an alarming food shortage before the end of this year," Aiken told reporters.

Taking cognizance of reports that War Manpower Commissioner Paul V. McNutt had announced he would "go as far as necessary" to give agriculture all the workers needed to plant and harvest the crops, Aiken expressed hope "he will act speedily."

He urged that McNutt set up a program "that is adequate and certain, as we can't afford any mistakes."

At the same time, Aiken expressed hope McNutt and other administration leaders would limit the armed forces to a size that can be fed. "The time has come to determine the maximum number of men we can put into the army and navy and still feed and maintain them while allowing food and equipment for all United Nations," Aiken, a leading Republican farm bloc member, declared.

# FLOODS SWEEP THREE STATES

## Thousands Homeless In Ohio, Kentucky And West Virginia

Portsmouth, O., Jan. 1—(AP)—This industrial city of 40,466 residents braced itself today to meet the crest of a flood swollen Ohio river as a company of United States army engineers patrolled the streets to aid rescue work and maintain order.

River-wise residents of this important steel and show-making community faced a rampaging stream which with its tributaries left between 17,000 and 20,000 homeless in West Virginia and brought death to two persons in western Pennsylvania.

On the basis of up-stream reports where the river now is cresting or falling, a crest of 60 feet, 11 above flood stage, is expected here tomorrow. The dike which partially protects this city is 62 feet high but a crest of 61 feet would close the Wheeling steel plant, shoe factories and other industries, it was said.

At least 10,000 Ohioans were reported to have been removed from their homes during the night, and the Ohio State Highway Department said all endangered persons on both sides of the stream as far south as Huntington, W. Va., had been evacuated.

Score of flood-threatened families evacuated lowlands and exposed areas in northeastern Kentucky today as the Ohio river and its tributaries rose rapidly.

The weather bureau at Huntington, W. Va., warned the Ashland and Catlettsburg, Ky., communities to prepare for a crest of 65 feet by tomorrow night.

In Ashland a call was issued today for all available men to assist in evacuating families in threatened areas there and at Catlettsburg.

A battalion of Negro soldiers went from Fort Knox today to the Henderson (Ky.) area to help gather crops threatened by flood waters.

Williamsburg, Va., Jan. 1—(AP)—James A. Payne, former secretary of Chambers of Commerce at Staunton and Fredericksburg, Va., and Wilson, N. C., was shot and seriously wounded early today in a dispute over a woman. H. Wecc—St. Chief of Police W. H. Kelly said with a fellow employee.

## Blackout Rules Must Be Obeyed

Now that there is no advance notice as to when blackouts will be called, it is not known when they are called whether it is a test blackout or an air raid. For this reason the Office of Civilian Defense has ordered that the rules covering the blackout must be obeyed by all without exception and that those violating such rules must be punished.

In the future, the names of any person or persons who during a blackout, refuse to obey the orders given them by the Air Raid Wardens or Auxiliary Police or who through carelessness, otherwise violate blackout rules, will be turned over to the Greenville Police Department where they will be ordered to court for trial. The fine authorized by the City of Greenville for those guilty of such violations is fifty dollars.

The above notice was given by Charles A. White, Commander of Civilian Defense.

**Negro Soldier Killed**  
Fayetteville, Jan. 1—(AP)—Pvt James Hines, Negro, of Fort Bragg was fatally stabbed in a street altercation here last night. Lillie Cantey, a woman companion, was seriously cut.

the middle Don area, and far south of Stalingrad were three closely-knit phases of one major strategic operation, carefully drawn up by the Red army command to save Stalingrad.

"The aim was skillfully accomplished," the communique declared. It revealed that the Soviet drives went into high gear Dec. 12 and imputed bad planning to the German high command.

"In the course of September, 1942, the German Fascist troops were halted by the Red army before Stalingrad," the special victory recapitulation recounted.

"The war's trend disclosed that the German strategic plans to capture Stalingrad and to cut off the central European part of the Soviets from the Volga and the Urals was hurriedly formed without taking into account their actual resources and the Soviet reserves.

"In complete contrast was the Soviet's strategic plan for surrounding and defeating the German troops at Stalingrad, drawn up by the supreme command of the Red army. This plan was carried out in November and December, 1942."

Twenty-seven Russian commanders were cited specifically in the communique for their leadership among infantry, tank and plane forces, under the general leadership of Gen. Gregory K. Zhukov. Commanders principally singled out were Col. Gen. N. F. Vatutin, Lt. Gen. Constantin Rokossovsky, Lt. Gen. F. L. Golikov, Col. Gen. Yermenko, Col. Gen. Visslavsky and Col. Gen. Voronov.

For the first time Soviet authorities, claimed officially that the 22 German divisions before Stalingrad—some of the Nazi troops still hold dugouts in the factory area of the Volga river port—were tightly encircled.

And for the first time Col. Gen. Yermenko was named as the supreme commander of the city which went under siege 131 days ago today. (Yermenko was not listed in available American directories and his name has not figured in Soviet strategy reports before.)

The regular communique of the Soviet command, issued early today following the special announcement, said the drives continued yesterday on all fronts. It reported the capture of Oblivskaya, a city on the Chir river in the lower Don 90 miles west of Stalingrad and 100 miles southeast of Millerovo, which Red army units now surround. A train load of airplanes was reported taken at Oblivskaya.

The capture of the district centers of Nizhne Chirskaya, about 65 miles southwest of Stalingrad on the west bank of the Don near its junction with the Chir river, and of Pritynoo—a variable spelling—is shown on available maps 40 miles

slightly southwest of Elsta and 40 miles south of Remontnoe to which the Russians had driven Tuesday. The extent of the advance indicates the speed with which the Red army was moved into the Kalmyck steppes. The town is only about 10 miles from the waters of the Manyeh river.

The third communique of New Year's Day (the Soviet Information Bureau's midday bulletin, said the Russian offensive continued to roll in last night's fighting, with the capture of several more populated places southwest of Stalingrad and three more towns in the middle Don.

German counter-attacks remained bitter, the bulletin said, but futile.
