Germans Evacuate Taman In Flight From Caucasus

Reported Fleeing Across Kerch Strait To Crimea; Nazi Forces Fighting Desperately To Block Russian Flanking Movements Along Upper Dnieper

London, Oct. 4.—(AP)—German troops were threatened with the loss of their last tenuous toehold in the Caucasus today as the Red army drove them back from Staro-Tamanskaya on the Taman peninsula, while on the upper Dnieper river the Nazis fought furiously to block a Russian flanking movement aimed at Mogilev.

The announcement of the fall of Staro-Tamanskaya was made by the Berlin radio, and the full extent of the German collapse in the Caucasus was indicated in a Russian communiqué last night which told of the sinking of a number of troop-laden ships which apparently were attempting to evacuate the remnants of the shattered German army across the narrow Kerch strait to the Crimea.

On the central front, Moscow said, more than 2,000 Nazis were killed as the Russians stormed across the Pronya river, 28 miles east of Mogilev, to occupy 70 villages in a maneuver which threatened to turn the German flank in that sector.

The Soviet ground forces were supported by Red army airmen, who pounded both Mogilev and Rostov, an important junction town 50 miles to the north.

The Russians said that large quantities of supplies and Nazi artillery pieces were captured, as well as considerable material which had been taken from Russians in that area.

South of Mogilev the Russian columns advancing on Gomel found their assaults slowed up by the Germans, who launched numerous counter attacks all of which were repulsed.

The Russians said they had taken 1,300 German prisoners and 3 to 5 miles and captured 20 villages.

The Russians were apparently stalled at the Dnieper river barrier in the vicinity of Kiev and Dnepropetrovsk to the south, and the Soviet communiqué told only of reconnaissance and heavy artillery fire.

It was apparent that the Russians were preparing a major effort to hurl the Germans out of the Caucasus and trap, if possible, the remaining Nazi forces concentrated (Continued on Page Six)

Unions Would End 'No-Strike' Pledge

Buffalo, N. Y., Oct. 4.—(AP)—The CIO United Automobile Workers' eighth convention opened today with indications of a spirited floor battle over the question of reaffirming or revoking the union's "no-strike" pledge.

Six resolutions submitted by local unions to delegates urge withdrawal of this pledge, some sponsors contending that Congress "has been unappreciative of labor's sacrifices" and that employers "have taken advantage" of the pledge to obstruct collective bargaining and to wage a vicious offensive against labor unions.

Five resolutions favor the pledge's continuance, one asserting strikes "help the Axis and play into the hands of the fifth column agents in the United States," and another declaring any interruption of production hurts the war effort, gives comfort to the nation's enemies and "is unreasonable to labor."

CLAIM SINKING OF U. S. SHIPS

Japs Say Cruiser, Five Transports And Six Subs Sunk

New York, Oct. 4.—(AP)—The Berlin radio said today that five Allied transports, a cruiser and ten planes were destroyed Friday during a Japanese aerial attack on a convoy off Vella Lavella in the central Solomon Islands. There was no Allied confirmation of such losses.

The broadcast added that planes from the Japanese naval air force repeatedly attacked the Allied convoy, which it said was protected by 45 fighters.

The Japanese admitted loss of five of their planes.

London, Oct. 4.—(AP)—A communiqué broadcast by the Tokyo radio today declared that Japanese naval units had sunk six Allied submarines during September "near Japan proper and in other operational areas."

The bulletin provided indirect confirmation of U. S. Navy announcements concerning the extensive operations being carried out by American submarines in Japanese waters, where they have been reported taking a heavy toll of enemy shipping. The Japanese claims concerning the number of submarines reported sunk, however, is not borne out by American acknowledgments of submarine losses.

Japs Pushed Into A Hopeless Position In British New Guinea

Allied Headquarters in the Southwest Pacific, Oct. 4.—(AP)—Their last important coastal supply base gone and their land flank beset by a column of Australian troops, the Japanese on New Guinea's Huon peninsula today were squeezed between the mountains and the sea.

The enemy's position, General Douglas MacArthur said in a communiqué, was "futile if not untenable, and the Allies had every reason to believe the entire northeastern New Guinea shoreline as far as Madang was within grasp."

Finschhafen, the major enemy anchorage and air station on the eastern coast of the Huon peninsula, fell Saturday to Australia's famed Ninth Division, battle-hardened veterans of Tobruk and El Alamein, thus declared General MacArthur, the Allies have achieved dominance of the entire peninsula as well.

The speed of this double envelopment caught the enemy completely by surprise and has resulted not only in the dislocation of his grip on British New Guinea but has caused him large losses with no compensation damage inflicted on our own forces," General MacArthur declared triumphantly.

Missing

Staff Sergeant Morris Abeounis, 19, of this city has been missing in action since September 27, according to official government notification received late Saturday by his parents, Mr. and Mrs. B. G. Abeounis. No details of the area of operations in which he was lost were included in the message. Sergeant Abeounis was a bombardier aboard a B-24 Liberator bomber. A son of Mr. and Mrs. Lee Apple, of Charlotte, member of the same bomber crew also was reported missing according to a telephone call received Saturday night by Mrs. Abeounis from Apple's mother.

Sergeant Abeounis was a graduate of Greenville High School and studied several months at East Carolina Teachers College before enlisting in the Army Air Force in November, 1942. Early in August he spent a brief furlough here before returning to his post in Colorado. He left for overseas service early in September and a letter to his parents written September 26 indicated he was about to take part in his first mission against the enemy. The official notice listed him as missing the day following the writing of the letter.

NEW TAX PLAN IS PRESENTED BY TREASURY

Would Repeal Victory Tax, Lower Exemptions And Increased Income And Excise Taxes

Washington, Oct. 4.—(AP)—Secretary Morgenthau asked Congress today to provide an additional \$10,500,000,000 a year in wartime taxes, taking \$6,500,000,000 of this huge sum from individual incomes.

Repeal of the victory tax, which Morgenthau said would relieve 9,000,000 hard-pressed families from tax on their incomes, was included in an administration program which embraced also big increases in corporation and excise taxes.

With President Roosevelt's approval the treasury secretary presented the House Ways and Means committee the tax plan designed to boost annual federal revenues to nearly \$50,000,000,000, approximately one-third the national income.

In brief, it proposed:

1. Individual incomes—raise rates and lower exemptions so as to gather in an additional \$6,500,000,000 annually. Merge the victory tax with the income tax. Lower the exemptions for married persons from \$1,200 to \$1,100; dependents from \$350 to \$300, and retain the \$500 exemption for single persons.

2. Corporations—raise rates so as to raise another \$1,100,000,000 with small corporations given "special favorable treatment."

3. Excise taxes—stiff increases in taxes on so-called luxuries—including liquor, beer, tobacco, travel, club and gum—for an added government income of \$2,500,000,000.

4. Estate and gift taxes—reduce the exemption for estate taxes from \$60,000 to \$40,000 and increase estate and gift taxes throughout the scale. (Continued on Page Six)

The WAR TODAY

AN ANALYSIS OF THE NEWS

The Balkans are boiling with reports that Germany is seeking a separate peace with Russia, and that Moscow is considering the idea.

These and other recent stories along a similar line undoubtedly were inspired by Berlin put out partly as feelers, with the hope of creating distrust among the Allies.

Along with this Hitler has ordered his commanders to hold a "blood wall" across northern Italy and to "defend Fortress Europe" to the last drop of blood. A German commentator hands out the word that this is a "guaranty that the Nazi armies in fortress Europe will be able to hold their positions many years if necessary, until the Allies are convinced the war is futile."

The intent of this is to implant in the minds of the Allies the thought that, after all, it might be better to make peace now than to let the war drag on interminably.

Would Russia make a separate peace with Germany?

Indications thus far have been that she has no intention whatsoever of doing so. However, with one of the greatest crises of the war now being staged along the Dnieper, military developments might alter Russia's mind.

Moscow's call for the western Allies to open a second front in France has been repeated almost daily as the German retreat has continued. Continued inability to open that front might result in the Soviet taking independent action as

Flying Fortresses Blast Nazi Industries Today

Raids On Frankfurt Followed RAF Night Attack On Kassel

London, Oct. 4.—(AP)—American Flying Fortresses, supported by long-range Thunderbolts, swept into Germany today and attacked targets in Frankfurt, which is 91 miles southwest of Kassel where RAF heavy bombers struck last night, it was announced today.

The air ministry also said that British Mosquitos bombed Hannover and targets in the Rhineland last night. Other bombers laid mines in enemy waters.

A British communiqué described the Kassel attack as "very heavy" and said preliminary reports indicated "that heavy damage was done to this important industrial target."

The weather was described as excellent.

The RAF's night operations, including the Kassel raid, cost 24 bombers.

Frankfurt, with a population of more than half a million, is a big inland port on the main river, a railway center, and the site of large chemical, chemical plants, and other war factories.

It was the 37th raid of the war on that city. It has been untouched by air assault, however, since last December.

Today's daylight raid by the big American bombers and their long-range escorts was the first precision attack of the war on Frankfurt.

The Kassel raid was the fourth big blow in six months on that manufacturing center for Messerschmitt fighter planes and other war machines.

The twin blows followed the now-familiar Allied strategy of splitting the German defenses as the cities less than 100 miles apart, one (Continued on Page Six)

Manslaughter Case Set For November

W. J. Francis, driver of a Carolina Coach Company passenger bus, charged with manslaughter by the grand jury in connection with the death of Alvin M. Wingate of Ayden last August 12 when Wingate's car and the bus collided on Duckhorn avenue, will be tried in Superior court at the November criminal term.

The collision occurred, it is alleged, shortly after a severe storm when the street was slick from mud deposited by flood water. Wingate suffered a fractured skull, his wife suffered minor injuries, a daughter, Nancy Wingate, 3, suffered two broken legs and an arm, and Alvin Wingate, an infant, was slightly injured. It was testified at a coroner's inquest, when it was recommended that the grand jury further investigate the collision.

Wingate lived at Ayden, but was working on a war project at Newport News, Va., and was at home on a visit at the time of the accident.

British Make New Landings Well Up Adriatic Coast Of Italy; American Fifth Army Drives Across Calore River To Flank Nazis; French Take Bastia, Corsica

Allied Headquarters, Algiers, Oct. 4.—(AP)—The British Eighth Army, with the support of Allied naval forces which penetrated the Adriatic, have landed and clinched positions at Termoli, on the Adriatic coast almost midway between the Italian heel and the mouth of the river Po in northern Italy, official frontline dispatches announced today.

Simultaneously, United States troops of Lt. Gen. Mark W. Clark's Fifth Army, have surged forward from Benevento in their march on Rome from Naples and have captured an important crossing of the Calore river, thereby threatening to turn the flank of any water defense line which the Germans may attempt to hold along the Volturno river.

The final collapse of German resistance in Corsica was marked today by the entry of French forces into Bastia.

Moroccan Goums of the French forces were the first to enter the city at the northeastern tip of the Mediterranean island which now becomes a threat to the German forces on the Italian mainland above Rome.

Remnants of German forces were still scattered on beaches at isolated points both north and south of Bastia. But these were being pressed by French troops and American Rangers.

Gen. Sir Bernard L. Montgomery's advance up the Adriatic coast—along the historic path of conquerors toward the Emilia Way, which leads to the Po valley—has been threatened by the defenses of German Marshals Rommel and Kesselring which may be centered about Rome and the Apennines.

His march was advanced greatly by the leapfrog tactics of amphibious landing forces which seized Termoli by surprise, beat off German counterattacks, took an undisciplined number of prisoners well behind the enemy's rear and then made a junction with the main body of the Eighth Army which continued to sound up the coast.

Termoli is 50 miles north of Foggia, the airbase city, and approximately 17 miles north of Gen. Montgomery's previous position at the mouth of the Forore river north of the "spur" of the Italian boot.

Already there was evidence that the crossing of the Calore by the Americans was forcing the Germans to withdraw from the Volturno. (Continued on Page Six)

More Attacks On Jap Supply Bases

New Delhi, Oct. 4.—(AP)—Heavy attacks on Japanese supply bases and rail transport were carried out by American medium and fighter-bombers in northern and central Burma Saturday and Sunday, a U. S. headquarters announcement said today. (Such attacks frequently precede an invasion.)

Tenth Airforce Mitchell's caused heavy destruction on tracks and rolling stock and left several large fires raging in the storage area during Sunday assaults on Saging, Irrawaddy river port in central Burma, the announcement said.

P-40 fighter-bombers tore up railway tracks and left five fires raging among warehouses Saturday in a furious raid on Namti, north Burma supply center. It was the second heavy raid in two days on that main central Japanese supply base.

Both attacks were carried out without loss to the Americans, the announcement added.

Wave Of Sabotage Is Sweeping Over Rumania

Bern, Switzerland, Oct. 4.—(AP)—A Budapest dispatch to the Basler Nachrichten declared today that an organized campaign of sabotage has been under way for the past five days in Axis-dominated Rumania.

The dispatch reported fires and explosions, accompanied by heavy loss of life, had partially destroyed an important leather factory at Mocior-Nitza and the Schmidt chemical works—one of the largest plants of its kind in Rumania.

Telephone lines were said to have been cut to hamper fire fighters and first aid units after four heavy explosions started a blaze in the leather factory, where 31 persons

were reported to have perished. An official explanation, however, the Budapest dispatch said, attributed the disaster to a carelessly dropped cigarette.

The other factories engaged in production of war materials were said to have been damaged by explosions only a few hours apart.

The explosions were not unexpected, the dispatch said, "since some time ago big military stores in Bucharest were transferred to other parts of the country."

That was the manifesto issued by the "patriotic front of Bulgaria," calling on the Bulgarian people and army to break with the Germans and to collaborate with other Balkan nations and America, Britain and Russia on the basis of the Atlantic Charter. Istanbul believes this manifesto was inspired by Russia, and this being so it is a remarkable document because the Soviet regards the Balkans as its sphere of influence and heretofore has appeared to favor on any Anglo-American intrusion, such as invasion. The gesture seems to mean that Moscow doesn't intend to exclude Britain and the United States from Balkan affairs.

Thus the three-power conference bids fair to meet in a favorable atmosphere. Once such difficult issues as that of the "second front" and the Balkans can be ironed out, we may be able to get an answer whether Russia will grant the Allies air bases in Siberia for operations against Japan.

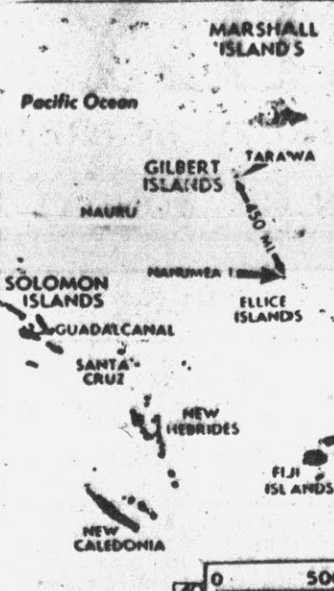

ended that President Roosevelt now has authority to defer pre-Pearl Harbor fathers from the draft.

While Hill disputed this interpretation of the Selective Service Act, Senator Taft (R-Ohio) supported Damner's view and won an admission from Hill that deferments could be ordered on the basis of dependency.

Hill said that if Congress should pass the Wheeler bill to delay induction of pre-Pearl Harbor fathers until after Jan. 1, "the inevitable result would be to lengthen the war" because the army and navy would not obtain sufficient men to carry out the general staff's strategic plans.

The high command is hopeful, Hill said, that after January 1 the army will not have to take more than 75,000 men a month, getting these replacements largely from among youths just becoming 18 years old.

Senator Johnson had said he had "authentic" figures indicating that there are more than 3,500,000 men in the army with more than a year's training.

Johnson, a supporter of the move to delay the induction of pre-Pearl Harbor fathers, said that of this total figure, 800,000 men have had two years service, 300,000 have had three years service and 100,000 more than three years service.

Hill said he doubted the accuracy of the 3,500,000-man figure but expressed the belief that even if it were correct, a great number of these men probably were in supporting activities.

In any event, he said, these figures would have little effect on the father draft. He pointed out that the ultimate plans call for an army of 7,700,000 by the end of the year and that Chief of Staff Gen. George C. Marshall and others had made it clear that the army must draft fathers in order to meet its present goals.

He added that the army takes the view that the greater the number of adequately trained men, the fewer the casualties.

Meanwhile Senator Wheeler, the sponsor of the anti-father-draft bill, was expected to continue his fight despite the assertions of Senate leaders that the bill is virtually dead. Other opponents of the father draft are expected to introduce substitute measures.

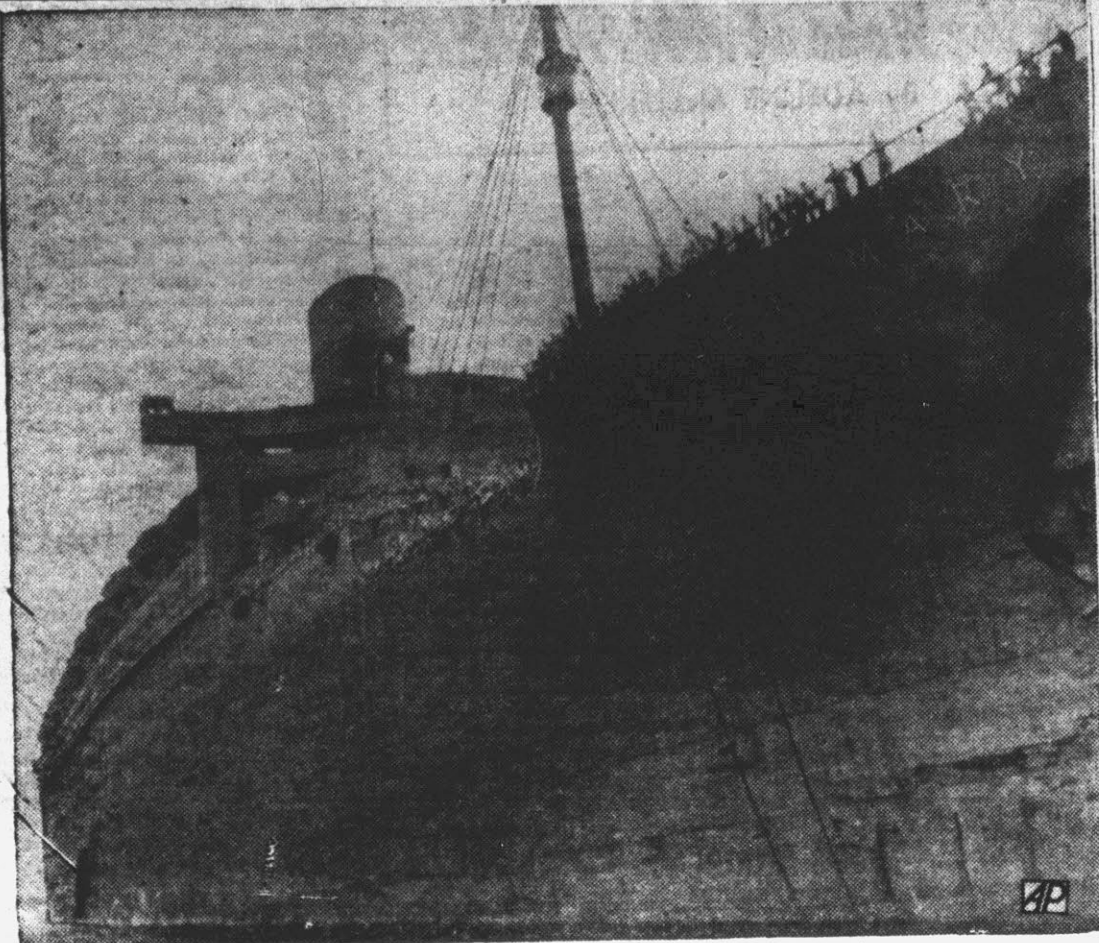

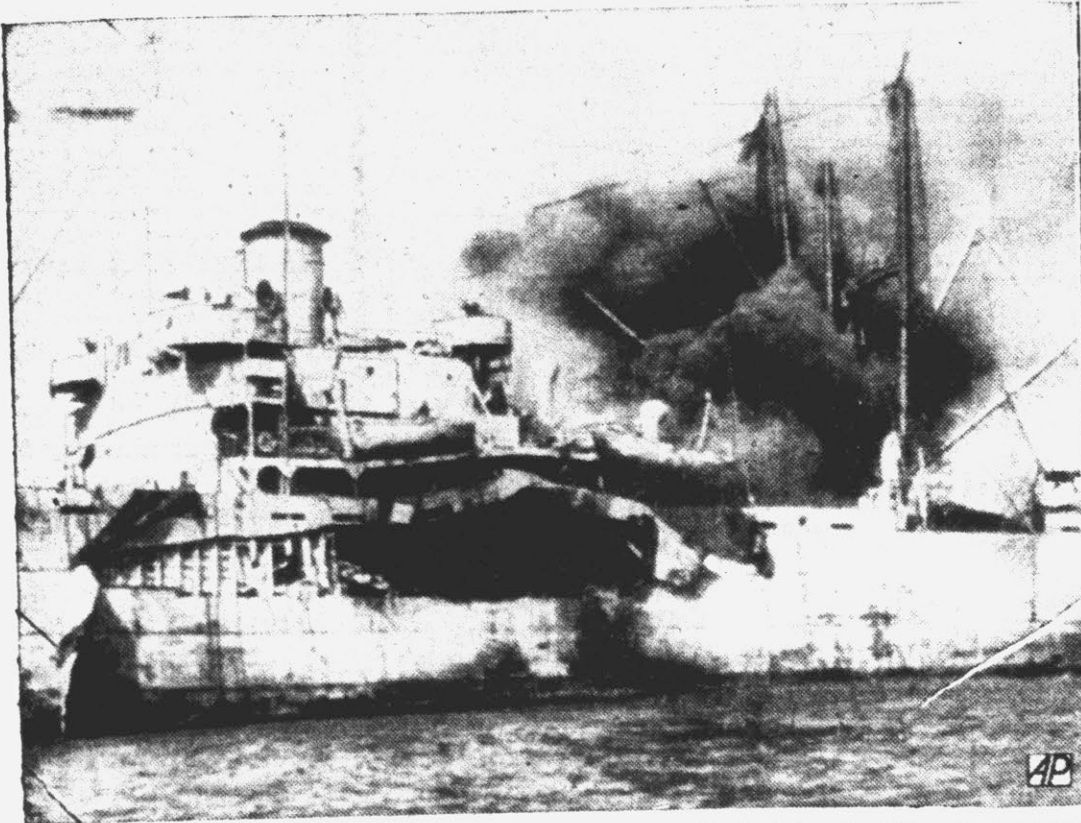

Strength FOR THE DAY

By EARL L. DOUGLAS

VERY NEAR
Just recently I went to the home of a woman whose only son had been reported lost in a bombing expedition. As I talked with her I had some insight into what Christian believers can endure when they have to live with conceivable trouble in the past decade, yet faith has not diminished, nor has courage been destroyed.

It was the day we bombed the Romanian oil fields. Somewhere in that vast welter of fire and carnage a plane with her boy in it crashed to the ground. She teaches school every day and on Saturday goes for some kind of voluntary service in the local hospital. She will not give up. He went through torture for his country; she endures the burning fires of sorrow in the same spirit.

The thing which impressed me most was what she said about the keen sense she had that death does not destroy life. "I feel," she said, "that he is more alive now than he has ever been. WASHINGTON IN WARTIME

By JACK STINNEY

Washington—Whatever else may be said about the appointment of Edward R. Stettinius, Jr., as Under-Secretary of State and much may be said, none of it bodes Washington political observers saw it as just one more step in the President's long swing to the right and another bit of setting the Democratic administration house in order before the 1944 elections.

In view of the swing and the State department vacancy, it's surprising that none of us here saw the

Stettinius appointment coming. Stettinius is not only a scion of, but a success in, big business. His father was a Morgan partner and young Edward was born to wealth. For some years after his graduation from the University of Virginia, he was known by the very dubiously complimentary title of "Crown Prince of Steel." He lived, or rather worked it down, coming up the hard way, through the General Motors shops, he became the \$100,000-a-year chairman of the board of C. & M. before he was 40 and quit that job to take a \$1-a-year assignment in the war effort three years ago.

In spite of that capitalistic background, if there is any delicacy of relationships with Russia, as has been hinted, Stettinius should be one of the first choices for a man in the State department to deal with. As administrator of lend-lease in which job it's generally conceded that he has been one of the greatest successes in Washington, he battled long and hard to fulfill Russian demands when they needed help most.

Regardless of that, however, observers here see as most significant the fact that Stettinius is one more of the President's moves to gouge out the political spot and plug them with conservatives. They consider it as part of the whole cloth that was started on the loom when Henry L. Stimson and Frank Knox were brought in to be secretaries of War and Navy, when the parade of presidential officials' heads with Donald Nelson as chief of WPB and Charles L. Wilson as his right-hand man; when OPA was shaken up to make way for Prentiss Brown and then reshaken to put in Chester Bowles as virtual business manager of the price control agency.

The elevation of Leo T. Crowley to foreign economic coordinator, the appointment of Herbert H. Lehman to the President's personal staff, presumably for a stopgap period, until he can be given possibly a world relief job; the naming of James F. Byrnes as economic stabilizer, and Marvin Jones as war food administrator are all part of the same tapestry. Also considered part of it were the public spankings administered Vice-President Wallace and Secretary of Commerce Jesse Jones, though it is becoming apparent that the latter was whipped much more gently than the Vice President. The presumably forced resignation of Sumner Welles, whom Stettinius succeeds, also fits in.

The event to which these moves are political is subject for debate that could well make the air blue over the cracker barrels throughout the country for months to come. It already has caused plenty of chin-wagging here; but political or not, the consensus on both sides of the aisle is that we are getting on with the war effort at home better than at any time since Pearl Harbor.

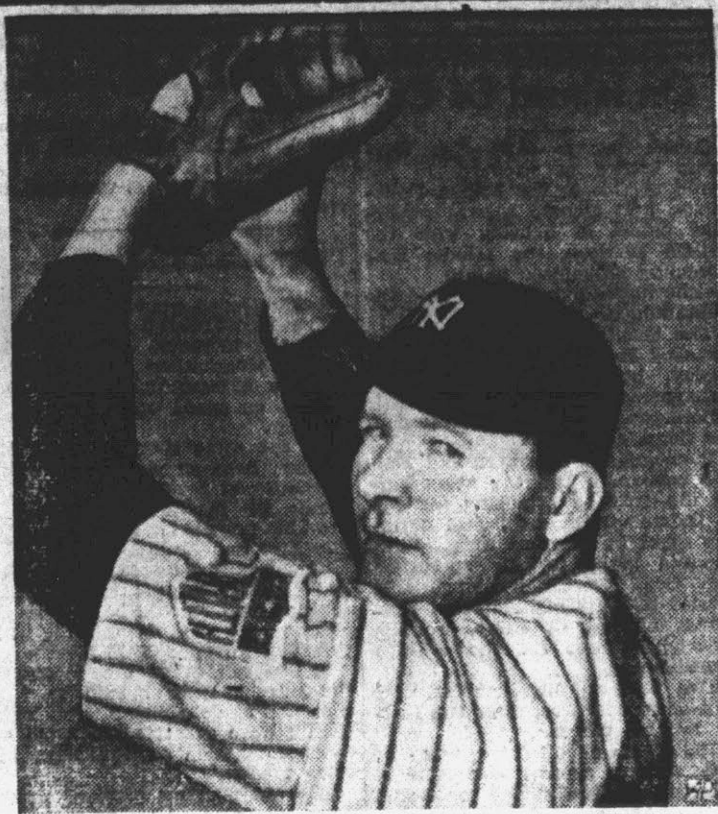

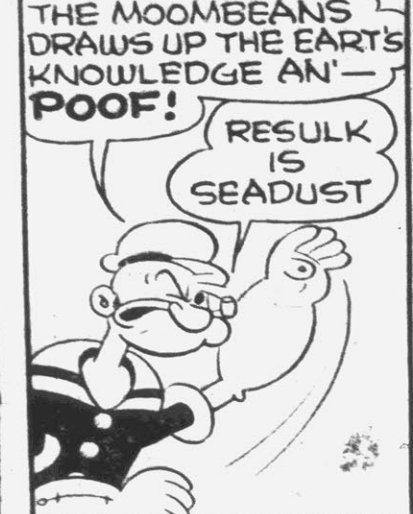
