U. S. Heavy Bombers Strike Deep Into Germany Today

Aircraft factories at Gotha and Ball-bearing plants at Schweinfurt targets of swarms of Forcresses; Other forces sweep France and Holland

By W. W. HERCHER London, Feb. 24.—(AP)—American heavy bombers battered aircraft factories at Gotha and the ball-bearing works at Schweinfurt today in their fifth consecutive day of smashing at the very roots of German air power, deep in the Reich.

The four-engine craft renewed the war's greatest aerial offensive as swarms of American Marauders and British Typhoons were striking across the channel.

Gotha is in central Germany 150 miles southwest of Berlin. Schweinfurt, where the American air forces suffered one of their most grievous losses of 60 Flying Fortresses last October 14, is 230 miles southwest of Berlin.

A U. S. headquarters announcement said the powerful American assaults beginning Sunday and continuing through yesterday not only included the largest number of bombers ever sent out at one time but also employed the greatest forces of bombers ever to operate on four successive days in daylight over any target.

The Allied daylight assault was resumed after German raiders sharply attacked London last night and RAF Mosquitos had set sirens wailing in Germany again in a series of scattered attacks over the western Reich.

Dutch airfields were the targets selected for the daylight pounding by the American medium Marauders. They struck under a cover of Allied fighters while the RAF's Typhoon fighter-bombers went after military objectives in northern France.

The renewed assault came on the heels of a U. S. strategic air force headquarters announcement which said that the concentrated American air attacks on German aircraft factories have so reduced Nazi fighter production that every enemy plane shot down in combat now is a vital contribution toward knocking Germany's air force out of action.

The statement was made in an official bulletin analyzing the results of the campaign which the Americans began months ago and which hit its peak with four successive days of heavy bombing in which planes based in both Britain and Italy participated.

Official statements here and from Allied headquarters, Naples, said a total of 343 German planes had been shot down in the last four days by American airmen in attacks on Germany. Thirty-three of these were shot down yesterday in an attack on Steyr, Austria, by Liberators and escorting fighters from Italy.

Listing 310 German fighters as shot down during the course of these raids on Sunday, Monday and Tuesday, the statement said: "Before the precision bombers began their concentrated attacks upon the German aircraft industry months ago, heavy losses inflicted (Continued On Page Four)

Germans Report Evacuation Of Rogachev, Nazi Base In White Russia Above Gomel

London, Feb. 24.—(AP)—Premier Stalin announced tonight the Russian army has captured Dno, east of Pskov, and the Berlin radio acknowledged the Germans have evacuated Rogachev, Nazi base in White Russia above Gomel.

Stalin's announcement, broadcast by Moscow radio, said Dno, "a powerful stronghold of German defenses," had capitulated to Russian forces developing their offensive in the difficult forests and swamps region of the Baltic front.

The Berlin radio's announcement of Rogachev's evacuation, not immediately confirmed by the Russians, said the Nazi defenders had fallen back to the west bank of the Prut river.

The loss of Rogachev, on the main railroad to Bobruisk and Minsk, 14 miles north of Zlobin, would mean that the southern end of the White Russian front was crumbling before the Russian blows and threaten the rail junction of Zlobin itself with netrim.

Premier Stalin ordered Dno's capture celebrated at Moscow tonight with 12 salvos from 124 cannon. Moscow has remained silent recently on the White Russian offensive, which the Germans announced yesterday had broken the Nazis' lines northeast of Rogachev, resulting in heavy fighting.

Pskov itself, 64 miles west of Dno, was threatened from two other directions by Soviet forces driving down from Strugi Krasnoye, 44 miles to the northeast, and from the frozen marsh and forest country to the northwest, where troops of Gen. Leonid A. Govorov's Leningrad army last week reported 25 miles away.

St. Krasnoye, a town on the Leningrad-Pskov trunk railway, and 30 other localities were captured yesterday by Govorov's left wing. (Continued on Page Six)

Vote Of Confidence Is Given Senator Barkley

Unanimously Re-elected Senate Leader; Upheaval May Have Effect On Fourth Term Prospects

(By The Associated Press) Washington, Feb. 24.—A unanimous Democratic vote returned Senator Barkley today to the Senate leadership he resigned in a sensational rebuff to President Roosevelt's tax veto, and the veteran Kentuckian announced he would continue in the important party post.

Stamping, in effect, their approval on Barkley's denunciation of Mr. Roosevelt's tax message, Democratic senators roared their acceptance of his resignation and enthusiastically re-elected him leader.

After the dramatic party conference, from which Barkley walked off handing in his resignation, the Kentuckian's "deepest personal affection" for Mr. Roosevelt.

The conference, by unanimous votes, immediately accepted the resignation, then re-elected him leader.

Thus was enacted the second chapter in a political drama which raised a serious Democratic challenge to President Roosevelt's leadership in the 1944 election year.

Emerging from Barkley's office where they went as members of a committee appointed to notify the Kentuckian of his unanimous re-election, Senators Clark (D-Mo.) and Tydings (D-Md) told reports.

"Yes, he's agreed to accept." Earlier, Barkley had formally submitted his resignation in a letter to the caucus which he told reporters was "strictly in the family."

Denying that there were any fourth-term implications in his historic break with President Roosevelt yesterday over the tax bill veto, Barkley asserted:

"I've always had and still have the deepest personal affection for the President. He stands right along personally and officially with Woodrow Wilson who has been my ideal of a President for the last generation."

Some anti-fourth termers and lukewarm administration followers believed Barkley's resignation and vote of confidence to remain a Senate majority leader would slow up or actually "jeopardize" the President's renomination, or at least buttress movements such as are being led by onetime Roosevelt War Secretary Harry Woodring and former Governor of Massachusetts Joseph B. Ely.

War Is Carried Closer To Tokyo

Heavy U. S. Carrier Force Hits Mariana Islands; Americans Extend Gains In The Marshalls

Pacific Fleet Headquarters, Pearl Harbor, Feb. 24.—(AP)—The war's first blow against the Mariana Islands, deep within Japan's defense ring, was dealt powerfully Tuesday by hundreds of planes from aircraft carriers, sent out by Rear Adm. Marc A. Mitscher who lashed at Truk last week and who made possible the 1942 raid on Tokyo.

The bombing of the Marianas, 700 miles northwest of Truk and 1,300 miles south of Tokyo, occurred on the same day that invasion forces completed a six-day conquest of Eniwetok, a western Marshalls air base within hand-batted bombing range of Truk.

The Mariana and Eniwetok developments were disclosed late yesterday by Adm. Chester W. Nimitz, Admiral Mitscher, who captained the carrier Hornet from which the Doolittle bombers took off for Tokyo, presumably led into the daring Marianas operation elements of the same task force used last Wednesday and Thursday against Truk, demonstrating the sustained striking power of the fleet.

Radio silence to protect his ships' movements precluded details as to whether the Mariana raiders sank any warships in Tanapag harbor at Saipan island—the same harbor from which some Japanese fleet units sailed in June, 1942, to defeat at Midway.

Tinian, a naval air base, also was a target Tuesday. It and Saipan are near the bottom of the Mariana ladder of islands ranging north directly toward Japan. The attacked bases are approximately 3,800 statute miles southwest of Pearl Harbor and 1,700 miles west of the newly won jagged base of Kwajalein in the Marshalls.

FATE OF FINNS IS UNCERTAIN

Next Few Days Expected To Reveal Peace Talk Results

Washington, Feb. 24.—(AP)—Finland apparently entered its most critical period of the war today with the departure from Stockholm of Dr. Juho K. Paasikivi, peace envoy.

The immediate issue confronting the Helsinki Government, assuming peace terms have been arranged with Russia, is whether it can save the country from the fate of Italy—prevent its becoming a battleground for German and Allied armies.

On the other hand, if peace negotiations at Stockholm failed, the issue is how long Finland can stand off the smashing Red army attacks expected to follow up the recent Helsinki air raids.

If the negotiations at Stockholm were conclusive, it is believed here that the next few days will see the tale told—either in Finnish efforts to rid the country of Germans or in new Russian blows at Finland.

URGES BREAK WITH SPAIN

Spanish Neutrality Termed Farce By Rep. Coffee

Washington, Feb. 24.—(AP)—Representative Coffee (D-Wash.) today demanded that the United States immediately break all diplomatic relations with Spain.

"We must make this break now on our own terms," he said in a speech prepared for delivery in the house, "before the Axis forces us to break with Fascist Spain on terms such as Japan handed us at Pearl Harbor."

Coffee, who previously has called for a house investigation of Falangist activities in South America, denounced Franco, Spain's leader, as "Hitler's faithful puppet" and as a man of worthless promises.

There is no doubt, Coffee declared, as to where Falangist Spain fits into the Axis war picture. "Neutral" Spanish ships, he said, "deliver thousands of Nazi agents to ports in every American nation. 'Neutral' Spanish ships deliver thousands of tons of Nazi propaganda to all of Latin America. 'Neutral' Spanish ships rendezvous with Nazi submarines in Latin American waters; supply them with oil, water and food; give them information on the movements of United Nations convoys."

"In the face of the cold facts about Franco in Spain and Franco in Latin America, why are we permitting a new smokescreen to be raised in Madrid and in London and in Washington when the issue of Spain's role is broached?"

"Why all this pious talk about Franco's new neutrality? Why all this fantastic nonsense about Franco?" (Continued on Page Four)

Congressmen Vote 299 To 95 To Override Veto; Senate Expected To Take Similar Action Tomorrow; Independent Internal Revenue Agency To Be Sought

By FRANCIS M. LE MAY Washington, Feb. 24.—(AP)—In strident rebellion against President Roosevelt's tax views, the house today voted 299 to 95 to pass the \$2,350,000,000 new revenue bill over his veto.

Ninety-nine Democrats and one minor party member joined 190 Republicans in voting to override. Three Republicans, three minor party members and 89 Democrats voted to sustain the chief executive.

The senate is expected to duplicate the house action tomorrow, putting the tax bill on the statute books "the President's objections notwithstanding."

A rebellion in Democratic ranks that reeled political Washington back on its heels preceded the house action. Involved were Senate Democratic Leader Barkley of Kentucky, and Chairman Doughton (D-NC) of the Ways and Means committee, both of whom called for action over-riding the President.

The house galleries were filled an hour before the motion to override came to a roll call, and crowds gathered in the halls of the capitol to catch even a small glimpse of the proceedings.

The 80-year-old Doughton declared he had "parted company" with the President on the veto issue, saying Mr. Roosevelt's message reflected "on the judgment and integrity of the congress of the United States," and that the executive "has told us in effect that if you'll accept my dictation and abdicate your responsibility, I'll approve what you do."

Mr. Roosevelt's Washington radio day veto message described the tax bill as a measure for the relief of "the greedy."

This was the second time within a year the President had been over-ruled in the house. The Smith-Connally anti-strike bill became law last June over the President's veto, the house voting 244 to 109 to override.

Mr. Roosevelt has been successful during that time in having two vetoes sustained. Both of these vetoes prevented the outlining of food subsidies as a part of the wartime stabilization program.

Today's house action was one of the worst legislative setbacks the President has suffered since he took office 11 years ago.

Immediately after the overriding vote, Representative Knutson (R-Minn.) Republican leader of the Ways and Means committee, issued a statement calling for "a complete shakeup of the policy-making personnel in the treasury department."

In a joint statement yesterday, Knutson and Doughton said they hoped the treasury "would cease trying to obstruct when it cannot help."

It was announced today by Rev. Robert W. Bradshaw, pastor of the church.

Nearly 8,000,000 Methodists will take part in the observance in 42,000 churches, where they will "renew their covenant with God and give of their substance to building His kingdom in the hearts and lives of men," states Bishop Jaul B. Kern of Nashville, Tenn., chairman of the national committee for the week of dedication.

"A world at its worst calls for a church at its best" is the general theme for the entire week. Services will emphasize the place of the church in the present world emergency as related to the home, the community, "the world task" and "its source of power."

Methodism's "mobilization of its spiritual resources" will culminate on Sunday, March 5, when men, women and children will make personal commitments of dedication and contribute to a sacrificial, voluntary offering. The Rev. Grover C. Emmons of Nashville, executive secretary of the committee for the Week of Dedication, states that the offering will be used to carry on war emergency projects, including the following:

Expansion of missionary work in Latin America, aid to missionaries in invaded countries, spiritual ministry to members of the armed services, relief for war refugees, new buildings and workers for Christian services to "dislocated" families in war industry communities, and special aid to Methodist schools. None of these projects are provided for in the regular church budget.

"The church stands in the midst of a world surrounded by perils and full of possibilities," declared Mr. Bradshaw. "Christian people are backing the boys and girls on the fighting fronts, promising to work, pray and plan for an peaceful and neighborly world in which all peoples may live as brothers. Methodism's Week of Dedication gives our people their opportunity to rededicate themselves to this cause, spiritually and financially."

Special services during the week will be held in Jarvis Memorial Church as follows:

A Recent Gift

Children in the intermediate grades will be very much interested in a book entitled "Little Jungle Village," which Mrs. L. T. Shotwell gave to the library recently. The book was written by her cousin, Jo Besse McElven Waldeck of Kingstree, S. C., and New York.

The story of the book is based on two Indian children, "Pebwek" and "Mamo," brother and sister of the Arawak tribe, whom Mrs. Waldeck met when she went with her husband on an expedition far up the Cuyuni river "back of beyond" in British Guiana jungles. She lived with them for many months, learned their language, and was adopted into their tribe. She grew to love them and now tells with real affection the story of these two barfoot children who were so naive and yet so wise in the ways of the jungle.

An outstanding feature of the book are the illustrations by Baroness Katharina Donbrowski, an artist of international fame. Her illustrations carry out the charm and atmosphere of the book, for she has lived in the South American jungles.

Marika Karasz is the author of "See and Sew." It is a picture book of sewing a learning-to-sew book for the beginner, done from the new angle of picture instruction. Though prepared primarily for girls, it is not only for children. In these days of wartime economy and Red Cross sewing circles, the instruction between these covers will be useful to any woman who has not sewed before.

The library now has three copies of Eric Knight's ever popular "Lassie Come Home." This is one of the

"Australia: The Island Continent" is a book by Grace Allen Hagarth, especially prepared for children in the grades. It is a Junior Literary Guild book, giving in detail the things children want to know about a foreign country.

Following a report by Miss Henrietta Lund, social worker in the Department of Welfare of the National Lutheran Council, on conditions on the west coast, where "the greatest migration this country has ever known has centered," the council plans to increase its work of welfare and service in this area. "With the uprooting of families and the disturbing of all of their habits of life, physical needs and spiritual distress were prevalent everywhere," Miss Lund reported. "All existing welfare and social service agencies were swamped. No provision had been made to meet the present emergencies, or even to look after the children who felt that they were not wanted. Children are being locked up in rooming houses while mothers go to work in industrial plants. There are unmarried mothers for whom no agency exists throughout an entire state. Everywhere one meets appalling problems wrecking the lives of thousands.

"All men are brothers and I must learn to think of them and treat them as such," Dr. Lena Madson Phillips, president of the International Federation of Business and Professional Women, recently told an assembly of church women. "To begin at home I must change my attitude toward the decent American Negro. I must not condemn labor in its struggles just because it is labor. I must remember the greatness of the Jewish race and that it gave me the Christ, whose teachings are the highest I yet know. I must somehow come to the place where I feel that it is deeply important for every Chinese child to have a bottle of milk or its equivalent. . . . These and their kind are hard lessons for you and for me. But they are lessons we must learn if we expect the generations to come to live in a reasonable, decent, peaceful world."

WASHINGTON IN WARTIME

Washington—Out of this war, it's just possible that the United States will acquire some more territory—not by conquest, but by purchase.

Rep. Carl Hinshaw, Pasadena, Calif., Republican, has introduced in the House a joint resolution for the purchase of Lower California from Mexico. It isn't the first time that this idea has cropped up, but it does seem the most propitious.

In other words, Congressman Hinshaw's arguments are almost irrefutable. He contends that it wouldn't only be a good thing for the United States, but for Mexico as well. If enough Mexican officials agree with him, it might be a deal.

To take up Congressman Hinshaw's argument: What has Mexico got to lose? A 40,000 square mile area that has never supported as many as 100,000 people. A section of a nation that is almost as hard to defend and as unprofitable to exploit commercially as the Aleutians or Wake Island.

It could gain cash credit in the United States to extend its great program for internal development, a very likely improvement in tourist travel (via Baja California) to Mexico's western states, and the elimination of one of its greatest defense headaches.

And the United States could gain the opportunity of closing forever a possible invasion door, and the opportunity once more to develop a frontier—a little game at which we have been very good. Mr. Hinshaw thinks there are considerable opportunities there in resorts and California's minerals have hardly been scratched.

again to figure his victory tax. He writes \$2,600, his total income; subtracts \$624, his victory tax exemption, and finds the taxable difference is \$1,976.

Then he must pick out his victory tax rate. Married and with one dependent, he finds it's 2.9 per cent. He multiplies \$1,976 by .029. The answer—\$57.304. He drops the last decimal place as being less than 5. That has to be recorded on Page 1, too. Added to \$155, that makes his total taxes, up to this point, \$212.30.

To find his "forgiveness," he has to compare this figure with his 1942 tax. The slip the internal revenue collector sent him says it was \$97.52, and the amount he paid on it last March and June was \$48.76. He enters the larger tax figure, \$212.30.

Next he finds a little box for "forgiveness." He writes in the smaller tax figure—\$97.52, his "forgiveness" is three fourths of that, or three times \$24.38, which is \$73.14. The uncancelled portion is \$24.38, which is carried out to the tax column and added to \$212.30. That makes his total tax liability \$236.68.

Now he lists the amounts he already has paid: \$171.60, which the company took out of his pay for victory and income taxes; the \$48.76 he paid last March and June. Total—\$220.36.

He subtracts that from \$236.68. He still owes \$16.32.

He's entitled to postpone payment of half the uncancelled portion of his 1942 tax. Half of \$24.38 is \$12.19, so he subtracts that from what he owes—\$16.32 and finds the amount

he's going to pay with this return—\$4.13.

German planes continued to bomb and shoot up beachhead troops until noon, but rain in the afternoon kept them on the ground. Heavy cannonading resulted from both lines throughout the day.

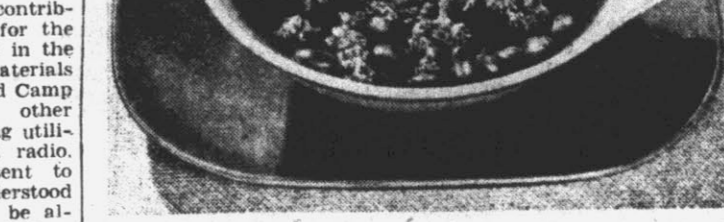

Under the supervision of Rev. and Mrs. E. S. Parker, the 4-H members are making plans for another year in the 4-H victory garden near the school. To date the ground is being put in readiness for planting.

the county on community and neighborhood basis for neighborhood leaders. The object of these meetings is for the increase of production rather than increase of acreage in the majority of cases. Mrs. Maggie Strong, food conservation leader, presented the canning budget to club women, showing them how to figure the amount needed for the family. She stressed the importance of having 32 quarts of vegetables and 24 quarts of fruits per person as the minimum.

(Continued From Page One) breakfast hour. It was the first daylight alert since last July 9, although a friendly plane set off a false alarm last month.

Thousands of incendiaries and many high explosive bombs were showered down on the capital last night, causing dozens of deaths and widespread damage. At least four of the raiders, most of which attacked from a great height, were reported downed.

Berlin is boasting that a "non-stop offensive" has been launched against the British capital, according to a dispatch to the Swedish newspaper Aftonbladet.

All the stained glass windows were blown from a chapel near one of London's historic buildings and while the exterior suffered damage, the chapel's richly-ornamented interior was marred only slightly.

More than 2,500 Germans were killed on the north Russian front, Moscow declared, adding that "many German officers and men were taken prisoner."

The German high command acknowledged Soviet advances in the north, saying that "in the northern sector of the eastern front our detaching movements southwest and west of Lake Ilmen were continued according to plan."

West and northwest of Krivoi Rog, troops of Gen. Rodion Y. Malinovsky's third Ukrainian army wiped out 6,000 Germans and captured Nazi-held communities, the Russian communique reported, as they pushed on toward the Bug river.

War Bonds

Inside Krivoi Rog, which fell to the Russians on Tuesday after a bitter four-months' siege, huge stores of booty were still being counted, Moscow said. Sixteen tanks, more than 100 guns, 600 machineguns, 7,000 rifles, 660 trucks, 170 wagons and other equipment were listed among the war material abandoned by the Nazis.

A pair of prehistoric ivory sunglasses, believed to be several thousand years old, was dug from an Alaskan grave.

Two Nazi airmen who parachuted into London's suburbs were reported to have been captured without resistance.

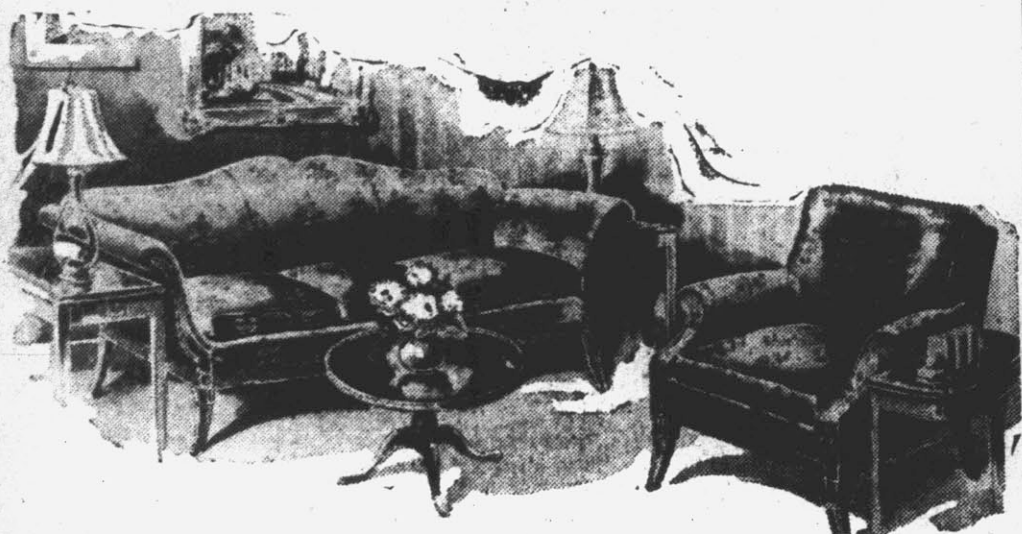

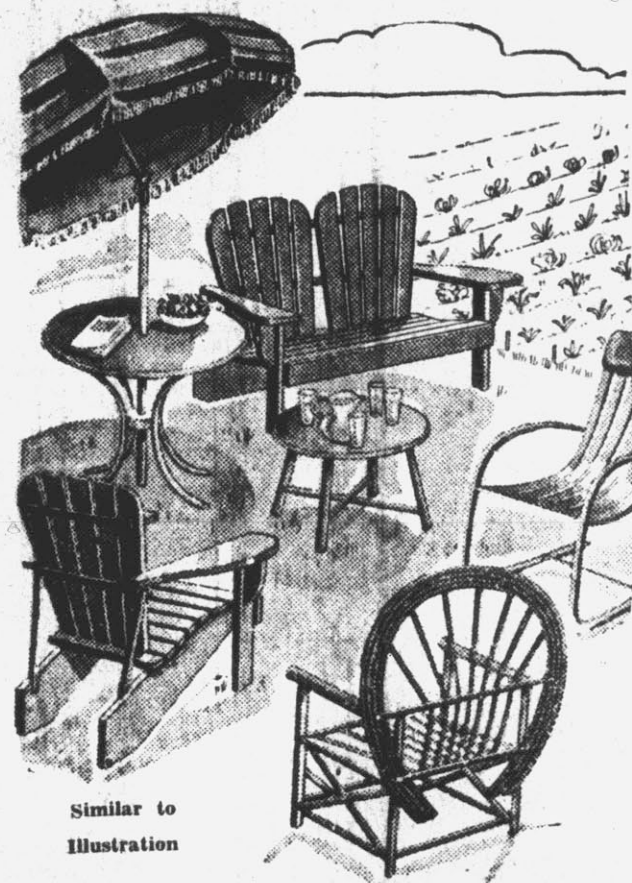

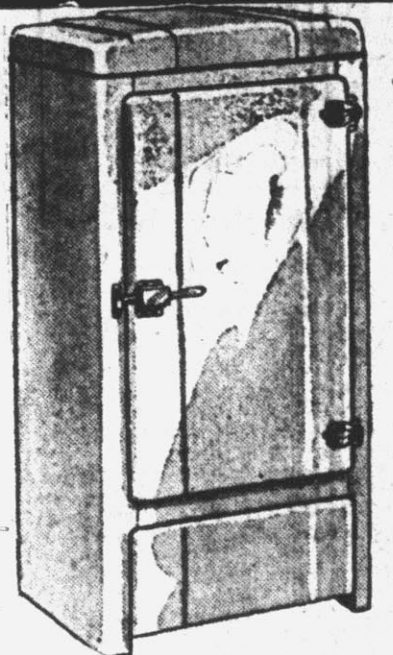
