SIX MEMBERS OF FACULTY FIRED BY COLLEGE BOARD

Action Taken By Trustees In Executive Meeting Tuesday; Teachers Are Charged With 'Inciting' Insurrection Among the Students

The affairs of East Carolina Teachers College became the subject of much talk and heated discussion here today when it came to light that in an executive meeting here last Tuesday the Board of Trustees declined to rehire six members of the faculty, three of whom are known to have been slated for "firing" by Dr. L. R. Meadows before he retired as president of the institution May 1.

The notices mailed to four men and two women members of the faculty, advised them they were not re-elected because they had been found by the board to "have been instrumental in inciting students to insurrection, and for unwholesome influences on the campus."

Coming so close on the heels of Dr. Meadows' retirement after he had been exonerated by the board of charges of mishandling of college funds and subsequently indicted by a Pitt County grand jury, the news of Tuesday's meeting was received by the community with apparent astonishment.

Dr. Howard J. McGinnis, acting president of the college, this morning confirmed the fact that the action had been taken but declined to give out the names of the faculty members affected because he had not been authorized by the board to issue any statement. One local board member declared that the reason that the board had given no publicity to the meeting was "that it had no desire to further embarrass the faculty members by making their names public."

It was reliably stated today, however, that those to whom the letters were mailed included Dr. M. L. Wright, Dr. E. L. Henderson, Dr. Herbert ReBarker, Dr. Beecher Flanagan, Misses Katherine Holzclaw and Pearl Chapman. The first three listed had previously been notified by Dr. Meadows to appear before the board to show cause why they should not be dismissed, but the notices had been withdrawn by Dr. Meadows within 24 hours of the time of their issuance.

SAYS CONVICTED MAN IS INNOCENT

Norfolk, Va., June 9—(AP)—Clara Mae Stowe, 14, who returned to her Norfolk home Sunday after nine months in Baltimore, told Norfolk County Commonwealth's Attorney A. O. Lynch today that Charles M. Godwin, 33, of Ashoklee, N. C., was innocent of any complicity in her disappearance.

Godwin was sentenced to five years in prison in Norfolk County Circuit Court on a charge of secreting the girl. He is in jail awaiting outcome of a motion by defense counsel to have the verdict set aside.

DOUGHBOYS SMASH OUTER CRUST OF NAZI EUROPE

With American Forces in France, June 8.—(Delayed)—(AP)—Fighting as American troops did in Tunisia, Sicily and Italy, doughboys have smashed through the outer crust of Hitler's fortress in a gallant display of courage and skill.

The battle of the beachheads has developed now into a race to get enough doughboys, guns and supplies ashore to beat back the enemy attack, and it looks as if we are winning.

Never before has an army attempted to land such vast numbers of men and materials in such a short time, but the job is being done after a shaky start.

While we landed behind the assault troops the enemy still was pouring a heavy machine-gun, mortar and artillery fire into the boats as they drove ashore and had our troops pinned behind a gravel bank just about the water's edge.

WAR SHORTS

(By The Associated Press) STOCKHOLM—The Finnish government has indefinitely banned the oppositional afternoon newspaper Svenska Pressen, on the ground that it is too pro-ally, a Helsinki dispatch said today.

A BRITISH PORT—A score of American glider pilots who carried D-Day invasion forces to France have arrived back here on an LST after sneaking out through German lines.

JAPS ADVANCE IN CHINA AREA

Allies Gain In Other Areas; Jap Cruiser Damaged

Myitkyna, great north Burma base, the Allies partly completed link between the Ledo and Burma roads, was slipping from Japan's grip today.

Lt. Gen. Joseph W. Stilwell's shugging ground troops snatched one end of the north Myitkyna airfield. Airborne Chindits dislodged the Japanese from Holo, two miles northeast of Myitkyna. Inside the big city where house-to-house fighting has raged for days, Chinese infantry grabbed new positions.

The Allied southeast Asia command also announced a 14-mile lunge down the Kohima road toward Imphal, Allied-held capital of the Indian province of Manipur.

Other British troops drove the Japanese from positions five and seven miles southeast of Kohima. Of all Pacific war theaters Japan was on the offensive only in central China. One column of Nipponese, estimated at 70,000 to 80,000 troops, advanced within seven and a half miles of Changsha, capital of Hunan province, in an attempt to cleave China by pushing south along the Hankow-Canton railway.

A Chinese army spokesman at Chungking said the penetration to seven and one-half miles was made by an enemy column bearing from the north on the rail city whose defenders have been ordered by Generalissimo Chiang Kai-Shek to stay to the last.

Meanwhile, Chinese troops, knifing westward in a Salween river of the Fourteenth and Tenth armies sufficiently to attempt a determined stand.

The Allied advance also enveloped Vetrail, on a lateral road from Tarquinia, and about six miles southwest of Viterbo.

The German high command earlier announced evacuation of Tarquinia, and said its rear guards were withdrawn north of the town.

So rapid was the drive above Rome that German forces guarding the Adriatic sector also began to retreat to avoid encirclement, and Allied troops were rolling forward along the entire Italian front.

Striving to maintain close contact with the fleeing enemy, which has shown no disposition as yet to make a determined stand, the Allied Fifth army raced steadily north and northwest from Rome.

Lt. Gen. Mark W. Clark's columns, driving north from the capital, occupied the entire Lake Bracciano area and moved on to capture Caprarola, 24 miles north of Rome on the east side of Lake Di Vico, and about 10 miles southeast of the highway junction town of Viterbo.

CIVILIAN D-DAY IS NEXT MONDAY

Washington, June 9—(AP)—Plans for civilian D-day—next Monday—will be the fifth war loan drive were unfolded by the treasury today.

Spearhead of the \$16,000,000,000 campaign will be ceremonies at Texarkana, on the border of Texas and Arkansas.

There Treasury Secretary Morgenthau and governors of Texas, Arkansas, Louisiana, Oklahoma and New Mexico will join in a day of activities climaxed by an hour-long radio program produced by Actor-Author Orson Welles.

Besides Welles, 18 stage, screen and radio stars will participate in the program starting at 10 p. m. Joe E. Brown, Walter Houston, Danny Kaye, Keenan Wynn, Agnes Moorehead and Joseph Cotton will be in Texarkana for the occasion. Joining the broadcast from Hollywood will be Lionel Barrymore, Charles Laughton, Paul Muni, Edward Arnold, Walter Pidgeon, Susan Hayward, Gloria Jean, Thomas Mitchell, Laird Cregar, Martha O'Driscoll, Jane Randolph and Ray Collins.

DEBACLE SPREADS AMONG GERMAN FORCES IN ITALY

Shattered Armies Retreating Along Adriatic After Swift Withdrawals Above Rome

Rome, June 9—(AP)—Fifth army troops racing after the retreating Germans captured Viterbo, prize road and rail junction 40 miles northwest of Rome, in a swift seven-mile dash today, and also seized Tarquinia near the coast, 55 miles above Rome.

There were no signs the Nazi command had been able to reorganize the fleeing remnants of the Fourteenth and Tenth armies sufficiently to attempt a determined stand.

The Allied advance also enveloped Vetrail, on a lateral road from Tarquinia, and about six miles southwest of Viterbo.

The German high command earlier announced evacuation of Tarquinia, and said its rear guards were withdrawn north of the town.

So rapid was the drive above Rome that German forces guarding the Adriatic sector also began to retreat to avoid encirclement, and Allied troops were rolling forward along the entire Italian front.

Striving to maintain close contact with the fleeing enemy, which has shown no disposition as yet to make a determined stand, the Allied Fifth army raced steadily north and northwest from Rome.

Every single piece of paper, every magazine and every cardboard box you have around the house is just that much more ammunition to our fighting forces. If you turn it in so they can make use of it. Ammunition, food, medical supplies and practically everyone of the other 700,000 different items conveyed to our boys on the fighting fronts is wrapped in paper or packed in cardboard boxes or both. No wonder the packing and packaging of supplies for the men on the fighting fronts is fully as important as producing the supplies themselves.

There is small wonder that the need for paper grows daily. No wonder current paper production cannot meet this steadily mounting demand for paper unless every household and every merchant joins in using less paper and in conserving that they must use or receive.

To help in this paper shortage, the Greenville Junior Chamber of Commerce will hold another of its house to house collections of waste paper Sunday afternoon, June 11. The drive will be held between the hours of two and six.

Chairman Alton Barrett of the Jaycee Salvage committee, urgently requests all people having waste paper to tie their magazines and newspapers in bundles, and to pack them as tightly as possible in a box or bin and place it either on the porch or on the curb in front of the house. A Jaycee pick-up truck will pick it up some time during the afternoon.

Nothing Like It

By CHRISTOPHER BUCKELY Representing British Press Distributed By Associated Press With Allied Forces in Normandy, June 7—(Delayed)—Standing this afternoon beside a group of citizens in Bayeux as Allied tanks, guns, "tank busters," armored cars and bren carriers rolled through town, I found this general comment most gratifyingly expressed in a single sentence: "The Germans have nothing like this."

They were quite clear that Germans had never mastered and could not muster the strength in armored vehicles which they saw before them. The Germans, they told us, seemed desperate for vehicles of one sort or another.

These early days of the invasion are the ones on which Hitler is gambling to produce a fluke which may give him a negotiated peace instead of unconditional surrender. He knows that, barring some freak of fortune, he already is beaten. This is the last long-shot gamble.

ALDERMEN IN BUSY SESSION

Discuss Budget And Agree Accept Pre-payment Taxes

The Board of Aldermen in session at the City Hall last night discussed the proposed budget for the next fiscal year, authorized the Finance Committee to make up a tentative budget to be submitted to the board at the regular meeting in July. The budget is officially adopted at the August meeting.

The proposal to house war prisoners at the NYA center this summer to be hired out to farmers was discussed. Tentative plans provide for the Marine Air Squadron to move over to the airfield across the river in time to provide for housing the prisoners. Plans for this are tentative.

Aldermen J. A. Watson, chairman of the Street Committee, reported that the city's order for a mechanical street sweeper had been given priority and that it would probably be delivered within the next two months or sooner. The department has cleared the streets under difficulties with the old worn-out machine, but has done a creditable job, it was stated.

A report from the Post-war Planning Committee stated that plans include paving, drainage and other necessary projects. The plan also includes the building of a modern swimming pool for the colored people.

Also included in the post-war planning program is the proposal to establish a fire station in West Greenville beyond the Coast Line railroad tracks. There are several schools in that section. A long train halted on the tracks when a fire breaks out in the west end would handicap the fire department.

Plans are being worked out to allow the marines stationed in Greenville to use the swimming pool free during off-hours. The committee is also considering a request of Miss Frances Alex, playground director, for use of the swimming pool to teach swimming to children participating in the playground program.

The board appropriated funds for carrying on the community canning project here this summer under the direction of Mrs. Ethel Reid Watters. This was granted on request of the home demonstration agent.

Plans for repairing the roof of the armory and installing wooden blinds at the Kings fire tower to prevent vandalism were approved. The city clerk was authorized to accept prepayment of 1944 taxes at the tentative rate of 90c on the dollar. He was also instructed to accept prepayment of privilege license taxes on last year's basis.

FARLEY ACTION DUE TO FOURTH TERM ATTITUDE

The resignation of James A. Farley as New York Democratic state chairman was regarded by Washington politicians today as an inevitable consequence of his known opposition to a fourth term for any president and his apparent belief that President Roosevelt will run again.

With nomination within the President's grasp—if he wants it—Farley's position as party leader of one of the most pivotal of states was fast becoming awkward if not untenable, they said.

Mr. Roosevelt's doctor described the President yesterday as physically fit and this led to new fourth term speculation.

Neither Farley nor his long-time associates in Washington gave any hint that he would bolt the party or even join in any anti-Roosevelt movement which might develop within the framework of the party. Rather, his friends said, his will be a hands-off attitude.

The former postmaster-general and ex-national Democratic chairman explained yesterday he was resigning because his business duties—his Coca-Cola Company executive—would not allow him to give enough time to committee affairs. A successor is to be chosen July 11.

In 1940 Farley stayed in as state chairman despite his opposition to a third term.

Farley still plans to go to Chicago as a convention delegate. There with his phenomenal personal acquaintance, he could be in position to keep in touch with world-released the six convention delegates pledged to him and urge them to support Gov. Thomas Dewey of New York for the presidential nomination.

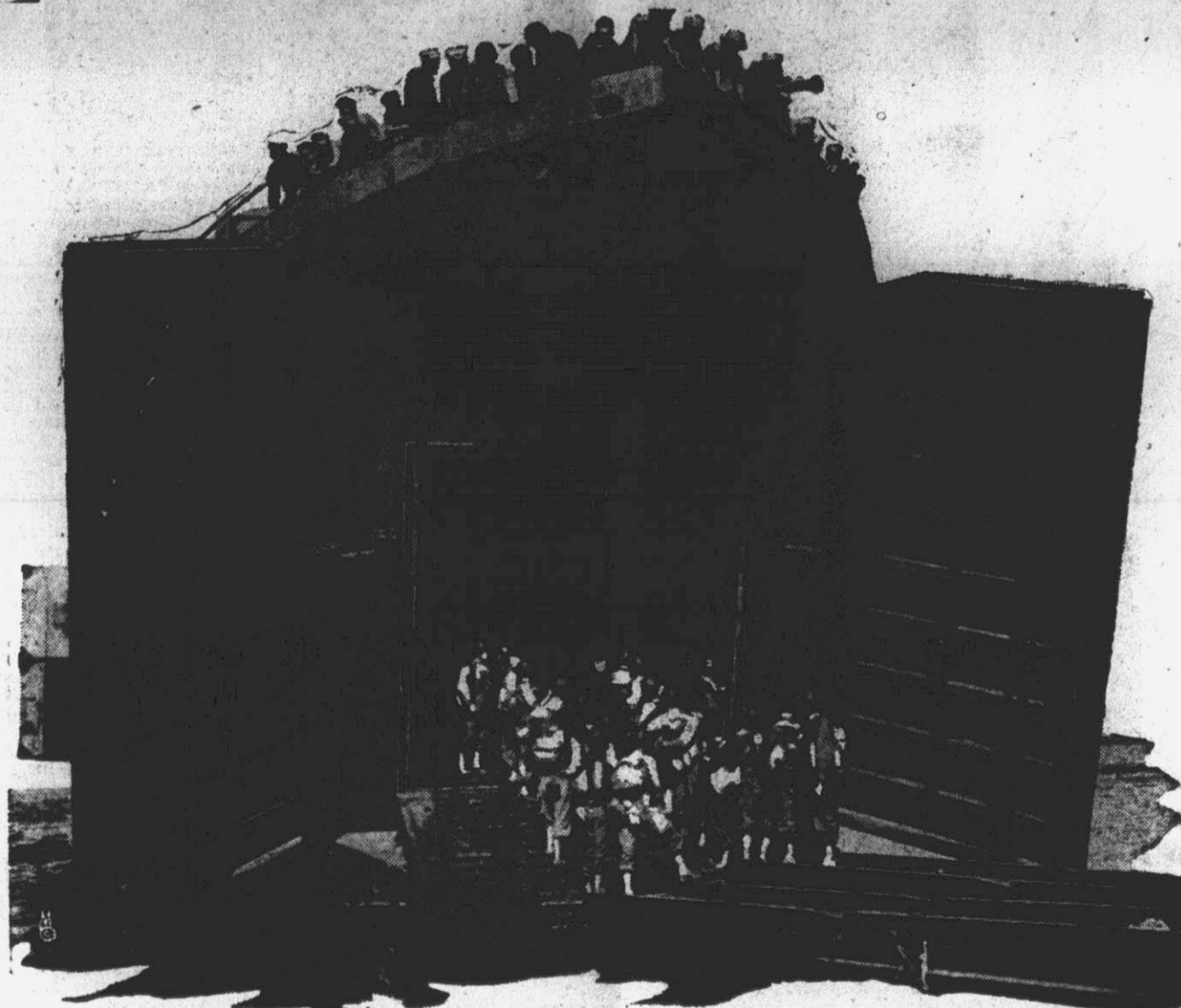

Strength FOR THE DAY By EARL L. DOUGLAS

TRUE AND FALSE IDEAS OF FREEDOM

What is freedom? Most people would say that freedom is the opportunity to do what one wants to do when one wants to do it. But freedom of this variety usually degenerates into servitude.

San Francisco-Californians have known the Japanese intimately longer than any other persons on this continent. They have hated them heartily. Twenty-odd years ago, when I was a student at the University of California in Berkeley, the yellow peril was already hissing, but still something very real.

Much of this opinion antipathy toward a people whose economic and social standards were far below those of the American way of life. But much of it, too, was a realistic conception of the Nipponese character. That's why I feel that the following little verbal cartoon is one of the best analyses of Japanese personality I have seen. It appeared in the San Francisco Chronicle.

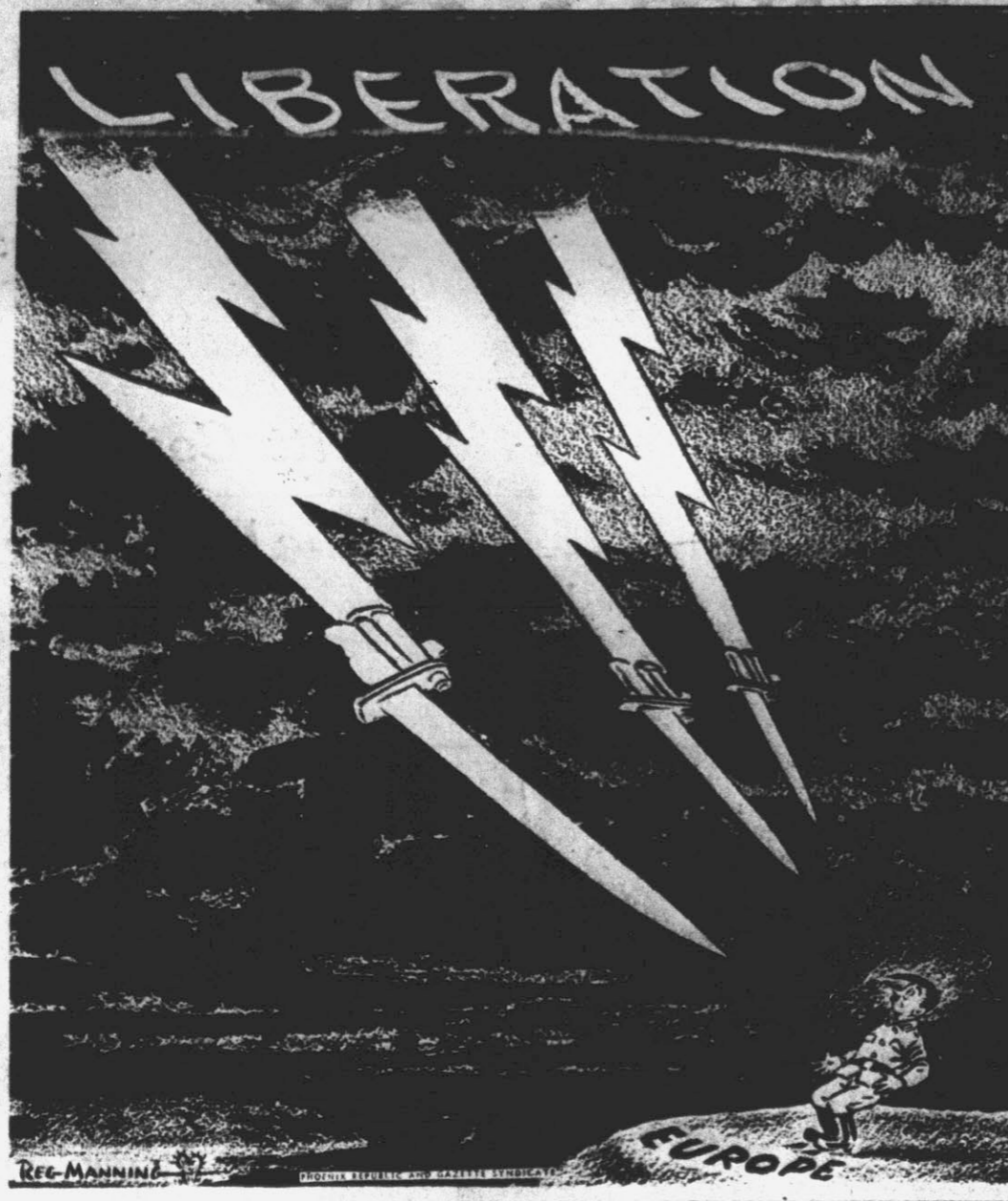
It has to do with Japanese "strategy" in India. Here it is: "Very sorry Japanese cannot trust Hindu. Japanese commander carefully select 12 of Indians taken prisoner in Malaya. Treat very polite. Slap face, make them understand Japanese very superior people. Tell them Englishman no good. Americans much worse. Cannibals. Eat Hindus if they catch 'em. Japanese promise Hindus happy life. Slap faces again so they believe. Teach them all very nice Japanese sabotage, also best kind of propaganda make trouble in India. Hindus say this very kind of Japanese. Glad to oblige. Get faces slapped again so they remember.

"Japanese give Hindus money. Also some diamonds if they need more expensive money. Put Hindus ashore in India by Japanese submarine. Hindus right away hunt up British constable, tell all about Japanese arrangements. Very bad. Hindus Japanese officer get court martial, maybe. Neglect of duty. Not slap Hindu faces enough so they appreciate comership with superior kind of people."

Allied warships roamed up and down the coast as roving artillery spotting German rockets and strong points.

Deteriorating weather again fell upon the channel, but headquarters said the wind was in a more favorable direction for unloading streams of supplies and reinforcements.

The German communiqué conceded the loss of Ste. Mere Eglise, astride one of the main German arteries leading from Cherbourg, saying the Americans were pushing "north and south" from the landing head there.

Then a later Berlin broadcast said U. S. troops had advanced a mile beyond the town toward Valognes, 12 miles southeast of the port that would form a great funnel for Allied reinforcements and supplies into the battle for France.

American Rear Admiral John Leslie Hall, Jr., on a tour of the Beachhead, told correspondents operations were going well, but stressed the necessity of quickly building up our forces.

Doughboys have occupied Formigny on the road from Caen to Carentan, a field dispatch said. Forigny, one of the few towns identified of more reported taken, is nine miles northwest of Bayeux, and three miles inland.

Front dispatches said the battle was developing into a race for supplies, and "it looks as if the Allies are winning." There was a freshening breeze today over the misty English channel after a hampering overnight rain.

The Germans rolled up more tanks, dropped parachute troops, and sent some supplies charging to the front behind horses.

The Germans made no mention of parachutists earlier reported landed on the west coast 20 miles from Ste. Mere Eglise in an effort to pinch off the tip of the peninsula and its line of supply.

in. Many Nazi prisoners have been taken. The Germans said the Allies had penetrated five miles below and six miles west of fallen Bayeux, and said Allied beachheads had been strengthened. The Nazi high command claimed gains east of the Orne.

One front dispatch said Americans now hold a beachhead five miles deep on a broad scale, with smaller penetrations several miles farther inland. U. S. parachute troops captured one town, it said, and infantrymen drove the Nazis from another. Much of the fighting was waged on a tree-to-tree and ditch-to-ditch basis, it added.

Other front reports said "it is becoming the most involved battle with local retreats and advances having a very definite effect on the general plans both of our commanders and the enemy. Both are seizing every chance to drive in a wedge when there is the slightest faltering."

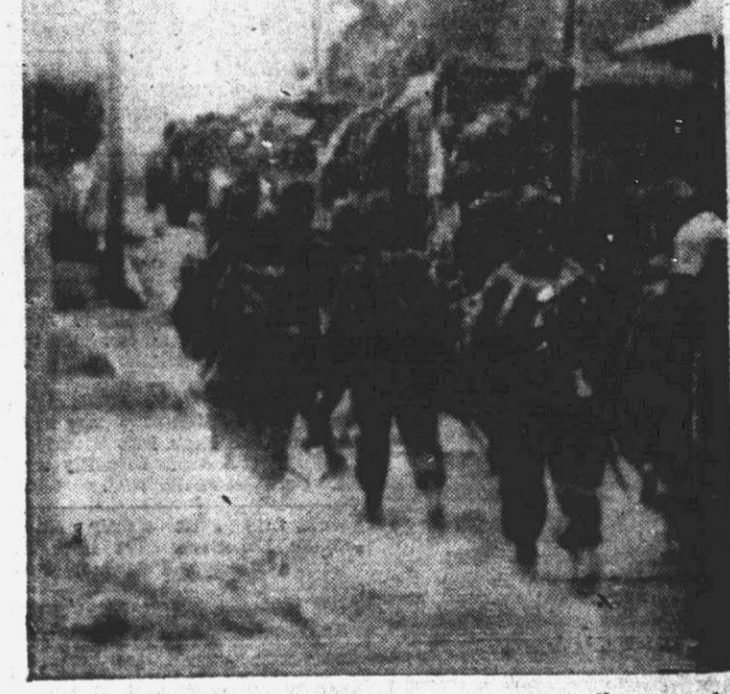

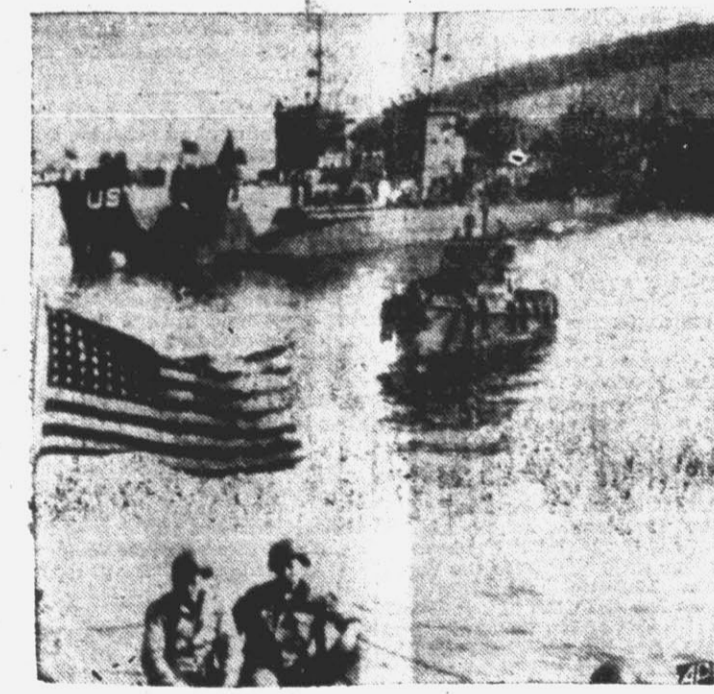

Physician Reports On Roosevelt's Condition

By HOWARD FLIEGER

Washington, June 9—(AP)—President Roosevelt (age 62, weight 180) is in better health today than he has been in any time for a year—that's the opinion of his doctor who told reporters:

"He's in better physical condition than the average man of his age."

Questions of war and politics are affected by the report.

The President has talked of a possible trip for a closer look at the war and Democrats who have piled up more than enough convention votes to nominate him for a fourth term have agreed that the state of his health would play a big part in what he does.

But the President is going to take it as easy as possible if the doctor. Vice Admiral Ross T. McIntire, has his way. He'll get in as much swimming as possible, avoid lunch-time work and relax in the sunshine when it can be arranged.

At the request of reporters, McIntire yesterday went over the results of a physical examination the President underwent. At the same time he told, for the first time, the full list of ailments that beset the chief executive last winter after his return from Teheran.

It started with the flu and led to an intestinal upset. A cold, sinus infection and acute bronchitis.

Mr. Roosevelt responded to last month's physical tests in "splendid fashion—well within normal limits in all regards," McIntire said. He termed it an "extremely satisfactory" checkup.

McIntire's talk with reporters indicated—although he didn't say so—that he regards the President physically equal to a major trip should Mr. Roosevelt decide upon a future conference with Prime Minister Churchill of Great Britain or any other war leader.

The President started the trip talk when he laughingly told a recent news conference he hoped to see the Prime Minister sometime before January 25—end of the third term—but that he'd be glad to see him next spring or anytime.

The President's weight of 180 pounds is the lowest it has been at any time since he entered the White House, McIntire said. It's four pounds less than the doctor always has regarded as Mr. Roosevelt's best weight. But he said the President thinks it's a fine weight.

Good Registration For Summer Term

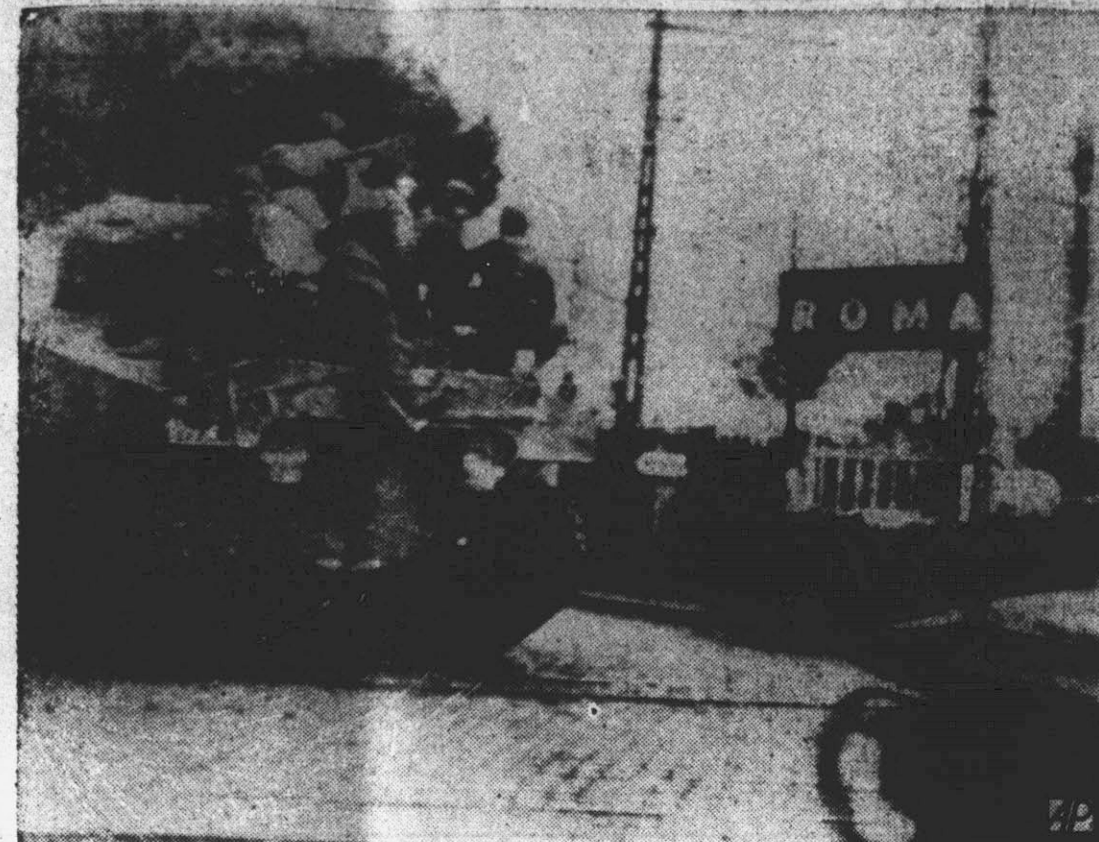

PRESIDENT IN GOOD HEALTH

Physician Reports On Roosevelt's Condition

Washington, June 9—(AP)—President Roosevelt (age 62, weight 180) is in better health today than he has been in any time for a year—that's the opinion of his doctor who told reporters:

"He's in better physical condition than the average man of his age."

Questions of war and politics are affected by the report.

The President has talked of a possible trip for a closer look at the war and Democrats who have piled up more than enough convention votes to nominate him for a fourth term have agreed that the state of his health would play a big part in what he does.

But the President is going to take it as easy as possible if the doctor. Vice Admiral Ross T. McIntire, has his way. He'll get in as much swimming as possible, avoid lunch-time work and relax in the sunshine when it can be arranged.

At the request of reporters, McIntire yesterday went over the results of a physical examination the President underwent. At the same time he told, for the first time, the full list of ailments that beset the chief executive last winter after his return from Teheran.

It started with the flu and led to an intestinal upset. A cold, sinus infection and acute bronchitis.

Mr. Roosevelt responded to last month's physical tests in "splendid fashion—well within normal limits in all regards," McIntire said. He termed it an "extremely satisfactory" checkup.

McIntire's talk with reporters indicated—although he didn't say so—that he regards the President physically equal to a major trip should Mr. Roosevelt decide upon a future conference with Prime Minister Churchill of Great Britain or any other war leader.

The President started the trip talk when he laughingly told a recent news conference he hoped to see the Prime Minister sometime before January 25—end of the third term—but that he'd be glad to see him next spring or anytime.

The President's weight of 180 pounds is the lowest it has been at any time since he entered the White House, McIntire said. It's four pounds less than the doctor always has regarded as Mr. Roosevelt's best weight. But he said the President thinks it's a fine weight.

Good Registration For Summer Term

up 372 military vehicles, wrecked 25 locomotives, bombed 14 bridges, attacked 35 railroad yards and damaged one tunnel, two warehouses, three factories, two oil tanks, seven military encampments, one overpass and 10 flak cars.

NEW YORK—NBC said today the Berlin radio is "apparently getting ready for a possible fall of the Vichy government which is meeting today."

It recorded a Berlin broadcast saying "The People's National Government is ready to take over if the French Government does not do its duty."

SUPREME HEADQUARTERS, AEF—U. S. heavy bombers striking from the south 500 to 750 strong battered prime targets in the Munich area of southern Germany today, in a new pincer attack on the Nazi war machine coordinated with disruptive blows on German positions in France from the west.

(A BBC broadcast said the Allied whiplash from Britain had destroyed all railway bridges on the Seine river between Paris and the sea.)

LONDON—Moscow announced today that Soviet troops, seeking to improve their positions, have captured a height of "great importance" north of Iasi in Romania, where a German radio commentator declared yesterday that Russian armored forces had launched an offensive on a wide front.

WASHINGTON—An army-endorsed bill boosting the pay of expert infantrymen from \$5 to \$10 a month was approved unanimously today by the Senate Military Committee.

MOSCOW—All signs point to an early opening of an offensive by the Red army on the eastern front to match the blows against Hitler on the western front.

The Russian people are avidly following the progress of the Allies in France and Italy.

Things seen on this correspondent's three recent trips to the Russian front tend to back the predictions of a new Red offensive. Preparations are being made for an attack which should shake Hitler from Russian soil and drive the Nazis back to Berlin.

WASHINGTON—American bombers, hitting hard at Japanese positions in the central Pacific, blasted airfields, runways and gun positions on a half dozen islands Wednesday and Thursday, the navy reported today.

SUPREME HEADQUARTERS, AEF—Four towns of the many captured in France so far have been identified by headquarters and field dispatches:

Ste. Mere Eglise, a scant 20 miles southeast of Cherbourg.

Formigny, 20 miles farther east on the Carentan-Caen road.

Bayeux, 10 miles southeast of Formigny, and five miles inland.

Berniere-Sur-Mer, 11 miles north of Caen and 10 miles west of the Orne river mouth.

SUPREME HEADQUARTERS, AEF—American parachute troops dropping into the Ste. Mere Eglise sector of France below Cherbourg, carried out the most successful airborne operation in war history, it was disclosed today, and only about two per cent of more than 1,000 RAP and U. S. planes operating on D-Day were lost.

NEW STRIKE IS FORESEEN

May Ask Government To Seize Ward Plant Again

Washington, June 9—(AP)—Another Montgomery Ward strike in Chicago shaped up as a possibility today, with a union statement that it is coming the government again.

A special House committee, which wound up public hearings yesterday on the authority of President Roosevelt to seize the Ward plant in April, developed this set of facts:

1. The War Labor Board has again ordered Wards to extend a CIO contract which includes a union maintenance of membership clause.

2. Ward officials challenged the WLB's right to impose such a condition.

3. The union said that a new strike was quite probable, as a result and that the President would be asked, if that happens, to seize the property again.

Samuel Wolchok, president of the International Retail and Wholesale Workers (CIO), told the committee that if Ward's contention that it is not a war industry is upheld, it would be necessary then for the union to say it had no obligation to stay on the job.

He told reporters that if Wards refuses to obey the new WLB order to extend the old contract, there would be a strike. If that happens he said he hoped the Congress would back up the President in a new seizure of the plant, and said that this time the property should be retained until the terms of the board's order are carried out.

In the previous seizure, Wolchok testified, the government "did nothing to enforce the WLB directive for restoration of the provisions of the contract."

"The Board of Trustees of East Carolina Teachers College met today (June 6) in session for the purpose of the annual election of the members of the faculty for the ensuing year, 1944-45, and you were not re-elected because the board found you have been instrumental in inciting students to insurrection and for unwholesome influences on the campus."

"If you should desire the board to take a different course you are privileged to request the same in writing within 30 days and the board will be called in session to hear you on this matter."

The board held its regular commencement meeting two weeks ago.

In the Fifth army north of Rome, the troops moved seven miles north to win the Bracciano area. Another element seized the town of Sutri six miles north of Lake Bracciano.

The Eighth army conformed with this drive by a continued thrust northward along the east side of the Tiber, but progress there was slower due to demolitions and mines.

Just east of the Tiber 20 enemy anti-tank and self-propelled guns were knocked out in the vicinity of Monterotondo, whose capture was announced yesterday. Lt. Gen. Sir Oliver Leese's forces have gone several miles beyond Monterotondo.
