## Fifth Army Smashes New German Line Above Rome

### Americans Now Within 10 Miles Of Cherbourg After Capturing Montebourg In Expanding Beachhead Action; Several Towns Captured In Gains Along Entire Front

Rome, June 13—(AP)—The Germans north of Rome fought bitterly today along a new line of defenses from Lake Bolsena to the sea but Fifth Army troops smashed through and occupied nearly all the western shore of the lake and all but wiped out a strong point east of Orbetello, 71 miles northwest of Rome.

Moving up both sides of Lake Bolsena, Allied forces of the western shore captured Valentano, junction of three highways some 55 miles north of Rome and pushed on, nearing Latera, four miles further north.

Northwest of the Lake, South African forces moving toward Orvieto ran into a stiff battle in Bagno Rezio.

On the Tyrrhenian coast American doughboys encountered a new series of dug-in defenses east of Orbetello and attacked through high ground directly toward lateral highway 74, which is about 90 road miles from Rome at that point. In a sharp and bloody engagement they captured 142 prisoners from the German 162nd Airborne division and killed 100 more of the enemy.

The advance was considerably more rapid on the Adriatic sector, where Eighth army troops crossed the Saline river, some five miles north of captured Pesara, at several places.

These Allied forces took Popoli, on the Rome-Pescara road 10 miles north of Sulmona, where the advance had halted only long enough to take 20 prisoners.

South of Terni, in the center of the advance, the enemy continued to put up a fight but some progress was made there, also.

The Eighth army forces in the Tiber valley advanced to the southwest of Carsoli, reaching high ground across highway No. 5 and taking a number of prisoners. It was announced by the Allied naval command that a port party, established at Civitavecchia June 9 to begin restoring the facilities which had been heavily battered by Allied bombing and other demolitions. Many mines have been swept up from the coast from Anzio northward.

Last night RAF bombers swept over Hungary and attacked the Almaszufu oil refineries near Kom.

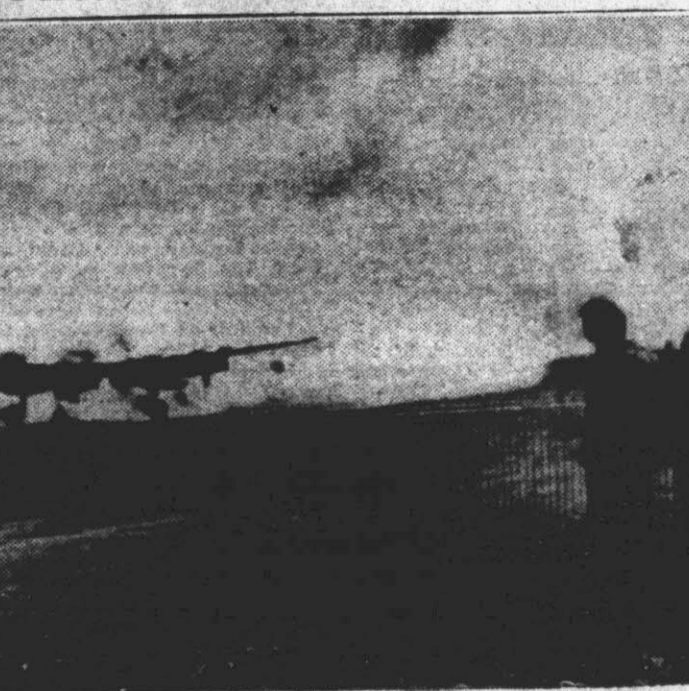

### Russian Forces Surge Deeper Into Finland

#### Advance Units Within 36 Miles Of Viipuri, Second City Of Finland

London, June 13—(AP)—As Soviet troops surge ahead in their drive on Viipuri and the Finnish capital of Helsinki, the opinion was freely expressed in many quarters in London today that Finland might be knocked out of the war by the end of this month.

The latest Moscow communiqué said the Finns were putting up stubborn resistance from prepared positions but had failed to halt the Red army's Karelian offensive. The bulletin announced the seizure of Paivola, about 40 miles from Viipuri and Kivennapa, about 10 miles northeast of Raivola.

(A Stockholm dispatch broadcast this morning by the British radio and recorded by CBS said the Finns, "worried about the Russian break through," had begun evacuating Viipuri and various regions in the path of the advancing Russians.)

More than 50 representatives of 17 War Price and Rationing boards of 15 counties were in conference at the City Hall today about plans for continuing and upholding the wartime price control program.

Mrs. Ruth Vick Everett of Raleigh, district information executive presided. It was apparent throughout the meeting that the work of the Office of Price Control has been gratifyingly satisfactory and that the general public has come to appreciate the great work done in controlling prices during this war in comparison with the skyrocket prices of the first World War.

Price control from every standpoint from the farm, manufacturing plant or other source, all the way to the ultimate consumer was discussed, reports were made, constructive suggestions offered and useful recommendations made from the results of experiences in the rationing offices in the area.

Speakers at the morning conference were Guy W. Rawls of Raleigh, district operations executive; Mrs. Everett, Walter A. Kavanaugh, district price executive; E. F. Stager, specialist in consumer services and automotive program; R. B. Yowell, durable goods representative; W. A. Lincham, apparel representative. The morning session was concluded with an open forum discussion led by George P. Whitely, Jr., associate price executive. Adjournment was taken at 12:30 for lunch.

At the afternoon session Mrs. Everett reviewed and summarized the events of the morning session and introduced the volunteer assistants' program. An interesting feature was a skit entitled, "A Model Price Panel Hearing," by staff members and clerks. George P. Whitely led a discussion of recruiting and training volunteer assistants. The meeting was concluded with introduction of field representatives and announcements.

### War Shorts

LONDON—The skies over Dover strait were overcast today and a heavy shower fell during the morning, but there was little wind and the sea remained calm, with excellent visibility from coast to coast.

WASHINGTON—Sweden has agreed to make a very substantial reduction in shipments to Germany of ball-bearings vital to the Nazi effort, it was learned today.

LONDON—The German air force sent a small number of raiders over Britain early today—apparently in an effort to divert attention from the battle for Normandy—air support in the battle for Normandy—giving London its first alert in 47 days.

### Says Americans Being Tortured

New York, June 13—(AP)—Stanley Richardson, NBC reporter from London, said in a broadcast from London last night that there is "indisputable evidence that the Germans tortured and murdered" American paratroopers during the early hours of the Normandy landings.

Richardson, who had just returned from headquarters of an American airborne division near Carentan, said in one instance the bodies of three American enlisted paratroopers, stripped to the waist, with their hands bound, were found in a heap beside the wall of a former German command post.

"There is every indication," said Richardson, "that these Americans were executed after they had been captured, in violation of the rules of war."

In a second case the body of a second lieutenant was found with his throat cut and a German army knife beside him. Richardson said that according to the body of the officer "landed in a tree and was murdered as he hung helplessly there."

A third case concerned a major who was found in a village "dead of multiple stab wounds," Richardson declared.

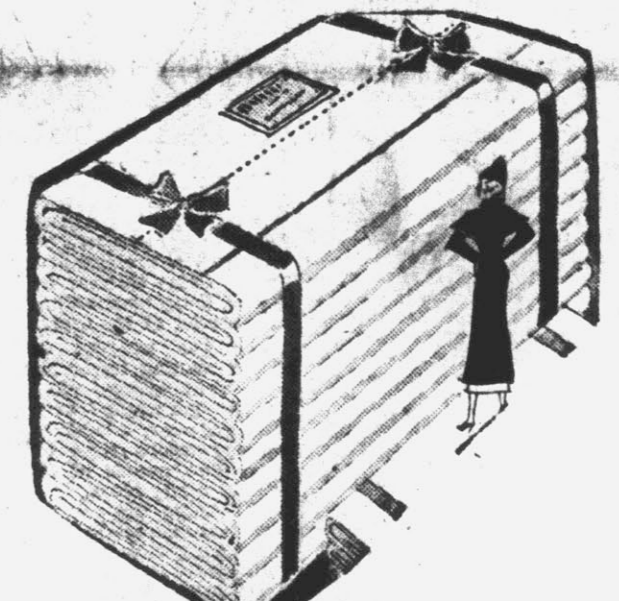

—530 miles from the Philippines—and Truk for the second straight day.  
MacArthur's Allied forces also expanded their Biak island holdings against stubborn enemy resistance and, to their rear, maintained steady attacks against Japanese trapped on islands stretching for 1,500 miles from Bougainville to Dutch New Guinea. Casualties in Dutch New Guinea, MacArthur announced, have accounted for 6,705 Japanese in recent weeks. Bombers kept up their daily schedule with an attack on Rabaul in New Britain.  
President Roosevelt in a broadcast last night drew a broad picture of what confronts the enemy in the Pacific: "...We have depleted the Japs of the power to check the momentum of our ever-growing and ever-advancing military forces."  
"We have reduced their shipping by more than three million tons. We have overcome their original advantage in the air. We have cut off from a return to the homeland tens of thousands of beleaguered Japanese troops now face starvation and surrender."  
The President promised that when Hitler is finished the Allies will turn full strength against Japan and force her unconditional surrender or national suicide.  
In India Allied forces chased the enemy back near the Burma border and claimed victory in the battle for Kohima and were nearer full seizure of Myitkyina in northern Burma. Chinese forces pressed on toward Myitkyina against stoutly-resisting Japanese in the Salween river sector.  
Chinese troops fought savagely to hold off a three-sided Japanese drive to capture Changsha, control point on the vital Hankow-Canton railway of south central China. The enemy was within six miles of the city on the east and pressing close from the north and northwest. The Japanese in this drive have been credited with seeking to bottle up all of eastern China against future Allied use.

The targets included the airbase at Oberpfaffenhofen, 15 miles southwest of Munich, and a field used to assemble ME-109 twin-engine fighters.  
Other targets were the Milpertshofen ordnance depot at the west side of Munich, and two aircraft engine plants of the Allach Motor Works, eight miles northwest of Munich.  
Other formations attacked the railyards at Innsbruck, Austria, as well as oil factories at Porto Marghera, near Venice.  
Lightnings and Thunderbolts provided the Mediterranean-based planes penetration cover while Lightnings and Mustangs handled the target cover. The blows were dealt despite intense enemy flak.  
The daylight precision attacks from Britain and Italy followed a night attack by more than 3,000 RAF bombers against German transport facilities and the synthetic oil manufacturing center of Galkenkirchen in the Ruhr. On Galunankirchen, the RAF dumped 1,512 tons of high explosives and incendiaries.  
Escorted by Mustangs, Thunderbolts and Lightnings, the Fortresses rained explosives on airbases at Evreux-Fauville and Dreux-Flers-Everque. Clear weather made possible visual bombing. The Fortresses followed up yesterday's attack by up to 1,400 American heavy bombers against 16 airfields.  
Berlin said Italy-based bombers struck at Munich.  
The Marauders and Havocs attacked railroads, fuel dumps and other targets in close-up support of the beachhead forces.  
In a series of broadcasts, the Berlin radio told of heavy air battles raging over the whole invasion area and said that Allied planes surging over the Alps had penetrated to Bavaria and Franconia. Other daylight raiders were reported in small numbers over western and northern Germany.  
Following up yesterday's record assault by 1,400 American heavy bombers, the RAF included in its overnight targets bridges near Caen center of some of the heaviest fighting in the Allied invasion drive, and Cologne in western Germany—an important railway hub.  
The Luftwaffe, evidently trying to save face after its weak showing in Normandy, sent a few planes over southern and eastern England and got one lone plane through to London for the first time since April 27.

To the British people the Soviet Karelian isthmus offensive came as somewhat of a surprise, for many had believed that Stalin's strategy would be to strike first in Romania in the hope of shattering the last vestiges of Balkan allegiance to Hitler.  
It was generally conceded, however, that Moscow probably was guided by more than easy expediency in lashing out at a subordinate enemy. If they can neutralize Finland quickly, thus eliminating the threat to the Red's northern flank, the Russians naturally will be in better position for a drive against the enemy elsewhere.  
Furthermore, if able to base their planes in Finland, the Russians would strengthen their hand against German positions in the Baltic states. Soviet warships and submarines would be free to work out of the Gulf of Finland, which the Germans have laced with elaborate anti-submarine nets.  
Reports from Stockholm and even from Berlin say the Finns admit frankly they stand little chance against the Red army offensive, launched two months after the Helsinki government rejected Moscow's armistice terms.  
It seemed apparent that the Finns would have to fight alone. The German divisions in Finland are said to probably will be of little help.  
British press dispatches from Sweden suggesting retirement of the present Finnish government in favor of peacemakers are regarded here as plausible.

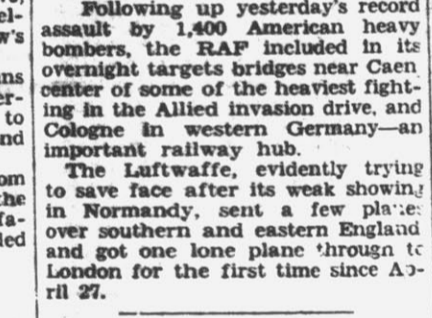

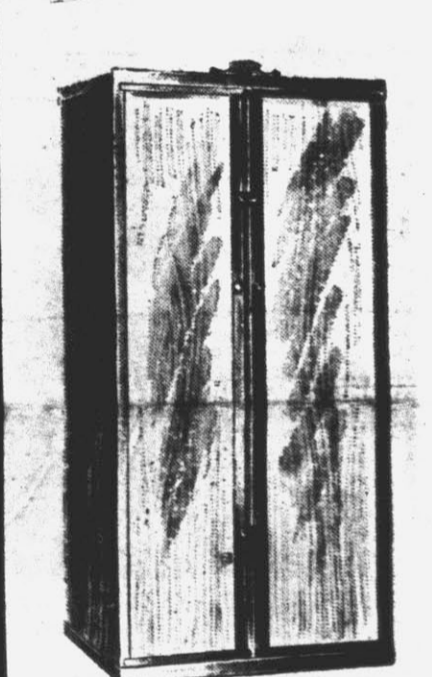

lege." Last week when we  
discussed the situation with  
one of the board members  
we were told that the board  
was "impervious to anything  
the newspapers or the public  
might say," and were given  
to understand that the board  
and not the public, was run-  
ning the college, despite the  
fact that the institution be-  
longs to the people of North  
Carolina. This board mem-  
ber further stated that he  
disappointed some members  
of the board at his own request  
nor did he have any inten-  
tion of getting off the board  
voluntarily. We cannot say  
that these two board mem-  
bers expressed the views and  
feelings of all the board  
members, but we do know  
that the two referred to  
above are influential mem-  
bers of the board, and no  
doubt others would follow  
their line of thought and  
reasoning.

Our attitude in the whole  
matter is the same as it has  
been from the beginning,  
and that is, that peace and  
harmony must be restored  
at the college before the in-  
stitution can function prop-  
erly and render the service  
it is supposed to render to  
the State. In order to accom-  
plish this there should be a  
Board of Trustees in which  
the public has full confi-  
dence. This board should at  
the first opportunity elect a  
president of the institution  
qualified in every way to run  
the college on an efficient  
basis. The next step should  
be a full and complete im-  
partial investigation of  
every department and every  
faculty member, with the  
view to making replace-  
ments where necessary for

the good of the institution.  
Any faculty changes, how-  
ever, should be made solely  
on the basis of qualifications  
and fitness for the positions,  
rather than whether or not  
the member involved was  
for or against Dr. Meadows  
in the recent controversy.

Because we are interested  
in the welfare of the college  
and feel that the above steps  
are necessary to assure its  
future success, last Saturday  
we sent the following tele-  
gram to Governor Broughton  
in the hope that it would  
bring to him a realization of  
the seriousness of the situa-  
tion and prompt him to  
do everything possible to  
end the present controversy  
and restore the college to its  
proper place:

Consensus of public opinion here  
is that the best interests of East  
Carolina Teachers College would be  
served by your request for resigna-  
tions of present members of the  
Board of Trustees and official ac-  
count of you, if within powers of  
your office, to remove them in case  
they decline your request for resig-  
nations.

We believe the above tele-  
gram expresses the thoughts  
and opinions of the vast ma-  
jority of opponents and we  
urge that you as a citizen  
interested in the welfare of  
the college, put your shoul-

der to the wheel and do  
something about helping to  
straighten out this deplor-  
able situation.

## AMERICA IN WARTIME

St. Louis—Only a few states will  
have a better opportunity than  
Missouri to look over the field be-  
fore they cast their vote in the pri-  
maries, which are August 1 here,  
after both national conventions  
have been held.

Perhaps this has something to do  
with the present lack of interest  
here on the part of voters, and con-  
versely the fact that Missouri in  
recent years has rarely seen more  
candidates out for high offices.

Politically, Missouri is more kith  
and kin to California than any of  
the states I have visited. It doesn't  
have California's peculiar voting  
laws which so confuse party lines,  
but it does have other confusions.  
For example, both senators, Bennett  
(Champ) Clark and Harry S. Tru-  
man, are Democrats. It has eight  
Republican representatives to five  
Democrats in Congress, and its gov-  
ernor, Forrest C. Donnell, is a Re-  
publican, now campaigning for the  
Republican nomination for U. S.  
Senator.

In 1938, this border state was so  
predominantly Democratic that the  
Republicans could elect only one  
representative to Congress. In 1940,  
they were able to name only three.  
But that year they captured the  
governorship. Two years later the  
balance of power for representa-  
tives in Congress swung far in their  
favor, but they didn't control the

state legislature.

This, however, was enough to give  
the Republicans a new lease on life  
and has resulted in bringing out a  
whole battalion of candidates for  
the nominations in both parties.

The situation is further compli-  
cated by a split in the state Demo-  
cratic party, with both Pendergast  
and anti-Pendergast Democrats  
having candidates in the field for  
several important offices. Observers  
in Kansas City and here, however,  
say that regardless of who wins the  
nominations, the Democrats will  
undoubtedly present a solid front in  
November.

Recent polls have given the edge  
here to Gov. Thomas E. Dewey, if  
he opposes President Roosevelt in  
the general election, but neither im-  
partial observers nor politicians feel  
positive about it.

None of the Republican candidates  
for gubernatorial nomination, Jean  
Paul Bradshaw, stated very flatly  
the other day: "The Republicans  
cannot expect to win on the weak-  
ness of the Democratic party."

Mr. Bradshaw feels Missouri is  
one of the pivotal states and that  
the Republicans will have to fight  
every inch of the way to win.

The problem for prognosticators  
here as in so many states is what  
the war time shift in population is  
going to do to the vote. Missouri  
has "lost" about 64 per cent of its  
population, according to estimates  
of the War Food Administration.

But "lost" means really a consid-  
erable turnover. War workers have  
replaced thousands of youngsters  
gone to war.
