

ALLIES STRIKE AT NAZIS IN BALKANS

British 'Lost Division' Withdrawn From Arnhem

Remnants Of Sky Troops Escape After Nine-Day Bloody Battle; Other Allied Forces Continue Drives Toward German Homeland At Both Ends Of Front.

By JAMES M. LONG London, Sept. 27.—(AP)—The Allied invasion of Holland struck to the Maas River line guarding Germany today, but the bloody, nine-day struggle at Arnhem had ended, with withdrawal across the upper Rhine of the battered survivors of the British "Lost Division."

The pullback of the airborne division, which took place Monday night but was disclosed only today, lost a Dutch teahold into the German Ruhr. Nevertheless the gallant stand of the "Red Devils" had measurably speeded the rapidly increasing invasion of "Holland" farther south.

Supreme headquarters gave no information on how many men of the division—normally 9,000 strong—were saved, but said the wounded were left behind. (German broadcasts declared 1,500 were killed, and 403 captured.)

(NBC's David Anderson broadcast from the western front today that of the 7,000 to 8,000 British troops in the Arnhem pocket at least 2,000 had been evacuated to the south bank of the Rhine river by this morning. Twelve hundred wounded British airborne troops were being treated and are under the care of the German commander, Anderson said.)

A number of British doctors stayed behind to tend the wounded, despite the certainty of capture. (The troops evacuated from the pocket reported they had never seen so many German dead in a small area, as at Arnhem, Anderson added.)

Setback, at the hands of furious German counterattacks that tinged of the gallant division and prevented the British Second Army's land drive from achieving a junction in rescuing force, lost a gamble to win quickly a crossing of the upper Rhine for a flanking drive into Germany around the upper end of the Siegfried Line.

The Allied campaign in Holland now had thrust up a 50-mile-long corridor from Belgium, and was rapidly broadening out east and west. Two penetrations had been made into Germany east of Nijmegen and west of Kleve, upper end of the Siegfried Line.

An Associated Press front dispatch declared the battle of Holland was slowly but surely swinging (Continued on Page Four)

SAYS CONTROL STILL NEEDED

Byrnes Urges Price And Wage Limits After War.

Washington, Sept. 27.—(AP)—War Mobilization Director James F. Byrnes said today the government must continue its controls over prices and wages after the war "until the dangers of inflation are passed."

Although he did not mention specifically the Little Steel formula limiting wage increase to 15 per cent above January, 1941 levels, he said:

"While we are prosecuting the war against Japan, price control must continue just as wage control (Continued on page four)

Russian And Romanian Forces Concentrating Pressure Against Hungary.

By Eddie Gilmore Moscow, Sept. 27.—(AP)—The German retreat to Riga was turned into a desperate stampede today by swiftly pursuing Red Army armor and infantry which had cleared northern Latvia to within 30 miles of the Baltic coast.

North and east of Riga the enemy was making no attempt to hold an organized line but the overall escape corridor westward from the city along the coast in the direction of east Prussia was being kept open regardless of losses, front dispatches said.

The Red Air force wrecked hundreds of trucks and dozens of railway cars being used by the Germans to flee from the northern Baltic.

Minimum of One And Half To Two Years Will Be Required To Defeat Japs After Germany Falls.

Washington, Sept. 27.—(AP)—The job of crushing Japan is expected to require an "absolute minimum" of one and a half to two years after defeat of Germany, the Office of War Information said today in a summary of war agencies' data.

Indeed, the psychological effect of an end to the European war is apt to favor the Japanese rather than the Allies, OWI said, figuring it this way:

"For the United States, defeat of Germany will mean that a half-way point has been reached in the global war, and will bring extensive changes in the war economy which might induce a let-down in effort and morale.

To the Japanese, the end of the war with Germany will mean that Japan's war with the United Nations is just beginning. It might well heighten Japan's determination and fighting spirit."

OWI said its findings were based on information from the state, war and navy departments and the foreign economic administration.

While the odds of military strength, natural resources and the quality of fighting forces and equipment all favor the United Nations, OWI said there are a number of factors which may enable Japan to prolong the war.

These were said to include the ability of Japan to increase her production of "almost every category of war equipment and military supplies."

On the other hand, OWI repeated Japan has "failed to capitalize" thus far on her conquests since Pearl Harbor, limiting war production to capacity of the Jap's pre-war industrial plant.

Geography is another factor fighting on the side of Tokyo, OWI said, adding that before Allied might can be brought to bear it must be based within striking distance of Japan's homeland.

To this OWI added that the "29 Superfortress raids, while possible now only at periods of 10 days or more, were called a "definite advance."

The agency pointed out that tremendous shipping problems must be solved before a major invasion can be launched against Japan, and added it may be several months before (Continued on page six)

Reconstruction Plans For Italy Formulated

HIGHTOWER Washington, Sept. 27.—(AP)—Far-reaching plans for the political and economic reconstruction of Italy were being put in final shape in London and Washington today in line with a new policy of greater Italian home rule worked out by President Roosevelt and Prime Minister Churchill.

Brig. Gen. William O'Dwyer, American member of the Allied Commission for Italy, is said to be preparing to return to his post almost immediately with orders to carry out the gradual shifting over of the one-time enemy country from a military to a civilian basis.

A report which O'Dwyer made to President Roosevelt, immediately before the Quebec conference on military administration of Italian affairs was credited in some official quarters here with influencing the decision by the President and Prime Minister Churchill to order the change-over at this time.

This report was described as holding right Allied military controls over Italian affairs largely responsible for the widespread shortages, hunger, black market operations and similar economic problems that have been widely reported from Italy.

No Losses

Washington, Sept. 27.—(AP)—The "large force" of B-29 Superfortresses which struck targets in Manchuria and occupied China yesterday returned to Chinese bases without loss of a single plane, the War Department reported today.

In addition to the previously reported blow against industrial installations at Anshaw in Manchuria and against the dock areas at Dairen, the 20th Bomb Command said the aerial giants also hit military targets at Loyang and Kaifeng in occupied China.

Results of the Manchuria blows "were not conclusively known since the bombing was accomplished chiefly through a heavy cloud cover," a communique said, adding, however, that crews returning from Loyang and Kaifeng reported "good" results.

Enemy aircraft fire was weak and fighter opposition light, the war bulletin said. Japanese broadcasts had claimed 13 planes had been downed.

AIRMEN BLAST RAIL CENTERS

Aerial War On Nazi Communications Continues.

London, Sept. 27.—(AP)—More than 1,100 American heavy bombers attacked railroad yards and industrial plants today at Kassel, Ludwigshafen, Cologne and Mainz, all in western Germany.

The big U. S. bombers struck out in the third straight day of heavy attacks on German communications and war plants behind the western front.

A strong force of British Lancasters and Halifaxes set fires at the inland German port of Karlsruhe and at Frankfurt last night in attacks costing two bombers. Karlsruhe is on the Rhine 100 miles beyond Metz, for which Americans are fighting. Frankfurt is about the same distance from Luxembourg, another GI front, and both cities are supply centers for the embattled German armies.

It was estimated that 6,000 tons of explosives plummeted on six German (Continued on page four)

Recapture Two Convicts In City

Paul Jenkins and William T. Brown, long term prisoners, jumped from a State Prison Camp truck on Dickinson avenue near Greene street this morning and made a dash for freedom that lasted only 45 minutes.

The escaping prisoners ran through Harris and Rogers tobacco warehouse to Pitt street and disappeared. State Prison Camp guards and local police captured the two convicts between Third street school and the river. They are now spending some days in solitary confinement, Supt. Paul Crawford said.

Jenkins was sent up from Wilson county for second degree murder and was serving a 30-year sentence. Brown was sent up from Cumberland land county for larceny and was serving from four to six years. Brown recently made a break for liberty which lasted about five minutes, prison officials said.

Sea And Airborne Troops Land On Dalmatian Coast

81st Division Troops Invade Angaur



Under the protecting guns of American warships, U. S. troops of the 81st Infantry division swam on the northern beaches of Angaur in the Palau Island, of the Pacific. Intense fires were started on the island by the terrific bombardment delivered by naval vessels and American planes. Four days later Angaur island was secured, and soldiers turned to mopping up scattered remnants of the Jap force. The 81st, known as the "Wildcat" division, trained at Camp Rucker, Ala. Its predecessor, the famous "Wildcat" division of World War I, helped smash the Hindenburg line in the Allied drive that forced the Germans to call for the armistice. (AP Wirephoto.)

Move Designed To Cut Off Return Of Hitler's Southern Armies To The Reich; British Naval Units Blocking Evacuation Of Aegean Islands By Nazis.

(By The Associated Press) Rome, Sept. 27.—Allied sea and airborne troops have landed in Albania and on islands off Yugoslavia, the Allied command announced today, in operations to block German detachments fleeing from the Balkans toward the Reich.

"Land forces of the Adriatic" already were operating on a wide front in the Adriatic area of Albania, a Balkan air force communique said.

The Allied naval command said that Royal Navy landing craft, supported by destroyers and light coastal vessels, had been operating since Sept. 15 among the southern Dalmatian islands off Yugoslavia, carrying Allied troops and partisans who were striking at German withdrawal routes.

(An Istanbul dispatch said that Greek patriots took over the island of Samothrace, 55 miles west of Gallipoli, yesterday after Bulgarian occupying troops left, and that the Germans had evacuated the islands of Paros and Naxos in the Cyclades group. The Nazis also are abandoning said land operations since Sept. 15 among the southern Dalmatian islands off Yugoslavia, carrying Allied troops and partisans who were striking at German withdrawal routes.)

(Cairo announced four huge German troop-carrying aircraft had been shot down by British fighters over the Aegean, indicating that the enemy was trying to evacuate key personnel from Greece by air. Four other big German planes were sent down by Middle East pilots, and Allied fighters shot up German man transport on Crete.)

The Allied command's announcement said land operations thus far included destruction of the German garrison at Himara, in Albania. The operation made use of the Albanian coastal road so precarious for the Germans that "the enemy was forced to send supplies to other garrisons by small seagoing craft."

The German radio said the landings were made "from Albania along the whole Dalmatian coast," which lies to the north in Yugoslavia. Another broadcast from Berlin said official news agency DNB said "strong Aegean and air forces attacked the island groups off the Dalmatian coast 'on a broad front,' and that fighting continued.

Between the advancing Russians in the northeast and the Allied forces on the coast, the Germans faced prospects of a march through a mountainous country dotted by partisan forces, both Albanian and (Continued on page six)

Nazis Counterattack On The Italian Front

American Fifth Army Pushed Back Short Distance; British Forge Ahead.

By NOLAND NORGAARD Rome, Sept. 27.—(AP)—A strong German counterattack in which, an official report declared, the Nazi command expended liberally his personnel, has driven Americans of the Fifth Army from a portion of the Monte la Fine hill pass, 20 miles south of Bologna, the Allied command today.

Meanwhile, the Eighth army extended its bridgeheads across the Rubicon, one-time boundary of Republican Rome and Cisalpine Gaul in the southeastern edge of the Po valley, and fought its way into the (Continued on page four)

SUCCESS ON PELELIU NEAR

Victory In Sight As Jap Resistance Crumbles.

U. S. Pacific Fleet headquarters, Pearl Harbor, Sept. 27.—(AP)—The biggest victory of the Palau invasion appeared in sight today for ridge-scaling Marines and soldiers who have killed more than 7,000 Japanese while suffering 5,500 casualties—686 killed, 406 missing, 4,408 wounded—in the first 10 days.

The leathernecks and doughboys, compressing the enemy on Peleliu's tortuous terrain into two pockets, bid for an early end to organized enemy resistance on the bitterly-defended air base 515 miles east of the Philippines.

The casualty figures—giving the lie to Japanese broadcasts that American losses up to Sept. 23 amounted to 12,400—were announced last night in a communique which hinted some of the wounded (Continued on page four)

Today On The Home Front

Editor's Note: This is the third in a series on veterans' benefits, ranging from demobilization to jobs and pensions.

Washington, Sept. 27.—(AP)—The soldier about to be discharged back into civilian life is sent to a separation center at Army camps across the country.

There, his papers are checked and he is given a record—called a separation qualification record—of his civilian and military occupational training.

Which means: the kind of jobs he had done in civilian life and the kind of jobs he learned to do in the Army. It is intended to help his readjustment to civilian life and for this reason:

The record will be the veteran's official Army introduction to future employers, educational authorities or any civilian agency with which he deals for a job.

The soldier attends lectures, the last he will hear in the Army, about his return to civilian life and his new responsibilities. He is also told about his rights and benefits as a veteran.

He turns in all his equipment. The Army takes back everything except one complete uniform, one extra shirt, gloves, ties, socks, underwear, towel, toilet articles and personal belongings.

He is permitted to wear the uniform 90 days after discharge although most veterans probably will wear it only until they get civilian clothes. He can of course wear it thereafter upon special occasions.

He is given a physical examination. If there is anything wrong with his body or teeth that can be corrected, his discharge may be delayed until the condition is remedied at a government hospital. He can waive such treatment if he wishes.

AN ANALYSIS OF THE NEWS

The government has chosen today, when Allied spirits are lower than at any time since heavy bombing failed to break the Germans at Cassino, to tell us that we will be fighting through all of next year and into 1946.

It is just as well that way. The situation with regard to Japan has been obvious. But now, rather than when we are overrunning Germany, is a much better time to emphasize that the end of the war in Europe will merely give us a chance to hitch up our pants and spit on our hands.

In passing, and while awaiting the end of the news blockade regarding Holland, it is worth noting that the battle of Arnhem may be temporarily, overplayed in its relation to the whole western front. Word that the British second army is swinging eastward toward Germany may mean that the Arnhem situation is decided and that we must get on with the invasion of Germany, leaving the city to be developed as other Allied forces clear the enemy from western Holland.

But to get back to Japan. It is a coincidence that the OWI report should come immediately after a new operation by our B-29's, of which we are inordinately proud.

Two years ago we were just as proud of our Fortresses and Liberators over Europe, doing a job which proved too insignificant compared with the one ultimately required.

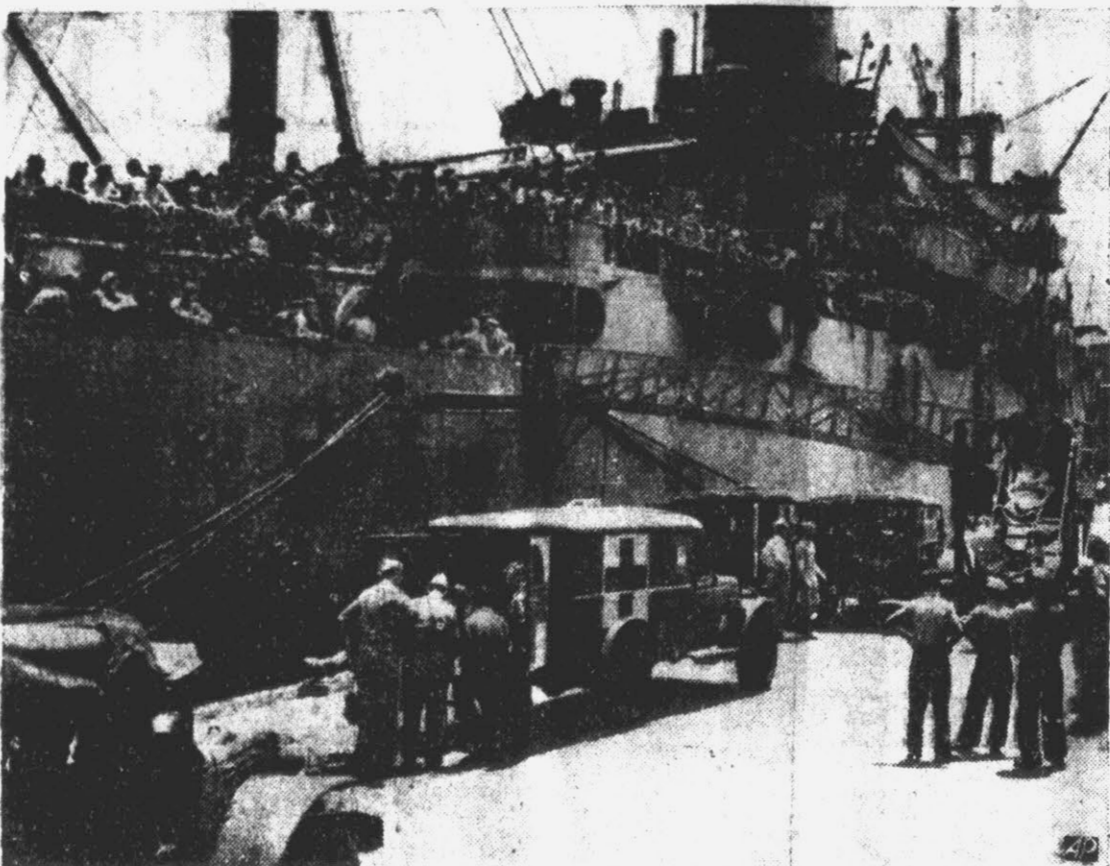

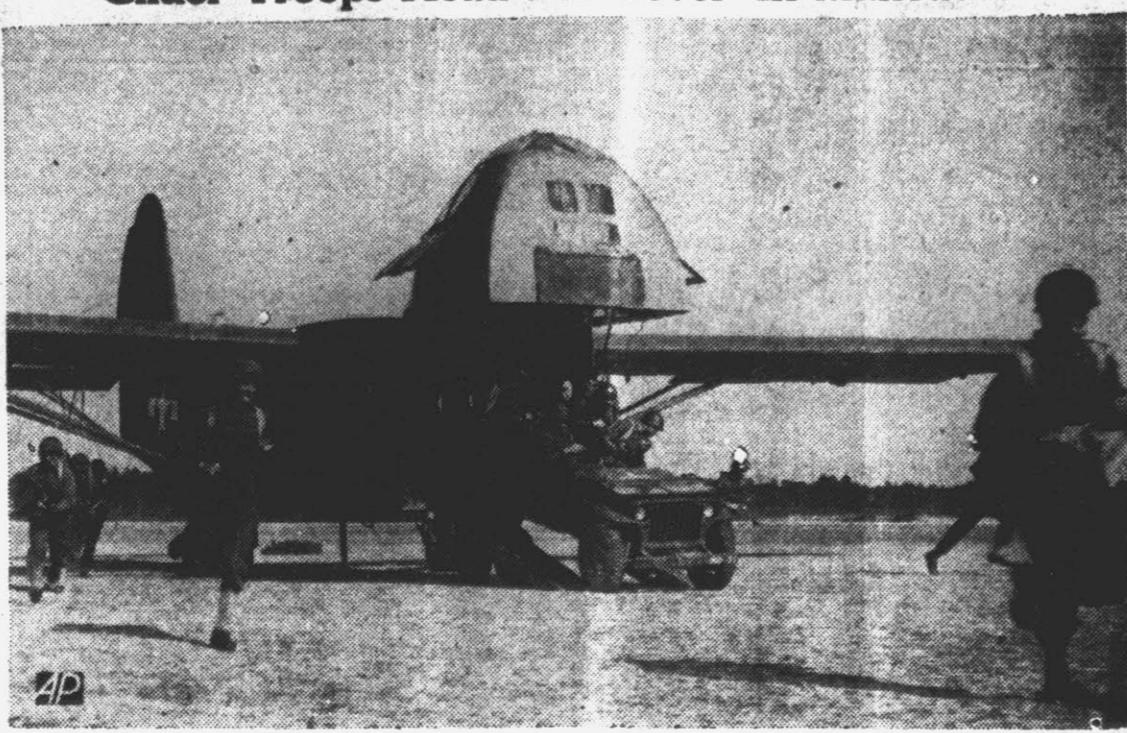

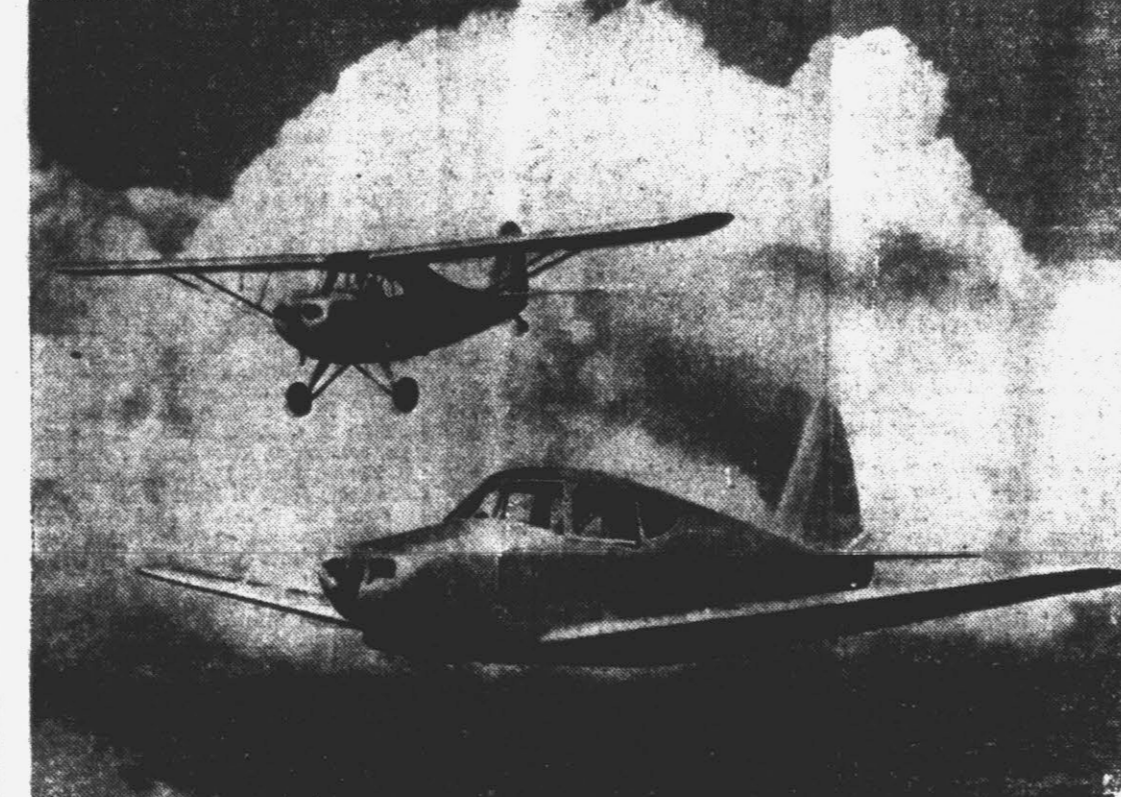

Hunting and Fishing

Raleigh, N. C., Sept. 27—(AP)—Deer and bear of both sexes will be taken in the tenth big game hunt on the Pisgah preserve this year to eliminate surpluses. Local participation is expected to predominate, although hunters from nearly every state have attended in past years.

Plans for organized hunts were announced by Carl G. Krueger, forest supervisor, and chief refuge supervisor J. M. Longshore.

The 1944 hunting schedule for Pisgah National Forest cooperative areas is:

Pisgah reserve, squirrel, October 9-14, inclusive; Mt. Mitchell, bear, October 16, 17, 20, 21, 23, 26; Sherwood, bear, October 16, 17, 21, 22, 25, 26, 30, 31, November 3, 4, 9, 10; Daniel Boone, bear, October 18, 19, 23, 24, 27, 28; Pisgah preserve, deer and bear, November 8-11, 12, inclusive; Mt. Mitchell, deer, November 8-11, 14-17, inclusive; Daniel Boone, deer, November 22-25, 27-30, inclusive.

Some 30,000 trout are being reared by the Fish and Wildlife Service at the Davidson River Rearing Station for use on the Pisgah areas. Additional stock will be furnished by State Hatcheries.

Recent high waters hurt striped bass (Rock) fishing along the Roanoke River, but it is almost back to par along the Scuppernon, which was filled with limbs, leaves and other debris by the recent hurricane.

Supervisor J. M. Stingley says "Hoffman Forest is full of bears. There's one big fellow that comes around Depe Tower and makes himself at home. He isn't scared of anything. They ought to be thinned out."

It was a queer fish that Captain Preston Stone of Hatteras caught in his net the other day while operating his shrimp boat. The fish weighed slightly less than a pound, was shaped like a croaker, but had a long flat head thickly studded with small stones. It was deep red.

A 15-foot shark weighing more than a half ton was caught in a shrimp trawl at Southport, it was just a pain in the net.

The season for marsh hens (Sora, Rail, Gallinule) has been on for almost four weeks now but few hunters have gone after them. The marsh hen, slightly larger than a quail, is a fast runner, darting in and out of the marsh grass. Though able to fly, they prefer to run, with the result that clear shots are hard to get.

There has been an increase in wild Russian hogs in Western Carolina, but no sizeable increase in the number of rabbits and squirrels there, contrary to other sections of the state.

Pitt County Schedule

The schedule of opening and closing of the hunting seasons for Pitt county as prescribed by state law is as follows:

Squirrel, deer and bear, opens Monday, Oct. 2; closes Jan. 1.

Quail, turkey and rabbit, opens No. 23 (Thanksgiving Day); closes Feb. 10.

Coon and opossum (with guns and dogs only), opens Oct. 15; closes Feb. 15.

Mink, muskrat, opossum and raccoon (trapping), opens Nov. 15; closes Feb. 15.

The Fish and Wildlife Service has announced a change in the dove hunting season for this state this year. According to present regulations it opened Sept. 23 and closes Oct. 15. The dove season will reopen Dec. 25 and close on Jan. 20. This is a split season.

Provision has been made that Christmas Day and New Year's Day will be open for hunting quail in lay counties, the game protector said.

Battle Of Words Rages On The Political Front

Dewey Preparing For Counterattack By President Roosevelt.

By JACK BELL

En route to Albany with Dewey, Sept. 27—(AP)—Homeward bound from his western tour on the New Deal, Gov. Thomas E. Dewey gave renewed indications today that he is ready for a swift counter-attack against expected new blasts on the Republicans by President Roosevelt.

Dewey announced he plans to speak in West Virginia, on Oct. 6, just one day after Mr. Roosevelt goes on the air to talk to Democratic party rallies. The New York governor smilingly told a news conference yesterday that he had been apprised of the President's radio date.

(In New York, the Republican National Committee announced the West Virginia address would be made at Charleston and would be broadcast nationally over NBC from 9 to 9:30 P. M., except for a news conference.)

When a reporter remarked that the lapse of time was so short between the two there might not be sufficient opportunity to prepare an answer to anything the President might say, Dewey observed that he had written his Oklahoma City speech, delivered Monday night, in 12 hours.

"You had better do some more 12 hour speeches, then," said Dick Lee, a reporter for the New York Daily News, amid laughter.

Dewey said he was pleased with the reception that had been given his Oklahoma City address, in which he called for restoration of "Integrity in the White House."

Paul Lockwood, his secretary, said that many of a record number of telegrams received were "expressed genuine anger at the irresponsible speech of Mr. Roosevelt," made Saturday night and answered by Dewey Monday.

When a reporter asked if any offers of cash contributions had been received, Dewey shook his head. He smiled as he added that the Republican National Committee had had to use its credit to obtain time on an additional radio chain (Blue) to carry it.

Dewey apparently was planning nearly a week of rest and speech writing before his next campaign foray. He said he had no speeches prepared at this time.

As he traveled eastward last night Dewey made four after dark appearances, according to listeners who overflowed railroad tracks, perched on boxcars, and stood in trucks at Claremore and Vinita, Okla., and at Monett and Springfield, Mo.

At Monett, observing that a crowd which railroad officials said approached 5,000 persons had gathered, Dewey remarked that "There must be a lot of people who want a change in Washington."

"We're going to have it," came a shout from the crowd.

"That's right," Dewey declared. "We're on our way. It's not going to be such a tough job if we have your help."

At both Monett and Vinita Dewey said he would always regard the creation of an organization for peace "as an objective and a purpose more sacred than any man's political future or his election to office."

Shortly before midnight in Springfield Dewey told a crowd of about 2,500 persons it would be one of the first tasks of a Republican administration to bring home "at the earliest possible moment after the war ends the men who have fought the war."

Declaring at Vinita that the crisis has been reached "of a war which with God's help will be over by January 29," the nominee said that the question of providing jobs for returning service men soon must be faced.

"We have 10 million men coming home from this war and with God's permission it won't be long," he said. "Ten million men coming home who want to come home to a country where they are not ordered all day long what jobs they have or may not have by an all-wise group of braintrusts who sit in ivory towers in Washington and think they know how the American people want to live."

"What we want is a country with an opportunity for every man who has a little business to go ahead with it. An opportunity for every man who has an idea to go out and create a job for himself and a business for himself and more jobs for people. To do that, what we want is to get rid of this administration."

Miss Jean McIver Lane, a North Carolinian, is a new instructor in the Art department. Miss Lane is a member of Phi Beta Kappa and was, in 1943, junior art editor for the J. B. Audit Davenport Books Hard Job

Depositors in Roderick Davenport's unlicensed "banking" business in seven Eastern Carolina cities stand to lose about \$600,000, it is indicated in the incomplete audit report of the State Banking Commission, recently issued. Investors in the "big borrowing and small lending" syndicate who hoped to make large profits are faced with total loss, it appears.

The audit was made by direction of Governor Broughton after Fifth Judicial District Solicitor Dave M. Clark had indicted Davenport and some of his associates in Superior Court in Greenville.

Davenport, who is from New Bern, is out under \$15,000 bond on charges to defraud the public. All of his indicted associates have been released from jail.

According to Bank Examiner J. A. Cramer's report, Davenport's records are so incomplete that the entire sum entrusted to him for investment probably never will be known.

In Superior Court here yesterday Judge R. Hunt Parker of Roanoke Rapids praised Solicitor Clark's fearlessness in indicting Davenport and his associates. He said that Clark had performed a great service to the community in that he carried out the indictments before the farmers began receiving tobacco checks, thereby preventing further losses.

Riga the Russians yesterday overran more than 300 communities. For all practical purposes neighboring Estonia to the north already was liberated.

A communique last night said Red Army troops captured 200 planes yesterday in clearing up Estonia's west coast. Few Germans now remain on Estonian soil except those on the fortress islands offshore.

On the southern end of the eastern front the Russians appeared to be concentrating new pressure on Hungary. Although nothing was said officially there seemed reason to believe the combined Russian and Romanian armies are battering at its borders and may already have crossed.

(The Paris radio quoted Istanbul diplomatic circles as saying it was believed "only a question of hours" before Hungary, weakening under the increasing pressure, appeals to the Allies through Turkey for an armistice.)

But it was at Riga the Germans had been placed in the most obvious peril. The Nazis were fighting desperate rearguard actions around the port as Red armies closed in from three directions. On the south the Red Army last was reported only six miles away.

The Germans still had a narrow corridor from Riga along the Baltic coast to east Prussia, but it was under constant Russian attack.

Along the Polish-Czechoslovakian border, where heavy fighting is in progress, the Russians battered their way through deep fortifications and seized Turka, 12 miles from the frontier. Nine other communities in that mountainous region also fell.

Switzerland Bombed

London, Sept. 27—(AP)—American fighterbombers dropped bombs in the canton of Thurgau in Switzerland this morning in an effort to bomb a bridge over the river Thur.

A Swiss broadcast said it added there were no immediate reports of casualties.

Jap Planes Raid Superfort Base

U. S. Superfortress Base, West China, Sept. 27—(AP)—A dozen Japanese medium bombers raided this Superfortress base last night in a "peanut sized" retaliation for the attack on enemy industry yesterday at Anshan in Manchuria.

The raid was virtually harmless although the alert lasted two hours and a half and drove the exuberant American pilots into muddy foxholes. No B-29 was destroyed; no runway was hit.

Small diversionary forces of B-29s hit docks and warehouses at Dairen, all bulging with war goods piled up as a result of the enemy shipping shortage. Several planes also bombed rail yards at Sensiang, in China.

Incomplete reports put Japanese fighter losses over Manchuria at six destroyed, six probably downed and 12 damaged.

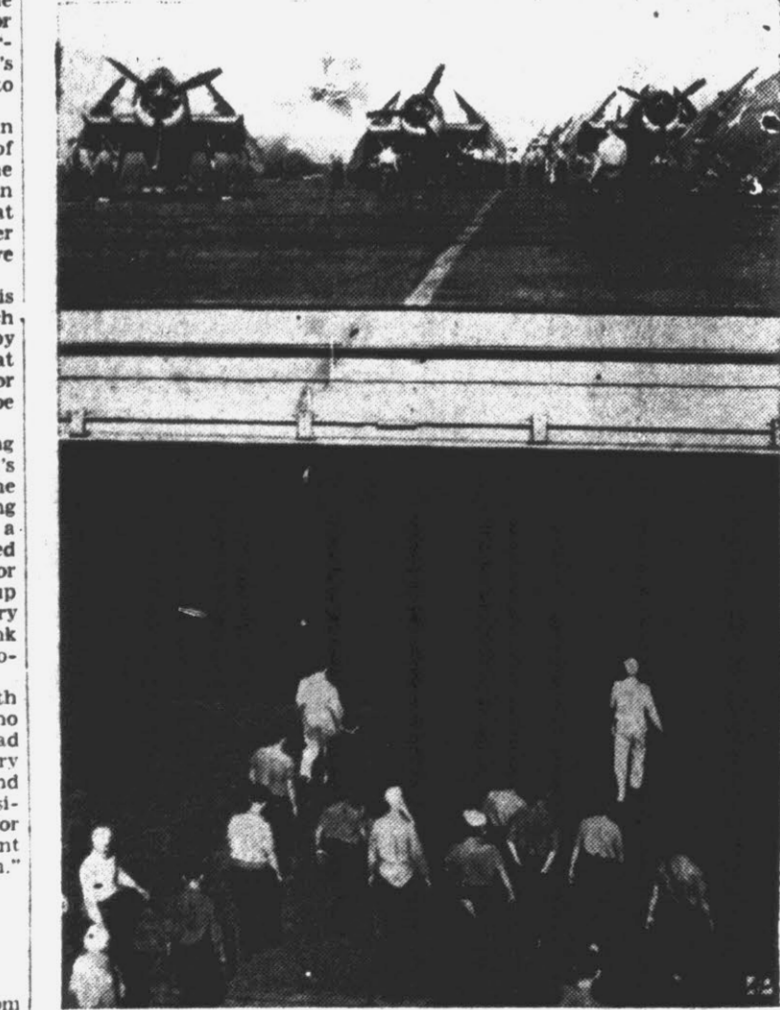

fore shipping to be transferred from the Atlantic can be made effective in the Pacific.

OWI said:

"At present, the course of the war in China is all in Japan's favor. Instead of securing additional advance bases from which to strike at Japan by air, the Allies have lost several in recent months."

Even though the number of Japanese planes destroyed is high compared to our own losses, Japanese plants are turning them out "as rapidly as we destroy them and probably can maintain or even increase this production slightly," OWI stated. It added that the Nipponese can now mass their air power in a narrowing theater of war.

This is also true on the shipping side, where sinkings of Japanese ships are estimated at 1,500,000 tons a year against output, which it is calculated, has not yet reached 1,000,000 tons a year.

OWI estimates there now are 4,000,000 men in the enemy army. In addition, there are approximately 2,000,000 available and fit for military service who have not been called up, and about 1,500,000 in the 17 to 20 age group, not yet subject to the draft.
