Russians Seek To Broaden Base Of Oder River Drive

Zhukov Unlimbers One of War's Heaviest Artillery Barrages At German Fortifications Blocking Way to Berlin; Reds Closing In On Stettin

KING London, Feb. 9—(AP)—The Russians have smashed to within 25 miles of Stettin, the Port of Berlin, and have exploded a fresh offensive northwest of Breslau threatening the encirclement of that huge industrial center, it was reported today. Marshal Gregory Zhukov unlimbered one of the war's heaviest artillery barrages at fortifications along the Oder temporarily blocking the direct way to Berlin. One of the first towns to fall in the new offensive of Marshal Ivan Konev from his Maltsch bridgehead over the Oder was Parchwitz, 30 miles west-northwest of Breslau, the Berlin radio said. The German command said the First Ukrainian army thrusts had reached Liegnitz, a rail center of 76,000 a little more than eight miles southeast of Parchwitz. The Russian armies were within 40 miles of closing the escape gap from Breslau, a city of 615,000. The town of Kurtsch, 12 miles south of Breslau, was captured yesterday. While Moscow had not officially confirmed the launching of the new drive, Moscow dispatches said Konev in heavy fighting was "hitting at Liegnitz guarding the approaches to Saxony." On the Berlin front Zhukov was out-gunning the Germans in the grim duel across the middle Oder, the Germans declared they had narrowed down or eliminated most of the main bridgeheads they previously reported thrust across the river. Moscow still had not officially announced creation of any of these bridgeheads, and correspondents in the Soviet capital said it was unlikely any Soviet announcements would be made until the Russians were sure they had won the battle along this vital zone. Northwest of Kuestrin, where the Germans have reported a bridgehead within 30 miles of Berlin, Moscow correspondents said a particularly heavy curtain of artillery fire was being laid down around Wriezen, a German headquarters 23 (Continued on Page Six)

The WAR TODAY AN ANALYSIS OF THE NEWS

By DEWITT MACKENZIE Associated Press War Analyst The growing intensity of the Allied assault which is boring the Reich from both east and west has strengthened the belief among observers that the Big Three, now in momentous conference in the Black Sea area, are likely soon to call on the German people to desert Hitlerdom. Much must depend, as I see it, on the speed with which the Allied armies are able to pile up the threat against Berlin. The broadening of the attack on the Western front by the launching of the Canadian-British offensive is a most hopeful development. Should it be the design of Messrs. Roosevelt, Churchill and Stalin to issue such a summons, it's logical to assume that it would come at the psychological moment when the Germans have been squeezed just hard enough—a matter calling for very delicate timing. That moment might be the fall of Berlin, or when the capital is invested and its capture is clearly imminent. One of the greatest blows that could be inflicted on the morale of the German people would be the loss of their first city. The final effect of such a summons would be greatly strengthened if the call came while the Big Three were in session. Certainly no ultimatum could be more effective than

Widenhouse Still On Witness Stand

J. C. PENNEY TO VISIT HERE Chain Store Founder To Speak At City Hall Thursday

Cross examination of M. L. Widenhouse, auditor, and one of the state's chief witnesses in the trial of Dr. Leon R. Meadows on charges of embezzlement and false pretense, was still in progress when court recessed for lunch today, but indications were that the defense would conclude its questioning of the witness during the afternoon. Widenhouse has been on the stand since Tuesday afternoon and his cross examination by Clay Carter, of defense counsel, has been under way since Wednesday afternoon. Highlights of today's examination of the witness were his admission of another error in his audit covering an item of \$7.50 for which Dr. Meadows was not allowed credit, but which Widenhouse said should have been allowed. The witness also admitted that the change of date on one of the items about which he was questioned this morning, was one of the changes he referred to in his direct testimony when he said that the books contained additions and changes. He admitted that the change referred to today was apparently for the purpose of correcting an obvious error. The item in question was one for which Dr. Meadows had been allowed credit in the audit and the change in date had no effect on the item, the witness said. Continuing the cross examination along the same pattern of questions as used yesterday, defense counsel sought to drive home to the jury the implication that without full investigation of items the auditor had disallowed them in preparing his audit upon which indictments against Dr. Meadows are based. MAYOR HUNG BY GERMANS

Third In Series Of Executions 'For Cowardice'

London, Feb. 9—(AP)—The Germans announced today the execution of another mayor for fleeing his city before the advancing Red Army. Mayor Schroeter of Koenigsberg, a small Pomeranian town on the east side of the Oder between Berlin and Stettin, was "hanged for leaving his town without receiving evacuation orders," the Berlin radio said. The first announcement did not locate Koenigsberg and left the impression that the capital of East Prussia was meant. Later Berlin broadcasts identified the town. Schroeter was sentenced in court at Schwedt, 30 miles south of Stettin. This was the third in a series of Eastern front civilian executions announced by the Germans. Previously the deputy mayor of Breslau was executed and other officials of Bromberg, the fallen fortress in Pomerania, were executed "for cowardice." The Paris radio said some foreign slave workers had risen against the Germans even as Heinrich Himmler organized German guerrillas for last ditch resistance against the Allied invaders. German authorities were reported to have prohibited further withdrawal of foreign workers from threatened areas in the east on the ground that those already evacuated had created unrest in the rear areas. Two Men Die In Spectacular Fire

Chicago, Feb. 9—(AP)—Two men were believed to have died early today when they were trapped in a spectacular fire which shot flames 250 feet into the air from the plant of the Verling Steel Company. Ray Olsen, night superintendent, identified the two as Martin Lightfoot, a negro, and John Gagalewki, night watchman. Olsen said the two were near him on the second floor when an explosion occurred, and that he heard them screaming. Fifteen others, all welders, escaped. Olsen said the blaze apparently started in a paint vat near where the welders were at work. Attempts to extinguish it with hand equipment failed.

Republicans Don't Like Dewey's Foreign Program

By JACK BELL Washington, Feb. 9—(AP)—Governor Thomas E. Dewey's declaration of cooperation with the administration's international objectives today provoked both praise and dissent among Republican Congressmen. In an address last night the 1944 presidential nominee said President Roosevelt has the support of both parties and the prayers of the American people in his current meeting with Prime Minister Churchill and Marshal Stalin. But he added "rare" meeting of the big three are not enough, and he criticized what he termed "false liberalism" in postwar domestic plans. In effect, Dewey told a select crowd of banqueting party members here last night that the GOP quarrel with the administration is one of individuals and methods, not objectives—so far as international relations are concerned. But on the home front, the 1944 Republican presidential nominee found plenty of grounds for political battling. Specifically he mentioned what he called the Administration's tendency to believe "that to cure every ill you pass a law and appropriate a billion dollars." The New York governor's demand for immediate American participation in the international decisions which are revamping the map of Europe found almost universal approval among members of congress. Yanks Driving Toward Dock Section In Manila

Japanese Spread New Fires In Last Stand For Capital; Planes Pour Bomb Loads on Corregidor.

Manila, Feb. 9—(AP)—U. S. infantrymen, splashing across the Pasig river in amphibious tanks, drove toward the prized dock section of Manila today in the face of new enemy demoralization charges set off in the old Intramuros district, a death trap for its congested Filipino and Chinese residents. Unseasonal rain dampened many of the scattered fires set wantonly by the desperate and trapped Japanese defenders but the Intramuros, or walled city, blazed so fiercely for a time that the heat could be felt blocks away. (Some fires are still burning but the worst of the flames seem to have burned themselves out, George Thomas Foster reported in an NBC broadcast from Manila. He said a regiment of doughboys crossed the Pasig today "and there is hope that the property destroying phase of the battle for Manila may be nearing a close.") The 37th infantry division entered southern Manila by crossing the wide Pasig river near the governmental Malacanang palace and began to root out the Japanese who had destroyed the four bridges. The Yanks worked south and southwestward through comparatively open spaces around the gas works, with the harbor facilities their prime immediate objective. Gen. Douglas MacArthur announced today the 37th was assisting the 11th airborne division in clearing south Manila. Maj. Gen. Joseph M. Swing's 11th airborne, which swept into the southwest was last reported fighting around Nichols field on the southern fringe of Manila. Small-scale but stiff resistance slowed this spearhead. Japanese artillery fire began to taper off yesterday after two days of continuous shelling of American held north Manila. MacArthur announced the destruction of more than 200 Japanese tanks—more than two-thirds of the striking power of the Japanese second armored division—in operations on the central Luzon plain, where the enemy is slowly being driven into the eastern foothills. MAY PROVIDE NEW HOSPITAL

Introduce Bill To Provide For Paralytic Children

Raleigh, Feb. 9—(AP)—Bills to extend additional aid to the mentally unfortunate and to provide for the establishment of a 50-bed hospital for spastic paralytic children were introduced today in the legislature. Senator O'Berry of Wayne, sponsor of two of the measures, said that a special commission appointed by former Governor Broughton had studied the needs of a spastic paralytic hospital and had found a great need. He said a nine-member board of directors would be appointed by the governor to study the matter and report back to the next assembly. It would have authority to select a superintendent and fix his salary, subject to the approval of the budget bureau. It could accept donations but could not spend money on permanent improvements unless such provisions is made by the assembly. State-owned property could be utilized for the hospital. Another O'Berry bill would direct that the Hospital Board of Control should have a representative from each congressional district and that at large, all appointed by the governor for staggered terms. Three members would constitute the executive committee, and there would be a five-member advisory committee. The board would have authority to employ a superintendent of mental hygiene, who would be a doctor of medicine with demonstrated executive ability, and a general business manager. Out-patient clinics would be held at the mental hospitals at medical schools or at general hospitals. Senator Mitchell of Iredell sent a bill to liberalize the rules for commitment to mental hospitals. His measure, drawn up by 15 mental experts of the state, would allow commitment by two physicians, and remove the provision that commitments must be made by clerks of superior court. Patients could be placed in the institutions for observation for 30 days, and indefinitely confined if such a step seemed necessary. Ten-day observation periods would be provided for violent patients in order that they would not have to be confined in the hospital from out of state, who become insane while in North Carolina, could be treated until transferred. Criminals, too, could be confined for observation if believed mentally unbalanced. A state mental health council would be authorized to study needs for mental health of the people. Regs. Barker of Durham and Smith of Davidson introduced bills to require the immunization of children against whooping cough before they become one year old. (Continued on Page Six)

Order Restrains Armour Company

Raleigh, Feb. 9—(AP)—The Raleigh OPA office has obtained temporary restraint orders against Armour and Company of Durham and Wilmington following charges the two branches violated OPA regulations. Theodore S. Johnson, OPA district director, announced yesterday. The orders signed by U. S. District Judge Johnson J. Hayes are returnable before him in Durham and Raleigh on Feb. 15. Johnson said the Durham branch was charged with selling dressed poultry at wholesale not completely drawn, but with charging drawn prices. He said the Wilmington branch was charged with requiring retailers to purchase lamb in order to buy other meats.

Would Accept Nurse Draft

Washington, Feb. 9—(AP)—The American Nurses Association said today it would accept a nurses' draft "only as a first step in a selective service act for all women." The association recommended instead a federally-financed recruitment program to be at least comparable in scope to those employed in enlisting WACs and WAVes.

Canadian First Army Drives On Kleve; U. S. First and Third Armies Batter Siegfried Defenses On 70-Mile Front; Other Armies Mop Up German Pockets

LONG Paris, Feb. 9—(AP)—Field Marshal Montgomery's powerful new offensive toward the Ruhr carried within four miles tonight of fire-racked Kleve, northern terminal of the original Siegfried Line, and penetrated deeply into the West Wall fortifications in the Reichswald. Since dawn, the flame-throwing Canadian First Army had advanced more than two miles deeper into northwest Germany and captured six more towns, one of them three miles from the Rhine, before it branches out to form the West and Neder Rhine in Holland. Most of the villages were in Germany. The nearest to Kleve was Prassel and the nearest to the Rhine was the Dutch village of Leuth. Tuthen, on the main road from captured Kraenichburg to Kleve, was taken along with Zampol, Niel and Breedeberg in the onward surge of the Canadian and British tanks and infantry. The new attack, bringing to life a long dormant sector, opened a pincer on the Ruhr, for the south of the Kleve-Kraenichburg road and Third Army were cutting in toward the arsenal region of coal and steel. In the center the American Ninth and British Second armies were deployed along the Oder River for a frontal blow to the dense industrial area. The new drive had carried from four to five miles inside Germany and deep into the Reichswald, 40 square miles of dense forest in the thick winter woods of the Siegfried Line were overrun. In the south and center, the American First Army moved within a mile of the head Schwammenauel Dam, controlling the Ruhr flood levels and the Third Army drove eight miles deep into the Reich and to within a mile of Freun. The French First Army stages out the last organized German resistance south of Strasbourg and won holds (Continued on page six)

Opposition Grows To Manpower Bill

Washington, Feb. 9—(AP)—Senator Chandler (R-Ky) reported today that opposition to the work or jail bill is growing in the Senate Military Committee which is rounding out its first week of semi-secret hearings on the measure. Friends of the bill, however, said they are encouraged by the general trend of testimony and the concerted endorsement of the measure by high government officials. Although no change in progress has been made in four days, Senator Austin (R-Vt), an advocate of the legislation, said he saw no signs of stalling within the committee and declared "We're making as fast as we can." Nevertheless, Chairman Thomas (D-Utah) expects the hearings to continue at least all next week.

Sent To Jail For Assaulting Woman

By CHESTER WALSH Charles Carraway, white mechanic employed at a local garage, charged with assault on a woman, was sentenced to a year in State Prison on each charge. The court recommended that his mental condition be examined.

"You two boys have simply jitterbugged yourselves into jail," said Judge Jimmy Roberts in Police Court today when police testified that they found William J. Fleming, Jr. and Fred Bush, Negroes, dancing in a night club and that they were not employed anywhere. They were charged with vagrancy. The judge gave each of them 30 days in jail and assigned them to work on the city streets.

Lester Kilpatrick had to serve 30 days or pay costs for being drunk. Judgment was suspended on payment of costs in the case charging James B. McDuffy with reckless driving. He paid costs. John David Williams, colored, charged with perjury in connection with falsely testifying in the case against James Peyton, Jr., colored, at the last session of court, was convicted of contempt of court and given 30 days in jail. Incidentally, Peyton was given a jail sentence for buying stolen goods—a revolver.

General Intelligence Service To Supercede Agencies

Chicago, Feb. 9.—(AP)—A copy-righted dispatch to the Chicago Tribune today said President Roosevelt had received a draft of an order together with a proposal to establish a "central intelligence service" charged with coordination of postwar intelligence work and superseding existing federal police agencies.

The paper's Washington bureau, in an article by Walter Trohan, said the "highly confidential and secret memorandum was given Mr. Roosevelt by Brig. Gen. William J. Donovan, director of the office of strategic services. The office would have no police power.

The Tribune asserted it had "secured exclusively" a copy of the memorandum, and added: "The Tribune also obtained a copy of an equally secret suggested draft of an order setting up the general intelligence service, which would supercede all existing federal police and intelligence units, including military intelligence, naval intelligence, the Federal Bureau of Investigation, the secret service, the internal revenue agents, and the Federal Communications Commission which monitors all radio airways. The order gives the unit a wholesale grant of power."

Only 15 copies of the two documents were made, the paper declared, "each plastered with secrecy injunctions." These according to the story were sent to officials such as Admiral Leahy, the President's chief of staff, General Marshall, army chief of staff, Admiral King, chief of naval operations, Secretary of State Stettinius, Secretary of the Navy Forrestal, and Secretary of War Stimson.

The Tribune quoted the Donovan memorandum as saying: "Once our enemies are defeated the demand will be equally pressing for information that will aid us in solving the problems of peace.

"This will require two things: "1. That intelligence control be returned to the supervision of the President.

"2. The establishment of a central authority reporting directly to you (the President), with responsibility to frame intelligence objectives and to collect and coordinate the intelligence material required by the executive branch in planning and carrying out the national policy and strategy."

This would be "a permanent long-range plan," the Tribune quoted the memorandum, "but you may want to consider whether this (or part of it) should be done now, by executive or legislative action.

"The immediate revision and coordination of our present intelligence system would effect substantial economies and aid the more efficient and speedy termination of the war.

"Information important to the national defense being gathered now by certain departments and agencies, is not being used to full advantage in the war. Coordination at the strategy level would prevent waste and avoid the present confusion that leads to waste and unnecessary duplication."

Call For Adoption Of Military Service

Washington, Feb. 9.—(AP)—Disputing a contention of 12 fellow educators, 14 college heads today called for immediate consideration and adoption of universal military training.

They said in a letter to President Roosevelt, who has expressed him-

self as convinced of the necessity for postwar universal training; "If adopted now, we believe that a sound plan for universal military training will enable the United States to speak with greater authority at the peace table in favor of an international organization to enforce peace."

More Collections Received For Fund

In addition, the department has a thorough study of the whole officer detail here under way and all who are physically able and not doing specific jobs for which they are particularly fitted will be assigned to combat or training duty.

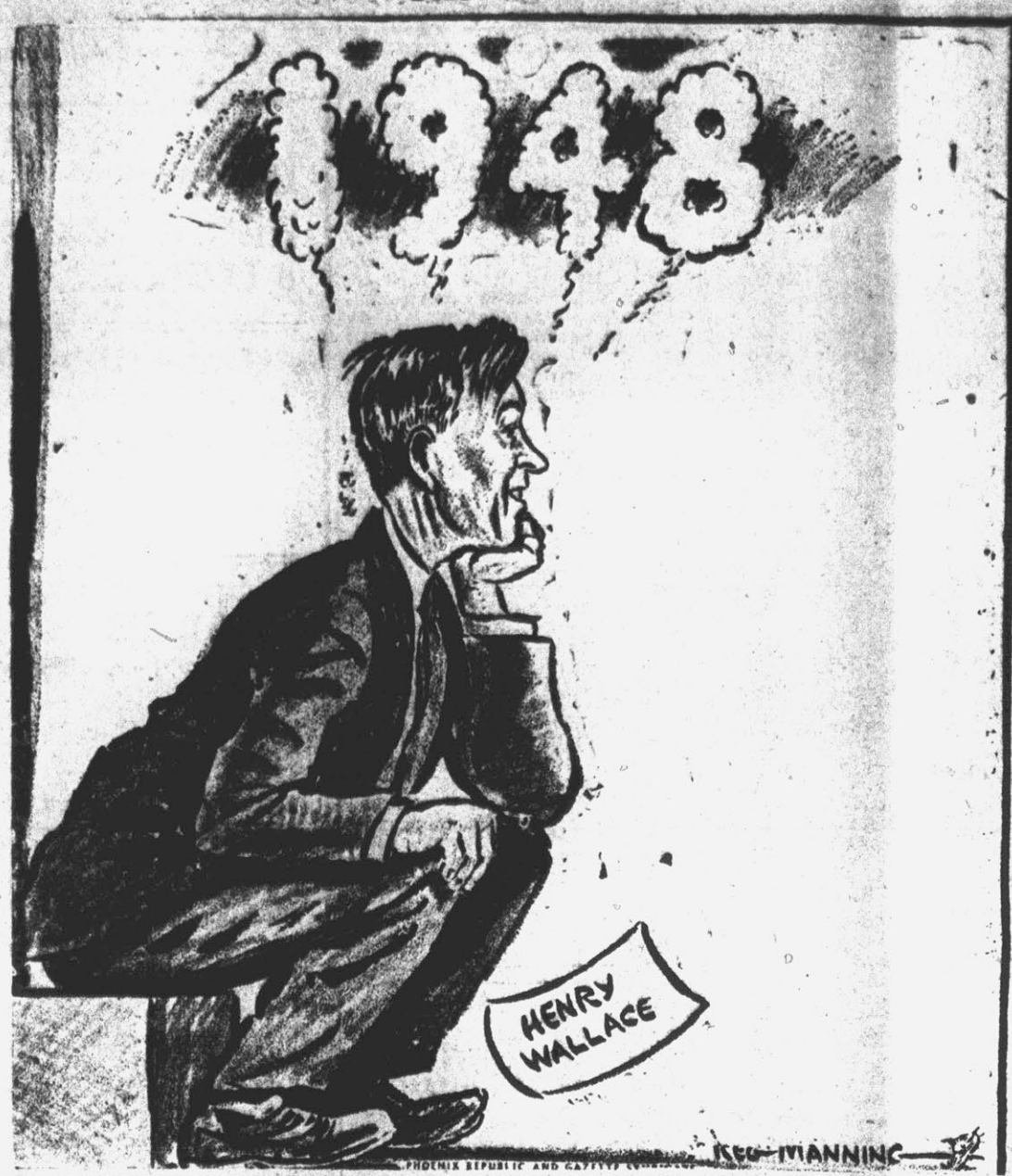
Rep. Jennings Randolph, rotund Democrat from West Virginia, has introduced a bill to establish a national university devoted entirely to training men and women for service in federal, state and local governments. It isn't the first time the idea has been broached but it is being given more attention now than ever before. Administration of the war and its many ramifications has brought home to the people generally the shortcomings of government employes more forcefully than at any time in recent decades.

Washington these days reminds local columnist Jerry Klutz of the story about the dying patriarch who roused from a coma and called his wife, five sons and two daughters. When each had answered and in turn assured the old man that they were by his side, he rose up in bed horrified, and stormed: "Then who's tending the store?"

That's about the way it has been around here lately. On Capitol Hill they tell about an administration senator dashing down to the White House to get a decision on some important legislation now in debate. He met a colleague coming out. The latter shook his head: "It's no use. The President 'can't be seen' (the censorship way of guarding his whereabouts.) Harry Hopkins is on his way from Rome to somewhere. Jimmy Byrnes is 'out of the country.' And even Secretary of State Stettinius is 'unavailable and will be for some days.'"

(Note: After careful check, it was determined that Vice President Harry Truman, Henry Wallace, Jesse Jones, Mrs. Roosevelt and Fala still were in town, but there wasn't any assurance that one or all might not depart any moment. And that still doesn't answer the question about who's running the

store.)

Under orders of the Office of Defense Transportation, conventions have dropped to their lowest level in years, but ODT privately reports that the applications for holding conventions are staggering. The latest large group to call off its annual convention was the National Tuberculosis Association, which had scheduled a June session of 1,700 delegates in Buffalo, N. Y., in June. But in the first few weeks after the order, ODT received 110 applications from groups who insisted their annual meetings were absolutely necessary. After investigation, ODT okayed two, turned down 108.

Interior Secretary Harold L. Ickes is in another row with Congress, but this one probably won't make headlines. Rep. Edward Hebert (D-La.) had introduced a bill to take Ickes' private police force away from him. He wants to merge the U. S. park police with the metropolitan police force. Ickes says his police force, which patrols the District of Columbia's miles of parks (15 per cent of the capital's total area) is more efficient than the District coppers.

Fact: Our lend-lease exports of cigarettes in 1944 required only about 1-1/4 per cent of our production during that period. No cigarettes have been supplied under lend-lease for civilians. For every cigarette lend-leased to Allied troops in 1944 we sent 26 to our armed forces abroad.

Fiction: The misconception that large quantities of beef are being lend-leased.  
Fact: Only 0.7 per cent of our total supply of beef and veal was exported under lend-lease in 1944.

25th divisions. Lupao's capture virtually completed the campaign to secure the left flank on Luzon.

Total enemy casualties for Luzon have been listed at more than 48,000.  
American planes poured another heavy bomb load on Corregidor fortress, at the entrance to Manila bay, starting large fires in defense positions. Two small freighters were sunk and two others damaged by U. S. bombers hitting off the Chinese coast. Borneo's airframe facilities and oil installations took an 82-ton bombing.

In Bataan, the 11th corps under Maj. Gen. Charles P. Hall was last reported probing southward along

the east coast of the peninsula after five days of some of the roughest fighting of the Pacific war. Yank forces have sealed off the base of the peninsula and are moving down for the cleanup.

minutely regarding more than 150 items from Dr. Meadows' "Memo Books." Where credit has been allowed he has been asked if, in regard to those items, he did not find the books correct, and where items were disallowed he has been questioned as to whether or not he exhausted every source of information before disallowing the items.

The replies of the witness followed the same pattern of admitting that certain items were correct and stating that failure of Dr. Meadows to furnish supporting documents or evidence had caused the disallowance of other items. Several of the disallowed items were those about which there has been previous testimony purporting to show that the expenditures were for work or materials on Dr. Meadows' private property.

Questioned at length yesterday afternoon about a group of items totaling more than \$3,000, said to have been paid to J. W. Clark for paving, paving materials and use of a concrete mixer, the witness testified that during the period covered

by the transactions shown in Dr. Meadows' books, Clark received several checks from the college for paying work and that there were no substantiating documents to Meadows' transactions to show that they did not cover all or part of the same ones for which Clark was paid by the college. He said that Clark had told him that on several occasions he had sold small quantities of materials to the college. The witness stated that he felt sure Dr. Meadows was due credit for at least some part of the payments claimed, but that there were no records upon which to base the calculations and therefore he had disallowed all the items.

## Oil Supplies Hit By Heavy Bombers

London, Feb. 9.—(AP)—Approximately 1,300 American heavy bombers escorted by more than 850 fighters, attacked German oil supplies and railways today, adding their weight to what may be a record 24-

hour assault. The main force attacked the synthetic oil plant at Lphtendorf, a few miles northeast of Leipzig. Other Flying Fortresses and Liberators hit armament and motor transport factories at Weimar in central Ger-

many, switching yards, burg and several other communications targets.

## Not Satisfied With Goldberg Testimony

Washington, Feb. 9.—(AP)—His curiosity unabated by Auctioneer Jacob Goldberg's dramatic testimony, Senator Mead (D-NY) sought further explanation today of the use of "big names" in soliciting government business.

The chairman of the senate war investigating committee instructed Goldberg to return next week with a complete answer as to how, Bernard M. Baruch's name found its way into letters from surplus liquidators, Inc., to RFC officials.

Richard E. Durham, a director of the company, testified last week that he had written defense plant corporation officials letters in which he said Baruch had authorized the use of his name in endorsing Goldberg as an auctioneer of surplus government property.

He did so, he said, under instructions from Herman Brandt, company secretary, and without any personal authority from Baruch, financier, and presidential adviser.

## Fail To Agree On Wallace Legislation

Washington, Feb. 9.—(AP)—Legislation designed to insure Henry A. Wallace's confirmation for a cabinet job was stymied in the House Rules Committee today after a noisy debate studded with charges of "horse trading."

The committee failed to reach a conclusion whether to send to the House floor the Senate passed George bill divorcing the RFC from the Commerce Department, prior to a Senate vote on Wallace's nomination as commerce secretary.

Rep. Cox (D-Ga.) rules member, declared there had been a "horse trade" between the Senate and the White House, whereby the Senate would not pass on confirmation of the former vice president until March 1.

Chairman Spence (D-Ky.) of the House Banking Committee, demanded that the rules group give the legislation clearance, bluntly asked the members "Are you going to scuttle the orderly procedures of the House?"

Tempers flared as Spence asked the rules members if they were "questioning the integrity" of his committee, which has approved the George measure.

Other bills introduced by them would clarify and bring up to date certain health laws, and authorize counties to levy taxes to carry out public health programs. Women could be recruited for the state guard under a measure by Rep. Caveness of Guilford. Guardsmen would be exempt from jury duty and the state guard would be made a permanent organization. The governor would be empowered to appoint one or more adjutants general to direct the guard.

Another Barker-Smith bill would allow marriages of persons cured of venereal diseases by quick treatment. Under the present law, a person found with venereal disease when applying for a marriage license must wait one year before applying. The measure today would make the law to conform to quick treatments.

(Continued From Page One) miles northeast of Berlin. Soviet infantrymen with tank support were battling hard to cut between Kuestrin and the Oder just to the west, but the Germans declared an encirclement of the fortress had been broken.

The push toward the big ship-building center of Stettin was on a 40-mile front and threatened to carve a 13,500-square mile area of Pomerania, the Polish Corridor and Danzig into a huge pocket in which 20 or 30 German divisions might be trapped.

The closest officially announced approach to Stettin (270,000) was at Sammenthino 18 miles southeast of Pyritz, where the Germans have reported fighting for several days.

The deepest drive toward the Baltic was at Reetz, northeast of Sammenthin and 18 miles east of Stargard, one of the chief points guarding the approaches of Stettin.

The Russians were 13 miles of the Stettin-Stargard-Danzig railway and in this sector were less than 60 miles from the Baltic.

The German radio said the fighting in Silesia in the "Breslau-Glogau-Liegnitz triangle has risen to the pitch of a truly gigantic battle."

The menace to the network of German industries in Saxony and the Suedetenland grew with Konev's steady advance toward the factory town of Strehlen, 21 miles south of Breslau, and Neisse, another manufacturing and railway center 44 miles south-southeast of Breslau.

To the southeast strong armored columns were steadily driving the Germans out of the last bit of southwestern Poland and were reported within 15 miles of Cieszyn (Teschen), gateway to Jablunka Pass.

of the Siegfried Line, was imminently menaced. The new attack front widened to seven miles. Formidable forest defenses in the Reichswald, considerably weakened by a terrific artillery and air bombardment, were being mopped up swiftly. Five German and two Dutch towns fell.

The American First Army 85 miles to the south advanced to within a mile of the vast Schwammenauel Dam, controlling flood waters on the Roer River barrier to the Ruhr and the Cologne Plain.

The Third Army advanced to within a mile of Preum and reached the Pruem River eight miles inside the Reich.

The French First Army broke the last German position south of Strasbourg and drew up to the upper Rhine banks on a 90-mile front from north of Strasbourg to Switzerland.

Like an avalanche which moves slowly at first, Gen. Eisenhower's offensive along the Western front was gathering power.

German broadcasts said the Can-

adians had breached Nazi lines in a large scale offensive. The weight of Allied attacks on other fronts also was said by Berlin to be increasing.
