Port of Stettin Being Shelled By Russian Artillery

Soviet Armies Making Drive To Outflank Port Of Berlin For Enveloping Move On Capitol From North; Reds Cut Deeper Into Pomeranian Territory

London, March 6—(AP)—Russian troops closing on Stettin have reached the Oder near Greifenhagen, 11 miles south of the port, a Moscow dispatch said today. The Germans declared the Soviets had thrust to within 13 miles of Stettin Bay and 35 of the U-boat base of Swinemunde. Red army artillery was shelling Stettin, the Port of Berlin at the Oder's mouth. The river divides into two main channels at Greifenhagen. The German high command said Marshal Gregory Zhukov's First White Russian army was wheeling westward on a 40-mile front from Stargard to Greifenberg, the latter town 14 miles from the Baltic coast and 17 northeast of captured Naugard. It said a Zhukov spearhead had been stopped northeast of Gollnow at a point 13 miles from Stettin Bay. Gollnow is northwest of Stargard and southwest of Naugard, both captured yesterday. The Berlin radio asserted Zhukov had massed five infantry and two tank armies on the central sector for a push westward on Berlin. Marshal Stalin announced tonight the capture of Grudziadz, encircled head-on between the Baltic corridor and the Vistula. Grudziadz is 55 miles south of Danzig. Grudziadz was cleared block by block by savage assaults of Marshal Konstantin Rokossovsky's Second White Russian army, and 5,000 prisoners were taken in the city, including the commander who had been ordered to hold at all costs, Stalin's order of the day said. Its fall cleared communications feeding troops striking toward Danzig. Moscow dispatches said Zhukov's First White Russian army was advancing steadily beyond Stargard, 19 miles east of Stettin, and Naugard, 22 miles north of Stargard. (Continued on Page Six)

YANKS WINDING UP TWO BATTLE

Jap Casualties Huge In Philippine Campaign

U. S. Pacific Fleet Headquarters, Guam, March 6—(AP)—The climactic blow in the savage 16-day battle for Iwo Jima, where more than 2,000 Marines have died while killing more than 12,000 Japanese, was poised today—grown in power by supplies pouring ashore on the east and west coasts. There were no appreciable changes in the lines yesterday as the Leathernecks, holding more than two-thirds of the eight square mile island, built up their positions for a grand scale assault on the rocky defense-studded north end. In Washington yesterday, Navy Secretary Forrestal disclosed on his return from a visit to Iwo that 2,000 Marines have been killed, adding the loss was not out of proportion to the importance of taking the island. It is needed to put American fighter planes and Liberator bombers within range of Japan. Forrestal gave no figures for wounded and missing. The last official figure supplied by Adm. Chester W. Nimitz covered casualties for the first three days. The figures included 644 killed, 4,168 wounded and 500 missing, although some of the missing are now being located. Both Forrestal and Nimitz have given the incomplete count of Japanese dead found inside American lines at more than 12,500. Other enemy dead are known to be buried under smashed pillboxes. Still others are behind the Japanese lines, a dwindling area which has been shelled by Fifth fleet warships, pounded by Marine artillery and bombed by planes.

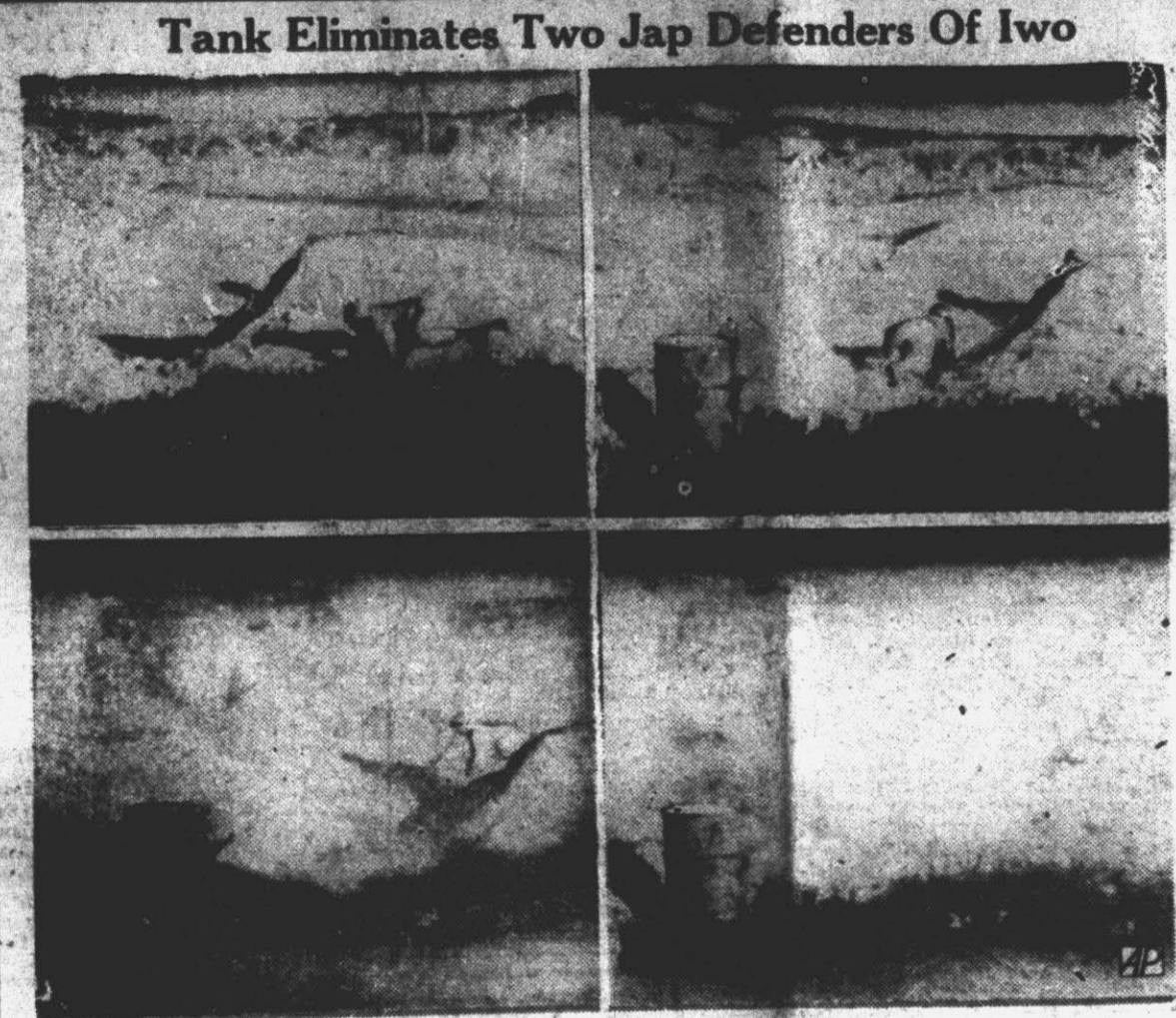

Roatta Escape Creates Crisis

Rome, March 6—(AP)—A civilian was killed, another was injured, and a British soldier was wounded when Romans waving red flags attempted to attack the royal palace today while Crown Prince Umberto was inside. Two bombs were thrown and shots were fired in the clash between mounted carabinieri and the crowd near the entrance to Quirinal palace in the midst of an Italian political crisis generated by the escape of an Italian general accused of war crimes. Umberto, who as lieutenant general of the realm, has taken over the duties of King Vittorio Emanuele, failed to appear during or after the disturbance, in which the demonstrators shouted "Death to the King." A political crisis loomed in the wake of Roatta's escape. Demands for the reorganization of the government may topple the cabinet of Premier Ivanoe Bonomi and clear the way for the premier-ship for Count Carlo Sforza. Vetoed by the British as foreign minister in the present government several weeks ago, Sforza was expected to make a strong bid in the event Bonomi's government fell. Columns of Carabinieri patrolled the streets, guarded government buildings and the royal palace. Work was suspended in all but most essential industries for a mass protest meeting. The demonstration was sponsored by Socialists, Communists and opposition groups.

FRANCE MAY ASSUME LEAD

Country Plans Western European Bloc At Conference

London, March 6—(AP)—Diplomats expressed the belief today that France was preparing to take the lead at the San Francisco world security conference on behalf of greater power for the small nations in the projected international setup. France made it clear in declining an invitation to become a conference sponsor that she would propose amendments to the Dumbarton Oaks blueprint for world peace regarding alliances and voting procedure agreed upon by the big three at Yalta. The same position, in even more outspoken form, was taken today by the Royal Netherlands government. A spokesman said the feeling in Dutch official circles was that the small nations would have considerable reluctance "to sign a pact under which any nation, however great, could have a position making it legally a judge in its own cause." Voting Procedure May Aid U. S. Participation

Washington, March 6—(AP)—Republican and Democratic senators said today the big three agreement on international voting procedure may help smooth the path to American participation in a world peace-keeping organization. Most legislators apparently regarded as a practical—if not perfect—solution for a difficult problem the proposal giving any of the five biggest members of a projected world security organization, the right to veto the use of force against an accused aggressor. There was a tinge of disappointment in some quarters, but it was more than offset by prompt contentions that if the San Francisco conference accepts this agreement the chances of senate approval will be brighter. Senator George (D-Ga.), ranking Democratic member of the Foreign Relations Committee, told a reporter he thinks the American people will be better satisfied about joining a world league if they know the United States must agree before its military forces can be ordered into action against any other country.

MEADOWS CASE STILL GOES ON

State Offering Rebuttal Testimony Today

Meadows was endeavoring to show that state funds were available for repairs and improvements at East Carolina Teachers College during the period that Meadows was president of the institution. The testimony was in rebuttal to Dr. Meadows' testimony that it was necessary for him to spend special funds for these purposes because sufficient state funds were not available. Robert G. Deyton, assistant director of North Carolina Bureau of Motor Vehicle Inspection, occupied the witness stand throughout the morning and was in the midst of his testimony when court recessed for lunch. The examination of Deyton will probably require all of the afternoon session. Following Deyton the state has a number of other witnesses to offer indicating that it may be late tomorrow or Thursday before the presentation of evidence is ended. Bayard Clark (D-NC) of Fayetteville, who will be 63 April 5, is being mentioned prominently, this source disclosed. Senators Bailey (D-NC) and Hoey (D-NC) are expected to confer with Attorney General Biddle this week about the age factor before submitting their recommendations to the judgeship appointment. Rep. HOUSE PASSES REVENUE BILL

Measure Introduced To Curb Hasty Marriages

Raleigh, March 6—(AP)—The House unanimously passed today the \$129,000,000 Revenue Bill, which had been amended to raise the tax on pure, fermented wines to 50 cents and the tax on synthetic or imitation wines to \$1.20. Rep. John Kerr of Warren, Finance chairman, advocated the new wine amendment, sponsored by Rep. Moore of Wilson. He called it a "compromise" and said that it probably would pass the Senate without opposition. Thus the Assembly, which for the last few days had reached a highly controversial issue that was expected to delay adjournment indefinitely, solved the problem, and floor leaders predicted that adjournment might come by March 19. The first wine amendment, which set the Finance bill back on first reading last week already had been blamed with delaying adjournment by several days. The amendment, in effect, would raise to \$1.20 a gallon the tax on synthetic, or imitation, wines, and raise to 50 cents the total tax on pure wines. The amendment was not ruled material, since it is a tax reduction, the House already having adopted an amendment to increase by \$1 a gallon the tax on all wines. Therefore, the bill will not have to go back on first reading. Rep. Currie of Camden introduced a bill to provide elections in Southern Pines and Pinehurst on the question of alcoholic beverage control stores in those resorts. Reps. Crissman and Caviness sent up a bill to allow juries to recommend mercy in convicting a person of rape. Juries already may recommend mercy in first degree burglary and arson. Reps. Burgess of Camden and Peeler of Washington introduced a bill aimed at hasty marriages—to force registrars of deeds to wait five days before issuing a marriage license. The application must be on file that long and should a registrar violate the law, he could be fined \$200. Rep. Ciffin of Martin sent up a bill to give state highway patrolmen full police power off the highways, and Rep. Bridger of Bladen introduced a bill to outlaw hunting on Sundays. Violation of Bridger's proposed law would carry a penalty of a \$50 fine or 30 days imprisonment. Senator Hampton of Washington sent up three bills. One would petition Congress to postpone for 10 years the time the National Park Service could take over the Cape Hatteras National Seashore Park, and to authorize the North Carolina Cape Hatteras Seashore Commission to accept land within the area of the park. Surprisingly Light Opposition Encountered In Drive To Take Industrial Center; Churchill Tells Men 'One Strong Heaven Will Do The Job'

With U. S. First Army, March 6—(AP)—The fall of Cologne was officially announced tonight. By JAMES M. LONG Paris, March 6—(AP)—American troops fought through Cologne to the Rhine tonight, and in the south the U. S. Third Army spurred 25 miles toward the Rhine in the Coblenz area. American First Army tanks and troops fought past the famous Dom Cathedral in Cologne, Germany's fourth city, and a front dispatch declared "Cologne for all military purposes has fallen." Germans retreated south from Cologne along a corridor to Bonn. The Third Army tanks broke out of their Kyll River bridgehead farther south yesterday morning and raced 25 miles, or more than halfway the distance to the Rhine. They were meeting "only medium resistance" in the push to the river in this sector. More than 1,500 Germans including a corps commander were captured. American troops had driven to the Rhine all along a line north of Cologne except for a bend in the river south of Dusseldorf, and captured the Ford motor plant just north of the city. In Cologne, greatest prize yet taken in Germany by the Western Allies, only a hint of resistance was left in the main part of the city. Infantry and armored columns were driving against it. By mid-morning today, the First Army had won one-third of Cologne, and then smashed on through. Three divisions, the Third armored, Eighth and 104th infantry—reached the Ringstrasse against surprisingly light opposition. The mans fought in what once was the rail section of Cologne, by far the greatest traffic center in West Germany. (Continued on Page Four)

DEWEY SIGNS LABOR BILL

N. Y. Legislature Enacts Discrimination Law

Alderman, N. Y., March 6—(AP)—A law by which New York employers willfully exercising religious or racial prejudice in selecting workers face fines and imprisonment will go on the statute books after early signature by Governor Thomas E. Dewey. Legislative action on what both supporters and opponents termed "the most drastic measure ever enacted in the United States" was completed last night when the senate voted the bill, 49 to 6. The assembly approved the proposal last week, 109-32. Dewey, 1944 Republican presidential nominee, threw his support behind the bill which was passed with unanimous minority Democratic support in both houses. Individual Republicans strongly opposed the proposal, although G. O. P. leaders were favorable. Follow-up senate action, Dewey termed passage "an historic step." Today On The Home Front

Washington, March 6—(AP)—Let us get to thinking how bright we are, here's something to chew on. It was put together by the U. S. Chamber of Commerce to show the connection between education and economic well-being. The moral is: The better schooled we are, the better we live. Says the Chamber: "Education is a challenge to American business (because) it is an essential instrument in the expansion of our dynamic economy." The Chamber suggests that educators and business men get together to "talk things over." Here goes with the Chamber's findings: An average of about 60 per cent of the grown-up in this country have an 8th grade education or less. Only 10 per cent have gone to college or beyond. The two main factors pulling down the average: the low level of negro education in the south and many older foreign-born people, particularly in the northeastern states. Only about 4,222,000 native born white people have had less than 5 years of schooling. This is 7.4 per cent. But among the entire negro population the percentage having less than 5 years of schooling averages 41.3. School attendance: Twenty-five states had 50 per cent or more of their 14-18-year-olds enrolled in public or private schools in 1940. (That figure shows the normal situation before we got into the war.) The highest records of attendance in 1940—those above 60 per cent—were made by Washington, Utah and Nevada. These were followed closely by California, New York, Kansas, Wyoming and Nebraska, with percentages between 57 and 51-2. The lower records of attendance generally are found throughout the Southern states, Mississippi with 27 per cent and Alabama with 28 per cent. And, of course, the low attendance in the South is more pronounced among the negroes than among the whites. Salaries of teachers: The Chamber says "The range in average salaries for 1940, between \$2,604 per year in New York and \$550 per year in Mississippi, would indicate that equal educational opportunity does not exist among the states." "Crushing living costs are not comparable, it is possible to secure the same quality of teacher at 21 per cent of the other's cost. Fourteen states paid an average salary of less than \$1,000 per year in 1940." The Chamber made a breakdown along educational and economic lines and found that: (Continued on Page Four)

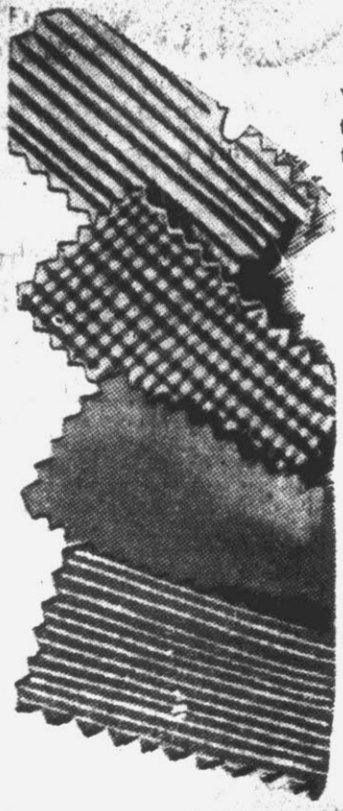

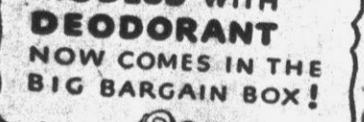

AMERICA IN WARTIME

By JACK STINNETT

Washington—Capitol Hill observers are convinced there's much more than meets the eye to that exchange of hard words and a few fistfuls on the House floor the other day between Reps. John E. Rankin (D-Miss.) and Frank E. Hooks (D-Mich.).

There have been fights on the floors of both the House and Senate before. Tempers, rubbed raw by bitter political recriminations have burst out in ink-well throwing and—in earlier days—challenges to duels.

Depending on your point of view, you may consider this latest ruckus as a regrettably undignified public exhibition, or you may laughingly tuck it away in memory as the day when the "Tupelo Terror" and "Fearless Frank" chose to get rough for benefit of the House galleries.

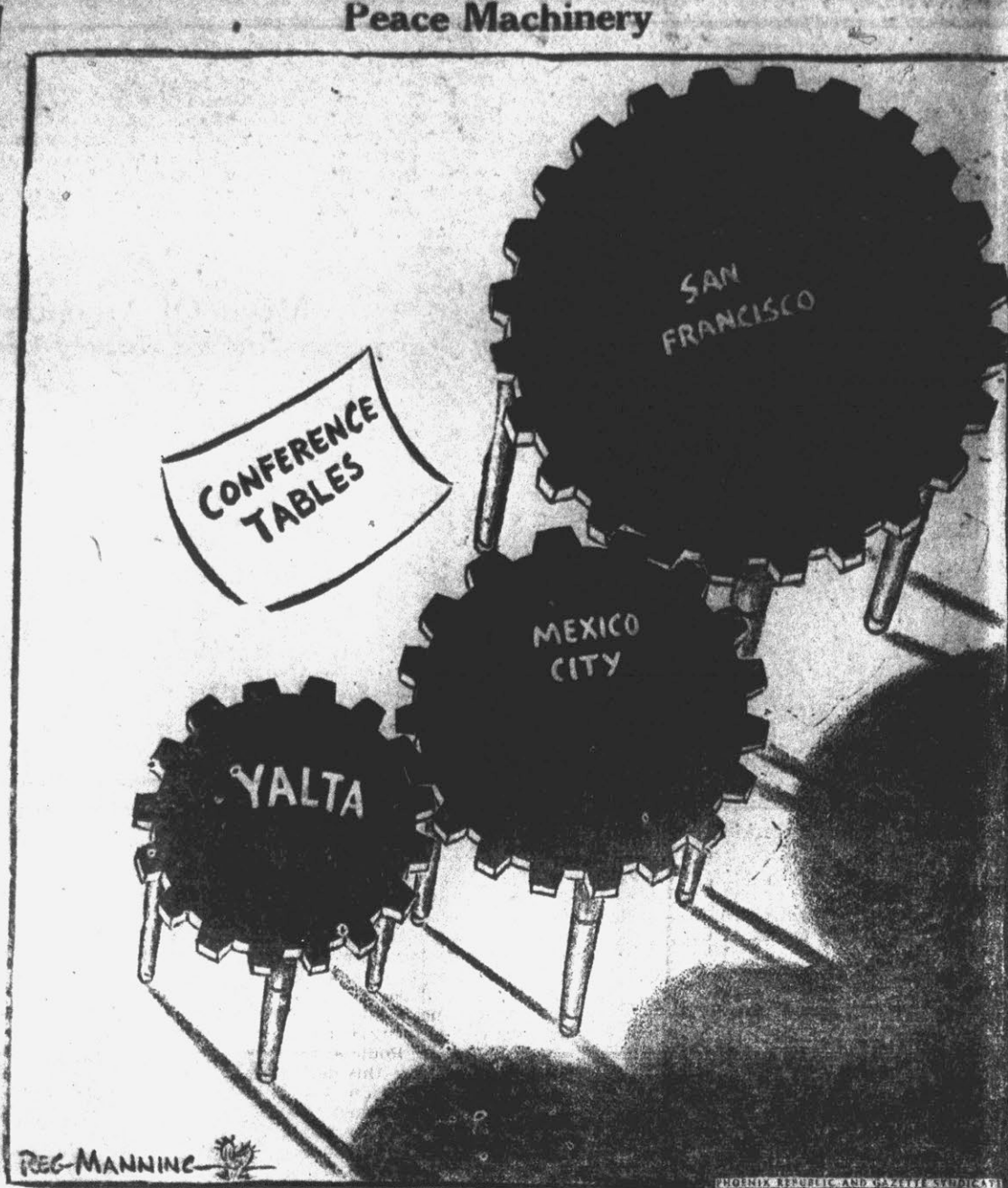
Serious-minded observers on the Hill see in it a symbol of the ever greater widening of the breach between the conservative and left-wing branches of the Democratic party. The result can only spell greater trouble ahead for the administration.

With the defeat in the last election of a number of the ultra-conservatives, isolationists, and organized labor foes, the administration had every reason to believe that the troublesome days ahead as it worked toward world peace and homefront reconversion would find Congress more cooperative.

But Congress is in more open rebellion today than at any time since the tax rebellion of nearly a year ago, when Majority Leader Sen. Alben Barkley broke with the President over his veto of the 1944 tax bill. That brush was smoothed out.

For the first time since Coolidge days, Congress has challenged the Presidential appointment of a cabinet member. The case of the confirmation of Henry A. Wallace as secretary of commerce has forced the administration to compromise. In passing the George Bill, to take great lending agencies out of Commerce, the House had a hand in the revolt and it was only by a narrow squeak that the administration in that chamber prevented killing of the appointment of Wallace.

Similarly, the appointment of Aubrey Williams as chief of the Rural Electrification Administration came under coalition fire and so did elevation of Col. Elliott Roosevelt to brigadier general, although opposition centered primarily around the



fact that Elliott's dog travelled on an airplane A-priority, with never any serious question raised about his ability as an air reconnaissance officer.

While the Republicans aren't all of one mind, there are enough of them generally opposed to the administration to make the added vote of the anti-administration (mostly southern) Democrats a serious matter for any administration-backed legislation.

The Hook-Rankin battle was a clear demonstration of just how far apart these factions in the Democratic party are. Hook, often a spokesman for organized labor and defender of the Political Action Committee of the CIO, represents the liberal wing. Rankin, revivifier of the Dies committee and one of the most outspoken opponents of the administration, represents the southern ultra-conservatives.

The day after the clash on the floor both combatants apologized, but they weren't "kiss-and-make-up" apologies. Hook contended he hadn't used the language he had been accused of using; Rankin insisted that he had gone "only what any gentleman would do under the circumstances." The bitter, stormy days in Congress aren't over by any means.

"No one is going to be able to say that we will be giving a delegate the power to declare war," Ball went on, "because it is obvious that under this agreement force will never be used against a major power because that power could veto it."

The Germans won't know—and most certainly we stay-at-homes won't know—when or where the crossings are to be attempted until General Ike suddenly rushes his equipment and troops to the chosen spots and makes whirlwind preparations for the assault. It's a fair guess, however, that he will make crossings in several places. While he might essay this new drive very soon, the signs are that he will make a considerable pause to get fully set.

Supreme headquarters announce that the Allies are making "good progress" in knocking out enemy bridgeheads west of the Rhine. The battle for the great Prussian city of Cologne—arrogant symbol of German militarism—seems to be about finished through lack of Nazi resistance.

This is a pleasant surprise, for the Hitlerites had been expected to put up a stiff fight to hold this prize, both for its moral effect and to protect the huge Hohenzollern bridge across the Rhine. Rundstedt could have made a strong stand there if he had so elected, for I know from having wandered many a time through the narrow and crooked streets of the old city that infantry could put up a good defense there. However, it's reported that only about a thousand German troops have been left in the city, and Rundstedt has blown the Hohenzollern bridge, indicating that the big portion of Cologne on the west bank isn't to be defended in strength.
Loss of such bridges, by the way, won't prevent the Allies from getting across. They will depend on pontoons and those amazing amphibian machines which are equally at home on land or in water. What

our state has led the entire nation in this great social advance which will assure equality of opportunity for all our people, regardless of race, creed, color, or national origin.

Although the new law is directed equally against labor unions, employment agencies, and employers, and makes violation a misdemeanor punishable by a \$500 fine and a year imprisonment, most debate concerned its application to employers. Individuals or firms employing fewer than six persons are exempt, as are religious, charitable, social, and fraternal organizations.

The law will be enforced by a five-member commission, which will be empowered to order hearings upon complaint of any person considering himself discriminated against. If mediation fails, a "cease and desist" order may be issued. This may be followed by judicial review upon filing of misdemeanor charges.

Debate in both legislative houses followed the same general pattern. Opponents all said they opposed discrimination, but asserted that "goodness cannot be legislated," that education held the key to the problem, and that enactment of the law would intensify religious and racial prejudices, by emphasizing them.
Supporters, including Irving M. Ives, assembly Republican leader, who with Elmer F. Quinn, Democratic senate leader, sponsored the bill, called it a "noble experiment" which would safeguard constitutional rights of all citizens if properly and honestly enforced.

Well Known Stokes Citizen Died Today

R. O. Conleton, 68, well-known citizen of Stokes, died at his home Tuesday morning at 7:40 o'clock following a long illness.

Funeral services will be held at the home at 3 o'clock Wednesday afternoon by Dr. Robert S. Boyd, Presbyterian minister of Greenville. Burial will be in the family cemetery.

Mr. Conleton spent all of his life in the Stokes community. He first married Miss Bennie Moore, who died in 1920. Surviving this union are a son, Pvt. Harry B. Conleton, U. S. army, stationed at McGuire General Hospital, Richmond, Va., and a daughter, Mrs. John Taylor Barnhill of Greenville.

He later married Miss Florence Lamb of Sampson county, who with a daughter, Miss Frances Lamb Conleton, a student at East Carolina Teachers College, survives him.
Mr. Conleton was a member of one of the oldest families of Pitt county.

To the north, Lt. Gen. William H. Simpson's Ninth army wiped out all but one small pocket on the Rhine south of the Duesseldorf suburb of Neuss and drove, with the Canadians, into the Wesel pocket farther down the Rhine.

Prime Minister Churchill told British troops on a visit to the northern front that "one strong wave will win the war."
Beyond the Kyll River on the approaches to Coblenz, Lt. Gen. George S. Patton's Third army was declared by the German communiqué to have made a deep breach in

Nazi lines northeast of Kyllburg. Patton's movements were largely blacked out—similar to the secrecy prevailing during the great Rhine-land breakthrough. His nearest reported distance from Coblenz was 44 miles.

Tanks and infantry rolled through the great industrial area in the north and western sections of Germany's fourth largest city, and shelled the railroad marshalling yards, among the biggest in the Reich.

The fall of Cologne was expected hourly.
The German communiqué said that south of Cologne Lt. Gen. George S. Patton's "blacked out" Third army had achieved a deep breach in German lines guarding the middle Rhine and Coblenz in the area northeast of Kyllburg in the Kyll. At last reports, the Americans were 44 miles from Coblenz and pushing beyond the Kyll River, last great natural barrier, from two bridgeheads four and five miles wide and three deep.

Between these erupting fronts, the Americans First army pushed to within seven miles of Bonn.

To the north, the foe was feverishly strengthening fortifications east of the Rhine and mustering troops to man them.
Nazi demolition squads, trying desperately to guard the rich industrial Ruhr left the Rhine bridgeless along the twisting 70-mile stretch from Bonn to Wesel.

The Americans held the whole west bank of the Rhine from Cologne all the way north to Rheinberg, five miles south of Wesel, except for a tiny pocket in the river-bend two miles north of Homberg and a six-mile stretch from two to three miles deep from south of Neuss to Worringen.

Kiwanis Calls Off Annual Convention

Governor Gregg Chery has requested the North Carolina Office of Civilian Defense to recruit in this state 105 WAC technicians for service in southern hospitals. These women are desperately needed to care for wounded soldiers, sailors and marines. The wounded are coming back from the war theaters at the rate of 1,000 a day and women are needed in the WACs to care for them.

Ordinarily a nurse can handle 15 beds, but if a nurse can give one of these WAC medical assistants she can handle 25 beds of wounded servicemen. To join the Woman's Army Corps a woman must be 23 years old and not over 45. She must have had at least two years in high school and be able to pass certain mental and physical tests. After enlisting in the WAC a woman is given 12 weeks of intensive training. She is then assigned to a hospital of her own choice in one of the southern states with the rating and pay of a corporal.

Mayor Bruce Sugg of Greenville today expressed the hope that some of our Greenville and Pitt county women will enlist in the WAC.

Strikers Remain Idle In Detroit

Detroit, March 6—(AP)—Approximately 13,000 Detroit area war plant workers remained idle today as workers in six Briggs Manufacturing Company plants refused to end their strike and employes in five factories of Gar Wood Industries, Inc., left their jobs.

The Briggs strike, which followed the discharge of a group of workers whom the company accused of leading earlier strikes, entered its fifth day. The Gar Wood stoppage, involving 2,000 employes, followed a change in shift hours from six eight-hour days weekly to five 10-hour days. A spokesman for local 250, United Automobile Workers (CIO), said the new hours would make transportation more difficult.

Officers of local 212, UAW-CIO, representing the 11,000 Briggs strikers, reiterated today a demand for "unconditional reinstatement of 12 discharged employes" as a condition to ending their strike.

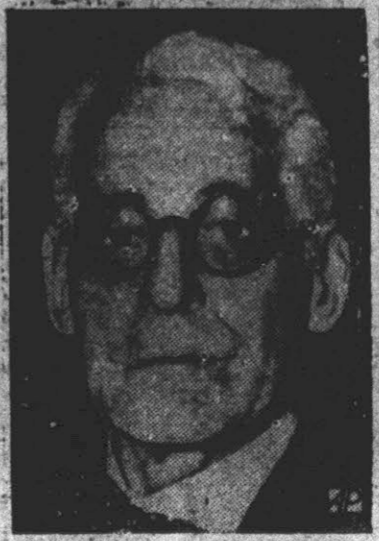

ed sufficient funds for the projects and that unexpended balances had been returned to the state.

When Deyton concludes his testimony the state is expected to offer a number of witnesses with testimony regarding paving projects at the college and the necessary amount of materials for the same. This line of testimony was started yesterday afternoon but was halted pending arrival of other witnesses, in order that all testimony on the subject might be presented together.

Other rebuttal witnesses yesterday afternoon included W. L. Baldree who testified that a college check for \$45.83 had been endorsed by him and turned over to Dr. Meadows as repayment for a check of the same amount advanced to him by Meadows. Dr. Meadows had testified that the personal check given Baldree was in payment for vacation time and had nothing to do with the college check. The item had been charged to the college in Meadows' memo book.

E. L. Baker testified that on the

day before the meeting of the college trustees here last spring Dr. Meadows had asked him to give him (Meadows) a letter of recommendation and that he had declined to do so. Objection by defense counsel prevented him from stating why he would not give the letter. Baker also denied Meadows' testimony that he had asked Meadows to pay for the cement transactions in cash instead of by college check.

C. E. Jones, former crew foreman for Civil Works Administration testified that in January, February and March 1934 he and his men did considerable work on the college campus including placing of shrubbery, paving sidewalks and installing curb and gutter along both sides of most of the college drive-ways. "The defense had presented testimony purporting to show that all such improvements at the college had been brought about after Dr. Meadows became president of the institution.

W. W. Aycock, manager of Carolina Telephone and Telegraph Company, was shown receipts issued by J. W. Tyndall, dated in 1937, and testified that the dial telephone numbers shown on the bill heads were not assigned until January 1939 and that the dial system was not put into operation here until July 1939. These receipts had previously been presented into evidence by the defense and the state had challenged them on the ground that they had been issued at least two years after the transactions they purported to represent.

and tightening his flank on the Baltic coast in preparation for a new push on Berlin.

The Germans also reported local

breaches by the second white Russian army pushing up the Polish Corridor farther east toward Gdynia and Danzig.

Zhukov already had turned heavy guns, some recently taken from the enemy, on the eastern suburbs of Stettin.

As Zhukov thus set for a knockout blow against Stettin, capture of which would be a strategic prize, Marshal K. K. Rokossovsky's Second White Russian army to the northeast slashed deeper into the coastal strip of Pomerania between Danzig and Koeshin.

The battle for Stettin seemed virtually under way, although Zhukov's hardest blows at the moment apparently were directed toward Gollnow and Cammin, on the last main road and railway to the seacoast east of the Oder.

The sprawling factories of Stettin, Berlin's port, are spread out on both sides of the Oder at the southwest corner of Dammacher lake. Gollnow is located northeast of this body of water. Cammin is only three miles from the Baltic on the eastern arm of the Oder estuary.

East of Cammin the big seaboard towns of Treptow and Kibitz faced the prospect of immediate isolation as the Russians struck swiftly ahead. (Berlin said Kolberg already was being stormed).

Field dispatches said German counterattacks organized in the Stettin area with Volksturm infantry and a smattering of veteran armored units were on an unimpressive scale.

Zhukov's troops struck out for Altdamm, east bank Oder river suburb of Stettin, after capturing Stargard in a street battle that was officially declared to have cost the Germans 4,000 killed.
