British Intervene In Syrian Dispute

Eden Tells Commons Prime Minister Churchill Had Called Upon Gen. De Gaulle To Withdraw French Troops To Their Barracks To Prevent Further Bloodshed

By ALEX H. SINGLETON London, May 31 (AP)—Prime Minister Churchill called upon Gen. De Gaulle today to withdraw French troops in Syria to their barracks. Britain has instructed her armed forces in the Middle East to intervene in the fighting between French and Syrian forces to prevent further bloodshed, Churchill said.

De Gaulle called key ministers into session in Paris immediately after he received Churchill's demand. Paris dispatches said the French government was surprised at the London announcement.

In Washington, the State Department disclosed the United States last Monday had urged France to review her policy toward Syria and neighboring Lebanon.

Fighting which has taken at least 30 lives continued in Damascus, and two huge fires swept sections of the city.

Britain, with France, promised the Levant states their independence after Britain and French forces eliminated Vichy control there.

In order to avoid a collision between British and French forces, request was made for French troops to cease fire and to withdraw to their barracks, the Prime Minister told De Gaulle. British forces have been in Syria since 1941 when they and the Free French knocked out German control.

The action was announced in Commons by Foreign Secretary Anthony Eden following the third emergency session of the British cabinet within 24 hours.

Once firing has ceased and order has been restored we shall be prepared to begin tri-partite discussion here in London, the message to De Gaulle continued.

The British minister in Damascus reported the situation had deteriorated further in the Syrian capital. Eden said, with heavy firing and shelling during the night. Two large fires were reported spreading.

We have not acted until our over-all responsibility was so serious that we simply had to act or stand by and see a situation develop which would have shamed us all, Eden told Commons.

The British foreign secretary spoke after a responsible spokesman in Paris had declared that a direct collision between Britain and France was possible as the result of the (Continued on Page Six)

REVISION OF POINT VALUES

Tomatoes And Spinach Go Up, Some Items Lowered

Washington, May 31 (AP)—Point values on canned tomatoes and spinach will be higher beginning Sunday. However, the ration cost of tomato juice and vegetable juice combinations will be trimmed. The OPA announced this today along with other red point food values for the new ration period which runs from Sunday through June 30.

The blue point revision boosts the value on No. 2 cans of tomatoes to 40 points, up 10, while a can of spinach of the same size will require 20 instead of 10 points. Spinach in No. 2 1/2 cans also will be up 10 points to 30.

Ten points will buy two cans of tomato juice or vegetable juice combinations in containers through size 2 1/2. But the current value of 10 points per can will continue for single purchases. In 46-ounce containers both kinds of juice will have a value of 10 points, down from 20. The changes in meat values, disclosed last night, are confined to upward adjustments for a few fat cuts of pork. This, OPA said, was necessary to prevent housewives diverting them to lard.

Fat backs and plate bacon go from five to eight points a pound, while dry-cured and aged bacon sides go up a point to nine. Regular bacon remains at eight points a pound.

The only other red point change is a reduction from eight to six points a pound for soft cheeses, such as limburger, camembert and leicester.

Price Administrator Chester Bowles estimated meat supplies available for civilians in June will be about seven per cent less than this month.

Ambassador To Peru Washington, May 31 (AP)—William D. Pawley, 48, of Miami, Fla., an aviation pioneer in China, Cuba and India, was nominated by President Truman today to be ambassador to Peru. This is his first diplomatic appointment.

Committees Will Hear Appointees

Washington, May 31 (AP)—Two cabinet appointees have dates today with Senate committees expected to speed their names to the Senate for confirmation.

The Judiciary Committee called Assistant Attorney General Tom C. Clark of Texas to a hearing on his nomination to succeed Attorney General Francis Biddle.

Rep. Clinton P. Anderson of New Mexico had an invitation from the Agriculture Committee considering his selection to be Secretary of Agriculture.

Both men are expected to win hearty endorsement, but opposition has developed against the nomination of Claude Wickard, present Secretary of Agriculture, to be Administrator of the Rural Electrification Administration.

Senator Shipstead (R-Minn) has served notice he will fight the Wickard appointment, but other Agriculture Committee members said Wickard, as well as Anderson, will be approved and confirmed.

A favorable Labor Committee report on the nomination of Federal Judge Lewis B. Schwelbenbach of Washington to become Secretary of Labor succeeding Frances Perkins was filed with the Senate Monday. He may win final confirmation today.

Syrian Dispute Tests United Nation's Faith

Delegates Apprehensive Over Ability Of Big Powers To Keep World On Friendly Basis

By JOHN M. HIGHTOWER AP Diplomatic News Editor San Francisco, May 31 (AP)—Bloody fighting in Syria put to its severest test today the good neighbor policy on which the United Nations are seeking to erect a new world league to keep peace.

Topping off Iran's demand for withdrawal of Allied troops and the prolonged Big-Three dispute over Poland, the outbreak in the Levant aroused new apprehensions of many delegations here over the ability of the big powers to work out their world interests in a friendly and unselfish manner.

American officials, however, are telling these small nation representatives that had the projected world organization already been in existence problems such as the Levant crisis, especially, probably would have been more easily and speedily solved.

Secretary of State Stettinius threw his influence against letting any current issues interfere with the work of the conference. Officials appeared confident that he would succeed and the league charter would be produced early in June.

Stettinius was drawn directly into the Levant situation when a group of Arab delegates protested to him against French policy in Syria and Lebanon. The shooting started after Senegalese reinforcements arrived in the former French mandates and the two countries claimed a threat to their recently won independence.

Woolard Urges Bond Purchases

In view of the fact that only orders for E War Bonds are tabulated before June 1, indications are, from orders reported during the last few days, that the Region 1's overall quota will be oversubscribed as usual, the banker stated.

It may be added that the overall quotas for the previous six War Loan drives were over \$35,000,000 and that the total sales were over \$45,000,000. Counting the totals of all E bond sales, Region 1 has sold all quotas to date.

It has been called to our attention, however, that the sales of E bonds since April 1, which will apply on the Seventh War Loan drive, are lagging. It is hoped, however, that the people will rally to the support of War Bond sales during the month of June and show our boys who are fighting the Japs in the Pacific that we are behind them 100 per cent, Mr. Woolard said.

PRESS INVITED TO MEETINGS

Agriculture Board Wants Public To Get News

Raleigh, May 31 (AP)—The State Board of Agriculture, through its public relations office, today gave a special invitation to reporters to attend its sessions today and tomorrow.

This statement was issued: "The State Board of Agriculture will be in session today and tomorrow, and any and all news reporters who want to 'pop in and pop out' of the meeting should feel free to do so. The work of the board will not be hampered in the least. Rather, the presence of reporters at the meeting should give board members the feeling that the public is sitting with them in their deliberations and thus lend strength to policies adopted by them.

"Although the door to the board room may be closed during the meeting, it is figuratively open at all times to the press."

The statement was in direct contradiction to an announced policy of the State Highway and Public Works Commission which has adopted a "closed-door" policy, handing out its own press releases after the meeting. Chairman A. H. Graham said such a policy would prevent reporters from "popping in and out" of meetings, and thus disturbing the commission.

Three new members of the agriculture board were sworn in today. They are Claude Hall of Wayne county, Reeves Nolan of Person county, and Hawley Poole of West End. The oath was administered by Associate Justice A. F. Sewell of the State Supreme Court.

Six Killed By Balloon Bomb

Washington, May 31 (AP)—Undersecretary of War Patterson disclosed today that a woman and five children were killed by a bomb from one of the long-range Japanese balloons sporadically attacking the western part of this country.

Asked if he had any further information on the balloons, Patterson said he cited the incident of the woman and children to emphasize the need for precautions.

He said the six were killed in a western state, but gave no names or other details except that the tragedy occurred during a fishing trip when one of the children began playing with an unexploded bomb dropped by one of the unmanned paper balloons. The woman's husband and one child, Patterson said, were the only survivors.

The army previously had reported that no property damage has resulted from the balloon raids.

Will Investigate Army Discharges

Washington, May 31 (AP)—The House Military Committee called today for an Army explanation of some of its courts martial sentences and discharges.

Rep. Thomason (D-Tex.) ranking majority member, said representatives of the adjutant general's office have been asked to appear tomorrow.

Asserting that some soldiers and airmen have been given "discharges without honor" apparently after suffering nerve exhaustion from combat experiences, Thomason said he wants a "complete explanation" of War Department policies in such matters.

He cited the case of one Texan whose discharge as a psychoneurotic he said, appeared unjust. The man is a lawyer and served overseas, said Thomason, adding that with "such a stigma on his discharge he will be handicapped for life."

Sections of the G. I. Bill of Rights provide for a board of review to consider such cases. Explaining that many veterans' benefits are given only to those with honorable discharges, Thomason said he wanted to hear how the review board is functioning.

Kai-Shek Resigns As Prime Minister China

Appointment Of Soong Seen As Move Toward Greater Chinese Unity

By SPENCER MOON Chungking, May 31 (AP)—Chiang Kai-Shek resigned today as Premier and turned the post over to acting Premier T. V. Soong in a move viewed as a step toward solidifying China at a time when the Allied nations are applying tremendous pressure on Japan from all quarters.

Chiang retained his post as president of China and head of the state. He also remains China's generalissimo, and now will be able to concentrate fully on military tasks in this critical period of the war on the continent of Asia.

When Soong, Chiang's brother-in-law, became acting premier last December, the shift was regarded as a popular one, possibly paving the way for a working agreement between the Central Government and the Communists of North China. Soong's attitude toward the Communists is known to be moderate.

Soong's elevation to the full premiership or president of the Executive Yuan, as the post is designated in China, raised the possibility that he would attend any forthcoming meeting of the Big Five leaders of the United Nations.

Soong's popularity throughout the country is expected to strengthen the Central Government's hand in the military situation. There have been some unconfirmed reports that an agreement already has been reached in principle between the Central Government and the Communists of the North to wage a single war against the Japanese invader.

Soong actually became Chiang's "right hand man" last December on his appointment as acting premier. As such, he had attended to most of the generalissimo's premiership duties. Thus his elevation comes as no particular surprise.

It was announced also that Wong Wei-Hao, Minister of Economic Affairs, had been appointed vice-premier. In this position he will succeed H. H. Kung, also a brother-in-law of Soong.

It was generally believed that Soong, besides taking over the premiership, might also take the portfolio of the Finance Ministry from O. K. Yui, who possibly might be made the scapegoat for the recent gold scandal and the failure to arrest inflation. In such an event Soong probably would relinquish the Foreign Affairs Ministry, possibly in favor of V. K. Wellington Koo, Chinese ambassador to Britain.

New Flanking Movement Makes Encirclement Of Shuri Garrison Imminent; Rain And Mud Continue To Make Movement Of Troops And Supplies Difficult

By HAMILTON W. FARON Guam, May 31 (AP)—First division marines who yesterday raised the American flag in victory over Shuri castle, pressed a flank attack today against the Nipponese Shuri town garrison fanatically holding out against two divisions north and east of the ruined city.

The advance patrols of the fifth regiment met slight opposition as they shoved ahead toward the western flank of the almost encircled enemy.

The already knee-deep mud which has slowed the whole Okinawa campaign for weeks was made more sloppy by fresh downpours.

All available Tenth army men not in the front line were set to carrying munitions, water and rations afoot to the fighting fronts.

Company A of the fifth regiment under Capt. Julius D. Dusenberry of Florence, S. C., first occupied Shuri castle, medieval fortress which was the home of 16th century Ryukyuu kings and in recent months the headquarters of the Japanese command on Okinawa.

The invading Leathernecks found only 50 Japanese troops, which they killed, two women and a baby.

One of the first acts of the occupying company was to raise the stars and bars of the American Civil War Confederacy, which was the company's victory flag at bloody Peleliu. The American standard was officially raised approximately 25 hours later.

Japs Withdrawing From Southern Part Of China

Chungking, May 31 (AP)—Chinese front dispatches reported today that Chinese forces had recaptured Ishan on the Kwangsi-Kweichow railway 43 miles west of the railroad of Luichow, former site of an important American air base.

Another Chinese column striking northeastward along the highway from Indo-China was reported within 55 miles of Luichow.

The new threat to the flame-swept communications hub was disclosed by the Chinese high command, which reported the column advancing from the southwest had by-passed Pinyang, 60 miles above captured Yungning (Nanning), and reached the vicinity of the strongly fortified Japanese positions at Chienkiang, 25 miles beyond. Fighting was in progress.

Another Chinese column was attacking Pinyang. At the other end of the spreading wedge driven into the Japanese north-south corridor the Chinese reached a point 60 miles southwest of Nanning and 145 miles from Chienkiang on the highway to Lungchow and Japanese-occupied French Indo-China.

The Chinese announced the southern bank of the Yung river, opposite Yungning, has been completely cleared of enemy troops since Monday. In one south bank river village more than 100 enemy dead were counted.

Casualties Pass The Million Mark

Washington, May 31 (AP)—American combat casualties in World War 2 passed the million mark today.

The Army has lost 890,019 men and the Navy 112,868, a total of 1,002,887.

These casualties, suffered in three years and five months of fighting, represent an increase of 6,798 over last week's report.

The breakdown on army casualties as reported today by Undersecretary of War Patterson, and corresponding figures for the preceding week:

Killed 183,563 and 181,739; wounded 553,088 and 550,508; missing 52,746 and 57,802; prisoners 100,622 and 96,478. Of the wounded, 309,646 have returned to duty. Similar figures for the Navy: Killed 43,534 and 42,807; wounded 54,380 and 52,905; missing 10,709 and 10,505; prisoners 4,245 and 4,247.

The WAR TODAY AN ANALYSIS OF THE NEWS

The increasingly bloody clash in Syria between natives and French troops is based on a fundamental which should cause peace-makers the world over to pause for reflection, and it's this:

The Syrians have the Atlantic Charter in the melting-pot and they're applying the heat to discover what its promises of sovereignty mean to them.

When I returned from a trip through the Middle-East and the Far East in '43 I reported in this column that the hopes of the Orient were centered in the Charter but that there was widespread suspicion everywhere that this historic document was framed for Western countries and not for the East. Well, in one way or another this question is going to be brought to a head.

The matter isn't confined to Syria. We see it in another significant development in the Middle East. This is the demand by Iran (Persia) that British, Russian and American troops be withdrawn from the country. There the Atlantic Charter crops up again.

The British and Russians are self-invited guests at the Persian board. They invaded the country when the Teheran government failed to oust

thousands of Germans who were using Persia as a base for activities against the Allies.

There was fighting and Persians changed their minds. A British-Russian-Persian alliance was signed and it was based on the Atlantic Charter.

American troops were sent to Persia to run one of the world's greatest transport jobs—movement of war supplies to Russia from the head of the Persian Gulf by rail and desert highways. The Yanks appeared to be welcome, though it wasn't quite clear whether this was because the Persians loved us or more our Allies the less. Anyway, I was told in the Persian capital that the people frankly hoped Americans would act as a buffer between them and the Anglo-Russian pair.

The point is that the Persians have feared their country would fall again under the domination of a foreign power or powers as the result of post-war rivalries among the Allies. These fears, of course, are based on past events. Today's situation is a repetition of old history, so far as Russia and Britain are concerned. Skipping from 1600 when Pizarro acquired control of the Persian Gulf, we find Russia and Britain in 1907 partitioning Persia (Continued on Page Four)

In Battle of Okinawa. Chief Petty Officer I. H. Morris, Jr., on a battleship in the Pacific, who has been in the navy nearly six years, in a letter to his parents, Mr. and Mrs. I. H. Morris, 406 Harding street, Greenville, tells some of his experiences in the battle against the Japs of Okinawa. He told of a Jap plane flying low and fast and coming directly at the ship, barely skimming the water. Despite heavy anti-aircraft fire, the plane continued to approach the ship until, all of a sudden it dipped the left wing and crashed harmlessly into the ocean with a tremendous explosion. "It was a trying ordeal for all of us on the ship, but we danced like children after the plane exploded. It was on this day that American planes shot down 200 Jap aircraft."

Morris has been on the same battleship since before the war started. He has been in all theaters of war. "While fighting off Okinawa our boys know that they are fighting in Tojo's front yard," he wrote.

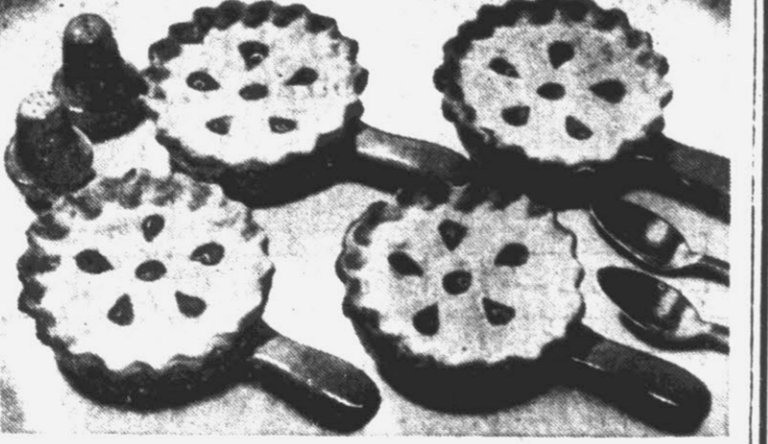

Individual Lamb Pie... or use beef, pork or veal

- Mix together 2 tsp. flour, 1/2 tsp. salt, 1/8 tsp. pepper
- In it, roll 1/2 lb. lamb stew, cubed
- Brown in 2 tsp. fat
- Add & brown 2 tsp. minced onion
- Add 4 cups boiling water
- Cover and simmer 1 1/2 hours
- Add 1 cup diced potatoes, 1/2 cup sliced celery, 1/2 cup diced turnips, 4 small onions, 1/4 bay leaf
- Cover and simmer until vegetables are tender. Remove bay leaf.
- Thicken with 2 tsp. flour mixed with 1/4 cup water

Stir in 16 ginger snaps, rolled fine. Simmer until ginger snaps are thoroughly dissolved. It's grand served on bread.

AMERICA IN WARTIME

By JACK STINNETT

Washington—It is generally admitted that of all the creaking machinery of the House and Senate, the committee system most needs overhauling.

Sen. Robert M. La Follette, Jr., chairman of the La Follette-Monroney joint committee investigating the organization of Congress, introduced a resolution two years ago to reduce the Senate standing committees from 33 to 13. "No person familiar with the situation in the Senate today," he said then, "can deny that there is a pressing need for committee reorganization."

On that score, no one has stepped up with a denial although some students of Congressional reform aren't convinced that mere reduction in the number of committees is the solution.

More than half of the members of the House serve on two or more of the 48 standing committees in the lower chamber. The average senator serves on at least five. Roland Young, in his authoritative "This is Congress," observes that senators often are "forced to bounce in and out of committee meetings much like debutantes trying to make all the cocktail parties on New Year's Eve."

It is in these committees that 80 to 90 per cent of all our legislation is drawn and approved.

In one recent session in the House, out of nearly 840 bills passed only 102 drew three or more pages of debate in the three or more passages of the Congressional Record. The reason members took the committees' word for it that the bills were necessary and good.

The committee system got something of an overhauling in the House in 1911 when the inherited power of Speaker "Uncle Joe" Cannon to make all committee appointments was broken. Assignments now are made by the Republican Committee on Committees and the Democratic Ways and Means Committee.

Ten years later, the Senate lopped off 40 useless committees, but they didn't get rid of all the dead limbs then.

La Follette recalls that when his father came here in 1906, he immediately was made chairman of the "Committee to Investigate the Condition of the Potomac River Flats," although the Potomac river flats had been eliminated years before.

George B. Galloway, staff director of the La Follette-Monroney Committee, reports that the Senate Committee on Manufactures, with six employes drawing \$13,620 a year, has met only once in the last two

years. That makes something wrong somewhere.

The seniority system of selection of the powerful committee chairmen ("petty barons," Woodrow Wilson called them) has also come in for much criticism. It has resulted in men in the seventies and even eighties heading up some of our most important committees; of isolationists holding key positions on the majority or minority sides of military and foreign affairs committees; and of men too ill to attend sessions still holding sway.

The other important criticism is against the understaffing and incompetent staffing of committee experts, mainly because of low salary limitations. The departments pay some of their experts more than Congressmen receive themselves.

into zones of influence.

Some years later, in an effort to gain strength to stand off the Russo-British influence, Persia appealed to the United States to send her an economic advisor. Upon the recommendation of President Taft, The Theheran engaged W. Morgan Shuster as treasurer-general and advisor, but Russia objected so strongly that Shuster was allowed to go.

After 1921 Persia developed a strong autocracy. Russia was reorganizing and England was retrenching. The result was that between 1921 and 1941 Theheran was little bothered by pressure from England or Russia. However, Germany gained economic control of the country by purchasing the agricultural products, for which Persia had no alternative market, and selling the Persians the machinery they needed. This accounts for the pro-German leanings in Persia at the outbreak of the present war.

Now Persia fears that she will come under Russian and British domination again unless there is an agreement among the Allies which will preclude this. She has been banking in America's disinterestedness to save the day.

taking of Ningteh Sunday. Signs that the Japanese were preparing to abandon the former American air base site of Liuchow coming after their loss Sunday of Yungning (Nanning) 120 miles to the southwest, reinforced a growing belief here that Japan is about to surrender the main military fruits of her swift conquest of Indo-China, Thailand, Malaya and the Netherlands Indies.

Such a move would mean that imperial headquarters at Tokyo has decided to write off its investment in men and materiel as a non-paying proposition, and to leave its forces south of China to shift for themselves. The land corridor serving those forces already has been almost severed by the Chinese, while American planes and submarines have made the sea lanes more of a hazard than a link.

The situation at Liuchow also suggested the possibility that Japan even planned to quit southeast China, leaving only small holdout pockets while concentrating her strength between the Yangtze and Amur rivers for a last ditch defense of her continental possessions.

One of the reasons for such a concentration in the north may be growing fear of Russian intervention along the Amur river. An even bigger Japanese consideration may have been preparations in China for a full-scale offensive against them in the south, marked by increased American assistance to Chinese ground forces in supplies, armament and training under the American army's Chinese combat command.

The preparations came to their first fruition in the recent smashing of the Japanese drive on Chihkiang, which may have played a big part in the change of Japanese calculations.

Tokyo's apparent decision to liquidate the Japanese position in southeast Asia seems based on harsh military logic: a fully developed Chinese offensive would leave the Japanese troops there at best a battered asset, next to worthless when and if finally consolidated with the

independence. The United States, Stettinius told the group, stands firmly by its support of their independence, but the whole matter is being handled by the State Department at Washington. Indications were that the United States and Britain had protested French moves and are now urging both sides to stop fighting.

The French explanation for having troops in the Levant is that under agreement with Syria and Lebanon France is responsible for military security in the two countries. The French also argue that if they pulled out completely some other power would replace them. They have investments in the country, further, they cite plans for using these troops against Japan.

Questions of what to do about maintaining peace and security until the projected world organization is functioning came up last night in a conference committee handling enforcement arrangements for the security council.

The original Dumbarton Oaks plan provides that until the council has armed forces at its disposal a Russian-British-American-Chinese agreement signed in Moscow in 1943 should prevail. In that the Big Four pledged themselves to use their forces during the interim period only for the maintenance of peace and security.

However, it was also agreed that the security council should take over peaceful settlement of disputes when it is created since the Oaks plan was vague on this point the committee voted to refer two paragraphs to a subcommittee today for re-drafting.

Other conference issues moved slowly toward final solution. The Big Five were still awaiting word from Moscow on a proposed interpretation of the veto-voting formula which would permit any state to get a hearing before the security council without the possibility that one of the big powers could gag it with a veto.

American officials continued that this interpretation—which still lacks full Moscow approval—should be particularly reassuring to small nations now because of the Syria-Lebanon crisis. If the council were functioning, they said, France could not, if it desired, prevent Syria and Lebanon from getting a hearing.

If it came to a question of seeking

peaceful settlement of the dispute France still could not veto action because under the formula a party to a dispute must refrain from voting on such questions. However, if it came to a question of using force to restore order, France would have a veto.

Landon Accepts Truman Invitation

Washington, May 31—(AP)—Former Gov. Alf M. Landon of Kansas has accepted an invitation to confer with President Truman, but no definite date has been set for his visit to the White House.

Press Secretary Charles G. Ross told a news conference today that the President had received a "very cordial" letter from Landon, the 1936 Republican presidential nominee, accepting the invitation. He added that a time convenient to both will be arranged.

In reply to a reporter's question, Ross said no reply had as yet been received to a similar invitation sent to Gov. Thomas E. Dewey of New York, the 1944 Republican presidential nominee.

Demand For Potatoes

Raleigh, May 31—(AP)—The most active demand for Irish potatoes in several years is now being experienced by the growers in eastern North Carolina, the Department of Agriculture reported after a survey of the situation. The Department reported that the early crop has been bringing ceiling prices since marketing commenced three weeks ago.

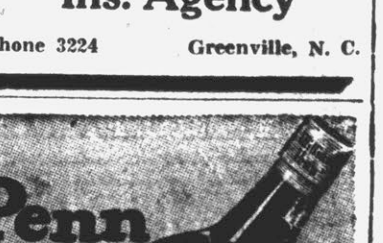

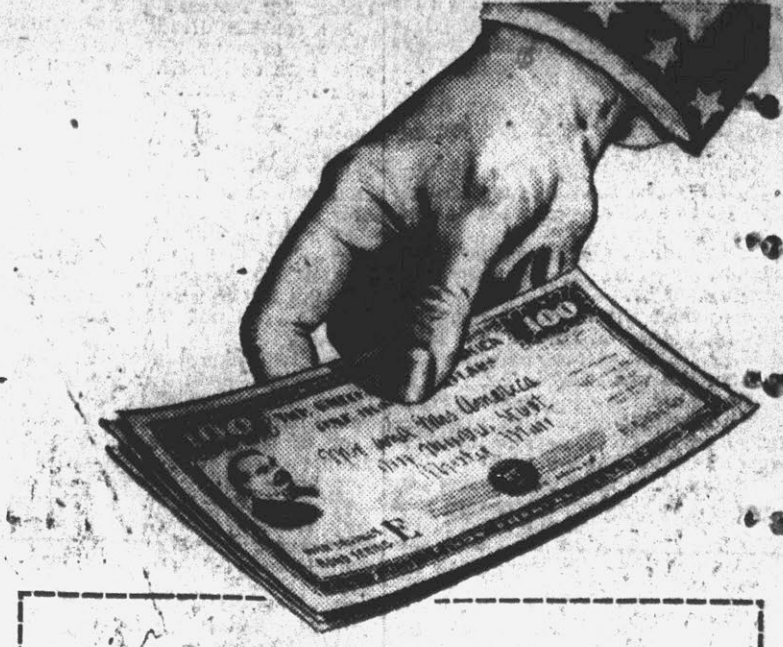

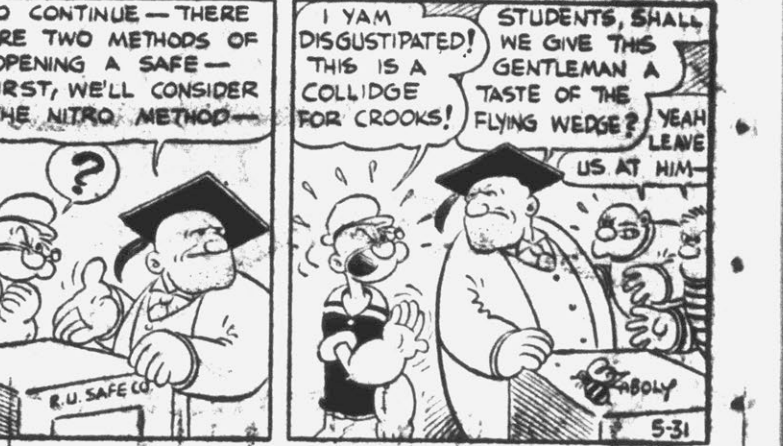

Continued on page four. stiffest resistance was encountered by Maj. Gen. Andrew D. Bruce's 77th infantry division. Japanese efforts to slow the Yank advance through deep mud was described not only as strong but fanatical.

Naha, the Okinawa capital on the west coast, was wholly in American hands except for isolated groups of Japanese.

"We've pretty well cleared out all of Naha except that small part of the city on the south shore of Naha harbor," Gen. Shepherd told correspondent headquarters.

Sixth division units advanced toward Naha 100 to 300 yards toward the Kokubara hills where mortar and machinegun fire was encountered from an estimated 350 troops, mostly Koreans. The marines neared the Kokuba river which empties into Naha harbor.

On the east flank, seventh infantry doughboys expanded their holdings by moving onto high ground near Yonakawa town, adjacent to captured Yonabaru, and sent patrols far to the west toward an imminent juncture with the sixth division marines south of Shuri.

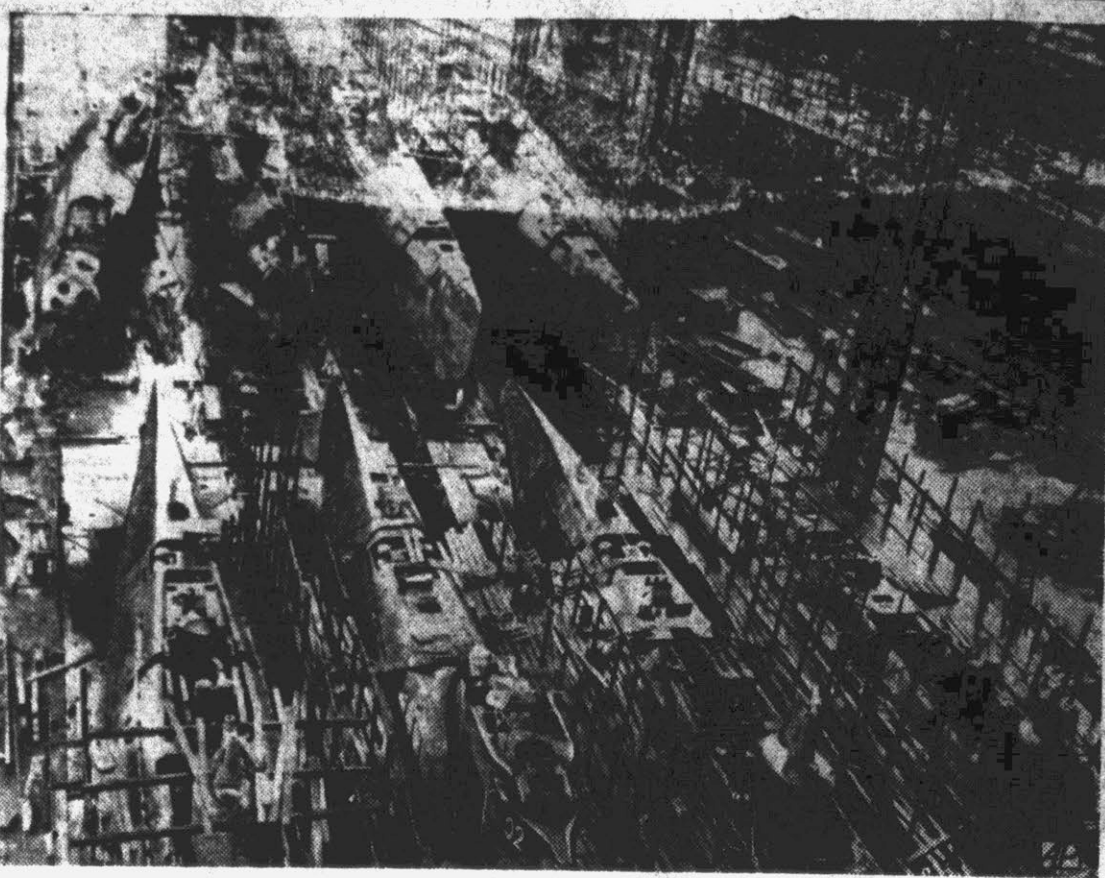
Two more American light vessels were damaged in small Japanese air attacks carried out on the Okinawa area Tuesday despite bad weather. Eight Japanese planes were shot down.

TRAFFIC JAM DURING FIRE

Reckless Motorists Handicap Fire Department

By CHESTER WALSH Motorists seriously interfered with the fire department last night about 8:30 when it was called to a fire at the home of Raymond Fleming Negro in the Bama suburb, south of the city. Motorists recklessly speeding to the fire and creating a traffic jam in the neighborhood of the fire handicapped firemen fighting the blaze. Fleming's home was destroyed, but the firemen saved the house next door.

The Bama is outside the city limits. Streets adjacent to the fire were entirely blocked for some time, interfering with the laying of hose and fighting the dangerous blaze. Chief Gardner said had another alarm been sounded in the city the fire apparatus could not have gotten through the traffic jam in half an hour.

There is a city ordinance requiring vehicular traffic to go to the curb and remain there five minutes when fire apparatus is passing. The custom in other cities of the police directing traffic during a fire could well be applied here, an insurance man observing the traffic jam last night, said. Police clear the way for funeral processions and they should cooperate with the fire department when an alarm sounds, the observing citizen said.

An alarm sounded this morning about 9:30, resulting from the tripping of a valve in the automatic sprinkler system at the Person-Garrett tobacco factory on West Tenth street. There was no fire.

Judge Revokes Prison Terms

Raleigh, May 31—(AP)—Federal Judge Johnson J. Hayes yesterday struck out prison sentences he previously had given two young Oxford women and a Raleigh man, each of whom had pleaded guilty to black market operations in handling ration coupons.

Edith T. Royster and Dorothy Nell Dixon, both 20, were permitted to pay fines of \$500 each and were placed on probation for 18 months. Each had been sentenced to serve a year and a day in federal prison. Thomas L. Cannon, preparing to serve a similar sentence, was fined \$300 and placed on probation for three years.

WAR CRIMES LIST GROWS

Chairman Urges Speedy Trials For Offenders

London, May 31—(AP)—Lord Wright told the United Nations War Crimes Commission today that 2,657 individuals had been charged with war crimes by various Allied Nations and the Commission itself, of these, 2,524 are Germans.

"The time has now come when the mere collection of material must change over into action," said the Australian chairman of the conference, representing the United States and 15 other nations. "Action here means the trial of criminals and their conviction, sentence and punishment where appropriate."

Of those charged with war crimes in addition to Germans, 110 are Italians, 17 are Bulgarians, two are Hungarians, two are Albanians and two are Romanians.

None of the names was given. From the various lists, Lord Wright said, the Investigating Committee has passed approximately 800 names of Germans for publication in the next list of war criminals, along with 185 more as suspects.

"Justice to be effective must be expeditious," he said. "Any avoidable delay is certainly mischievous and may be fatal to the attainment of the object which is sought, that is the punishment of the criminals for the double purpose of retribution to satisfy the peoples' demands for justice and of warning and example to deter such crimes in the future."

Lord Wright said the special feature of Nazi or Fascist crimes was that they were not merely perpetrated on an unprecedented scale over the whole range of military operations and enemy occupation, but that "they exhibit every trace of a general scheme."

"They all clearly emanate from a master criminal and his entourage and are carried out according to plan by elaborate, organized agencies and instrumentalities," Lord Wright said, "that is by individuals under common direction and by common concert."

He said the function of the commission was to acquire evidence and to trace crimes from actual perpetrators to "the central mind or authority such as Hitler or Goering, right through the intermediate agencies x x x and to analyze the extent of common purpose or conspiracy."

HUNT FOR OIL STILL GOES ON

Many Projects Under Way In East Carolina

Raleigh, May 31—(AP)—An intensive, highly competitive hunt is under way for oil along the North Carolina coast, and even under river bottoms.

Thousands and thousands of acres are under lease. One well is being drilled; and exploratory work is going on from the sound regions to points many miles inland. The well, near Morehead City, is about 3,700 feet down. Engineers say that some oil and gas, but neither in commercial quantities, have been found there. And still the drill is biting deeper.

Four companies are seeking leases, and have been for many months. They are the coastal plains, owned by North Carolinians, which has leased state lands, river and sound bottoms in an area roughly south from New Bern to Ocracoke Island. It sank the first drill.

Standard Oil Company leased state lands in an area stretching from Washington to Cape Hatteras. The state retained its rights to other parts of its properties, but will get a cut on proceeds from the leased land, if commercial quantities of gas or oil are found.

The Texas and Sinclair companies also are in on the search, joining with the other two in leasing huge areas from private owners for the exploratory work.

Seismograph experiments have mostly been in the sound areas. Engineers set off explosions under the earth's surface, and the vibrations are recorded. The machines indicate the type of earth, rock, or other mass through which the vibrations pass.

Search for oil—accentuated during the war—now new to eastern Carolina. A well was sunk in Craven county in 1924, about 20 miles from the scene of the present drilling. It went down to 2,400 feet but was abandoned.

Full rules and regulations governing the exploitation of gas and oil already are on the statute books of North Carolina. Senator Roy Hampton of Pamlico, after studying reports and laws of other states in which oil and gas are being leased, pushed two measures through the 1945 legislature.

One of Hampton's measures would "prevent waste, foster, encourage and provide conservation of crude oil and natural gas, and products thereof, and protect the vested, equal or correlative rights of owners of crude oil or natural gas." A petroleum division would be set up in the Department of Conservation and Development to supervise operations. The other Hampton measure provides for the registration of drilling operators engaged in exploration for oil and gas; and provides for the proper plugging of abandoned wells to prevent overflow upon adjacent lands; and prevents pollution of water supplies.

The laws were the result of research not only by Hampton and other legislators, but of hearings, and data obtained from the major oil companies.

So intensive became the leasing that acquisition of land for the protected Cape Hatteras National Seashore Park were halted. The last legislature ruled that further acquisitions could not be made for two years, but efforts already are in motion to give the park another lease on life.

(Continued From Page One) fighting between Syrians and French which already had cost 300 or more lives.

Eden said Damascus had been bombed from the air and subjected to heavy, concentrated shellfire after British and U. S. officials were evacuated.

Churchill told De Gaulle that Britain's order to Gen. Sir Bernard Paret, British commander in the Middle East, to intervene had been issued with "profound regret."

The Syrian minister in Paris declared only outside intervention could solve the crisis.

"The fighting is spreading," Eden said. "We are only in touch with our minister by wireless."

The French, insisting that the trouble was mainly caused by outside interference, claimed documentary evidence to back their stand.

The Syrian minister to France, Adnan Bey Atassi, declared that foreign intervention alone could not solve the problem. The only solution, he asserted, was for the French to clear out of Syria entirely.

His statement issued just after a conference with U. S. Ambassador Jefferson Caffery in Paris, said originally Syria demanded only that the French troops be removed from the cities of the country.

Both the French and British cabinets held emergency sessions.

The British cabinet met for the third time in less than 24 hours, with a full attendance of the ministers.

Damascus dispatches written yesterday and received today said chaos prevailed in the Syrian capital, after an all-night French bombardment of the city Tuesday night, and Cairo dispatches said heavy fighting continued today.

Clashes occurred all over the country and a rebellion of the fierce Druz tribesmen in the southern part of Syria apparently was threatened.

Quiet prevailed in the neighboring Levant state of Lebanon.

The trouble flared up Tuesday night, Damascus dispatches said, when Syrian conscripts bolted from the French forces and the French fired into the crowd which welcomed the fugitives.

Each side accused the other of starting the shooting.

Syria, predominantly Moslem, and Lebanon, predominantly Christian, were mandated to France after the first World War, and were promised their independence when the British and Free French of Gen. De Gaulle upset Vichy and a threatened German invasion in 1941. Their independence was proclaimed in 1943, but negotiations have been complicated by French insistence upon retaining air and naval bases and protection for a French pipeline across the country to the Mosul oil fields. The negotiations were broken off when the French sent troop reinforcements into the Levant.

Negroes Promote Cannery In Ayden

Ayden, May 31—The people of Ayden and the surrounding communities of Grifton, Pleasant Plains, Rogers, Winterville, Haddocks, Helens and Little Creek realized recently a cherished hope and an ambition of almost two years, when

they witnessed the opening of their community canning plant.

A demonstration in canning meats and vegetables was given. This demonstration was in charge of Prof. J. J. Brown, agricultural teacher in the Ayden school. He was assisted by some of the faithful patrons of the school, Roy and Sam Williams, and the agriculture teachers of the Berry O'Kelly group, section B, Profs. Cherry, Franks, Semmons, Smith and Rogers, of Brick, N. C.

Three hundred and twelve quarts of meats and vegetables were preserved in this demonstration, namely, peas, beans and cabbage; meats, beef and pork.

Prof. J. D. Lennon, former teacher of agriculture here and now holding a similar position in Durham county, planted a seed. That seed was cultivated by the people of the community and J. J. Brown, the present teacher, until now it has grown into a mature plant. A modern and well equipped plant housed in a cement block building 50x36 feet. These blocks were made in the shop of the school and the major portion of the building construction done by boys, who are agricultural students—and are NFA members. In order to complete this project these boys received some training in many trades. They are as follows:

Making and finishing cement blocks, brickmasonry, carpentry, cement mixing and finishing, painting, tinsmith, pipefitting and plumbing, electric wiring.

When these boys enter into life's vocations they will have this knowledge and experience to fit them for a better and happier farm life, the sponsors of the project said.
