

Russia Insists On Quick Settlement Trouble In Syria

Says Events In Syria And Lebanon Do Not Correspond With Aims Of United Nations Conference To Create Organization To Insure Worldwide Security

Paris, June 2—(AP)—Gen. De Gaulle clearly indicated today that France will not submit the Syrian question to the proposed tripartite conference. He declared a number of British agents created the uprising in Lebanon and Syria.

Asked about submission of the problem to the conference of French, British and United States representatives, De Gaulle told a press conference:

"We wish that when we were invited to London an answer could have been given in a different way—and it would have been better also for the invitation itself."

London, June 2—(AP)—There were indications today that Gen. Charles De Gaulle was unwilling to take part at the present time in an international conference to settle France's dispute with Lebanon and Syria, as Moscow told other members of the Big Five. The conflict which has arisen must be settled in a peaceful manner.

An Associated Press dispatch from Damascus reported French forces there retired to their barracks last yesterday under the noses of British tanks. An official Paris statement had said merely that the troops had been ordered "to cease fire and hold their positions."

The broadcast Soviet statement by the People's Commissariat for Foreign Affairs, disclosing the Russian note to Paris, Washington, London and Chungking, asked for "speedy measures to stop military operations in Syria."

The statement referred to "armed clashes" in progress in Syria.

The statement concluded: "The Soviet government has addressed this suggestion to the French provisional government and also has addressed it to the governments of Great Britain, the United States of America and China to whom belongs the initiative in the creation of a postwar organization for peace and international security."

The statement also said: "The events in Syria and Lebanon do not correspond to the spirit of the decisions adopted at Dumbarton Oaks or to the aims of the United Nations conference for the creation of an organization to insure peace and security for the peoples." The statement

President Truman's disclosure that the U. S. army in the Pacific ultimately will be twice its present size, and "bigger than our army was in Europe at its height," will fall on sorry ears in a Japan which already is apparently abandoning its hold on southern China and concentrating its strength in the north.

There are signs the Mikado's war lords are adopting Hitler's strategy for his desperate last-ditch stand. This was to fight a delaying action and ultimately to retire into his inner fortress for a finish fight. Meanwhile he pinned his slender hopes on some circumstance causing a quarrel among the Allies. Apropos of this, the well-informed British official military commentator Veritas makes these observations:

"Japan at the present time finds herself in a situation not unlike that of Germany before D-day. In a sense the Japanese are awaiting their own D-day. They have suffered considerable reverses in outlying territories, their naval power has been crippled so that it can no longer protect their sea lines of communication or keep Allied forces out of Japanese home waters, and Allied submarines and air attacks have already destroyed a large proportion of their ocean-going transport."

PROMISE FAIR SHARE OF MEAT

OPA Announces Plan For More Even Distribution

Washington, June 2—(AP)—The OPA today promised each county of the nation a fair share of the short meat supply.

Price Administrator Chester Bowles announced a "fair distribution plan" directing all commercial slaughterers to resume the pattern of distribution they followed in the first three months of 1944.

Bowles emphasized that the plan will not give each area as much meat as last year, but he called it "a long way toward the goal of fair and even distribution of the supply that we do have."

The new action supplements an earlier order limiting the amount of farm slaughter for sale and slaughter by non-federally inspected plants.

Federally inspected meat, in addition to supplying the armed forces, is the only meat that can be shipped across state lines.

"Already animals going to federally inspected plants are on the increase," Bowles said in a statement. Describing the "fair distribution plan" as a logical followup, Bowles said some slaughterers, "for a variety of reasons," have changed their normal pattern of geographical distribution, thereby accounting in large measure for present faulty distribution.

The first three months of last year were chosen as the base period, he said, because it was the most recent complete quarter of flush production in all parts of the country. "The order will be come effective June 27."

During each reporting period (months) any slaughterer must deliver into each county at least 80 per cent (by weight) of the proportionate amount of the civilian meat supply be delivered into that county in each of the first three months of 1944.

During any three consecutive accounting periods, however, a slaughterer's deliveries into each county (Continued on page two)

Moscow Stands Firm Over Veto Question

Conference Continues Task Of Erecting World Peace Structure

San Francisco June 2—(AP)—Russia is standing firm on a rigid interpretation of big-five veto controls over United Nations machinery designed to keep world peace.

Ambassador Andrei Gromyko, Soviet delegation chief, handed a new note to the Russian attitude last night to Secretary of State Stettinius and the chiefs of the British, French and Chinese delegations at the United Nations conference.

It was learned today that when Gromyko rapidly summarized its contents others present gathered that Moscow firmly opposes any relaxation of the veto power and may be objecting even to receipt of a complaint by the security council of the projected world organization, except when there is unanimous agreement among the big powers.

The veto power stands as an overriding right of any of the big five nations to forbid any decisive step it may disapprove. While this appeared to intensify differences among the big five over how the veto should be applied—Britain pressed for a less rigid interpretation—Stettinius went ahead nevertheless with plans for trying to speed the conference to conclusion early this month.

It was agreed tentatively that the big-five should meet at least once a day from now on until the log-jam of conference committee work—which has been blocked principally by the veto issue—is completely broken and all remaining problems are cleared up.

In line with this schedule the big-five were called to another meeting at Stettinius' penthouse headquarters today (10 a. m. PWT). The first committee to complete its assigned task was one charged with drafting the preamble, purposes and principles of the projected world organization.

Under the committee statement, armed force could only be used by any member nation in accordance with United Nations principles for international peace and security. "All members of the organization," the draft says, "shall settle their international disputes by peaceful means in such a manner that international peace and security are not endangered."

NEW CARRIER RAID AGAINST JAPAN TODAY

Tokyo Reports Attacks On Airfields On Kyushu Island For Two Hours This Morning

Guam, June 2—(AP)—Carrier raids on Japan were renewed today. Tokyo radio reported, in the wake of B-29 fire raids which have inflicted "shockingly great" damage on Nippon's major industrial cities.

Tokyo reported "approximately 200" seaborne fighter planes and an unannounced number of flying boats from bases in the Kerama islands bombed and strafed airfields on Kyushu island for two hours this morning.

Some raiders also strafed trails in their attack on the most southerly island of Nippon, Tokyo said. The report followed other enemy broadcasts saying Superfort fire raids on Tokyo had forced the capital's residents to dig subterranean homes and predicting martial law might be declared to meet devastation inflicted by B-29s.

A Japanese domestic broadcast quoted an editorial in the Tokyo Mainichi saying that "because of the fact that the number of war victims has increased to such a tremendous amount, we certainly would not be surprised even if we see a necessity of adopting martial law."

Airmen returning to their Marianas islands bases from the latest incendiary attack made on Japan's second largest city by more than 450 Superforts, reported it was so effective that the "heart of Osaka seemed to be burning out."

All agreed results were excellent. Some veteran fire raiders placed it among the most successful B-29 raids on Japan.

The entire city was covered by a cloud of smoke so huge that the last waves had trouble finding their targets.

Ten Superforts failed to return. About 36 Tinian-based B-29s landed on Iwo Jima because they were short of gas. They burned up all their fuel climbing to get out of bad weather on the way to Osaka.

Japanese airmen did try a new but crude chain and bucket weapon in an attempt to bring down the big bombers.

Lt. James M. Pearson, Manchester, Tenn., commander of a Saipan-based plane, said a Japanese fighter dropped a device made of two cylinders about the size of paint buckets linked together by a nine-foot chain. The Nipponese released the dive about 700 feet above Pearson's plane.

"The pilot's aim was bad," Pearson said, "and the thing dropped several hundred feet behind us."

Pearson said the containers may have held explosives, but they dropped out of sight.

Allied Forces To Celebrate D-Day

Paris, June 2—(AP)—In a message to all members of his command, Gen. Eisenhower said today the first anniversary of the Normandy landings last June 6 would be observed as a holiday for Allied forces.

He called for a brief pause June 6 to "pledge anew our full energies to the tasks before us" and suggested that "our celebrating of the day should be quiet and strenuous as well as solemn and physically for the coming months."

TEN DON'TS

Stocks, Bonds, Real Estates and Churches

1. Don't let any possible conversion slump frighten you. In certain industries there must, of necessity, be some unemployment while switching over from war to peace work, but in most cases this slump will be only temporary. With it there will be a decline in the earnings of some companies but, after a readjustment for excess profits, this should not be troublesome.

2. Don't buy the new low-coupon rate long-term bonds which are now being issued. Money rates will continue low for only a short time. The pendulum always has swung and is going to continue to swing. Many bonds now selling on a 3 1/2 per cent basis will some time again be selling on a 6 per cent basis. Much lower prices for fixed interest securities are inevitable.

3. Don't hold second-grade railroad securities any longer; but now take your profits. This applies to most railroad stocks and certainly to railroad income bonds which are now selling at fantastic prices. Railroad net earnings are headed for a severe postwar slump which will probably last many years.

4. Don't sell the general stock market. The Dow-Jones Industrial averages will surely sell for more some time during the next twelve months than they do at the present time. This probably also applies to many utility stocks. I am especially

Rumored Laval Killed Himself

Paris, June 2—(AP)—A London report that Pierre Laval had committed suicide was received with skepticism today in Paris circles where the former Vichy chief of government was well known.

The Exchange Telegraph Agency in London quoted the Luxembourg radio as saying Laval had committed suicide.

These sources had no information concerning the radio statement, nor the earlier claim that Laval, last reported in Spain, had agreed to surrender himself to France.

JAPS RENEW RESISTANCE

Reformed Shimbu Line Offers Stiff Opposition

Manila, June 2—(AP)—Yanks of the 38th Division ran into strong opposition yesterday while attacking Japanese elements forced out of the old Shimbu line east of Manila.

Enemy resistance also stiffened again on Mindanao Island, but Americans pushed into the head of the Carayan Valley, prospective last stand for the Japanese on Luzon, and a survey showed Allied air forces in this area had sunk or damaged 2,117,482 tons of Japanese shipping since January 1.

Despite the beating administered to the Shimbu line by the Americans after the Japanese were driven into that sector from Manila in February, the enemy managed to conserve important forces there.

In yesterday's attack 150 or more Japanese were killed at a river bend position. On Mindanao, the 31st Division drove the enemy back about half a mile east of Maybay but reported heavy opposition Wednesday from Japanese held hill caves east of Maagok.

The 32d Division blasted the last of the Japanese from the Villa Verde trail, historic route between the central Luzon Plains and the Cagayan Valley.

The 32nd joined the 25th Division north of the trail recently but had to backtrack and clear several road blocks and hill positions to make the road safe for traffic. The trail has been widened to highway dimensions. The 32nd built the road with armored bulldozers and in the course of the job, killed more than 9,000 Japanese.

From the new road the Yanks can drive into the Cagayan Valley, where the Japanese are concentrating for a final stand. It is their last major hold on the Philippines.

Tenth Army Starts Forking Drive Toward Airfield And Harbor After Completing Capture Of Shuri; Backbo Jap Defenses On Island Believed Broken

Guam, June 2—(AP)—The U. S. 10th Army, after completing capture of Japan's main defense line on southern Okinawa by capturing all of Shuri, sprang forking drives today aimed at obtaining use of the island's best airfield and harbor.

A front line dispatch from Associated Press Correspondent Al Dopking said another 10 days may see the end of organized enemy resistance.

An Okinawa dispatch from Associated Press Correspondent Vern Haglund noted, however, that the west coast peninsula below the failed capital of Naha is "alive with troops" in position to defend the big Naha airfield.

An official Navy spokesman said yesterday in Washington he was convinced the backbone of Japan's Okinawa defenses has been broken. Tokyo radio found little to say about the ground operations but sought to bolster the homeland with extensive claims of American shipping sunk by suicide planes and assurances more such attacks are in the offing. The unnamed American Navy spokesman in Washington listed losses of 23 U. S. Navy ships and two merchant ammunition ships in the Okinawa area since the invasion on April 1. More than 40 others have been damaged.

The complete occupation Friday of heavily fortified Shuri, in the center of the once formidable Naha-Yonabaru line, was announced in today's fleet communiqué which reported general advance yesterday up to 2,000 yards.

On the west coast below fallen Naha, Maj. Gen. Lemuel C. Shepherd's Sixth Marine Division crossed the Kokuba River yesterday. That put it in position to cut across a peninsula containing the largest and best enemy airfield on Okinawa.

On the east coast, Maj. Gen. Archibald V. Arnold's Seventh Infantry Division spearheaded south in an apparent drive to cut off Chinese Peninsula forming the southern arm of Nakagusuku harbor. That major anchorage, once used by the Japanese fleet, thus could be opened to American warships.

Adm. Chester W. Nimitz' communiqué today spoke of "diminishing resistance" and mopping up operations in "newly captured areas behind the lines," suggesting strongly the acceleration of the drive.

GOD SEES TO THE DETAILS

God has a plan for our lives—
down to the smallest detail.

He does not compel us to adhere
to that plan. Fatalism teaches that
things which are to be shall be. But
Christianity knows nothing of fatal-
ism. The Bible teaches that God
lays out a plan for us and will help
us to achieve it. But there is no
compulsion about it. We can fol-
low that plan or some other. As the
saying expression puts it, we can take
it or let it alone.

Fatalism declares that things hap-
pen as the result of blind force.
Christian faith leads us to believe
that all things are either part of
God's plan or are made to fit into
it.

Many people let it alone. They
have plans of their own which seem
infinitely better than the apparent-
ly stern plans of God. But there are
two difficulties about rejecting God's
plan: First, when we get into trou-
ble we have no powers but our own
to help us out; and second, when we
come to the end of a self-planned
life, there is a bitterness about it
which sends us down to the grave
with tears and sorrow.

God's plan may lead us through
many a dark valley and past many
a cross, but it leads out at last into
an open space of green pastures and
still waters—and joys without num-
ber.

AMERICA IN WARTIME

Washington—For the first 16
years of this century government
administrative expenditures and the
cost of Congress ran almost the
same. Since that time, the gap in
these expenditures has been widen-
ing. In 1940, for every \$7 spent on
government, only one cent was
spent on Congress.

The costs of Congress include
salaries and expenses of members
and all expenses of operating ad-
ministrative offices, except those of
the Library of Congress, the office
of the Capitol architect and the
botanic garden.

There are many conclusions to be
drawn from this. One of them
must certainly be that it is the
administrative branch of government
that is carrying the ball and that
Congress too often is doing no more
than appropriate money and dele-
gate broad powers to the chief ex-
ecutive and his departments and
agencies.

This decrease in the power of
Congress has been going on for a
long time, but in recent years it has
decreased with a rush. That is one
important factor that gave rise to
the La Follette-McCormack commit-
tee on reorganization of Congress and
to the amazing mass of suggestions
piling up for recapturing the con-
stitutional rights of the legislative
arm.

Instance after instance has been
cited before the committee of cases
in which Congress has delegated
broad powers (as in the Lend Lease
Act) and then has seen those
powers inefficiently or high-hand-
edly administered in a manner
which Congressmen claim was not
at all their intent.

Even before we got into the war,
Congress had granted President
Roosevelt broad powers. Critics
complained often that they made
nothing but rubber stamps and
White House errand boys of our
federal law makers. Some of the
complaints between the late executive
and Congress, as a result, are
classic.

In President Roosevelt's later
years, there was much evidence
that he was seeking a better re-
lationship with Congress, espe-
cially on foreign policy. President
Truman has gone well beyond this.

How long this Congressional
executive honeymoon will last is
anyone's guess. Even if it lasted
for years, the basic faults of Con-
gress that gave rise to its loss of
power, prestige and authority would
remain.

The remedies suggested are nu-
merous. Many have been the sug-
gestions that if the Congressional

committee system is streamlined
the committee chairmen form a
legislative cabinet to work with the
President's cabinet.

It has been suggested, and bills
have even been introduced to the
effect, that Cabinet members be
given the privileges of the House
and Senate floors to report and
answer questions on their admin-
istration of the laws.

Another interesting suggestion is
that assistant secretaries of the de-
partments be appointed with Con-
gressional floor privileges and be
permitted to participate in debate
on ending legislation. They would
not, of course, have voting privi-
leges.

What is important now is that—
through the non-partisan joint
committee on the organization of
Congress—the members do seem to
be unhitching the span that has
served them so ineffectively in re-
cent years.

verification in connection with in-
vestments is necessary for one's
good character, health, income and
happiness.

8. Don't be skimp on money
spent for the education of yourself
or your children. If, in the years to
come, the shadow of Russia ever
falls on the United States, those
who are experts in any one subject
will have nothing to fear. Hence,
the importance of having your chil-
dren educated and trained to hold
some necessary position under all
economic conditions.

9. Don't neglect the churches after
the war is over. We talk about
"fox-hole religion" among the ser-
vicemen, but there are many more
foxholes here in the United States
than there are abroad. The church-
es will especially be entitled to your
attendance and support after this
global warfare has come to an end.
See that you then repay the church-
es for what they are now doing for
you and your families.

10. Don't forget that you are go-
ing to die some time. Not only take

care in making your will, but keep
it up to date through the proper
use of codicils. Too many people
sacrifice their lives by hard work
and thrift to accumulate some
money; but give almost no thought
to how the money is to be used af-
ter they go. This means give more
thought to the use of forming trusts
for your heirs and others. Your lo-
cal banker will give you good sug-
gestions, free of charge, concerning
such trusts.

nese flattery of Russian prowess has
become more fulsome as inter-Al-
lied difficulties in Europe have in-
creased. "There is naturally no infor-
mation as to whether this verbal woo-
ing of Moscow is being followed by
an offer of gifts. Certain French
Commentators have been asserting
roundly that Japan is prepared to
hand over Manchuria in order to
win over the Russians. An offer of
that kind seems most unlikely, for
that kind of armament production
of Manchukuo are essential to Ja-
pan in meeting the forthcoming as-
sault of the Allies from the south.
Certainly Japan would give a very
great deal to buy off Russia now
during the deadliest crisis in Japa-
nese history."

build up an army after going to war
because we had allies to hold off
the enemy until we were ready.

But next time, they say, we may
be plunged into a war so suddenly
that we'd be crushed if we waited
until then to create an army.
Without going into detail, some
of the other arguments for forced
training say it would teach young
Americans discipline, leadership,
group living, disregard for class
distinction. There are arguments
against all these claims.
One of the main arguments

against such training is this:

Building up a large pool of mili-
tary-minded men is bad in a democ-
racy and should not be necessary
if the new league of nations being
formed in San Francisco is really
intended to maintain world security
and prevent war.

Further, these arguers against
say, we need not fear a surprise at-
tack because if we are alert at all
we'll know in years in advance when
war against us seems likely and
therefore can prepare in plenty of
time.

The American Legion is one of
the strongest supporters of compul-
sory training. A number of educa-
tors are going to testify against the
measure.

entered tunnels of the Balatoc mine
and found the bodies of about 200
Japanese who apparently were killed
by fellow soldiers or left to die
because they could not move.

Philippine President Sergio Os-
mena announced one division of the
Commonwealth Army had been ac-
cepted by Gen. Douglas MacArthur
for "the campaign against Japan"
and would be equipped with Ameri-
can arms. It is being formed at
two centers on Luzon Island.

MacArthur's communique today
reported the South Seas air block-
ade, in addition to sinking the more
than 2,000,000 tons of enemy ship-
ping, had destroyed 1,220 Japanese
planes and dropped more than 70,
000 tons of bombs in support of
ground operations. In these opera-
tions 113,627 sorties were flown.

MacArthur reported 135 heavy
bombers and 60 fighters lashed at
Formosa Wednesday and that the
U. S. 13th Airforce and the Austr-
lian airforce sent 170 bombers and
fighters against Japanese targets on
Borneo Tuesday.

must come up to 90 per cent of the
proportionate amount he delivered
during each of the first three
months of 1944.

Thus a slaughterer must, within a
tolerance of 20 per cent for one
month and 10 per cent for three
consecutive months, deliver the
meat period by period, to the same
county and in the same proportion
to each county that he delivered in
the base period.

Here is a hypothetical example of
how the scheme works:
A slaughterer in St. Joseph, Mo.,
delivered a total of 100,000 pounds
of meat in each of the first three
months of 1944, but in the first
three months of the distribution
plan his supplies total only 80,000
pounds monthly.

Of the 100,000 pounds in each of
the three base months, 1,000 pounds
went to Doniphan county, Kans.
Since there is a 20 per cent reduc-
tion in total supplies, Doniphan
county's fair share becomes 800
pounds monthly.

The slaughterer must actually de-
liver a minimum of 840 pounds in a
month, or 80 per cent of the coun-
ty's proportionate share, figured on
the base period.

For three consecutive months,
however, the delivery must be in-
creased to 90 per cent, an average
of 720 pounds a month.

Slaughterers who keep records on
the basis of trading areas rather
than counties may apply for an ex-
emption. Deliveries, however, must
follow the pattern of distribution in
the base period.

The order also provides that OPA
may direct slaughterers to deliver
meat "in such a manner and quan-
tity as is considered necessary to
alleviate area shortages or to fur-
ther the fair distribution of meat
among consumers and other users."

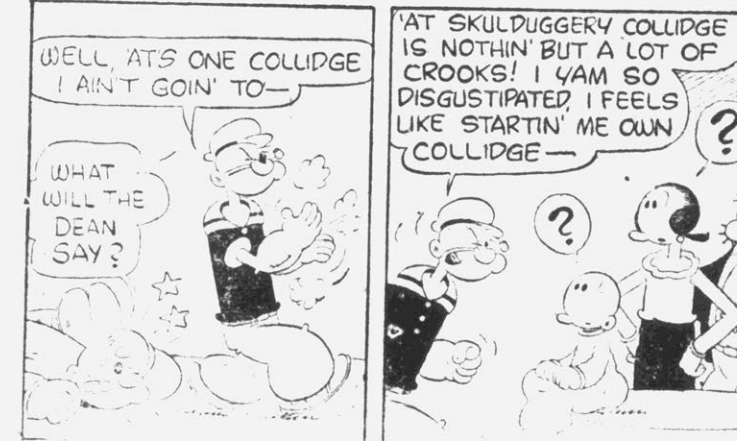

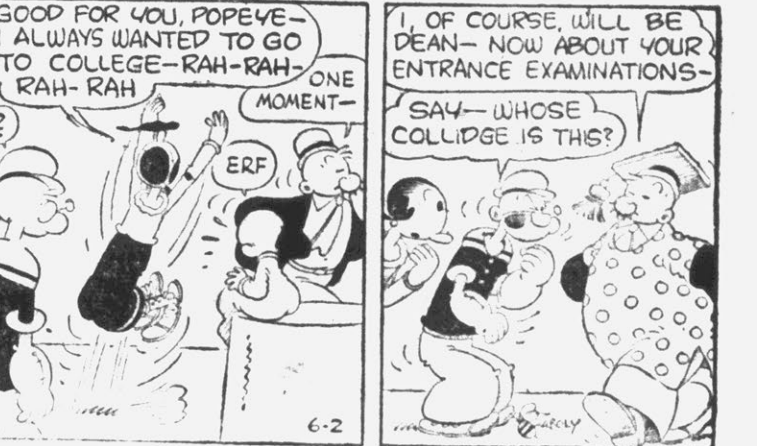

HEAR TALKS ON 'GI' BENEFITS

Informational Meeting Held Here Last Night

By CHESTER WALSH

One of the most representative audiences to assemble here since the war began attended the Veterans' "informational banquet" at the Olde Towne Inn last night. Every phase of the community life was represented—business, professional, industrial, mercantile, judicial, law enforcement, civic, religious and educational groups. Junius H. Rose was master of ceremonies. The meeting was sponsored by the Greenville Merchants Association. Charles R. McBrayer, president of the association, extended greetings and explained that the meeting was held to provide information for everybody about the assistance the Veterans' Bureau will provide for returning servicemen.

A feature of the meeting was when Chairman Rose called on the guests to stand and introduce themselves. After that it appeared that the 75 or 80 men and women present were more interested and ready to function consistently for the benefit of the veterans.

Mrs. J. B. Spillman, manager of the Greenville branch of the War Manpower Commission, introduced R. A. Wadsworth, who gave a clear and concise word picture of what the Veterans' Bureau is doing and is preparing to do for returning servicemen. He reminded that there are 343,000 North Carolina men and women in the armed forces, plus about 25,000 workers who have migrated to war jobs in other places, who will sooner or later return to the Old North State for readjustment to civilian life.

Wadsworth struck a highlight when he declared that the assistance the Veterans' Bureau is providing in finding jobs for veterans is a thousand times better than the PWA and that the "GI Bill of Rights" is one of the greatest documents ever enacted into law in this country by a grateful nation and then stressed the point that this is the American Legion's bill.

Wadsworth came closer to home when he reminded that there are 4,385 Pitt county men and women in the armed forces and that it is not their fault that they had to leave their homes and go to war. He concluded by saying that "We must use a little common sense, much patience and perseverance and give returning servicemen a chance to make good when they come back home."

W. W. Pollock of Washington, district supervisor for the Veterans' Bureau, introduced bureau representatives from various Eastern Carolina cities.

Other speakers on the program were W. H. Bill, Dunn, manager of the local office of the Veterans' Bureau, who described miscellaneous benefits; John S. Vickers, area supervisor, who explained veterans' employment rights, and Jake E. Skinner, who explained veterans' readjustment allowance. Dr. Robert S. Boyd said the invocation. June Rose led the singing of "America" and thanked Mrs. Cora E. Powell, secretary of the Merchants Association and Mrs. Spillman of the War Manpower Commission for arranging the meeting.

Judge Dink James today called attention to the shocking information in the University News Letter that North Carolina stands at the bottom of the list of 48 states for having 49 out of every 100 white men examined for military service rejected for physical or mental defects, and 71 out of every 100 Negroes rejected for the same reason. The actual figures are: North Carolina white men rejected, 49.2 per cent; Negroes, 71.5 per cent.

Checking over the counties, the report shows that Pitt county, the largest tobacco growing county in the world, stands 73rd for rejections for military service. The armed forces rejected 44 out of every 100 white men examined for military service, and 64 Negroes. The actual
