Russian Identify Body That Of Adolf Hitler

Say Former Died Of Poisoning In Underground Berlin Hide-out; Bodies Of Goebbels And Members Of His Family Also Identified

Berlin, June 6—(AP)—A high Russian military source said today a body found in Berlin had been identified with fair certainty as that of Adolf Hitler.

The body, smoke-blackened and charred, was one of four discovered in the ruins of the great underground fortress beneath the new Reich chancellery after the fall of Berlin. These four bodies, any one of which answered pretty well to Hitler's description, were removed and carefully examined by Russian army physicians.

All were badly burned from the flamethrowers with which the Red Army soldiers finally cleared out the underground command post where Hitler and his leading Nazis made their last ditch stand.

After careful examination of teeth and other characteristics the Russians singled out one body which they believed almost certainly is that of the Nazi Fuehrer.

Asked why no official announcement of the discovery has been made yet by Moscow, this Russian source said that as long as any element of uncertainty exists the Russians do not wish to state definitely that Hitler's body has been found. The source added, however, that there seemed little doubt that this actually is the corpse of Hitler.

Examination of the body showed that the man almost certainly died of poisoning.

Whether this was self-administered there is no sure means of knowing. It will be recalled, however, that Russian sources recently reported that Hitler died of an injection given by his physician, Doctor Morel, after he had been insane and half-paralyzed for several days. According to a telegram sent by Propaganda Minister Paul Joseph Goebbels to Grand-Adm. Karl Doenitz, Hitler died at 3:30 p. m. on

JUDGE DENIES DEFENSE PLEA MEADOWS CASE

Selection Of Jury From Special Lenoir County Venire Making Slow Progress This Afternoon

Superior Court Judge J. Paul Frizzelle of Snow Hill today denied a defense plea of former jeopardy in the trial of Dr. Leon R. Meadows, charged with false pretense and embezzlement of more than \$14,000 while president of East Carolina Teachers College.

The defense immediately excepted indicating it will take the issue to the state Supreme Court for settlement at the conclusion of the trial. Legal steps to take the issue immediately to the high court were not taken, as expected in some quarters before the court reconvened today after a recess since Monday afternoon.

One hundred special veniremen from Lenoir county reported before the court at 9:30 a. m., today and examination of a possible jury started shortly before noon. The court on Monday had denied a defense motion for a change of venue, based on the contention that Meadows could not get a fair and impartial trial in Pitt county. Defense counsel went so far as to enter affidavits asserting that 90 per cent of the sentiment in this county was against the former college president.

State and defense attorneys, with Jesse Jones of Kinston, assisting Solicitor D. M. Clark and Chief Defense Counsel Albion Dunn in the way, battled for at least two hours on the former jeopardy plea.

Dunn contended that Superior Court Judge Clawson Williams of Sanford, who presided over the former eight-weeks trial, was without authority to declare a mistrial in the original hearing. He insisted that Judge Williams in convening a regular civil term four days before the end of the Meadows trial automatically disqualified himself and that Judge Williams' action had the automatic effect of acquittal. Former jeopardy means that a defendant cannot be tried twice on the same charge. If acquitted the first time, former jeopardy is precluded. (Continued on page six)

Plane With 21 Aboard Missing

Washington, June 6—(AP)—An Army transport plane carrying 18 WACS and a crew of three has been missing for a week on a 766-mile flight in Africa, the War Department announced today.

The plane left Accra, British West Africa on a flight to Roberts Field in Liberia on May 30 and was last reported over Takoradi, British West Africa, about 150 miles west of Accra.

The WACS, members of a group assigned to the Army Transport Command base at Accra since last October, were being transferred to a new assignment.

Airplane and surface craft have undertaken a widespread search for the missing plane along the French Ivory Coast, between British West Africa and Liberia.

Although some WACS were wounded by bombing in England and at least one lost her life in an air crash in this country, these are the first WACS reported lost overseas during the war.

Draft Opponents Fear Regimentation Of Mind

Washington, June 6—(AP)—The spokesman for a large segment of American education cautioned today against "regimentation of the mind" he said would result from a peacetime draft law.

First of a group of opposition witnesses expected to be heard during the next three days, A. J. Brumby, vice president of the American Council on Education, told the House Postwar Military Policy Committee.

"The opposition of representatives of higher education to immediate action on conscription is due primarily to the fear of what universal military training will do in regimenting the minds of our youths."

"It is impossible to give only military training—the body cannot be regimented without comparable regimentation of the mind."

For Congress to act now on a peacetime draft program, Brumby said, is to declare "in advance that we have no faith in collective security and international action" and to assert "that we believe that World War III is inevitable and that it will come soon."

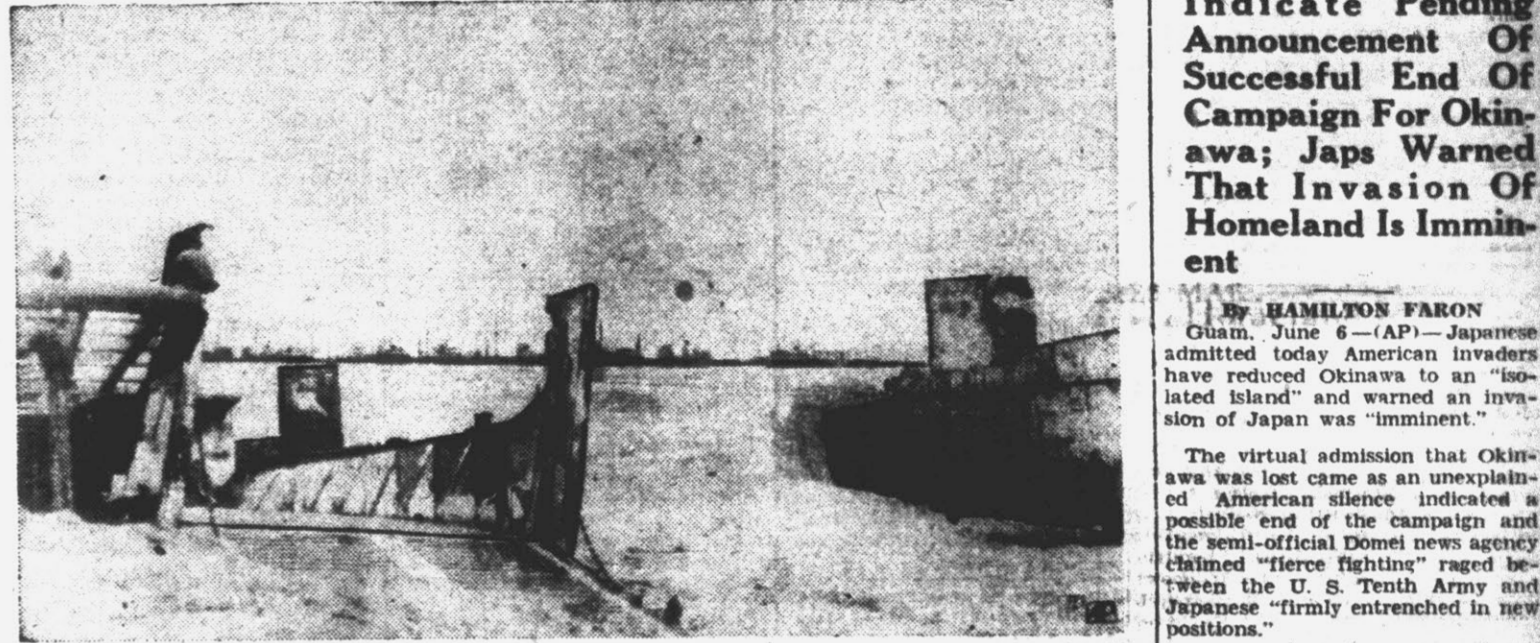
Before taking such action, he suggested, "we must first make an earnest and sincere effort to establish an international structure which will maintain the peace."

Brumby said "the summary of the considered judgment of approximately 1,100 college and university presidents indicates that they believe that it is now unwise to enact legislation requiring universal military service."

JAPS WILL GO UNDER GROUND

Guam, June 6—(AP)—Anticipating greater B-29 destruction of Japanese cities, the Tokyo government created a new reconstruction agency today even as the great port city of Kobe smoldered from yesterday's 450 plane fire-bombing.

Domei news agency broadcasts announced the creation of the division for the reconstruction of the war-ravaged areas. Its task will be to rebuild wrecked cities underground where they will be safe from incendiary raids, evacuate Superfortress target areas, and feed the hundreds of thousands of Japanese left homeless by B-29 attacks.

The immediate concern of the division, Domei said, will be centered principally in Tokyo, Yokohama, Osaka and Kobe where raids have been heavy of late and damages have been considerable.

But the news agency said, "It is also urgent to carry out the program throughout the nation."

Yoji Monbe, named as head of the division, will be assisted by 15 advisers and 26 engineers. Tokyo radio described this set up as merely "the nucleus organ" of the government plan for "promoting extensive and speedy efficiency in the reconstruction of the nation."

Orders Seizure Of Oil Company

Washington, June 6—(AP)—President Truman today directed Secretary Ickes to seize and operate the Humbel Oil and Refining Company plants at Ingleside, Texas, as a result of a labor disturbance.

The President's order said the company's facilities were needed for the production of crude oil and other products vital to the war effort and that their occupation is threatened with interruption by the labor dispute.

The President directed all federal agencies, including the War Manpower Commission, the Selective Service system and the Justice Department to cooperate with Ickes, as War Petroleum Administrator, in operation of the facilities.

Everybody will want to share in the prizes to be awarded on that day. Parents and adults are invited to visit the playgrounds.

News Blackout May Indicate Pending Announcement Of Successful End Of Campaign For Okinawa; Japs Warned That Invasion Of Homeland Is Imminent

Guam, June 6—(AP)—Japanese admitted today American invaders have reduced Okinawa to an "isolated island" and warned an invasion of Japan was "imminent."

The virtual admission that Okinawa was lost came as an unexpected American silence indicated a possible end of the campaign and the semi-official Domei news agency claimed "fierce fighting" raged between the U. S. Tenth Army and Japanese "firmly entrenched in new positions."

Admiral Chester W. Nimitz, in his daily communique, failed even to mention ground action on the island, reporting only United States air strikes into Japanese home waters.

Such news blackouts in the past often have preceded announcement of developments of major importance, such as conclusions of campaigns or the launching of new invasions.

Japan's invasion consciousness was sharpened further by a plea for its citizens to emulate the children of Aka Jima, who died in hand grenade "banzai" charges against American troops, and by radio Tokyo's claim the Japanese mainland has been converted into "an impregnable fortress."

A "new kind of underground warfare now being prepared by the Japanese is so different from anything used in Europe it will mark a new epoch in military history," Tokyo said.

The powerful Tokyo newspaper Yomiuri Hochi saw developments on Okinawa and "the recently intensified enemy air raids on Japanese cities," as "unquestionably significant of a direct invasion attempt against the Japanese homeland."

"It is high time the entire nation buried its bridges and made the fullest preparations for this imminent development, whose outcome will decide the rise or fall of our country for centuries to come," said a broadcast version of Yomiuri's editorial.

Domei acknowledged the Japanese were meeting "numerically superior" American forces on Okinawa and reported the landing of Marines on Oroku Peninsula, below Naha, which Admiral Nimitz disclosed yesterday. The landing force was reported by the Japanese to include 100 tanks and "400 to 500 infantry reinforcements."

Today On The Home Front

Washington, June 6—(AP)—About 10 million people must pay—by June 15—the second installment on their 1945 income taxes.

You're one of them if, by last March 15, you filed a declaration of estimated tax for this year and then paid the first installment.

If you're in this group, you probably have received a bill from the collector of internal revenue for the second installment.

That bill will show the balance of tax you owe for 1945. It also will show—if you don't want to pay the full balance—what is due on your quarterly installment.

So, unless you want to pay the full balance, just pay the installment. Most people will do that.

The financial position of some people may have changed since they filed that estimate of tax last March 15. They may have married, had a new baby, or acquired other new dependents.

They could, if they want, make an amended declaration by June 15. This would mean a change in their payments.

But there's not much reason why they should. They can wait till next March 15—when they make a final return on 1945 income—to file an amended declaration. They can straighten out their tax change then. But—suppose your business condition has changed drastically. Suppose you're an independent contractor, who has had a number of contracts cancelled since March

He rejoined his outfit and went to Germany where he again was wounded and reported missing in action. Harris took his place in the ranks in Germany last December 23 and six days later he was taken prisoner by the Germans. He was liberated when Germany fell. He has a brother in the Army Quartermaster's corps and stationed in Castella, Italy.

 The summer storm tore a limb off an apple tree. The fruit had almost fully developed. The limb fell to the ground and, to the amazement of many people, the apples grew to their full size and ripened.

But the next spring there was, of course, no foliage on the limb that had been torn off. The tree, rooted in the ground, was covered with blossoms and the limbs later sagged with fruit.

People and institutions will often bear fruit even after they have been torn from the tree whose roots go down into the ground. Institutions started by some vigorous personality may go on for quite a while on the momentum which, during his lifetime, that outstanding person had generated. A business occasionally keeps going after a strong hand has left the helm because of the reputation it built up. Occasionally children of poorly churched parents separate themselves utterly from the church and yet continue to live fine and upright lives. But their children usually show the evil effects of this separation. The limb of the apple tree matured the fruit that had started to grow, but no fruit grew the next year. Only the tree rooted in the soil could produce fruit.

St. Paul speaks of our being rooted and grounded in life. And by that he means being rooted and grounded in Christ, who was the setting forth in human form of God's love. Without that sustenance, our souls languish and die.

AMERICA IN WARTIME
 By JACK STINNETT

Washington—A Swede who has two farms in South Dakota, a huge dairy cattle ranch in New Mexico, a son in the Army, and who has been more critical of food handling than any other official in Washington—that's Clinton P. Anderson, who soon will be our new secretary of agriculture.

When President Truman surprised the wise guys and named the Democratic congressman from New Mexico for the job, there may have been just a little bit of that "it-you're-so-smart-run-it-yourself" glint in his eye.

As chairman of the house committee investigating food shortages, Rep. "Clint" Anderson had scoured the administration set-up for sugar and meat shortages particularly. He was ready to launch on a whole survey of the nation's pantry when the President named him "food czar" with all the authority that Secretary of Agriculture Wickard and War Food Administrator Marvin Jones have had to date.

The tall, curly-haired 49-year-old New Mexican has about as varied an experience as any successful man could have. Born on a South Dakota farm, on which his father from Sweden has prospered, young Clint got his education at South Dakota Wesleyan and the University of Michigan.

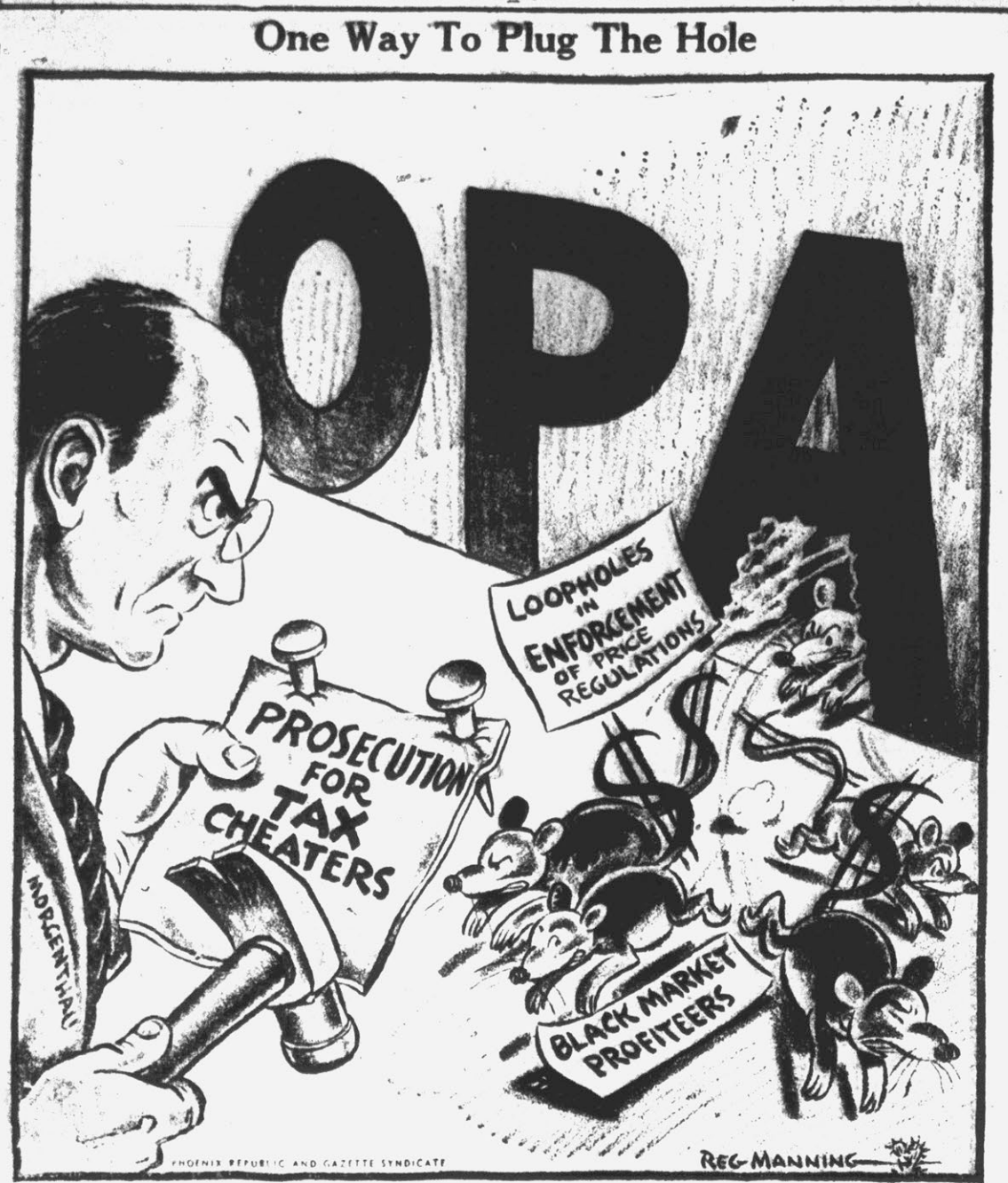
His father was a member of the now defunct Populist Party, but young Clint carried his admiration for President Wilson to the polls and never has been anything but a loyal Democrat since.

After a turn at newspapering, Anderson moved to New Mexico for his health. He built up a considerably successful general insurance business at Albuquerque, acquired an 800-acre ranch.

When President Roosevelt came into office, Anderson was president of Rotary International. The next year he was state treasurer. In 1935, he was in charge of the state relief administration and then moved up to a Federal Emergency Relief Administration job.

He was serving his third term in Congress when he was tapped for the agriculture job.

For the most part Anderson is a good natured fellow, but he's pretty impatient about indirect testimony and red tape. Many who have testified before his committees have



found out.

Horseback riding is his favorite outdoor sport, and he comes by that ambling cowboy gait naturally. The Andersons have 30 good saddle horses on their New Mexico ranch and kept something of a stable here until feed and gasoline (for riding to where they could ride) became too great a problem.

Anderson likes to mull over his extensive library of western Americana and Franklin D. Rooseveltiana, and to play bridge, at which he's expert.

Mrs. Anderson, like many wives of government officials, devotes most of her time to keeping house, standing in line for groceries and meats, doing Red Cross work, and keeping up with the family. The younger branch of the family includes Nancy, who goes to Mount Vernon Seminary, and Cpl. Sherman, who is at Camp Crowder, Mo.

Example: You get \$3,500 in salary from which taxes are withheld but you expect to get more than \$100 from rent or dividends or some other source. In this case you must have filed a declaration no matter how many exemptions you claim.

 diplomatic problems—including Poland, Syria and war criminals trials—there are many reasons for an early big three meeting. President Truman and Prime Minister Churchill have announced they would like to meet with Marshal Stalin as soon as possible. An unconfirmed broadcast over the Russian-controlled Graz (Austria) radio said Stalin favored a parley soon.

The London Star said Montgomery was flying back to London from the Berlin meeting yesterday "for important consultations on the future of Germany."

Dispatches from Berlin disclosed that Gen. Eisenhower had left Berlin last night to return to his headquarters at Frankfurt after signing a joint declaration announcing the assumption of supreme authority in the Reich by the four victorious powers.

While it was agreed that further meetings of the council should be held at an early date, the dispatches said, no specific time or place was set.

The meeting was cut short, correspondents said, when the American, British and French representatives learned that Marshal Gregory Zhukov, Soviet member of the council had no instructions from his government to carry on further discussions until the withdrawal of American and British troops from the zone to be occupied by Russian forces is completed.

The correspondents disclosed that the signing of the four-power declaration—a ceremony which requires only 25 minutes—was held up approximately six hours when the Russians unexpectedly interposed last minute objections to article 10 of the 2,500-word document, which Soviet representatives previously had read and approved in London.

The Russians apparently believed the article might be construed by the Japanese as a breach of neutrality.

It was finally decided to omit the article from the declaration.

One of the American pool correspondents, Drew Middleton of the New York Times, wrote from Berlin

 demand that opposing views be put to the test of conference vote.

In that event the odds are about 100 to 1 that the Russian view would be batted down hard and the position of the other four powers upheld. Virtually all the small nations except those directly in Russia's sphere of influence favor limiting the veto power.

The next move of the United States delegation, according to present indications, will not be decided upon by President Truman until Stalin has sent Gromyko new instructions. These might either re-

affirm Russia's previous view, first expressed last Friday to the other powers here, or modify it.

The Soviet position is that in the 11-member security council, in which the Big Five would have permanent seats, all the Big Five would have to agree before the council could take up a dispute and begin to discuss it—except that if one of the Big Five was party to the dispute it could not vote.

The United States, with the support of the other powers, has taken an adamant position that no one power must be able to prevent a dispute from coming before the council for discussion. The world charter itself would guarantee any state the right to call the council's attention to a "dispute or situation" threatening peace. The Russian interpretation is regarded by the other four to mean that any one power should have the right to force the council to ignore the dispute even after receiving such a notice.

On this anniversary of the D-Day landings in Normandy, Denmark became the 50th member of the conference as committees plodded along on various issues. About 11 remain—mostly of a technical nature. But all questions connected with the veto problem are being delayed until a final decision is made—either by Russia to change its view—or by the United States to force ahead against Soviet opposition.

Caught in this jam is an entire section of the proposed world charter—section A of chapter 8—in which are set forth peaceful procedures for settling disputes. In addition to guaranteeing any state the right of appeal to the council, this charter empowers the council to investigate and make recommendations for settling disputes.

Despite the American-Soviet negotiations over right of free discussion in the council, it appeared there would be no abridgement of the same right in the assembly. A conference committee agreed that the assembly should be able to discuss any situation in international relations—the Big Five considered leaving to reverse this action, but decided against it. Russia still could move independently, but was not expected to do so.

Outside the veto argument, international trusteeships remained the hottest current question. Here again the United States, while holding on to its views, is trying to bring about agreement with other powers in order to present a common front to conference committees.

The principal conflict is over a Russian proposal for elimination of a trusteeship provision that would freeze left-over World War I mandates in their present status until they voluntarily were brought within the new system. American officials have been trying to talk the Russians out of this proposal. Unless this and other less critical points are cleared up by Friday, the American delegation may decide to go ahead and put them up to a vote of the conference committee.

Jap Balloon
 Detroit, June 6—(AP)—The Army disclosed today that a Japanese balloon has fallen in Michigan within the past few months.

The information, released by the Sixth Service Command, was restricted to that statement only.

Near Halfway Mark
 Washington, June 6—(AP)—Purchases of "E" bonds in the 7th War Loan today totalled \$1,982,000, 900 or 49.9 per cent of the \$4,000,000,000 quota.

Total individual purchases were \$4,139,000,000 or 50 per cent of the overall quota of \$7,000,000,000.

The campaign opened May 14 and closes June 30.

Anniversary Of D-Day Observed

Paris, June 6—(AP)—The first anniversary of the Allied landings on the Normandy beaches found the victorious Allies enjoying a holiday today in simple observance of the memorable date.

Just a year ago in the early morning darkness some 5,000 ships poured thousands of fully equipped men on the beaches of France. Overhead thousands of Allied planes dived—some carrying airborne troops.

Today on these same beaches veterans of the invasion—the greatest military achievement in history—honored the memory of those who died as they battled for a hold in Hitler's European fortress.

In accord with Gen. Eisenhower's wishes in designating June 6 as a holiday for Allied soldiers, formal ceremonies generally were avoided.

Many American troops who participated in the 11-month battle of Europe were preparing to leave for home and discharge or the Pacific and the war with Japan. Others were already home or in transit.

But for those still on the continent and in the United Kingdom this was a day of quiet celebration which the supreme commander said should "strengthen us spiritually and physically for the coming months."

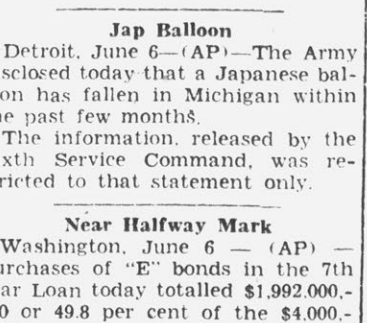

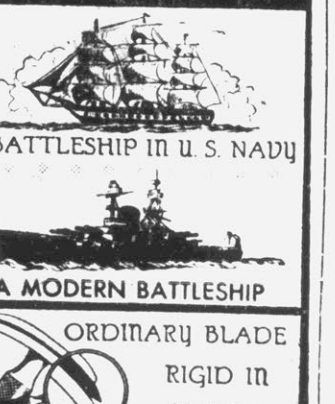

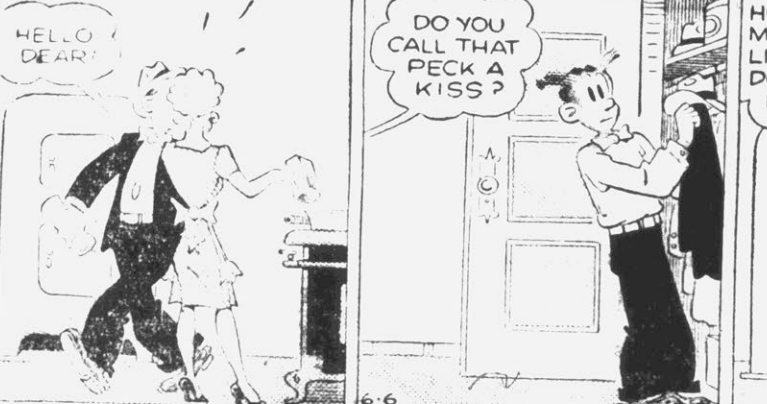

clearing of war damages."

The emperor's military command which has been trying unsuccessfully for a year to halt the big bombs, yesterday used piloted baka rocket bombs over Kobe in a frantic effort at interception.

Returning pilots agreed that opposition was heavier than usual. Antiaircraft fire was termed "hot" and fighter planes attacked viciously.

Eight Superfortresses were lost. At least one of these was rammed over Kobe, the 21st bomber command said.

Pilots reported that Japanese fliers strafed crewmen parachuting from one crippled Superfort. Dense concentrations of fire bombs set raging fires throughout Kobe's industrial areas. A lack of ground winds at the target, however, apparently prevented fires from spreading as they did in other raided leading Nipponese cities. Kobe is Japan's sixth largest city and its most important seaport.

REPULSE JAPS ON MINDANAO

Enemy Forces Driven From All Useful Areas

By FRED HAMPSON
Manila, June 6—(AP)—Japanese forces on Mindanao thrown back from all useful areas of the island, may have to make their last stand in the mountain east of the Sayre highway and west of Davao.

The harassed Japanese have been hurled from their prepared positions and are being given the "squeeze play" by two veteran divisions—the 24th commanded by Maj. Gen. R. B. Woodruff and the 31st commanded by Maj. Gen. Clarence Martin.

In northeastern Luzon, another hot Philippines battleground, Maj. Gen. Robert S. Beitzler's Buckeye (37th) Division is crowding on toward Bayombong on Highway Five after capturing the key road junction town of Arifao in the Cagayan Valley.

Spearheading the 31st's central Mindanao advance, Lt. Col. George Williams of Birmingham, Ala., led his crack Dixie unit through narrow Silae Creek canyon.

The Dixie unit is known throughout the Southwest Pacific as "Pap-py's Boys." Their advance was in keeping with their reputation—they won their first fame on the Drinimor River of New Guinea with a jungle-flanking action that trapped several thousand Japanese.

transport" was sunk and another warship of unidentified category "severely crippled with direct torpedo hits," as Nipponese torpedobombers attacked United States warships near the islands of Mikako, Kume, and Tonaki. Mikako is south of Okinawa, while Kume and Tonaki are due west in the Ryukyu group.

Only mention of Okinawa in Nimitz' communique was that adverse weather prevented enemy air activity Monday, the day Domei said the torpedo bomber attack was carried out. The attack was pressed home, Domei said, by pilots braving "inclement weather."

The Japanese report mentioned activity among "enemy transports in Okinawa waters, apparently in an attempt to land badly needed supplies for the enemy ground forces."

Nimitz told of the tightening blockade on Japanese shipping. Privateers of Fleet Air Wing One exploded a large oiler, sank three cargo ships and damaged a small

freighter in vital waters between Asia and Japan.

Aerial harassment of shipping in these lanes has forced the Japanese to use a longer route north through Manchuria to supply forces on the mainland. Only in darkness and poor weather do the Japanese now send traffic between Korea and Japan.

Nimitz reported that planes of Fleet Air Wing One had sunk 94,405 tons of shipping and damaged 91,205 tons since beginning operations in the Okinawa area two months ago.

In other strikes, Fleet Air Wing 18 sank three small cargo ships and damaged three others south of Honshu, the main Japanese island, yesterday.

Yangtze port southeast of Hankow. In Honan Province, Chinese planes inflicted 400 casualties on Japanese reinforcements moving toward Hsihsiakow, while in Shansi Province three spans of bridges on the Tatung-Puchow railroad were damaged.

Fourteen Japanese barracks were destroyed by Chinese air raiders southeast of the Yangtze port of Ichang, westernmost enemy bastion on that river.

Goebbels' own body was discovered by the Russians in the same underground shelter, together with those of his wife and children. All had died by poisoning. Goebbels apparently had administered poison to the members of his family and then committed suicide himself. His body was found practically decapitated by a shell splinter or explosive charge which had caught him full in the neck, almost tearing his head from his body.

The bodies of Goebbels and his family also were badly burned, but were identified by the Russians without too much difficulty.

The Russians have given no hint as to how the bodies of Hitler, Goebbels and other Nazis found in Berlin have been disposed of. This probably will remain a secret for all time to guard against the possibility of Nazi fanatics trying to recover the bodies.


