Tar River Expected To Reach 18 Foot Stage

By ASSOCIATED PRESS Great improvement was noted today in Eastern North Carolina's highway system, which has been practically paralyzed all week due to four swollen rivers.

The Weather Bureau officials say the rivers—the Cape Fear, the Tar, Roanoke and Neuse—have reached their crests and are subsiding in their upper and middle reaches, but that the worst is yet to come in the lower reaches.

The Highway Department described the travel situation as much better and said that all main North Carolina highways are open except: U. S. 15-A at Lillington; U. S. 301 north and south of Fayetteville; N. C. 87 from Fayetteville to Acme; U. S. 74 from Maxton to Lumberton; N. C. 217 between Erwin and Linden; and N. C. 95 east of Rocky Mount.

At Fayetteville, the Cape Fear had reached a stage of 68.7 feet this morning and was standing. The river crested there at 8 p. m. last night, and officials expect the fall to begin soon.

At Weldon the Roanoke had gone to 46.4 feet and was rising slowly. The crest was expected there today. At Williamston, the Roanoke had reached 10 feet and is still rising.

The Tar was falling along all of its upper tributaries, but highway and weather officials expect trouble at Tarboro. The river had gone to 24 feet there this morning and was still rising. It is expected to crest there late Saturday at 23 feet. At Rocky Mount the reading was stationary at 13.3 feet.

At Goldsboro the Neuse was rising and the worst is expected there Sunday or Monday. This morning's reading recorded 20.8 feet and rising. At Kinston the river was at 14.5 feet and rising. The Neuse was at 24.8 feet at Neuse and falling.

The highway department said it is probable that U. S. 701 will be closed over the Cape Fear at Elizabethtown late today or tomorrow. All main routes west of U. S. 1 are open and in fair passable condition, officials said.

Carl Vinson, Georgia Democrat, chairman of the House Naval Committee, hollered for the State Department to come up and explain its policy on Pacific islands which the navy would like to use as bases.

5. Senator Elbert Thomas, scholarly Utah Democrat, chairman of the Senate Military Committee, suddenly demanded that all youths under 21 be relieved from the draft. Today he told reporters—vigorously—that youths 18, 19 and 20 years old ought to be allowed to attend school in peace. He wants to write this into the pending bill, which offers inducements to soldiers and sailors to reenlist.

Meaning Gen. George C. Marshall's peace pipe parley with Congress yesterday was considered by many lawmakers a good explanation of demobilization problems, but it didn't solve all congressional problems, nor quiet the clamor: The real trouble is: Frustrated members still don't know how to answer Mr. Smith or Mr. Jones when he asks them to get his son Joe out of the army.

More and more law-makers are accepting the army's offer to take over all their mail relating to discharges and answer it for them. Neither Senate nor House was in session today. Today In Congress

Washington, Sept. 21.—(AP)—A hum of activity came from the capitol today despite the fact that congress was in recess.

The hum came from committee rooms where: The Senate Military committee approved house-passed legislation designed to encourage voluntary enlistments in the armed forces, and Chairman Thomas (D-Utah) dropped his plan to limit selective service to men 21 to 26 years old. The committee clearly indicated it was not ready to act on draft revision now.

Democrats of the House Ways and Means committee voted down a Republican proposal to question Elliott Roosevelt personally about his financial transactions. John Hartford, chain grocery store head, listed the major part of a loan to the son of the late President as a "bad debt" on his income tax and the Republicans also wanted to question him and former RPC Chairman Jesse Jones, who reportedly settled the original debt.

The committee Democrats reportedly contended the group is without authority to subpoena witnesses without a special house resolution.

Nominations of Robert P. Patterson as secretary of war and W. Stuart Symington as surplus property administrator were approved by the Senate Military Affairs committee.

At a Maryland congressional delegation's conference with CIO representatives, urging enactment of President Truman's legislative program, Senator Tydings (D-Md) walked out with the angry comment that "I don't intend to sit here and be threatened." Tydings made his exit after Robert Lamb, CIO national legislative representative, said "any members of congress who don't get on the bandwagon and vote for a 65-cent minimum wage are going to be sorry in 1946." Lamb said he had made no threats.

Treaties May Hinge On Red Control In Europe; U. S. Control In Pacific

Russia Unwilling To Give Up Demands For Mediterranean Positions If America Is To Control Mandated Islands In Pacific; Romanian Peace Discussed

By FLORA LEWIS London, Sept. 21.—(AP)—Indications pointed today that the World War II peace settlement is becoming increasingly a question of the extent of Russian control in Europe as weighed against the extent of American control in the Pacific.

So far as is known the question of Pacific policy has received no attention from the Big Five Council of Foreign Ministers meeting here.

Nevertheless, the British press has seized upon Russian Foreign Commissar V. M. Molotov's press conference hint that Moscow is unwilling to give up its demands for Mediterranean colonies so long as the United States wants control of the mandated Pacific islands it seized from the Japanese.

While the foreign ministers continued their discussions on a Romanian peace treaty—which reliable sources report may be turned over to deputies today—there were more and more signs that no final decisions could be reached until global political contentions are ironed out. It seemed evident that Russia sees no difference in American claims aimed at insuring Pacific security and its own demands for Central European security and commercial outlets.

Diplomatic quarters closest to the Yugoslav-Italian frontier argument have indicated dissatisfaction with a communique which appeared to indicate agreement on a racial frontier and internationalization of the disputed port of Trieste.

These sources say the communique, which turned the frontier problem over to the Council's deputies, was misleading and that it was worded by the British and Americans without full Soviet approval.

Authoritative sources reported a major part of the Romanian talks were devoted to the disposal of Transylvania, a point on which the armistice is vague. The Soviets became (Continued on Page Two)

ROOSEVELT FOREWARNED

Letter Says He Knew In Advance Of Jap Attack

Albany, N. Y., Sept. 21.—(AP)—Gov. Thomas E. Dewey today declined to make public a letter from General Marshall which reportedly admitted President Roosevelt knew the Japanese were going to attack 15 hours before Pearl Harbor.

"Since I received the letter in confidence, I refer you to General Marshall for the text of it," the 1944 Republican presidential candidate said.

Questioned by reporters concerning a story in the current issue of "Life" magazine which also said Dewey declined to use his information in the campaign, the governor declined to answer most questions.

"I would rather not comment at this time," he explained.

However, close friends of Dewey said he felt last year that he would rather be defeated for president than endanger the war effort.

Asked "in the event you are requested to testify before a congressional committee, would you do so?" the governor said:

"Certainly, I would testify if I had any information the committee wanted, although I have no information not available directly from government sources to any congressional committee."

STRIKES CAUSE GAS SHORTAGE

Transportation Operations Cut In Large Cities

By ASSOCIATED PRESS Gasoline was back on the scarcity list in some sections of the nation today as a strike of CIO oil workers gained headway.

More than a dozen refineries and plants were closed, and others were ready to shut down as workers took strike votes. Emergency rationing of gasoline was ordered in Toledo, Ohio.

As the federal government stepped into attempts to effect a settlement of the strike started last Monday by the oil workers, the stoppages curtailed gasoline supplies in scores of cities and idled more than 20,000 workers. Elsewhere across the nation, labor disputes kept an additional 200,000 men and women away from their jobs.

The oil strike hit hardest in the Texas gulf coast region where 14,000 were idle in refineries and affiliated industries. Another 5,300 were ready to leave their jobs and thousands more were taking strike votes.

The closing of the only remaining refinery in the Toledo area last night resulted in emergency rationing of gasoline for the Ohio city.

Large cities feeling the pinch of gas and fuel shortages included Chicago, Detroit and Cleveland.

Some 5,000 oil workers in the Chicago-Indiana area were idle by the closing of four refineries and one terminal which resulted in the shutdown of several gas stations.

CIO union leaders mapped final plans for the closing of the huge Standard Oil plant at Whiting, Ind., the only large refinery in northern Indiana continuing in operation.

In the Detroit area, where more than 80,000 of the country's 220,000 idle are out because of strikes and shutdowns, union leaders went on with plans for strike votes in plants of the Big Three—Chrysler, General Motors and Ford.

In Portland, Ore., President Ballard of the CIO International Wood Workers of America said that an unofficial tabulation of 30,000 ballots cast by members in Oregon, Washington and California showed an "overwhelming" approval of giving the union authority to call a strike.

The union's negotiations committee will meet Wednesday and has power to call a strike if it decides the demands for a \$11.15 an hour (Continued on Page Four)

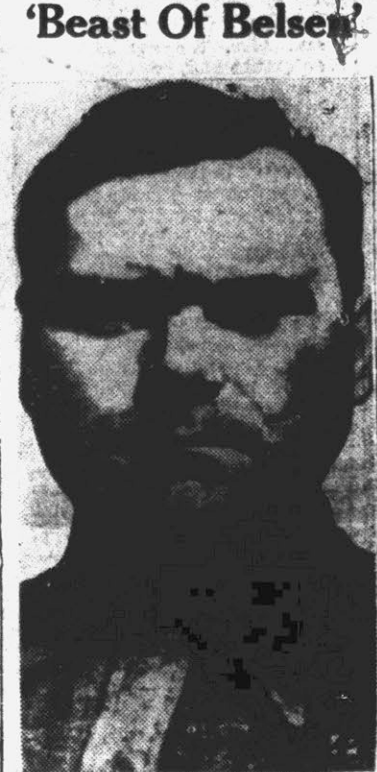

Subject Of Order Had Recently Been Appointed Head Of First Jap Army With Allied Approval; 10-Point Guide For Press And Radio Operations Issued

Tokyo, Sept. 21.—(AP)—General MacArthur today ordered the "immediate arrest" of Lt. Gen. Kenji Hara—whose recent appointment to command Japan's First General Army was given Allied acceptance—and issued a 10-point code to guide operations of the censored Japanese press and radio.

Japan's cabinet met meanwhile for three hours to discuss problems which well informed sources said included mounting food shortages and repatriation of Japanese civilians from Manchuria and Korea.

The newspaper Asahi today added another dime novel thriller to the tales of Japanese surrender-crisis intrigue, reporting that former Premier Kantaro Suzuki barely escaped with his life from a band of armed Japanese soldiers on August 15. The band, evidently angered by surrender plans, machine-gunned in quick succession two houses from which Suzuki had recently departed.

Dohara, once called Japan's "Lawrence of Manchuria," was his country's advance agent in its Asiatic conquest.

His appointment as commander of the First General Army, succeeding Field Marshal Gen. Sugiyama, who committed suicide, was a surprise to many Japanese, who said his past record was not one that would inspire American confidence.

American army officers, nevertheless, said after the conference that Dohara had pledged full cooperation and was "courteous and cooperative."

General MacArthur's code for the Japanese press specified that news "must adhere strictly to the truth" and said that "nothing may be printed which might directly or indirectly disturb public tranquility."

Meanwhile American Marines prepared to expand the smoothly running occupation of Japan to the big naval base of Sasebo on Kyushu. The Fifth Amphibious Force is scheduled to take over the base tomorrow.

New Casualty Figures Given Washington, D. C., Sept. 21.—(AP)—U. S. war casualties have reached 1,071,268, or 536 more than a week ago.

Comparative Army figures in the latest count are: killed 206,569 and 204,045; wounded 571,696 and 571,696; missing 24,131 and 25,083; prisoners 120,066 and 120,827.

Navy figures: killed 54,008 and 53,089; wounded 90,236 and 79,732; missing 11,197 and 11,262; prisoners 3,379 and 3,605.

Auto workers want a raise that will average them more money hourly—working a 40-hour peacetime week—than they averaged in wartime working 48 hours.

By JAMES MARLOW Detroit, Sept. 21.—(AP)—The auto workers want a raise that will average them more money hourly—working a 40-hour peacetime week—than they averaged in wartime working 48 hours.

But this raise—according to the figuring of the CIO's United Automobile Workers (UAW)—would still give the workers less money to take home every week than they got in wartime.

The UAW is demanding a 30 per cent wage increase from the entire auto industry. The figures given here on earnings are from the UAW.

They will be used here because there is very little difference between them and similar figures on auto workers earnings obtained from the Automobile Manufacturers' Association.

In 1940—before war pressure was felt and while workers still were on a 40-hour week—auto workers' basic hourly average rate of pay was 94.6 cents.

(Some of course made more, some less. But 94.6 cents was the basic hourly average rate of pay.)

By 1944 their basic hourly average rate of pay—through wage increases and more people working in higher paying jobs—had climbed to \$1.15.

But their average earnings per hour—as distinct from just the basic hourly average rate of pay—climbed higher. And for this reason:

In 1944 they were working a 48-hour week and getting time and a half pay for overtime for those ex-

tra eight hours which they did not work in peacetime.

Because of that overtime and some other factors, in 1944 their average earnings per hour were \$1.27. Here it is briefly:

1940—Basic hourly average rate of pay—94.6 cents.

1944—Basic hourly average rate of pay—\$1.15.

1944—Average hourly earnings—\$1.27.

Now the auto workers, with the war over, are back on a 40-hour week.

UAW people estimate that auto workers now are getting a basic hourly average rate of \$1.12, or about 17 cents an hour more than in peacetime 1940.

Because UAW is asking a 30 per cent increase for all its workers, 30 per cent of \$1.12 would be 33 cents.

That 33 cents—added to the present basic hourly average rate of \$1.12—would give the auto workers a basic hourly average rate of \$1.45 now.

(No overtime would be involved in that \$1.45. It would be \$1.45 an hour week—the auto workers' average rate of pay—by working a 40-hour week—the auto workers' average hourly earnings were \$1.26, or 18 cents less than they want now for straight time.

Actually—the way UAW figures it out—not all of that 30 per cent increase would be a flat 30 per cent increase to all UAW workers.

About 7 per cent would go for things like these: Making wage adjustments in different locations, making adjustments in wage rates (Continued on Page Four)

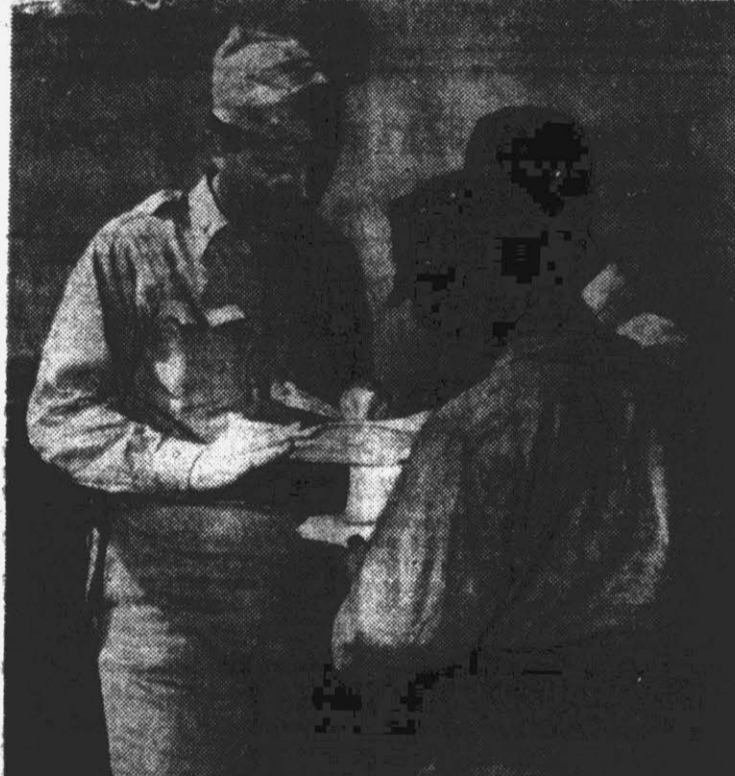

NO DEFENSE IN TRIAL OF EPES

Case To Go To Jury Late Today Or Tomorrow

By HENRY LESENE
Columbia, S. C., Sept. 21.—(AP)—The case of Lt. Samuel C. Epes, charged with killing his wife with an overdose of sedative, will go to the jury without defense testimony.

Defense Attorney Edgar A. Brown announced the defense would not offer any witnesses, after Judge A. L. Gaston overruled a motion for a directed verdict of acquittal.

Brown's announcement came as the State completed the mass of testimony it contends shows that Epes killed his frail school teacher wife for love of another woman.

The defense claimed the State had not proved a crime had been committed other than Epes own statement he had buried his comely young wife in an abandoned foxhole.

The defense of young Epes, while admitting he secretly buried his wife in a moment of panic after she died from an overdose of sedatives, steadfastly has denied killing her.

Counsel for the 27-year-old son of a wealthy Virginia industrialist insisted no statement of an accused could be used against him unless the State proved a crime had been committed.

This, they said, the State had not done.

"The young man may have acted like a fool in a moment of panic but he is not charged with being a fool in the indictment," said Brown.

He referred to the bizarre burial of petite, 98-pound Mary Lee Epes whom the State claims Epes drugged and suffocated.

By electing not to offer any testimony the defense will get in both the opening and closing remarks to the jury.

Although arguments have not been limited it is believed likely the five-day-old trial will go to the jury today or tomorrow.

The State rested its case in the fifth day of the dramatic trial for his life of handsome young Epes, who admits burying his wife in a foxhole grave but denies killing her.

The 27-year-old son of a wealthy industrialist, has, in statements to officers, attributed the death of his wife to an overdose of self-administered sedative tablets.

The prosecution, however, offered medical testimony that the 98-pound Mary Lee Epes would have been in a deep anesthesia before she had taken the amount of the drug disclosed by an autopsy.

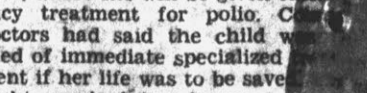

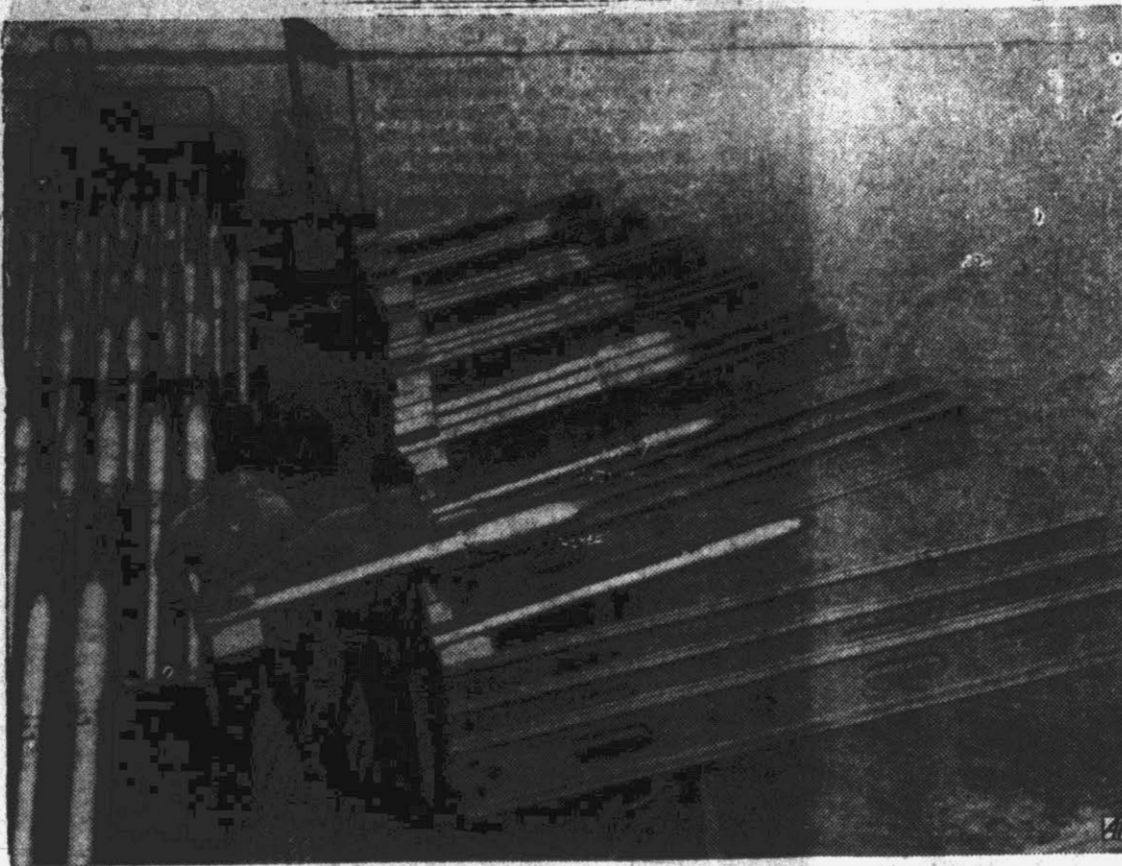

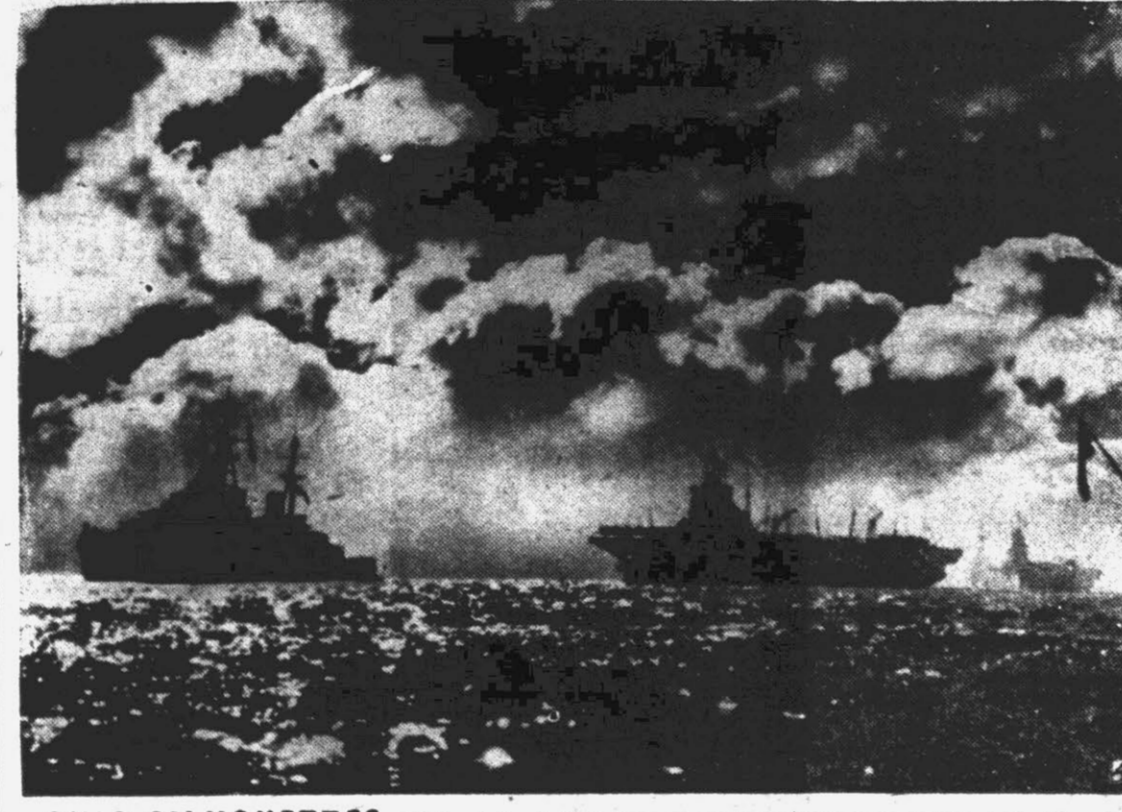

Harv (The Cat) Brecheen played with Charlie Grimm's dancing Bruins last night, shutting them out with only six hits, 2-0, for the Cardinals' 15th victory in 20 starts against the Cubs.

The Red Birds are only two games behind Chicago with eight to go. Two more with the leaders are slated next Tuesday and Wednesday after the Cards enter in Cincinnati twice while Chicago is at home to Pittsburgh for a three-game set.

St. Louis' three night games produced three kept pitching duels. Brecheen's decision over Ray (Pop) Prim was most important to Billy Southworth's tattered crew which would have been virtually eliminated, four games behind, if they hadn't won.

Despite Brecheen's fancy south-pawing, it took a sensational double play engineered by Marty (Mr. Shortstop) Marion in the ninth inning to make it stick. Brecheen, the league leading pitcher, now has won his last six straight, allowing only a total of 29 hits in the six outings. He has one the route 11 times in his last 12 starts.

Phil Cavarretta, Chicago's candidate for the league batting title, slammed his first hit of the series, double in the ninth, while his average shrank to .350, only one point ahead of Boston's Tommy Holmes.

Both National League contenders are idle today with the only action a two-night doubleheader between Philadelphia and Brooklyn which dropped a 3-2 game to Boston yesterday.

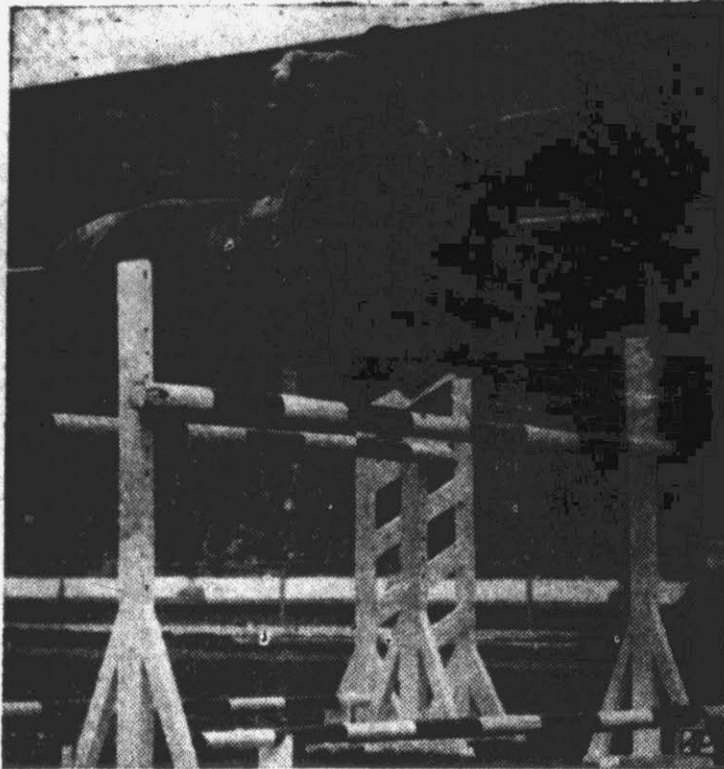

Rape Charge Not Proved In Court

In Superior Court at Elizabethtown, Bladen County, yesterday, James Brock, 22, of Greenville, who was charged with raping Mrs. Bertha Pollard, 26, of Greenville, during a picnic at White Lake last July 1, submitted a plea of assault on a female, a misdemeanor, and the State Solicitor accepted it. Brock was on trial for his life. The plea was entered after Defense Attorney E. Hoover Taft of Greenville had made his argument to the jury and by agreement with the solicitor. The presiding judge entered a judgment of assault on a female, placed Brock on probation and allowed him until next March to pay the court costs. Blount and Taft were counsel for the defendant.

According to the testimony, the alleged assault was committed, during a picnic at White Lake on Sunday, July 1. The party of picnickers returned to Greenville in a truck. The warrant against Brock was sworn out two days later.

Quiet Today
Buenos Aires, Sept. 20—(AP)—Argentina's capital city returned to work today after virtual suspension of commercial and industrial activities yesterday while a throng estimated unofficially at almost a half million, march through the streets in a demonstration arranged by opponents of the military government. The only incident reported was a brush between a group of demonstrators and mounted police as sabber-brandishing officers sought to disperse the group.

ROUGH ROAD FOR TRUMAN

House May Defeat Curtailed Jobless-Aid Bill

Washington, Sept. 21.—(AP)—Given the severest Senate rebuff since he took office, President Truman may be in for even rougher treatment in the House on the issue of aid to the jobless.

Mr. Truman's proposal for broad expansion of unemployment compensation was tossed over to the House after the Senate turned its thumbs down on a large part of the administration program. The chamber did, however, agree to extend unemployment benefits to a maximum of 26 weeks at federal expense and to pay travel expenses for displaced war workers.

Senator Wagner (D-NY) said the bill, passed by voice vote in the Senate yesterday, is greatly "watered down" from urgent presidential recommendations.

Administration troubles were multiplied in the House, as leading members of the Ways and Means Committee declared the legislation, as proposed by the President, would "promote idleness."

The Senate rejected Mr. Truman's proposal that Congress provide benefits up to \$25 a week by supplementing jobless programs administered by the states. This action left payments at the various state rates, which range from \$15 to \$28.

The bill as passed by the Senate provides for:
1. Payments to the jobless for 26 weeks, with the federal government taking over after the state's duration of payments has expired. For instance, if a state provided \$20 a week for 20 weeks, the federal government would pay \$20 for six weeks more. Present state programs range from 14 to 26 weeks.

2. Unemployment compensation protection for some 2,900,000 federal civilian workers and 400,000 maritime workers. Payments to these persons who lose their jobs would be at levels of the state where the

employees worked.
3. Travel allowances to permit former workers to go home or to a new job. A \$200 limit is put on the amount for one worker and his family.
4. Return of the U. S. Employment Service to the states within 90 days.
Members of the Ways and Means Committee predicted the House strike out the provision for extending the duration of benefits. A few said the committee, which takes up the bill Monday, might kill the measure completely.
During hearings on the legislation as recommended by the administration, both Chairman Doughton (D-NC) and Rep. Knutson of Minnesota, senior Republican, said it would promote idleness. Doughton said he viewed the problem as not one of unemployment but of redistributing workers.

More Butter
Washington, Sept. 21.—(AP)—Food manufacturers will be allotted slightly more butter during the last three months of the year than during the current quarter.

Announcing this today, OPA said the butter ration of these users would be from 67 to 70 per cent of consumption in the 1942 base period. It is now 50 per cent.

Hero Returns
Oakland, Calif., Sept. 21.—(AP)—Lt. Col. James P. Devereux, who surrendered Wake Island to an overwhelming Japanese force, landed at the Oakland airport today. Devereux recently was freed from a prison camp in Japan. He was accompanied by 11 Marines, all former war prisoners.
