JAPS FACE LIFE OR DEATH DECISION

LeMay Warns Civilians To Flee From Eleven Cities

Commander Of Superforts Boldly Lists Next Targets Of His Giant Bombers; Leaflets Tell Jap People To Overthrow Leaders And Seek Peace Or Face Death

Guam, Saturday, July 28—(AP)—The Twentieth Air Force bluntly announced to Japan today the 11 cities which are next on the B-29 fire-bombing target list and, in the unprecedented pre-strike warning, announced that four or more of the cities will be ignited within the next few days.

The warning, punctuating Allied demands for Japanese surrender, was issued by Maj. Gen. Curtis LeMay, who advised 800,000 Nippon civilians to flee to safety and "restore peace by demanding new and good leaders who will end the war."

In a frank effort to convince the Japanese people their cause is hopeless and the military is powerless to protect them, LeMay gave the Japanese this warning:

As this was written Superforts from the 73rd Wing were returning to Saipan after showering 60,000 warning pamphlets on each of the 11 cities.

Here are the cities which are being targeted by the B-29 Superforts: Ichinomiya, Tsu, Ujijima, Nagasaki, Nishinomiya, Aomori, Oga, and Koriyama, all multi-industrial, transport and industrial centers on Honshu; Urawa, a shipping and war plant center on Shikoku; Kurume, rail hub, manufacturing center and location of an arsenal on Kyushu; and Hakodate, financial and manufacturing center of Hokkaido Island.

Urawa and Ichinomiya are the only ones bombed before in incendiary raids.

Sometime within the next few days LeMay said "a normal force of Superforts carrying about 3,500 tons of bombs" will strike at industrial targets in four or more cities. Strikes in recent weeks have been averaging from 450 to 600 plane each.

The warning, which will be broadcast to Japanese at intervals by the Office of War Information starting at 8 a. m. today (6 p. m. Friday, U. S. Eastern War Time), came while pillars of fire rose from ruins of three industrial cities set afire by 350 Superforts early Friday.

Friday's raid was the third in four days.

Black-haired, stocky, cigar-chewing LeMay said:

"The Japanese have refused to come up and fight. We have been burning their air at will, burning down their cities. Now we are telling the citizens what towns we are going to burn down."

Permits To Be Given For 15 White Units And 10 Negro Units

The new war housing program providing for the construction of private housing in six North Carolina cities, including Greenville, has been approved by the National Housing Agency. Willard T. Kizer, executive secretary of the Greenville Chamber of Commerce, announced today.

The H-8 housing program for Greenville consists of 25 sales units, including 10 for Negro occupancy. The sales ceiling on the 15 white units is \$7,000. Negro units, \$3,500. These units may be produced for rental with a rental ceiling of \$60 on the white and \$30 on Negro units.

Kizer wrote Congressman Herbert C. Bonner last May 10 concerning a survey the Chamber of Commerce had made here. Bonner informed him that the Federal Housing Administration at Atlanta had stated that 25 housing units had been approved for Greenville, and that the matter would be handled through the Greensboro office.

Application forms will shortly be available at the Chamber of Commerce. Permits for building these 25 houses will do much to alleviate the acute house shortage in Greenville, Kizer said.

Liquor Rations Same Next Month

Raleigh, July 27—(AP)—Retail liquor stores in the 25 sales counties have been issued the following order by the state ABC chairman, Carl E. Williamson, governing the month of August.

"Coupons Nos. 33 and 34 will be valid any time during the month for one quart or one-fifth each, or two pints or two-tenths each, of any whiskey or scotch."

Expect Vote On Charter Tomorrow

Senate Holding Over-time Session Today And Will Meet Earlier In The Morning With The Hope Of Final Vote by 5 P. M.

Washington, July 27—(AP)—Senator Barkley (D-Ky.) urged the Senate today to prepare for a final vote ratifying the United Nations charter at 5 p. m. (EWTN commentary).

The Democratic leader told his colleagues he wants them to stay on the job till 7 p. m. tonight. He asked for a meeting at 10 a. m. tomorrow, two hours earlier than usual.

Barkley's move to wind up consideration of the 50-nation peace-keeping agreement this week won the support of Senator White (R-Me.), the minority leader. White said it was "difficult to conceive that anything new can be said" about the charter.

However, Senator Morse (R-Ore.) served notice he would object to any limitation on debate, declaring "I'm going to keep the forum open."

Opening the fifth day of debate, Senator Tamm (D-De.) said Senate approval of the charter would commit the United States to furnish troops and equipment to the proposed international organization to help keep world peace.

Tamm argued the military agreements to be made with the projected security council should be submitted to both houses and not referred alone to the Senate as a treaty.

Tamm told his colleagues he had received a printed announcement declaring that any appropriation made to finance "an unconstitutional act" itself would be unconstitutional, and it is the privilege of the people to refuse to contribute to the support of such legislation.

"This article is clearly treasonable and intended to incite rebellion against the acts of Congress," Tamm said. "The fact that some persons or organization is willing to expend money for the purpose of inciting treason is worthy of some investigation."

Juvenile Delinquency Babson Thinks Food A Factor

Gloucester, Mass., July 27—This youth where I was brought up has its youth problem the same as every other city. It is probably worse today than when I was a boy; but considering the additional distractions of today, such as automobiles, movies, radios and funnies, the situation is not so much worse. I am sure that if these new factors had existed fifty years ago the youth problem would then have been serious.

Reasons For Behavior

There are four basic reasons for behavior, viz: Heredity, environment, home training, religion and food. When discussing the teenagers or the bobby-sox girls of today, it is too late to consider heredity so far as they are concerned. Their diet has been cast. Furthermore, as everyone recognizes the importance of home-training, I need not here discuss this, except to say that much of the trouble which parents are having is due to the poor example they set.

I will say something about the other two factors, namely, religion and food, to which we owe 90 per cent of our troubles and disappointments as well as our successes and pleasures. Certainly the behavior of our children is greatly influenced by what they believe and by what they eat. Too many preachers seem to think that religion is something apart from food and drink. There is nothing in the Bible which substantiates this notion. In fact, the food which the Jews were allowed to eat, by their priests, was an important part of their religious ritual.

World Awaiting Official Jap Reply To Ultimatum

Speculation And Rumors Accompany Washington Reaction To Potsdam Ultimatum; Former Jap Diplomat Urges His People To Accept The Terms

Washington, July 27—(AP)—This capital buzzed with speculation and rumor today over the possibility of a prompt Japanese surrender under the Potsdam ultimatum.

Many officials hoped that the bold stroke of psychological warfare engineered by President Truman, Winston Churchill and Generalissimo Chiang Kai-shek would get that result. But none could or would predict it.

The consensus on Capitol Hill was that the eight-point definition of unconditional surrender laid down by the Big Three of the Pacific war constituted a hard, just peace.

What Nippon's leaders have to gain by accepting now is an end to the destruction of their country. Against this they have not only the certainty of mounting Anglo-American-Chinese assaults but also the obvious possibility that Russia may go into action in Asia. This possibility is emphasized by the fact the ultimatum was issued at Potsdam.

And Japanese leaders now know definitely two things of which they appear to have been unsure before:

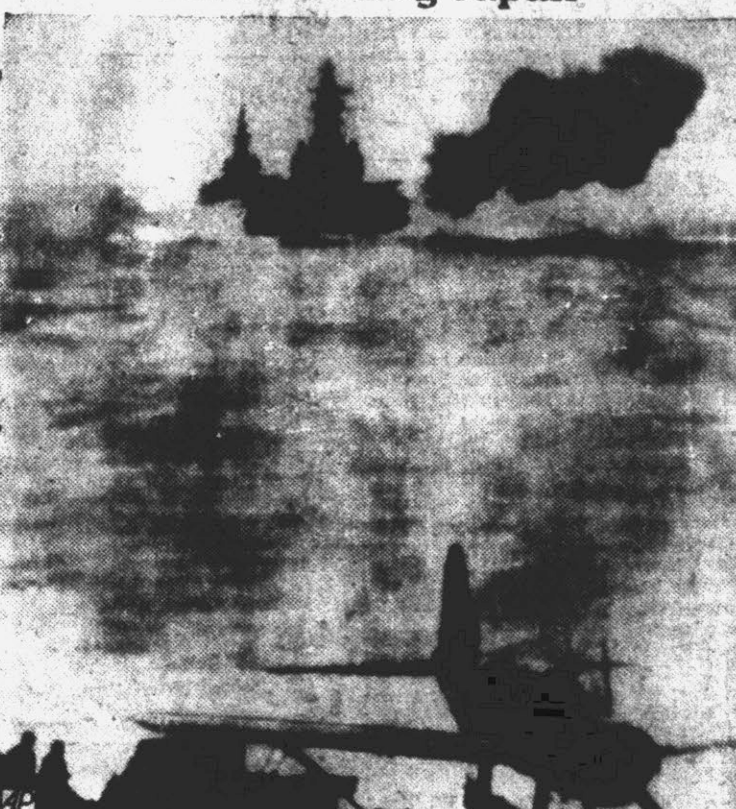
1. The Allies have no intention of offering a soft or compromise peace.

2. The way is left open for the Japanese people to try to save their imperial throne. Diplomatic authorities consider it significant that yesterday's ultimatum made no mention of destroying the emperor or the throne while on the other hand it promised the enemy freedom of religion and eventually of government.

Whether the present emperor, Hirohito, would be allowed to remain on the throne might depend on whether the Japanese people appeared to want him and whether he could serve Allied purposes in giving Japan a peaceful, responsible government.

Election Leaves U.S. Politicos Wondering

Some Think British Swing To Left Will Be Reflected In America

Washington, July 27—(AP)—British rejection of the Churchill government set American politicians wondering today whether the postwar era will bring an American turn to the left and what will happen if it does.

Members of Congress voiced wide disagreement over the effect they think the British voting results may have on the war with Japan and on general international relations between this country and Britain.

But the victory of a Labor Party which campaigned for government ownership of Britain's basic industries convinced many that the United States may face similar issues when the Pacific War ends.

Senator Austin (R-Vt.), for instance, said he thinks the two major parties will have to improve upon their flexibility to meet domestic and foreign problems.

"We are confronted with the greatest attack on free economy in history," Austin told a reporter. "If we maintain the capitalistic system and free government we will have to improve our flexibility and move quickly to meet economic, political and international problems."

Senators Johnson (D-Colo.) and Wherry (R-Neb.) said they thought the left wing victory in England "shows the way the world is going."

Both added, however, that there are few signs in this country now of a similar trend.

Japanese News Agency Declares Nation Will Ignore Allied Demand For Uncon- ditional Surrender And Will Prosecute War To The Bitter End

San Francisco, July 27—(AP)—The world waited today to see whether the Japanese government would confirm the Domei agency report that Japan will ignore the American-British-Chinese ultimatum to surrender or be destroyed.

The Nipponese news agency did not state the source of its "authoritative" report. But it did disclose that the cabinet had met and that the Allied surrender proclamation was discussed. Perhaps a cabinet member was Domei's source.

As for the Japanese people, they got only a dead-pan and incomplete account of the ultimatum in these words:

"A proclamation was issued in Potsdam yesterday (Thursday) in the name of Churchill, Truman and Chiang Kai-shek calling upon the Japanese to announce unconditional surrender or see their homeland destroyed. Reuters reports from Potsdam. Stalin's name was conspicuous by its absence in the proclamation."

This version appeared framed to convince the Japanese people of two things:

1. The Allies are hard-hearted and cruel, determined to destroy the Japanese race. Tokyo did not mention Allied assurances of a peaceful future for Japan according to Atlantic Charter guarantees.

2. That the reason Marshal Stalin did not join in the ultimatum constituted a blow to President Truman, Mr. Churchill, and Generalissimo Chiang Kai-shek. The brief then conveniently ignored the fact that Russia is not at war with Japan and could hardly join in an ultimatum.

Meanwhile it was reported from Salzburg, Austria, that at least one Japanese militarist has admitted he was wrong and that Japan should surrender unconditionally.

He is Gen. Hiroshi Oshima, the Japanese ambassador to Germany at the time the Nazis surrendered. Oshima's movements both before and after the German capitulation were under close scrutiny today. He and his staff, it was reported, could have surrendered to neutral Russians or got into Switzerland, but they fled westward toward American lines and allowed themselves to be taken by their enemies instead.

A possible answer came from Salzburg. U. S. army censors allowed correspondents to cable the news that Oshima's secretary, American-born Toshio Yamazaki, said that before Oshima was brought to this country for internment he made a "recommendation" that Japan surrender unconditionally.

Today On The Home Front

Washington, July 27—(AP)—People ask: Does the Army or civil authorities take custody of a soldier who commits an offense in a civilian community?

For instance: Suppose a soldier, without cause, shot and killed a city cop.

The War Department gave this answer: The Army always decides. It can try a man or let the civil authorities have him.

Army courts are patterned after civil courts, in a fact they range from courts that try for minor offenses to courts that try for serious crimes.

There are three kinds of court martial: summary, special, general. The work as follows:

1. A summary court martial. It consists of one officer. He can order up to—but no more than—one month in jail or forfeiture of two-thirds of one month's pay.

2. A special court martial. This consists of any number of officers, but not less than three. They can order up to—but no more than—six months' confinement or a fine equal to 6 months' pay.

3. A general court martial. This consists of any number of officers, but not less than five. This court, like a state criminal court, tries for serious offenses like absence without leave, desertion, rape, murder.

The verdict of the general court martial is not necessarily final. The verdict and sentence must be passed upon by the person—usually a high ranking officer—who appointed the court.

He can approve or disapprove the verdict and cut down the sentence. He can never increase the sentence. His action also is not final. It is subject to further review.

To explain the procedure in operation, here's an example of an actual case. The name Smith is used instead of the soldier's right name.

He was drafted in 1942. In the first year of service he was AWOL (absent without leave) five times.

The first four times his company captain disciplined him by ordering him not to leave the post for 1 week.

The fifth time he went AWOL he was given a summary court martial which ordered him confined for 1 month.

In 1943 he disappeared from the Army. Eight months later he gave himself up. He was taken before a general court martial on a charge of desertion.

He was given a defense counsel, had a trial, was convicted, was sentenced to 15 years imprisonment, all his pay was forfeited, and he was ordered dishonorably discharged.

The verdict was reviewed by the judge advocate on the staff of the general who was in command of Smith's. Because Smith had given himself up, the judge advocate recommended:

That, instead of desertion, he should have been tried on the lesser offense of AWOL, that his sentence should be reduced from 15 to 10 (Continued on page four)

An Analysis Of The News

Winston Churchill has gone down to political defeat in the midst of that stirring drama which brought him to power and in fact has marked his whole adventurous life, for as his government was being voted out of existence he signed the historic Allied ultimatum of Potsdam, calling on Japan to surrender unconditionally or suffer "prompt and utter destruction."

That was a "fitting farewell gesture for a gallant warrior—one of the great figures in English history—who has had so great a part in saving the world from Axis slavery. This edict, which in effect renews Britain's pledge to wage war against Nippon to the finish, of course made the approval of the new Prime minister, Major Clement Attlee, who has been attending the Big Three conference as Churchill's "deputy." Attlee says England will see it through.

Conservative party and represents a heavy swing to the left.

The Leftist development in England isn't new, although there have been those who refused to see it. This column has been pointing to it consistently since 1942. However, as I remarked yesterday, we shouldn't misunderstand the meaning of this trend, for it has little to do with long-haired intellectual Socialism. It isn't revolutionary but evolutionary—a gradual development arising from the search of the working class for a better way of life. One would expect it to progress without fireworks.

The Labor party aims at "a Socialist Commonwealth of Great Britain." This contemplates as an initial step the nationalization of coal mines, iron and steel plants, railroads and all other forms of public transportation. Public ownership of the Bank of England also is advocated.

Of course this presages a great change in England's domestic politics. It means further breaking up of the vast estates of the landed gentry. It means an acceleration of the leveling off of incomes. The England of Queen Victoria has gone forever.

However, while we may expect a big change domestically, Britain's foreign policy is likely to remain broadly the same. Britain's recommended rehabilitation of Europe will be carried out in full.

Wright Aeronautical Corporation in New Jersey and to approximately 20,000 at the Chrysler Corporation's huge Dodge Chicago plant came last night as production of the bomber engines was at a virtual standstill.

"These two plants manufacture four-fifths of all B-29 engines," Patterson said in a statement in Washington. "The supply of those engines is so short that the B-29 attacks on Japan will be reduced within a matter of days if these strikes continue. That will mean an unnecessary prolongation of the war."

"The entire Japanese empire has been unable to stop the heavy B-29 attacks on Japanese war industries," Patterson said in his statement, but he added that the strikes in Chicago and New Jersey will stop those attacks unless the strikes are terminated at once.

Robert Wright, president of local 274, United Automobile Workers of America (CIO), whose members are on strike at the Dodge plant, replied to Patterson's statement and charged that the company had refused to negotiate grievances. He asked the acting war secretary to send telegrams to both the union and company to discuss their differences.

"Then it is possible that the people will immediately return to work," Wright said.

The 50,000 strikers at the six plants comprised the bulk of the almost 90,000 idled by labor disputes throughout the country, affecting about 30 industries. The number was the largest in almost a month.

The employees at the New Jersey plants of the Wright Aeronautical Company yesterday rejected pleas of union leaders to return to work and production halted at the plants in Woodridge, Patterson said. The strike started a week ago in the Woodridge factory and spread to other plants.

Increase Denied
Washington, July 27.—(AP)—Stabilization Director William H. Davis turned down today a request by the southern pine industry for an increase of \$2.75 a thousand board feet in maximum prices.
Davis said, however, he "would consider favorably any practicable proposal" for the relief of marginal producers of southern pine lumber.

are convinced that Japan has lost the war and we feel that if we can convince enough of them they have nothing to look forward to but total destruction, we may shorten the war.

"We are not trying to kill civilians but to destroy the war potential of the military clique. We are telling them where we are going to hit and they can't do anything about it."

LeMay said his command has given much thought to the safety of the crews but "we don't expect any more opposition than usual. They can't mass sufficient defenses over 11 widely separated cities to make this any more than the normal mission."

"We cannot promise that only these cities will be among those attacked (in the next few days) but at least four will be, so heed this warning and evacuate these cities immediately."

Friday's mission was carried out with the loss of only one B-29.

The reluctant Japanese air force, however, put up some fighter opposition to the new American raid after having made aggressive interception against carrier planes and Liberators over the homeland on Wednesday in an apparent reversal of the recent passive resistance.

The sudden resumption of fighter defense still was not on a great scale and failed to prevent the success of the various American assaults which put a total of nearly 4,000 American and British carrier and land planes over the home islands in three days.

The Superfortresses, more than 350 strong, lost one plane in dropping 2,200 tons of fire bombs that set great conflagrations raging before dawn in the southwestern industrial cities of Osaka, Matsuyama and Tokuyama. Returning airmen said the flames spread beyond the target areas, sending columns of smoke 18,000 feet into the cloudy sky.

The Army Far East Air Forces of Gen. George C. Kenney disclosed that for the first time since they began raiding Japan from Okinawa on July 3, they ran into fighters over Kyushu on Wednesday.

The Seventh Air Force Liberators had to leave their fighter escort behind because of bad weather. Some 30 Japanese pilots jumped at this seeming chance. In the result a series of fights, one Liberator was lost and others were holed severely, but they shot down at least 11 interceptors and left the aviation center of Tsuki wreathed in flames and explosions.

Similarly the U. S. Third Fleet's carrier planes met scores of Japanese fighters when they attacked the Kure naval base on Wednesday. Nineteen interceptors were shot down.

The fleet itself with its 1,000-odd planes was somewhere at sea today.

day under a security blackout after worsening weather ended its smashing attack on Wednesday alone. The Japanese, who contended in radio broadcasts that they were hoarding their admittedly scarce planes to combat in imminent invasion, relied on unusually heavy antiaircraft fire for defense of the Shanghai area against some 300 Fifth and Seventh Air Force Liberators, Mitchells, Invaders, Thunderbolts and Mustangs.

On both Wednesday and Thursday, Privateers of the naval force maintained their close blockade of Japanese shipping. They sank four and damaged five Japanese vessels in Sagami Channel south of Tokyo on Wednesday, and sank six small freighters, a trawler and barge and set another freighter on fire in extensive patrols off western Honshu and in Korean waters Thursday.

These big land-based naval planes also ran into Japanese interceptors shooting down two of seven Thursday.

One of the great religious figures of a generation ago was Lyman Abbott, editor of the Outlook. I recall how as a young man I awaited his articles and editorials each week with the greatest anticipation. He influenced the thoughts of thousands of us.

Just recently I came across something he wrote shortly after his eightieth birthday on the prospect of approaching death. "I look forward to the great adventure, which now cannot be far off," he wrote, "with awe but not with apprehension. I enjoy my work, my home, my friends, my life. I shall be sorry to part with them. But all my life I have stood in the bow looking forward with hopeful anticipation to the life before me. When the time comes for my embarkation, and the ropes are cast off and I put out to sea, I think I shall be standing in the bow and still looking forward with eager curiosity and glad hopefulness to the new world to which the unknown voyage will bring me."

I remember hearing Dr. Abbott preach when he was past eighty-five, and I felt that he could not have preached better when he was half that age. Sometime later he passed away, still "standing in the bow" and looking into the future with that vital eagerness which characterized his whole life.

AMERICA IN WARTIME

(Jack Stinnett Is On Vacation)
Washington—The secretary of a certain senator is taking a college course in English composition in what little spare time she has. Recently the class was asked to write a theme on any subject upon which an opinion could be expressed.

Here is part of what she wrote: "I believe there should be some restrictions made on writing to congressmen during wartime, and I'll tell you why."

"In the first place I cannot reconcile the daily hue and cry to be heard every day over the radio—'Carry unwrapped packages; do not waste paper, a vital war material'—with the enormous amount of paper that is consumed in the correspondence between senators and representatives and their constituents."

"If people have an important piece of legislation that they want introduced to the Congress, or a legitimate problem that they wish to present to their representatives or senators, that is their right and privilege and I am all for it. But practically 75 per cent of all the mail received on the Hill doesn't accomplish a thing and might just as well never be written."

Here are several examples of what I mean: A great amount of the mail has to do with other departments of the government, the State Department, the Treasury Department, the Post Office Department, the War and Navy Departments, the Office of Price Administration, the War Production Board; and the office of the congressman is simply a transmittal agency.

"They send the constituents' letter to the various departments with a covering letter asking for a report on the matter mentioned. Nine times out of ten the department to which the original letter is referred has already received an exact duplicate from the same person about the same question."

"In due course this department sends the congressman the report on the case and he in turn sends it to the constituent with another covering letter. Not only this, but the same constituent has in the meantime, written to both their senators and several representatives on the same matter, and they all go through the same procedure. What else can they do?"

"There is an unwritten law that congressmen must acknowledge all the mail they receive. And yet they

do not have the authority to decide departmental matters, they are not supposed to use P. I. (political influence) with the War or Navy departments and they are not in a position to appoint delegates to the peace conference, for instance, or to issue visas for the foreign wives of our servicemen to enter the United States."

think we should make here. The Laborites undoubtedly will do their utmost to shake off the tradition of imperialism that has clung to the Conservative party like the old man of the sea. Among other things this might give rise to a fresh effort to settle the dangerous Indian question. And it might influence the government's policy towards P. I.'s pre-war spheres of influence—Greece and the Middle East, for example.

Sixty-two year old Attlee while totally lacking the color and magnetism of the Churchill personality, is an earnest and determined leader. He is generally regarded by his colleagues as being the good Samaritan type of Socialist. He is thumbs-down on Communism for Britain (although friendly towards Russia) and always has preached against dictatorships, either of the left or of the right.

Attlee has been a Laborite since the birth of the party. He is the son of a London lawyer and is a graduate of Oxford. He also studied law but deserted that for social work. He went to live on London's poverty ridden East Side, and earned a living as a dock worker. The constituency which returned him to Commons is Limehouse, locale of some of the world's most famous mystery stories.

approved. Then the whole case was sent to the office of the judge advocate general in Washington. This office approved of the general's action in reducing the sentence. Smith started serving his time.

Six months later his record was sent to the Undersecretary of War for clemency review. His record in prison was good. The undersecretary decided to cut his sentence down to two years.

(The case of every soldier sentenced by a general court martial to a disciplinary barracks or federal prison is reviewed for clemency 6 months after his confinement. A similar review is made every year thereafter.)

Smith's case will come back to the undersecretary for review a year from now. His sentence then may be further reduced.

If Smith's conduct continues good he may, when finally released from confinement, be restored to duty and in that way obtain an honorable discharge.

(D-Wash) suggested that the Democrats would benefit. Several Republicans contended, however, that Churchill's loss of the premiership was merely a case of turning the "ins" out, a result they said might well come in this country in the next general election.

Opinions also were varied about the effect on the Japanese war of the British change in leadership. Senators George (D-Ga), Taft (R-Ohio) and McKellar (T-Miss) felt it would make no difference.

But Senator McFarland (D-Ariz) was "afraid the British regard the war as over." A viewpoint shared by Senator Moore (R-Okla.). (In London Clement R. Attlee, the new prime minister, said "the first thing we have to do is finish the war with Japan.")

Senator Bridges (R-NH) thought the United States would have to "reappraise our entire relationship with Britain" in the international field. Taft, however, said he believed there would be little difference in the policies of a government headed by Attlee and that which Churchill captained.

Senator Ferguson (R-Mich) said "it looks like we will have to start all over again in our relations with Britain" and George added there is bound to be some "uncertainty." It might be all for the best, though, said Senator Ball (R-Minn). A labor government, he continued, might have a more American viewpoint on international problems than Churchill who "played the empire hard."

Russia did not sign the proclamation issued late yesterday from this scene of the Big Three conference, but the absence of Premier Stalin's name was no insurance against Soviet intervention in the Pacific war. Stalin conducted a long series of conversations with Chinese Premier T. V. Soong just before coming to Potsdam.

(The Japanese News Agency Domei said the ultimatum would be ignored and that Japan would fight to the "bitter end.")

The ultimatum included these terms and said "We shall not deviate from them: There are no alternatives: We shall brook no delay."

1. Japan must overthrow her militarist ruling clique.
2. Undesignated points of Japanese territory will be occupied until Japan's war power is convincingly destroyed.
3. Japanese sovereignty will be limited to the four main islands of Honshu, Hokkaido, Kyushu and Shikoku, and minor islands. This

would strip Japan of all her conquests and other dominated areas, including Manchuria, North China, Korea, the Bonins, Kuriles, Pescadores, Formosa, mandated islands, Netherlands East Indies, Malaya, French Indo-China, Thailand.

4. Japan will not be allowed to return to peaceful pursuits. 5. Japan will not be enslaved, but "stern justice shall be meted out to all war criminals," especially those responsible for cruelties on prisoners.

6. Japan must restore freedom of speech, religion and thought and establish respect for fundamental rights. 7. All armament industries will be taken from Japan. Raw materials will be permitted for essential economy and to permit payment of reparations.

8. Occupation will end when Japan loses her warlike attitude and leadership. "We call upon the government of Japan to proclaim now the unconditional surrender of all Japanese armed forces, and to provide proper and adequate assurances of their good faith in such action," the ultimatum from President Truman, President Chiang Kai-shek, and Winston Churchill, then British prime minister said.

"The alternative for Japan is prompt and utter destruction."

Relations Committee had counted only 13 more Senators who wished to make formal speeches.

Only when the debate closes will Connally be able, under the rules, to cast up the formal ratification resolution. Even then a single objection could hold it for consideration another legislative day. Connally, however, expects no delay from that contingency.

The fourth day of debate yesterday lacked the fire of some of the previous sessions. Senator after senator went on record for the international peace preserving plan, but the chamber's attention inevitably strayed to the news from Potsdam of the American-Sino-British ultimatum for Japan's immediate capitulation.

Senator Wherry (R-Nebr) observed that the ultimatum "ought to be a boon toward passage of this

charter." Significant of the changed sentiment of the Senate in 25 years, Senator Capper (R-Kans), who voted against the League of Nations a generation ago, announced his support for the new charter and expressed the opinion it would work.

It will work, he predicted, "because of the realization that unless the Big Five—particularly the Big Three—work together in the post-war world, the prospects of avoiding a world war III are slender indeed."

Senator Pepper (D-Fla) delivered the day's longest speech—two hours and a half. The Senate's obvious intention of ratifying the charter, he said, means "we have won the peace."

The Florida senator stressed heavily his contention that the agreements necessary to implement the charter can be handled through joint resolutions requiring simple majorities of both houses of Congress, rather than through treaties, which take two-thirds Senate approval.

vides 15 white sales units and 10 sales units for Negro occupancy, with a sales ceiling of \$7,000 for the white and \$2,500 for the Negro units. These units may be produced for owner occupancy or for rental purposes with a rental ceiling of \$40 on the white units and \$30 on the Negro units. It is not expected, however, that all dwelling units will be produced to sell or rent at maximum prices.

"The units built under this quota will not carry occupancy restrictions. Certificates for priorities covering not more than 50 per cent of the quota may be issued prior to October 1, 1945. Furthermore, at least 30 per cent of the priorities granted during any quarterly period are to be issued to individuals for homes of their own."

"Private builders and other persons interested in the production of new dwelling units under this quota should make application for priority assistance and authority to begin construction to Jack H. Brown, state director of the Federal Housing Administration, Greensboro, N. C. Undoubtedly Brown will be glad to supply any additional information desired and to ren-

der full assistance in making priorities available." Secretary Kyzer will be glad to give further information upon request.

Georgia Sales Heavy.
Valdosta, Ga., July 27.—(AP)—Continued heavy sales and steady to slightly higher prices appeared likely again today on the Georgia-Florida fine-cured tobacco belt.

The USDA marketing service reported yesterday that 15,631,012 pounds of untied bright leaf tobacco was sold in the first two days of auctions on the 19 markets. The season opened Tuesday.

Gross sales Wednesday for Georgia totaled \$671,806 at an average of \$41.58 per hundred, and Florida, \$712,032 at \$41.10. A general average of \$41.35 was established for the belt on Wednesday.

A season average through Wednesday of \$41.28 per hundred pounds was registered.

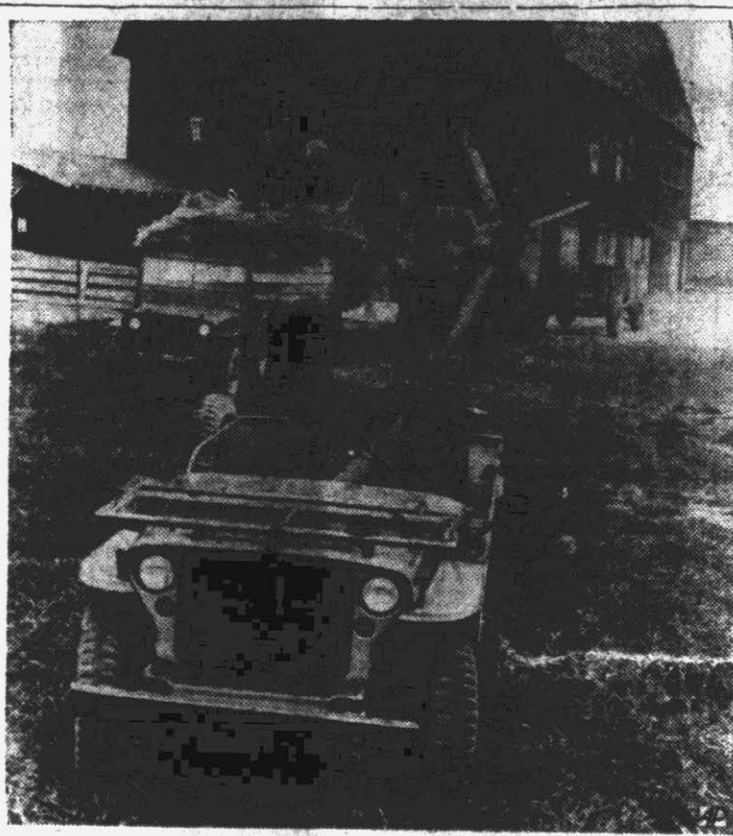

Ruffing wasn't able to finish although he had a neat two-hit shut-out through the first six innings, played in oppressive heat and gathering gloom that twice forced interruptions, once for an hour. It was so dark in the mid-innings that spectators followed the ball only by watching movements of the players.

Charley the Red, sat out the long wait and picked up again where he had left off. But after tripling in the sixth, was forced to retire after yielding a walk, two singles and the first A's run in the seventh. Al Gettel finished but Ruffing received credit for the victory.

Not since the final game of the 1942 World Series with the St. Louis Cardinals had Ruffing started a major league game. Then, under similar shadowy weather conditions, Whitey Kuroski pulled a fast ball into the left field stands completing the upset of the Yanks.

New York's victory in the only scheduled American League contest sent them into a three-way tie with Chicago and Boston for third place, only four lengths behind leading Detroit.

AUSTRALIA TO REDUCE ARMY

Will Retain Forces For Part In Pacific War

Canberra, July 27.—(AP)—Australia plans to reduce her army 50 per cent and her air force nearly as much, but considers it vital that her forces take part in the main offensive against Japan. Prime Minister J. B. Chifley told the House of Representatives today.

He said the army would be cut from six divisions to three and the air force from 53 squadrons to 25 but that the Navy would be maintained at its present strength.

Chifley added that the government advisory war council proposed Australia's main contribution to the offensive be a Royal Australian Navy Squadron, under its own command, and an expeditionary unit of land and air forces operating under Australian commanders in a manner similar to the Australian Imperial Force (AIF) when in the Middle East.

He added that three Royal Australian Air Force (RAAF) squadrons from overseas would be provided as a contribution to the very large range RAF task force in the Pacific. These would be in addition to two RAAF fighter squadrons already overseas for participation with the forces of occupation in Europe.

A token force would be associated if possible with the British in operations to recapture Singapore to avenge defeat there in 1942 and to contribute to liberation of Australian prisoners of war.

The remainder of Australian forces would continue their present operations in Borneo, New Guinea, New Britain and the Solomons.

Chifley said the government council's views were that if any change were made in boundaries of the present command setup in the Southwest Pacific area, operational control of Australian forces on the mainland of the commonwealth, Papua and Australian mandated territories should revert to service authorities, who would also control any allied forces that might be assigned to those areas.

Chifley added, "Any arrangements for a change in the command setup relating to control of Australian forces should continue to provide that the commonwealth have an effective voice in policy governing use of our forces and the following principles embodied in (General) MacArthur's directive should be maintained:

"The right of the government to refuse the use of its forces for any project which it considers inadvisable.

"The right of commanders of Australian forces to communicate direct with the Australian government."

Clark took the stand about noon yesterday and testified that he had received something like \$5,000 from Dr. Meadows in payment for paying work and materials for the college. He stated that many times Dr. Meadows advanced sums of money to him before the work was finished and that sometimes the payments had been made in cash and sometimes by check.

On cross-examination he admitted that letters written by him to Dr. Meadows regarding the payments were based entirely on figures furnished him by Meadows and not from his own (Clark's) records as the letters stated. He further admitted that the letters were written in Greenville and turned over to Dr. Meadows late in December, 1943, although they bore datelines of Cocoa, Fla., several days prior to the time they were actually written. The letters stated that "from my records I find" and related certain dates and amounts of payments received by Clark from Meadows. Under Jones' questioning Clark admitted that he had no such records and that the figures in their entirety had been furnished him by Dr. Meadows at the time the letters were requested and that he had used Meadows figures in the letters as though they were his own.

Clark also admitted that he was summoned by the State as a witness for the first trial; that he had wired Solicitor Dave Clark that it was impossible for him to attend; that he later arrived in the city and was in conference with Dr. Meadows and members of his counsel at Meadows' home before he informed the solicitor he was in town. When the solicitor did not put Clark on the stand as a prosecution witness in the first trial the defense used him and the result of his cross examination at that time caused Clark to declare that he must be ignorant or he would not have used the Meadows figures and called them his own.

Jones held back no punches in grilling cross examination yesterday and courtroom spectators declared that Clark had fared even worse than during the first trial.

Weeds And Grass Menace To Health

BLUE POINT VALUES CUT

Several Canned Articles Increased, Others Reduced

Washington, July 27.—(AP)—Housewives, whose point worries have been chiefly red, got blue news today about the blues.

Beginning Sunday, six canned and bottled foods take on sharply increased ration values.

The increases, effective through the period except that a No. 10 can of corn, 6 pounds, 10 ounces, will require 130 instead of 100 points. These big cans are sold chiefly to hotels and restaurants.

Here are the increases:

Spinach, No. 1 can, 30 points, up 10; No. 2 can, 50 points, up 20; asparagus, No. 2 can, 20 points, up 10; applesauce, No. 2 can, 20 points, up 10; apricots, No. 2 can, 50 points, up 20; grape juice, pint, 40 points, up 10; grape juice, quart, 70 points, up 20.

The decreases:

Orange and grapefruit juice blends, 46-ounce can, 10 points, down 10; No. 2 can, 10 points, for two cans, down 10; grapefruit juice, 46-ounce can, 10 points, down 10; No. 2 can, 10 points for two cans, down 10; tomato catsup and chili sauce, 14-ounce size, 10 points, down 10.

The OPA said in announcing the point changes that new supplies of both asparagus and spinach for civilians will be only about half as large as from the last year.

Smaller amounts of both canned apples and applesauce also have been allocated from the 1945-46 pack. The prospective civilian supply of apricots is about one-third less than last year.
