President Decides To End Huge Lend-Lease Program

Future Foreign Buying Arrangements Doubt As Various Nations Study Possibilities Of Cash Loans Or Grants From This Country

Washington, Aug. 20.—(AP)—Lend-lease, a \$5-billion-dollar pipeline to victory, is closing down.

President Truman, it was learned over the week, has decided to end the mutual aid program under which this country has poured more than \$40,000,000,000 worth of weapons, food and equipment to bolster the Allied fight against the Axis.

In return, some \$5,000,000,000 has been channeled up as reverse lend-lease.

With victory now won on all the fronts, letters of notification have been drafted to advise foreign purchasing missions here that they will have to make some other arrangements for future supplies.

Presumably, this will bring a heavy demand for loans from the recently-expanded export-import bank.

Presumably, too, the action will lead to an early decision by this country on which goods it wants to export and which are to be left with the recipients for some future settlement.

Even before Mr. Truman's decision to terminate lend-lease operations became known, an influential London financial magazine took note of the fiscal problem Britain will face in the immediate postwar period.

The publication, the Economist, suggested in effect that Great Britain obtain a \$5,000,000,000 cash grant from the United States to permit her to pay off her foreign debts at about 50 cents on the dollar, with a note for the balance.

The United Kingdom has been the chief recipient of lend-lease aid. From inception of the program in March, 1941, to last April 1, latest date for which figures are now available, she received goods valued at \$15,750,000,000.

Estimating Britain's overseas indebtedness at between \$16,000,000,000 and \$20,000,000,000, exclusive of anything owed under lend-lease, the Economist said this amount should be scaled down in the light of inflated prices and that England then would need about \$6,000,000,000 in cash to carry out the funding program.

Posing its own question as to where the money might come from, the magazine added:

"Clearly, there could only be one source—the United States."

The suggestion produced obvious surprise in Washington. While officials declined immediate comment, it was plain they regarded the proposal chiefly as a British trial balloon.

There had been reports that England might seek as much as \$5,000,000,000 in financial aid from this country, but all such talk hinged on a loan basis rather than a outright grant.

Russia, with some \$8,410,000,000 worth of lend-lease assistance, ranks second to England in goods received. Soviet and United States officials recently concluded several months of conversations aimed at

TO TAKE HAND IN BALKANS

Effort To Be Made To Assure Free Elections

Washington, Aug. 20.—(AP)—The United States announced today it will send a commission to Greece soon to aid in securing a free election by secret ballot.

Russia declined an invitation to join helping make the Greek voting fully democratic. Britain and France will share responsibility with the United States.

The reason for Russia's aloofness was not disclosed. It may be related to protests of the western Allies about the governments which have been set up in Balkan countries where the Communists dominate under Soviet influence.

The first of these countries, Bulgaria, is to have an election next Sunday and Secretary of State Byrnes has warned that arrangements for it do not seem to be free from "fear and intimidation."

His statement apparently heralded a policy of applying political pressure to promote more democratic governments in the Balkans.

London, Aug. 20.—(AP)—Foreign Secretary Ernest Bevin told Commons today that the governments of Bulgaria, Romania and Hungary—all in the Soviet sphere—"do not represent the majority of the people."

He expressed conviction that the crown colony of Hong Kong on China's coast would revert to Great Britain, although he foresaw possible difficulties.

He said the new Labor government would welcome a change in the Spanish regime of Generalissimo Franco and would take no steps to "promote or encourage civil war in that country."

Bevin called on all Poles, military and civilian, to return to their country and said Generalissimo Stalin had assured him Russian troops would be withdrawn from Poland except "a small number required to maintain communications necessary for Soviet troops in Germany."

A peace treaty for Italy will be discussed soon by the conference of foreign ministers of the Big Five powers, Bevin said, expressing hope that the "treaty should be made on fair terms" rather than on revenge.

He said the United States, Great Britain and France had undertaken to "assist in supervision of an election" in Greece.

In the first full dress debate of the new government of Prime Minister Clement Attlee, Bevin declared Europe was "a happy hunting ground" for men seeking political power and warned sternly that the substitution "of one form of totalitarianism for another" must be prevented.

His remarks about the Balkans came early in his far-reaching review.

"The governments set up in Bulgaria, Romania and Hungary do not represent the views of the majority of the people," Bevin asserted.

"The impression we get from recent developments is that one kind of totalitarianism is being replaced by another," he told the House in the first full dress debate on the new Laborite governments foreign policy.

That, he said, "is not what we understand by that very much overworked word democracy which appeared to be in need of a definition."

(Secretary of State Byrnes on Saturday said the Bulgarian government that the United States considered it did not fully represent the people of Bulgaria.)

President Truman Orders Continued War-time Controls Needed To Aid Reconversion

Washington, Aug. 20.—(AP)—President Truman continued to give top place to postwar problems today, calling to the White House Reconversion Director John W. Snyder and a special advisory committee on reconversion problems.

The committee, headed by former Governor O. Max Gardner of North Carolina, consists of representatives of organized business, labor and farm groups. It was created to advise the Office of War Mobilization and Reconversion when Secretary of State Byrnes was director.

Before the committee met, another big cutback in war orders was announced. The War Shipping Administration cancelled \$425,000,000 of contracts for 135 vessels and special military equipment for the navy.

Seeking to speed the flow of scarce materials into civilian production, WPB Chairman J. A. Krug asked all prime and sub-contractors to cancel with "utmost speed" all orders for materials no longer needed to fill military commitments.

Krug's letter said that to do otherwise will "needlessly postpone the full-fledged reconversion effort which is crucial to the Nation's economic welfare."

To Support Demand For Control Pacific Bases

Washington, Aug. 20.—(AP)—Strong congressional backing lined up today behind a House Naval Committee's recommendation for firmer United States control of Pacific bases than through "gentlemen's agreements."

This country, the committee said, should at least have a working agreement for use of bases on islands held by our own Allies as well as Japan.

Just what Congress could do about this was uncertain. But indications are that both Senate and House will be asked soon to en record as supporting the committee's position and urging the State Department to strive for a strong United States hold on any islands needed to keep peace.

"It is apparent that we must be given very definite and tangible results with respect to the use of such areas," a naval subcommittee declared in a report made public by Chairman Vinson (D-Ga.).

"Nor can we rely upon 'gentlemen's agreement' in these matters," it added.

If the United States is to discharge her responsibility as keeper of the peace in the Pacific, the committee said, it must have the bases from which to operate. And these bases, the report continued, were taken at great cost in American lives and were built at great cost in American money.

The committee urged outright control by the United States of Japanese-occupied islands and outlying Japanese-owned islands and retention of "very definite rights" to

American bases built on islands controlled by our Allies. It withheld until later recommendations as to Formosa, Ponape, Jaluit and Yap, still held by Japan.

The report recommended "at least dominating control" over the Marshalls, the Carolines, the Marianas, the Ius, the Bonins and the Ryukyus; "specific and substantial rights" to sites of American bases on Allied islands, and "full title" to bases at Manus, Noumea, Espiritu Santo and Guadalcanal.

Japs To Sign Surrender Terms Within Ten Days

COUNTY WILL AID VETERANS

Arthur B. Corey Will Be Service Officer

At the request of the local post of the American Legion, Pitt County Commissioners in session Friday night voted to establish a veterans' office for the county and employ Arthur B. Corey as part time service officer to take care of veterans' needs in the way of claims under the GI Bill of Rights and other claims that may arise from their services to their country. Similar offices have been set up by a number of counties in the State.

Agreeing with Legion representatives that the county should offer every aid possible to the returning veterans or families of veterans who had paid the supreme sacrifice in the war, the commissioners ordered the establishment of the office September 1. Any Pitt County veteran, regardless of color or creed, or member of their families can visit Mr. Corey's office and be assured that their claims will receive proper and prompt attention without cost.

In addition to employing Corey as service officer the county will furnish a secretary for the office to aid in the interviewing, filling of forms, affidavits, etc.

The office will deal with every phase of servicemen's benefits including claims, hospitalization, information on loans, procurement of college education and any other matters between the veterans and the government.

In setting up the office it was the desire of the commissioners to render a real service to the veterans by making it possible for them to handle all their affairs through one office instead of having to follow the usual unsatisfactory custom of going from one agency to another in their efforts to have their claims adjusted.

Mr. Corey has done practically all the service officer work for the American Legion here during its 25 years of existence and is well versed in veterans' benefits.

WAINWRIGHT IS LIBERATED

Hero Of Bataan May Witness Jap Surrender

Chungking, Aug. 20.—(AP)—Lt. Gen. Jonathan M. Wainwright, the tall hero of Corregidor who was rescued from a Japanese prison camp by a humanitarian team of American parachutists, is due in Chungking shortly and may witness the formal surrender of the forces which held him more than three years.

Among the hundreds of Allied prisoners released by the sudden arrival of the airborne teams carrying relief supplies were Maj. Gen. George M. Parker, Jr., of Portland, Ore., who served under Wainwright in the final days of the battle of Philippines, and A. W. L. Tjarda van Starkenborgh Stachouwer, governor general of the Netherlands East Indies.

Also with Wainwright in Manchuria, it was learned on high authority, were Lt. Gen. Arthur Percival, British commander at Singapore when that stronghold was captured by the Japanese in 1942, and Sir Shenton Thomas, governor of Singapore.

The dropping of the humanitarian teams brought a protest from the Japanese general staff. The Japanese informed General MacArthur that the action endangered the smooth cessation of hostilities and asked him to see to it that

Today On The Home Front

Washington, Aug. 20.—(AP)—With unemployment facing millions in the months ahead, here's something to remember about unemployment pay.

First: If you're jobless now and eligible for unemployment pay, make application for the pay and a new job at your State's public employment office.

The rules that make you eligible vary by states. You'll find out whether you're eligible when you apply at the office.

To qualify, generally, you must have worked in covered employment, be jobless now, and be willing, able and ready to work.

This is how the unemployment compensation system operates:

All states and the District of Columbia have unemployment pay laws. Employers in all states pay into the State Unemployment Compensation Fund a percentage of their payroll. It's never more than three per cent.

In three states—Alabama, California, New Jersey—employers and employees both pay into the fund. But only workers in "covered" employments can get unemployment pay. Generally, workers in business and industry are "covered."

This is not always true. The states' laws vary, as noted. In one state an employer of one or more persons has to pay into the fund. In another state an employer doesn't have to pay unless he

Jap Emissaries Given Full Instructions As To Preparation For Allied Occupation

MacArthur, With Land, Sea And Air Forces Will Take Over When Weather Permits

Manila, Aug. 20.—(AP)—Formal surrender of Japan will be signed within 10 days, General MacArthur announced today.

Only adverse weather can delay the formal end of the war, the Supreme Allied commander said, as he sent Emperor Hirohito's delegates flying home with detailed instructions on the Allied occupation.

The homeland appeared troubled. The Japanese officially messaged MacArthur indicating that they would have to keep some forces under arms "for the maintenance of order in Japan as well as on the continent."

The same message asked MacArthur to send officials to investigate "the actual situation in China." (As heard by FCC monitors in San Francisco, the Japanese broadcast said Chungking and Communist leaders were making separate surrender demands, adding to a "confused situation.")

Within 24 hours after their arrival in Manila, the Mikado's emissaries left Nichols Field at 7:03 p. m. today. They left behind full details needed by MacArthur for imminent victorious entry in Japan at the head of ground, air and naval occupation forces. They will be prepared, said a headquarters spokesman, "for any contingency."

The envoys were told the date MacArthur and his accompanying forces intend to arrive in Japan and instructed to prepare the necessary airfields, harbors and other facilities for their arrival.

Takashi Kawabe and the other emissaries would report immediately to high government and military officials and perhaps to the emperor himself.

"We will do the best possible to make sure that all arrangements are completed on time," the emissaries said before leaving Manila.

It was understood that the formal surrender will be signed by General MacArthur in or near Tokyo. Thereafter, a statement issued by the supreme commander said, he will direct the Japanese headquarters to issue instructions for the unconditional surrender of all Japanese commanders abroad to surrender their forces to the appropriate theater commanders.

It was understood that all plans were definitely made during whirlwind conferences here last night and this morning and that no further exchange of radio instruction would be necessary.

Manila sessions definitely cleared the air, MacArthur aides said, and made a successful occupation of Japan more promising.

An Analysis Of The News

Preliminaries to the great drama of Japanese formal surrender have been staged in Manila by General MacArthur with firm but quiet dignity—an attitude calculated to remind the Mikado's sixteen emissaries that they were in the presence of conquerors but not bullies.

The supreme commander who personally remained aloof from the conferences seems to have struck the happy medium which will best serve the interests of disarming the Japanese nation, both physically and mentally, and to tend to create a stable peace. Some folks are doing a lot of worrying for fear we won't use the Japs rough enough, but thus far nothing has happened to encourage the idea that we are doing so.

MacArthur has been proceeding with shrewd authority. The signs are that the Mikado's emissaries have been deeply impressed, and in fact have known very well that they were in the presence of their masters. The Japanese response to this treatment is said to have been an apparently sincere attitude in furnishing the military information necessary for the delicate task of occupying Japan. This attitude of cooperation on the part of the entire Japanese delegation appears to be one of the outstanding facts emerging from the conference.

The pressing matter of the moment is the military occupation of Japan, and it is believed in Manila that this will soon come. The country is in a state of high tension, as is to be expected of a public which suddenly has been confronted with the first major defeat in the history of the nation. Each state turns its fund over to the Federal Government which puts the money in the treasury, with each state's account kept separate.

Then when a State has to pay out unemployment money it draws on its account.

About how much a week can an unemployed worker receive? Usually, about half of his weekly wage when he was working, but there is a top limit no matter how much he earned.

Today only six states have top rates of \$24 to \$28, including allowances for dependents. Not all states have allowances for dependents.

Ten states have top rates of \$15 a week. Do all workers receive the same unemployment pay? No. The amount and the number of weeks in which it will be paid depend upon the jobless applicant's past work record. Now

China's morale might have collapsed if the few thousand missionaries had left China when the American State Department did its best to get us out of there in 1937," says Mrs. Dorothy D. Social Security

No Matter At What Age You Die—Here is something you want to tell your family: Under old-age and survivors insurance, survivors benefits are payable when you die—no matter at what age that happens.

That is something some workers' families still don't understand. The wife and child of a living wage earner can get benefits until the worker is 65 or over and stops work. But they can get survivors benefits when the worker dies any time, whether it's before he is 65 or after—provided he is insured at the time of his death. There may be monthly benefits, or just a lump-sum, depending on who makes up the family. But almost always something is payable to an insured worker's family when he dies.

If the worker leaves no one immediately eligible for monthly benefits a lump-sum death benefit is payable if a claim is filed within 2 years. This lump-sum goes to the widow, widower, child, grandchild, or parent, in the order named. If the worker is not survived by any such relative the lump-sum may be paid to other relatives or friends in reimbursement for burial expenses.

So don't delay telling your family. You are building benefit rights for them. Make sure they know they can get their benefits when you are gone—no matter at what age death comes.

Bevin said the Greek Regent, Archbishop Damaskinos, has accepted an invitation to visit England "in order that we may discuss these problems face to face."

He challenged the accuracy of Yugoslav charges that Slav-speaking Greeks had been mistreated in northern Greece, saying the charges were not substantiated by investigations of British troops in that area.

Turning to relations with Italy, Bevin said the question of making a peace treaty with that former enemy country would be raised before the coming conference of the Big Five foreign ministers in London.

WASHINGTON DAYBOOK

By JACK STINNETT

Washington — There was just enough boondoggling in the WPA Federal Theater to make it a popular political football. It was one of the first of the depression projects opponents were able to kick clear out of the New Deal stadium.

Those serious-minded stage and literary folk who saw in it the germ of a national theater comparable to those operating in some 40 other major cities were sufficiently discouraged to let the whole business drop.

The tremendous success of the USO Camp Shows and of such Army sponsored projects as Irving Berlin's "This Is the Army" and Miss Hart's Air Forces play, "Winged Victory," has given the national theater hopefuls a new lease on life.

Sen. Elbert D. Thomas, the Utah senator who carries a lot of weight in Washington on matters cultural, has given them his blessing.

The plan for a national theater that would lift the stage out of the mere 36 cities which now have access to professional entertainment has been worked out.

Robert Breen, a sergeant discharged after three years' service in the Army; Cpl. Robert Porterfield, AAF; and Wilva Davis laid the plan before Senator Thomas and in the closing days before recess, the Senate passed it to his colleagues with the assertion that it deserves "the greatest encouragement, cooperation and serious consideration of those in a position to help."

Briefly, the plays and productions would have to meet standards of quality and be backed by "persons of business and artistic integrity." They would have to supply a definite need in the community or area in which they would be presented and the plan of operation would have to be sound.

The American National Theater and Academy, which has been functioning since 1935, would administer the foundation.

Funds would be raised by individual grants and bequests, industry and humanitarian foundation grants and allocations from county, city, state and federal governments—in other words, just as funds are now raised for libraries, museums and educational institutions.

Any one who knows the professional theater in this country can predict that "The Public Theater Foundation" has a rocky road ahead. It will be interesting to see if the New York producers, the big theatrical booking agencies and

much he earned and how long he earned it.

For how many weeks can an unemployed worker receive benefits? This varies, too. Some states, but few pay for as long as 26 weeks. Some pay for only 10 weeks.

But not all workers are eligible to receive unemployment pay for the maximum number of weeks provided in the state law.

If you don't know where to file an application for a job and a claim for unemployment pay—you have to be willing to work when you ask for the unemployment pay—ask at your nearest postoffice.

If you have been working in different states or if you move into a new state, and are jobless, you do what you would have done if you had remained in the state all the time.

You go to the unemployment office, register for a job, file your claim for unemployment pay, and explain about your work in other states.

The State Employment Security Agency will examine your claim and forward it to the other state, or states, in which you may be qualified for unemployment pay.

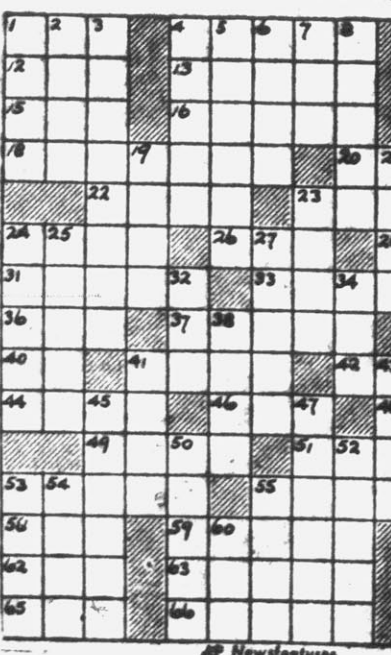
Any benefits to which you may be entitled under another state law will be paid to you by check sent directly from the states that owes them.

If you feel that the decision on your claim is wrong, you can appeal. Every state provides for a fair hearing on an appeal.

If you're turned down on that, you can go to court. Usually you have to act fast on an appeal, usually within five days after being notified of the decision on your claim.

certainly would please the American public to see Wainwright receive this tribute. He will go down in history as one of the bravest of the brave—the man who was given the terrible assignment of holding an untenable position as long as possible and then suffering the soldier's nightmare—surrender.

Resistance of Japan's crack Kwantung army in Manchuria to the invading Russian forces has all but faded out. The Japs are surrendering almost everywhere with the result that the Muscovites are rapidly occupying this great country after less than a fortnight of war.

So vanishes Japan's dream of building up great possessions on the continent. It was her theft of Manchuria from China in 1931 that inaugurated the aggression which swept across Europe. Japan's success in "getting away" with this brigandage encouraged Mussolini to undertake aggression, and this in turn encouraged Hitler. It has been a long and cruel road from Manchuria, but maybe that is fate's way of giving up permanent peace.

not try to use them as an excuse for hiking prices.

The President said he was issuing these orders in order to "Promote a swift and orderly transition to a peacetime economy of free independent private enterprise with full employment and maximum production in industry and agriculture and to assure the general stability of prices and costs and the maintenance of purchasing power."

Mr. Truman is known to have ordered his staff to the strictly wartime agencies as quickly as possible. He wants the regular peacetime departments to take over any of the wartime agencies' functions needed in peacetime.

The Office of Civilian Defense (OCD) died a month ago. The Office of Scientific Research and Development will go soon.

Others are slated for the skid. But OPA and the War Production Board, both with important jobs to do, will hang around a while.

But the President may propose a new government department—a department of public welfare. The head of this department would become a member of the Cabinet.

Mr. Truman wants, where possible, all federal activities under Cabinet members' direction. And he wants departments to absorb separate agencies.

Secretary of Labor Schwellenbach has proposed a reorganization program to Mr. Truman. It reportedly calls for a new bureau of labor relations to take over WLB functions and any other industrial peace machinery that management and labor may agree upon at their forthcoming conference.

The OPA still stands on its prediction that eventually it can put through a drop in clothing prices. Months ago it was thought this could be done by fall. There's no more talk of that.

Treasury officials say the government will not attempt to stop cashing of War Bonds.

But Secretary Vinson urged Americans to hold their bonds, not try to cash them now.

The eighth and final War Bond drive—probably with a goal of 12 billion dollars—is expected to start October 29.

Mr. Truman has asked that V-J Day, when he proclaims it, be a day of work and not a holiday. The reason: Because so many people made August 15 and 16 holidays.

And it was learned over the weekend—the President has decided to end the lend-lease program through which this country piped more than 40 million dollars in weapons, food and equipment to its Allies.

seeking some arrangement under which Russia might continue to obtain heavy industrial equipment originally ordered under lend-lease. Those discussions brought no accord, however.

Will Clayton, Assistant Secretary of State, now in London for the UNRRA conference, also was assigned the task of reviewing the entire Anglo-American economic situation.

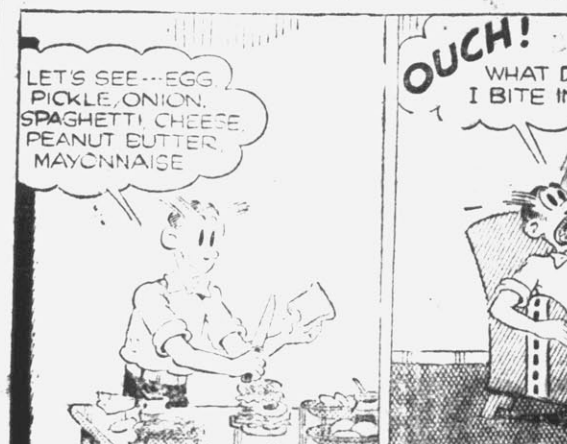

In blanking the Giants yesterday, Borowy pitched his first National League shut out and his fifth complete game in Chicago Cubs uniform.

In his five games for Chicago, Borowy has given up but 13 runs in 45 innings in winning four and losing one.

Fordham Hank's 8-0 conquest of the Giants in the nightcap before 41,457 at the Polo Grounds earned the Cubs a double victory as Lefty Ray Prim outdueled Harry Feldman, 3-1, in the opener.

The Cards divided their double-header with Boston, losing the opener 2-1, but winning the second for a 5-4 decision.

Detroit retained its game and a half margin over Washington's Senators, in their battle for first place when both squads divided bar-bain bills. Each won their first contests, as Izy Trout pitched the Bengals to a 6-1 triumph over the Philadelphia Athletics and Johnny Niggeling did likewise for the Senators with a 7-1 drubbing of the Cleveland Indians.

The A's won the nightcap 8-3 in 11 innings. A nine-run outburst in the seventh gave the Indians a 9-3 decision over the Nats in the finale.

The Philadelphia Phillies surprised by winning two from the Cincinnati Reds 5-0 and 4-2.

Charlie Keller made his first appearance in a Yankee uniform since 1943 as the New Yorkers split with the Chicago White Sox. The Yankees off on the right foot with a 4-2 win but the Sox blanked them with a 2-0 victory.

Brooklyn and Pittsburgh split although Manager Frank Frisch was not around to see his Pirates win the second, having been banished by Umpire Jocko Conlan for protesting

a decision. Les Webber pitched the Dodgers to a 6-3 win in the opener, while Nick Strincevich tested the Brooks Ralph Branca 4-2 in the nightcap.

Dave Ferris failed to notch his 20th victory, in the first game of a double header with the St. Louis Browns, but ancient Mike Ryba, who came to the rescue of Ferris in the ninth, pitched four scoreless rounds to give the Sox a 10-5 win in 13 innings. The Browns, with Al Hollingsworth registering his eighth success, won the second 6-3.

MORE TROUBLE INSIDE CHINA

Clashes Between Regulars And Communists Reported

Chungking, Aug. 20.—(AP)—Credible reports today said Gen. Yeh Shih-shan's regular Chinese forces had clashed with Chinese Communists near Talyuan. Japanese-occupied central of Shansi Province in North China.

The Communists were said to have seized the airfield near Talyuan and then been ejected by the regulars.

Earlier, the high command announced the re-occupation of a town near Talyuan, and a string of nearly a dozen other towns along the Talyuan-Tatung railway, chief north-south communications in Shansi.

(The movement of Generalissimo Chiang Kai-shek's troops northward into Shansi indicated he might be maneuvering to put forces between Yenan, Communist seat in Shensi Province, to the west, and the Chinese seaboard with its important cities of Peiping, Tientsin, Chungking, Nanking and Shanghai.)

Dispatches to Chungking showed several national government agencies already functioning in Shanghai, apparently without interference from the Japanese. Pro-Chinese government newspapers were openly published in Shanghai.

Other reports said Japanese troops at Amoy, last enemy pocket in coastal Fukien Province, had sent envoys to the Chinese lines to arrange surrender.

Chinese government troops striking swiftly into north China are

advancing on Paotow in the Inner Mongolian Province of Suiyuan, 100 miles northwest of the Shansi border and 330 miles west of Peiping, the high command announced today.

The development came as the Chinese awaited the arrival of surrender envoys from the Japanese supreme command and coincided with a warning by the Chinese Communist commander to Generalissimo Chiang Kai-shek to act swiftly to avert a "grave threat" of civil war between the government and Communist forces.

As arrangements were completed for the surrender, foreign reports said 20,000 to 30,000 Communist guerrillas were moving on Wuhu, Yangtze river port, possibly preparing to drive 60 miles downstream to Nanking, which is to be the new seat of Chiang's government.

It was pointed out that sizeable puppet forces in Nanking were reported to have switched their allegiance from the Japanese to the Chungking government, and were in position to repel a Communist attack.

The Communists demanded full participation in the Japanese sur-

render, which will take place formally at Chungking in western Hunan.

The Communists also demanded participation in the peace conference.

Gen. Chu Teh, Communist commander, in a defiant note to Chiang, asserted bluntly that 260,000,000 Chinese were "dissatisfied" with what he called the government's one-party dictatorship. He listed these demands:

1. That Chungking consult and reach agreement with the Yenan Communists on acceptance of Japanese and puppet troop surrenders, and on any parts and treaties concluded after the surrender.

2. That the Communists be given the right to accept surrender of Japanese and puppet troops in areas under Communist control.

3. The Communists be allowed to send their own representatives to the Allied acceptance of Japanese surrender, and be permitted to participate in post-war control of Japan.

4. The Communists should have the right to participate in the peace conference and future United Nations conferences.

5. That the present "one-party dictatorship" be abolished, an all-party conference called, and that government troops around Communist areas be withdrawn and democratic reforms instituted.

6. That Chiang take steps to avoid civil war. On this point Chu said "I now seriously warn you not to consider this unimportant."

The ceiling price increases, however, represented only part of the extra costs of wartime transportation. The balance has been paid by the Reconstruction Finance Corporation.

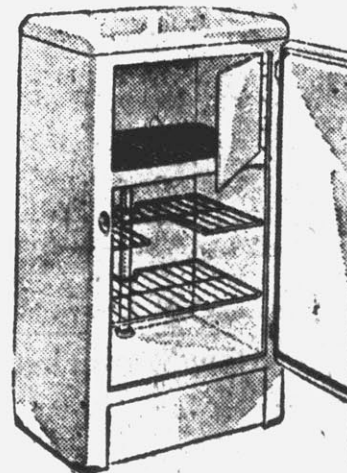

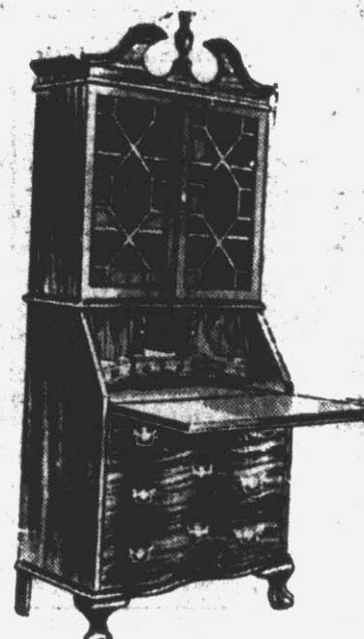

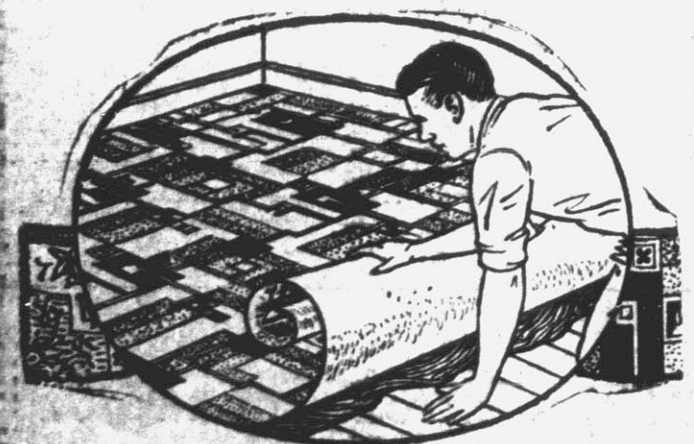
