Council To Hear Boundary Issues

Yugoslavia Wants Trieste, The Province Of Venezia And Dalmatian Lands; Settlement Boundary Dispute May Reveal Trend On Control Of Central Europe

London, Sept. 17.—(AP)—The Yugoslav embassy published today a 9,000-word memorandum backing its claim to disputed Trieste, the province of Venezia Giulia and the Dalmatian Islands, which it will present to the Big Five foreign ministers here this afternoon.

The Italians and five British dominions also will put forward their views on the controversial Italian-Yugoslav frontier problem, which has been a constant source of dispute through two world wars.

The Yugoslav document, which will be backed by arguments from Vice Premier Edward Karelj, head of the Belgrade delegation, declared that the "whole problem has been created by Italy's greed."

The Italians have prepared counterclaims although they are expected to concede the Yugoslav claims of the port of Trieste.

Representatives of Italy and Yugoslavia, as well as five British dominions, were ready to argue their cases.

The question reflects a whole panorama of divergent big power views and many delegates have expressed the opinion that the decision on the Italian-Yugoslav border is closely linked to the outcome of the tug of war for control of central Europe.

There appears to be agreement among the Big Five foreign ministers on only one aspect of the boundary dispute—that the port of Trieste should be under international control, as was the case after World War I.

On the administration of the city of Trieste the Italian Peninsula and the whole province of Venezia Giulia, however, there is a basic conflict.

The Yugoslavs claim all this territory. The Italians claim the same area which was theirs before the recent war although apparently they are willing to concede small changes of the border, probably leaving Trieste to Yugoslavia.

The Russians are expected to support the Yugoslavs, while the Americans and British are believed to lean toward the Italian view.

The vital question of who will rule the Italian colonies has been left for the time being to the Big Five deputies. The problem was referred to them by the foreign ministers with the charge to make fullest possible use of the American plan to let the United Nations appoint administrators of the colonies.

The British and Chinese are reported to support the American plan, while the Russians and French are opposed. The French are believed to prefer to let the Italians administer the colonies rather than set the precedent of independence and international administration which might become a rallying cry in their own African colonies.

NAVY PLEDGES QUICK ACTION

Promises Release Of Over 800,000 By Christmas

Washington, Sept. 17.—(AP)—The Navy promised senators today it will put 764,000 enlisted men and 75,000 officers back into civilian clothes by Christmas.

This pledge was made by Vice Admiral Louis E. Denfeld, chief of personnel, as the Senate Military Committee resumed its inquiry into why service discharges aren't coming faster.

Previously Undersecretary Gates told the senators the "situation in the Pacific is not sufficiently stable and secure to justify the early return of all naval forces and the activities which support them."

Denfeld said that demobilization is moving as swiftly as military needs, transportation, and separation facilities will permit.

"I wish to make it clear," he said, "that I am not here indicating any desire or intent to schedule demobilization to fit any luxurious ideas or to fit our convenience."

"I am sure you will agree that we have a clear-cut responsibility not to strip our ships and our bases—nor those functions here at home which support them."

Senator Burton (R-Ohio) brought out in questioning that, unlike the Army, the Navy doesn't let men out of uniform because they are needed in reconversion.

Gates said a detailed plan on Navy demobilization will be ready soon for congressional naval affairs committees.

A "Red Apple" Army and Navy recruitment bill comes up today in the House. Indications are it will touch off a battle over the draft.

Written by the House Military Committee in an effort to sidetrack proposals to halt inductions and force speedier demobilization, the measure seeks to induce men now in the service to reenlist.

Two senators, meanwhile, came forward with new plans to get more men out of uniform:

1. Senator Edwin C. Johnson (D-Colo.) drafted a bill to require the discharge within six months of all enlisted men with two years or more of service.

BEGIN TRIAL OF GERMANS

Concentration Camp Officials Face Military Court

Lueneburg, Sept. 17.—(AP)—Josef Kramer, director of the notorious Belzen concentration camp and 47 S.S. (Elite Guard) henchmen go on trial for their lives today before a British military court.

Most of the first day probably will be consumed in arrangements with the trial expected to last about three weeks. Conviction can mean death by hanging or shooting, or at the discretion of the court imprisonment up to life, confiscation of property or mere fine.

Kramer—popularly known as "the Beast of Belzen"—is the most widely publicized defendant, but the spotlight also was focused on bland 21-year-old Irma Greese who served for three years as a guard at the infamous women's camp at Ravensbrück, north of Berlin, and at Auschwitz in Poland before going to Belzen.

Uncensored horror films of Belzen and Auschwitz are part of the prosecution's evidence.

The court was convened by order of Field Marshal Sir Bernard L. Montgomery under royal warrant authorizing a military court, similar to a field general court martial, to try war criminals.

The "Belzen gang" is charged jointly with the violation of the laws and usages of war, "causing the death of a number of nationals, including one British national sailor, Keith Mayne, and causing physical suffering to other nationals."

Kramer and 11 other S.S. members also are charged with "ill-treating and causing the death of Allied nationals," a charge growing out of their activities at the gas-chamber horror camp at Auschwitz before they were transferred to Belzen.

Trials Begin Nov. 1
Nuremberg, Sept. 17.—(AP)—Supreme Court Justice Robert H. Jackson, chief U. S. War Crimes prosecutor, says the United States expects to be ready to begin trials of Nazi war leaders by Nov. 1 and may proceed on its own if the other Allied nations are not prepared to go ahead at that time.

Would Put End To Aluminum Monopoly

Washington, Sept. 17.—(AP)—Attorney General Tom C. Clark told Congress today the Aluminum Company of America (Alcoa) should be split into a number of competing companies.

His contention: more competition in the aluminum industry is essential to national security and business prosperity. In a report to Congress on the industry's reconversion and surplus property problems, Clark wrote:

"Monopoly was a burden on war production. Expansion was hampered by the fact that there was only one experienced company in this strategic industry on which our allpower depended."

Independent operators, the attorney general said, cannot survive in a competitive struggle with Alcoa's "aggregation of advantages in Bauxite and power supply, plant locations, market and financial strength and connections with foreign producers."

(Bauxite is the commercial ore from which aluminum is produced.)
"The only solution," Clark said, "lies in the split-up of Alcoa into a number of competing companies."

Automotive Industry Hard Hit By Strikes

Widespread Labor Disputes Bring Total Number Of Idle Workers To More Than 210,000

The Shakespearean witches of Macbeth had a description of the strike scene today—"Bubble, bubble, toil and trouble," except that more than 210,000 American workers weren't toiling as the result of labor disputes.

More than half the total number of 432,148 were concentrated in seven states. Michigan led the parade with more than 80,000, including 10,000 in Windsor, Ohio, second with 21,830, followed by Pennsylvania, 17,120; Wisconsin, 7,875; Illinois, 5,574; New Jersey, 3,900; and Iowa, 2,850.

In addition there were various other disputes, headed by Westinghouse Electric Company's 47,000 idle, that were scattered across 12 other states to account for the balance.

The strike and layoffs in the Ford Motor Company and supplying plants gave Michigan the distinction of standing at the head of the list. Some 58,800 were idle because of layoffs in the Ford plant itself while 4,500 remained on strike at the Kelsey-Hayes Wheel Company.

The balance of the state total was scattered between the Hudson Motor Corp., the Murray Corp., and the Pattersons.

Detroit, Sept. 17.—(AP)—More than 80,000 workers were idle in the Detroit area today as the huge automotive industry and the powerful United Automobile Workers (UAW) Union headed for a showdown on the union's demands for a general 30 per cent wage increase for the industry.

Strikes and layoffs idled 70,000 in Detroit and 10,000 in nearby Windsor, Ont., while UAW-CIO leaders

More Atrocity Stories Revealed By Prisoners

Five Americans were killed simply because they were flimsy, and three others were beheaded after they were marching through Japanese streets bearing signs. "These are the American devils who bombed us," Maj. John A. Cingulab of Sherman Oaks, Calif., related at Hong Kong today in one of a series of fresh atrocity stories.

An Australian army intelligence report issued at Melbourne said that of 3,350 British and Australian prisoners taken to Borneo, only six were known to be alive.

Last January, the Melbourne report said, 203 prisoners died of 450 sent on a death march through the Borneo mountains. Another death march claimed 353 lives out of 536 men and the others died later or were killed.

At Darwin, Australia, Pvt. J. W. Larkin, in an interview, gave new details of the abuse of Gen. Jonathan M. Wainwright, commander of the surrender of Corregidor, and Lt. Gen. Sir Arthur Percival, commander at the fall of Singapore.

"All of them, including Wainwright and Percival, had to go on morning parade with the rest of the prisoners of war and were often struck by the inspecting sergeant major, who always carried a bamboo cane," said Larkin. He was liberated from a Formosa prison.

At Sydney, Sgt. A. M. Blain, a member of Australia's House of Representatives, charged "every Japanese guard is a war criminal guilty of appalling atrocities."

Recently freed from a prison camp in the Singapore area, Blain said he lost 72 pounds, dropping from 170 to 98.

The Melbourne radio said a Colonel Suva, "responsible for all the 600 prisoners of war graves in Kuching cemetery," had killed himself with a table knife at army headquarters.

Major Singlaub, who led rescue paratroopers landing on Hainan island August 27, so befuddled Japanese officers in a battle of wits that he and his men gained command of their prisoner camp after they had been threatened by bayonet-pointing Japanese.

The commander of Australian prisoners, Col. W. J. R. Scott, said Major Singlaub's coup at the Hainan Island camp was one of the coolest and most courageous he had ever seen.

As the Japanese started "taking us prisoners," Singlaub, in turn, ordered them "to guard our parachute medical and food supplies."

This so shocked them that they did. Their colonel sent his chief of staff to investigate but as the latter was only a captain Singlaub ordered him around, too.

"When I insisted that the Allies had defeated them and they complied with our orders, they took us to the camp and provided food and medicine, which the prisoners had not had."

Tropical Storm To Miss This Section

Hurricane That Swept Florida Blowing Itself Out In South Carolina

Raleigh, Sept. 17.—A tropical storm heading into North Carolina has changed its course, the U. S. Weather Bureau here reported today, and will reach the central portion of the state about midnight.

The storm, remnant of a dying tropical hurricane that swept out of the Caribbean, will cause gusts of about 40 miles an hour in the Piedmont area, with heavy rains extending as far east as the coastal plain.

The storm has passed about 30 miles west of Charleston and now is following a north course. It rapidly is diminishing in intensity.

Earlier, the storm's path indicated it would enter this state in Columbus County and pass into Virginia through Gates County.

Heavy rains are expected to cause damage along the Tar, Neuse, Roanoke and Cape Fear rivers in Eastern North Carolina.

Charleston, S. C., Sept. 17.—(AP)—A West Indian hurricane drove across South Carolina today, adding a reported two deaths and heavy property damage to the toll of three fatalities and \$50,000,000 loss it inflicted in its path across Florida.

The South Carolina deaths were reported from Gourin, a village 12 miles south of Kingstree, where one white person and one Negro were said to have been killed.

The lumber plant of the Camp Manufacturing Company there was damaged. Charleston escaped without serious damage from the wind but a downpour of rain flooded low-lying areas of the city, and interfered with automobile and bus transportation.

Some residents were unable to get away from their homes because of the high water.

Although the city had prepared for a wind velocity of upwards of 70 miles per hour, the highest reported was about 55 miles.

The storm curved into the interior west of Charleston during the morning. Weather observers said at the time it was following a northerly course, heading in the general direction of Sumter, with prospects of diminishing winds.

At Columbia, the Weather Bureau predicted winds of 10 to 15 miles an hour for the Sumter area late today, and reported the likelihood that the storm would skirt the capital as it headed northwestward.

Heavy rains caused widespread damage to crops and otherwise.

At Rockingham, N. C., two textile mill power dams gave way under the weight of the waters, inundating the area.

Expects Early End To Meat Rationing

Washington, Sept. 17.—(AP)—Secretary of Agriculture Anderson said today the duration of meat rationing depends upon the extent of food commitments abroad.

Leaving a White House conference where he went over the rationing and subsidy programs with President Truman, Anderson told the reporters:

"If it is necessary to continue meat rationing it will be a liberal one, equal to a normal peacetime consumption in this country."

He said there is enough meat in this country to meet the normal domestic needs without the necessity of rationing.

Anderson said he was hopeful all subsidies could be terminated by next June 30, with the possible exception of that on flour.

There probably will be a need for sugar rationing in 1946, he said, but he was a little more hopeful that rationing of fats and oils may be terminated by January 1.

18-Pound Baby

Lawton, Pa., Sept. 17.—(AP)—An 18-pound baby girl was born last Wednesday to Mr. and Mrs. Francis Strohl, it was reported yesterday by Dr. Harvey Fry of Montrose. The child is alive and well, he added.

Mrs. Strohl, 38 years old and the mother of 15 children, has had an uneventful recovery after giving birth to the near-record baby, Dr. Fry reported. Her other children were of normal weight at birth.

Records of the American Medical Association, Chicago, showed a 20-pound girl born July 1940, to Mr. and Mrs. Joseph Hunter of near Poplar Bluff, Mo., the heaviest baby reported in recent years. The AMA Journal for Nov. 1936, told of a 25-pound stillborn baby girl reported at Pellham, Ga., in 1916.

PAYROLL LEVY MAY INCREASE

Social Security Tax Due For Big Jump January 1

Washington, Sept. 17.—(AP)—Congress, pondering a new \$4,000,000 tax reduction proposal, drew a reminder today that it will have to decide soon what to do about another type of taxes—payroll levies.

These finance old age pensions and other Social Security benefits. Unless Congress acts in the meantime, the payroll tax will jump from one to 2 1/2 per cent on worker and employer alike next January 1.

Congress has halted similar automatic increases in the past. But Senator George (D-Ga.), who reads the Senate Finance Committee, said the situation may be different this year.

The reason: President Truman has asked that the Social Security system be broadened. And a lot of bills are pending along this line.

In view of these proposals, George told a reporter, "It has become necessary for Congress to determine what policy it is going to follow."

Washington, Sept. 17.—(AP)—The government probably will decide this week whether to end meat rationing by October 1 or continue it a while longer.

Meanwhile, OPA is receiving what officials describe as a "tremendous volume" of mail from people all over the country.

Most of the letters are from housewives. In general, OPA says, they want rationing continued, but they want rationing continued on a basis of fairness.

Many fear they will have difficulty obtaining meat if controls are lifted. A number express this sentiment: Let's continue rationing so we can send some meat to hungry people in liberated countries.

According to OPA, most letter advocates an immediate end to rationing come from people in the meat business. They are convinced supply warrants such a move. They say they want to get rid of the red tape of rationing.

Here are samples of what the A. Brooklyne (N.Y.) housewife has written: I want to voice my protest against removing rationing by October 1. This would encourage black marketing and thereby deny to the unemployed any opportunity to get meat. Let's feed Europe for a while and keep rationing in America for at least another year.

From a grocer at Parkersburg, W. Va.: I firmly believe that rationing could be eliminated. . . . It

has outlived its usefulness. I have been informed by the meat suppliers that we shall immediately receive more meat, with the exception of pork.

And this from a consumer in Berkeley, Calif.: I think (meat rationing) should be continued at least until harvest time next year. . . . In the meantime, we should immediately step up our food shipments to liberated countries. . . . We are at the moment the guns cease firing.

A food merchant at Heron Lake, Minn., says: Our farmers really will be late. . . . If meat and butter rationing continue. . . . My suggestion would be to get rid of meat rationing at once.

A Golf, Kans., real estate man: If you want to send a big smile all over the USA—for the seller and the buyer—give us all a 30-day vacation on food prices.

And from Pittsburgh: This winter there are undoubtedly going to be hundreds of thousands of people in Europe and Asia perilously close to death by starvation. . . . That being the case, why are we contemplating removing most meat from rationing? . . . I can keep my belt on tight or tighter than it has been, until the war-torn people get back on their feet.

And this letter without a return address or legible postmark: I have not bought a steak since rationing (Continued on Page Two)

ENDURANCE CAN BE MAJESTIC
Some weeks ago we had occasion to recall the fortitude of Harry Lauder when his son was killed in the first World War. The way he endured his grief made a profound impression upon his generation.

In a magazine article he wrote a few years after the death of his son, Captain John Lauder, Harry tells how, his heart filled with grief, he finally forced himself to go on the stage with his hat cocked on the side of his head and a laugh on his lips as usual. The people in the stalls made it harder than ever by letting out great sobs and cries of "Poor Harry!" The greatest comedian of his generation stood helpless for a few minutes watching this demonstration on the part of his friends. At last in desperation he motioned the orchestra leader to start up a song. Somehow he managed to get through it, telling a story to two, and soon he had the crowd laughing with him instead of crying. And when he went off the stage, the audience cheered and shouted, "Brave Harry Brave Harry!" and kept shouting long after he was in his dressing room.

Often our pity for people is turned into veritable envy as we see how magnificently they take their sorrow. We wonder if we could do the same if we were confronted with similar trials. It is a real victory for any man when our pity for his tribulations is turned into enthusiastic admiration over the way he endures them.

WASHINGTON DAYBOOK

Washington — President Truman wasn't fooling when he said (some of us thought half jokingly) at one of his press conferences soon after V-J Day that perhaps the time had come when we could get around to a little politics.

Political observers here saw in his first postwar message to Congress enough little atom squanders to keep the capital dome bouncing around for a good many months to come.

With customary plain speaking, the President put the administration on record on a dozen more or less controversial issues. These started with the full employment act and high, nationally uniform interim unemployment compensation. They ended with a promise to come up soon with a national health program that will urge medical care and some form of sickness and accident insurance to the entire nation.

The President urged inducements for enlistment in the Army and Navy and promised every effort would be made to replace overseas veterans with volunteers. But he left no doubt on the administration's stand for continuation of Selective Service.

In asking that the Fair Employment Practice Committee be made permanent, the President almost assured the nation of a filibuster, with Senators Bilbo and Eastland, of Mississippi, attempting to talk the measure to death in the upper chamber.

When we get around to specific legislation, based on the President's broad recommendations for an extensive public works program, the economy bloc in Congress is sure to issue. The President specifically mentioned highway construction and repair, an airport network and regional watershed authorities similar to TVA.

Considering that it will be necessary to bring Administrator Chester A. Brown to combat inflation for some time by resisting pressures for high wages on some commodities, President Truman said: "I must be clearly that he has my back, and my confidence."

It was considered fair warning that any attempted tampering with the white House can muster into the front.

Come here think the President wanted a step on settlement of Lend-Lease. Others contend there was little difference between his



previous stand and his message statement that "we must recognize that it will not be possible for our allies to pay us dollars for the overwhelming portion of Lend-Lease obligations."

In any event the settlement of Lend-Lease is bound to become one of the big political issues. Most observers take it for granted that the economic policy of the administration will be to whittle demands for repayment to the absolute minimum.

Isn't surprising since I learned in Cairo in 1942 that Egypt was going after this territory. Whether an Egyptian trusteeship of this area would fit into the United Nations plan remains to be seen.

Certainly Libya should be under United Nations control, especially the eastern section where lies the famous port of Tobruk. Tobruk harbor is small, but it's the best natural harbor on the north coast of Africa.

That's half the story. The other half is the big island of Crete, which lies some 200 miles north of Tobruk. These two positions "straddle" the main sea lane where the Mediterranean narrows—that is, they dominate it militarily. They must be under United Nations control.

There's one other issue likely to be raised in connection with Libya. Native leaders told me that they were seeking their independence and hoped to make the powerful chief of the Senussi their king.

The board urged the men to return to their jobs pending negotiation on a dispute centering over discharge of three men, but only 350 of the 4,500 Kelsey strikers showed up at a Sunday meeting at which the back-to-work idea was disregarded.

In Windsor, Canada, a strike of protested working conditions, was 10,000 Ford Company workers, who implemented Sunday night by a decision of union representatives of 10,000 other Windsor workers to seek a strike vote, too.

International Union officers, who indicated they would throw the union's entire reserve of \$4,000,000 into the fight for the industry-wide wage increase, hinted they might ask other CIO unions for assistance in the drive.

The executive board, which is still conferring at Flint, Mich., heard Walter Reuther, UAW vice president, declare, "The first company would be struck before the snow flies."

Union spokesmen expressed hope the strike vote might be avoided by management agreement to pay the 30 per cent, but they set no time limit on the GM acceptance.

Twenty-seven already were in custody; only 17 remained at liberty, and two others were dead by their own hands.

General MacArthur announced that the 31st, 37th, and 38th American divisions would go home soon from Manila. The supreme commander also disclosed that he had protested strongly over Russia's mistaken destruction of a B-29 over Korea.

Earlier MacArthur summoned Japanese Premier Higashi-Kuni to his headquarters where he is believed to have informed the prince bluntly that Japan is not an equal and has not yet proved her right to be treated as one—the same strong statement that was given to the new-censored Japanese press Saturday.

The general today instituted a thorough American information bureau program, utilizing Japanese press, radio and schools.

Admiral Halsey's naval forces in the meantime speeded Japanese disarmament by smashing 25 big coastal defense guns fringing Tokyo Bay, and scuttling 51 midsize submarines, 103 suicide boats and 108 man guided torpedoes.

With an estimated half of Japan's 3,000,000 homeland soldiers now disarmed, the second great Allied task—evacuation of prisoners of war—proceeded while fresh atrocity reports rolled in hourly.

Twenty-seventh of the war crime suspects to be taken into Allied custody was Vice Adm. Ken Terashima, minister of communications and railways in former Premier Tojo's wartime cabinet. Japanese officials surrendered him to American custody today.

Admiral Terashima was driven to the Yokohama jail, where such other war crimes suspects as Lt. Gen. Shigenori Kuroda, Homma's successor as Philippines commander, and ex-navy Minister Shigetaro Shimada, already were confined.

Nobuske Kishi, commerce and industry minister in the Pearl Harbor cabinet, also was taken into custody today. He came to Tokyo from Yamaguchi prefecture, where he had been ill.

Warlord Tojo himself, who tried suicide with a pistol last week, "is getting along fine" in the U. S. 98th Evacuation Hospital in Yokohama and is expected to be completely recovered in a month, Lt. Col. James M. Perry said today.

Shigenori Tojo also on the Allied "wanted" list, and foreign minister in two Japanese war cabinets, was ill at his home from a heart attack.

The list of those in custody, included one reported leader of the infamous Black Dragon Society—Col. Kingoro Hashimoto. Another, Yoshitsuka Kuzuu, who claimed he had been president of the Terrorist Society since 1938, reportedly had been found and was expected to be picked up soon.

MacArthur's headquarters were transferred today from the customs office at Yokohama to the Daiichi Sogo (First Mutual Life Insurance) building in the Hibiy district of Tokyo. Trucks and jeeps shuttled all day long between the cities, transferring personnel and tons of records and equipment.

The new location, fronting the Imperial Palace grounds, will be headquarters for the duration of the occupation.

Six hundred officers and 14,000 enlisted men formed the advance echelon of the headquarters in the 20-mile move.

MacArthur and his aides, with other high headquarters officials, are quartered in the U. S. Embassy building.

The actual transfer was supervised by Col. V. D. Whitley of Raleigh, N. C., headquarters commandant.

Seek Disposition Roosevelt Matter

Washington, Sept. 17—(AP)—The House Ways and Means Committee today sought speedy disposition of the Elliott Roosevelt financial inquiry lest the long-drawn investigation delay tax cutting legislation.

But what to do about the retired brigadier general's case apparently had the committeemen in a quandary.

They have finished reading young Roosevelt's 200-page statement in which the late President's second son said he borrowed at various times over \$600,000 to finance a Texas radio chain.

Of that amount, \$200,000 was loaned in 1939 by John Hartford, president of the Great Atlantic & Pacific Tea Co.

The congressional inquiry began after reports were published that Hartford had lost only \$4,000 of the loan and listed the remaining \$196,000 as a bad debt deduction in his 1942 income tax return.

Questions before the committee are whether the deduction should be allowed and how the loan should be treated in Elliott's tax returns.

committed to devoting all its early efforts to writing a general tax reduction bill. Latest proposal in that direction came over the week-end from Rep. Robertson (D-Va.), a committee member who suggested:

1. Eliminate the present three per cent "normal" tax on individual incomes, and
2. Drop the 95 per cent excess profits tax now levied against corporations.

Robertson cited these two examples of his plan and that of Rep. Knutson (R-Minn.):

A married person with two dependents with a net income of \$2,500 would have his taxes cut from \$102.50 to \$5 under the Robertson plan and to only \$2 under the Knutson plan.

The same taxpayer with \$25,000 income would have his \$9,375 tax bill cut by \$750 under the Robertson plan and by \$1,875 under the Knutson system.

Both Knutson and Robertson are agreed that the excess profits levy should go, but Knutson wants it knocked off as of September 1, while Robertson would erase it January 1.

Flooded Rivers Caused By Rain

Raleigh, Sept. 17—(AP)—The Cape Fear and Neuse rivers are expected to reach flood stage today, the U. S. Weather Bureau reported.

The Cape Fear is expected to reach flood stage above Fayetteville, and the Neuse in the Smithfield-goldsboro vicinity.

The weather bureau reported that the Neuse yesterday had risen 15.2 feet which was a rise of 8 feet over the preceding day. The Cape Fear at Fayetteville had reached 30 feet yesterday, which was a rise of 18 feet over the same time the day before.

The weather bureau predicts that other rivers in North Carolina may reach flood stage. It is too early yet to tell what extent the heavy rains have had on the slowly rising Tar. Only the lower part of the Roanoke will be affected, the bureau said.

2. Senator Connally (D-Texas) called on the Army to classify all its men and release them by steps.

Former prisoners of war would go out automatically under Connally plan with quick discharges to follow for: all men with combat service, fathers, married men and those in upper age brackets.

The House bill holds out these inducements to men to sign up for another hitch:

1. Enlistments for only two years if the recruit wishes. The present Army period is three years, the Navy's four.
2. Optional retirement after 20 years of Army service, instead of 30. This would conform with the Navy's system.
3. Travel pay of five cents a mile home and back for a furlough between the time of discharge or release and reenlistment.
4. The option of taking muster-out pay before reenlisting, instead of waiting until the end of the new enlistment period.
5. A reenlistment bonus based on the highest grade held by the man reenlisting. Generally, this bonus is \$150 for a master sergeant, a technical sergeant or a staff sergeant, and \$75 for a sergeant, a corporal, or a private.
6. Continued free mail.
7. Extension, for the period of reenlistment, of the time a veteran may avail himself of benefits of the G. I. Bill of Rights.

Second, the cross casts light on the mind of Christ. Like His mother, He kept things in His heart. If any other way except to die He was willing to get willing to die. Jesus read in the Old Testament, "By His stripes we are healed," "wounded for our transgressions" led as lambs to slaughter."

Third, the cross casts light on the gentleness of Christ. Jesus knew of the serpent lifted by Moses in the Old Testament and he was willing to be crucified. In the garden Jesus did not fight back—He kept His temper in the presence of Judas.

Fourth, the cross throws light on the supreme satisfaction of Christ. Jesus wanted men to get to God—they could only come by the cross. He talked little of His troubles. He loved the world. If the world scorns you, look to Jesus. He will see you through. He came, not to call righteous, but sinners to repentance. All that is whole need not a physician but he that is sick. Will you look to the cross and see Him who died for you and come take up your cross and follow Him?

Baseball

It looks like Detroit and Chicago, after a 10-year wait, will meet again in the October World Series.

With but two weeks of the current campaign remaining, it appeared today that only a spectacular upset by either of the two runner-ups, Washington's Senators or St. Louis Cardinals, together with a complete collapse on the part of the leaders, could eradicate the leads of the front running Tigers and Cubs who last met in the 1935 classic.

Including yesterday's double triumph over Brooklyn, 3-2 and 4-2, the Chicago Cubs boasted a four game lead over the world champion Red Birds, with each team having a dozen games left on the calendar. Of these, five are against each other.

The Tigers own a two and a half game edge over the Senators in the American League, with nine games left to play and six for the Nats.

Chicago's twin victories came as St. Louis was splitting two games with Philadelphia and marked the Cub's 18th sweep of a doubleheader this season to better the old major league record of 17 held by the Cards.

The Phillies edged out the Cards, 4-3, in the opener. The Cards won the nightcap, 10-3, clubbing five Philly hurlers for 15 hits.

The Tigers chilled Washington's pennant hopes by halving the doubleheader with their chief rivals. The Capital City challengers downed Detroit's southpaw ace, Hal Newhouse, in the opener, 3-2, but the Bengals barged back to squeeze out a 5-4 decision in the closer and take a 3-1 edge in the series.

St. Louis' Browns retained their one-game lead over the Yankees in their battle for third place by splitting two games with New York. The Sewallmen won the first 6-2. The Yanks won the second, 5-4.

After Steve Gromek had won his 17th game for Cleveland, shutting out the Philadelphia Athletics 3-0 in the first game, the Mackmen came back to win the second, 7-5, with a five-run fifth inning.

The New York Giants and Pittsburgh Pirates also split. Jack Barrett's 15th homer won the first for the Pirates, 3-2, but Jack Brewer's four-hitter gave the Giants a 9-2 nightcap win.

The Chicago White Sox hung a double defeat upon the Boston Red Sox, 5-3 and 6-1.

The Braves and Reds divided their pair. Boston rallied for three runs to grab the first, 4-3, while the Reds capped the second, 5-4 in 11 innings.
