Personal Clashes Flare In Today's Session Of Conference Of Ministers

Verbal Exchanges Between Bevin And Molotov As Big Five Council Discusses Reparation, Food And Boundaries; Early Meeting Of Big Three Likely

By FLORA LEWIS London, Sept. 25.—(AP)—Bitter personal clashes were reported today between British Foreign Secretary Ernest Bevin and Russian Foreign Commissar Molotov as the Big Five Council talked of boundaries, reparation and food apparently without moving nearer to any major agreement.

Reliable sources said the Russians were unresponsive to American and British proposals that Austria be freed from the Great Balkan Granary, always its source of farm products, and were determined also to prevent the western powers from discussing Balkan frontiers.

Molotov was reported also to have flatly opposed American and British proposals that arms reduction clauses be written into peace treaties with Hungary, Romania, Bulgaria and Finland.

Molotov, objecting to the British suggestion of a joint Allied policy in the Far East, his idea, it was learned, would be that Gen. MacArthur should consult an inter-Allied commission in making policy for Japan and other Pacific regions.

Conference sources said U. S. Secretary of State James F. Byrnes objected to the Russians raising such a question at this conference because he came here with the understanding that only European issues would be discussed.

An informant who attended the secret sessions of the foreign ministers of the United States, Russia, Great Britain, France and China gave this as an example of the friction between Molotov and Bevin.

Molotov, objecting to the British attitude against Balkan governments sponsored by Russia, declared that Bevin was supporting an anti-democratic regime in Greece.

Angered, Bevin retorted that he refused to permit that he be spoken to in such a tone. "Besides," Bevin is reported to have said, "I am tired of always being the butt for accusations. It is as though I am always being put in the prisoners' dock. Is it because I used to be a doctor?"

"Well," Molotov was reported to have replied, "I don't know but there is one thing you and I have in common anyway. Our nobility is not very old."

Regarding the reparation issue, the Russians are declared wanting assurance that Poles and residents of the Russian-occupied Baltic States be returned. The American-British attitude was that Moscow cannot claim these peoples unless they wish to return.

WELCOME FOR NEW STUDENTS

Approximately 350 Freshmen At College Here

Dr. Howard J. McGinnis, acting president of East Carolina Teachers' College, welcomed approximately 350 freshmen to the campus at the formal opening of the college here today.

POLICE SOLVE ROBBERY HERE

Cause Arrest Of Burglars And Recover Brown-Wood Loot

By CHESTER WALSH Police Chief Jim Tanner announced last night that one of a series of robberies committed here during the past several weeks was solved when the sheriff at Waltersboro, S. C., working on information given by Greenville police, arrested four men and recovered some of the loot stolen from the Brown-Wood Motor Company.

Those arrested are Gordon Taylor, 29; William Taylor, 17, both of Richmond, Va., and James Taylor, 16, and Herman Boule, 16, both of Fayetteville. The FBI wanted the quartet for an alleged \$1,500 hold-up in Virginia. They were turned over to the FBI.

The men are charged here with breaking and entering the Brown-Wood Motor Company place on Dickinson avenue on the night of September 9 and the larceny of an automobile, two radios, two raincoats, a pistol and an alarm clock. Authorities at Waltersboro recovered this property. Billy Brown was planning to go to South Carolina to claim the property. The robbery was committed during a thunderstorm.

On the same night J. B. Kittrell's warehouse here was looted of a ton of sugar in 100-pound bags and Mixon's retreading plant was robbed of some tires and tubes and rubber. Authorities expect to make some arrests in these cases shortly. Chief Tanner said, "It takes a little time to solve these robberies," he added, but we are staying right behind them."

Saslow's jewelry store, on Evans street, reported to police that their store was robbed last Friday night during a storm. Up to last night the store had not provided police with an inventory of missing merchandise, the chief said.

Robbers broke into John G. Clark's office at the Sinclair plant on Dickinson avenue Saturday night and tried to open the safe. They left without taking anything, police said. It was reported to authorities here that on the same night the Sinclair office at Ayden was entered and the safe was opened. The robbers secured no money.

In the meantime Greenville police, the sheriff's office and the State Highway Patrol are working on these cases and have some clues.

Planning To Close Hollywood Canteen

Hollywood, Sept. 25.—(AP)—The Hollywood Canteen, which provided a touch of glamour for many a visiting service man during the war years, will close Thanksgiving day after three years of entertaining but its services will continue in another form.

Government Takes Steps End Widespread Strikes

Oil Workers' Strike Poses Test Of Government Labor Policy As List Of Idle Grows

By The Associated Press The government moved today to unsmother the increasingly heavy traffic of strikes and work stoppages along the nation's labor front.

The number of men and women off their jobs by strikes and forced shutdowns across the country touched around the 350,000 mark, the highest in months. Some 100,000 workers joined the army of idle labor disputants within the last 24 hours as strife among labor-management gained headway.

Increased wages were the principal demands in the majority of the disputes. As the government stepped in to attempt to effect a settlement of a spreading oil strike which already has idled 30,000 workers, there was no immediate indication other front-rank stoppages would be called off.

Headlining the troubled labor front was New York City's strike of 15,000 AFL building service employees. Business in the metropolis was partially paralyzed after the workers left their jobs yesterday. Elevators halted in more than 2,000 office and loft buildings, including the skyscraping 102-floor Empire State structure, the famous Woolworth building and other tall buildings. Hundreds of thousands of New Yorkers were inconvenienced by the strike, called in protest over a War Labor Board ruling on wages and hours. Hotels and apartment houses were not immediately affected by the strike.

Detroit's turbulent labor situation, however, continued to share in the spotlight. Gov. Harry F. Kelley of Michigan ordered an investigation of the month-old strike of 4,500 workers at the Kelsey-Hayes Wheel Company which precipitated layoff of 50,000 Ford Motor Company automobile employees. Some 90,000 were idle in the nation's automotive capital over labor disputes.

One of the country's biggest single walkouts occurred yesterday as 60,000 AFL lumber and sawmill workers left their jobs in Oregon, Washington, Idaho and Montana in a dispute over wages. Another 2,000 in Montana awaited a call to join the walkout.

Three other strikes yesterday added 22,000 to the mounting list of idle. They included 15,000 CIO workers of the New York Shipbuilding Corporation in the Philadelphia-Camden, N. J. area. The huge yard where eight Navy ships are under construction, closed, as the workers went on a sitdown, their second within a week.

The trouble stemmed from the firing of several men charged with looting by the company. Other stoppages in the last 24 hours idled 5,000 at the Western Cartridge Company plant in East Alton, Ill., and 2,000 workers at the Simmons Company in Kenosha, Wis.

Department of Labor officials in Washington watched for results at the conference in Chicago at which oil company representatives and officials of the CIO oil workers international union were to meet with members of the Federal Conciliation Service.

The strike, in its second week, has crippled production in six states—Texas, Indiana, Illinois, Michigan, Ohio and West Virginia, and threatens to spread to other major petroleum-producing areas. Dr. Meadows Begins Prison Term Today

Former College Head Reasserts His Innocence In Withdrawal Appeal

Raleigh, Sept. 25.—(AP)—Dr. Leon R. Meadows, former president of East Carolina Teachers' College, entered Central Prison here today to begin a three-year sentence for embezzlement and false pretense.

The 62-year-old educator, accompanied by Sheriff Ruel W. Tyson of Pitt County, surrendered himself to prison authorities at 1 p. m. He immediately was sent to the receiving block to begin the routine of prison life.

Several days will be necessary to process Meadows at the prison. Warden H. H. Watson said he had not decided where he will place Meadows or what his duties will be. Usually, a man of Meadows' education and background is assigned to work in the hospital or offices of the prison.

Dr. Meadows, through his counsel, Judge Albion Dunn, officially withdrew his appeal to the Supreme Court at the Superior Court clerk's office here this morning and immediately reported to Sheriff Ruel W. Tyson. Before leaving Greenville shortly after 10 o'clock for Raleigh, Dr. Meadows issued a statement in which he reasserted his innocence and declared he was entering upon his term of imprisonment "trusting and praying that the truth, as known to me, will finally be established and proclaimed."

Requests Commitment. The defendant, through his counsel, Albion Dunn, hereby withdraws his appeal to the Supreme Court, which was noted to the judgment of his Honor J. "At the conclusion of my second trial an appeal to the Supreme Court was noted. I have asked my attorneys to withdraw the appeal. I shall accept the verdict of the court.

"In making this decision I wish to reiterate that I have never used, for my personal gain or benefit, a single penny of the funds entrusted to the president of the college by authority of the resolution of the Board of Trustees, as of August 29, 1924, or of any other funds which came into my hands and which were to be used for the welfare of the college.

"After many months of minute investigation by agencies of the State there were brought charges that I had not satisfactorily explained to them items of expenditures totalling \$18,636.34 during the ten years of my administration up to August 29, 1945. (Continued on Page Two)

Such a thing is unprecedented, and if the Imperial descendant of the Sun Goddess can thus walk among mortals and do homage to his conquerors without losing face with the Japanese people—then he is a wizard.

SLAY IS NAMED COLLEGE DEAN

Dr. J. I. Oppelt Is Head Of Practice Teaching

Dr. Howard J. McGinnis announced at the opening faculty meeting at East Carolina Teachers' College yesterday the appointment of Dr. Ronald J. Slay as dean of the college, and Dr. J. I. Oppelt as director of practice teaching and the Placement Office at the college. Dr. Slay, head of the science department at the college since 1923, assumed his new duties with the opening of the fall term today. He is the first person to hold the position of dean at ECTC. He is a Mississippiian. He became head of the science department 22 years ago and has since been active in college and civic affairs. He received a B. S. degree at the University of Mississippi, where he was an outstanding athlete. Later he received the M. A. and Ph. D. degrees from Columbia University. He did special graduate work at Johns Hopkins. In addition to his regular duties, Dr. Slay during the past year assisted in the registrar's office at the college.

Dean Slay has had varied experience as a teacher in North Carolina colleges. He taught three summers at the University of North Carolina, and for eight years he has taught science education at the summer school at Duke University. He is a member of various societies, including the American Association for the Advancement of Science, National Association for Science Teachers and Phi Delta Kappa, honorary educational society.

Dean Slay and his family have made their home in Greenville since he became a member of the faculty. Mrs. Slay (nee Maggie D. Campbell of Mississippi) is active in church, club and social life in Greenville.

Dr. Oppelt, newly appointed director of practice teaching, became a member of the college faculty in 1944. Before coming to Greenville he had been connected with the Ohio school system as principal and superintendent, and was on the faculty of Simpson College, Indianapolis, Ind., several years. SAYS FRANCO WAR CRIMINAL

Soviet Ambassador Urges Removal Of Spanish Dictator

New York, Sept. 25—(AP)—Acting Soviet Ambassador Nikolai V. Novikov called last night for the removal of Generalissimo Franco as head of the Spanish government and said he should be tried "as a war criminal."

Novikov, charge d'affaires of the Soviet embassy in Washington and acting ambassador in the absence of Andrei Gromyko, addressed 17,000 persons at a Madison Square Garden rally sponsored by the Spanish Republican government in exile.

Prof. Harold J. Laski, chairman of the British Labor party's executive committee, addressing the rally by radio from London urged the democracies to withdraw their recognition of the Franco regime and recognize the Spanish government-in-exile, now functioning in Mexico.

The Russian representative said Franco, through actions against the Soviet Union, had "put himself on the same level with Hitler and Mussolini and, in the same measure as they, is subject to prosecution as a war criminal."

Continued from Page One on which I was indicted after being exonerated by the Board of Trustees, following three full days of open hearing. At the first trial which lasted eight weeks, Judge Williams threw out nine of the sixteen counts of the bill of indictment and there was a mistrial on the seven remaining counts. At the second trial, which lasted twelve weeks, the jury acquitted me of all the counts except two and these amount to \$3,745.82.

"My attorneys are unanimous in their opinion that an appeal to the Supreme Court would result in a new trial, but I am told that under prevailing rules and with all reasonable dispatch my case would not be ready for argument in the Supreme Court before the late spring of 1946. This suggests to me that if a new trial were granted, the case would not be called for re-trial in the Superior Court until a much later date.

"With all my deep consciousness of innocence I am doubtful if I should impose upon my family this burden of uncertainty and weariness for two more years.

"So today I am entering upon my term of imprisonment, trusting and praying that the truth, as known to me, will be finally established and proclaimed.

"I am very grateful to my attorneys for their able and loyal assistance to me throughout this trying ordeal and desire to express my appreciation to my friends who have stood by me."

said he wanted to indicate a few things which ought to make one think deeper than the first typical superficial reaction of not looking 'another campaign.' "This one is the most important of the United War Fund campaigns to be put on," he declared.

"Our state met every challenge that was afforded us both civil and military," he said. Then he went on in detail to mention the high spots of achievement of North Carolina during the course of World War II. Two billions in industrial production for the war effort. Quoting a high up army ordinance officer, the speaker said, "It could be stated without exaggeration that every member of the armed forces in Africa, Italy, France, Germany, Burma, over the Hump, South Sea Islands or China either wore or carried something made in North Carolina" because North Carolina made and produced such a wide variety of things.

There were fifty military installations in North Carolina, one of which was the largest and another which was the second largest—the second a marine base which is to be permanent. Armed forces trained in North Carolina landed at Guadalcanal. Soldiers trained at Fort Bragg entered Bizerte ahead of the British.

Native sons as General Lee who pioneered airborne troops and a native of Davie County who released the first atomic bomb were mentioned. At this point Governor Broughton interrupted the flow of remarks to comment that in North Carolina they did not know how to brag but they could make a few passes in that direction. Then he added:

"Our part in World War II will make glad the hearts of us all and even those yet unborn. Then he touched on the fact that all from the war has not been tragedy for from the experiences of races and nationalities fighting together will come greater fraternity and understanding.

At this point he drove home the point that any state that had acquitted itself so during the war with industrial, agricultural, and financial cooperation both for profit and for love of fellow man could not now fall the final call of the United War Fund.

"The war is over. We are back in the groove. On the way to reconversion and recovery. But there are seven million fighting men still at their posts. Would it be fair to them having won the victory from the most vicious enemy since Genghis Khan to leave them now in Europe or Japan" without evidence of interest of the folks at home in helping relieve the boredom and inactivity while they await transportation. He illustrated the transportation problem by telling how the Queen Mary brought home fourteen

thousand soldiers recently but that it would take five hundred trips of such a huge ship to bring home all the men in Italy and Germany. "If we abandon them without the humaneness and comfort to relieve the boredom and idleness, we will not be living up to our record." Then he called the names of several general officers who had said and he quoted "These services are needed unabated until December 31, 1946. This will be last United War Fund Campaign. I want to do for them what I can."

"At least to have a place where they can sit down, have a little music or a little diversion. This fund is the only way they can get that," he declared. "Are we going to leave them to get their diversion in the dives of the East?"

Then Mr. Broughton brought the matter to focus on Eastern Carolina by indicating that some of the funds raised in the War Fund would go for relief in China which was once a big market for local tobacco. This fund would buy goodwill from those people for the people of America who wish to sell them.

"If we want to maintain goodwill for our products, we can do it no better way than to show the other nations through China relief which is part of this Fund."

"In keeping with the fine spirit of North Carolina, we must succeed and I know we will succeed" in the United War Fund Campaign to open soon, he declared in conclusion.

Spencer of Swanquarter; Clarence Griffin of Williamston, chairman of Martin County; Francis Manning of Williamston, publicity chairman for Martin County; R. A. Joyner, of Farmville; J. W. WASHINGTON DAYBOOK

By SACK STINNETT

(First Of Four Articles)
Washington—Not only has business taken over a government war agency, but with peace, it is expanding it into what may well become one of the most important phases of our "odd neighbors" to the world's policy.

It is the International Training Administration, Inc., a non-profit cooperative organization whose aim is to give the practical "know-how" of our industry, commerce and agriculture to the qualified young men and women of other lands.

So shy has been ITA in publicizing its accomplishments that few persons know it even exists. But since its inception four years ago it has given practical training in American business methods and techniques to 1,000 young foreigners from all over the globe.

As recently as early in September, 250 Chinese arrived here for assignment to top-ranking producers and distributors all over the country. Their training will be an intimate study of how the United States and its machines do business.

More than four years ago when Nelson Rockefeller was breaking in as coordinator of Inter-American Affairs, conversations with a group of business men crystallized the idea of giving outstanding young Latin Americans a year or so of learning-by-doing, and incidentally spreading the gospel of U. S. business.

Rockefeller called in serious energetic Elliott S. Hanson, an official of United States Steel, thoroughly familiar with foreign trade and foreign lands and asked him to head up an office of "Inter-American Trade Scholarships."

Hanson agreed. The results have now spread from Latin America to Turkey on the east and China on the west and soon will stride the globe if an India project goes through.

The idea is to bring picked groups of bright young foreigners to this country, give them a brief indoctrination course in how to live and get about in American cities, and then in a year or two of concentrated training to take them up the ladder in American factories, offices, laboratories, and fields. The expense was to be borne one-third by government, two-thirds by business. The trainees were to be given an



average of approximately \$150 a month for living expenses. So well did the trade scholarship program work through 1942 and 1943 that other government departments and many businesses with practical technical and professional training programs were demanding its services. It became the Inter-American Training Administration.

Industry realized, too, that it had something here that needed more permanence than any war agency would have when peace came and the economy-minded in Congress started whetting their knives. In June, 1944, business took over the government agency and it became ITA, Inc., and Elliott S. Hanson became its president.

execute a revolutionary coup and oust the emperor. From time to time they have dared raise their voices against him, but as often have been roughly dealt with by the police. Military-ridden Japan hasn't been a very healthful place for the growth of revolutionary ideas, or at least for their execution. It's given to wonder now, however, whether the anti-monarchists may not get into action again. America's attitude towards political change is clearly defined for MacArthur in the statement on initial post-war policy in Japan, issued by the White House in Washington last Saturday. This says:

"The policy is to use the existing form of government in Japan, not to support it. Changes in the form of government initiated by the Japanese people or government in the direction of modifying its feudal and authoritarian tendencies are to be permitted and favored. In the event that the execution of such changes involves the use of force by the Japanese people or government against persons opposed thereto, the

supreme commander should intervene only where necessary to insure the security of his forces and the attainment of all other objectives of the occupation."

Whether the Mikado elects to present himself before MacArthur, the fact remains that there has been considerable talk of his possible abdication. The Marquis Koichi Kido, Lord Keeper of the Privy Seal and one of the emperor's close advisors, has told Associated Press Correspondent Brines that abdication might be possible, although it isn't being officially considered now. Should Hirohito retire it probably would be in favor either of his young son or of his Oxford educated brother Chichibu.

Meantime MacArthur has ordered a complete report on the emperor's huge fortune, which heretofore has been one of the best kept state secrets. The Imperial family owns stocks in every Jap enterprise—sometimes as much as forty per cent.

The 3 per cent pay increase for this purpose would be administered by the UAW.

3. About 1 per cent of the 30 per cent increase would be used to correct inequities within an individual plant. For instance: Here are Jones and Smith. They work side by side. Each does a slightly different job from the other. But both need the same amount of intelligence and muscle for their work. Jones gets \$1 an hour but Smith gets \$1.25. That 1 per cent would be used to bring Jones closer up to Smith.

4. Now we come to the 23 per cent which is left after deducting the UAW people say it would be used this way: There would not be a 23 per cent—or any percent—increase to auto workers.

That 23 per cent increase in the industry payroll would be divided by the number of workers to find a flat sum in cents which each of the worker could be given.

And all UAW workers would get the same amount of increase in cents.

Just for illustration let's assume—although it probably would be more—that the 23 per cent increase turned out to be an increase of 23 cents to each worker.

Then the man making 85 cents an hour would, with the 23-cent increase, get \$1.08 an hour. A man making \$1.75 would get \$1.98.

In this way the wage of the low-paid worker would be brought up closer to the wage of the higher-paid man.

If each received a 23 per cent increase—instead of 23 cents—the man now making the higher wage would get a greater increase than his lower-paid fellow worker.

UAW people say they'll insist on a 30 per cent increase. They will probably settle for less.

That would mean a change in the figures given here. These figures are rough ones anyway, although they are approximate.

He stared at the troops and the troops stared at him as they jogged past.

Destroyers and cruisers and swooping planes were on hand to make certain there was no trickery. The town had been leveled by a pre-surrender B-29 fire raid.

Mr. G. W. Orta, in questions submitted through the premier's office some time ago by the Associated Press, specifically was asked the extent of his information about the Pearl Harbor attack; and whether he received any peace documents from the Americans shortly before the war.

No official explanation was given for the ruler's silence on these questions.

One of his closest advisers, Marquis Koichi Kido, lord keeper of the privy seal, answered some of the queries yesterday when he said Hirohito received—and ignored—both President Roosevelt's peace message and the U. S. State Department's November 26, 1941, peace memorandum.

Molotov was reported to have objected to drawing Balkan borders in treaties, asserting that it would be better to let the countries work out frontiers for themselves.

When the Americans and British declared that borders were one of the important reasons for writing treaties, the Russians were said to have replied that if boundaries were included in the documents the big powers would be actually guaranteeing the frontiers and each would have to be consulted in case of future changes.

Belief that another meeting of

President Truman, Premier Stalin and Prime Minister Attlee may be necessary to iron out Europe's major peace problems was voiced in some quarters today as the Foreign Ministers' Council prepared to close its two weeks session with the record of important agreements precisely at zero.

Some delegates still spoke hopefully of a second session of the Big Five foreign ministers in December, but this could be arranged only if the deputies were able to work out solutions to the many problems tossed their way by the foreign ministers.

There has been no formal mention of another session of the major powers' leaders, but the thought has been expressed by some delegates that top-level consideration might be needed to smooth the rocky path to European agreements.

These sources felt it might be necessary to include Gen. De Gaulle in such a meeting. The French here have been reported resentful of what was termed an attempt by the Russians to exclude them from consideration of certain problems—particularly the Balkan discussions.

Gen. De Gaulle's object during the past year has been to obtain recognition of France as a major power. The French were just beginning to overcome the sting of being kept out of the Potsdam conference when the Balkan treaty question arose.

Final conference talks were expected to be concentrated on European inland waterways and the Soviet demand for acceleration in the repatriation of Russian nationals. The present snag in the latter problem is on the formula for deciding just who is Russian in view of frontier changes.

Russia claims some Poles as citizens, even though the Poles in some instances have refused to return to their homes in Eastern Poland, which became part of the Soviet Union when the border moved west.

Among the many other questions which the ministers failed to settle and which they turned over to the deputies is the problem of Chinese claims on Italy, which were disclosed today. One official source said this was China's only proposal during the meeting. Details were unavailable, but apparently the demands were modest, since little argument reportedly was raised.

But the Chinese claims were important with regard to whether France and China should be permitted to help write peace treaties in the cases of countries with which they did not sign armistices.

WILL VISIT PEARL HARBOR

Investigators Will Go To Hawaii For Study

Washington, Sept. 25—(AP)—A Senate-House committee decided today to visit Pearl Harbor in its investigation of the sneak Japanese attack which plunged the United States into war.

Chairman Barkley (D-Ky.) said the group would go to Hawaii as soon as it has made a preliminary study of evidence already obtained by various inquiry boards.

He said hearings probably will be held there. Testimony likely will be taken from witnesses who would have difficulty in coming to Washington for hearings here, he added.

The primary objective of the trip, Barkley said, will be to familiarize committee members with the physical layout of Pearl Harbor in relation to preparations made to meet such an attack as the Japanese staged.

Only one member, Senator Brewster (R-Me.) previously has visited Pearl Harbor. Barkley said all committee members would be urged to take the flying trip.

In quest of a counsel for the inquiry, the committee today interviewed Roger Whiteford, a Wash-

ington attorney. Barkley said about 20 names had been suggested for the counsel post, but no decision had been made yet.

He added that William D. Mitchell, former attorney general, would appear before the group tomorrow. Mitchell has been proposed as counsel.

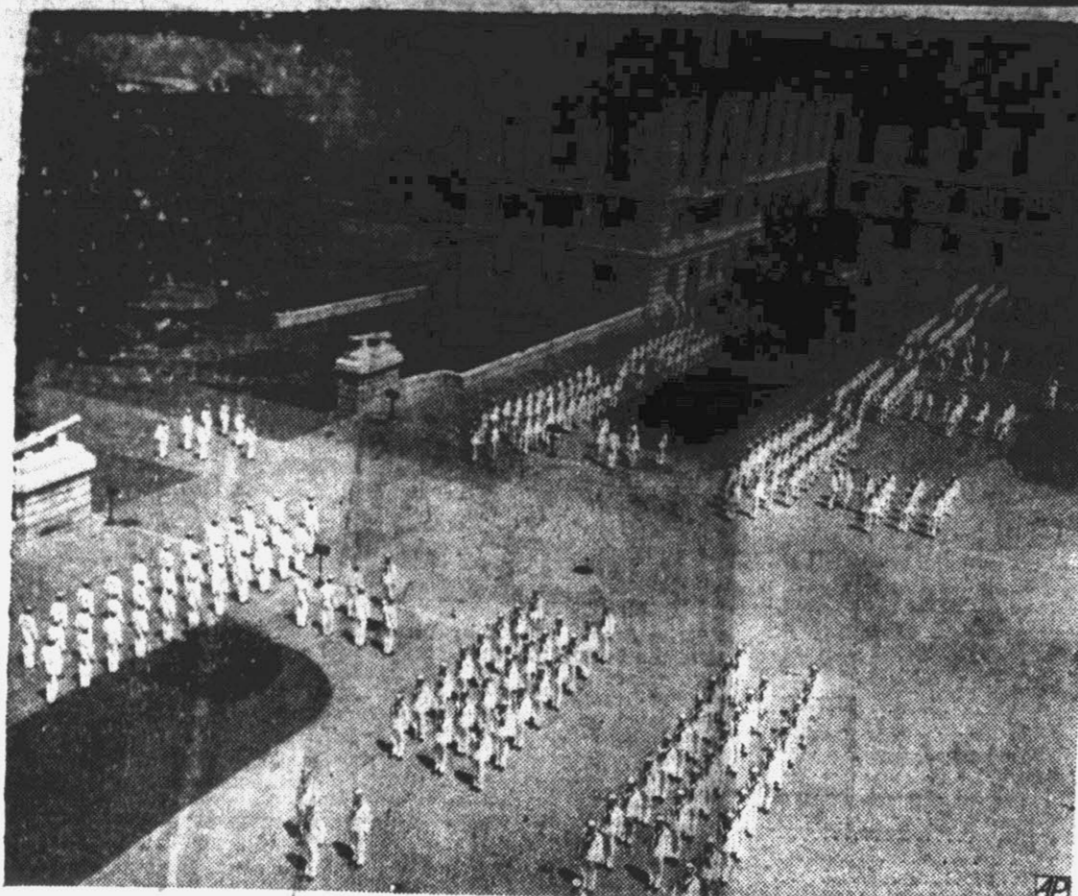

RIVERS NOW ON THE WANE

State Is Recovering From One of Worst Floods

By ASSOCIATED PRESS

Waters on a majority of North Carolina rivers and streams were dropping steadily to a normal level today, after a week-long flood which will rank as one of the most disastrous in the State's history.

The "critical point" seems to have passed at Elizabethtown, Tarboro and Goldsboro. The Cape Fear, Tar and Neuse appear to have reached their crests at these three respective points.

In the very lower reaches, however, these rivers continued to rise toward their crests, with little damage anticipated by the Highway Department and Weather Bureau. The Cape Fear is expected to crest at Wilmington tomorrow.

The Weather Bureau reported the Neuse at Kinston to be at 21 feet. At Greenville, the Tar had slowly risen to 19.2 feet.

At Fayetteville, the Cape Fear continued to recede, and Red Cross officials continued to rehabilitate 1,500 families which were driven from their homes by high water.

The Highway Department reports the once paralyzed highway system "practically normal." The only highway causing trouble now is No. 87 from Elizabethtown to

Filmington.

U. S. 117 south of Goldsboro remained closed today but will be reopened tomorrow.

Highways opened today are U. S. 64 and 258 at Tarboro and U. S. 95 east of Rocky Mount.

Meanwhile, the State Highway and Agriculture departments continued their inspection of flood damages. Chairman of the Highway Commission, A. H. Graham said that an untold amount of damage had been done to roads

Standard Time

Washington, Sept. 25—(AP)—President Truman today signed legislation returning the nation to standard time effective at 2 a. m. Sunday, Sept. 30.

On that day, clocks must be turned back one hour to end daylight saving or war time.

Fathers Of Three To Be Discharged

Washington, Sept. 25—(AP)—The Navy announced today that any enlisted man with three or more children under 18 years of age will be released at his own request.

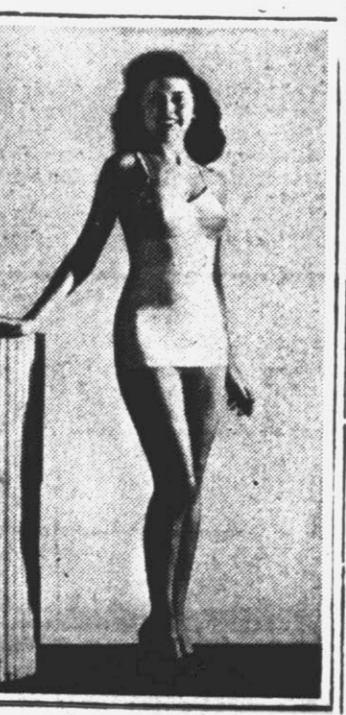
The move, effective immediately, marks a liberalization of policy governing so-called "hardship" cases which are handled outside the point discharge system. Under such conditions, an enlisted man would be considered a "prima facie hardship case," the Navy explained.

The change will not affect the point system, which gives a flat 10 point credit for dependency regardless of number of dependents.

The Navy estimated at the time the point system went into effect that there were about 97,000 enlisted men in the Navy with three or more children. A "sizeable percentage" of that number already have been released under the point system, however.

The new rule does not apply for officers. "Hardship" cases involving officers will continue to be considered individually.
