Believes Berliners Would Vote To Just Communists

General Eisenhower Says All Major Posts Of Local Government Now Under Communist Domination; Investigation Shows Democratic Parties Growing

Washington, Oct. 16.—(AP)—General Eisenhower said today "normal reports indicate a fair and impartially supervised election in Berlin would not support the present Communist Party dominance" of the city's government.

The general put into his second monthly report on military government in the American zone of occupation a critique on politics in Germany—including those in the Russian zone.

Here is what he had to say about Berlin, where the Allied control authority has its headquarters and where the four Allied powers have four zones.

"Four organized parties exist there. They were granted permission by the Soviet military authorities to organize and so were functioning when U. S. forces occupied the U. S. sector of Berlin. Four parties are the Communist Party, the Social Democratic Party, the Christian Democratic Union, and the Liberal Democratic Party.

"The first two are well organized, active and have a basis of former members on which to build. The latter two groups are new parties, though drawing support from middle class, conservative bourgeois elements formerly associated with the Centre, the German Democratic Party, and the German People's Party.

"The four parties in Berlin joined, on the initiative of the Communist Party, in a united front political bloc intended to unify their

JAPAN BEGINS LONG ROAD TO REFORMATION

Officials Working To Revise Constitution Whereby Japanese Government Would Serve Rather Than Dominate People

Tokyo, Oct. 16.—(AP)—New Japan, poverty stricken and spiritually crushed, officially without vestige of an armed force for the first time in history and without standing among nations, began the long road back to acceptance in the society of the world today.

Politicians and militarists whose lives had been dedicated to the growth of the stolen empire, struggled to revise the constitution for a peaceful Japan in which the government would serve rather than dominate the people, and to outdo each other in cooperation with the conquering occupation forces.

More than 500 members of the new Nippon working masses party, freed now from fear of the dread "thought police," distributed handbills calling for the mass suicide of the former ruling classes of Japan, then publicly demonstrated before General MacArthur's headquarters.

Their Japanese banners, as they paraded past the imperial palace moat, dealt not with the problems of empire, however. They asked MacArthur to tell the government to give them more bread.

Evidence of what General MacArthur had in mind yesterday when in his broadcast announcing completion of Japanese demobilization he referred to the "humiliation and finality of this surrender," was developed in stories of self-abasement of military men. American officers sorting details of the former Nipponese fighting machine have encountered scores of such cases.

American artillery officers were shown an undamaged coastal gun by a bowing Japanese officer. "This was one of our best weapons, but we never fired it," he asserted.

Other Americans viewed the world's largest anti-aircraft gun and were told "We couldn't get the hang of the mass fire control principle." A Japanese general displayed Japan's newest and largest tank and admitted it never was used because the Japanese couldn't get the bugs out of it.

American naval authorities found the same zeal for confession of ineptitude when they took over two of the world's largest submarines—5,700-ton undersea monsters with 50,000-mile cruising range.

As the Americans, who entered Japan with less than a division and disarmed a nation with 4,000,000 fighting men on the ground, continued to extend their occupation (Continued on Page Four)

No Announcement Of Next Move By Washington; Violence Flares In New York Longshoremen's Strike; Scarcity Of Coal Closing Schools And Industries

By ASSOCIATED PRESS The nation's labor disputes, numbering at least 135, kept some 385,000 workers from their jobs today, the lowest total this month, but the general labor picture was not very bright.

The darkest cloud came out of Washington in the form of Secretary of Labor Schwellenbach's announcement of the collapse of the conference to settle the critical soft coal strike.

In New York City, where a 17-day strike of AFL longshoremen has virtually paralyzed shipping in the world's biggest harbor, there was reported violence within the union ranks and by CIO unionists, as extra police were ordered to the waterfront.

On the bright side was the resumption of service to some 1,000,000 New England bus and trolley riders as buses, under control of the Commonwealth of Massachusetts, began rolling after a three-day strike of 1,800 eastern Massachusetts street railway employes.

The scarcity of fuel in many of the strike area brought further curtailment to steel and other industries, and threatened to close three large Pittsburgh high and junior high schools: Cold weather in the western part of Pennsylvania may also force some churches to close by the end of the week, a coal merchants' association spokesman said.

Violence was reported in the 16-day old strike of dock workers in New York harbor, which has virtually halted all outbound shipping, and hundreds of extra police were ordered to patrol duty along the big waterfront today. The additional squads of police came after rival factions within the AFL Inter-

Many Released Workers Now Enjoying Long Delayed Vacations

By SIGRID ARNE AP News Feature Writer Seattle, Oct. 16.—(AP)—It may be next March or April before the nation knows whether it has again a great pool of unemployed workers who can't find jobs.

And, perhaps, when the "reconversion smog" has cleared, the nation will discover that its center of population has had a shove toward the West.

This reporter has talked to city and federal officials, to employers and labor leaders from coast to coast in the last seven weeks; from New Bedford, Mass., to Seattle, and everywhere the story is the same.

There is a huge slice of workers who seem to have "evaporated." They have been laid off, but they are not looking for jobs, and they are not applying for unemployment compensation.

Will they be back seeking jobs later? If so, what portion of them? What are they doing now? How long will their savings last? This one fact seems clear: The farther west you go the greater is the desire among workers to stay in the cities where they have worked these four war years. Kansas City has found that more than 50 per cent of its new population wants to stay, and here in Seattle, 75 per cent of the people plan to stick it out.

If jobs can be found for them in their newly adopted cities, it will result in a permanent shift of population to the west.

Nothing but guesses are available anywhere now, but here is a sample of what's happening.

Bridgeport, Conn. Two weeks after V-J Day some 15,000 to 25,000 were out of work, but only 8,000 had applied for unemployment compensation at the same time 800 job openings were going begging. Most surprising of all some 24,000 (Continued on page four)

HALSEY URGES ARMED PEACE

Pacific Hero Says America Must Remain Strong

San Francisco, Oct. 16.—(AP)—Admiral Halsey, warmly welcomed home from the wars, said today that the peace must be a military one if it is to last.

"This is what we have dreamed of, hoped for, fought for and prayed for—to return home again, knowing that our enemies have been vanquished," the admiral said in a broadcast after the ships of his Third Fleet had dropped anchor in San Francisco Bay yesterday.

"But let us not forget that to be a lasting peace, it must be a military one.

"Enemies are both born and made—the United States must vigilantly guard itself against aggression, yet cooperate to the utmost in perfecting a world organization which will function with smoothness, efficiency and certainty."

The admiral was to get the key to the city today after a parade of units of his Third Fleet up historic Market Street, and tonight he and his officers will be guests at a band- (Continued on page six)

SAYS REPORT IS MISLEADING

Eisenhower Disagrees With Harrison Statement

42—SAYS REPORT—WASH. Washington, Oct. 16.—(AP)—General Dwight D. Eisenhower reported today that Jewish refugees in American occupied Germany generally have more housing space than is required for U. S. soldiers.

The commander of U. S. forces in Europe made this statement in a letter to President Truman in reply to a report by Earl G. Harrison, U. S. representative on the Inter-Governmental Committee on Refugees, on conditions in the U. S. zone.

Japs Forced Yen On Country At Bayonet Point

By RUSSELL BRINES Tokyo, Oct. 16.—(AP)—Printing presses backed by Japanese bayonets deluged China with now-worthless currency, adding up to about 54,000,000,000 (B) U. S. dollars in face value, the Tokyo newspaper Asahi said today.

The figure was the first to be published indicating the degree of financial plundering of Japanese-occupied territories by Japanese militarists. It was disclosed by the newspaper in its demands on the imperial government to curb inflation.

Notes totalling 4,000,000,000,000 (T) Yuan were issued by the Central Reserve Bank of China, financial agency backed by the Japanese militarists, the newspaper said.

This sum, at the official rate of five yuan to one yen, equaled 800,000,000,000 (B) yen, or nearly 20 times the war time homeland note output of the Bank of Japan, which contributed much to inflation in Nippon. The current rate is 15 yen to one U. S. dollar.

American authorities, studying the records of the Central Reserve Bank of China and other Japanese institutions used to exploit the empire's conquests, have declined to announce figures until their survey is completed.

Asahi's report was made in a story outlining some of the financial problems facing the government.

But the actual plundering implied by the size of the China bank's note issue must be doubted to evaluate the total of militaristic financial profits. When the notes were first issued they were arbitrarily discounted at one for two former Chinese yuan, thereby halving all bank accounts and other assets. (Continued on Page Four)

Miss "Points"

Manila, Oct. 16.—(AP)—A very junior miss in Dallas is going to be named "Points," her jubilant father, Master Sgt. Ernest J. C. Creighton, told Red Cross workers.

Creighton asked the Red Cross to check on the health of his wife who was expecting a baby in October. The check disclosed that the daughter had arrived on the scene prematurely August 30.

Creighton let out a long whoop and then explained that he was scheduled to go to Japan with the occupation troops but the baby's early arrival gave him the necessary points for an immediate transfer home. "Whatever we name her, I will always call her Points," Creighton said.

Upward Trend In Highway Deaths

Raleigh, Oct. 16.—(AP)—In his report for the first six months of the year, T. Boddie Ward, Motor Vehicles Commissioner, yesterday announced that 275 persons were killed on North Carolina highways during that period as compared with 305 during the corresponding period last year.

His report also stated that as of Sept. 20, 1945, a total of 447 persons had met death on the state's highways and 2,862 injured in 4,856 accidents.

Today In Congress

Washington, Oct. 16.—(AP)—A House committee called for more facts on atomic energy. The CIO called for bigger tax cuts for small income people and business.

That was part of the story on death and taxes—two of the big subjects today in Congress.

In addition, The Senate Judiciary Committee okayed a bill to let President Truman reshuffle government bureaus and commissioners—with Congress keeping the right to veto any of the changes. That veto proposal may bring on a stiff fight on the Senate floor.

The President himself asked Congress to find out whether Puerto Rico wants independence, statehood, a dominion form of government or an improved local government. This country, he said in a message, should be ready to give Puerto Rico what it wants.

Secretary of Commerce Wallace urged an immediate boost in the nation's minimum wage level from 40 to 65 cents an hour. He appeared when a House committee started work on a bill to bring about the raise for employes of companies in interstate commerce.

The CIO said the House approved tax bill—to cut taxes by \$5,350,000,000—would give "huge windfalls" to the richest individuals and corporations.

By GRAHAM HOVEY (Substituting for James Marlow) Washington, Oct. 16.—(AP)—A week from today, an Allied Far Eastern Advisory Commission will be established in Washington.

Its main job? To make recommendations on how Japan can best carry out its surrender agreements.

Some people think the United States agreed to establish the commission because the Russians complained about the way General MacArthur was running things in Tokyo. Others believe the commission will govern Japan in place of MacArthur.

Both groups are wrong. First of all, Russia never has lodged a complaint about MacArthur's Tokyo administration. Nor has any other government.

Ang Secretary of State Bernes first proposed the commission to Russia, Britain and China August 21—right after the Japanese surrender.

Finally, MacArthur will remain the boss in Tokyo. The commission can't send him a single directive. It will not even send its recommendations to him; they'll go to the governments represented on the commission.

Well, then, will the commission's work be just "window dressing"? Is it intended to give an appearance of international teamwork while the U. S., through MacArthur, continues to crack the whip alone?

By DEWITT MACKENZIE AP Foreign Affairs Analyst MacArthur's epitaph for broken Japan is so starkly realistic that it brings one up with a jolt.

"This ends its military might and its military influence in international affairs. It no longer reckons as a world power, either large or small."

This perishes an evil power which for almost a hundred years increasingly dominated the Orient until finally greed impelled it to overreach itself in an effort to master and enslave not only its neighbors but to conquer great countries of the western world. We have realized, of course, that Japan has suffered complete defeat, but we are so close to this epochal event that it is difficult to sense its true immensity.

Nippon has been utterly smashed. Not only that but she has been deprived of her ill-got gains and thrust back into her tiny island Kingdom. She now lacks the resources to recover anything approaching her former position. She has been flung into the oblivion from which she emerged almost within the memory of living man.

Now that's a fact of tremendous import. It means that a vacuum has been created in the Orient, with the disappearance of this dominant power. It is in the nature of things that something must rush to fill that vacuum. That is, some other power will in due course take its place.

What will it be? He would indeed be gifted with rare vision who could see that now

LOUIS WILL FIGHT CONN

Heavyweight Champion To Defend His Title In June Bout

New York, Oct. 16—(AP)—Joe Louis is going to defend his title against Billy Conn next June in a bout that will probably draw a \$3,000,000 gate, but where the fight will be held is a guessing game that involves New York, Chicago, Philadelphia and Detroit.

The Brown Bomber signed to defend his title yesterday in a scene reminiscent of the hoopla and fanfare of pre-war days when a heavyweight championship contract signing was a great event.

Conn is scheduled to come in tomorrow to scribble his name on the legal document that will enrich him for life. This being the first title bout among the big boys since Louis flattened Abe Simon in March, 1942.

Promoter Mike Jacobs plans to sock a \$100 label on the ringside seats and expects that the fight will do \$3,000,000 at the gate and "I wouldn't want to try to guess what the figure might be if you counted in movies, radio and television."

Uncle Mike is sold on television and believes that it won't be long before the gate from the sale of tickets at the site of a super-special battle will be dwarfed by the revenues collected from hundreds of theaters where the fight will be televised.

It's the question of the extras that may cost New York a title fight again. Jacobs said the Empire State exacts a five per cent tax on the gross receipts of movies and the levy extends to all the states or countries where the film might be shown. He figures that if Conn wins, the pictures will be worth more than the gross gate.

Chicago drew \$2,650,000—the largest gate in history—for the second Jack Dempsey-Geney Tunney fight in 1927.

All critics who did not place the West Pointers first on their ticket ranked the Cadets second. Alabama moved up from seventh to sixth place and Pennsylvania, victor over North Carolina, hopped from 13th place a week ago to seventh while Indiana and Texas, eighth and 10th respectively in the first compilation, kept those places in the present counting.

Purdue, whose Bollweavers crushed Iowa, 40 to 0, shot from the 15th slot of seven days ago, to ninth this week.

Michigan, ninth in the previous listing, skidded to 13th, following its defeat by Army, while Southern California, lone West Coast power a week ago, spun from sixth to 14th in the 33 to 6 defeat by the San Diego Naval Outfit.

Ohio State and Purdue appear to have the toughest battle to retain their rankings this weekend as the loser almost certain to become a discard in the Big Ten title race. Army shouldn't have too much trouble in keeping its prestige playing the Melville, R. L. Torpedo Boat
