Senate Talking Investigation

Adm. William D. Leahy Tells Congressional Pearl Harbor Investigator He Has No Recollection Of President Saying Doubtful U. S. Fight Japan

Washington, Nov. 21.—(AP)—Adm. William D. Leahy has told a congressional Pearl Harbor investigator he has no recollection that President Roosevelt ever said it was doubtful the United States would fight if the Japanese attacked the Philippines.

Disclosing that Leahy had made this statement to him, Rep. John W. Murphy (D-Pa.) told a reporter today he plans to re-examine Adm. O. Richardson, former commander in chief of the fleet, about a White House luncheon conversation with the late President on Oct. 8, 1940.

Leahy, who was Mr. Roosevelt's wartime military adviser and was part of the luncheon 14 months before this country was plunged into war, was called to testify before the Senate-House investigating committee after it finishes hearing Richardson today.

Cordell Hull, former Secretary of State, also was on the list of witnesses, but Chairman Barkley (D-Ky.) said he may not be reached until after tomorrow's Thanksgiving holiday.

In his report of the Oct. 8, 1940 White House conversation Richardson testified earlier he asked Mr. Roosevelt if this country was going to enter the war. He paraphrased the President's reply as follows:

"He replied that if the Japanese attacked Thailand, or the Kure Islands, or the Dutch East Indies, we would not enter the war; that if they even attacked the Philippines he doubted whether we would enter the war, but that they could not always avoid making mistakes and that as the war continued, and the area of operations expanded sooner or later they would make a mistake and we would enter the war."

Murphy said he feared this statement on the Philippines might have repercussions. Accordingly, he said he asked Leahy about it.

He quoted the admiral as replying that he, Leahy, had a sharp recollection of Richardson's having argued for return of the fleet from Hawaii to the Pacific coast but that he had no recollection of the President's having expressed doubt that an attack on the Philippines might provoke this country to war.

Senator Lucas (D-Ill.) said Leahy was called to meet this committee's understanding that it would summon all witnesses available where a conversation was reported with a man who since had died. He said Leahy would be asked at this time only about the White House conference and would be recalled, later for other testimony.

Senator Ferguson (R-Mich.) prepared to continue, meanwhile, his cross-examination of Richardson.

Ferguson and Senator Brewster of Maine, the other Republican Senate member of the committee, were prevented by a Senate recess from replying today to a contention.

The other day there died in Tennessee a man named Luke Lea. One of the high points of his very active life (he was soldier, publisher, senator) was an attempt to kidnap the Kaiser.

Colonel Lea and a handful of picked followers essayed the capture of the German emperor in Holland shortly after the end of World War One because all the Allied bluster about trying war criminals, and the shouts of "Hang the Kaiser," proved to have been the thumping of empty tubs. Lea and his colleagues decided to take the matter into their own hands.

The colonel was living ahead of his time. Today—a generation later—the Nuremberg trials are under way, and a score of Nazi leaders are facing judgment for the part they played in Hitler's assault on humanity. The other day Josef Kramer, the "Beast of Belsen" and twenty-nine others were convicted by the British at Lüneburg for the horrors of the Belsen and Auschwitz concentration camps. And Japan's war-lords are being brought to book.

These trials, as I see it, mark a world movement in the right direction. It's difficult for you and me, as we think of loved ones lost in this cruel war, to see good coming out of such a conflict. But it is

INTERVENTION IS PROPOSED

Proposal Made That President Truman Intervene At Conference

Washington, Nov. 21.—(AP)—A proposal that President Truman intervene in the Labor-Management Conference to hasten its seemingly slow progress was reported today.

Persons concerned over what they consider the failure of delegates to grapple effectively with major problems of labor unrest have suggested that Mr. Truman deliver to the conference a "yardstick" of the work he expects of it.

This was reported by two public officials well posted on conference affairs, but both unwilling to be quoted by name.

One said the suggestion already had been taken up with Mr. Truman, but neither wanted to guess whether the President might decide to step in.

Behind the plan was this argument:

That in calling the conference Mr. Truman desired some voluntary agreement on means of minimizing labor disputes which would make it unnecessary to call on Congress for restrictive labor laws.

That it is time—after more than two weeks of meetings—for the industry and union delegates to be told what steps must be taken to render action by Congress unnecessary.

That a lack of such concrete achievements might leave open the way for industrial upheavals which could submerge any long-range approaches to labor-management understanding.

That the proposed "yardstick" of progress might include agreement first on some machinery for voluntary arbitration of disputes, and second, on a fact-finding procedure.

Elderly Negro Man Killed By Bullet

James Worthington, 78-year-old Negro tenant farmer on Dixie farm near Ayden was fatally wounded by a 22 rifle bullet in the temple yesterday afternoon while working in a cornfield. He died at his home early today without regaining consciousness.

Pitt County Coroner Griffin H. Rouse said \$468 Worthington had in his pocket was intact when he was found. The corner and a deputy sheriff inclined to the belief that a stray bullet from a hunter's rifle in nearby woods struck the man.

When Worthington failed to return to his son-in-law's home on the Cannon farm last night, search was started. He was found in an unconscious condition.

Coroner Rouse said an inquest will be held after further investigation.

ECTC PLANS ENLARGEMENT

Million Dollar Improvement Program Discussed

Tentative plans for a \$1,000,000 building and improvement program for East Carolina Teachers College were discussed at a meeting of the Building Committee of the Board of Trustees held here yesterday, according to Dr. Howard J. McGinnis, acting president of the college.

Seven new buildings and six projects involving improvements or additions to present buildings were discussed.

Present for the meeting were the committee members, including Ralph M. Garrett and J. Herbert Waldrop of Greenville and Mrs. Charles M. Johnson of Raleigh and architects Eric Planagan of Henderson and W. W. Pollock of Raleigh.

New buildings include a health and physical education building, a student union, a dormitory and apartment building for teachers, a workshop and storage plant for the staff maintaining buildings and grounds, a dormitory for women students, a library, and an arts and industries building.

Plans to complete several structures on the campus were under consideration. Additions to the present laundry and to the power plant, both of which now have inadequate facilities, are being pressed, along with the remodeling of student dormitories to improve lighting.

According to present plans, Ragsdale Hall, one wing of which is now occupied by men students, will be converted into a dormitory for men.

These gift packages can be assembled easily. Just buy four or five of the items recommended and wrap attractively in a Christmas package. Be sure to attach a label to the outside showing contents of the package.

This is a government-authorized project. Packages will be received through Saturday, December 8, by Mrs. Arthur Corey, rehabilitation chairman of the American Legion Auxiliary or by any member of the Auxiliary. The following is a suggested list of items for Christmas gifts for the patients:

Stationery and writing portfolios, address books (medium size), manicuring sets (for men), snapshot albums, leather frame mirrors, wallets, shaving sets, money belts, leather traveling playing card sets, cigarette cases, whisk broom in leather case, military brush sets, white handkerchiefs, white scarfs, tobacco pouches, pipes and pipe tobacco, mechanical pencils, shoe polish, sets, small leather or plastic boxes for insulin or buttons, sewing kits, small dictionary, small magazines, books and pocket books, shaving cream, tooth paste, deck of cards, cigarettes, socks, puzzles, dice.

Razor blades, needles, knives and needles are prohibited.

Your name on a card may be included in the package, but no letters or personal notes.

Shifting In Commands Of Army And Navy Top

Army And Navy Undergo Major Top Command Shift In Midst Of Inter-Service Scrap To Merge

Washington, Nov. 21.—(AP)—The army and navy underwent a major shift in top commands today in the midst of an inter-service scrap over proposals to merge them.

President Truman announced the biggest shakeup in the defense departments since before the war, with these four changes:

1. General of the army George C. Marshall, 64-year-old army chief of staff, retires, to be succeeded by General of the Army Dwight D. Eisenhower, 55.

Fleet Admiral Ernest J. King, who will be 67 Friday, retires as chief of naval operations, and Fleet Admiral Chester W. Nimitz, 60, takes his place.

3. Gen. Joseph T. McNarney, 52, who recently was acting Allied supreme commander in the Mediterranean theater, succeeds Eisenhower as commanding general of the American forces in the European theater, commander-in-chief of the U. S. occupation forces in Germany and U. S. Representative on the Allied Control Council of Germany.

4. Adm. Raymond A. Spruance, wartime commander of the Fifth Fleet, who has been described by associates as a "cold-blooded fighting fool," becomes commander-in-chief of the Pacific Fleet in place of Nimitz. He is 59.

The shifts were announced at a late afternoon news conference yesterday. Mr. Truman said Gen. Brehon Somervell, commander of the army service forces, had asked to be relieved, too, but he had not consented to their retirement at

that time.

He said both Marshall and King had sought retirement after Japan surrendered but that he had prevailed on them to stay until now.

Asked about the differences in views on the army-navy merger—Eisenhower favoring it and Nimitz now opposing—Mr. Truman said he would state his own attitude in a message to Congress and after that all will be in the same boat. He did not amplify.

In a formal statement, the President said Marshall feels that his primary duty of directing the mobilization, training and employment of the wartime army has been completed and that decisions bearing on "an interim and postwar army" should be made by a successor.

Mr. Truman reiterated his view that Marshall is the greatest military man that this country ever produced—or any other country, for that matter.

Pending Senate action on Eisenhower's nomination, the President named the 55-year-old Kansan as acting chief of staff, effective immediately.

Nimitz will return to the Pacific to turn over his command to Admiral Spruance, then return here for a few weeks' rest before taking over King's place.

Immediate reaction on Capitol Hill to the command shifts was uniformly favorable.

The Marshall-Eisenhower and King-Nimitz changes have long been expected. Their names were on nearly every lip during the war.

Committee of the House Expenditures Committee yesterday approved a "compromise" version of the measure.

Though this version hasn't been made public, all signs indicate that it falls far short of the jobs for all guarantee wanted by Rep. Wright Patman (D-Tex.) and other supporters of the bill.

But Patman told a reporter he is not too concerned about that, because the main thing is for the Expenditures Committee not to "keep the measure bottled up any longer."

Labor disputes—shall the House go ahead and debate a bill that would punish unions if they violate no-strike contracts, or shall the House wait until the National Labor-Management Conference is over?

The House Rules Committee met today to decide that issue.

Education—Shall the Federal Government spend \$300,000,000 a year to strengthen public schools, especially schools in states that do not collect much tax money?

On this disputed question, the House Education Committee has decided to go ahead and work on a bill now, instead of waiting for President Truman to make a long-awaited statement on federal aid to education.

U. S. Employment Service—On what date shall it be returned to the control of state governments?

Yesterday, by a count of 35-31, the Senate voted down a proposal to postpone the date until next June 30. The Senate decided instead that the employment offices

German Wartime Leaders All Pleading Not Guilty

CIO's Auto Workers Stage Strike Today

Walkout At Plants Of General Motors Corporation Aimed At Crippling Gigantic Producer To Force Wage Boost

Detroit, Nov. 21.—(AP)—The CIO's United Auto Workers Union struck at the plants of General Motors Corp. today in a walkout aimed at crippling the gigantic producer in order to force a 30 per cent wage rate boost.

The strike, first, big authorized peacetime walkout of the UAW-CIO and the union's first such blow at General Motors since the sit-down strike of 1937, began before 11 a. m. (EST).

All GM's plants in 20 states, employing close to 200,000 production workers, were ordered out in the long threatened battle between America's largest labor union and biggest operating corporation.

The first reported walkout at an individual plant was at Flint, Mich., where employees left work at the Buick Motors plant. Nearly all had left the plant by 10:40 a. m.

Buick's force had been reduced temporarily from its original estimated 9,000 by a shortage of chassis frames which had stopped the production of Buick cars several days ago.

In meetings at Flint last night Union members were warned to refrain from violence, but to see that non-union foremen were not permitted to enter the Flint plant.

Local 1076 of the AFL's Building and Trade Council notified the Flint UAW-CIO that approximately 1,000 AFL workers aiding in the General Motors reconversion program will walkout in sympathy with the auto workers.

Officials of the Railway Brotherhood told the strikers that a single man posted at track entrances to GM plants will be recognized as a picket line, and that railway traffic into the factories will cease.

Chevrolet Local 659 took over a restaurant near the Flint plant this morning and planned to serve coffee, doughnuts and sandwiches to pickets.

Two Flint locals voted strike funds to augment those provided by the International UAW-CIO, but two other units turned down similar proposals.

Buick Local 599 voted to take \$2 per member out of its general fund to aid the strike cause and Fishermen Body Local 581 voted a strike as well.

National Troops Are On Advance

Chungking, Nov. 21.—(AP)—Nationalist troops who broke into Manchuria through the Great Wall were reported by the army newspaper Ho Ping Pao today to be approaching Hingcheng on the Peiping-Mukden railroad some 60 miles northeast of Shanhaikwan.

The Nationalists encountered little or no resistance, the report indicated, as their present position is 25 miles northeast of yesterday's.

The newspaper predicted the Communist-held port of Huludao, 17 miles northeast of northern Hingcheng, will be captured in a few days. It said the area between the eastern end of the Great Wall and Puning, about 25 miles westward, had been cleared by the government forces.

Communist sources in Chungking, meanwhile, drew attention to what they described as a "serious situation" in Central China where more than 100,000 government troops were purportedly massing. The insurgent spokesman asserted large scale fighting is expected soon in central Honan and northern Hupei provinces, where 14 government divisions are strung along a 110-mile front, facing the Communist Eighth Route army and the new Fourth army, which recently joined forces.

The government advance already has wrested a number of towns from the Communists.

They were separated by time and seemed in a way unrelated.

Yet the history books will show how each, by failing to do what it set out to do, led to World War II. All were supposed to get the world back to a sane, peaceful, prosperous position.

For months now, ever since the atomic bomb hit Hiroshima, we've been listening to a torrent of words on that weapon; we should keep it, we should share it, we should outlaw it.

And while we listened the foreign ministers of this country, Britain, Russia, France and China, met fruitlessly in London, and the United States and Britain continued to plumb Russia's intentions in middle Europe.

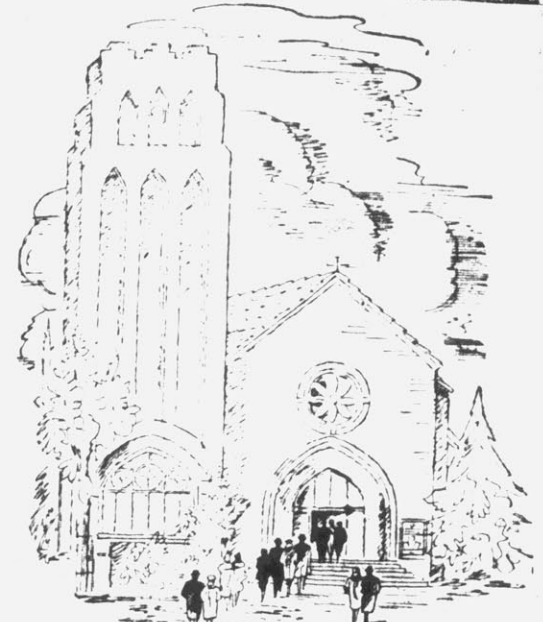

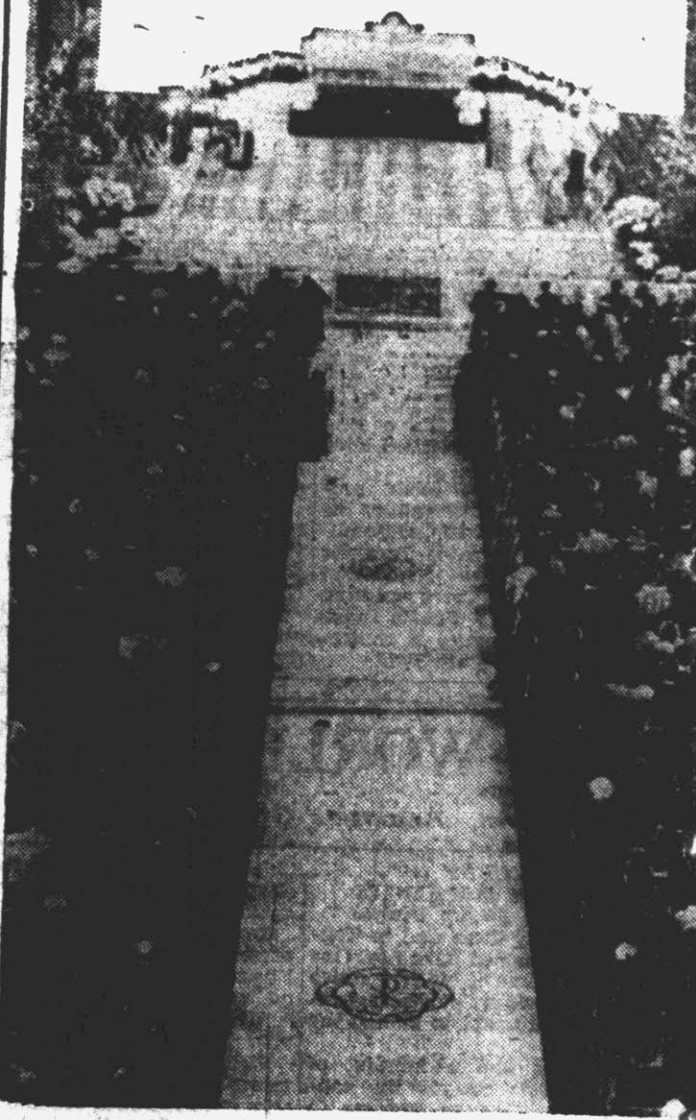

Justice Jackson, in a 20,000-word statement to the court, asserted:

"They have subjected their European neighbors to every outrage and torture, every spoliation and deprivation that insolence, cruelty and greed could inflict."

"They have brought the German people to the lowest pitch of wretchedness, from which they can entertain no hope of early deliverance. They have incited domestic violence in every continent."

He said the real complaining party in the trial was civilization, which "is still a struggling and imperfect thing."

"It does not plead that the United States or any other country has been blameless of the conditions which made the German people

easy victims of the blandishments and intimidations of the Nazi conspirators."

"But it points to the dreadful sequence of aggressions and crimes I have recited—it points to the weariness of the flesh, the exhaustion of resources and the destruction of all that was beautiful or useful in so much of the world, and to greater potentialities for destruction in the days to come."

Hess, apparently suffering from an attack of abdominal cramps, was led from the courtroom a short time after the defendants had entered their pleas, but returned six minutes later and sat down.

During the brief intermission before the trial resumed, several lawyers took advantage of the recess to talk to their clients, with

only Goering, Rosenberg and Grand Admiral Karl Doenitz conferring with their counsel.

When Justice Jackson stepped to the center of the courtroom and began reading his 20,000-word statement, the Nazi defendants leaned forward and listened closely in marked contrast to their indifference to the proceedings yesterday.

When Jackson solemnly stated that the Nazi leaders would be convicted by their own documents, Hans Frank, Hitler's ruler over conquered Poland, laughed aloud. There were no smiles from the others, however.

At Jackson's reference to the Reichstag fire, Goering leaned quickly forward.

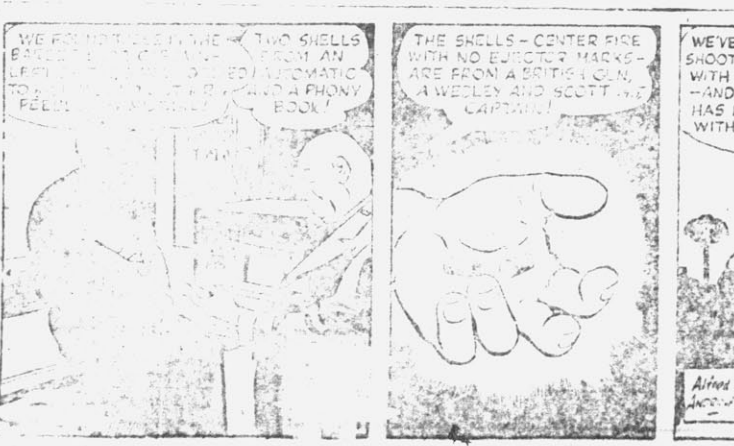

Urges Farmers To Cast Votes

Every farmer has a vital interest in future decisions on farm problems, whether local, state, or national. W. Kerr Scott, commissioner of Agriculture, said here today in an effort to encourage Tar Heel farmers to go to their community center and vote in the annual election of AAA committees on November 30.

Urging a full representative vote in each of the 1,733 AAA communities throughout the State, Scott deplored "stay-at-home" tendencies among some farmers, and appealed for a full turn-out for this year's

elections. About 350,000 North Carolina farmers are eligible to vote in the coming elections. A total of 9,065 community committees and 100 delegates to county conventions are to be elected. Two alternate committees will also be chosen for each community. The delegates will elect three member county committees to administer AAA activities in each county.

"Many grave problems lie ahead for agriculture," Scott asserted, "and it is most important that these men have the support of every eligible farmer in their community."

Marine Officer Is Found Guilty

Cherry Point, Nov. 21—(AP)—Capt. William B. Thalheimer, Reserve Marine captain from Richmond, Va., is hopeful "that some, or all, of the remaining six findings which now stand against him before a trial by courts martial—will be set aside or disapproved," his defense counsel said last night.

Found guilty by a general court martial of "conduct to the prejudice of good order and discipline, culpable inefficiency and neglect of duty," the Post Exchange officer now awaits court consideration of the remaining six findings—all that remain of the original 24 specifications of the three charges against him. On the 24, 18 have been disposed of favorably to Thalheimer.

The remaining charges alleged that the Marine officer had "inefficiently handled the Post Exchange and was guilty of conduct to the prejudice of good order and discipline."

Social Security

Due to the shift in employment caused by the end of the war, the value of your social security account card becomes increasingly important. The individual who has been engaged in farm work and goes into industrial employment of a war job, will need an account number. The men and women, boys and girls who may engage in farm work following a period of industrial employment should hold on to their social security account cards because some of the work may be considered covered employment. Furthermore, on the return of such workers to their old jobs in the cities or to other commercial or industrial employment, the same account number will be good. Therefore, Mrs. Ruth G. Duffy, manager of the Rocky Mount Social Security Board office, suggests that workers make sure that this very valuable account card be kept in some place where it will not be lost.

The President's advisers were said to be divided on the idea. Those favoring his intervention were perhaps outnumbered, it was said, by those who felt the government should let the industry and labor leaders run the conference themselves.

Mr. Truman's only comment on the parley's progress—given at his news conference late yesterday—was that he hoped the meeting would yet produce a concrete formula for the settlement of labor disputes.

Conference Secretary George W.

Taylor told newsmen that the conference as yet had given no consideration "that I know of" to the creation of machinery to replace the War Labor Board or meet the immediate crisis in automobiles, steel and other converting industries.

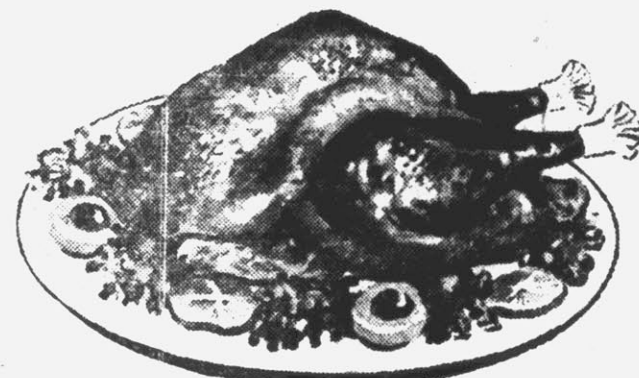

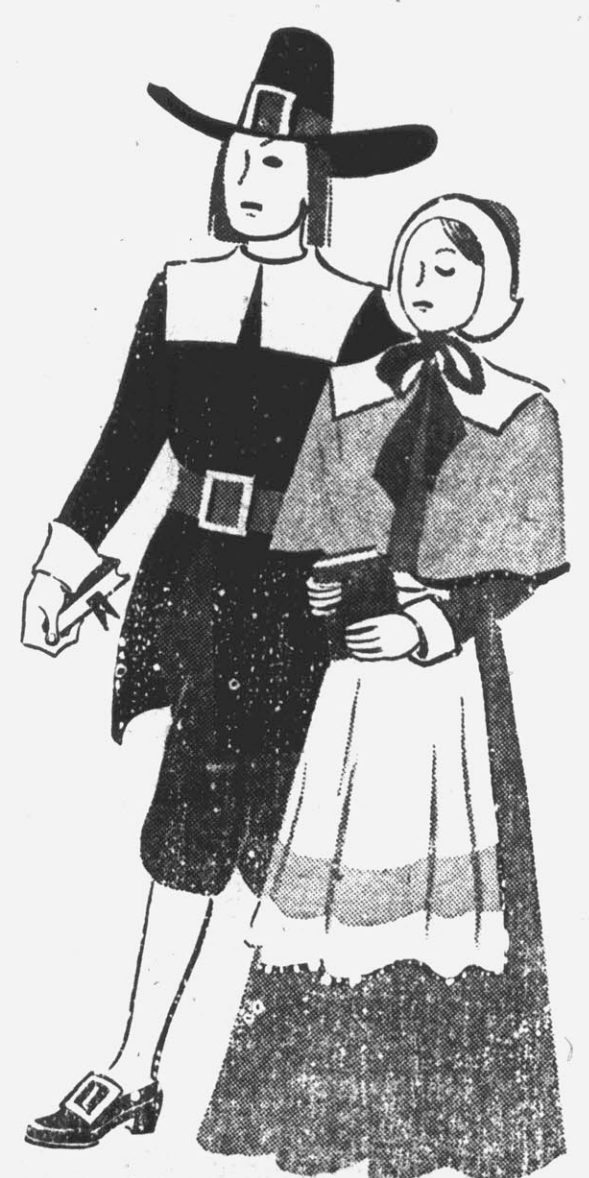
