Troops Protest War Dept. Order

Soldiers Blame War Department for Concessions in Redeployment Policy; GI's To Put Case Before Visiting Congressmen

By JOHN GROVER Manila, Jan. 7—(AP)—A charge that a uniformed man, representing himself as an officer, examined hundreds of soldier telegrams protesting to Congress a demobilization slowdown was made today as Manila still echoed to a mass demonstration by thousands of miffing U. S. enlisted men.

The charge was made by Earl Baumgardner, manager of the Manila branch of the Radio Corporation of America, shortly after the soldiers demonstrated outside the office of their commanding general and called another mass meeting for tonight.

Baumgardner said a Filipino night supervisor was on duty early today when a man wearing an U. S. Army officer's uniform entered the office, demanded to see the files, and read them.

The manager declared that whoever the man was, he had no authority to examine the files, violated the civil and criminal codes, and he had called the matter to the attention of Lt. Gen. W. D. Styer, commanding army forces in the Western Pacific.

"You can be certain that the examination of the cable office files was without the knowledge or approval of General Styer," said T. Col. A. R. Hurd, public relations officer.

Earlier a committee of five GI's personally placed the men's "beef" in the hands of Lt. Gen. W. D. Styer, commander of Army forces in the Western Pacific, after a parade of about 3,000 soldiers to headquarters this morning.

Styer told the committee that the "changing international situation" forbade sending all eligible men home immediately.

Military police said all the demonstrations had been orderly, and even good-natured, but Styer asked that a mass meeting planned for later today be called off. The committee said it was too late to do so, and estimated 10,000 men would attend.

The general declined an invitation to address the meeting, but said he would make a statement through the press and radio.

"We don't blame the Army forces of the Western Pacific, we blame the War Department," said Kennedy, who was slated to be chairman of tonight's mass meeting.

The War Department on Jan. 4 announced a slowdown of the demobilization program and delay in the rate of returning troops home, because of difficulties in getting replacements for overseas service.

The GI demonstrators, by word and by mimeographed pamphlets which suddenly appeared along the routes of march, said there had been much "snafu" and contradiction over redeployment, and bitterly criticized the War Department and Army "brass hats."

The soldier speakers, counseling the men against excesses, said they (Continued on Page Two)

PEACE PARLEY PROGRESSING

Delegates Pleased With Results At Close Of Day's Session

Chungking, Jan. 7—(AP)—Gen. George C. Marshall met today with government and Communist peace negotiators and at the end of the first historic session declared that he was made progress.

President Truman's special envoy, making his first comment since he stepped into the midst of the Chinese negotiations after the rivals agreed to methods leading to a truce, said the conferences would be resumed tomorrow.

Marshall met for about three hours with Gen. Chou En-Lai, head of the delegation the Communists sent here to talk peace, and Gen. Chang Chun, representing the Chinese government.

Big Four Approve Austrian Regime

Washington, Jan. 7—(AP)—The United States formally recognized the government of Austria today and expressed hope that the first nation engulfed by Nazi Germany soon would achieve democracy and complete independence.

Russia, Britain and France joined this country in granting recognition to the lenna regime headed by Chancellor Leopold Figl and President Karl Renner. The recognition does not affect the authority of the Allied council, which will continue to carry out "Allied objectives in Austria."

TIME RUNNING OUT IN STEEL STRIKE HOPES

Strike Preparations Continue In Steel Industry; Little Hope Of Compromise

Pittsburgh, Jan. 7—(AP)—The great steel strike of 1946 will begin a week from today—unless something occurs to prevent this record-breaking walkout of 800,000 workers.

The giant opponents, the steel industry and the CIO Steelworkers union—as far apart as ever on the issues—were going ahead with their strike preparations today. Steel mills are rushing to produce all they can before the shut-down January 14. Steelworkers are counting their pennies, budgeting their cash.

Some in Pittsburgh, especially among minor executives in the steel plants, still cling to a belief that there will be no strike.

Here is a summary of the issues and arguments in the dispute:

The union demanded a general pay raise of \$2 a day for all the workers. The steel companies said they can't give any raise at all unless the OPA lets them charge higher prices for steel. So the union voted to strike.

The opponents disagree flatly over:

- 1. Whether a strike would be a violation of the union's contracts. 2. Who's to blame for the lack of collective bargaining over the wage demand. 3. The size of the industry's profits.

On the question of whether higher steel prices should be allowed, there is no clash between the union and the companies. The union, taking no position, says, "prices are a matter between the companies and the OPA."

That is one interesting difference between the steel dispute and the General Motors strike. The CIO auto workers are actively opposing higher prices on autos. The steelworkers are just keeping quiet about higher prices for steel.

Another difference between the steel and General Motors dispute is that the steel companies, led by U. S. Steel Corp., are pleading inability to pay. General Motors is not pleading inability to pay.

Here is the situation on whether the union is violating its contracts: The written agreements between the union and the companies contain a clause saying there shall be no strikes. This clause is found in the section describing the procedure for adjustment of grievances.

Steel executives have interpreted this clause as preventing all strikes, for any reason at all. The union says the provision was intended to apply only to grievances arising out of differences over the interpretation of the contract.

The union says the no-strike clause was never meant to apply in case of a request for a general wage increase. The union points to another clause in the contracts which says that if there is a change in the national wage policy (there has been such a change), the union shall have the right to reopen the question of a general wage increase.

Union lawyers say that if the right to reopen wage negotiations did not include the right to strike, it would be meaningless. A spokesman for U. S. Steel said today that it may be meaningless, "but it's there just the same." Thus U. S. Steel continues to take the position that the no-strike clause means there shall be no strike for any reason.

Officer Kills Craze Negress

Lulu Joyner, Negress, aged about 30, died in the local hospital early last night from bullet wounds received at the hands of police when she ran amuck with a pistol and threatened the lives of persons in her neighborhood on west Fifth street.

A coroner's jury impaneled by Coroner Griffin H. Rouse, heard testimony of witnesses after the killing and returned a verdict that Officer R. T. Rogerson, who fired the fatal shots did so in self defense and that his act was necessary for the public safety.

For some time the woman had been reported as a disturbing element in her neighborhood and early last night she was said to have threatened to kill anybody who came near her house. When a call was received at police headquarters Chief James Tanner sent four of his veteran officers, John Mobley, Ray Harps, Jasper Mills and R. T. Rogerson, to the scene. When the officers arrived the woman had barricaded herself in the house and immediately opened fire on them. After the exchange of several shots Officer Rogerson reached the front door of the house and the woman cracked the door open and fired at him barely missing his head. His face was burned from the close contact of the bullet. Rogerson immediately opened fire through the open door as the woman closed and locked it. After the shooting had subsided the officers broke down the door and found the woman lying across a bed inside suffering three bullet wounds. She was removed to Pitt General hospital where she died a short while later.

SS General Testifies As To Nazi Brutality

Nazis Set Goal Of Wiping Out 30,000,000 Slavs On Eastern Front; Criminal Brigade Used By High Command

By JAMES F. KING Nurnberg, Jan. 7—(AP)—Waffen SS Lt. Gen. Erich Von Dem Bach-Zelewski told the international military tribunal today that the Nazis attacked Russia with a goal of wiping out 30,000,000 Slavs.

Calmly and without batting an eye, the 46-year-old ardent Nazi admitted that brutality was directed especially against partisans on the Eastern Front and asserted that the German high command could not help being fully aware of the methods used.

His testimony was against the 22 ranking Nazis on trial as war criminals before the court of the United States, Great Britain, Russia and France. He commanded German units which suppressed the Warsaw uprising in 1944 and was awarded the Knight's Cross by Hitler for his systematic destruction of the Polish capital in a 61-day siege.

Before that, Heinrich Himmler of the Gestapo had resigned his chief of all counter activities against Russian partisans, and he is reputed to have been selected by Himmler to lead the Nazi post-war underground.

Allied officers said Bach-Zelewski probably had witnessed more atrocities than any other German witness who has appeared at the trial.

Chicago Father Pleads For Abducted Daughter

Chicago, Jan. 7—(AP)—Golden-haired Suzanne Degnan, 6, was kidnapped for \$20,000 ransom today and her father, a \$7,500 a year government employe appealing by radio for her safe return, promised "I'll give you the money."

James Degnan, 36, Chicago OPA executive, made the special appeal within a few hours after the Chicago city news bureau reported the kidnapper had telephoned the family to repeat the ransom demand made in a not left near Suzanne's bed early today.

"If you have any sympathy or understanding in your heart, you will return the child to the family," Degnan said in a local broadcast over WMAQ, an NBC outlet.

"Please let me know what I can do, how I can contact you, I'll give you the money. I'll do anything to get my child back. If you harm her, God will repay you. Please, please do not harm her."

Suzanne, blue-eyed and possessing a face a former neighbor described as "the most cheerful little face I ever saw," was abducted apparently by someone misled by the size of the degnan home into believing her a child of wealth.

The Degnans share a north side residence at 5943 Kenmore Avenue with an attorney and his wife and their daughter and son-in-law.

The Degnan was missed from her bed at 7:30 a. m. when her father went to call her for school. The city news bureau said the kidnapper telephoned at 10 a. m. to reiterate the ransom demand to Degnan who earlier had told newsmen

Oil Workers Union Wage Dispute Nears Solution

COTTON UNDER OPA CEILING

Agency Hopes To Avoid Taking Action In Clothing Shortage

Washington, Jan. 7—(AP)—Despite OPA's flat announcement that price ceilings will be clamped on raw cotton to check mounting clothing costs, agency officials acknowledged today they hope to avoid such action.

They disclosed a big "maybe" in the plan as the government, in another move, tried to assure sufficient apparel for veterans. It appealed to retail dealers to set aside for servicemen up to 100 per cent of their stocks of scarce garments.

OPA officials who asked anonymity, said they wanted to make it clear there was "no bluff" in the agency's statement over the weekend that it plans to bring cotton under price control for the first time.

But, they added, these plans are conditioned on whether the announcement has the effect of checking speculation in cotton prices, which OPA Chief Chester Bowles said are being bid up by "traders who are betting on inflation."

Bowles said OPA plans to do everything in its power to avoid raising prices for clothing. The agency also is counting on release of 1,500,000 bales of government cotton to stabilize prices and ease pressures on textile and garment ceilings.

"But if the cotton price rise is not halted," said one official, "OPA definitely will go ahead with plans for ceilings."

Rep. Camp (D-Ga) termed the OPA proposal "ridiculous," saying "There isn't 30 cents worth of cotton in a \$3 shirt." Camp added in a statement issued at his Newnan, Ga., home that "if Mr. Bowles wants to keep the cost of clothing down he'd better go to other fields."

To meet legal requirements, OPA expects to announce by January 15 a schedule by prospective ceilings for the 1946 cotton crop. This advance announcement must be made at least 15 days before spring planting.

Columbia, S. C., Jan. 7—(AP)—State Agriculture Commissioner J. Roy Jones of South Carolina said today of an Office of Price Administration proposal to put a ceiling price on the 1946 cotton crop that he would like to "know more about what kind of a ceiling is proposed."

"Since I do not know what ceiling price Mr. (Chester A.) Bowles, OPA administrator, has in mind," Jones told the Associated Press in response to questions, "I do not feel I can give an intelligent answer to the proposal."

"Certainly cotton is not bringing the farmer any greater premium now, and until recently has been selling below parity on the open market. The fact that so much of the staple has gone into the government loan and purchase program is a definite indication of this fact."

"This is the first time I ever heard of having to keep prices down" (Continued on Page Two)

Settlement Is Seen Nearer In Oil Wage Dispute — Oldest Since V-J Day; Prospects Of Steel, Electrical And Meat Strikes Still Threaten Nation

The oil fact-finding panel reconvened today with signs that the oldest postwar wage dispute—between the CIO-Oil Workers and a large segment of the industry—is nearing settlement.

Agreement on an 18 percent wage increase for the Texas Company's West Tulsa refinery, matching the amount Sinclair Refining Company previously had settled for at all its operations, was regarded by government officials as a significant break in the three and one-half month dispute.

The union struck in September for a 30 per cent increase, leading to Navy seizure of 53 refineries and pipelines on October 4.

The Texas Company development, and its possible effect in setting a pattern for the balance of the industry still under Navy operation, served to ease the tension slightly as the nation entered one of its most crucial weeks since V-J Day.

Strikes in steel, electrical manufacturing and meat packing industries are scheduled to begin in that order on Monday, Tuesday and Wednesday of next week, idling 1,100,000 workers.

This number would augment the strike of CIO-auto workers at General Motors, CIO-glassworkers at Pittsburgh Plateglass and Libbey-Owens-Ford and an independent union at 31 Western Electric plants in New York and New Jersey.

With only a week remaining to avert the additional shutdowns, there are these prospects, aside from whatever may stem from the oil fact-finding inquiry:

Steel — President Truman's fact-finding panel has asked the U. S. Steel Corporation and CIO steelworkers to resume collective bargaining. Government labor sources say they are hopeful the company will make its first counter offer to the union's demands for a \$2 daily wage increase.

The fact-finders may call company and union representatives to Washington this week to discuss preliminaries to the inquiry, due to be completed by February 10.

General Motors—The fact-finding board which has finished its inquiry into the strike of 175,000 CIO-auto workers over a 30 per cent (Continued on Page Four)

A coroner's jury will meet at Farmville tonight at 7 o'clock for an inquest.

An Analysis Of The News

Paris, Jan. 7—The French capital's famous girl-show, the Folies Bergeres, has, of course, always been a revealing affair, but in these post-war days one finds it making disclosure in a far larger sense than is implied in our little pun.

One shouldn't expect, for instance, to be able to gauge the state of the nation from a visit to the Folies, or yet to make interesting psychological observations regarding the genus Yankee-GI. Still that has been the experience of Madame Mack and myself on renewing acquaintance after some years with this internationally known variety show.

We sat on the center aisle and five rows back. We noted that a large percentage of the crowd was American officers and GI's.

Our first discovery had to do with the state of the nation, and it was indeed startling. The great theater was unheated although it was sub-freezing. Most spectators kept their overcoats on, as did many of the orchestra, and they still were cold. The real sufferers, however, were the ladies of the cast, who were in an unhappy state of deshabille for such a night. G strings aren't great protection against wintry blasts, and some girls were blue with cold.

Still, they were good troupers, for they went through two and a half hours of torture without losing their smiles.

So here again there was registered in an extraordinary manner one of the most dangerous problems not only of France but of all Europe—the terrible shortage of coal and other fuel. This shortage is striking everywhere — homes, public places, business houses, industries. It fills the winter months with peril.

However, to return to the Folies Bergeres. Mrs. Mack and I were much interested in getting the reaction of the GI's to this G-string symphony, which is considerably more liberal than the shows to which the boys are accustomed at home. The present Folies, by the way, are no more free-and-easy than were those which I saw offered a generation ago during the last war to the dads of the present GI's. But the Folies always were naughty. That's the naked truth.

It must be admitted that some very handsome figures drifted across the stage, still (and we thought this would be of particular interest to the girls back home) the GI's showed little or no enthusiasm. They applauded a superb strong-man act, some very funny turns by a comedian and other bits—but had small (Continued on page two)

Washington, Jan. 7—(AP)—January 15 is a tax deadline. It affects about 10,000,000 out of 50,000,000 taxpayers. You're one of the 10,000,000 and by January 15 must do something about the tax on your 1945 income if—

1. You've been making quarterly payments on your estimated tax for 1945. The fourth, final payment is due January 15.

2. You've been making the payments but under-estimated the tax owed by more than 20 per cent. You must make the correction by January 15. There's a penalty if you don't.

3. You should have, but didn't, file an estimate on 1945 tax.

4. You're a farmer who hasn't paid any tax on 1945 income. The full 1945 income tax was withheld regularly in 1945 from the wages or salaries of about 40,000,000 people. They knew early last year it would be deducted.

So they didn't have to file an estimate, or make any quarterly payments. The full tax was deducted from wages or salaries up to \$5,000. But last March 15 about 10,000,000 people did have to file an estimate. Those who had to do this were:

1. Persons whose 1945 wages were more than \$5,000, plus \$500 for each exemption besides a taxpayer's own (Continued on page two)

It also was understood that no political problems were touched upon at today's session, which was devoted entirely to a discussion of details for the truce and the restoration of China's paralyzed communications. After the conference, Marshall told reporters it would be "highly undesirable" to disclose the character of the talks now, but promised that a full statement would be made when they are finished. To this Chou added: "It's been a good morning." "It went very well," added Chang.
