INCLUDE VETS IN EXPANDED SOCIAL PLANS

Broader National System Of Social Security Urged

Washington, Jan. 28.—(AP)—Expansion of the Social Security program to provide veterans with insurance credits for time spent in uniform was recommended by the Federal Security Agency today.

This was urged as part of a broader "national system of social insurance" outlined in the Social Security Board's 10th annual report to Congress.

In addition to old age and survivors insurance credits for veterans for time spent in service, the board recommended:

1. Federal insurance against medical care costs, including payments to doctors and hospitals.

2. Establishment of a single national program of unemployment insurance to replace existing federal-state programs.

3. Extension of jobless benefit rights to all employees in industries currently covered, and to as many non-covered groups "as is administratively feasible."

4. Maximum weekly unemployment benefits of at least \$25, payable for up to 26 weeks.

5. Expansion of the old age and survivors insurance program to cover "all gainful workers," including agricultural, domestic and public service employees, as well as those in business for themselves.

6. Liberalization of these benefits, particularly for low paid workers.

7. Benefit payments for both permanent and temporary disabilities.

8. Expansion of federal-state programs of general public assistance to cover "all needy persons" and so that payments may be more adequate.

Under the old age insurance program the board urged that the

Washington, Jan. 28.—(AP)—Southern Democrats in the Senate are filibustering again. They may be successful again, too.

A number of times in recent years they've been able to filibuster, or threatening a filibuster, to block Senate action on certain bills.

Those bills involved Negroes, directly or indirectly. For example: Anti-lynching bills, anti-poll tax bills and now the present bill that would create a permanent fair employment practice commission—FEPC.

The FEPC bill is designed to prevent discrimination—against persons seeking a job—on grounds of race, color or religious belief.

President Roosevelt created a temporary, war time FEPC. Southern Democrats disliked it.

The permanent FEPC, to be set up under the present bill, would be a successor to the war time FEPC.

Senator Russell of Georgia, a leader in the filibuster, said on the floor that the South isn't opposed to equality of education or economic opportunity for Negroes.

But he added that he thinks the permanent FEPC would try to impose social equality on the South between whites and Negroes. He's

Gov. Cherry Honors Pitt County Board

"Well Done," Says Governor In Presenting Medals To Selective Service Draft Board Members Here

At the courthouse here today Governor R. Gregg Cherry paid tribute to Selective Service Draft Board members and appeal board members and agents, for meritorious and continuous wartime service of 24 Eastern North Carolina counties and awarded them medals. Brig. Gen. J. Van B. Betts, state director of Selective Service, accompanied the governor to Greenville.

General Metts, after expressing his personal appreciation for services rendered by Selective Service officials and reading letters and telegrams of appreciation from Major General Hershey, head of Selective Service, and Major General Brooks, head of the Fourth Service Area, introduced the governor.

After expressing his pleasure at being in Pitt County and mingling with representative and patriotic citizens of the northeastern counties, Governor Cherry said in part:

"We are here today to pay honor to a group of North Carolinians who fought what has been one of the most thankless battles of World War II in one of the most ignored and forgotten sectors. Because they served at home, and not on a foreign field or in foreign waters, the men who manned the Selective Service machinery of the State have indeed had a thankless task. If citations were given for insults 'received in action,' criticism suffered and Dr. R. J. Slay.

Washington, Jan. 28.—(AP)—There can't be a filibuster in the House. There debate on any given bill is limited. Not so in the Senate. That's what makes a filibuster possible in the Senate. This is how a filibuster works:

A bill is introduced in the Senate for debate and vote. But it is opposed by an individual senator or a group of senators, such as the Southern opposition to the FEPC bill.

They can prevent the Senate from voting by talking endlessly, or until the majority of the Senate agrees not to try to vote on the bill.

Thus a filibuster blocks all other business of the Senate and enables a minority of the senators to force a majority to do what the minority wants done—which is to abandon the bill.

If the majority of the Senate agrees to forget about voting on the FEPC bill, it will be a victory for the Southern. There's only one way to stop a filibuster: By imposing a rule called cloture.

Like this: At least 16 senators sign a petition asking the full Senate to vote on whether in a particular case—such as debate on the FEPC bill—debate by any senator

POLICE SOLVE MURDER CASE

Husband Confesses To Dismemberment Slaying

Los Angeles, Jan. 28.—(AP)—Arthur Eggers, mild mannered sheriff's clerk, has signed a confession to the decapitation slaying of his wife, Sheriff Capt. Gordon Bowers says, but hours of searching for her head and hands had proved fruitless today.

Bowers reported Eggers' confession Saturday night, and touched off an all-night and all-day hunt for the members which Eggers said had been severed with a saw and thrown from the car deeper in a canyon than the spot where her body was found.

But after deputies had spent many hours plodding through brush Eggers accompanying them, he turned and said:

"Well, it's almost too horrifying to tell, but here's the truth: I

GI Committee Has Won Its Objectives

Manila, Jan. 28.—(AP)—After an action-packed three weeks of life, the soldier committee formed to protest the Army's demobilization slowdown will be disbanded, because it has carried out its objectives.

Tech Sgt. Lawrence N. Spitz of Woonsocket, R. I., chairman of the committee, pointed out in announcing the dissolution that the committee had obtained hearings with Secretary of War Paterson, the lead congressional committee and in conjunction with similar groups in the Pacific theaters, had resulted in the formation of a special subcommittee to investigate demobilization.

The announcement added that "The GI committee earnestly hopes that United States troops will not be used for armed intervention in the internal affairs of the Philippines."

Bermuda Conference Settles Many Disputed Points; Delegates Refer Principles Of Accord To Capitols For Approval

STREIB Associated Press Aviation Reporter Hamilton, Bermuda, Jan. 28.—(AP)—Representatives of the United States and Great Britain have reached agreement here on a new commercial aviation pact and the principles of the accord have been referred to London and Washington for study and approval.

The heads of the conferring delegations issued a joint statement announcing the agreement but gave no details. Sir Henry Self of the British delegation and George Baker of the American delegation said they would meet the press later in the day to discuss the accord.

A well-informed source said disputed points were settled about as follows in the new agreement:

1. Rates to be fixed initially by air line operators at a traffic conference in New York in February and later reviewed at regular intervals by the U. S. and British governments. Rates would be based on operating costs.

2. The number of trips to be flown by each air line will be unlimited.

3. The right to carry passengers along regular routes from one country to another also will be virtually unlimited.

The formal announcement indicated the agreement had been reached at committee level and the delegates now must await instructions.

TODAY IN CONGRESS

A Review Of Your Government In Action

Washington, Jan. 28.—(AP)—President Truman posed a new controversy for Congress to grapple with today, telling its leaders he will send to the Capitol this week a message asking approval of a \$3,750,000,000 loan and other credits for Britain.

The controversial British loan question was brought to the fore as the House came to grips with the dispute over returning the U. S. Employment Service to State control. Mr. Truman wants the return delayed until mid-1947.

Another administration measure, the fact finding bill for labor disputes, was debated inconclusively in the House Rules Committee. The group will hold another session tomorrow to decide whether the House should be restricted in its consideration of this legislation or whether a go-forward should be given to members who want to tack on amendments covering other labor matters.

The Senate talk-fest aimed at killing the proposal for a permanent fair employment practices commission ranged to the international field. Senator Tydings (D-Md.) introduced a resolution calling for a world disarmament conference, explaining that he doubts United Nations action on atomic control can succeed.

The Senate's special committee considering domestic atom energy controls heard a recommendation from Dr. Harrison Davies, a scientist, that the military be excluded from policy making. The proposal got a mixed reception from the committee members.

Before the Pearl Harbor Investigating Committee, Capt. Ellis M. Zacharias testified that he had predicted in March, 1941, that any Japanese hostilities against the United States would start with an attack on the fleet on a Sunday morning. He said he made the forecast in a conference with Rear Adm. Husband E. Kimmel, then Pacific fleet commander, and another officer.

The House consideration of the employment service bill brought the first major test of Mr. Truman's influence over the new congressional session.

Called for debate was a bill from the House Labor Committee fixing June, 1947, as the date for returning the service to State control. This would be in accordance with Mr. Truman's wishes.

The Chief Executive brought on the showdown by refusing to sign a bill Congress passed in December to end federal authority over U. S. E. S. within 100 days. It was one of the points he made in his January 3 fireside chat to the nation.

REDS ASSERT IRAN APPEAL NOW INVALID

Security Council Hears Charges Today; U. S. May Be Involved

By JOHN M. HIGHTOWER London, Jan. 28.—(AP)—Russia challenged the validity of Iran's appeal to the United Nations Security Council today after the chief Iranian delegate had charged the Soviet Union was guilty of "a number of interventions in Iranian affairs."

Andreï Y. Vishinsky, the Soviet's vice commissar of foreign affairs, told the 11-member council, holding its first major hearing on a political issue between sovereign nations, that the Iranian charges were "raised by a government no longer in power and the claims have not sufficient grounds" for action by the security group.

A new Iranian premier, Ahmed Qavam 'Es Saltaneh, took over in Tehran during the week end, succeeding Ibrahim Hakimi who had instructed the Iranian delegation to raise the issue before the UNO.

S. H. Taqizadeh, chief Iranian delegate, told the council the dispute was being brought up because it might lead to "international friction."

Taqizadeh appeared at the council table on the invitation of the eleven members after Soviet Delegate A. Y. Vishinsky made it clear he had agreed only to a discussion at this time whether the council should formally take jurisdiction of the Iranian case. He reserved the right to press his request, previously filed, that the dispute be left to direct negotiations between Tehran and Moscow.

Informed sources said the United States might find herself involved in the Iranian dispute, as well as in the discussion of charges brought by Russia and the Ukraine that Britain is interfering in Greece and Indonesia.

The United States views on Iran were cited Saturday night in a note filed by the Iranian delegation, which said that charges of Russian interference in Iranian affairs could be "fully proved." The note pointed out that the United States had favored the withdrawal weeks ago of both British and Russian troops from the oil-rich little country. The last American troops already have left Iran.

Diplomats who declined to be quoted by name speculated that Britain might claim American support for her policies in Greece and Indonesia.

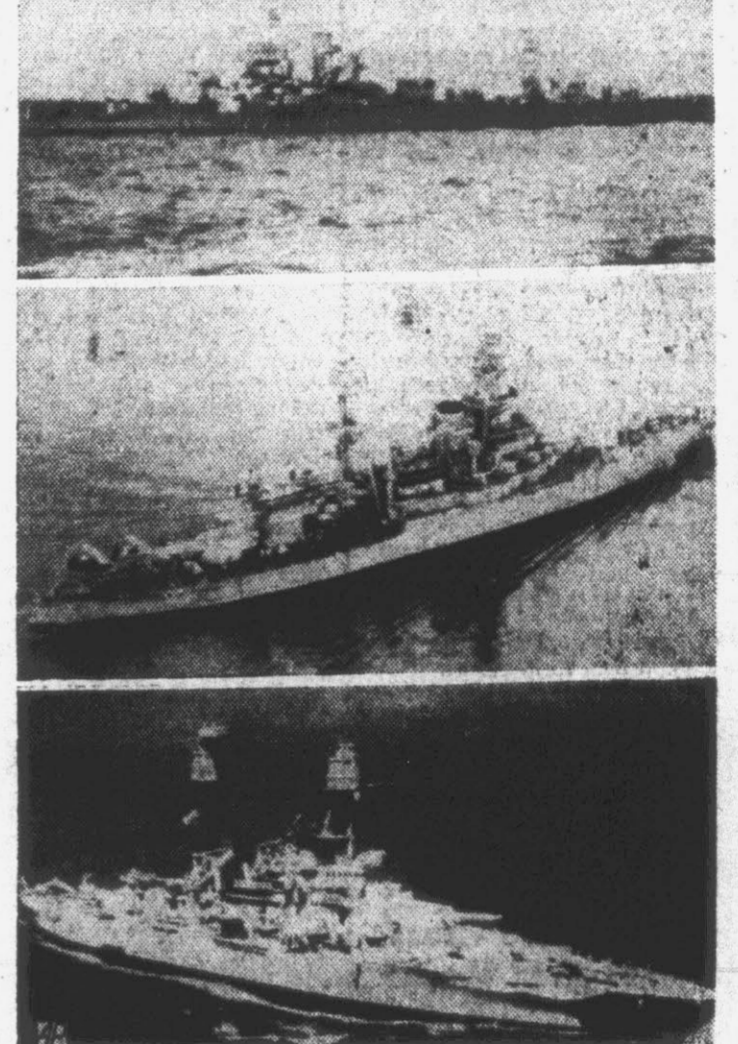
A Call For Help

Industry-Labor Outlook Brighter Than In Weeks

Ships on Which Atom Bomb Will Drop Distinctly Optimistic

Sharply increased livestock receipts at most principal markets and a return to work of apparently all 248,000 striking meat workers gave promise today that normal meat supplies would be quickly restored.

A government spokesman at Chicago said production was under way in the government-seized meat plants, with the striking CIO and AFL meat workers back on the job.

Farmers, who had held back much of their livestock during the strike, began shipping in quantity again. Receipts of cattle at principal markets today totaled 92,100 compared with 43,100 a week ago; sheep, 42,400 against 8,200 and hogs, 136,000 compared with 53,045.

Meanwhile, efforts were resumed in Washington to end a truck strike which has tied up shipments in the Midwest since Nov. 15. Senator Young (R-ND) arranged a meeting of senators with representatives of the AFL Central States Drivers Council and the Midwest Truck Operators Association. The drivers are seeking higher mileage rates.

In Washington, Harold C. Havighurst, professor of labor law at Northwestern University, told the Senate Labor Committee that enactment of any "labor bailing legislation" at this time would "bring us to the verge of a civil war."

A high government official predicts the steel strike will end "within a week or so."

This official said a "settlement bloc" within the steel industry has gained the ascendancy over those who would prefer to "fight it out" with 750,000 striking steelworkers.

Thus, another tilt was given today to a wave of optimism engendered by Ford and Chrysler wage settlements, resumption of meat packing under government control and railroad arbitration agreements.

However, around 1,400,000 workers continuing idle in labor dispute, not counting returning meat industry workers.

The Washington official, who is closely concerned with administration labor policy, but cannot be identified, said his forecast of a quick end to the steel strike was based only in part on the trend shown in the automotive agreement.

Representative Tells Of Wanton Destruction

N. C. WEEKEND DEATH TOLLS

Traffic Accidents Kill Eleven Of 12 Victims

By ASSOCIATED PRESS Weekend violence claimed the lives of at least 12 North Carolinians, with all except one caused by traffic accidents.

Seven of the 11 traffic victims met death in a two-car collision near Mount Airy late Friday night. Four persons were killed instantly and three others died later in a hospital; only one of eight principals is still alive.

The dead in the Mount Airy collision: Miss Hazel Hitta, Wade Greenwood, Miss Mazie Money and James P. Chappell, all of Mount Airy; Ray Flippin and Joseph Flippen of Pilot Mountain, and Dewey Owens of Seagrove. Only survivor is Edison Johnson of Pilot Mountain.

Winston-Salem reported two traffic accidents.

SLAUGHTERING BEGINS TODAY

Meat Plants To Resume Production Of Steaks

Chicago, Jan. 28.—(AP)—Steaks and chops were headed back to America's dinner tables today as slaughtering was to be resumed in packing plants where strikes had halted production since January 16.

A survey indicated that practically all the 248,000 AFL and CIO meat industry workers would return to the 134 packing plants seized Saturday by the U. S. Department of Agriculture.

Although slaughtering was to begin today, carcasses must be "hung" 24 to 48 hours, so that deliveries in quantity to the country's butcher shops probably will not start before Wednesday. However, government managers of some plants said deliveries would be resumed immediately of meat taken from supplies on hand.

Ralph A. Walter, president of the Chicago Livestock Exchange, said farmers had cut their shipments of livestock 75 per cent during the strike, and overshipments now were possible. However, said Walter, "we can now handle a slight oversupply, and we are sure we can get farmers to hold back later this week if we find the market glutted."

Letters From Returned Veterans Describe Waste Of Military Supplies; Investigation Of Services' Policy Is Asked

Washington, Jan. 28.—(AP)—Rep. Latham (R-NY) today cited what he termed "additional confirmation of wanton destruction of enormous quantities" of surplus military supplies in overseas Pacific bases.

Quoting from letters he said he has received from returned servicemen, the New Yorker, in a speech prepared for House delivery, called on Congress for immediate action "to decide what is to be done about it."

Latham said one of the letters, written from New Caledonia, contained this description:

"On Isle Nou over 250 boats of all kinds were burned, most of them in fair or good condition. Every day, for the past month, a large crane on a barge sinks absolutely into the sea, especially absolutely new electrical equipment."

"In Plum Bay about 1,000 vehicles, especially GMC trucks, have gathered with thousands of tires."

An Analysis Of The News

(This is the fourth of a series of columns on Generalissimo Franco By DeWitt MacKenzie, to whom the Spanish chief of state has just granted an interview.)

By DEWITT MACKENZIE Madrid, Jan. 28.—The question of whether the kingship shall be revived in Spain continues to be a subject of eager speculation and naturally was one of the points which I raised in my interview with Generalissimo Franco at the palace in El Pardo.

Franco replied that this is a matter which will be dealt with "when this is suitable to the interests of the nation" and that "it will have to be the Spaniards themselves who pronounce themselves in its favor."

I broached the matter by calling Franco's attention to the fact that his ambassador to Washington, Juan Francisco De Cardenas, recently was quoted as saying that "Spain is steadily and progressively restoring a political situation with a more representative system."

I asked if this had any relation to the current talk about a possible restoration of the monarchy.

"Spain is a country of boys and not closed constitution," was Franco's reply.

If, on the other hand, they suppressed facts, they would be doing something that no honest newspaper man can do with a good conscience. What, then, was the way out?

They decided to high-light heroism. The columns of the papers, therefore, were filled with accounts of how the people were courageously meeting this great disaster. All over the city the hearts of Englishmen thrilled as they read how the most inconsequential people rose to heights of real heroism as members of rescue parties. The stories described how rich and poor set together in comforting and helping one another. Everyone was soon talking about the sacrifice of which plain Mr. John Citizen was showing himself capable.

And the result? Well, we all know the result. Germany succeeded in breaking up practically everything in England except the spirit of the British people. When Britons of every class began to realize how heroic they really were, they felt sorry not for themselves but for the Nazis.

That is why a little handful of brave fighters, supported by a united and brave nation, was able to beat off one of the most savage attacks ever launched against any people. A nation suddenly awaked to the significance and magnitude of its own nobility.

## Home Economics Teachers Meet

Pitt County Home Economics teachers met last Thursday at First Carolina Teachers College for their regular monthly meeting. The Home Economics teachers from Chatham, Wayne, Jones, Polk, and Winterville, together with seven other teachers, and the supervisor of student teaching in Home Economics for East Carolina Teachers College were present. This group

met to decide "What Should Be Included in High School Home Economics on Home Improvement." Since a new state course of study is in the making for Home Economics Education the various county groups are holding workshops to present their findings to the state department. Pitt County teachers felt that if Home Improvement was to be practical and usable to the students, mothers and students should be given an opportunity to help to decide what should be taught.

The group decided upon the following goals:

1. Learning to appreciate the simple things that we can attain.
2. Learning to make the best use of what we have.
3. Understanding that the best home experiences are realized through family cooperation.
4. Learning to appreciate what we have.
5. Improve the outside of the home as well as the interior.

Home improvement should be cooperatively planned and gradually carried out. They also felt that emphasis should be made on the care of what we have, exterior surroundings, and renovation. At the first of the meeting the entire group was served tea by one of the Greenville first year Home Economics classes. Miss Louise Swann, Home Economics teacher of Greenville High School, led the discussion. Following the general discussion they divided into committees to further discuss the following subjects, pertaining to the big problem under discussion: Home Management, led by Mrs. Mildred Venters, H. E. teacher of Chatham; Exterior Surroundings, led by Miss Margaret Person, student teacher from ECTC; Selection and Arrangement, led by Miss Mabel Lucy, Home Economics teacher trainer PCTC; Improvement and Remodeling of Furniture, led by Mrs. Venetta Pentecost, H. E. teacher of Ayden; and Overall Goals, led by Miss Louise Swann, H. E. teacher of Greenville High School. At the next meetings, the teachers will take the suggestions of the group and plan "How to Teach Them" and "What Year to Teach Them" and the "Methods to Use in Teaching Them."

# PRISON TERM GIVEN WOMAN

## Superior Court Winds Up Busy Weeks; Two Court Orders

Paul Frizzelle of Snow Hill sentenced Dorothy May Stephenson, Negro woman of Ayden, to serve from eight to 10 years in State Prison for the second degree murder of Paul Edwards, Negro, with an accomplice in Ayden on January 20. Cases against Ed Hunter and Rufus Jenkins, Ayden Negroes, charged with complicity, were not pressed with leave. The court term was adjourned for the term Friday afternoon. Solicitor D. M. Clark said before the trial that he would not ask for a first degree verdict.

Judge Frizzelle signed an order Friday for the Greenville police department to return to Maj. W. H. Leonardson and Mrs. Barbara Lancaster, personal property including silverware, as their interests may appear by identification. The loot was recovered from Mrs. Frances Ullman's home on a search warrant early in last January when she was arrested on charges of breaking and entering and larceny at the home of Major and Mrs. W. H. Leonardson on Washington street. None of the recovered property is to be returned to Mrs. Ullman, the court ordered. The case has not been tried yet.

Judge Frizzelle signed another order Friday requiring Superior Court Clerk David T. House, Jr. to return to Dr. Leon R. Meadows two books, described as "Memo Book No. 1" and "Memo Book No. 2." The books were used as exhibits in the two trials of Dr. Meadows for embezzlement of East Carolina College and student funds. 


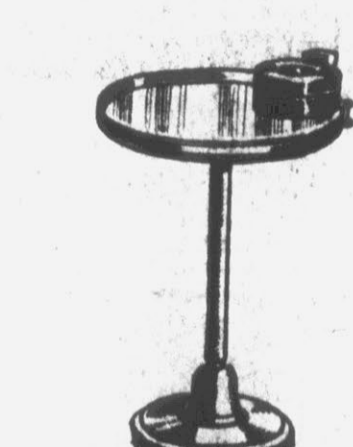
