National Labor Front Brighter

After A Week Of Threatened Strikes, Labor Front Is Comparatively Quiet; Railroad Walkout Is Postponed; N. Y. Western Electric Employees End Strike

The nation's labor front, after a week marked by threatening strikes against the nation's communications and railroad systems, appeared comparatively quiet—and somewhat brighter—today.

The postponing of a walkout of nearly 300,000 railroad workers, scheduled for Monday, after President Truman named a fact-finding board, followed settlement on Thursday of the wage dispute involving some 250,000 telephone workers.

As 17,300 Western Electric Co. employees in New York and New Jersey ended their 65-day strike, special mediator Arthur S. Meyer, a New York expressed hope a settlement might be reached soon in the 53-day work stoppage of 100,000 General Electric Company employees.

Earlier, Neil Brant of Washington, representative of the CIO United Electrical Workers Union, told striking employees of the Westinghouse Company at Mansfield, O., that the company's 75,000 strikers would be back "in a couple of days" if they were offered hourly wage increases of 18 1/2 cents. The union had demanded 25 cents.

Also on the credit side were reports from Detroit and San Francisco.

In San Francisco, International Officers of the Independent Association of Machinists, ended a four-month old strike of 7,000 machinists in bay area shipyards, asserting it was "illegal and unsanctioned." They ordered disciplinary action against local leaders for what they termed the unauthorized walkout.

The CIO United Auto Workers announced in Detroit that Nash-Kelvinator Company had granted an 18 1/2-cent hourly wage rate increase to 8,000 workers in plants in Milwaukee and Kenosha, Wis. The settlement was the fourth major wage agreement reached in the auto industry. Ford, Chrysler, and Hudson (Continued on Page Two)

Kaiser-Produced Home Displayed

Los Angeles, March 9—(AP)—Fritz Burns, head man of Henry Kaiser's mass home-building venture, who opened his own "postwar house" to the public this week, disclosed today that the two-bedroom dream home had cost him \$175,000.

The one-story, U-shaped, stone and plywood structure is equipped with all the electronic and mechanical gadgets a housewife could want: "packaged unit" bathrooms and kitchen, die-stamped out of metal for mass-production; a fully automatic laundry that tosses clothes out ready to iron; dust-precipitating air conditioning, and even a revolutionary germ-killing lighting system.

"In the first place," Burns said, "the lot (on fashionable Wilshire Boulevard) cost \$75,000. The rest was eaten up in research and experimentation. We became perfectionists and asked manufacturers to make things they never had made before. Our only consolation is that we now know more about building postwar houses than anyone else."

Washington, March 9—(AP)—The government's wage-raising policy is not so simple now.

Between Aug. 17 and Feb. 14—two dates to remember—the policy was roughly this:

You could raise wages without government approval—unless you wanted to use that as a basis for raising prices, too.

In that case you had to get the Wage Stabilization Board's approval on the pay raise before asking OPA permission to raise prices.

You can still raise wages without government approval—if you don't use the raise as an excuse for seeking price relief.

And if you raise wages between August 17 and February 14, automatically you can go direct to OPA for higher prices. You don't need the board's approval on your wage-raise.

But this week the Stabilization Board has outlined its new policy. Remember: Hereafter the story any pay increases mentioned means the boss wants to use them as a basis for seeking higher prices.

No. 1. Substandard Wages. The board considers wages below 55 cents an hour substandard. You can raise them to 55 cents and go direct

Countywide Meeting Of Pitt Countians Favor War Memorial

Spanish Consulate Blasted By Bomb

Buenos Aires, March 9—(AP)—A bomb exploded in the Spanish consulate early today, rousing many citizens of the residential district in which the building is situated.

The bomb was dropped at the building's main door and the blast was powerful enough to shatter the door and break windows in the consulate and neighboring building. The street was littered with broken glass.

There were no casualties. Police immediately began an investigation.

CITY TO SELL PAVING BONDS

Aldermen Will Improve Streets; Build Drainage Sewer

The Board of Aldermen in session at the City Hall Thursday night voted to order an election to authorize the sale of \$250,000 of street paving bonds; authorized City Clerk J. O. Duval to publish the resolution authorizing the project, and instructed him to fix the date of the election.

Incidentally, the streets of the city are seriously in need of repairs and there are some streets which should be paved to keep Greenville abreast of other cities. Mayor Jack Boyd presided.

The mayor announced that the surface drainage project, which includes a pipe line from Albemarle Avenue to the Atlantic Coast Line tracks and on to the river, will get under way about April 1. Incidentally, a state law permits a city or town to sell for these improvements two-thirds as much as the total amount of bonds retired the previous year. The drainage project will cost \$53,000. It will relieve some of the other sewers and prevent flooding of Evans streets in the vicinity of Evans and other streets north of 10 street.

The Aldermen ordered City Attorney R. B. Lee to draw up and publish the resolution making Dickinson Avenue from the Coast Line to the underpass a special fire zone, to permit regulation of building operations.

The city clerk was instructed to order a primary election to elect four aldermen on Monday, May 6. The four men whose terms expire this year are J. A. Watson, second ward; L. M. Buchanan, third; Dr. M. B. Massey, fourth, and Berry Bostic, fifth.

The Aldermen and county commissioners are still working on plans for the Airport Commission to take charge of the airfield across the river, now used by the U. S. (Continued on Page Four)

Army Ruling To Bar Communists

Washington, March 9—(AP)—Army personnel who "lack loyalty to the government and constitution of the United States" are to be barred henceforth from "sensitive duties."

These duties were defined by the War Department last night as including assignments connected with radar or atomic energy, attendance at officer candidate schools, aviation cadet training, and "duties in connection with information, education or orientation of troops."

In announcing the new policy, the Department upheld in effect the authority of Gen. Douglas MacArthur's headquarters to remove two staff members of the Pacific edition of the Stars and Stripes. The service paper is published under the War Department's Information and Education Division.

The men removed were Sgt. Kenneth L. Pettus of Chicago, managing editor, and Cpl. Barnard D. Rubin, Waterbury, Conn., columnist. Their transfer from the Pacific Stars and Stripes staff was accompanied by the assertion that they had been Communists and each had "at times flattered his public writings with Communist thought."

Babson Discusses Saving And Spending

Babson Park, Fla., March 8—I would be the last to decry the value of bank deposits. They are very useful and always will be. It should be remembered, however, that money is of no value in itself, but is good only as a medium of exchange. Money is like stocks. In order to sell stocks a buyer must be found and if there are no buyers at the price you paid, then you must sell the stocks at a loss. In the same way, in order to "sell" money—that is, exchange it for stocks, commodities or land, you may have to sell it at a loss, or discount, to get what you want. When prices go up, the value of your savings in the bank goes down.

Value of Bank Deposits

Always keep enough money in the bank to pay your taxes for a few years; also enough to buy food in an emergency. There are some other bills which you must pay in cash whether or not you have any income. Hence, I believe in always having a fair bank account. This especially applies to us "oldsters." The point I want readers to understand is that money and bank deposits are no good in themselves. They are of use only when there are goods, houses and land for sale. This means that when there is a scarcity of merchandise and when money is cheap it is a good time to store up money. But when goods are cheap and money is scarce, then we should store up goods. Today we have a half-way situation. Better now try to buy both real things for future use and keep a fair bank account. If inflation comes in full force, our bank accounts will not buy much.

Selective Buying

This surely is a time for selective buying. When buying bonds today, better buy certain government issues rather than low-yielding corporation bonds. When buying stocks, better buy into the merchandise or food chains rather than the railroads. When buying a home, get a small modern home rather than a large old house. It also is advisable to look more to the land than to the house. Well-located fertile land should gradually increase in value; but any house bought today will decrease in value.

I would rather have money in the bank than poor land upon which I must spend money for fertilizer, water and accessibility. But I would rather have good lawn than money in the bank if the land is fertile and has a flowing well, or natural irrigation. This means that it is a mistake to get "hipped" on money, bonds, stocks, land, etc. All of these are never all good or all bad. Most people lose their money by putting all their eggs in one basket.

Consider Lasting Qualities

God gave us brains, eyes to see with, ears to hear with, and tongues with which to ask questions. We should use all of these when swapping money for food, clothing, shelter or anything else; or when swapping these real things for money which we deposit in a bank. Every (Continued on Page Two)

Moscow Radio Says U.S. Breaks Treaty

Russia Maintains Recent United States Communication To Bulgaria "Infringes" Big Three Agreement On Bulgarian Cabinet; Says U. S. Sabotaging Agreement

London, March 9—(AP)—Russia maintained today that a recent United States communication to Bulgaria "infringes" a decision of the Big Three foreign ministers and has caused the opposition to the Bulgarian government to "sabotage" the three-power agreement.

The accusations, contained in a Soviet note to the U. S., were broadcast last night by the Moscow radio. The broadcast said the note was handed to the U. S. State Department earlier this week.

The Bulgarian decision, drafted in Moscow last December, declared that the United States and Britain would recognize Bulgaria after her cabinet had been broadened to include two members of opposition groups. The agreement was approved by U. S. Secretary of State James F. Byrnes, Russian Foreign Commissar V. M. Molotov and British Foreign Secretary Ernest Bevin.

The Russian broadcast asserted that the "United States government statement infringes the Moscow decision" because it informs Bulgaria that the new opposition members should participate in the government under "conditions mutually acceptable" to the government and (Continued on page two)

Plunging Horses Endanger Visitor

Washington, March 9—(AP)—Winston Churchill—a man who were out his admirers but not his welcome—rolled into Washington with his party this morning after laughing off a narrow escape from an old-fashioned accident in the colonial town of Williamsburg.

A suddenly-frightened pair of grey horses bucked, reared and plunged yesterday, and almost ran away with an ancient, flimsy open coach in which Churchill and General Dwight Eisenhower, U. S. Army Chief of Staff, were seated.

Frantic efforts of bewigged and colonial-costumed Negro coachmen finally quieted the horses, then Churchill, puffing a black cigar and apparently unperturbed, and Eisenhower, obviously worried about the British statesman's safety, climbed to the ground.

The near accident evidently was due to the bright flash of photographers' bulbs, and was aggravated by the excited screams of scores of spectators outside the stately reproduction of the mansion of the colonial governors here.

Died Today



JOHN GLENN

Oldest of America's newly honored Catholic prelates is venerable John Joseph Glennon, 83, archbishop of St. Louis since 1903. He was ordained in 1884. Told of his elevation to the College of Cardinals, he happily planned his first plane flight—to Rome for the consistory. The aged prelate's first post, the year he was ordained and a year after coming to America from Ireland, was as curate at St. Patrick's Church, Kansas City. Later rector of the city's cathedral and vicar general of the diocese, he went to St. Louis in April, 1903, as a coadjutor to the archbishop, whom he succeeded six months later. He was born in County Westmeath and educated in a Dublin seminary. An outstanding orator and forthright churchman, he was a civic, as well as ecclesiastical leader.

DEATH TAKES NEW CARDINAL

Cardinal Glennon, 83, Dies Two Weeks After Investment

Dublin, March 9—(AP)—John Cardinal Glennon, archbishop of St. Louis and the oldest of 32 cardinals elevated to the Purple two weeks ago, during consistories at Vatican City died here at 8:51 a. m. (2:51 a. m. EST) today at the home of Sean O'Kelly, president of Eire. He was 83 years old.

The death was announced at O'Kelly's residence.

The Irish-born prelate succumbed from complications which followed a congestion of the lungs.

His death reduced the membership of the Sacred College of Cardinals of the Roman Catholic Church to 63.

The passing of the Cardinal was announced at 9 a. m. (4 a. m. EST) by Msgr. John P. Cody, chancellor of the St. Louis Diocese.

Plans for the funeral were incomplete, but Msgr. Cody said "It is thought his Eminence's body will be taken back to St. Louis for burial in the cathedral," which was built under the prelate's direction.

"There is a special crypt in All Souls' Chapel which he had constructed for himself," a statement by Msgr. Cody said.

AP World Traveler

Bern, Switzerland, March 9—One of the mysteries of the late war was Switzerland's ability to maintain her neutrality, sitting as she was in the midst of many belligerents and under constant pressure from Hitler to cast her lot with the Axis.

We've found the answer here in Bern, and it's a strange story.

The fall of France left Switzerland absolutely alone in the face of the Nazi-Fascist combination. The world policy of the Swiss had been based on the balance of power in Europe. They had figured that if one country attacked them, then another would come to their rescue, but with France's collapse the axis war machine was rolling free.

The Swiss were against Nazism and democracy and religion. Some eight times Germany tried to get Switzerland to join Nazi movements of various sorts, the idea being to drive in Swiss neutrality. Each time this country refused, but the danger continued great.

So in 1940 Switzerland decided that, alone or not, she would fight to the end to defend herself. She had as her main defense the Alps, and believe me these mighty and precipitous mountains are close to (Continued on Page Two)

New Tension Beset Troubled Russian American Relations

Gulf Of Misunderstanding Widens Between Two Nations Still No Answer To Note Concerning Iran

Washington, March 9—(AP)—new tension beset troubled Russian American relations today with Moscow charging the United States violated a Big Three agreement with Bulgaria and is working to sabotage it.

The State Department has not yet acknowledged receipt of the sharp note from the Kremlin, but the Soviet broadcast reported it ready had been delivered, and responsible officials here said privately that a reply already was drafted.

The development capped an uneasy week which already has seen the United States register protest with Moscow on the situations in Iran and Manchuria, in line with the new sterner policy for international relations.

A State Department spokesman said there probably would be no official comment on the Soviet broadcast until Secretary Byrnes returns to Washington. Byrnes reportedly was at his home in Spartanburg, S. C., for the weekend.

Officials admitted privately, however, that restoration of Bulgaria to a global list of trouble spots may possibly extend to include Turkey had considerably widened the gulf of misunderstanding between this country and Russia.

The Bulgarian affair developed this way: At the Moscow conference of foreign ministers, it was agreed Russia should give "friendly advice" to Bulgaria to broaden its communist-dominated government with addition of two members from opposition parties.

Oppositionists declined cabinet posts subsequently offered, however, on grounds they would be misfigureheads with no real power. Thereupon, the Bulgarian government—with Russian backing—declared it had no further responsibility for carrying out the Moscow decision.

In a communication to Bulgaria made public Tuesday, the United States sided with the Bulgarian positionists.

Catastrophe And Lightning Strike

San Francisco, March 9—(AP)—wild goose catastrophe was repeated today by the State Division and Game, which attributed the death of 400 to 700 birds to a single bolt of lightning.

The dead geese and a few ducks were found after a thunderstorm last February 3. The Fish and Game Division investigated.

It concluded that a "large number of assorted birds" was flying in the ranch when a bolt of lightning headed earthward and passed through the flock, "certainly inflicting terrific heat and concussion thus causing the heavy loss."

The report said a goose was "pretty well insulated bird" that a heavy downpour of rain would make it more vulnerable to such an electric attack.

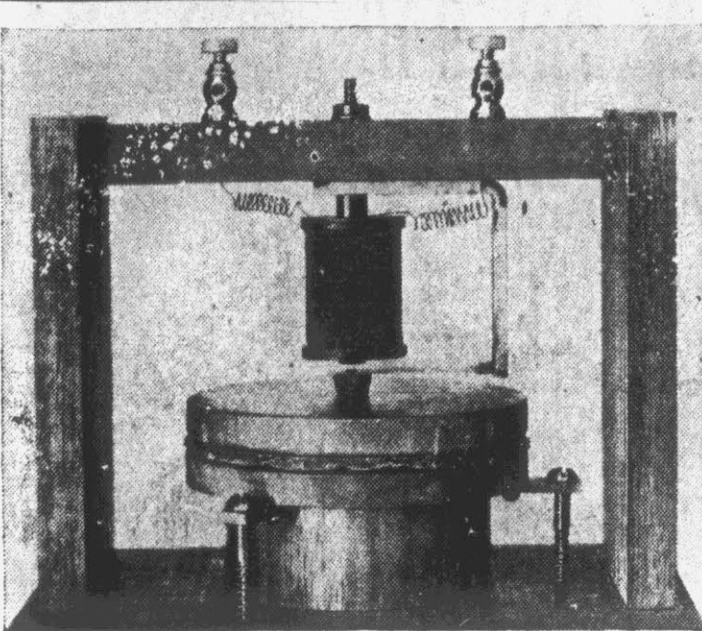

The First Telephone—1876



Today's telephone is a far cry from this crude instrument which transmitted the first telephone message 70 years ago, when Alexander Graham Bell spoke from the attic of a Boston boarding-house. 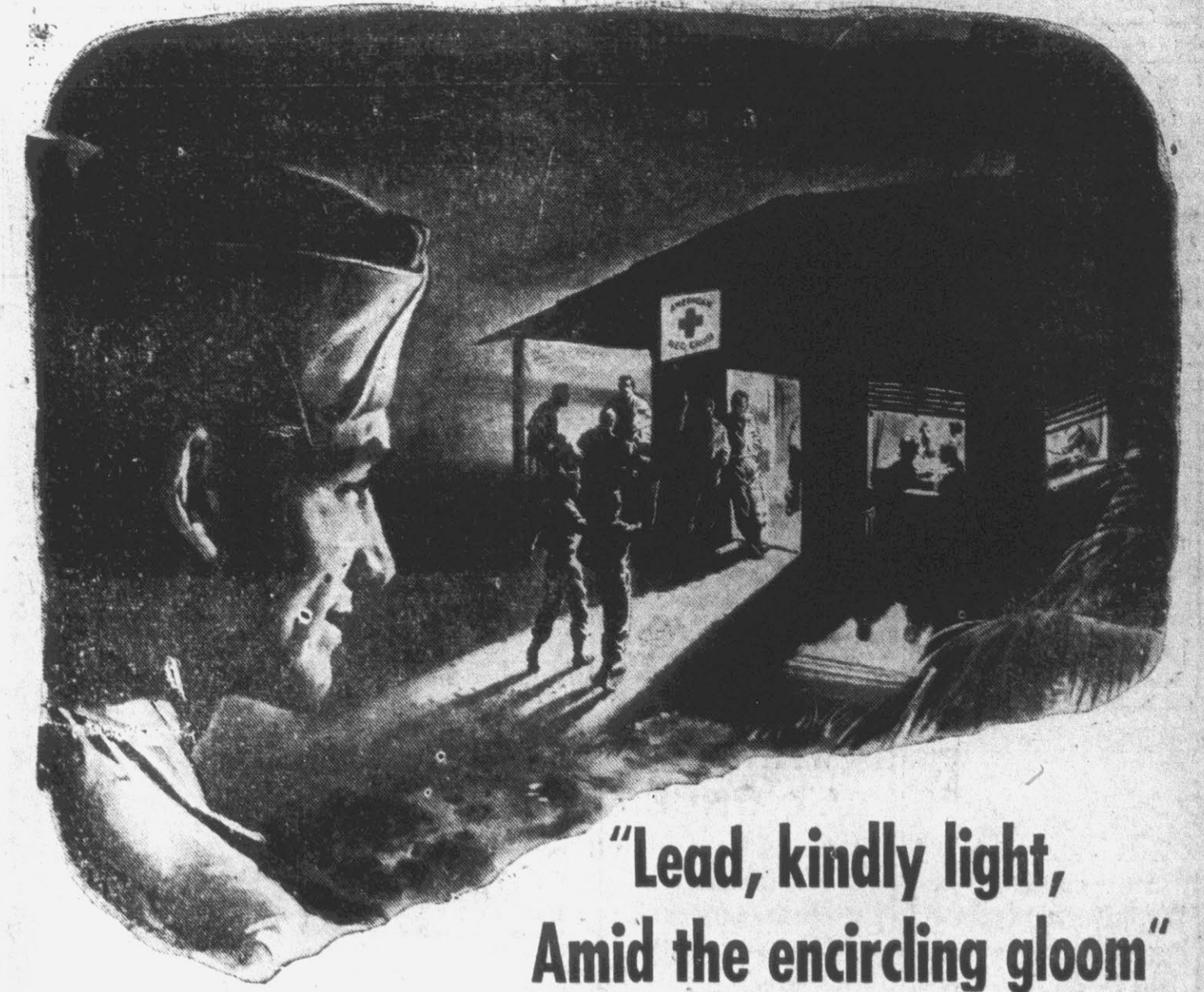

people of the county would vote for an issue of bonds in sufficient amount to build what Pitt County needs now more than anything else—a thoroughly modern hospital.

Sentiment expressed all over the county indicates that the people will vote for the war memorial hospital bond issue. Present hospital facilities here now include only 57 adult beds.

An interesting feature of the war memorial hospital proposal is that when the bond issue in sufficient amount is approved by the people at an election, it is planned to have the County Commissioners lease the war memorial hospital to an operating board of trustees and thus relieve the County Commissioners of any responsibility for its operation.

It was also pointed out that there is a bill now pending in Congress which provides for the Federal Government allotting from 50 to 70 per cent of the cost of building hospitals in localities where they are needed.

The war memorial hospital movement was started and is being carried on by public-spirited and patriotic citizens of Pitt County. Members of the medical profession have expressed whole-hearted support.

All qualified physicians and surgeons in the county may use the hospital facilities.

The movement to build a modern war memorial hospital for the people—white and Negro—is now getting into full swing. There has been no public meeting here in years at which such a representative group of citizens from all parts of the county was so solidly unanimous as for the proposed war memorial hospital—a living memorial to the veterans of World War I and World War II.

Committees are to be appointed to work out details, and in the meantime veterans of both wars and all Pitt countians now have a vision of a living memorial in a modern hospital, provided by the sale of bonds, and operated by a board of trustees, which removes from the county any responsibility for the much-needed institution's successful operation.
