RUSSIANS NOD APPROVAL STALIN TALK

Soviet's Man-
Street Sing-
Voicing Re-
Speech

Moscow, March 23—(AP)—Russia's man in the street voiced his approval today of Generalissimo Stalin's expression of confidence in the United Nations and his assurance that neither nations nor their armies want war.

"Stalin answered thoughts that everyone has been thinking—thoughts they have been thinking but failing to say," said a chauffeur.

"That's the kind of answer everyone has been hoping someone would make," said a policeman. "People all over the world have been afraid of one another. They do not want war and I believe they have now got reason to feel better."

"Russians only want peace," said a cook. "They are not interested in war. War brings only disaster and unhappiness to Russia as well as to the rest of the world."

"Why should people of the world go out and fight," said the cashier in a store. "The average workers all over the world don't want any war and I believe Comrade Stalin has spoken for them when he says nations and their armies don't want war."

"I am a soldier, but God knows I don't want war any more than an American or Chinese soldier wants it," said a Red army captain. "Comrade Stalin has spoken with this great wisdom once more."

"I have always said that the Russian people don't want any more wars and all they want is to be left alone," declared a Russian housewife and mother. "They certainly are not interested in gaining any land from anybody and it sounds ridiculous to a Russian to be accused of being aggressive."

"The questions asked Stalin were the ones everyone wanted answered," said a student, "and Stalin gave the answers everyone wanted to hear. The answers are coming to the people."

"Equality of nations is right," said an engineer. "The answers should calm down some people who are worried about war."

Pravda, organ of the Communist party gave Stalin's answers to this correspondent's questions first place in the news on its front page, headed off its news index with the story and displayed both at the top of the page under bold black head.

Ashes Of The Dead Confront Japanese

Shanghai, March 23—(AP)—Flag-draped boxes containing the ashes of three executed Doolittle fliers and a fellow airman who died in prison were placed dramatically today before the five-man military commission trying four Japanese officers on war crimes charges.

Three of the boxes were labeled "Lt. Dean E. Hallmark, 'Lt. William G. Farrow, 'Sgt. Harold A. Spatz," but they also carried the names respectively, J. Smith, H. E. Gande, E. L. Brister, under which they originally were registered falsely by the Japanese.

The ashes of Lt. Robert J. Meder, Lakewood, Ohio, carried only his name. He died of malnutrition in Nanking prison three months after the executions.

R. O. Scott, proprietor of a Shanghai funeral parlor, testified that Japanese officers furnished the correct names for the executed Americans after Japan surrendered.

Truman's Jackson Day Address Is Anticipated

Hard-Hitting And Progressive Speech Expected In President's First Political Address Since Taking Office

Washington, March 23—(AP)—President Truman was billed today for a hard-hitting speech to keynote his party's Jackson Day dinners throughout the nation.

The White House disclosed it would be the Chief Executive's first avowed political address since becoming President, and an aide said it would be front page talk, both hard hitting and "progressive."

Secretary Wallace, who has suggested reading out of the party those legislators who oppose the administration on major issues, will speak from the same platform.

Mr. Truman's 2,000-word speech will be delivered at the main 100 a plate banquet here at 10:15 p. m. (EST) following the Commerce Secretary's 12-minute address.

National radio networks will carry the two principal addresses to the other dinner rallies, in which an estimated 150,000 Democrats will participate across the country.

A record-breaking audience—close to 2,000—was expected at the local dinner, where tickets go to those contributing \$100 to party campaign chests.

The 1946 dinners find the party still bucking a rather successful congressional opposition of Republicans and a group of southern Democrats—a combination National Chairman Robert E. Hannegan has referred to as a "politically irresponsible coalition or 'glass compact.'"

Secretary Wallace, ardent New Dealer, proposed last week that Democrats deserting on important questions be forced into the Republican party. The suggestion did not evoke any Capitol Hill support and President Truman commented there is no set way to discipline those who stray off the reservation.

SEARCH OPENS FOR BANDITS

Federal, State And County Law Enforcers Join In Hunt

Warsaw, March 23—(AP)—Police Chief Thomas A. Rogers of Warsaw said today federal, state and county law enforcement officers were cooperating in a widespread search for three men who escaped after two of the number were surprised early yesterday robbing the Warsaw post office and had fought a running gun battle with a local police officer.

Town Officer Ira Ezzell exchanged shots with the masked pair after discovering them at their work in the post office shortly after 3 a. m., Rogers said. In the ensuing gun battle, which lasted several minutes, he said the two men made their way down Warsaw's main street and escaped in an automobile with a third accomplice.

Rogers said a Tide Water Power Company said it had been cracked and robbed of "less than \$50," and that the American Express Company office had been entered. Post-Continued on Page Two

ATOMIC TEST IS DELAYED BY PRESIDENT

Postponement Said Ordered Because Of Heavy Legislative Calendar

Washington, March 23—(AP)—President Truman called the Pacific atom bomb test off for six weeks and thereby set the capital buzzing today over the reasons behind his surprise decision.

Mr. Truman said merely he was ordering the postponement because a "heavy legislative" calendar will prevent Congressmen from witnessing the experiments which were scheduled to start in the Bikini atoll on May 15.

Announcement of the postponement virtually on the eve of the UNO sessions in New York aroused much conjecture, however, particularly since yesterday produced Generalissimo Stalin's public avowal of confidence in UNO's future world role and his statement he believed no nation was seeking war.

Perplexing features in the picture were that the A-bomb test force already had been put in motion and that the UNO meeting, as well as continued congressional sessions, both have been fairly definite for some time. Capitol Hill had not previously noted any widespread clamor in this election year for legislators to witness the experiment.

But Mr. Truman said a large number have expressed a desire to see both tests.

Initial reaction was that the president's unexpected decision was related in some degree to the uneasy recent state of international affairs. Continued on Page Two

U. S. "Sitting On A Volcano Of Disease"

Honolulu, March 23—(AP)—Capt. Paul Withington, assistant medical officer of the 14th naval district, declared today that the United States was "sitting on a volcano of disease" from the Orient which might erupt in a major epidemic at any time.

Withington, a former Honolulu physician who was awarded the legion of merit yesterday, laid the danger to rapid demobilization and resultant loss of medical personnel in the armed forces.

Japanese scrub typhus and malaria have spread in the Pacific while smallpox, cholera, and typhoid fever also are threatening unless rigidly controlled, said the medical officer, who emphasized that he was expressing his own views.

California State health authorities at San Francisco yesterday announced an "outbreak" of smallpox from the Orient in the San Francisco area, and called upon the public to undergo vaccination promptly.

A World Daily News dispatch reported large numbers of Communist troops were massing in Jehol province. It speculated they might be planning new attacks against government forces.

Troop Movements Go Under New Blackout

Washington, March 23—(AP)—The army has re-imposed a wartime security blackout on the movement and location of divisions or larger troop units, the War Department disclosed today.

The order applies to units in the United States as well as those overseas. It was described by officials as temporary pending further study whether to reinstate indefinitely a ban on release of information concerning such troop movements which was lifted at the end of the war.

(The action affects only official army announcements. Voluntary wartime censorship restrictions on newspapers have been lifted and there is nothing to prevent publication of such news obtained from sources other than the army.)

Officials declined comment whether it related to the current international situation. They said among "several reasons" for the order were frequent and sudden changes in orders for troop movements, which caused disappointment and confusion to families expecting the return of soldiers from overseas.

Babson Discusses Russia

Washington, D. C., March 23—Let us start with three statements with which most intelligent people agree: 1. Notwithstanding Churchill's blast, no group now wants a war with Russia. Surely the vote of the United States would be 100 per cent against it now, although we are better prepared for it now than we may ever be again.

2. Most of all, Russia does not want another war now. She knows that we saved her in World War II, and she knows she would lose all her gains with a World War III now.

3. Our State Department is so divided into Catholics, Protestants, New Dealers and capitalists that it cannot agree upon any foreign policy now—to say nothing of agreeing to fight Russia now.

Hence, there is no possibility of a war with Russia for an indefinite period.

Is War III Probable?
It is safe to add a fourth forecast, viz: If our present daily-dilly, contradictory, inconsistent and silly foreign policy continues long enough, we may have a war with

Russia some day. Then, the U. S. and Britain will not be so well prepared as we are today; while Russia could then be very much stronger and in addition will have all atomic bomb secrets. Only a spiritless awakening of our State Department, or split-up of Russia into two or more nations, can prevent such a conflict.

Conditions today are almost identical with those following World War I. Instead of a German Hitler, there can soon develop a Russian Hitler. Great Britain again has a labor government; France again is playing politics and talking pacifism; while U. S. mothers merely "wanna get their dear boys home."

World War II should have been unnecessary had it been "nipped in the bud." World War III can be prevented by the U. S. and Great Britain now joining on a fair, but firm, foreign policy, backed up by force.

DISPUTE OVER REFUGEES ON UNRRA AGENDA

Council To Discuss Handling of 500,000 Displaced Persons

Atlantic City, N. J., March 23—(AP)—Delegates to UNRRA's council meeting today took up the long-simmering dispute over what to do with hundreds of thousands of war-scattered refugees who do not want to go home.

This issue, involving more than 500,000 "displaced persons," reached the council floor today while representatives of 47 nations pondered their primary question—how to eke out from the world's available food supplies enough to feed a hungry world.

Most of them privately, some of them publicly, stated their belief that it just could not be done, with the result that sentiment is mounting here for a formal recommendation that peoples from ex-enemy countries must stand last in the queue for food relief.

Quietly, behind the scenes, a move to bring the United States back to war time rationing of commodities in short supply—particularly cereals, fats and oils—was gathering momentum despite a claim by Secretary of Agriculture Anderson that such a step would prove "impractical."

High Priority Is Given Iran Plea

New York, March 23—(AP)—Consideration of the Iranian complaint against Russia was handed a high priority today on the provisional agenda of the United Nations Security Council, which is due to open its sessions Monday.

The Iranian question, concerning the country's protest against the continued presence of Soviet troops on its territory in alleged violation of a tripartite treaty, was listed as item No. 3 in the agenda which will be submitted to the 11-nation group.

Rearrangement of the schedule can be made after the meeting opens, however, so as to give the case immediate consideration, according to UNO general secretary, Trygve Lie. This would be in accordance with a request by Edward R. Stettinius, U. S. delegate, who has urged that the dispute be first on the calendar.

But listed ahead of the Iranian case now was the report on rules of procedure and a report on rules for the military staff committee.

Stalin's Avowal Of Faith In United Nations Encourages Statesmen; Still Up To Russia To Conform With Assertions Says One Senator; New Ambassador Leaves For Moscow Tomorrow

Washington, March 23—(AP)—A more hopeful feeling on future international relations pervaded the Capital today as a new United States ambassador prepared to leave for Moscow.

Generalissimo Stalin's avowal of faith in the United Nations organization was taken as an encouraging prelude to the departure of Lt. Gen. Walter Bedell Smith, the new envoy, for his post in the Soviet capital. He plans to leave tomorrow.

President Truman's reaction to the Stalin statement was that he had always known the way the Russian leader felt. A White House spokesman disclosed this last night.

While lawmakers generally welcomed Stalin's declaration that no nations or their armies are seeking another war, there were many crossed fingers on Capitol Hill. The doubt was whether future Russian policy would back up everything Stalin had to say.

Senator Hatch (D-NM) asserted that it is up to Russia now to make her actions conform with Stalin's assertion that strength of UNO lies in equality "and not on the principles of the domination of some states over others."

The New Mexico senator told a reporter that after reading an interview with Stalin obtained by Eddie Gilmore, Associated Press Moscow correspondent, he believes the Soviet chief of state has a "complete misunderstanding" of free speech as it is known in this country.

He referred to Stalin's remarks that:

"It is necessary that the public and ruling circles of the power organize a world wide counter-propaganda against the propagandists of a new war, and for the insuring of peace—so that not a single act of the propagandists of a new war should remain without due rebuff on the part of the public and press, so that the incendiaries of war may thus be exposed in good time and may have no chance of misleading"

Death Takes Second Of New Cardinals

Hamburg, March 23—(AP)—British occupation authorities announced today that Clemens August Cardinal Count Von Galen died at his home in Muenster yesterday afternoon.

The cardinal, who recently returned to Germany from Vatican City where he was elevated to the Purple, was 68 years old.

The prelate, bishop of Muenster, underwent an operation for peritonitis on March 19.

He was the second of the new cardinals to die since the recent consistories at the Vatican. John Cardinal Glennon of St. Louis, who died in Dublin, Eire March 9, was the first.

Vatican City, March 23—(AP)—Reports of the death in Germany of Clemens August Cardinal Count Von Galen were received with expressions of sorrow today by Vatican prelates who recalled the German cardinal's firm anti-Nazi stand during the war.

AP World Traveler

Paris, March 23—France's appeal for assistance in inaugurating her five year economic plan is symptomatic of the shocking distress which blankets most of Europe and special envoy Leon Blum quite likely is only heaving trail for a long line of applicants from other nations.

Of course the big problem of the moment in most countries of the old world is to find food, on the basis that if you are starving it doesn't matter a tinker's dam how much money you have in your pocket unless it will buy something to eat. However, I take it that in the long run a full cupboard is dependent on a full purse, which means that there can be no permanent cure for hunger unless the economic situation is sound.

There was hunger in Europe after the first world conflict, and there was economic disturbance, but it was a happy interlude as compared with what is happening now. As this column has remarked before, you've got to be here in Europe and see these things in order to get a full realization of the extent of the catastrophe.

The total war which Hitler inaugurated truly belonged to the atomic age. It not only stopped the

wheels of progress but it destroyed the means of recovery. Those means now must come largely from the western hemisphere.

That's why we find France knocking at our door. She's one of the hard hit countries. Her present misfortune is due to various reasons, including political confusion and spiritual hurt, but we find enough cause for economic distress in the despoliation of this great country by the Hitlerites.

Here, as in most other occupied territories, the Nazis not only sent thousands of citizens to servitude in Germany but plundered the country of equipment essential to keep the economic wheels turning.

For instance, much of the rolling stock of the railroads was run off for use in Germany and other invaded countries. Factories were stripped of machinery, and machine tools were stolen wholesale.

In short, when the war ended France had been so crippled that she lacked the basic means of recovery and had to look abroad for help. The same is true of most other countries which were overrun by Hitler. Another case in hand is little Holland which has been negotiating credits in Washington.

When I was in Holland a month ago I saw the return of soldiers from overseas.

Washington, March 23—(AP)—Suppose you are a veteran and need some war surplus property to resume your old business or set up in a new one.

You should make application as a veteran or as a small business man.

There is a difference, which goes so far as to require your application to be made to a different agency. Choice of the wrong channel may mean failure to get scarce materials.

The easiest way evidently is to consider yourself as a veteran and apply to the War Assets Corporation. (Beginning next week it will be known as the War Assets Administration.)

If you can present proof of military service, there should be no trouble getting a preference certificate to buy the goods—if you can find them.

That's the rub. Your preference certificate entitles you only to third place among applicants for surplus goods. Top priority is given to federal and state governments and their subdivisions. Next comes tax supported institutions, such as

colleges or hospitals, et cetera, rather after these but ahead of the general public.

Now, let's suppose you forget you are a veteran and instead style yourself a small business man, according to government definition whether you have been in a certain business before or seek to enter it for the first time. But you must show qualifications to carry on the business successfully.

In this case your application would be made to the small business offices which used to be part of the small war plants corporate but recently were made a part of the Reconstruction Finance Corporation.

You have to prove your case to the RFC. If you do, the government becomes your agent and buys the goods for you from the War Assets Corporation. In doing so it exercises top priority and gets your material reserved for you. It makes no difference to you whether you are a veteran or not. It makes no difference to the RFC, legally at least, whether you are a veteran or not. (Continued on Page Two)

STRENGTH FOR THE DAY WE NEED MORE THAN PHILOSOPHY

Some one has said that philoso-
phers build castles and then an-
nounce to live in hells. Their phi-
losophies are often much greater
than the principles and hopes which
govern their lives.

The same, of course, can be said
of anyone who profess any sort of
philosophy of life. It can be said
of you and of me that our theories
about life are a lot better than our
daily behavior. None of us should
throw stones at the glass house in
which the philosopher lives.

But without being harsh in our
judgment of others, we may well
ask why the profound philosophy
which has come down to us through
the centuries should help us so little
in the living of a righteous and
peaceful life. Do we go to Plato
when we want to know the right
thing to do? Do we find consolation
in the writings of Kant when sorrow
has torn our hearts? Do Hume and
Hegel exercise a profound influence
on our daily decisions?

The answer of course is No. When
we want to know what is
right we consult the Ten Command-
ments. When we want consolation
we turn to the New Testament.
Why? Because we regard philoso-
phy as what men think, and the
teachings of the Bible as what God
has said. The source of authority
makes a powerful difference when
right counsel is a matter of life or
death.

freedom of speech against the in-
terests of peace.

"Propaganda" counter or other-
wise, will not allow laws caused by
actions being words," declared
Hatch, a member of the Senate
Foreign Relations Committee and
former personal friend of President
Truman.

"If the great Soviet Union and the
other nations faithfully adhere to
the basic principles of the San
Francisco charter, all fear will dis-
appear overnight."

"We have had too much of that
already," he said.

The Soviet premier's statement
that the United Nations can play
"a great positive role in the cause
of maintaining universal peace and
order" was welcomed generally in
Congress as promising hope that
the organization can settle some
currently pressing international
problems when its Security Council
meets in New York next week.

Smith, who as Gen. Eisenhower's
chief of staff had been with Rus-
sian military men during the war,
said yesterday he will make "every
possible effort to increase under-
standing between the United States
and Russia in its new post."

After taking his oath as envoy
yesterday, Smith told the news that
the nation's goal should be to "make
sure that the Russians understand
that we are doing everything we can
to make certain the United Nations
Organization will be a success as
they have pledged themselves to do."

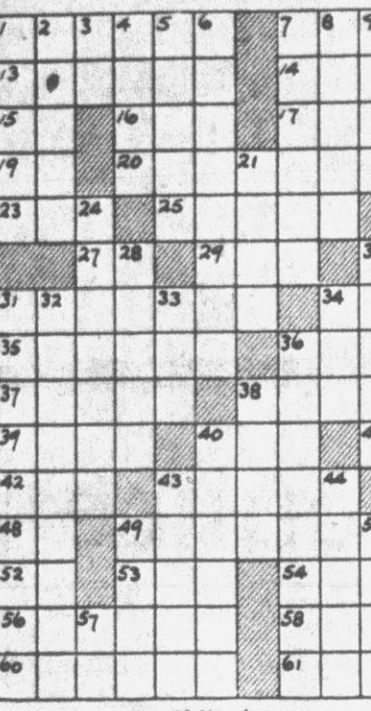

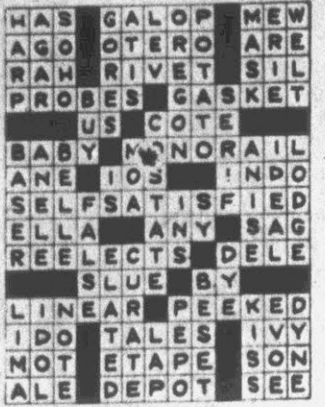

are a veteran or not. But you have
to be a small Business Man to do
business with them in this way.
That means your business does
not dominate or is not affiliated
with one which dominates its field
and that you will have less than
500 employees.

Also, your request for material
must not exceed a reasonable
amount. You can't hog the
market.

Finally, there is a provision in
the law that when the RFC acts as
agent for a small business in ac-
quiring surplus property, it must
do so because such action "is re-
quired to preserve and strengthen
the competitive position of small
business."

You must prove that you have
tried two ordinary channels, and
failed to obtain the needed mate-
rial—that you are actually a hard-
ship case.

Whether it is better for any in-
dividual to apply to the war as-
sets corporation as a veteran or to
the RFC as a small business man
will depend on how good a case he
can make out on the latter basis.

One thing that makes the de-
cision easier for the veteran-business
man is that there is a war as-
sets division in all regional RFC offices.

Representatives of both agencies
in Washington say advice and guid-
ance for veterans is available at
any of these offices.

Russia. For the past year, I have
been forecasting a break in the
stock market "due to a Russian
scare." This recently occurred when
stocks lost billions of dollars in a
few days. Now this is probably over
and we should go merrily along
for a while with better business and
higher stock prices.

This present Russian scare should
make Congress more willing to ap-
propriate funds for national de-
fense, cause it to help the British
Empire and to encourage that Em-
pire to do more for her colonies. The
best way to combat Communism is
for Capitalism to insure a higher
standard of living and greater se-
curity than does Communism. The
new atomic energy may succeed in
doing this.

I feel as President Truman and
Mr. Churchill agreed at Fulton,
Mo., on March 7: "These are perilous
times. The world either is
headed for destruction or for the
greatest age of progress in history."
If we are to have the latter, this
is a time to hold good stocks; while
if we are to witness destruction,
then it will make no difference as
to whether we have cash, stocks or
government bonds!

Nationalists vs. Inter-Nationalists.
Our people, unfortunately, are di-
vided into either isolationists or
non-isolationists. One group be-
lieves we should be content to put
our own house in order before mix-
ing up with the rest of the world.
The other group goes to an oppo-
site extreme and thinks that—
through the United Nations Organi-
zation—we can now run the world
and give every nation the Four
freedoms.

Both of the above groups are
wrong. Either group could get us
into trouble. If President Truman
should clean out our present State
Department and substitute there-
for a united department with a
middle ground, but firm, policy,
should be "limited internationalism."
It should be free from politics,
prejudice and philanthropy. It
should have one aim; namely, to
interfere only in those spots which
are liable to get us into war if left
to smolder.

ago, Prime Minister Scherhorn
told us that the Germans had taken
all but 15 percent of the country's
rolling stock. There is such a
shortage of machinery and machine
tools due to Nazi plundering, that
it has been impossible to get indus-
try under way or to repairs.

The question naturally arises why
these stolen railway cars and the
industrial machinery aren't return-
ed to France, Holland and the other
despoiled countries. Well, a little of
the answer is in my way back, but
I remind you again that this has
been a total war. Much of the
tremendous amount of wealth which
Hitler collected in Germany was de-
stroyed in the allied hurricane that
swept the Reich.

Then, too, even where machinery
and various kinds of supplies are
found intact, it frequently is diffi-
cult to determine ownership. I was
talking the other day with a famous
Dutch manufacturer who told me
of losing an invaluable trainload
of material to the Germans.

What appears to be this material
has now been found in one of the
occupied zones of Germany but

"any security" clauses in union con-
tracts. This, too, is likely to touch
off a battle if it reaches the con-
vention floor for debate.

The automobile companies have
been pressing for such clauses de-
signed to protect the companies
against unauthorized or "wild cat"

who take part. Such a provision
was written into the UAW-Ford
agreement and it aroused consid-
erable opposition among Ford workers.
There is no "company security"
clause in the UAW agreement with
General Motors.

the atomic bomb, anticipated by
the military's role in future atomic

Senate for its program.

Mr. Truman's public, passed last

Senator Johnson (D-Calif.), mem-
ber of both the Senate Military
Committee and the Senate Atomic
Energy Committee, told news-
men he had no advance knowledge of
the plan, but that he was deeply con-
cerned with the tests of the bomb on warera-
tors, and similar surprise.

The joint Army-navy task force
had proceeded with plans to start

John G. Clark Kiwanis Speaker

District Highway Commissioner John G. Clark of Greenville at the Kiwanis Club's supper meeting last night said Governor Cherry is solidly behind the plan to build more farm-to-market roads, and that every one of the 12 counties in this district will have their fair proportion of new roads—primary and secondary—and improvements.

Clark said appropriations for roads are made on a fair and impartial basis, and that the 12 counties in this district will get their share. Counties comprising the district are Pitt, Lenoir, Greene, Onslow, Jones, Carteret, Craven, Pamlico, Beaufort, Hyde, Washington and Tyrrell.

Commissioner Clark used a map to illustrate his interesting talk on road building. Referring to frequent requests when a road is built and requests come in from citizens asking that five or six miles of roadway be extended to a certain place, the commissioner said construction begins, and that extensions cannot be made until a survey is made and an appropriation set up for that project.

Clark held an optimistic outlook on prospects of new and improved roads; stressed preference to farm-to-market roads, and reminded that with plans made for extensive road building, the Highway Commission is handicapped by failure of much of the roadbuilding machinery ordered, to be delivered.

Judge Dink James presented Clark and paid him fine tribute for his loyalty to his state, county and city and the people.
