CHINESE FAIL TO AGREE ON TRUCE TERMS

Kai-Shek Rejects Truce Leaving Harbin And Changchun To Communists

Chungking, April 29—(AP)—Informed Chinese sources said tonight that Generalissimo Chiang Kai-Shek, Communist General Chou En-Lai and U. S. General George Marshall had failed to reach an agreement that would halt fighting in Manchuria. They have been conferring constantly.

Negotiations will be transferred to Nanking, where the capital is transferring this week, these sources declared.

Marshall was expected to fly to Nanking tomorrow, with Chou and Chiang following later in the week.

Marshall's headquarters still was silent regarding progress of the negotiations but Chinese sources said the generalissimo had rejected a democratic league formula for truce in Manchuria, leaving the Communists in control of Harbin and Changchun, the capital.

These sources said Chiang is depending upon his armies to reconquer Changchun before agreeing to a truce.

Marshall met with Chou this morning and Chiang later. A possibility that negotiators may reach an acceptable plan before leaving Chungking still existed, however, since Marshall is spending every available minute in conferences with the two leaders.

Nanking, April 29—(AP)—General Marshall has submitted a four-point proposal to Generalissimo Chiang Kai-Shek and Communist General Chou En-Lai for settlement of the grave Manchurian situation, the usually reliable Hsin Min Pao, a pro-government newspaper, reported today.

In a Chungking dispatch, the newspaper disclosed the points:

1. An immediate and unconditional armistice.
2. Retention of the status quo of the Manchurian regimes until a general election.
3. Reorganization of Manchuria.

Eisenhower Will Visit MacArthur

Hamilton Field, Calif., April 29—(AP)—General Eisenhower was en route to Hawaii today on the first leg of an inspection tour which will take him to the Pacific bases and include a conference in Tokyo with General MacArthur. The two have not met since before the war.

The Army Chief of Staff, during a brief stopover at Hamilton Field last night, said he and General MacArthur would discuss "common problems of administration and see how the GIs are getting along out there."

Concerning the army's manpower, General Eisenhower said: "We've got all the men we need right now. The big problem is to keep them for the next 18 months, which will be an important period. Those men out in the field have a lot of things to do. They've got to be in advance they'll have the personnel they need, so they can plan."

"I expect demobilization to level off by July 1, 1947, when the army will have 1,070,000 men. That will be the permanent figure. I've talked to all the experts and none has criticized the figure as too high. They agree we'll need that many."

Mediterranean Policy On Conference Agenda

Bevin And Molotov Expected To Clash Over Disposal Of Italian Colonies And Future Of Dodecanese Islands

Paris, April 29—(AP)—The four-power foreign ministers' conference ran into its most crucial session today, with the future of Italy's colonial possessions in North Africa and the Dodecanese Islands in the Mediterranean on the agenda.

It was on these questions that Russian Mediterranean interests and Britain's empire communications were expected to clash directly. There were indications that discussion of the Italian colonies, particularly the disposition of Tripolitania, would take up most of the session.

The Russians have asked for a trusteeship over Tripolitania, but British Foreign Secretary Ernest Bevin has declared such a grant would cut directly across Britain's Mediterranean communications to the Middle East and India. The United States has proposed a United Nations trusteeship for Libya, which includes Tripolitania, as well as for Eritrea and East Africa.

Although the foreign ministers agreed to put all phases of the thorny Italian peace problem on

today's agenda, American sources said it was doubtful if there would be time to discuss the disputed Yugoslav frontier and Trieste issues.

Secretary of State James F. Byrnes and the Russian Foreign Minister V. M. Molotov conferred for three hours last night over a dinner table, but the subjects discussed were not disclosed. Molotov was accompanied to the dinner by Andrei Y. Vishinsky, vice-minister of foreign affairs.

This morning Byrnes talked with the Egyptian ambassador, Sakry Pasha. Egyptians have indicated a direct interest in the Italian colonial question.

Despite today's tough agenda, the four ministers came to the session in an atmosphere of friendliness and conciliation. Senator Arthur H. Vandenberg (R-Mich.) said he was "pleased" with the course of the meetings so far. He called Russian concessions since the start of the conference last Thursday a "good sign."

Jap Militarists Indicted By Allies

Tojo And 27 Other Militaristic Leaders Indicted For War Crimes Ranging From Murder To Conspiracy Against World

Tokyo, April 29—(AP)—Japan's Warlord Hideki Tojo and 27 other militaristic leaders were indicted by the Allies today as war criminals. They will be arraigned May 3 on 55 specific charges ranging from murder of thousands of Americans on Pearl Harbor Day to conspiracy to hammer the whole world into slave states of the Axis.

Defense counsel are expected to be given reasonable time to prepare their cases before trials begin before an 11-nation tribunal.

Tribunal members heard Chief Allied Prosecutor Joseph B. Keenan read the indictments at the Japanese War Ministry Building, then called U. S. Navy Capt. Beverly M. Coleman, who will head the defense, into a brief conference.

Neither Keenan nor Chief Justice Sir William Webb, who heads the Allied tribunal, would comment as they left the buildings after the historic 35-minute session.

As he presented the indictments, Keenan outlined three categories of charges: crimes against peace, "conventional" war crimes, and "crimes against humanity." Offenses thus range from maltreatment of individuals to world conspiracy, and Keenan made it plain that the whole 18-year story of Japan's bloody bid for world power will be told in the forthcoming trials.

Named in the indictments were: Four former premiers: Tojo, Baron Kichiro Hiranuma, Koki Hirota and Gen. Kuniaki Koiso.

Adm. Osami Nagano, former chief of staff whose direct order launched the attack on Pearl Harbor.

HUMBER URGES PARTY UNITY

Candidate Is Principal Speaker At County Democratic Convention

Robert Lee Humber of Greenville, candidate for Congress from the First District, was the principal speaker at the Pitt County Democratic Convention held at the Court House here Saturday. John G. Clark of Greenville presided and introduced the speaker.

Mr. Humber, profound student of government, international lawyer and native of Greenville, spoke briefly. He reviewed the history of government in this country, tracing its workings as an example to the world. He pointed out the great parts played by Thomas Jefferson and others in founding the Democratic Party, and spoke with pride of the great contributions of Presidents Woodrow Wilson and Franklin D. TRUMAN SAID TO HAVE MADE COURT CHOICE

New Chief Justice Chosen, Yet Unnamed; President Turns To Coal Strike

Washington, April 29—(AP)—President Truman, his mind made up on the Supreme Court, rushed today to a search for means of settling the nationwide soft coal strike before industrial paralysis sets in.

The President's choice of a new chief justice to replace the late Harlan F. Stone and of a new member of the court to succeed the man who will be elevated to the presiding spot are expected to be announced early this week—possibly tomorrow.

That much was known definitely, but White House confidants for the most part declined to verify this latest speculation: (1) That either Robert H. Jackson or William O. Douglas will be moved up to head the court, and (2) that Secretary of War Robert P. Patterson, a Republican, will be added to its membership.

Jackson, a close friend of Mr. Truman, is serving as chief U. S. prosecutor at the Nazi war crimes trials in Nuremberg and probably would not return to the bench before the June adjournment even if he gets the nod. The new court term opens in October.

Some Capitol Hill friends of the President said they think that if Patterson is moved into the tribunal, W. Stuart Summington, assistant secretary of war for air, might be considered for the cabinet post.

Republicans Preparing Own Program For OPA

Washington, April 29—(AP)—A Republican effort to grab the price control bill in the Senate and run it through badly disorganized Democratic lines prompted, mixed predictions today of success and failure.

Shucking off the legislative wraps they have worn most of the time since 1933, the Republicans apparently are committing themselves to an open fight under the direction of Senator Telford of Ohio to force through a program of their own.

It is the first move of this nature since the GOP legislators adopted a general statement of policy last December. And it came at a time when dissatisfaction in Democratic ranks was demonstrated by a plea from Rep. Kilday (D-Texas) for his congressional colleagues to meet and adopt a program of their own.

Assuming that there now is no Democratic program except that sponsored by certain individuals Kilday criticized Secretary of Commerce Wallace in a statement for advocating that party members be punished for not supporting administration proposals.

SENATE HEARS AFL CHIEF ON OPA PROPOSAL

William Green Warns Against House-Passed Price Control Measure

Washington, April 29—(AP)—President William Green of the American Federation of Labor urged the Senate today to reject very promptly and unhesitatingly House OPA proposals which he said would amend price control to death.

"Hesitation will only breed chaos," he said. "Delay will only multiply confusion. Every day of postponement of the decision will help the profiteer and weaken the speculator."

Testifying before the Senate Banking Committee, Green said the most dangerous of the House amendments to legislation extending OPA beyond June 30 is one which would remove price control from any item whose production equals the 1940-41 rate.

He noted that there are now 8,000,000 more Americans than there were six years ago and accumulated demand for goods is vast because of non-civilian production in the war years.

Green said this amendment would require complete removal of price ceilings on commodities making up at least half of the consumer price index, which is the nearest measure we have of changes in the cost of living.

The labor leader, saying he spoke for 7,000,000 AFL members, also called unsound a House amendment requiring assurance of a profit on every item a manufacturer or distributor handles.

He said it would blow sky high the price ceilings and with them the prices on automobiles, refrigerators, radios, household appliances and many other consumer goods.

Green said the proposal does not take into account that many industries must of necessity operate at excessively high costs before they attain volume production.

Dairymen Opposed to City's Time Change

Clearfield, Pa., April 29—(AP)—Dairymen supplying milk to this western Pennsylvania community today threatened to strike unless the town rescinds its action adopting Daylight Saving Time and moves its clocks back one hour tonight.

The milk producers asserted farming operations weren't suited to fast time and that, among other things the cows refused to give as much milk when their milking hour was changed.

Burgess A. Hills told the aroused group of 40 some farmers that the borough council adopted Daylight Saving Time for its own employees only and that business establishments factories and homes followed suit on their own initiative. He promised to call the council together to seek some kind of settlement.

Resolution Setting Up Subcommittee Of Five To Investigate Spain Is Approved; Gromyko Abstains From Voting; Members Of Subcommittee Are Named

New York, April 29—(AP)—The United Nations Security Council, with Soviet Russia abstaining, today adopted a compromise resolution setting up a subcommittee of five members to investigate charges against the Franco government of Spain. Ten affirmative votes were cast.

Soviet delegate Andrei A. Gromyko kept his hand down when the vote was taken on a resolution which would require the subcommittee to report by May 31.

Dr. Hafez Afifi Pasha, chairman and Egyptian delegate, then named Australia, Brazil, China, France and Poland as members of the subcommittee.

The council then adjourned with the date of the next meeting to be announced by the chairman.

Dr. Oscar Lange, Polish delegate, told the United Nations Security Council that any commission appointed by the council to study the Franco case should report by May 31 to make sure that it "really works and does not merely shelve the question."

Dr. Lange, who was one of the framers of the Australian-backed "fast-track" compromise resolution presented last Friday, said that he wanted to go along with the Australian proposal in the interest of unanimity.

The Australian proposal would note the council's condemnation of the Franco regime of Spain and would call for a subcommittee of five council members to study the charges that Spain is a menace to world peace and is harboring Nazi war criminals.

Lange held up a vote on the proposal while he suggested that the committee be told to report May 31 instead of "as soon as practicable."

Paul Hasluck, 40-year old Australian sitting in the place of Lt. Col. W. R. Hodson, who has left the council because of his wife's illness in Paris, said he would accept the amendment if the others on the council agreed.

An Analysis Of The News

The question of how the UN Security Council shall handle the Franco regime of Spain continues to be one of the serious international worries, and the weekend brought the highly interesting indication that the generalissimo may be getting set for a countermove in the form of a referendum to test the temper of his people.

While there has been no official news of a plebiscite, observers see the possibility of one in the announcement that a census of all Spaniards over twenty-one is to be taken. Why over twenty-one? Naturally the thought is that it has to do with the vote.

My recent visit to Spain leads me to believe that it need cause no surprise if Franco tries to beat the Security Council to the punch by having a referendum. This might be in the nature of a "vote of confidence" in his government, or it might subtly couple this idea with the question of whether the people would like a return of the monarchy. I believe he would agree to restoration of the throne if the

pretender, Don Juan, would make concessions enabling the general to retire from the dictatorship gracefully, that is, without loss of face.

British Prime Minister Attlee said Saturday that he "should like to see the Spaniards put an end to it (the Franco regime)" as quickly as possible. "We don't offer any thoughts as to how the trick should be turned but undoubtedly he had peaceful means in mind since both England and the United States, while anxious to get rid of Franco, are equally anxious to avoid the horrors of civil war. There is, of course, another school who wouldn't be averse to seeing the matter ironed out in that bloody fashion."

Anyway, there certainly is much doubt whether the United Nations would find much balm in the glead of a Spanish referendum held under the auspices of the Franco government. In the first place the question arises as to how much freedom of action the voters would feel they had under a powerful dictatorship—whether a referendum would mean a great deal.

Women in the Church
by Mary Fowler

At the invitation of the Conference of British Missionary Societies, Miss Sue Weddell, a secretary of the Foreign Missions Conference of North America, has flown to London, England, to attend the annual meeting of the British body. While in Europe she will also attend sessions of the British Council of Churches, the General Assembly of the Church of Scotland, the Y. W. C. A., and of the Baptist and Methodist missionary societies, besides conferring with the Indian Committee of the British Conference, and other groups in the Netherlands, Switzerland and France.

The common American diaper—rectangular, triangular, or square makes no difference—has now come to have religious significance and to be much talked about in the nation's churches. For the Church Committee on Overseas Relief and Reconstruction, representing all American Protestantism, is seeking one million diapers for the near-naked babies of Europe. In Czechoslovakia, in Hungary, in Poland, and elsewhere in Europe, newborn babies are being wrapped in newspapers because clothing is unavailable, and this condition may persist for more than another year. The United Council of Church Women is also endeavoring to ease the diaper shortage; and there are reports of outfitting—flannel curtain interlinings and flannel made from many other sources being made into garments for the babies. Because old-style midwives deliver the majority of the babies in China, and because the training of doctors to replace them will take decades, the International Peace Hospital, in Yenan, Schuan, is cooperating with the Chinese Public Health Service in a campaign to re-educate midwives. The hospital and its branches classes are conducted in modern midwifery practices; the graduates are sent into the villages to instruct the present practitioners in up-to-date methods. A survey in one rural district showed that the infant death rate was almost twice as high in cases attended by old-style midwives than in cases where the mothers had no help whatever. The hospital is also preparing books on the order of comics to give illiterate mothers information about diet, cleanliness and the care of the child.

RUBINFOFF IS GREAT ARTIST

Violinist Gives Two Concerts At College Here

Rubinfoff and his magic violin, a name that thrills American music-lovers, who appears in concert at the college tonight, spent the week-end in Greenville. He likes the city and the people, he said while lunching with Eli Bloom and the writer Saturday night.

The famous violinist, who has played in concert before an audience of nearly a quarter of a million people, registered interest and pleasure when informed that the Greenville high school band and the glee clubs had been awarded No. 1 ratings at the Music Festival at Greensboro. The high school orchestra was rated No. 2. It would have received a one, but for lack of one instrument, a cello.

Rubinfoff loves music and people—especially young people. His concert this afternoon was especially for school and college students. There was a lofty kinship between the great violin virtuoso and his audience.

Rubinfoff has played the violin since he was five years old. At 14, while playing at the Royal University of Warsaw the great Victor Herbert heard him and brought him and his family to the United States. Rubinfoff lived in the great American composer's home a long time. His meteoric rise to fame on the radio and his achievements as a concert artist has made him America's most popular violinist. Rubinfoff, the man, is even more interesting than Rubinfoff, the violinist. His good humor, keen knowledge of human nature, love of the finer things in life, his appreciation of the ambition of the youth of the land qualifies him as a noble and courteous cavalier. His tribute to Charles Whedbee on a radio program Sunday demonstrated this.

Rubinfoff's concerts at the college this afternoon and tonight, are under the auspices of the Junior Chamber of Commerce. The Jaycees proceeds of the concerts will be given to the National Cancer Control Drive. His program will range from Bach's compositions to boogie-woogie. "I like to play what the audience wants," he said during an interview by a Reflector reporter. Gershwin's immortal "Rhapsody in Blue" will feature the program. Tickets are on sale by members of the Junior Chamber and at Warren's drug store.

Rubinfoff has appeared as soloist

and conductor with the Cincinnati, Chicago, Kansas City and London symphony orchestras. To illustrate the great violinist's rise to fame and eminence, Rubinfoff in 1935 played his famous Stradivarius violin in a concert for an audience of 82,000 persons in the Chicago Tribune music festival at Soldier's Field in Chicago. In 1936 he played before an audience of 150,000 persons in Grant Park, Chicago. At the same place in 1937 Rubinfoff played before an audience of 225,000 persons in Grant Park. For this he was signally honored. He was awarded a gold medal with a diamond centerpiece, with the following inscription: "Presented to Rubinfoff and his violin by the Chicago Federation of Musicians in appreciation of his services rendered in Grant Park, Chicago. Attendance 225,000 persons." Rubinfoff is proud of the trophy and wears it while on the stage.

Greenville is proud of the honor of having Rubinfoff in the city.

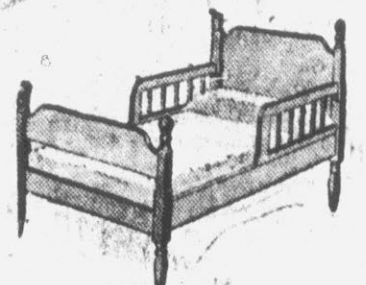

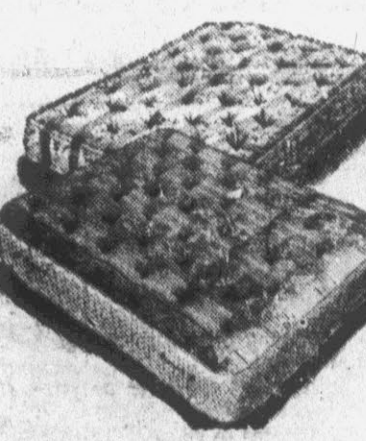

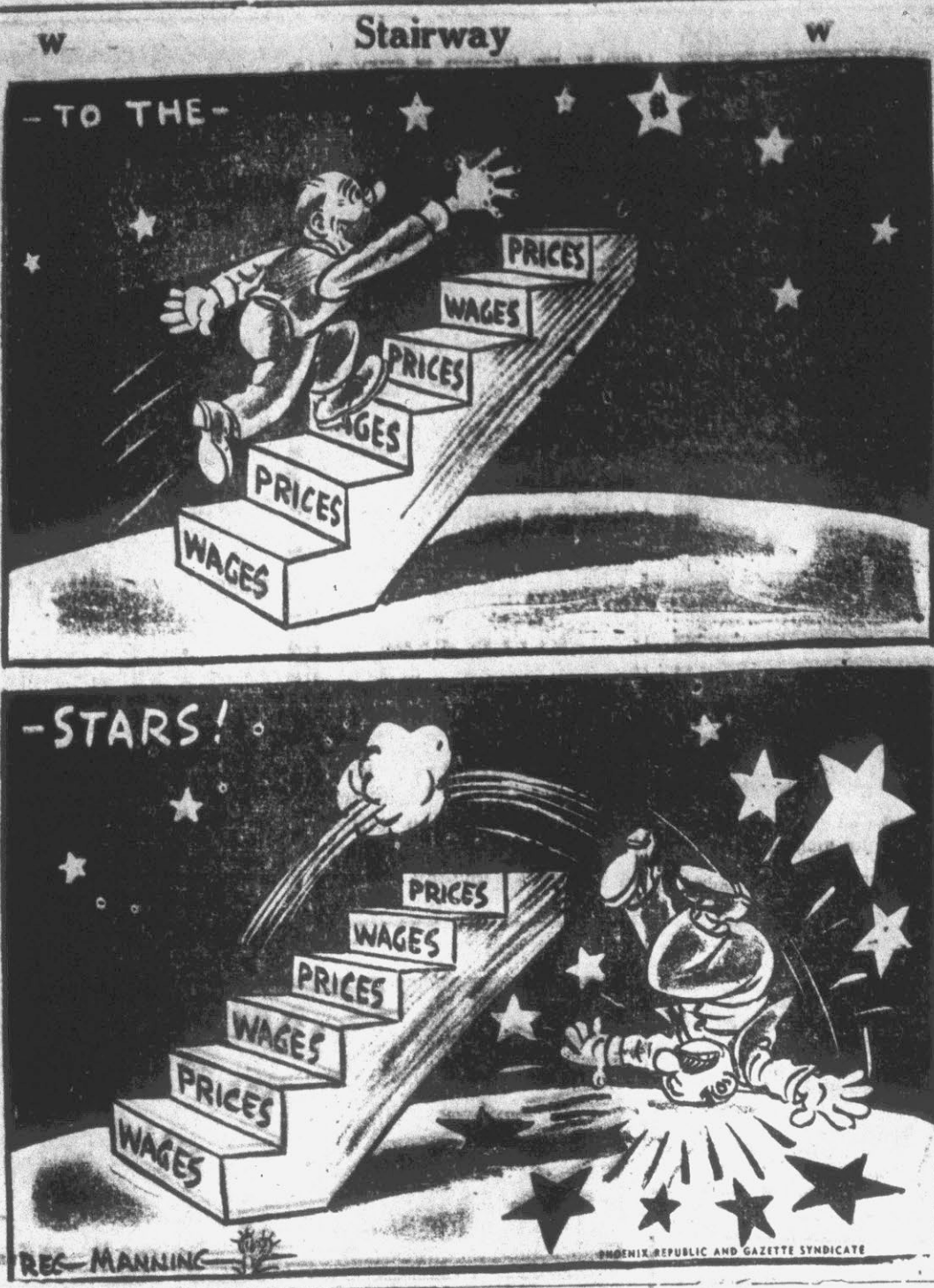

WASHINGTON DAYBOOK

Washington - German scientists found that airborne radioactive materials can cause cancer of the lung, and American investigators appraised



this as something which "should be of interest" to researchers in atomic energy.

The German researches were reported by a group of American scientific and technical investigators who unearthed many Nazi scientific secrets while the war was still on.

The American organization is known as the Technical Industrial Intelligence Branch (TIIB) of the joint intelligence objective agency, which operates under the supervision of the Army and Navy chiefs of staff.

One team of investigators learned from scientists of the Kaiser Wilhelm Institute in Germany that the Germans had investigated the cause of lung cancers among certain groups of miners in the Reich.

The German investigators reached the conclusion, a TIIB report says, that the lung cancer "was caused by breathing radium emanation and other radioactive materials present in the air in some of the mines."

Information on the research was obtained from Dr. Boris Rajewsky of the Kaiser Wilhelm Institute. In the official War Department "Smith Report" on American studies leading to the development of the atomic bomb, note is made of the health hazards associated with work on radioactive materials.

It was stated that radiations from such materials "have deadly effects akin to the effects of X-rays."

"They (radioactive materials) give off very penetrating radiations - gamma rays - which are much like X-rays in their physiological effects," declares the Smith report.

"They also give off Beta and Alpha rays which, although less penetrating, can still be dangerous."

The Smith report said that the amounts of radioactive material produced by the atomic-splitting of uranium in a relatively small chain-reacting system "may be equivalent to hundreds or thousands of grams of radium."

(The amounts of radium used in

hospitals and in ordinary physical measurements usually comprise but a few milligrams. A milligram is one-thousandth of a gram.)

Among the instruments used by the health division of the atomic bomb project was one called "sneezy" which was designed to measure the concentration of radioactive dust in the air.

Miss Laura Lindley, research director of the antisaloon league which has offices here, says the league is not trying to get congressional action, either.

Does she expect prohibition's return? She says: "That seems to be very far in the future. We're not working now for return of a national amendment. But we're trying to reduce the use of liquor as far as possible."

"We're most interested right now in liquor advertising," she says. "There is too much of it. There's vast liquor advertising over the radio. For example: In the evenings at the cocktail hours."

Meanwhile the Women's Christian Temperance Union is active throughout the states and in Pennsylvania the prohibition party has returned.

It polled enough votes in the state's last general election to win standing as a party. In the May primaries it will have candidates for governor and other state offices.

It also has announced a sticker campaign for a U. S. senatorial candidate.

three "compromises" as an indication of the apparent new Soviet attitude:

1. The Russians agreed to allow the French delegates to participate in discussion of Balkan treaties. The Russians previously had maintained that these treaties should be drafted by Britain, the United States and Russia.

2. The Russians agreed, according to authoritative reports, to leave Italy a basic naval fleet and to divide the remainder of the Italian ships among the four major powers after satisfying claims of Yugoslavia and Greece. Russia thus retreated from her previous demand for a third of the fleet, these reports said.

3. The Russians reportedly dropped their Yalta reparations formula of first setting an over-all, global figure and then finding means of payment. They are now believed to favor a British and American proposal that the victorious powers should first find out how much the vanquished can pay without going bankrupt.

GERMANS HOLD NEW ELECTION

The Communist Party Weak In County Council Elections

By RICHARD O'EGAN

Frankfurt, April 29—(AP)—Germany's fast growing new political party, the right of center Christian Social Union, won an overwhelming victory in weekend county council elections in the American zone, marred by rioting and pro-Nazi activity.

Conservative rural voters gave the church supported party almost a two to one lead over its nearest rival, the slightly left wing Social Democrats.

The Communist Party polled only a bare 5.4 per cent of the 3,138,347 votes cast in the second free election in the area in 13 years.

While 6,043 elected county officials took their seats on rural councils today, four U. S. army agencies were investigating a street battle between German voters and more than 5,000 Jewish displaced persons at Diessen in Bavaria.

Six persons were reported still in hospitals out of 18 treated for stab wounds and beatings in the riot, which finally was quelled by American soldiers.

Rural voters in staunchly pro-Catholic Bavaria gave the Christian Social Union its big total of 1,770,203 votes to the Social Democrats' 938,763 by overriding the majority the latter secured in more industrialized greater Hesse.

It was in the province of Greater Hesse that the Communists won the biggest vote, polling eight per cent of the total vote of 1,090,850 cast in the state, which includes the industrial cities of Frankfurt, Wiesbaden and Kassel.

Coal Negotiations To Be Promptly Resumed

Washington, April 28—(AP)—The Labor Department said today negotiations between John L. Lewis and the soft coal operators, broken off suddenly April 10, will be resumed immediately.

Speaking on behalf of the Department, Les Eichel, press representative, said the joint conference will be resumed in the Labor Department conference rooms at 2:30 p. m. (EST) with special mediators Edward McGrady and Paul W. Fuller sitting in. Eichel made the announcement after a 90-minute conference this morning between Schwellenbach and Lewis and his negotiating committee.

Diplomat Asks Help For Allies In Europe

Columbus, O., April 29—(AP)—Urging care of our recent allies and not our recent enemies, Charles Sawyer of Cincinnati, former U. S. ambassador to Belgium, today declared reports of European starvation were exaggerated when he left Europe.

"I do not know what conditions are today in Europe, he told the Columbus Kiwanis Club, but I do know that when I was there a few months ago, statements made as to starvation in Europe were exaggerated."

FLASHY TAKEOFF

Albuquerque, N. M., April 29—(AP)—Young Al Esquibel, competing in a high school track meet, literally shot into the lead at the start of the 100-yard dash.

His coach Dave Tomlinson, rubbed his eyes in gratified surprise. Later he learned the flash of the starter's gun had scorched Esquibel's back.

But Al didn't win.

Freight Association, testified before the Senate Interstate Commerce committee in rebuttal to testimony by Justice Department antitrust lawyers, who opposed senate approval of the so-called Bulwinkle bill. Passed by the house, it would permit railroads to fix rates by agreements, exempt from federal antitrust laws.

Kerr said the testimony against the bill by Governor Ellis Arnall of Georgia and that of Wendell Berge and James E. Kilday, antitrust lawyers, was "in conflict."

Kerr said that opponents claimed eastern railroads "had vetoed" lower rates in the south. He challenged anyone to prove this.

The witness said that the southern railway system had filed more than 100 independent rate reductions in the three years ended in 1943, that the Seaboard line had filed 78 in the same period, and that many of the smaller southern lines had followed a similar pattern.

Kerr also denied that as chairman of the Southern Freight Association he could exert an "important influence" over rates.

"I can't do anything but file a proposal," he said. "I think it is my duty to call attention to a maladjustment."

He said he had done this in the case of shipment of tinplate from

Baltimore, Md., to Tampa, Fla., and that the proposed reduced rate was withdrawn not because of his action, but because of water competition, on which the reduction was based, "had disappeared" during the war when the government took over ships.
