Hope Renewed In Peace Conference

Soviet Concessions Pave Way For Possible Break In Deadlock; Molotov Takes Initiative In Attempt To Solve Troublesome Issue Of Italy's African Empire

By LOUIS NEVIN Paris, May 11.—(AP)—U. S. Secretary of State James F. Byrnes accepted today the Soviet Union's demand for \$100,000,000 in reparations from Italy, but added conditions which led to a clash with Soviet Foreign Minister Vyacheslav M. Molotov.

This was reported by an American source.

Almost the entire two-hour informal meeting of the four-power conference was devoted to the reparations issue as the ministers continued their review of disputed points in Italian peace treaty proposals in efforts to narrow down the area of disagreement.

Byrnes, accepting the Russian reparations demand, was reported by the American source to have said these must be obtained only from:

- 1. Italian assets abroad.
2. Excess industrial equipment in former munitions factories.
3. Merchant shipping.
4. Naval vessels.

Molotov promptly disputed the last point. He said naval vessels were legitimate booty of war and should be apportioned among the victorious powers as such, and not as reparations.

Byrnes retorted that booty could be claimed only by those who had captured it, and the Russians had captured no Italian naval vessels.

The positions of British Foreign Secretary Bevin and French Foreign Minister Georges Bidault could not be learned immediately.

A new informal session was scheduled for the afternoon, at which the conference was to continue discussion of the question of Italy's pre-war bi-lateral treaties. This discussion was begun just before the conference broke up this morning.

Two surprise Russian concessions paved the way for a possible break in the week-long deadlock which had brought the conference to the brink of failure.

The Russian concessions were made by V. M. Molotov, Soviet foreign minister, who agreed to withdraw his opposition to:

- 1. A French proposal allowing Italy to remain, as sole trustee under the United Nations, her pre-Fascist colonies.
2. A United States proposal providing for the establishment of an inter-allied commission to investigate and prosecute war criminals within Italy for a certain limited time after the signing of the Italian peace treaty.

Both issues were held open for additional discussion today, at a small, informal session in Molotov's office in Luxembourg Palace. It is the Soviet delegate's turn to preside.

French official quarters said they were encouraged by last night's meeting in which, they said, Molotov took the initiative in an attempt to settle the long-troublesome issue of Italy's African empire.

EYEWITNESSES VERIFY STORY OF ACCIDENT

Twenty-Seven Killed In Mid-Air Collision Of Two Giant Bombers

Pensacola, Fla., May 11.—(AP)—Eye-witness accounts of the collision and crash of two giant four-engine navy bombers which cost 27 lives corroborated the navy version of the accident in some details but were at variance with the official account in others.

Identification of the 28 naval airmen awaited notification of next of kin today.

The accident occurred during simulated fighter plane ticks north of here yesterday morning near Munson and the Florida-Alabama border.

Officials of the Pensacola Naval Air Station, where the men and the planes were based, gave this version in a formal statement issued last night:

The two bombers, identified at Navy PB-4Ys, were flying in a phase of training program with a Hellcat fighter craft. The bombers were turning to avoid a practice attack by the fighter plane when the lead craft was struck by the one flying high position.

One engine of the lead bomber was knocked out and the plane went into a spin and crashed. The other bomber flew straight ahead for a time, then also spun and crashed.

The Hellcat pilot, unidentified by navy officials, witnessed the accident and radioed for help.

Navy searchers found 14 bodies in one bomber and 12 in the other. Another body wearing an unopened parachute was found nearby.

An eye-witness to the tragic double crash, L. C. Cook, dispatcher for the State Forest Service at Munson, said the fighter plane was making runs on the bomber when he saw the planes roaring overhead.

Charles Brackline, 72-year-old farmer of Munson, asserted the smaller fighter plane struck one of the huge bomber's tail and that pieces of the larger plane filled the air.

He said the impact threw the stricken bomber into the second. The first plane exploded as it fell and the second caught fire and exploded after it crashed, he said.

Washington, May 11.—(AP)—John L. Lewis wants more safety for his coal miners.

That's one of his demands upon the owners. And the owners are agreed upon the need for efforts to promote safety.

The problem to be worked out: How? There is no uniform safety law.

From year to year Lewis has about 475,000 of his union members working in the mines. Last year 1,079 were killed and 59,350 injured. Those are government figures.

That was the lowest death-injured total for any year.

Every year for each miner killed about 50 are injured or crippled.

Each of the 28 states which produce coal has its own safety laws and its own inspectors. The laws vary from state to state.

The government's Bureau of Mines has 157 inspectors who check on the mines but can't enforce their recommendations to correct bad conditions.

Government officials familiar with mine conditions say: In some states the laws and the inspectors are good; in some states neither the laws nor the inspectors are so good.

He said this in explaining how the standards of mines and state laws vary.

One of Lewis' lieutenants complains that no state has standards good enough to match those of the government.

This is what the government inspectors can do:

They can go in and investigate a mine, make recommendations to the owner for improving safety conditions, tell the union what they've recommended, and even make public their recommendations.

But that's all. They can't compel an owner to put their recommendations into practice.

The states themselves can cooperate with the government's standards and suggestion, or not.

Last December 24 men were killed in a Kentucky mine disaster. Dr. R. R. Sayers, director of the Bureau of Mines, recently told a congressional committee:

"Our man had inspected that mine four different times and very few of our recommendations were placed in effect."

He said that mine where the disaster happened had "very bad conditions."

Sharp Falling Off In Prospective Wheat Crop Predicted In Report

Washington, May 11.—(AP)—The latest wheat crop reports delivered a sharp body blow today to any hopes of government food officials for removal of present curbs on domestic consumption of flour and wheat products.

Dry weather in the southwestern plains forced the Agriculture Department to revise its crop estimates downward from the 330,636,000 bushels forecast a month ago to the current prospects of a yield of only 742,887,000 bushels.

The 88,000,000 bushel drop in the crop outlook since last month also meant unwelcome news for famine relief program planners who need all the wheat they can lay their hands on to aid the hungry abroad.

Despite present forecasts, however, improved weather and other conditions still can make possible another billion-bushel wheat crop, but present indications are that the total supply available for the marketing season beginning July 1 may be 60,000,000 bushels short of the amount available during the current season.

REPARATIONS PLAN STUDIED

New Policy For Setting Price Japan Must Pay For War

By TOM LAMBERT Tokyo, May 11.—(AP)—Arrival here of Reparations Commissioner Edwin W. Pauley coincides with disclosure today by well-informed sources that official thinking in Washington is swinging toward "a more practical policy" on the price Japan will have to pay for losing the war.

The new thought on reparations involves establishment of production capacity levels which will enable Japan to start recovery "so that we won't have to take care of these people forever."

The source said the proposed policy, as yet unannounced and which has scuttled some reparations work done by the Allied command, includes setting up two production capacity figures—maximum and minimum.

The maximum capacity figure, based on wartime production, is one the Japanese economy will be judged incapable of sustaining now.

The minimum, which will not be scaled lower, is a level of economy which Japan will be judged capable of maintaining within her own four islands.

Such policy would enable the Japanese to know what their production totals can be and would encourage resumption of industry by Japanese now timid about starting for fear their facilities might be taken for reparations.

The establishment of such minimum figures would not preclude tight controls on such major industries as steel, petroleum, light metals and chemicals—all of which are war potential.

The Far East Commission, which one source accused of being "laggard" on reparations policy, is known to want to send inspection teams to Japan to check reparations claims which will be entered by various victory nations. The source termed these claims "highly inflated."

AFL LEADERS OPEN MEETING IN ASHEVILLE

American Federation Of Labor Officially Launches Drive In South

Asheville, May 11.—(AP)—The era when the south attracted industry through the lure of low wages has just about vanished, according to the southern chief of the American Federation of Labor.

George Googe of Atlanta, discussing the rapid industrialization of the south at a news conference, declared that:

"Most of the new industries coming to the south today expect to pay decent wages and find union conditions."

He said chambers of commerce are no longer advertising low wages, except "possibly in some isolated sections of Mississippi."

Googe banned a gavel today and opened a two-day conference of southern AFL leaders in the city auditorium here. It was the official launching of the AFL southern organizing drive.

The chubby Googe, who bears no higher title than "AFL southern representative," but is a power in Dixie labor circles, will direct that campaign. The CIO also is making a drive for more southern members.

At the conference here, President William Green and other AFL big-wigs will speak. Attendance has been cut drastically by the coal strike. Googe said 8,000 delegates would have attended, but that several thousands were unable to come because the coal shortage has canceled special trains and chartered pullmans.

Googe's statements about southern industry were made to a group of reporters last night.

One asked him whether southern employers are "looking toward the AFL because they prefer it to the CIO." Googe replied carefully:

"I will say that southern employers are intelligent. For the last ten years they have been studying trade unions more than any other one subject. Our experience has been satisfactory on the whole, and in the majority of instances, employers have been very friendly. This doesn't apply to every industry. For example, the textile industry doesn't want unions."

Babson Park, Mass., May 10.—Compared with any other land on earth, we the people of North America, now are sitting on top of the world. Relative to any former period, we today have the greatest opportunity, both as to current conditions and future prospects. When you tune out the radio croaking, long enough to attend to solid facts and figures, you sense the speed of recent reconversion. The outlook is much brighter than some of the out-lookers.

Need Less Gripe and More Grip

During the recent big strikes there was an interval when a little griping by me and others was, perhaps, excusable. It was a kind of Monday Morning, a natural let-down after the victories of 1945. That period of indulgence, however, has gone, and I recommend that the time has come for all of us to cut out the crabbing and resume business. Despite the actions of labor leaders here at home and of Russian leaders abroad, the situation, fundamentally, is cheerful. Today, the chief cause for complaint is the chronic complaining.

New Highs Ahead

After the V-Days, Washington prophets forecast dire unemployment. They were wrong. Furthermore, instead of sagging, retail trade has soared, brick even in strikebound areas. Over-riding the shortage of goods and stoppage of output, business vitality has defied the gripe mongers. Ample buying power points to still further expansion.

Let's Blackout Those Blues

This country has been chosen as the site of the future UN World Capital. In the light of this honor, it is particularly important that America should regain its ancestral fortitude. In some misguided moments, it may have appeared that America had switched its national emblem from the eagle to the crab. This our mood must lift. Instead, we should make the most of the unprecedented opportunities. To capitalize to the full our abundant material and spiritual resources, we need the positive formula: Rather than crabbing about yesterday, let us count our manifold blessings for tomorrow.

World Looks To U. S. For Morale

This need for a more constructive spirit is doubly true in view of the new role of the U. S. in world affairs. UN leadership will not be won by formal diplomacy, but by the daily attitude which our people demonstrate. What would our international status become if measured by today's chorus of self-condemnation? Our global standing will not be helped if the U. S. becomes known throughout the world as Uncle Squawk instead of Uncle Sam.

LONG HUNGER STRIKE FATAL

IRA Man Dies After 23-Day Fast; Demonstrations In Ireland

Dublin, May 11.—(AP)—John McCaughey, 32, tight-lipped former Irish Republican Army "Adjutant General" died in his cell at Dublin's Mariboro prison early today after a 23-day hunger strike which caused political agitation throughout Eire.

In Belfast, David Fleming, another imprisoned IRA hunger striker, was reported in a "weak condition" as his fast entered its 50th day, but Dr. Fred McSorley, a Nationalist member of Parliament who visited Fleming yesterday, said he showed surprising vitality and probably would live "for many many days yet."

McCaughey, whose brother and four sisters were with him when he died, apparently kept silent to the end. He had refused to defend himself when a special Dublin military court sentenced him to death in 1941 for kidnapping and illegally assaulting another IRA leader, Stephen Hayes.

The death sentence was commuted to life imprisonment following a nationwide appeal for clemency.

His case had become a national issue and in the past three weeks, numerous Dublin mass meetings demanded his release. Thursday night mounted police broke up what they termed an attempted attack on Eire President Sean T. O'Kelly by 390 angry demonstrators.

Miners And Operators Reopen Soft Coal Negotiations; Truman Notifies Congress He Wants An Agreement In Next Four Or Five Days; Emergency Regulations To Continue

Washington, May 11.—(AP)—John L. Lewis re-entered the soft coal negotiations today as miners and operators sought to push on through a permanent settlement during a two-weeks strike truce.

Lewis, boss of the United Mine Workers, who had attended briefly one session with the operators this week, arrived early for today's meeting.

Prodded by President Truman to reach an early agreement, Federal Conciliator Edward McGrady said the conferees agreed to meet daily and vote each afternoon whether to continue into the night. They will decide this afternoon whether to meet Sunday.

President Truman put both the United Mine Workers and pit owners on notice that he wanted them to work out an agreement in the next or five days on a new contract.

The truce in the 40-day walkout materialized unexpectedly on Lewis' initiative yesterday. Its effect is to send the miners back to work Monday until May 25. In that time it is estimated that they can produce 25 million tons of coal, and gauging by the pre-strike weekly output of approximately 13 million tons.

The operators agreed to the truce proposal somewhat dubiously, emphasizing that differences were far from settled in regard to Lewis' demand for a royalty-raised health and welfare fund for his miners. This is the demand that has proved the big stumbling block in contract negotiations to date.

The White House reported that Lewis and a representative of the operators agreed, at a conference with Mr. Truman yesterday, on the principle of a welfare fund but differed on the manner in which it would be financed and administered.

First indication that the government did not intend to relax major emergency regulations came from the solid fuels administration which said distribution of the coal mined in the next two weeks will remain under its control.

The Office of Defense Transportation, which has embargoed all coal shipments, said food fuel and other essentials, said a decision on future rail movements will be made today.

On Capitol Hill, the truce agreement failed to bring any slackening in heavy Senate pressure for speed action on new legislation to cope with major labor disputes. The chamber, by a 66-9 vote yesterday made the subject its first item of business when it reconvenes Monday.

The WORLD TODAY

An Analysis Of The News

By DEWITT MACKENZIE Whether Winston Churchill's idea of a "United States of Europe, both of the East and of the West" materializes as a goodwill measure of peaceful collaboration, the indications are that the Old World will in any event be divided into two blocs—friendly or otherwise.

As I pointed out in yesterday's column, one bloc already has been formed in main, and that is the new Russian zone of influence which blankets most of the countries of eastern Europe and the Balkans. The logical corollary to that will be a western bloc of nations which will combine because of their special community of interests, including a democratic form of government that is at variance with the Soviet totalitarianism.

Naturally the fact that there were two groups of nations wouldn't ipso facto mean that they must be at logger-heads. Mr. Churchill's "United States of Europe, both of the East and of the West," under the guidance of a world organization, would be calculated "to unify this continent in a manner never known since the fall of the Roman Empire."

That would be the ideal. The cold reality is that nobody can say now what the relations among the Old World nations will be in the Europe of tomorrow. We cannot determine that until the realignment of the zones of influence has been finished—or at least until it is clear how great a change is contemplated.

The great unknown quantity at the moment is Russia's program. Moscow long ago made it quite clear that the Soviet Union was determined on extending its sphere of influence to the line from Stettin in Northern Germany southward along the eastern borders of Poland, Czechoslovakia and Austria to the Adriatic. The Russians also have emphasized their intention of having access to the Mediterranean. Broadly speaking, after we have noted these facts we get a dim-out.

The question agitating United Nations diplomats is how far Russia intends to try to expand. Lack of information on that vital point is one of the chief causes of all the troubles which have been bedeviling the Security Council of the United Nations and the unhappy conference of Big Four foreign ministers in Paris.

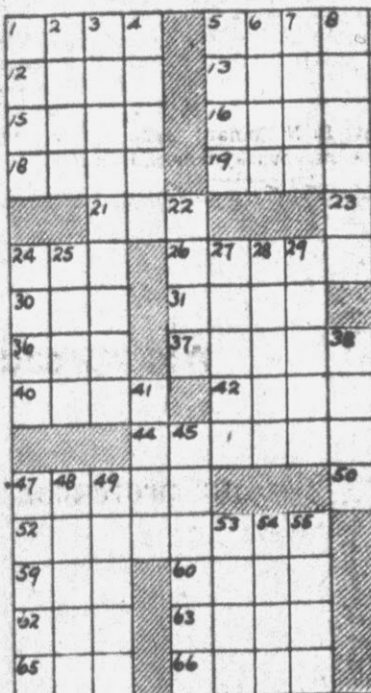
Refires After Long Ministry

The same Lewis lieutenant mentioned above suggested this is a possible means of imposing uniform safety upon the mines:

Congress should pass a law forbidding coal to be shipped across a state line from any mine which has failed to meet federal standards.

All mines then would have to get in line, he said because they have to ship across state lines to do business.

Meanwhile, Lewis will go to the pit with the owners over higher pay for his miners. He still hasn't said how much he wants.

The pay for miners under the contract which expired before they struck April 1 called for this:

For a 54-hour week—\$63.50. It was worked out this way:

Their regular working week is 35 hours. They get \$1 an hour for 35 hours and \$1.50 for every hour over that.

So, by working a 54-hour week, they'd receive \$35 for the first 35 hours and \$28.50 for the other 19 hours. Total: \$63.50.
