SENATE TAKES UP SELECTIVE SERVICE BILL

Pay Increase Appears Certain; Vote Nearing On Extension Of Draft

Washington, June 4.—(AP)—The Senate gingerly set itself today for a new try on deciding the future of the draft, but the only advance agreement was that those in the armed forces should get more money.

Senator Gurney (R-SD), floor leader for a proposed extension of selective service until May 15, 1947, told a reporter both House and Senate are certain to approve a pay increase proposal.

Senator Wherry (R-Neb), Republican whip who wants to suspend all inductions, said a majority of the Senate is agreed upon pay increases.

And Senator C. J. Johnson (D-Cole), who wrote the stopgap extension under which selective service is operating until July 1, said the only argument on pay is as to the amount.

Gurney made a long speech in favor of continuing selective service until May 15 of next year, with draft of 18- and 19-year-olds, now excluded from inductions by demands of a House majority.

Senator Vandenberg (R-Mich) noted the lack of peace treaties with Italy and Austria and observed that our armed forces in Europe had been cut to a very dangerous minimum.

Senator Smith (R-NJ) announced he favored the extension including induction of teen-agers even though this would include his own 18-year-old grandson.

Only one Democrat, Maybank of South Carolina joined these three Republicans in support of the extension, and Gurney surprised the Senate by suspending further action until today.

Off the floor, Gurney told reporters he had not intended to try for a vote yesterday either on the extension bill or any of a score of pending amendments.

Wherry said he expected strong support for a substitute he is now pressing jointly with Senator Reynolds (R-WVa). It would continue the selective service machinery.

Reynolds Denies Wife's Charges

Winston-Salem, June 4.—(AP)—R. J. H. (Dick) Reynolds, multimillionaire sportsman and former treasurer of the Democratic National Committee, denied yesterday his wife's allegation that he was a "nifty" person to have custody of his children.

In an answer to Elizabeth Dillard Reynolds' separation suit, Reynolds contended however, that she was a "proper" person to care for the children while they are young. He filed a divorce suit in Miami last week a few days after Mrs. Reynolds instituted an action here for separate maintenance and alimony.

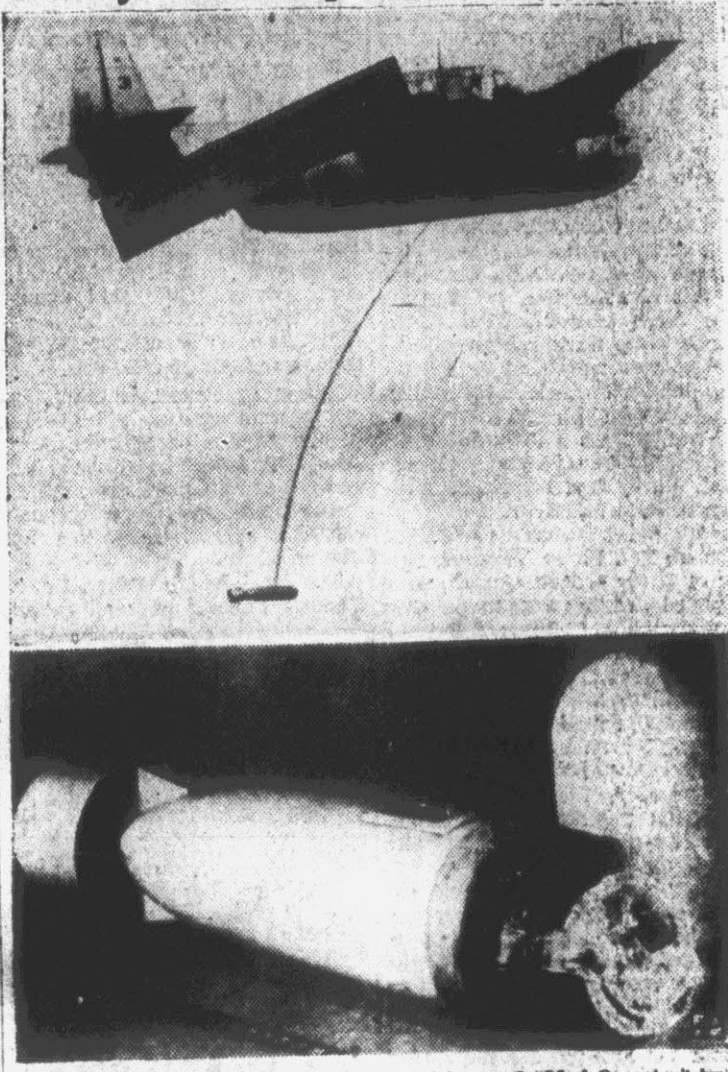
The former Winston-Salem mayor and wartime Navy officer also set forth that: He had not deliberately committed acts to embarrass his wife, as she alleged.

He did notify certain stores not to sell additional merchandise on his credit, but other stores were permitted to extend credit sufficient for the needs of her and their children.

He did not abandon his family after leaving the Navy last fall, as she charged.

At that time he told her he intended to get a divorce but was ready to make suitable financial arrangements.

Ernest Bevin Asks U.S. To Stand Firm

Decries Russian Rejection Of Byrnes' Proposed Treaty; Pleads "Do Not Be Dunted By The First Refusal"

London, June 4.—(AP)—Foreign Secretary Ernest Bevin addressed a warning appeal to Russia today that "if you value peace above all do not miss it. It may never come again."

The blunt diplomat, opening a foreign policy debate in the House of Commons, declared that permanent peace in Europe can be guaranteed "only if Russia enters freely into the European settlement."

He appealed to the United States to remain undaunted by the Russian rejection of Secretary of State Byrnes' proposal for a 25-year treaty to keep Germany and Japan disarmed, saying:

"The rest of us in Europe, at least, not only welcome this proposal but look upon it as giving the greatest possible hope for the removal of misunderstanding and the creation of confidence. It was a matter of profound regret to witness the way it was received by the Soviet representatives" at the recent conference of leading foreign ministers at Paris.

"If I can make one great appeal to the United States," he said, "it is this: Do not be daunted by the first refusal, in my view, to a unjustified suspicion."

Bevin expressed regret that "all through Russian speeches and writings" runs the "idea that the Russian methods alone represent democracy and that certain other systems are either Fascist or crypto-Fascist."

"This is one of the greatest obstacles to peace," Bevin declared in a speech opening a full dress debate on foreign affairs. The debate will continue for two days.

CIO Maritime Leader Hints New Concessions

Conciliation Conference Making Progress; Navy Pushes Mobilization To Run Merchant Fleet If Called Upon

Washington, June 4.—(AP)—A hint of new union concessions toward settlement of the threatened maritime strike on June 15 came today from President Joseph Curran of the CIO's National Maritime Union.

As the navy started mobilizing to run the merchant fleet if necessary, Curran told reporters that a compromise 42-hour week proposal "is our latest but not our last offer."

He did not elaborate, but another spokesman for the union gave this follow-up explanation: "We're prepared to avert a strike. We don't want a strike. We're willing to compromise and sign a satisfactory agreement. The point is, what is satisfactory."

Originally the union asked a 40-hour week at sea instead of the present 56 hours, demanding that each ship carry ten relief workers. Employers said this would be an insupportable burden making it impossible for American ships to compete with foreign lines. The new offer cuts the relief crew to eight, but still leaves a wide gap between the union and employer positions.

Federal conciliators are pushing for settlement of the NMU's demands, hoping this would set a pattern for the six other unions wrapped up in the committee for maritime unity (CMU).

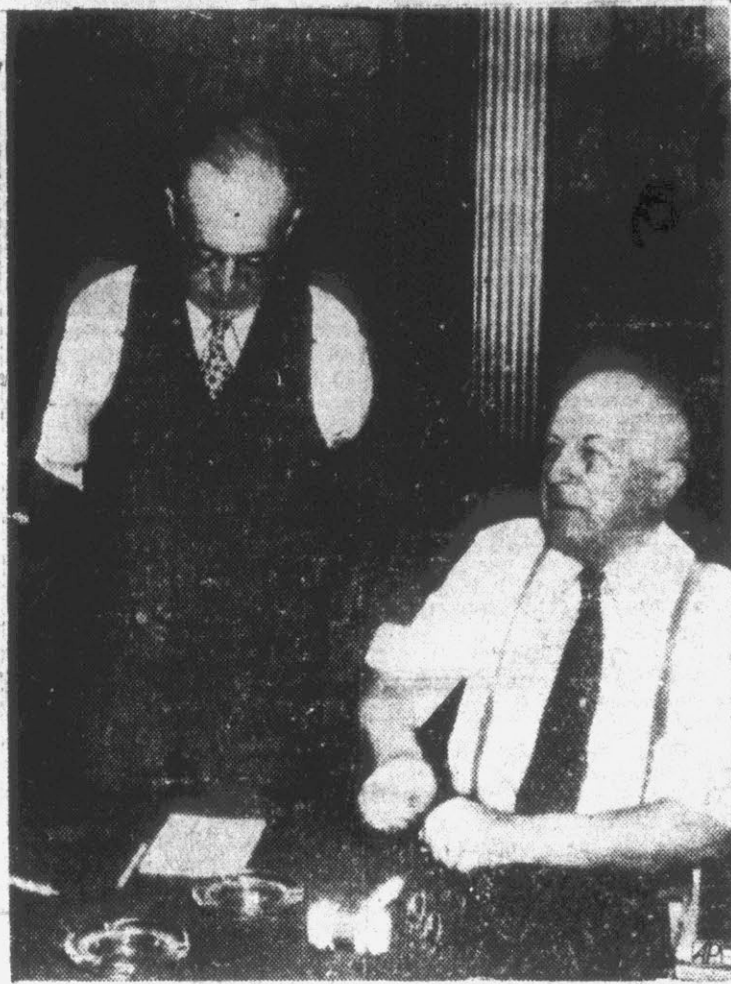
The conciliation conference took its first peek into the demands of west coast seamen today behind closed doors, with no results immediately reported. Meanwhile the government took preparatory steps to run the nation's 8,100 merchant ships if the mid-June deadline goes by without settlement.

Naval stations were ordered to comply their personnel for men with experience in the merchant marine, and also to line up volunteers among discharged navy men.

With time slipping away, ship operators and CIO leader Harry Bridges and Curran were negotiating day and night at the Labor Department.

Last night's session did not wind up until 15 minutes after midnight. Then U. S. Conciliation Director Edgar L. Warren told newsmen: "I. That a temporary deadlock forced the negotiators to turn away momentarily from the issue of a shorter work week for seamen of the CIO National Maritime Union and take up instead one of many issues—the number of electricians each ship could carry. The snag over hours developed after the union made two new offers and the (Continued on Page Four)

NO SUCCESSOR YET NAMED TO U. N. COUNCIL

Stettinius' Resignation Leaves Truman Task Of Finding New Replacement

Washington, June 4.—(AP)—President Truman today faced the exacting task of finding a new United States representative to the United Nations.

He once described the post as one of the highest and most important within the gift of the nation, and it was with obvious reluctance that he accepted the resignation of Edward R. Stettinius, Jr. late yesterday.

If the President and Secretary of State Byrnes had any successor to Stettinius in mind last night, some of their top aides did not know it. In fact, there were indications the two men had not even started surveying possible candidates.

One of these was a premature announcement by Byrnes through a press officer that Stettinius would continue for the time being. The State Department later corrected itself, saying the resignation would take effect immediately.

Herschel Johnson, a career diplomat who has served as deputy to Stettinius, will fill the U. N. seat temporarily.

Another indication that no replacement for Stettinius had been decided on was Mr. Truman's revelation that as late as yesterday morning he had hoped to persuade the white-haired, 45-year-old former Secretary of State to withdraw his resignation.

Much of the speculation about a successor centered about John G. Winant, former Republican governor of New Hampshire, who recently completed a six-year assignment as ambassador to Britain. Winant now is U. S. representative on the U. N. Economic and Social Council.

Others mentioned are Undersecretary of State Dean Acheson and Joseph E. Davies, former ambassador to Russia and Belgium.

RULING SAID REGRETTABLE

Court's Decision Called Boon To Ku Klux Klan's Growth

Atlanta, June 4.—(AP)—A statement by a governor that "it's fertilizer for the Ku Klux Klan" topped official Southern comment today on the Supreme Court's ruling against segregation on inter-state buses.

The statement came from Gov. Chauncey Sparks of Alabama, the first Southern governor to comment. Other officials who commented termed the court opinion "regrettable."

While the South wondered what the extent and effectiveness of the court decision would be, Rep. Wood (D-Ga.), chairman of the House Committee on Un-American Activities, said in Atlanta:

"The threat and intimidations of the Ku Klux Klan are an old American custom—just like illegal whiskey making."

Rep. Wood's comments were not in connection with the court's decision, but were made in an interview in which he told newsmen his committee had no intention of investigating the revived Klan.

In Georgia long regarded as the "home" of the Klan, Gov. Ellis Arnall has the State Legal Department preparing court steps to revoke the Klan's charter. It also faces a federal claim for \$700,000 back taxes.

Generally, official comment was immediately lacking on the anti-Jim Crow decision, but it particularly created a stir in Georgia, which is in the midst of a torrid gubernatorial campaign.

With its poll tax abolished only last year, and virtually no voting restrictions, Negroes are registered to vote for the first time in great numbers in the July 17 Democratic primary.

Talmadge, however, asserts that if he is elected the recent Supreme Court decision on negro voting can be circumvented by removing the primary from state resolution—as has been done in South Carolina.

Allied Chief Prosecutor Opens War Crimes Trial In Tokyo By Branding Militarists As Assassins And Common Felons

Tokyo, June 4.—(AP)—War-starting Hideki Tojo and 25 other deposed Japanese militarists today were branded "assassins" who ruled the "most treacherous and perfidious nation" of all time and who sought to dominate the world.

Chief Prosecutor Joseph B. Keenan made the charges in a 15,000-word opening statement at their war crimes trial before a 10-judge international military tribunal.

Keenan said that ever since 1904, when Japan sprang a surprise attack on Russia at Port Arthur that the entire world realized such action "is intolerable."

The Florida American prosecutor described the defendants as "common felons who deserve and will receive the punishment for ages meted out in every land to murderers, brigands, pirates and plunderers."

He said that Pearl Harbor, Hong Kong and Mukden "are all part of one grand pattern, and the vice of it consisted in the exhibition of utter contempt for the lives of blameless and helpless individuals all over the world."

Tojo and the other defendants, sitting in the brightly-lit prisoners' dock, listened intently through headphones to a translation of Keenan's charges.

Keenan noted for flights of oratory, delivered the entire 15,000-word statement in quiet tones. After he finished, court recessed until 3:30 p. m. to permit defense counsel more time to prepare its case.

He said he would prove Japanese air attacks on the United States and British gunboats Panay and Ladybird, were "evidence of wanton, reckless disregard for life and property and a demonstration to the Chinese people of the power and efficacy of Japanese arms."

He indicated a prosecution plan place individual blame when he said that during hostilities murder was so widespread that it must be as (Continued on Page 5)

Milling Industry To Feel Wheat Shortage

Washington, June 4.—(AP)—The pre-harvest wheat shortage will force the nation's milling industry to bump along at only partial capacity all during June.

This situation prevails despite a government offer to lend mills wheat from foreign relief stocks until the new crop becomes available in July.

The loan decision was announced even as senators heard advice from the Millers' National Federation yesterday that 98 per cent of all flour mills in the country would be forced to close by tonight.

To avoid any prolonged shutdown the Agriculture Department said it will make wheat available both to relieve domestic bread shortages and to produce flour for export.

But officials said the total quantity of grain which the government will be able to lend will be far from sufficient to keep all mills at full capacity until the new crop is available.

A POPPING FIRE
Kansas City, June 4.—(AP)—Fire broke out in the home of Leslie E. White Jr., spare-time hunter.

Neighbor Eugene Holman rushed to it with his garden hose. When firemen arrived they found the fire nearly out. All of White's shotgun and rifle ammunition—he had 1,100 rounds stored in the basement—exploded, and Holman busy spraying among the flying bullets and shots.

Inaugurated

Buenos Aires, June 4.—(AP)—Juan Domingo Peron was inaugurated as Argentina's 29th president today.

The 50-year-old army officer took the oath of office before a joint session of the chamber and senate, declaring:

"By God and country I swear faithfully to fill the office of president and if I fail, God and country can judge me."

He then drove through heavily guarded streets to the presidential offices, where retiring President Luis M. de Alvear, declared to him the staff of office and the presidential insignia of a blue and white ribbon. Farrell then left the Casa Rosada and Peron assumed his duties.

Peron's inauguration returned Argentina to a constitutional form of government for the first time since the military revolution three years ago. A series of military governments have ruled since that time.

N. Y. POLICE GRAFT PROBED

Mayor Orders Inquiry Following Columnists Bribe Charges

New York, June 4.—(AP)—The police department undertook today a sweeping investigation into the charges that members of the department were accepting huge bribes from bookmakers in the most cynical grafting spree in New York history.

The probe followed an order by Mayor O'Dwyer that the department clean its own house after New York Daily News columnist Ed Sullivan charged in his column yesterday that police detectives were receiving payments from bookmakers ranging from \$1,700 per bookmaker phone-per-month to \$3,000-per-month.

Control Of Atomic Research Impossible

New York, June 4.—(AP)—The United Nations subcommittee investigating Spain declared today that exclusion of Spain from the U. N. rendered impossible a really effective system of international control of atomic energy.

It recommended that if a freely elected Spanish government succeeded Generalissimo Franco's regime, its application for U. N. membership should be considered favorably.

The subcommittee made its statement in a supplement to a report calling for General Assembly action against Franco Spain. The supplement was handed out at a news conference by Dr. Herbert V. Evatt, chairman of the subcommittee and Australian delegate to the Security Council.

Does Russia Want War

Russia Wants No War, Says AP Correspondent Gilmore After Five Years in Moscow; Not Prepared For It In First Place, But Fearful Of Anti-Soviets Abroad

(Advance) . . . New York, June 4.—(AP)—Just back in the United States after almost five years in Russia as a correspondent is struck and startled by the questions he is asked about the possibility of war with Russia.

"Tell me," said a young man just out of the army, "should I go and recall that you've seen me living in Russia a long time. Aren't they about ready to fight us?"

You get similar questions from middle aged businessmen, club women, housewives, laborers, policemen, the inevitable taxidriver and so on.

Having lived outside the United States for more than six years now, it is very difficult to understand the urgency of such questions and thoughts about Russia going to war.

If five years in a country means anything, it lengthily daily conversations with diplomatic persons in Moscow who have talks with Russian leaders have their worth, if having a Russian wife, knowing dozens upon dozens of just plain Russians as well as a smattering of the party faithful should be contributing factors in helping to understand the Russian mind and attitude of a people, then the only possible answer is:

As sure as there's a face on the Kremlin clock and Joseph Stalin has a mustache the Russians do not want to fight anybody. (Continued on Page Four)

(Substituting for James Marlow) Washington, June 4.—(AP)—The health of American soldiers during the war just ended was better than during the first World War, latest figures from the Army Surgeon General's office show.

Statistics on disease incidence for the army up to the first of this year were shown to reporters yesterday in a pre-view of an exhibit to be presented to the American Medical Association in San Francisco next month.

Figured on a basis of per thousand and troop-strength per year, the record shows:

The overall disease rate was 649 in World War II, compared with 852 in the first World War; and the death rate from disease was 0.62, compared with 41.6 in the last war.

Battle wounds and injuries took the same toll in each war—112 out of every 1,000 combat troops per year—but the statistics for diseases were as follows:

Common respiratory diseases, 167 cases per 1,000 men a year, compared to 825 in the last war; venereal disease, 48 to 87; mumps, 4.8

to 56; measles 8.1 to 24; diarrheal diseases, 21.4 to 22; pneumonias 10.9 to 19; tuberculosis, 1.1 to 9.4; scarlet fever, 1.2 to 2.1.

The incidence of malaria was much higher in the recent war than in the first World War, the figures showing 18.9 compared to 8.8 in the last war.

Surgeon General Kirk, at a news conference held during the exhibit, disclosed proposed plans of his department to establish an "army medical research and graduate training center" at Forest Glen, Md.

He said he envisioned it as a national research institute which may give the general public, the Veterans' Administration, and the medical profession—as well as the army itself—the benefits of army medical research. The program must first be approved by the War Department and by Congress.

Kirk said his department also hopes for ultimate establishment of a school of "global medicine"—a science born of global warfare as American troops pushed into remote corners of the Arctic and the tropic and encountered little known

An Analysis Of The News

We should not miss the significance of the French general election and Italy's plebiscite to determine whether that country shall have a monarchy or a republic.

These are no ordinary events, for basically they represent major battles in the drive by Communism to control western Europe, as it already does the eastern part of the continent.

In France the Red forces have been unseated as the strongest party by a move of the country's voters towards the right. The Italian returns are still too incomplete at this writing to permit of any accurate estimate of the way the tide runs.

Of these two, the French elections are more important in determining the political future of Europe—perhaps of the whole world for that matter. A totalitarian Communist government in Paris would go far towards giving Russia domination of Europe clear through to the English channel. The present swing towards the right—though not great—moves France further

from dictatorship and closer to the Western Democracy of America and England. While Washington officially was silent, government officials expressed much gratification at the turn of events.

What has happened in France is this: The last government was a coalition comprising Communists, the popular Republican movement (which is middle-of-the-road politically) and Socialists, whose respective representations in the Assembly were 159, 150 and 146. There are, of course, other smaller parties.

The Assembly drew up a new constitution, the framing being dominated by the Communists and Socialists. This was submitted to a national referendum on May 3 and was rejected, necessitating the election of a new constituent assembly, which has now taken place.

The rejection of this constitution was a rebuff to the tendency towards totalitarianism. The present election reaffirms that viewpoint. The popular Republican movement (MRP) now has the largest (Continued on page four)

Umberto Appears Losing Election

Rome, June 4.—(AP)—Forces favoring the establishment of a republic appeared to be building up a commanding lead today as Italian officials completed the tabulation of approximately one-quarter of the votes cast in this nation's two-day elections.

A semi-official tabulation of approximately 10 percent of the 25,000,000 votes estimated to have cast showed the republic leading the monarchy almost two to one.

In addition, results from 25 percent of the ballots cast in the concurrent voting for a constituent assembly showed the middle-of-the-road Christian Democrats, headed by Premier Alcide De Gasperi, in first place with the Communists and Socialists battling it out for second.

It was emphasized, however, that most of the reported vote was from northern industrial Italy, republican stronghold, and that the aerial to the House of Savoy, could upset the calculations.

Umberto Appears Losing Election

Italy's monarch, King Umberto II, is expected to leave the country for the United Kingdom today, according to reports from Rome.

The king is expected to arrive in London today, where he will be met by the British ambassador. He is expected to remain in London until he can be escorted to the United Kingdom by a British aircraft carrier.

Big Toll Expected In Eastern Earthquake

Istanbul, Turkey, June 3—(AP)—Government officials declared today that the earthquake which devastated parts of East Turkey Friday probably killed 500 persons.

Village after village fell flat in the provinces of Mus and Erzurum, said Pezzi Kansalig, deputy for Erzurum.

Planes were pressed into service to move food, medicine and other supplies into the stricken area.

The community of Ustkran alone reported 200 killed, and the toll may be double that after the ruins are searched. Only two houses were left standing.

Rescue work was exceedingly slow because of the wide area of the quake, reported continuing with infrequent light shocks.

The stricken area is just west and north of the Lake Van district, that had been shaken frequently, but some dwellings were destroyed with great violence.

Turkey's last large earthquake killed 1,000 persons in 1943. The country's worst quake was at Erzincan in 1939 when an estimated 30,000 persons died.

Roxas Addresses Island Congress

Manila, June 3—(AP)—President Manuel Roxas asked the Philippine Congress today for authority to reorganize and streamline a 11 government offices and bureaus and proposed an offensive against inflation, lawlessness and economic inaction, financed largely by American loans.

The new president, reading a 15,000-word "state of the nation" message to a joint session of Congress disclosed he had asked the U. S. for a rehabilitation loan of 500 million pesos. The U. S. has already been asked for a loan of 800,000 to cover expected government deficits of the next five years.

Roxas' message, one of the most comprehensive and drastic ever presented a Philippine Congress, also called for higher taxes, new rights and responsibilities for organized labor, strong wage, price and rent control, and an army of 12,000 plus an expanded state police force. In addition, Roxas asked establishment of a national rehabilitation authority to direct reconstruction and a strong budget to pass on all public expenditures.

Vice-President Elpidio Quirino announced meanwhile that the budget for the fiscal year 1946-47 totals 250,000,000 pesos. A loan now being negotiated with the U. S. was expected to provide 193,000,000 pesos of the total, he added.

Philadelphia Police Seek "Thrill" Gang

Philadelphia, June 3—(AP)—Five young men and three giggling girls described by police as apparently out for thrills as well as money, engineered four holdups early today.

Two young men searched victims to obtain loot valued at less than \$200, while the girls sat in the car and three other boys either waited in the machine or stood beside it as lookouts. The holdup band always outdistanced police patrol wagons scouting the northeast Philadelphia area, sometimes turning corners on two wheels.

Adolph De Souza said one man held a pistol in his stomach and another put a knife to his neck while they robbed him, adding:

"All of the time I could hear the girls giggling in the maroon colored automobile."

WASHINGTON DAYBOOK

By JACK STUBBS

Washington—The 79th Congress is nearing the end of the line—and it probably will reach there with more work undone than any other Congress in a generation or so.

The tentative date for the adjournment is around July 1. Do not think for a minute that it will be much after this. Twenty-five states for certain, 29 probably, will have their primary elections or nominating conventions after July 2. That means that in over half the states 45 congressmen, 35 senators and incidentally 34 governors will have to do their main campaigning back home in the four months preceding Nov. 5.

That leaves a matter of weeks for the Congress to act on what the administration has designated as vital legislation. Something will be done about extension of OPA, whether it's satisfactory or not to the White House. Something will have to be done about extension of the draft. The appropriation bills will get enacted—a little hurriedly perhaps, and without too much argument. Observers on the Hill feel pretty confident that something will be done about the British loan. Something in the way of emergency housing may be forced over.

When Congress gets down to its last minute work, things do get done. But they don't always get done by an antagonistic Congress the way the administration would like to have them done. And the only whole, real program before the 79th Congress is that laid down by President Truman.

The Republicans and the Insurgent Democrats have come around on a few issues, but not many. The Army-Navy Merger bill, reported out by the Senate Military Affairs Committee, may die in the Naval Affairs Committee. The Fair Employment Practices act is already dead. The vitally important Atomic Energy bill still is being kicked around. Emergency housing legislation still is a political football. But these, with the exception of FEPC, have a chance.

Universal military training, minimum wage legislation, presidential succession, and about a dozen more of President Truman's legislative suggestions will have to be passed over. Time won't permit action on them.

In the next few weeks, bills will be passed hand over fist, but not many of them will be the controversial measures the President laid before Congress nearly a year before adjournment.

The finish of this 79th Congress

will be interesting to watch. Observers here are positive that it may have more bearing on the coming elections than any since that in 1930, when "Wall St." had dumped so many problems in the legislative laps.
