Austrian Demand Is Turned Down

Big Four Rejection Claim For Part Of Italy's Southern Tyrol; No Agreement Reached On Italian-French Border; Internationalization of Trieste May Result From Talks

Paris, June 24.—(AP)—An American informant said the Council of Foreign Ministers rejected today Austria's demand to take part of the Southern Tyrol from Italy but was unable to agree on the Italian-French frontier issue.

The Austrian demand would have given the new republic control of the strategic Pustertal Railroad.

The ministers met for an hour and a half during the morning.

The United States, Russian, British and French foreign ministers planned to discuss the Italian-French border late today.

The French have demanded and received tacit approval at previous conferences for minor adjustments in the Alpine region.

Disposition of surplus Italian naval units also was on the afternoon agenda.

Foreign Minister Molotov of Russia was declared to have sought a postponement of the French-Italian frontier issue while the American and British conferees insisted on an immediate decision.

Hope for solution of the troublesome Trieste problem, key to the Italian peace treaty, mounted today amid reports that the British, American and Russian delegations to the Foreign Ministers Council were considering a compromise plan put forward by France.

While nothing official was announced concerning the plan, it was reported that France had proposed that the disputed Adriatic port of Trieste be internationalized for a period of 10 years, after which a plebiscite would be held to decide whether the city should go to Italy or Yugoslavia.

It was understood that Georges Bidault, French provisional president and foreign minister, advanced the plan at a closed session last Friday, when the foreign ministers were re-examining the Italian-Yugoslav border issue.

It was not clear from unofficial reports of the French proposal how the compromise, if adopted, would affect the Italian-Yugoslav border question.

VINSON SWORN IN AS CHIEF OF TRIBUNAL

Thousands Watch Colorful Ceremony As Stone's Successor Takes Oath

Washington, June 24.—(AP)—Fred M. Vinson became the nation's 13th chief justice today at a colorful ceremony on the south portico of the White House.

Thousands watched the ceremony from the sun-bathed lawn to the rear of the mansion.

In solemn tones, Vinson declared "I do, so help me God," in facing each of the customary two oaths.

President Truman declared that Vinson's appointment as the 13th chief justice was "lucky for the United States and lucky for Mr. Vinson," and added, "I hope it is."

The entire ceremony lasted nine minutes. Before Vinson, seated in a dark blue suit, stepped out on to the portico to be sworn in, a navy band played "Pomp and Circumstance."

This set the pattern for the unusual ceremony, which was planned by Mr. Truman to rival in role or a presidential inauguration.

Drop Practice Bomb In Bikini Dress Rehearsal

B-29's Bombing Crew Score Hits On Target Fleet; Air Force Captain Killed By Propellor Just Before Take-Off

Aboard B-29 circling Bikini, June 24.—(AP)—The B-29 crew scheduled to drop the atomic bomb in a few days outgassed the weather today and scored "good" results with a practice bomb—after their plane's propeller killed an Army air forces captain just before the take off.

Ma) Gen. Roger Ramey of Denton, Tex., who rode the B-29 that dropped the practice bomb today, said:

"The Queen's day mission from an air operations point of view was apparently satisfactory. Final judgment depends on photographs and reports."

(From the U.S.S. Mt. McKinley, Associated Press Correspondent Elton C. Fay quoted the atomic bomb task force commander, Vice Adm. W. H. P. Blandy, as saying that the experiment was "swell" and that the real show is as good as the rehearsal.

Clouds obliterated the target ships in Bikini Lagoon when the B-29, piloted by Maj. Woodrow Swancutt of Wisconsin Rapids, Wis., made its first run. But the time the big plane came around again, the bomb-

ardier, Harold H. Wood of Borden-town, N. J., was able to take advantage of shifting clouds to drop his practice bomb within thirteen seconds of the scheduled time.

(Fay aboard the Mt. McKinley said the bomb went off "like a ball of orange flame bursting close to the target ships" in the Bikini fleet that is to be used on or about July 1, when the world's fourth atomic bomb actually is dropped. The Mt. McKinley was 10 miles away, but Fay said the bomb apparently went off at an altitude of 1,000 to 1,500 feet between the old battleship, USS Nevada, and the light carrier, Independence.)

Before Maj. Swancutt's plane, "Dave's Dream," took off, an Army air forces captain walked into a propeller and was killed. Members of the crew helped place his body in an ambulance before taking off one minute late. Their coolness and determination to carry out their mission was praised by military leaders, including Col. William H. Blanchard of Chelsea, Mass., who rode in the tailgun position of Maj. Swancutt's plane.

'IKE' CREDITS TEAMWORK FOR WINNING WAR

Says Three Battles Decided Victory In Final Report Of War In Europe

Washington, June 21.—(AP)—Gen. Dwight D. Eisenhower recorded in his final report today as supreme allied commander in Europe that he was kept in the dark about Russia's grand strategy until four months before V-E Day.

Then, however, Marshall Stalin came through with full plans for the "Red Army's" final offensive, which became one of a vise that crushed the German war machine to a degree never before experienced in the history of modern armies.

Eisenhower's belatedly published 123-page detailed report to the combined chiefs of staff covered the fateful 11 months from D-Day in Normandy to the German surrender. It was released by the War Department, which said only minor details were deleted for security reasons.

In the present Army Chief of Staff recorded briefly his difficulties. (Continued on Page Four)

Night Of Decision Approaches For Final Form Of Price Control Extension As Rep. Wolcott Predicts Agreement On Final Price Bill Within Hour; Session To Be Conclusive

Washington, June 21.—(AP)—OPA reaches its night of decision tonight.

Rep. Wolcott (R-Mich.) predicted the final form of price control extension legislation should be determined by 9 p. m. (EST).

Wolcott is a member of the joint congressional committee harmonizing differences between House and Senate OPA bills. The conferees meet at 8 p. m. in a session which Wolcott said probably will be conclusive.

If a deadlock develops on any of the four provisions which remain in dispute, the lawmaker said, the decision may be checked directly to the House and Senate, by reporting disagreement and asking for instructions.

The committee has no time to waste, for OPA expires Sunday at midnight unless the extension bill is enacted.

"I am very optimistic we can all come to an agreement within an hour," Wolcott told a reporter. "Every member should have made up his mind on the remaining problems by the time he enters the conference room."

Two reasons lay behind the unusual night session. Some of the conferees wanted time to consult with colleagues who are not members of the committee. In addition, the Banking Committee from which the House conferees were picked had a date to confer with the Rules Committee on procedure for calling up the British loan bill in the House.

If an OPA measure is agreed upon tonight, the House can take it tomorrow. There will be no opportunity to amend it; they must either vote it up or down, or send the conferees back with instructions to yield or hold out on controverted points.

After the House acts, the bill goes to the Senate, where there is always the chance of a time-consuming (Continued on Page Four)

SOVIET WANTS VETO POWERS

Press Asserts Russia Will Never Surrender "Rights"

Moscow, June 24.—(AP)—Pravda declared flatly today that Soviet Russia never will surrender the veto power in any atomic control plan, and said the United States proposal for control of the weapon "reflects evident striving for world rule."

"In our times, such striving cannot succeed," Pravda said in its lengthy international review denouncing the proposal of Bernard M. Baruch to the United Nations Security Council as the "product of atomic diplomacy."

The official Communist newspaper said that "there is not and cannot be a surrender to this right" of veto in atomic matters, such as the Baruch plan envisages if the United States is to share its secret of atomic fission in an effort to outlaw and control this \$2,000,000,000 weapon.

The newspaper praised the Russian counter proposal placed before the Security Council by Andrei Gromyko calling for "prohibition of production and use of atomic bombs—that in a few words is the essence of the Soviet proposal."

"The Soviet plan reflects unchanging Soviet politics of peace and defense and universal security," Pravda said, terming Gromyko's suggestion "humane, clear and workable."

The Russian proposal has been published conspicuously and textually in Russia. Baruch American plan never has been published fully or in its complete text in the Soviet press.

POLAND ASKS FRANCO BREAK

Calls Upon UN To Reconsider Action Against Spain

New York, June 24.—(AP)—Dr. Oscar Lange, Polish delegate, today called upon the United Nations Security Council to reconsider Poland's proposal for a complete and immediate diplomatic break with Franco Spain.

He said his government felt the Franco regime is a threat to peace but that Warsaw had agreed to concessions in the interest of unanimity.

A council majority last week approved a motion which would have sent the case to the General Assembly for its decision but that action was vetoed by Russia.

As Poland fought for action against the Franco regime, the United Nations was faced with these developments:

1. India filed a complaint against the Union of South Africa, charging discrimination against Indians living there and asking that the situation be brought before the General Assembly.

2. The secretary-general of the Arab League said in Cairo that the Palestine question would be brought before the U.N. either for action on the league's demands for Palestine independence or for final approval. In the event of British or Arab action.

American Aid To Nationalists Lashed By Red Leader; Asserts "Hands-Off" Agreement In China Has Been Broken

Nanking, June 24.—(AP)—Communist Leader Mao Tse-tung declared today the Chinese people believed that U. S. Army and Navy forces in China "have become a grave menace to the national peace, security and freedom" of the troubled nation.

The head of all Chinese Communists issued a statement at his Yenan headquarters—by far the strongest criticism yet leveled at U. S. activities in China—saying the people felt the departure of American military forces was "long overdue."

It came at a time when the efforts of General Marshall, special U. S. envoy, to bring the government and the Communists together had reached a crucial stage.

Tension had been increased earlier today when a mob beat up a party of leftist "peace delegates" from Shanghai as it stepped off a train at Nanking's railway station. The Communists charged the government's "secret police" were responsible for the incident.

Mao asserted that the United States had given aid only to the Kuomintang government and served notice that the Communists "are adamantly opposed" to a bill introduced in Congress earlier this month requesting continued U. S. military aid to China.

Since Japan's surrender, Mao insisted, United States aid to the government had "enormously increased."

He said the stationing of large U. S. forces in China was "a fundamental cause of the eventual outbreak and propagation of civil war in this country."

FRENCH FORM NEW CABINET

Pres. Bidault Stakes Future On Coalition Government

Paris, June 24.—(AP)—France's third post-liberation coalition government was organized today by President Georges Bidault with eight ministers of his own party, the popular Republican movement (MRP), seven Communists and six Socialists.

Bidault—who kept the foreign affairs portfolio handed him by Gen. Charles De Gaulle a year and a half ago—staked his future and that of his party on a cabinet formed only after sizeable concessions by the Communists, who retreated from their insistent demand that trade union demands for 25 per cent wage increases be met.

They agreed to Bidault's ceiling of 15 per cent salary basis for low wage brackets and a suggestion for a worker-employer government conference to study the whole problem of wages and prices.

The Communists also abstained from demanding one of the three key ministries in the government—interior, foreign affairs and national defense—which they had already sought in vain to be placed upon De Gaulle and threatened to ask of Bidault, Socialist Edouard Depreux got the interior post and the other two key portfolios went to MRP men.

Bidault's party also took over the finance, national economy, justice and information ministries. The French people will have an opportunity at elections in October, to give their verdict on how they think the new government has run the country.

SEVERE QUAKE IN NORTHWEST

Tall Buildings Sway, Hillside Move, In Earth Shocks

Seattle, June 24.—(AP)—Walls fell and a hillside walked yesterday morning in the Pacific Northwest when a strong earth shock jarred a wedge-shaped piece of the coast range from Vancouver Island to Kootenay in central British Columbia and south to Olympia, Wash.

One man died, Jacob L. Kingston, 69, succumbing to heart failure when he fell from a building as he walked toward church. There were no other reports of deaths or injuries.

The quake knocked the needle from the recorder at the University of Washington's seismograph at 11:43 a. m. (PST) and was recorded at 9:14 by the Dominion Astrophysical Observatory in Victoria, B. C. It was noticeable for a full minute to Seattleites, but the university reported its equipment continued to record vibrations for an hour.

"It was the most severe in several years," said Dr. J. A. Pearce, director of the Dominion station, estimating its epicenter as near Victoria, probably 25 miles distant.

From the villages along the east coast of Vancouver Island, north of Victoria, came reports of extensive damage to buildings and roads. A 300-foot high hill "walked" 35 feet closer to the sea at Campbell River and a house moved five feet off its foundations.

At Port Alberni the top of a brick-fronted building crashed to the ground. (Continued on Page Six)

U. S. Attitude

NEW YORK, June 24.—(AP)—An authorized American source declared today in commenting on the Pravda article on atomic energy control that the United States would not change.

"It would be interesting to know why the veto is so important as against the atomic bomb," the source said. "It appears they would rather have the atom alive than the veto dead."

"We will go on working, of course," he added. "America has no intention of releasing its secrets unless adequate safeguards are set up."

Ex-Serviceman Asks To Stay In England

Stoke on Trent, England, June 24.—(AP)—Richard H. Davis, Columbus, O., ex-soldier who did not want to go home because people here are more congenial and homelike, may remain in England for another six months, the home office ruled today.

Davis flew from the U. S. three months ago and married Alma Taylor, his wartime sweetheart. His three-month visitor's permit almost expired, he applied to the home office for permission to make his home here permanently.

His application first was denied on grounds of the clothes and food shortage. The extension was granted after more than 10,000 Britons signed a "let him stay" petition.

During his prolonged visit Davis' friends plan to continue circulation of the petition in the hope of obtaining home office permission for Davis to remain here permanently.

Roxas Cables Reply To Charges By Ickes

Manila, June 24.—(AP)—President Manuel Roxas, in an unprecedented personal cable, today took former U. S. Secretary of Interior Ickes to task for "completely false statements" in a recent radio talk.

Roxas defended his war record, said that he only surrendered to the Japanese after he was implored by General MacArthur to do so "to prevent hardships to other U. S. troops," and added:

"Your statement that I signed a declaration of war against the Allies is completely baseless, as inspection of the records will show."

"I withstood savage insistence by the Japanese for two years before entering the Philippines government, while it was under Japanese domination, and I only agreed to direct a food organization on the pleas and entreaties of hungry children and mothers."

Riotous Welcome For Families At Reunion

Yokohama, June 24.—(AP)—The first U. S. Army dependents arrived in Japan today—183 wives, 128 children and one mother—and were given a riotous welcome at the dock.

The gangplank had just touched down when husbands and fathers "warmed aboard, brushing past scores of military police who had thought they were on hand to preserve order."

There were reunions all over the army transport Ainsworth, in the passageways, in the cabins, even on ledgers between decks as families separated as much as two years got better acquainted.

It was mainly an officers' party, but the families of five enlisted men were aboard. Only 36 enlisted men in the whole U. S. Eighth army of occupation so far have asked transportation for their families. Apparently most of them hope they won't be here too long.

When a semblance of order was restored, families began moving down the gangplank to the music of two bands, which kept playing "Roll Out the Barrel" over and over, as though the needle was stuck.

An Analysis Of The News

Next Sunday's Polish plebiscite, and with it the fate of Vice Premier Mikolajczyk's Polish Peasant party, probably will be determined by the number of people who are willing to vote under the guns of a militia hastily organized by a government which has been waging a determined secret-police campaign against its political opponents.

The actions of the government itself in raiding and dissolving Polish Peasant party units, in jailing thousands of dissenters, are sufficient to lend credence to the almost unanimous reports of foreign observers that Mikolajczyk represents an overwhelming proportion of the voters. But political terror, killings and imprisonment, have been committed by both sides, it is true. Although Mikolajczyk claims the support of this type from the former underground forces is not only unsolicited but unwelcome to his party.

Knowing that some 5,000 and possibly 100,000 persons have been jailed without charge is enough to keep thousands and possibly mil-

lions of people away from the polls, even though the government did not plan to have 250,000 armed men standing by "to see that there is no trouble."

The voting Sunday is not technically a part of the "free elections" for which the western Allies have been working, and which they were promised, in Russian-dominated central Europe. Actually it is a referendum on government policies—whether a one- or two-house parliament is to be chosen in elections vaguely promised for "sometime in the autumn," whether the people approve nationalization of industries and of land reforms in which big estates are being split up among the peasants; and whether they approve annexation of presently-occupied portions of Germany.

But the showing of the Mikolajczyk forces will be highly indicative of the chances for any sort of democratic expression when elections do come. The Polish peasants are what might be described as leftist, but still democratic. Sunday's choice will be between their desire for a democratic legislature and the government desire for a Soviet-type (Continued on Page Four)

THE NATION TODAY

Washington, June 24.—(AP)—Of all the legislation batted around by Congress this year to restrict certain union activities, the Hobbs bill at the moment has the best chance of becoming law.

This bill—called an anti-racketeering bill—has had a strange history. It is not really something new to stop racketeering. It is an amendment to an old law.

The Supreme Court several years ago pointed out a loophole in that old law and now Congress—since both houses have passed the Hobbs bill—has decided to plug the hole.

The bill now is in President Truman's desk for him to sign into law or to veto, as he vetoed the Case bill June 11. The Case bill would have put several restrictions on unions.

The Hobbs bill doesn't apply only to racketeering attempts by unions but to anyone making such a try.

There's talk that Mr. Truman will let the Hobbs bill become law. But this is not certain. There are several reasons to think he may veto it. Here's the story:
In 1934 Congress passed an anti-

racketeering law making it a crime for anyone to obtain money from anyone by robbery or extortion, that is through threats of force or violence.

This applied only to goods in interstate commerce. For example, Jones, a New Jersey farmer, used to drive his truckload of vegetables from his farm to a market in New York City. Since he was crossing a state line, that put him in interstate commerce.

But one day, and every day thereafter, a group of New York union truck drivers stopped Jones.

They told him: "All the New York truck drivers belong to our union. You don't, you're from Jersey. Our drivers get \$10 a day. If you want to drive into New York with your truck, you'll have to do this:

"Give us \$10 every time you come in. One of our drivers will drive your truck into New York to the market and drive it out again. Or if you want to drive it yourself, you can, if you give us the \$10 anyway."

If Jones didn't come across with his \$10, he might be beaten up or (Continued on page four)

Manager Virgil Payne's Greenies took both week-end games from the league-leading Rocky Mount, setting them 3-2 in the Saturday night game played at Guy Smith Stadium and then journeyed over to Rocky Mount yesterday where they defeated the Rocks 9-6.

three hits in three trips officially to the plate, and figured in all of the Greenies three double plays during the game.
However, sharing honors with Carlson were Manager Virgil Payne and Pitcher Rex Benton. Payne hit a homer over the score board in the left field with one away in the second frame to account for the Greenies' first run of the game. He handled a total of eleven chances perfectly, and in fact the Greenies failed to make a single miscue. Rex Benton pitched eight hit ball, but kept them well scattered and was at all times master of the situation. He struck out a total of six Rocks and issued free passes to only five.
Rocky Mount scored their first run in the third frame when Colombo singled, stole second and came home on Martin's double. They knotted the count at two-all in the sixth frame when Balentine singled and later scored on Fowler's single.
During the game in the second inning Manager Harry Soufas and Catcher Bill Mundy were put out of the game for arguing with the umpire. Both players were run clear out of the ball park and a fine of \$25 each was slapped on each one of them.
But to the more than 400 Greenville fans who traveled to Rocky

Mount yesterday came the biggest thrill of their lives when the Greenies defeated the Rocks 9-6 and knocked out the Rocks ace pitcher Bill Kennedy. It was the third game that Kennedy had lost this season, losing previously to Wilson and Fayetteville clubs, and the first time in his total of thirteen games that he had been knocked out of the box. The big left-hander was forced to leave the box in the fourth inning with one out after Merle Blackwell singled. Carlson doubled, followed by Verne Blackwell's single. During his short stay in the box he allowed a total of eight runs, nine hits, struck out four batters and walked three men. He was replaced in the fourth frame by Nicoll, who allowed one run and seven hits in the five and two-third innings that he pitched.
Joe Alamo received credit for yesterday's win, but was forced to call on Tommy Lee in the ninth inning when the Rocks pounded out two homers and a single. Lee set the Rocks down in one-two-three order. Alamo was touched for a total of seven hits and all of the Rocks six runs, but for five of the innings he put the Rocks down without a single hit.
Featuring Greenville's attack in yesterday's game was Ray Carlson, Greene shortstop, who collected a total of two doubles and a homer in five trips to the plate, driving in three of the Greenies' runs, and Skipper Virgil Payne who collected two doubles and a single in four trips to the plate. Joe Parise did a pretty piece of fielding when he nabbed Munday's long hit foul ball to left field with a beautiful one-hand stab. The Greenies added two more double plays to their total in this game, making five double plays in the last two games.
The Greenies had two big innings when they pushed across four runs in the second on four hits, including doubles by Carlson and Payne and singles by M. Blackwell and Dwight Wall, aided by a free pass issued to Joe Parise. They tallied three runs in the fourth frame on singles by M. Blackwell, V. Blackwell, Carlson's doubles, aided by Martin's error. Singletons were scored in the first frame when Parise walked, went to second on a passed ball

KEEP AWAKE AT ALL COSTS
When Rip Van Winkle went up
the mountain, unaware of the long
slumber he was about to enter into,
he passed the village inn before
which there hung a picture of King
George I. When he came back twenty
years later, there was the picture
of another George on the sign post,
also a George who was first—in
war, first in peace, and first in
the hearts of his countrymen. Under
the leadership of George Wash-
ington, the colonies had won their
independence.

Someone has said that the re-
markable thing about Rip Van
Winkle was not that he slept for
twenty years but that he slept
through a revolution. World-shak-
ing events were taking place about
him, and poor old Rip was uncon-
scious of them all. French histor-
ians remind us that at about the
same period, the court of France
met in regal splendor, and as min-
isters of state reviewed the alarm-
ing situation into which the coun-
try had fallen, King Louis XVI
dozed off during the proceedings
and punctuated the oratory of his
ministers with his snores.

Are we sleeping through present
day revolutions, or are we alert to
the significance of the momentous
events going on around about us?
Youth should be especially thrilled
with the opportunities for service
and the challenge to their powers
which the present age and the
years immediately ahead of us pre-
sent.

WASHINGTON DAYBOOK

By FRANK E. TAYLOR

Washington — At the age of 18
Thomas G. Burch decided to give
up a job to become his own boss.

Now at the age of 77 he is climax-
ing a career of working for many
"bosses" by serving as the newly
appointed Democratic senator from
Virginia until the November gener-
al election.

The quiet, unassuming man who
succeeded the late Senator Carter
Glass to the Senate May 31 worked
up his own boss from a small
insurance business into varied ac-
tivities of banking, farming, real
estate and manufacturing.

As a public servant he served as
mayor of his home town of Mar-
tinsville, Va., and for 15 years as
a U. S. representative before be-
coming a member of the Senate.

Burch typifies the conservative
philosophy to which most Virginia
members of Congress have held
during his terms of office. He is
content to be a behind-the-scenes
worker in Congress.

He seldom makes speeches but
has a notable record in steering
through legislation on which he has
worked. He has served as a leader
in fights to prevent pyramiding
taxes on tobacco. As a member, and
later chairman, of the House Post
Office Committee he sponsored
much of the progressive postal ser-
vice legislation. In 1944 he saw
through a seven-year fight to bring
about postal service economies, in-
cluding the placing of fourth class
postmasters on a salary basis.

Along with a youthful interest in
business—he left a tobacco factory
job to enter insurance work for
himself—Burch showed an early in-
terest in politics and public affairs.
He served for years as chairman
of the Fifth District Democratic
Congressional Committee and was
a leader in bringing about changes
in Virginia state government.

In this latter work he served with
his close friend—and now his col-
league in the Senate—Harry Flood
Byrd, then governor, was aided by
Burch in gaining approval of a
pay-as-you-go road plan and a pro-
gram, designed to give more effi-
ciency in state government.

The new senator is sociable but
prefers informal gatherings to so-
cial events. He says he has no real
hobbies but likes set-back (a card
game), baseball and walking.
When at home he oftentimes walks
about his farms—he has four—and
in Washington he walks the mile or



so between his hotel and the Cap-
itol when time permits.
Congratulatory messages on his
appointment indicate that he has
succeeded in having others think of
him as an old and privileged Negro
servant once said Burch thought of
himself.

As a young man Burch had spoken
at a political meeting. After-
wards he asked the servant what he
thought of the speech.
"Pretty good," replied the servant,
"but you sure did speak well of
yourself."

power, the fight for control. As
you will recall, Mikolajczyk is an
uninvited guest at the government
table, more or less forced on the
Russians by the western powers in

its hand-picked regime at the ex-
pense of the "London Poles" headed
by Mikolajczyk. Practically all of
the other ministers are Moscow men
described as intending to retain
power at any cost.

It is conditions such as these,
conditions which have been part
of the preliminaries to establish-
ment of all police states, which the
Polish Peasant party faces Sunday.
Even with overwhelming popular support
it is difficult to get ordinary voters
to stand up at the polls and be
counted against a secret police, ar-
med and equipped, and the ever-
present threat of reprisal in a land
where a little food is a leaky shelter
and a few rags for warmth repre-
sent the height of ambition for mil-
lions.

court of violating the 1934 Anti-
Racketeering Act. But when the
men appealed to the Supreme Court
that court freed them because of
a technicality in the law.

The Supreme Court handed down
its decision in 1942. In 1943 Rep
Sam Hobbs, Alabama Democrat
got the House to pass a bill to
tighten up the 1934 law.

But the bill went to the Senate
which let it die without voting on
it. In December, 1945, Hobbs got
the House to pass his bill again
and again it went to the Senate,
languishing in a pigeonhole.

But a few weeks ago, angry be-
cause of the strikes, Congress passed
the Case bill. The Hobbs amend-
ment to the 1934 anti-racketeering
law was made a part of the Case
bill.

President Truman killed the Case
bill with his veto. He told why
point by point, in a long veto mes-
sage. When he got down to that
section which contained the Hobbs
amendment, he said:

"I am in full accord with the ob-
jectives which the Congress here
has in mind." But then, in effect
he said:

At some future time some federal
judge, trying an anti-racketeering
case, might decide the Hobbs
amendment meant something dif-
ferent from what Congress appar-
ently intended. For example:

The Hobbs amendment doesn't
say specifically that peaceful pick-
eting or a strike is not a violation
of the anti-racketeering law or of
the Hobbs amendment to that law.

In other words, Mr. Truman raised
the possibility that some federal
judge might decide that a strike or
picketing was an attempt to extort
money from an employer by force
and therefore violate the law.

That seemed to finish off the
Case amendment. But not Congress.
It pulled the amendment of the vetoed
Case bill and passed it as an inde-
pendent bill, an amendment to the
1934 law.

But the bill as it lies on Mr. Tru-
man's desk now is not changed in
any way or wording from the
Hobbs amendment which Mr. Tru-
man found fault with as it appeared
in the Case bill.

For that reason, he may restate

his objections to it and veto it.

But Rep. Hobbs says his bill
points out that none of the rights
guaranteed labor under the existing
laws shall be interfered with by his
bill. There the argument lies, wait-
ing for Mr. Truman's decision.

ing filibuster.
Although four major disagree-
ments remain, the key to the dis-
pute is whether to accept Senate
amendments lifting price ceilings
on meat, poultry and dairy prod-
ucts, petroleum and tobacco at the
end of June.

House members take the attitude
there is no need to single out spe-
cific commodities for special treat-
ment, in view of the decontrol pol-
icy already agreed upon. In general,
this policy calls for removal of
ceilings as soon as the supply of a
commodity exceeds or balances the
demand for it.

Wolcott said if the decontrol prob-
lem is settled tonight, the other
points at issue can be cleared away
in a few minutes.

The House voted a nine-months
extension of price control and the
Senate raised it to a year. It ap-
peared to be a toss-up which per-
iod would prevail.

ties of coordination with the Red
Army while lauding the teamwork
of the western allies. The United
States and Great Britain, he said
fought as "one nation."

Aside from teamwork, Eisenhower
concluded that the victory was
due to allied military and "instabil-
ity of spirit" and to misjudgment
by Hitler and Field Marshal
Von Rundstedt, the Nazi command-
er in the west.

In Eisenhower's judgment, three
battles were decisive in liberating
Europe:

1. The battle of the Normandy
beaches, where the foe was revealed
as a stubborn fighter but beset by
difficulties of supply and communi-
cations resulting largely from the
allied hammering on the air.

"Completely misled" by allied di-
versian operations, Von Rundstedt
held the bulk of his forces in the
Pas-de-Calais opposite England
waiting for a second assault which
never came.

2. The battle of the Falaise pocket,
where the enemy showed that
fatal tendency to stand and fight
when all the logic of war demanded
a strategic withdrawal.

3. Battles west of the Rhine dur-
ing February and March, 1945
where "the armies which had been
intended to defend Germany were
shattered beyond recovery."

Of the Russians, Eisenhower said
that in planning for the final spring
drive last year it was recognized
that its success hinged to a large
degree upon the weight of the Red

FOLGER WINS OVER CHATHAM

Losers To Run Again In 1948; Rives Concedes To Durham

Raleigh, N. C., June 24—(AP)—
Opponents have conceded victory
to Rep. John H. Folger of the Fifth
Congressional District and Rep.
Carl T. Durham of the Sixth Dis-
trict in North Carolina's Democrat-
ic runoff primary.

With only one of 141 precincts
unreported in Saturday's balloting,
Thurmond Chatham, Winston-Salem
Industrialist, sent a telegram of
congratulations to Folger and sim-
ultaneously issued a statement that
he would be a candidate again in
the 1948 primary.

The unofficial vote was Folger,
24,549; Chatham, 21,832.

With all ballots unofficially tab-
ulated in the Sixth District, E. Earl
Rives, Greensboro attorney, conceded
victory to Durham. The count
was Durham, 16,386; Rives, 14,588.

In both districts, nomination by
the Democratic party is equivalent
to election.

The Winston-Salem millionaire
blanket manufacturer led Folger
by 59 votes out of a total of 43,000
in the May 25 primary but lacked
a majority because a third candi-
date, Joe J. Harris, received 805.

Durham also led the ticket in the
first primary but failed of a ma-
jority over Rives and the other can-
didate, D. E. Scarborough, also of
Greensboro. Scarborough subse-
quently came out for Rives in the
runoff.

The contest between Chatham
and Folger developed into a series
of charges and countercharges of
election irregularities, with the in-
dustrialist contending the incum-
bent was favored by the CIO-PAC.

Folger replied that he had not
solicited any such support, and
there was never any formal an-
nouncement of an endorsement for
him from this source. Chatham was
accused by his opponents of being
a "sometime Democrat," who had
contributed to the anti-Roosevelt
liberty league and had voted for
Republican Presidential nominees
in 1936 and 1940.

Following their defeat in the run-
off, Rives and Chatham pledged
themselves to support the entire
Democratic ticket in the coming
general election.

declared that President Truman

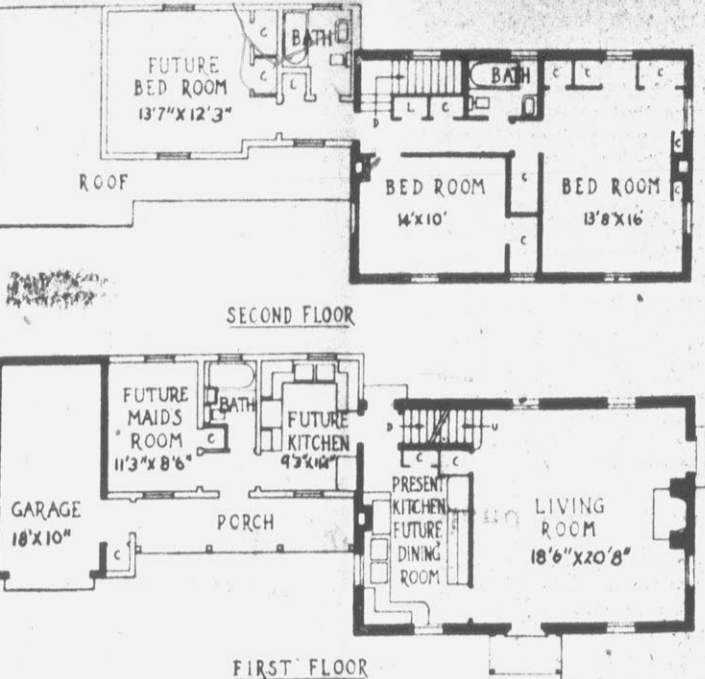
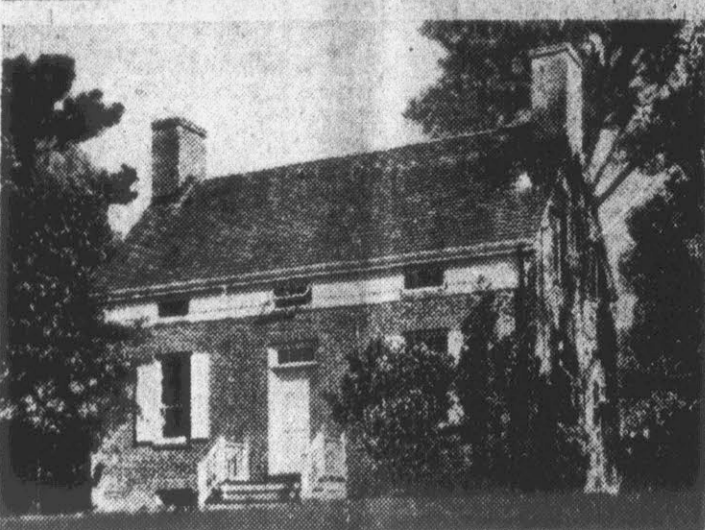

Future expansion has been considered in the plan of this compact house designed by Holden, McLaughlin and Associates (570 Lexington Ave., N. Y. C.).

Washington, June 21.—(AP)—A world war agency is soon to be liquidated, and Rep. Norblad (R-Ore) says it's about time.
Commenting on a \$10,000 appropriation to wind up the affairs of the U. S. Spruce Corporation by January 1, Norblad said it was "absolutely inexcusable that liquidation of this corporation should have taken 20 years."
"The purpose and usefulness of the Spruce Corporation, which was organized in August, 1918, ended on Armistice Day of that same year," he said. "It was the sole purpose of this corporation to provide spruce lumber for aircraft of the U. S. and all allies during the first World War. Norblad made his remarks during consideration of the government corporations' appropriation bill in the House.

SOVIET ARMY AIDS IN HUNT

Full Cooperation Given In Trailing Shooting Suspects

Vienna, June 24—(AP)—Russian and American investigators, working in close cooperation, were near a solution today of the shooting of two American military policemen Saturday night.
The Americans, both recovering in an Army hospital, were shot when they attempted to stop a stolen American jeep in which three Russian soldiers were riding.
Russian police and investigators have worked with the American provost marshal on the case from the beginning. Russian judge advocates participated in the questioning of suspects. A number of Russians were still under questioning today and one of the occupants of the stolen jeep was in custody.
A Russian lieutenant was shot while resisting arrest by American military policemen ordered to pick up suspects in the case. He was in serious condition with a bullet wound in the stomach.
The two Americans were shot at close range. One of them suffered from powder burns around his eyes. They were shot when they pulled their jeep beside the stolen jeep. A Russian reached out and fired at close range, hitting both soldiers in the face.

Jewish Underground Group Goes On Trial

Jerusalem, June 24—(AP)—A military court began today the trial of 31 members of Irgun Zvai Leumi, underground Jewish resistance organization, on charges of carrying arms and explosives.
The accused, including a 21-year-old woman, entered the heavily guarded courtroom chanting the 2,000-year-old slogan set by their ancestors against the Romans: "By blood and by fire Yehudah (Judah) has fallen; by blood and by fire it will be restored again."
The defendants, arrested in the desert south of Tel Aviv in April, are charged with possessing anti-personnel bombs, rifles, automatic weapons and other firearms and explosives.

Airline Heads Pian Study Of High Costs

Washington, June 24.—(AP)—Airline heads will consider tomorrow a study concluding that ground costs are excessive, with airport workers idle more than half the time, and recommending that the carriers establish a joint company to run terminals for all of them.
The report was prepared for the Air Transport Association (ATA), of which all scheduled airlines are members, by Joseph D. McGoldrick, former New York City comptroller. The ATA directors will meet tomorrow to discuss possible action.
Detailed studies were made at airports in five cities—Chicago and Peoria, Ill.; Detroit, Mich.; Denver, Colo., and Memphis, Tenn. Indications were that \$1,000,000 a year could be saved at those terminals by better operating methods in the handling of passenger enclerdu handling of passengers, mail, express and freight.

GI's Held Guilty Despite Orders

Bad Nauheim, Germany, June 24. (AP)—Col. C. B. Mickelwait, the U. S. Army's European theater judge advocate, told 12 American publishers and editors visiting the Lichfield cruelty trials here today that the army holds soldiers responsible for illegal brutality, even though done upon orders from superior officers.
The editors questioned Mickelwait about the army's policy regarding illegal and cruel punishments if ordered by superiors, as most of the Lichfield defendants contend they were.
"No one is justified in carrying out improper or illegal orders," Mickelwait answered, "although the facts must always be tested to see whether the defendant should have known the orders were illegal, and orders may be considered as mitigating circumstances."
Asked by one editor what recourse a soldier had if he considered an order illegal, Mickelwait explained that the soldier could appeal to "the proper commander" or to the inspector general or, if tried for disobedience, he could challenge the legality of the orders as a defense.
"Does an ordinary private know that?" one editor asked.
"I think that most of them do," Mickelwait replied.
