POLL REVEALS HOUSE FAVORS BRITISH LOAN

Final Vote Expected Today; Critics Fearing Russian Reaction

Washington, July 13—(AP)—A final vote was expected in the House today on the proposed \$3,750,000,000 British loan, with proponents arguing that the outcome will determine whether the world looks to Washington or Moscow for leadership.

Critics contended Russia might consider the loan an "overt act," and said it is more likely to promote war than peace.

As the House came to the show-down, Speaker Rayburn (D-Tex.) predicted ratification by 20 to 50 votes. The Senate has approved the transaction, 46 to 34.

The latest polls of House members showed 188 for the credit, with 163 against and 82 undecided or not reached. The pollsters report on Republicans was 90 for, 141 against, 151 not reporting; on Democrats, 158 for, 22 against and 50 not reporting. The two minor party members were not included in the poll, which was taken by Rep. Priest (D-Tenn.), for Democrats, and by Rep. Landis (R-Ind.), for Republicans.

First major test today was expected to come on an amendment by Rep. Dirksen (R-Ill.), proposing that Britain put up collateral for any money advanced. His amendment is expected to follow advice of Jesse Jones, former Secretary of Commerce, who has lashed British holdings in America and elsewhere that might be posted as security.

Other amendments expected would:

1. Require Britain to deed to the United States, in consideration for the loan, certain island areas in the Atlantic where this country now has 99 year lease for military purposes.
2. Stipulate that credit rather than cash be extended for goods purchased in the United States.
3. Require that interest on the loan begin immediately, rather than at the end of the first five years.
4. Provide that the interest rate be raised from two to four per cent.

Order Restrains U. S. Soldiers

Yokohama, July 13—(AP)—Lt. Gen. Robert L. Eichelberger, eighth army commander, cracked down on Yank soldiers who mistreat Japanese civilians today and threatened severe measures to halt serious crimes.

In a strong letter circulated last month and made public only today Gen. Eichelberger said that he meant to stop serious breaches of discipline. He pointed out that there were isolated "but very serious" added "bullying" actions of soldiers toward the Japanese would not be tolerated.

Ministers Fail To Form Policy

Meeting In Paris Adjourns On Note Of Disagreement Over Present Administration And Future Of Germany; Vandenberg And Connally Expected To Leave For U. S. Today

Paris, July 13—(AP)—Indo and the western allies had reached a definite parting of the ways on both the present administration and the future of Germany were seen today following the adjournment in disagreement last night of the foreign ministers council.

Sen. Vandenberg (R-Mich.) and Sen. Connally (D-Tex.), advisers to Secretary of State James F. Byrnes were expected to leave Paris by plane for the United States this morning. It was not known whether Byrnes planned to return to the United States or to remain in Europe to await the opening here July 29 of a 21-nation peace conference.

On the question of Germany however, the ministers failed to reach any major agreement, despite lengthy debate.

Soviet Foreign Minister V. M. Molotov refused to support a United States plan for a central economic administration for Germany. This proposal was backed by French Foreign Minister Georges Bidault in a remarkable concession, when he agreed to go along with Byrnes if the coal-rich Saar was not included.

Molotov asked further time to study the condition endorsed by Britain and the United States—that the Saar be placed under French

Women Kidnaped By Guerilla Forces

Tarlac, Luzon, P. M., July 13—(AP)—Twenty Filipino women were kidnaped today at the nearby village of Mayantoc by an armed band which Philippine army military police identified as members of the peasant irregular guerilla organization, the Hukbalahaps.

The military police said the kidnaping was apparently an aftermath of the clash between MPs and Huks near the village July 9 when 38 Huks and one MP were slain. Unable to provide a motive for the mass abductions, the MP officials speculated it might have resulted from an attempt to "recruit" camp cooks and workers.

Distraught provincial officials said they had good hopes the women would not be physically mistreated.

RELIEF BILL SLAPS SOVIET IRON CURTAIN

String Tied To UNRRA Funds For Russia; China Relief Shakeup Asked

Washington, July 13—(AP)—A pulled punch at foreign news censorship went to the Senate today along with word that UNRRA Director F. H. LaGuardia had demanded that the Chinese government overhaul its relief setup.

The relaxed censorship provision aimed at Russia, was contained in a \$2,700,000,000 money bill approved by the Senate Appropriations Committee. Disclosure of LaGuardia's action came in printed testimony of committee hearings on the measure.

This testimony disclosed that both LaGuardia and William L. Clayton, Assistant Secretary of State, had strongly urged elimination of a House provision denying UNRRA funds to any country which refuses to permit accredited American press representatives to "enter, observe and report without censorship on the distribution and utilization of relief" in that country.

The committee decided against striking out the amendment. But on motion of Senator Ball (R-Minn.), it decided that none of the UNRRA money in the bill could be spent unless correspondents were permitted to send reports on UNRRA activities "without any deletions or modifications by censorship."

Ball said this had the effect of not challenging Russia's right to maintain censorship, but providing for uncensored dispatches on UNRRA's operations. He said he did not know if the new version is acceptable to the State Department and to LaGuardia.

Asserting that UNRRA was a "heartbreaking" job at best, LaGuardia told the committee that the United States ought to do all it could to create good will.

"I want to hand out this food," he said. "I do not want to throw it at them."

LaGuardia contended that he had stopped all but vital food shipments to China only because supplies had piled up in ports there due to the breakdown in inland transportation. He said these supplies were deteriorating and were being stolen.

Georgia Purges List Of Voters

Atlanta, July 13—(AP)—Hundreds of negroes who have registered for the first time are being purged from the voting lists in Georgia a scant few days before the democratic primary.

How many hundreds it is hard to say. Georgia has more than 150 small rural counties. The situation varies from county to another. An agricultural while the purge is under way is difficult.

Negro leaders estimate that 20,000 negroes have been challenged. Any citizen can challenge a registrant. The negro leaders charge a conspiracy, saying no white persons are being challenged.

The hearings before boards of registrars—which act as courts in these matters—are going on in many counties. In some counties few negroes have been disqualified; in others, the challenged registrants have been written off the books in blocs.

Boston Woman Was Victim Of Strangler

Boston, July 13—(AP)—A short, stocky killer, described by Police Sergeant Raymond A. L. Monahan as a Negro, strangled Mrs. Helen Cronin, 40, in her bedroom early today and then allegedly tried to kill her 12-year old daughter by the same method.

Monahan said the strangler was interrupted while attacking Mrs. Cronin by her daughter Eleanor, and that after yanking tight a belt he threw around the mother's neck he tried to strangle her with it.

The attacker left behind a necktie which Monahan said was worn by a man who accompanied Mrs. Cronin to various cafes last evening.

"That clue, together with a description furnished by a taxi-cab driver who, Monahan reported, had taken Mrs. Cronin and a man to the Cronin home, gave police a definite lead in their search for the strangler, the sergeant said.

Babson Park, Mass., July 13—A book has been written by me and published by Harper and Brothers entitled, "Looking Ahead Fifty Years." In this book, I discuss various subjects, such as the future of investments, the development of new industries, the changes in farming, the outlook for small business, and the possibility of labor rule.

Numerous readers have written to me saying, "I will be dead and gone in fifty years. Tell me what you expect during the next five years." Of course, this is a more risky thing to do. I, too, will be dead before the end of fifty years, while I hope to be around for the next five years! But here is how I now feel about the immediate future.

Expect Low Interest Rates
I expect continued low interest rates. Hence, since money doubles in fifteen years at 5 per cent, should you not seek 5 per cent interest with reasonable safety rather than speculate even on the "long swings" of the stock market? Of course, you can't pick 5 per cent investments off blueberry bushes. You must take time to hunt them up and find them. Certainly, you should not be satisfied with bonds that pay less than 4 per cent interest unless they are either tax-exempt or convertible.

Days of Mass Unemployment Over
I expect continued employment among the masses or else government aid for them when unemployed. The upper middle-class people and the well-to-do will continue to

have their ups-and-downs; executives will again have their salaries reduced and their dividends cut with corresponding declines in stock prices; but the days for many years, employment are over for many years. The American people are not going to let labor leaders rule them; but the days when employers can be arbitrary are also over. Hence, if the Republicans have to return to office they must realize that we are living in a new world, whether they like it or not.

No political party can survive another era of low wages. If private industry cannot continue present wages, the government will do so or else provide wage subsidies. Hence, in view of the above, are not the merchandise stocks, the food producers and similar concerns the safest investments? Remember, high wages are a continue.

Real Estate a Prime Investment
I expect a continued demand for properly-located real estate, especially for homes. Next to food and clothing, reasonably-priced homes should continue as a prime investment. Hence, I believe that your time and investment should be in a home and enough fertile land for a "kit-chicken garden." Houses depreciate, but well-located land should appreciate.

Try to avoid large cities, especially on the coast. Unless a great spiritual awakening occurs, the chances are that World War III will come, when some of our large cities will be totally destroyed.

OPA Revival Bill Voted In Senate

BATTLE OVER VETO POWERS MOVES AHEAD

Attempted Changes In UN Charter Could Be Stopped By Soviet Veto

New York, July 13—(AP)—Advocates of Australian-American proposals for an autonomous international atomic control agency pushed ahead doggedly today on a course which may lead to a decisive showdown with Russia over the big power veto in the United Nations.

These proponents conceded that Russia could block any move to amend the charter on the veto question, simply by invoking the veto itself. Nevertheless, they proceeded on their course, with the suggestion that the charter and the set-up of the UN itself might prove to be outmoded in the atomic age.

These factors emerged after yesterday's acrimonious three-hour session of the 12-nation atomic working committee at which:

1—The retiring atomic chairman, Foreign Minister Herbert E. Evatt of Australia, rejected the Russian atomic plan as "impossible."

2—Bernard M. Baruch, of the United States, said Evatt's summation as chairman "conforms basically to the United States proposals." Apparently referring to a Russian demand for immediate destruction of atom bomb, Baruch added that "a solemn expression of pious intent is not sufficient x x x protection."

3—Soviet Delegate Andrei A. Gromyko said he saw no reason why exchange of atomic secrets should not be started immediately among the United Nations. He opposed unsuccessfully the formation of 12-nation committees to carry on under the commission.

CAUSTIC NOTE WRITTEN MAY

Board Says He Is Unable To Explain Role In Case

Washington, July 13—(AP)—The Senate War Investigating committee bluntly informed Rep. May (D-Ky.) that it could find no alternative to the conclusion that he is "unable to explain or contradict facts" linking him to a munitions combine it is investigating.

In a strongly worded letter to the chairman of the House Committee, the Senate Committee refused to accept the conditions he laid down for a personal appearance before the investigators.

"Stripped of 'ifs, ands' and 'buts,' the plain and simple import of your (May's) letter is that you decline to appear before the committee to face and explain the facts that have been presented," the letter said.

"The committee has sought to find an alternative to the conclusion that you admit those facts to be true, that you are unable to explain or contradict them. It cannot find any such alternative."

"We all are public servants. As such, the citizenry and its representative bodies, of which we are members, are entitled to an accounting of our stewardship of the public trust we have accepted."

"This should induce us to seek to account frequently, fully and openly. No possession should be more precious than the confidence of the public in the integrity and devotion to duty of a representative of the people in a democracy."

"When wrongfully challenged, we should rush to defend that integrity."

Traffic On Flooded Road Now Normal

Elizabeth City, N. C., July 13—(AP)—Water on the Roanoke highway connecting Roanoke Island, home of the Lost Colony, with the mainland, has been reduced and automobile traffic has returned to normal. R. R. Roper, division highway maintenance engineer, said today.

Tragic UNRRA Failure

Breakdown In China's Relief Distribution Blamed On Graft And Interference By Government And Reds; Too Little Reaches Starving Interior

The breakdown of Chinese distribution of UNRRA food, resulting in Director-General LaGuardia ordering all but emergency supplies withheld from China, appears to have been due to grave "mismanagement" to use a euphemism, but call it by any name you will and it still is a tragedy in view of the terrible famine conditions in that stricken country.

UNRRA staff members in China have accused Generalissimo Chiang Kai-Shek's government of failing to get materials to millions in the interior, and of using relief goods for political ends. It is said that

supplies also are reaching the black markets.

T. F. Ssang, head of the Chinese National Relief and Rehabilitation Administration (CNRA), in a scolding to Mr. LaGuardia, admitted the order cutting relief, admitted newsmen that "Soviet interference" both sides (Chinese Nationalists and Chinese Communists) had prevented supplies from reaching the stricken areas.

Sleepy Senators Pass Extension By 62-15; Amendment-Ridden Bill Is Weaker Than One Voted By President; Sent to House For Final Going-Over

Washington, July 13—(AP)—The Senate passed 62 to 15 early today an OPA revival bill that had been denuded of almost as many major price controls as it promised to restore.

Apparently amended far beyond the bounds which would permit its acceptance by President Truman, the one-year extension measure was sent to the House, where it seemed likely to receive a quick push toward a Senate-House conference committee.

There, administration leaders hope to rewrite it from tip to roots.

Rep. Wolcott of Michigan, top Republican of the Banking Committee, said an effort might be made to substitute for it the original extension bill President Truman vetoed June 29. Wolcott said the first bill appeared "stronger" than the latest Senate measure.

As it floundered through a sleepy Senate, the new measure would revive OPA and restore price control ceilings as of June 30. It would keep rent controls with the proviso that states take over in this field where they have adequate laws.

Price controls, however, would not be replaced on meat, poultry, eggs, butter, cheese, milk or other dairy products, cotton seed, soybeans, grain, livestock or poultry feed, nor on any form of tobacco. Petroleum would have no ceilings as long as supply meets domestic demands.

Reinstated were some of the provisions which President Truman vetoed in his June 29 veto.

This included a section giving final say on the lifting of food controls to the Secretary of Agriculture instead of OPA, which Mr. Truman said was an "unsound split of authority."

It contained also what he called "cost-plus" amendments for automobile and appliance dealers and lacked an additional \$250,000,000 in subsidies he asked.

In one major respect, however, it was more satisfactory to administration leaders than bill No. 1. The Senate put in a provision requiring that producers, manufacturers and processors ceilings be placed high enough to take care of the average increase in costs in their industry since 1940.

This was substituted for a provision inserted in the original bill by Senator Taft (R-Ohio) which Mr. Truman labeled as the "most damaging" section of that measure.

The apparent administration strategy was to take this measure direct to a Senate-House conference committee, where it could be amended with a 30-day extension of OPA powers voted by the House previously and joined together under rules that would permit almost any sort of final compromise.

The Senate named Senators Wagner (D-N.Y.), Barkley (D-Ky.), Downey (D-Calif.), Radcliffe (D-Mo.), Tobey (R-N.H.), Taft (R-Ohio), and Millikin (R-Colo.) as its conferees.

PORTER FEARS WORST AHEAD

Near Without Price Controls

Washington, July 13-(AP)-Declaring he is a "frightened man," OPA Administrator Paul Porter said today "we've had a last-just a taste-of what can happen" without price and rent controls.

Porter, in a radio address (ABC network), likened "inflation's chain reaction" to the aftermath of an atomic blast. He said the reaction will be slow in getting started.

"But when it does start-when it begins to rumble all along the line-some of the price increases you've been seeing in the last two weeks may look like pretty small potatoes by comparison," Porter continued.

He added that it is "that chain reaction of inflation which has me worried and has me saying"-with the author of a book on atomic energy-"I'm a frightened man."

Elaborating on his chain reaction theme, Porter said:

"I am not thinking of 79 cent lamb chops, or butter at \$1 a pound, or the thousands of unwarranted rent increases and evictions x x x x x I am thinking ahead to what may happen as a result of price increases that are being made in basic commodities and raw materials which for one reason or another haven't yet made themselves felt in your stores-at least not to the full effect they will be felt if controls are not restored promptly."

Noting that the Bureau of Labor Statistics' price index of 28 basic commodities had climbed 17 per cent during the first 11 days after controls expired July 1, Porter said prices measured by this index had risen "only about 13 per cent" between May 17, 1943, and last June 28.
