Holy Land Problem Handed To Britain

President Refuses To Commit United States To Role In Palestine; British Officials Must Seek New Solution; Truman Says Support Of American People Is Required

By ARTHUR GAVSHON London, Aug. 15.—(AP)—Authoritative sources in the British government said today that the United States has refused to participate in the plan for dividing Palestine as recommended by a British-American cabinet committee of experts, leaving Britain to cope with the problem by herself.

President Truman made the United States decision known in a letter saying he could neither accept nor reject the plan at this time without "the support of the American people," these sources said.

British officials, who had made it plain that the plan for dividing Palestine into four zones in a federal state depended upon support of the United States, say they now feel that they have to seek a new solution.

The government has decided not to make President Truman's letter public for the time being, the sources said.

The President's decision apparently meant that the admission of 100,000 Jews to Palestine, recommended by a British-American committee of inquiry which spent months in investigating the situation both in Europe and Palestine, would be postponed beyond the end of the year.

Both Arabs and Jews have declared the scheme, at least in many of its phases, was unacceptable. Jews were particularly incensed by failure to provide for the immediate admission of at least 100,000 of their number.

REVOLTS URGED IN PALESTINE

Broadcast Call To Arms; Would Form Underground Zionist Government

Jerusalem, Aug. 15.—(AP)—British forces, variously estimated at 50,000 to 200,000 men, were held ready for possible trouble today following a broadcast by Irgun Zvai Leumi, underground Jewish organization, calling upon Palestine's Jews to revolt against the British.

The broadcast, made over a secret radio station, urged unification of Irgun, Hagana and the so-called "Stern Gang"—similar resistance organizations—into a single Jewish army under an underground, Zionist government.

Calling upon all Jews to volunteer their services either with the army or the proposed underground government, the broadcaster said: "We must exert our every strength against two enemies—the British and time."

The underground government is needed, the broadcast said, "to guide our constant war against those two adversaries—no longer will we wage a war of retribution, but a constant war."

The broadcast also urged Jews to stop paying taxes to the Palestine government and turn the money over to the "Irgun Zvai Leumi war fund."

The broadcast was one of the first definite underground reactions to the deportation to the island of Cyprus of 1,000 European Jews who sought to enter Palestine without immigration certificates.

Its effect was to increase the tension that already gripped the Holy Land, as Arabs, British and Jews themselves nervously awaited an expected flare-up of violent extremist reaction to the deportation.

CIO Maps Strategy In Wage-Price Discussion

Emergency Meeting Called; Consider Launching New Wave Of Wage Demands; In View Of Higher Living Costs

Washington, Aug. 15.—(AP)—The CIO plotted its future wage-price strategy today.

Top national officers as well as regional, state and local representatives gathered for an emergency session to discuss what has happened to the wage-earner's dollar in the light of recent price increases.

The meeting, following a gathering of CIO vice presidents yesterday to draft formal declarations of policy, was thrown open to newsmen. The policy declarations were not made public immediately.

The top unanswered question in the agenda of today's session was whether the labor organization would launch a new wave of wage demands.

Three big CIO unions already are talking along this line. They are the packinghouse workers, now in wage negotiations with Swift and Company; the executive board of Ford local 800 of the CIO-Auto Workers; and the executive board of the CIO Oil Workers, meeting at Ft. Worth, Tex.

LAFOLLETTE'S FAVOR SOUGHT BY POLITICOS

Major Parties Seek Backing; Holds Balance Of Power In Wisconsin

Washington, Aug. 15.—(AP)—Both major parties obviously hoped today for Senator Robert M. LaFollette's support in November amid conflicting forecasts on the political portents of his defeat.

Senator for Wisconsin's GOP senatorial nomination by Joseph R. McCarthy, 37 year old war veteran, LaFollette himself kept mum on his future plans. He told a reporter by telephone that he will make no political decisions for two or three weeks, but he reiterated that he will not run as an independent.

As a former progressive who voted consistently with the Roosevelt New Deal on domestic legislation, the veteran lawmaker had an open invitation from Senator Taylor (D-Idaho) to come back into the administration fold.

In a statement reportedly inspired by party leaders, Taylor said LaFollette's defeat in the GOP primary would "there is no room in the Republican ranks for men with the interests of the people at heart."

When Democratic Chairman Robert E. Hannegan commented that LaFollette's loss meant certain victory in November for Howard W. Murray, the Democratic nominee, GOP publicity man William C. Murphy retorted that if Hannegan meant "it can get a hundred bucks of my money awfully easy."

Because the remnants of the progressive party, which he led back into the GOP fold last spring, may well hold the balance of power in November, LaFollette's support would look attractive to either McCarthy or McMurray.

On the Democratic side, politicians noted that Leo Crowley, former New Deal official, had endorsed LaFollette in the primary, but that the senator had been bitterly criticized by Democratic State Chairman Robert Tehan.

Paris, Aug. 15.—(AP)—The United States and Britain struck back today with blunt and unvarnished statements at Soviet "reflections" on their peace conference policies.

Finland, last of the five former enemy states to be heard, presented a keynote of "collaboration" with her great neighbor to the east, the Soviet Union.

Czechoslovakia bitterly replied to Hungarian attacks on Czech treatment of Hungarian minorities.

U. S. Secretary of State Byrnes, taking exception to Russian allegations during the debate on today that certain nations had enriched themselves during the war, said the war had cost the U. S. 400 billion dollars and "I hope the (Soviet spokesman) was not referring to the United States."

Finland Foreign Minister Carl Enckell praised Russia as generous victor, but entered a plea for a reduction by \$100,000,000 in Finland's reparations payments and an ending of the territorial cessions she has been forced to make.

Byrnes said economic treaties in contradiction of the Potsdam agreement would lead to enslavement and exploitation.

"Before America was attacked Franklin D. Roosevelt announced that the U. S. would be the symbol of democracy," he added. "America has asked for no recompense other than the freedoms she sought for all mankind. America seeks no territories or recompense."

Byrnes added that the U. S. was willing to help in the economic rebirth of any nation.

He spoke after Foreign Minister Jan Masaryk of Czechoslovakia had told the conference that Hungary's Foreign Minister Janos Gombos had tried to gloss over his nation's record as an axis satellite by castigating Czechoslovakia in an address before the party yesterday.

There was loud applause in the conference chamber when Byrnes said the U. S. would offer reciprocal friendship to any nation.

Foreign Minister Molotov listened intently as Byrnes spoke in a firm voice, occasionally gesturing with one hand.

The American secretary praised both Italy and Greece and objected to recent speeches by Russian and other Slav delegates giving the impression that other countries were more democratic than Italy because they have harmonized their views with the Russians.

Confidence Man Is Apprehended

New York, Aug. 15.—(AP)—Alexander Arlinsky, 41, of Lowell, Mass., described by Federal authorities as one of America's most notorious confidence men, was imprisoned for six years by Federal Judge Marion S. Boyd today after Arlinsky pleaded guilty to a four-count indictment charging him with impersonating government agents for purposes of fraud.

Arlinsky, who was said by Assistant U. S. Attorney Joseph J. Verdichio to have made a career of swindling women, six of whom he married, was the object of a state and federal search since 1940.

The defendant has a police record in a half dozen states, Verdichio said, adding that he made it a practice to prey upon unsuspecting wealthy women.

Bear Baiting?

GENEVA, SWITZERLAND, Aug. 15.—(AP)—The Russian delegation to the UNRRA General Council, blyning political considerations for an American deal with the Soviet Union case demanding that the UNRRA cease withdrawing Austrian products while UNRRA is shipping supplies into that country, has declined to discuss the issue.

"The Russian delegation refuses to take part in discussing this question," Nicolai Fenoy, Russian spokesman, told the UNRRA policy committee yesterday.

Fenoy said the whole matter, being political, was "outside the scope of UNRRA," and was a mere move to place the Soviet Union in a bad light. He was supported in his position by delegates from the Ukraine and White Russia.

McDiarmid, both of Raeford, and two sisters, Margaret McDiarmid and Mrs. Kate King, both of Raeford. A son, Wilson Hines McDiarmid, was killed in action in the European theater of operations on D-Day, 1942.

Great Lakes Tie-Up Expected By Strike

Cleveland, Aug. 15.—(AP)—The CIO National Maritime Union called its Great Lakes seamen out on strike today and estimated that sufficient non-union members would join the walkout to paralyze lake shipping within several days.

President Joseph Curran of the NUM, who sped to Cleveland by plane from Washington to help direct the strike, estimated the union's lake members at 4,500.

At strike headquarters here, a spokesman said between 4,000 and 5,000 other seamen were expected to join the work stoppage. He estimated the number of vessels operating on the lakes at 300 and said a "large majority" would be idle within a few days.

The spokesman said CIO members "from coast to coast" have agreed to cooperate. The extent of the cooperation was not defined.

Charge Communists Plan New Uprisings

Shanghai, China, Aug. 15.—(AP)—United States troops and naval personnel were ordered confined to their quarters from 6 p. m. to dawn tomorrow after Nationalist authorities charged the Communists were planning an uprising in Shanghai either tonight or within a few days.

Previous Communist uprising plots have been reported in Tientsin and Changchun.

No Communist troops are stationed in this city of 4,000,000, but there is a Communist underground.

Several American warships are in Shanghai but only a handful of American troops are here and they serve in the China service command.

The air forces' guided missile is the "Gapa," a slim, ten-foot long rocket powered projectile.

Waste Of Privileges

Many Of Half-Million Job Trainees Throwing Away Educational Privileges For Program Which Neither Gives Training Nor Will Lead To Better Jobs

By ROWLAND EVANS, JR. (For Marlow) Washington, August 15.—(AP)—Almost half a million veterans of World War II are taking training on the job under the GI Bill of Rights. They represent 40 per cent of all veterans enrolled under the GI Bill's educational provision.

Many of the half-million job trainees are throwing away educational privileges which over the four-year maximum period of GI schooling could represent \$9,900 worth of free education. They're throwing away this education because they're using up their allotted time in on-the-job training programs which neither give training nor lead to better jobs.

An official of the retraining and employment administration (RRA) told me something else. He said he couldn't substantiate it, but he was certain it could be proved if facilities were available to do so.

National Service Life Insurance

The liberalized insurance benefits which became available to veterans when President Truman signed the congressional act amending the national service life insurance act of 1940, were anticipated by numerous ex-servicemen and women in North Carolina who have recently reinstated policies they allowed to lapse when they left the service.

Widespread reinstatements in North Carolina were attributed by Regional Insurance Officer E. C. Bailey to expectation on the part of veterans that the law would be changed. Until January 1, 1947, he added, a veteran may reinstate lapsed national service life insurance simply by paying two months back premiums and signing a statement that his health is as good as when his premium was due. After that date a physical examination will be necessary in most cases.

As originally enacted, NSLI was designed to meet the needs of men and women at war. The new amendments make it more attractive to veterans in peace time. Besides providing for lump sum payments to beneficiaries, the amendments also create new types of policies, permit the naming of beneficiaries outside the restricted classes included in the original bill, and offer total disability benefits which were not previously included.

"Veterans now holding term insurance policies need feel no compulsion," Mr. Bailey continued, "to convert their policies immediately to permanent types. Term insurance policies issued before January 1, 1946, may be continued without change for eight years from the date they were issued and policies issued after December 31, 1946, are good for 5 years without the necessity of converting to any of the more permanent types of insurance."

Aged Sportsman Dies In Kentucky

Lexington, Ky., Aug. 15—(AP)—Col. E. R. Bradley, 86-year-old sportsman whose horses have won four Kentucky derbies, died of a heart attack at his Idle Hour farm at Lexington at 1 a. m. this morning.

Because of his advanced age, Col. Bradley has been less active in recent years but still maintained a lively interest in horse racing and thoroughbred breeding. These activities were centered at his Idle Hour farm near here, one of the show places of Kentucky's bluegrass region.

He formerly maintained other business interests in Palm Beach, Fla.—notably the Beach Club, often called the country's biggest gambling casino—but began to dispose of his property after suffering a heart attack in December, 1940.

Although he never witnessed a Kentucky Derby after 1937 because of his health, he listened to radio broadcasts of the races with close friends.

His derby winners included Be-have Yourself in 1921, Bubbling Over in 1926, Burgoon King in 1932 and Broker's Tip in 1933. His entries ran one-two in the Kentucky Derbies of 1921 and 1926.

His last effort to win the derby for a fifth time was made in 1945 with Burning Dream, which finished ninth. Bimelch, another Bradley hopeful, finished second in the 1940 derby.

THREE WORD GOSPEL

The funerals were held without incident, but later several hundred persons tried to storm a road block barring access to the Kingsway, the waterfront street.
Moored in the harbor was the Yugoslav Y. 2, a vessel which was captured Tuesday while bringing aboard 100 illegal Jewish immigrants to Palestine.

zation program depends on rolling back prices on essential food items.
The CIO has made similar suggestions. And President Philip Murray was scheduled to testify before the decontrol agency at 4 p. m.
Wirtz and Garman in a letter to Chairman Roy L. Thompson of the decontrol group, declared that "take home" pay has dropped 8 per cent since April, 1945.
They said job rates have increased 11 to 15 per cent but that average straight time hourly earnings have risen only about nine per cent.
Wirtz and Garman concluded:
"(A) That there is today, or was on June 30, relative wage stability; (B) That the program which has achieved that stability cannot be continued unless June 30 food price levels can be restored to the fullest extent consistent with the recent act of congress; (C) That this program probably can be continued and wage stability maintained, if there is that restoration; and (D) That the public interest will be greatly served by the recontrol of food prices which will permit the avoidance of wage inflation."

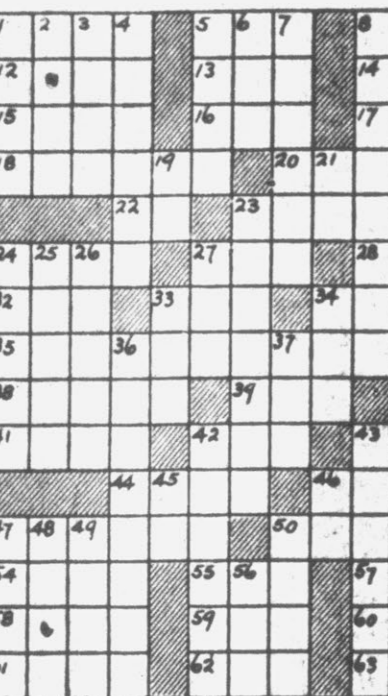
The stabilizers declared that if essential food prices are not recontrolled and rolled back there would have to be immediate consideration of several basic wage stabilization issues, including:
(A) Revision of the present 33 per cent cost of living wage standard and the possible change or elimination of other present wage provisions; and (B) The question of whether a new set of wage standards could, as a practical matter, be devised and administered effectively.

He said union representatives had been in Washington eight days and had worked continually with the Department of Labor to settle basic issues.
The NLU originally called the strike on 11 cargo companies and six tanker firms, but later extended

order to include all lake seamen, even non-members.

NLU officials said original demands for a 40-hour week had been discarded along with wage increases of 10, 15 and 18 cents hourly for beginners and certain rated men and preferential hiring through union halls.

The Arabs want Bengazi and Tobruk, though, and the Jews and Arabs want Palestine. Britain has met a part of this problem by transforming Transjordan into an independent military base, but this is insufficient to meet any general threat which might be developed among the Iraqis, the Kurds and Arab

job-training program many honest employers who otherwise would be only too glad to put it into effect.
Many ex-GIs are not well enough acquainted with the law to know just how much benefit can be derived from job-training. So when they get the run-around from unscrupulous employers they accept it and they keep right on using up their period of eligibility. The new law should help.

In yesterday's article it was stated that no veteran job-trainee could make more than \$175 or \$200 over and above his subsistence allow-

ance. This should have been clarified to show that the combination of wages plus allowance cannot under the new law exceed these sums: \$175 (if the veteran has no dependents) and \$200 (if he has one or more dependents).

ANCIENT LAW INVOKED HERE

Farmers Fined \$100 For Enticing Families To Leave Job

By CHESTER WALSH In Pitt County Court Tuesday Judge Dink James invoked an ancient statute to convict defendants of enticing farm workers to leave the employer with whom they had contracted to work, and to convict them of hiring workers who had unlawfully left their employ-

A. C. Rowland, Jr., and Lacey Morning, farmers, were charged with enticing and persuading Charlie Ross and Lonnie Tatum and their families, consisting of their wives, three sons and two daughters, nine persons in all, who were servants and employees of Hubert Moringo and Allen Moringo, said servants or employees having contracted to serve their said masters or employers, to leave unlawfully the service of their employers, and that A. C. Rowland, Jr., did unlawfully harbor and detain in his own service and from the service of their rightful employers, the said nine persons. Judge James fined Rowland and Moringo \$100 each.

Attorney John R. Barker, counsel for the plaintiffs, said today he will institute civil suit for \$1,500 damages for his clients against A. C. Rowland, Sr., and A. C. Rowland, Jr., and Lacey Morning. Barker said he will include A. C. Rowland, Sr., in the civil action. Although he was not convicted in the criminal action, the senior Rowland is alleged by the attorney and his clients to

be responsible, since his son, A. C. Rowland, Jr., was representing him.

Will Ask State Help To Meet Local Costs

Raleigh, N. C., Aug. 15—(AP)—The legislative committee of the North Carolina League of Municipalities met here today to formulate a program of legislation to be presented to the 1947 session of the General Assembly.

The league, informed sources said, "is alarmed over the financial strain faced by North Carolina cities and towns" and feels that the state should help "bear some of the burden by remitting part of certain taxes collected in cities and towns."

Commissioner J. E. L. Wade is chairman of the legislative committee which will present its legislative program to the annual conference of the League of Municipalities when it meets at Asheville on September 12-14.
